(57) **CLAIM**

We claim the ornamental design for an instrument decoration,  
as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of an instrument decoration  
showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a cross-sectional view of FIG. 3 taken along line  
4—4;

FIG. 5 is an enlargement of the portion of FIG. 4 included in  
the circle marked 5;

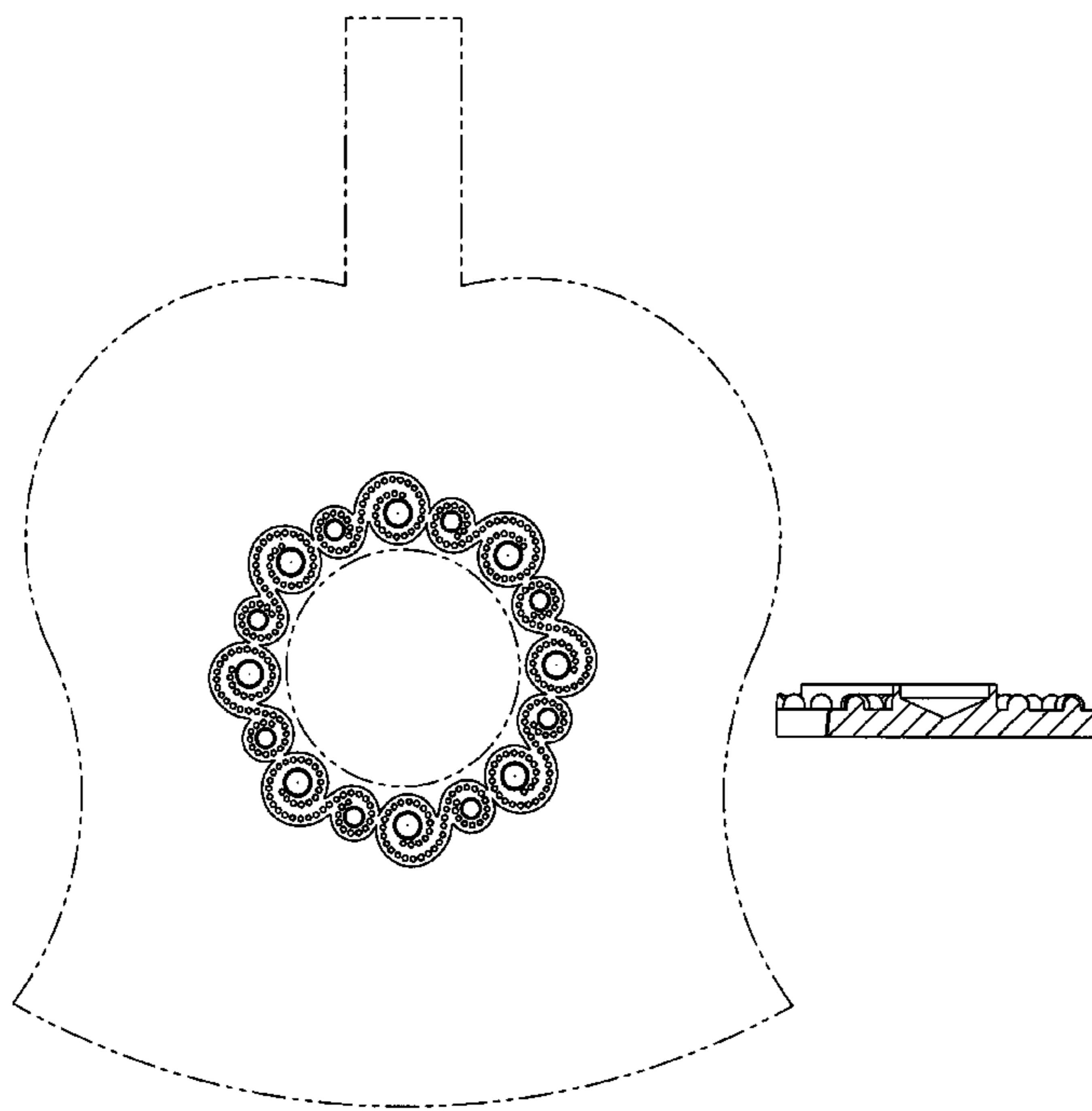
FIG. 6 is an enlargement of the portion of FIG. 4 included in  
the circle marked 6;

FIG. 7 is a rear elevational view thereof; and,

FIG. 8 is a side elevational view thereof, which represents any  
side of the instrument decoration.

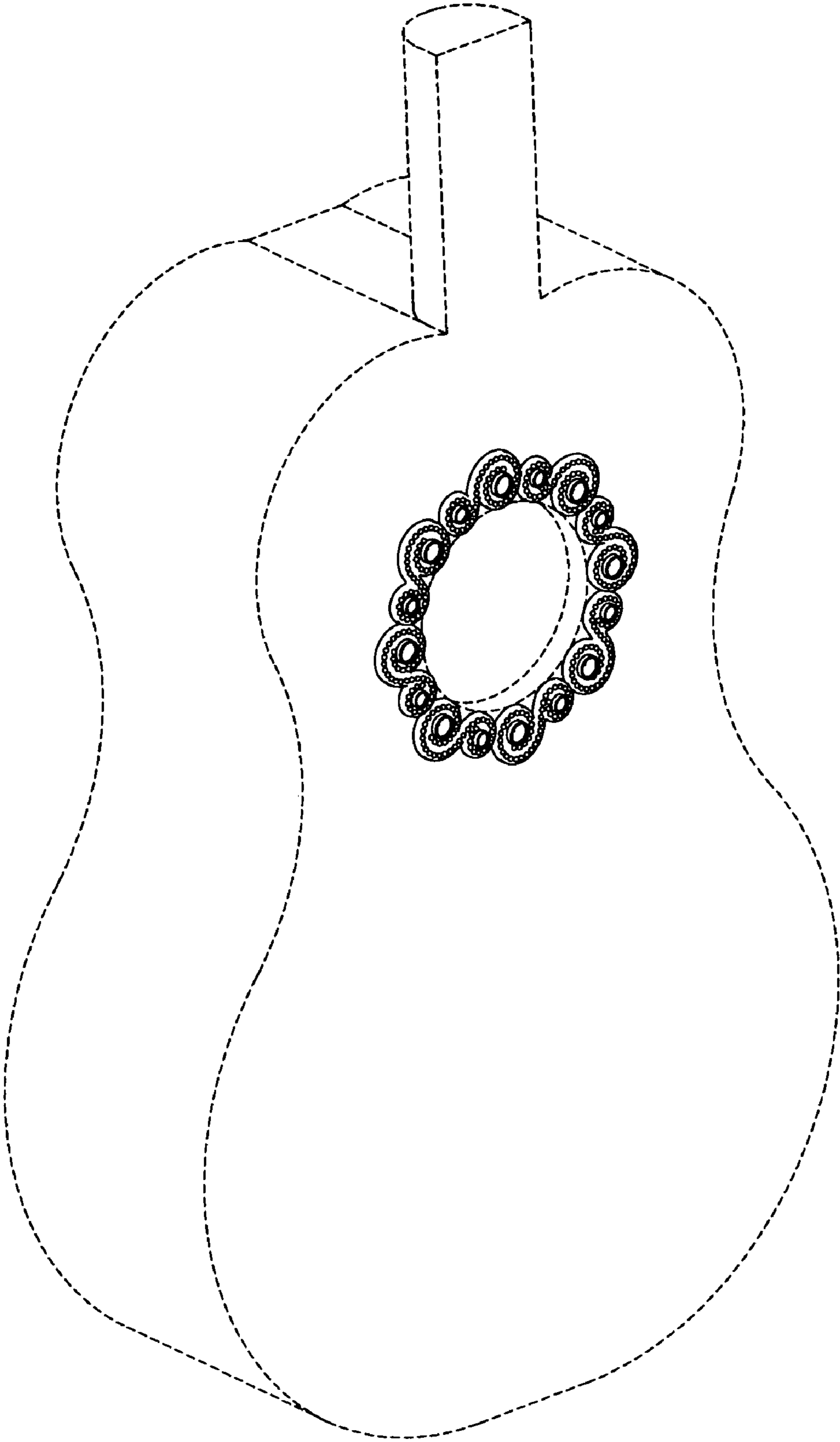

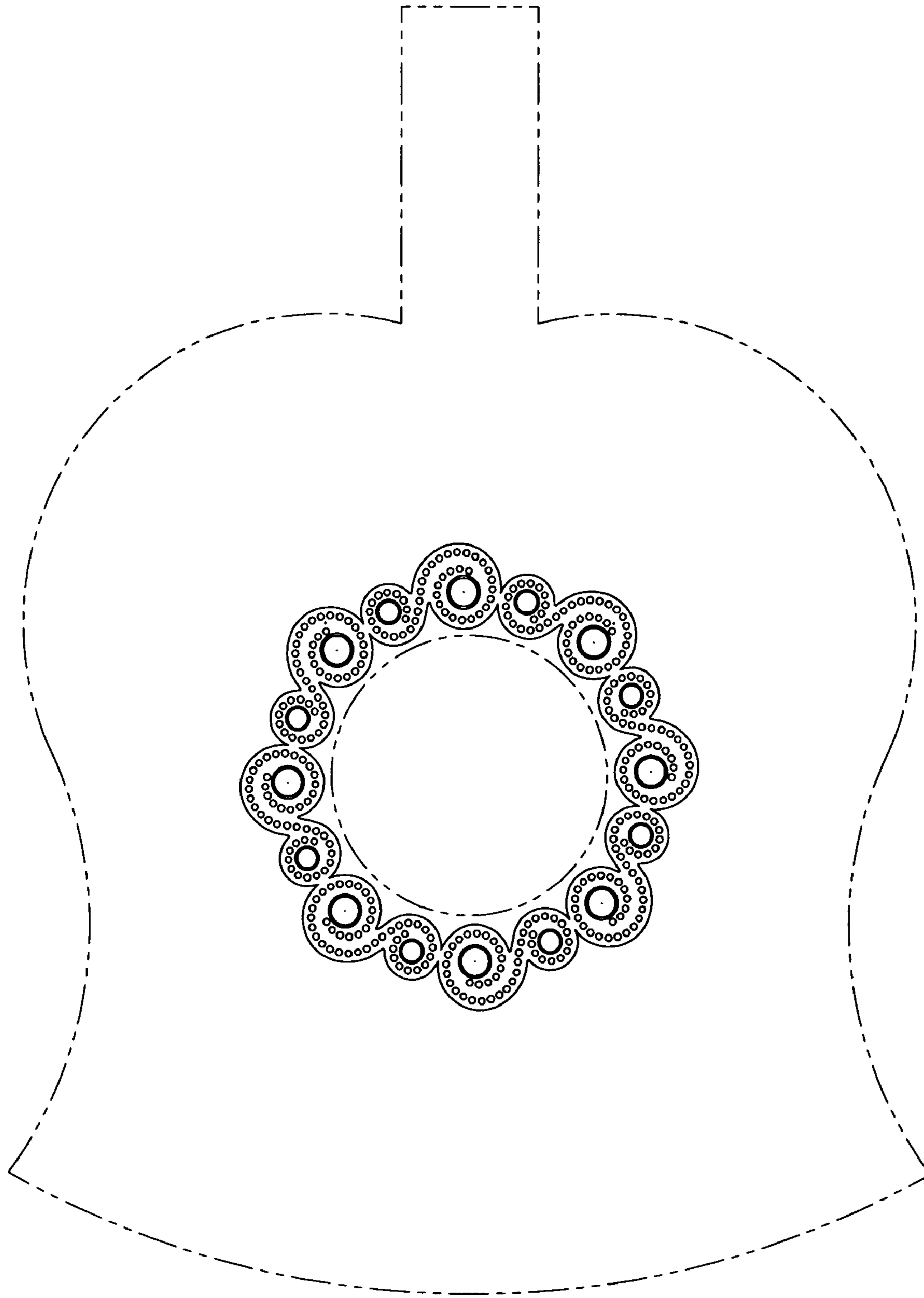

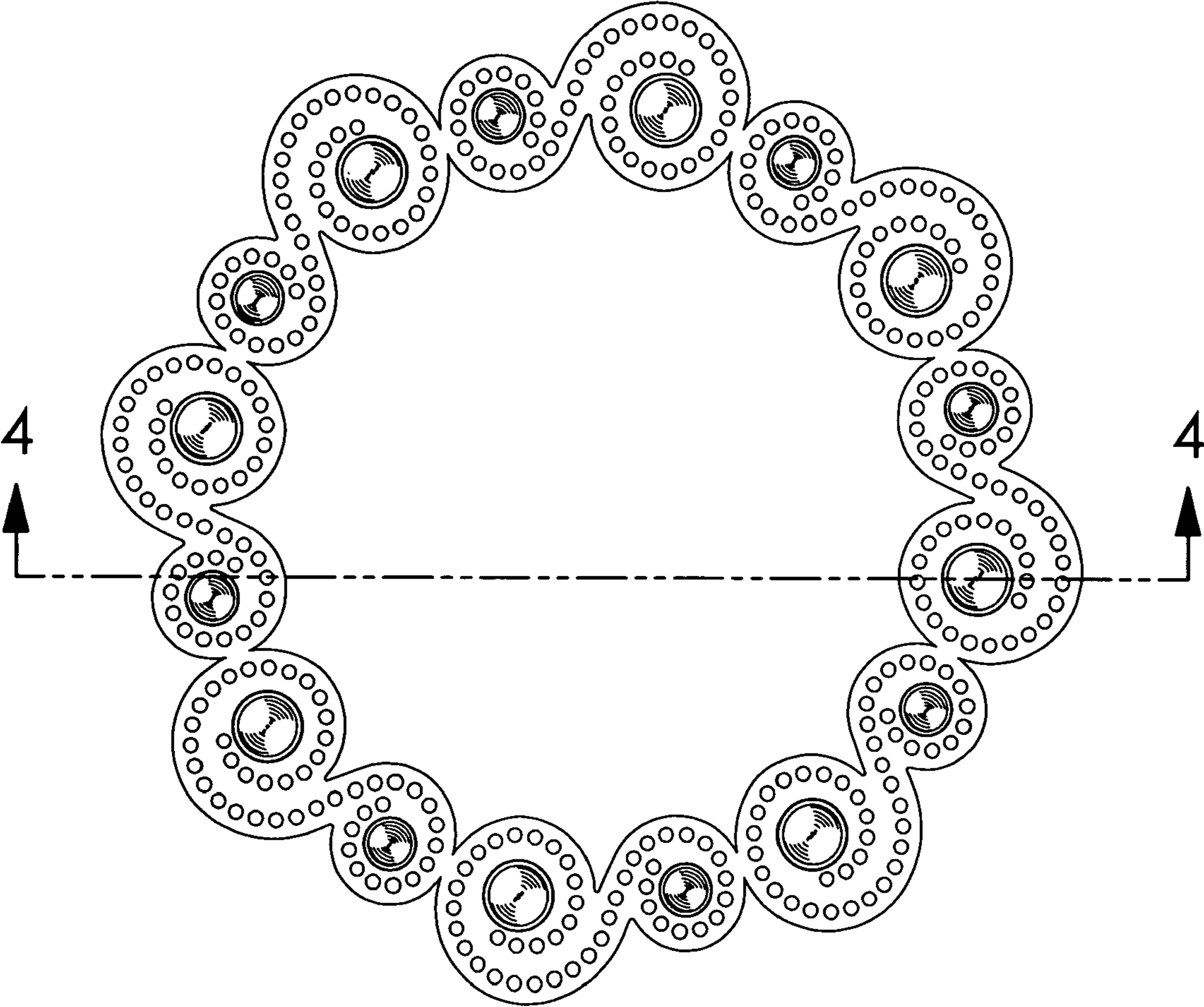

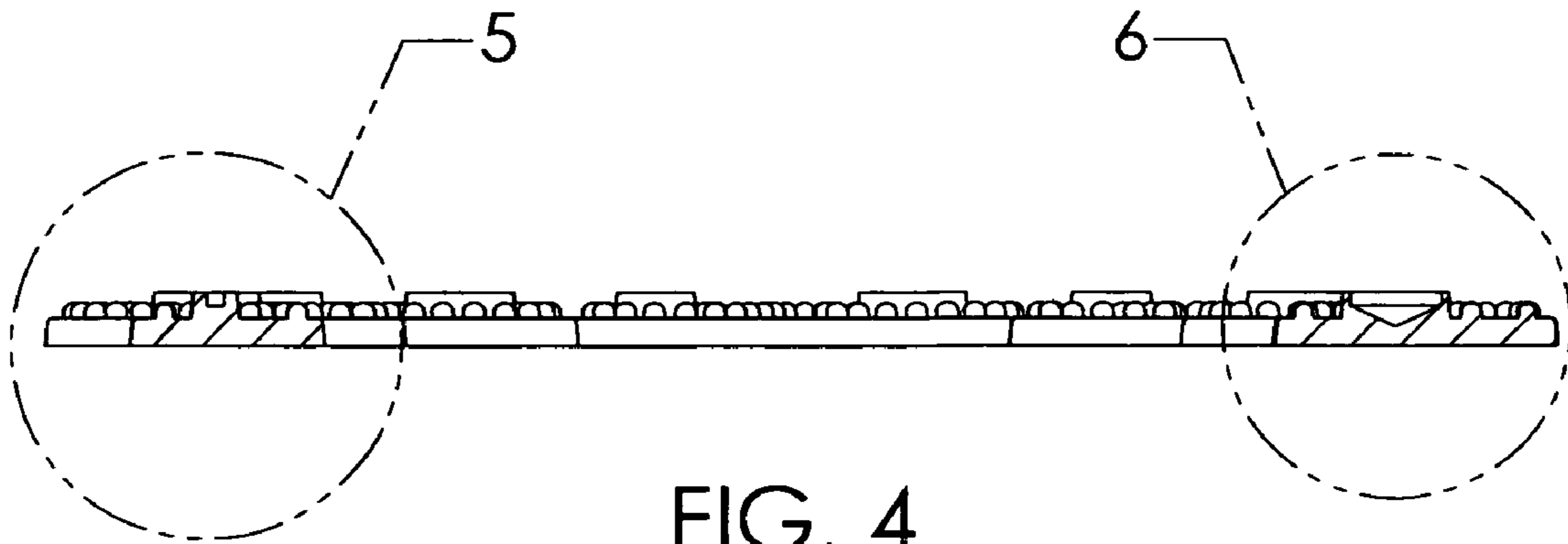

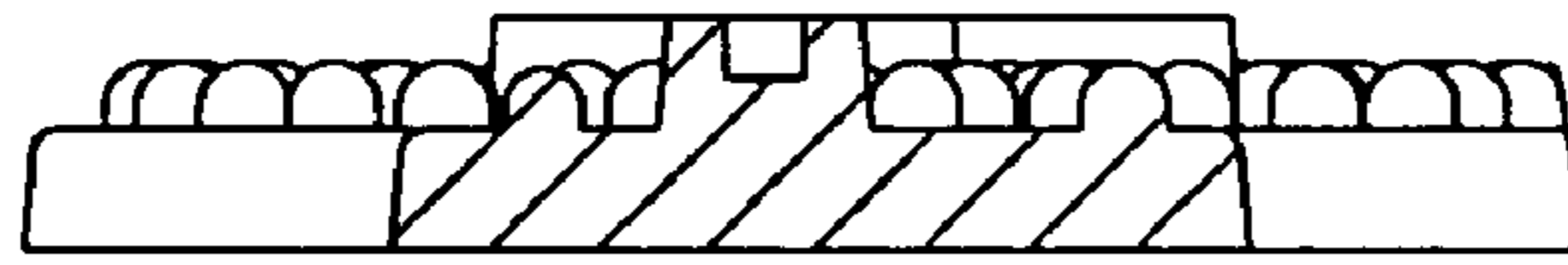

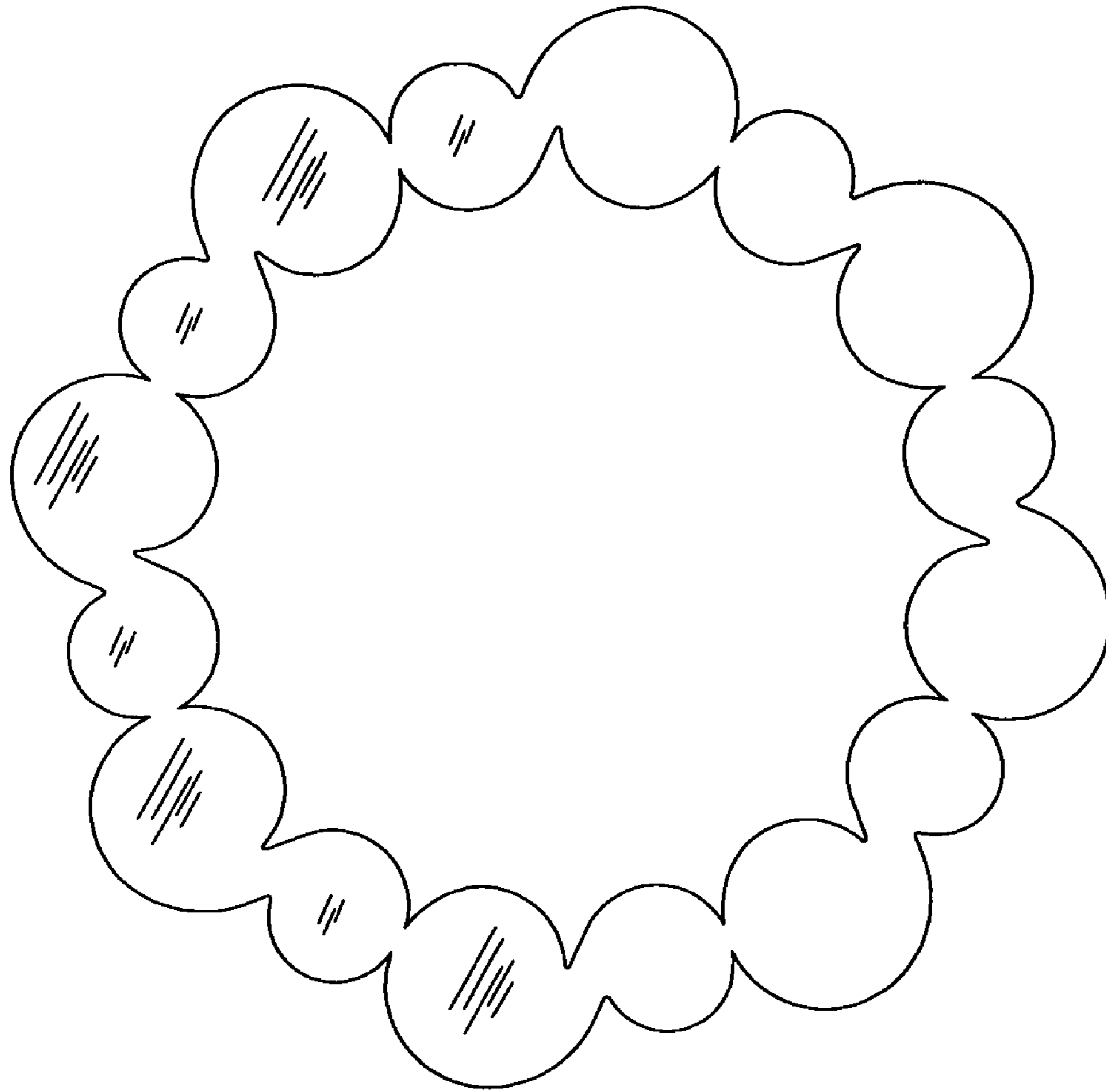
