(57) **CLAIM**

The ornamental design for a paper cartridge for printer, as shown and described.

FIG. 1 is a reduced top perspective view of a paper cartridge for a printer with a lid in the closed position against the top of the cartridge;

FIG. 2 is a reduced top perspective view thereof with an unclaimed portion removed so as not to obscure the claimed subject matter;

FIG. 3 is a top view of FIG. 1;

FIG. 4 is a top view of FIG. 2;

FIG. 5 is a front view of FIG. 1;

FIG. 6 is a right-side view of FIG. 1;

FIG. 7 is a rear view of FIG. 1;

FIG. 8 is a bottom view of FIG. 1;

FIG. 9 is a reduced bottom perspective view of FIG. 1;

FIG. 10 is a reduced top view of FIG. 1 in an unfolded position so the inside is visible;

FIG. 11 is a reduced top perspective view thereof with the lid in the folded condition against the bottom of the cartridge;

FIG. 12 is a reduced top perspective view of FIG. 11 with an unclaimed portion removed so as not to obscure the claimed subject matter;

FIG. 13 is a top view of FIG. 11;

FIG. 14 is the top view of FIG. 12;

FIG. 15 is a front view of FIG. 11;

FIG. 16 is a right-side view of FIG. 11;

FIG. 17 is a left-side view of FIG. 11;

FIG. 18 is a rear view of FIG. 11;

FIG. 19 is a bottom view of FIG. 11;

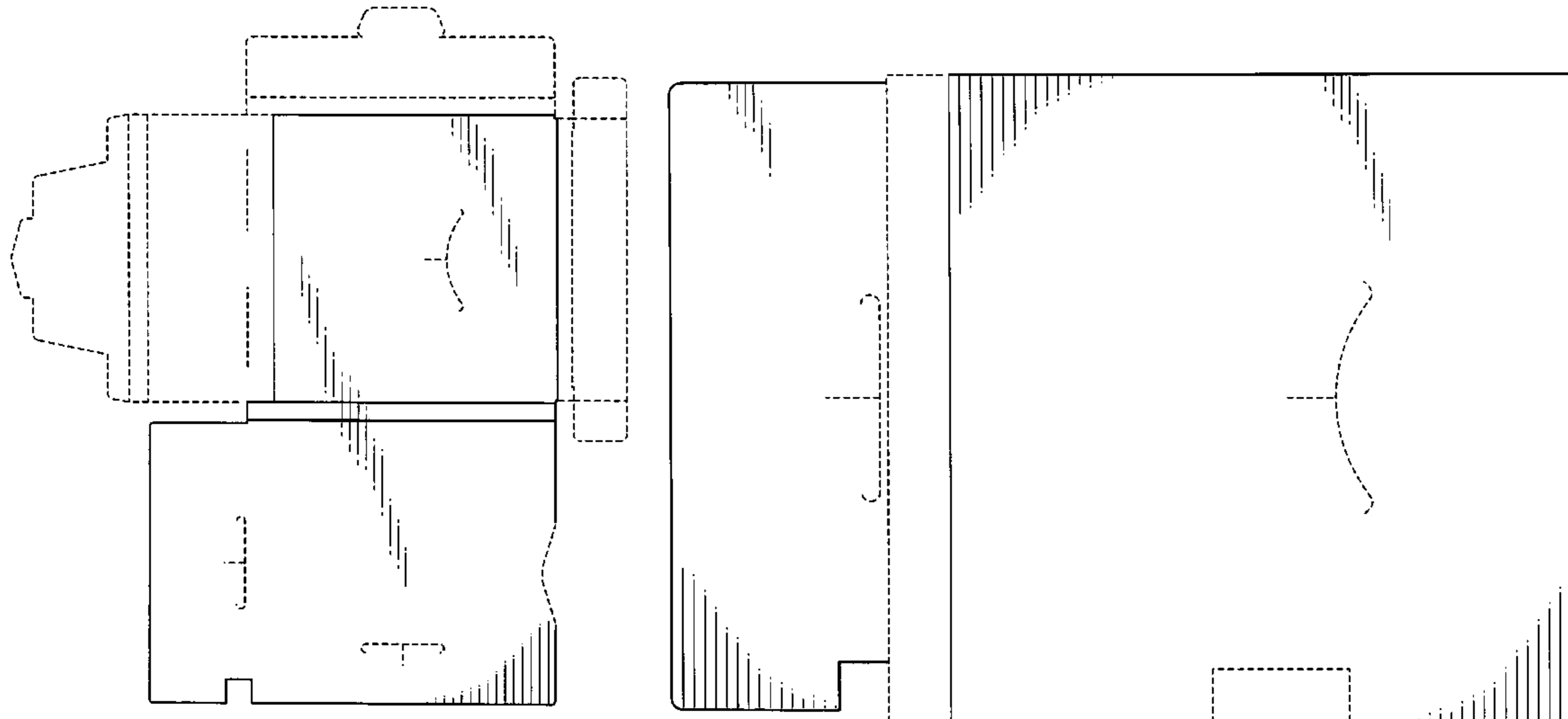
FIG. 20 is a bottom view of FIG. 12;

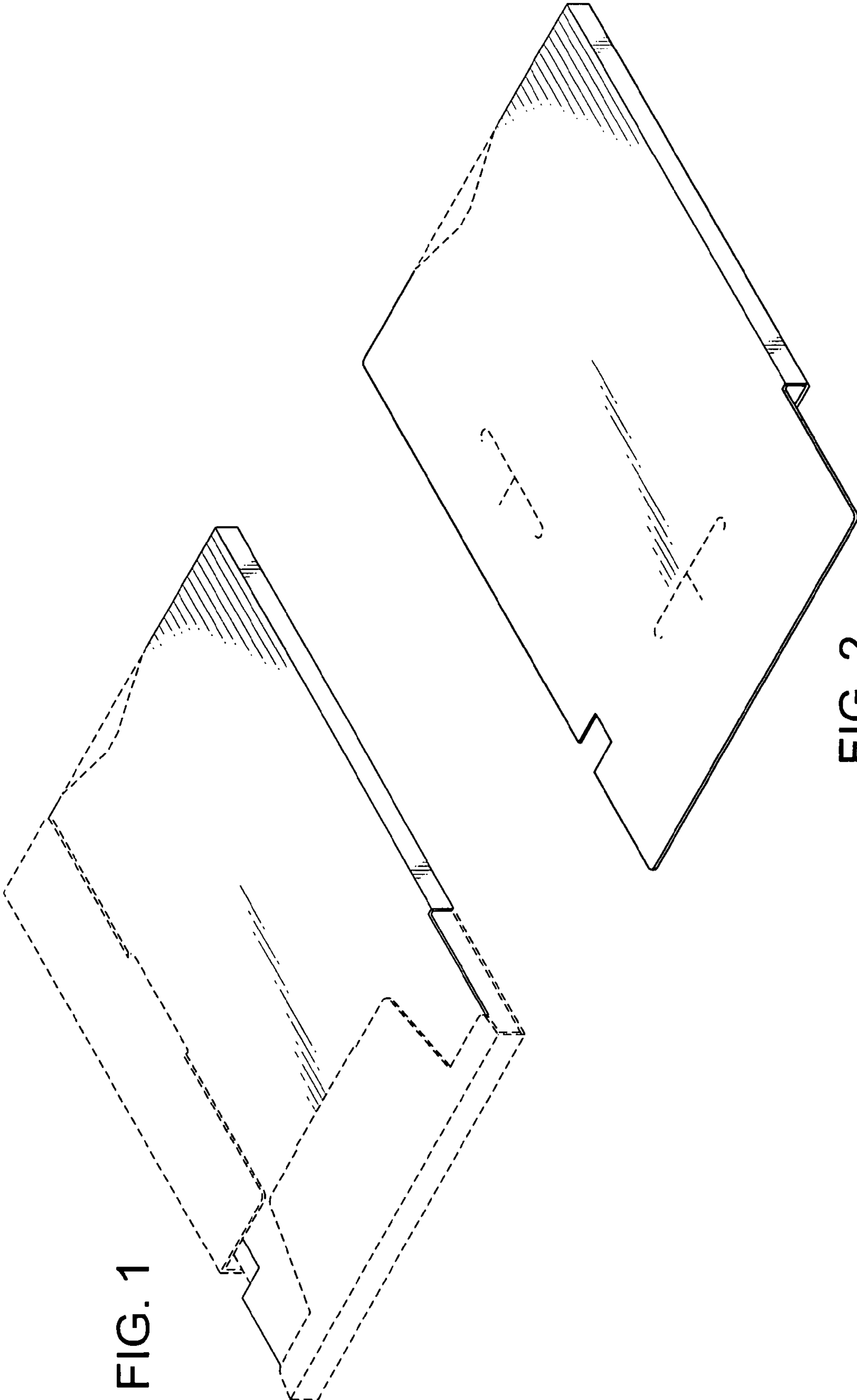

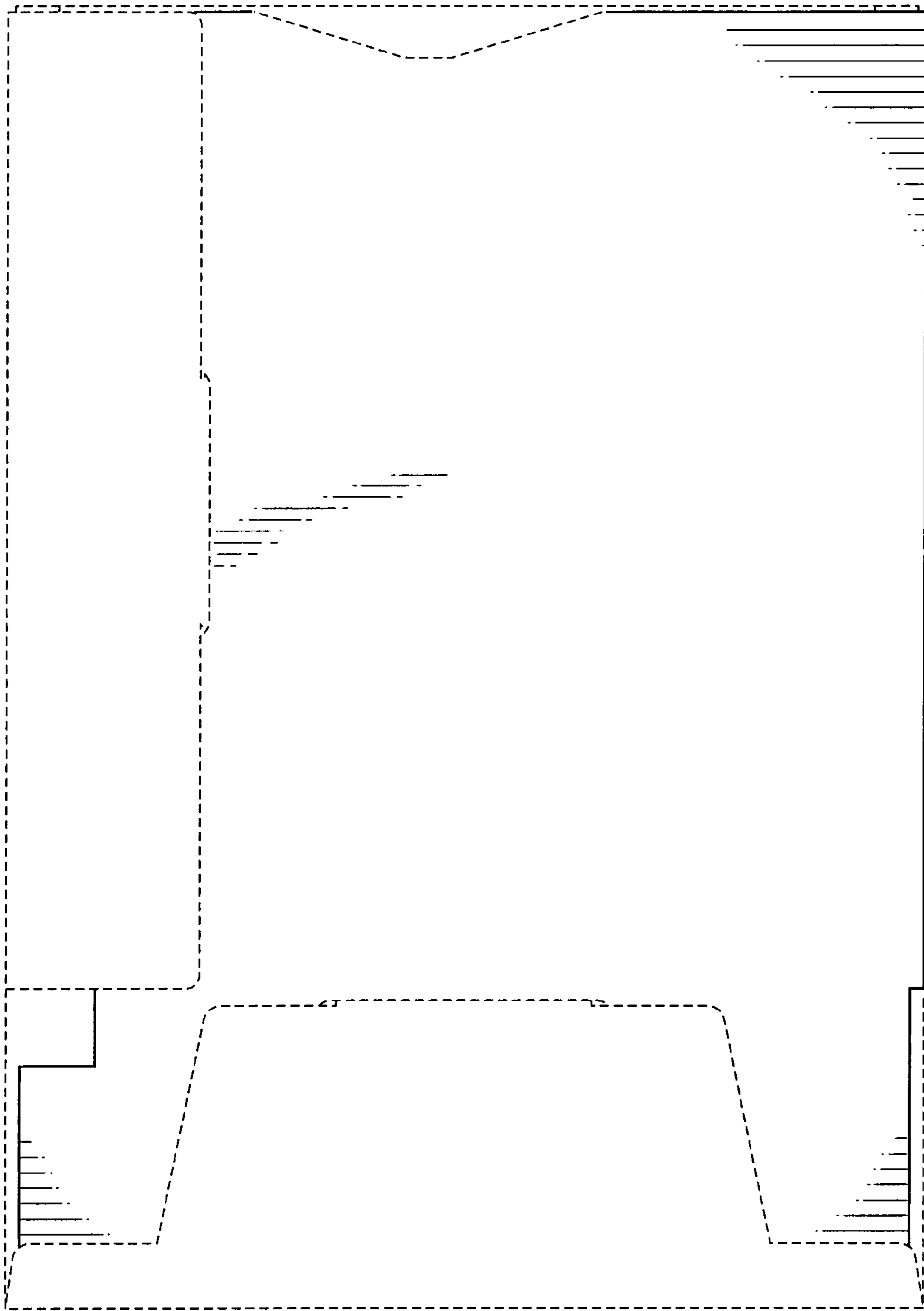

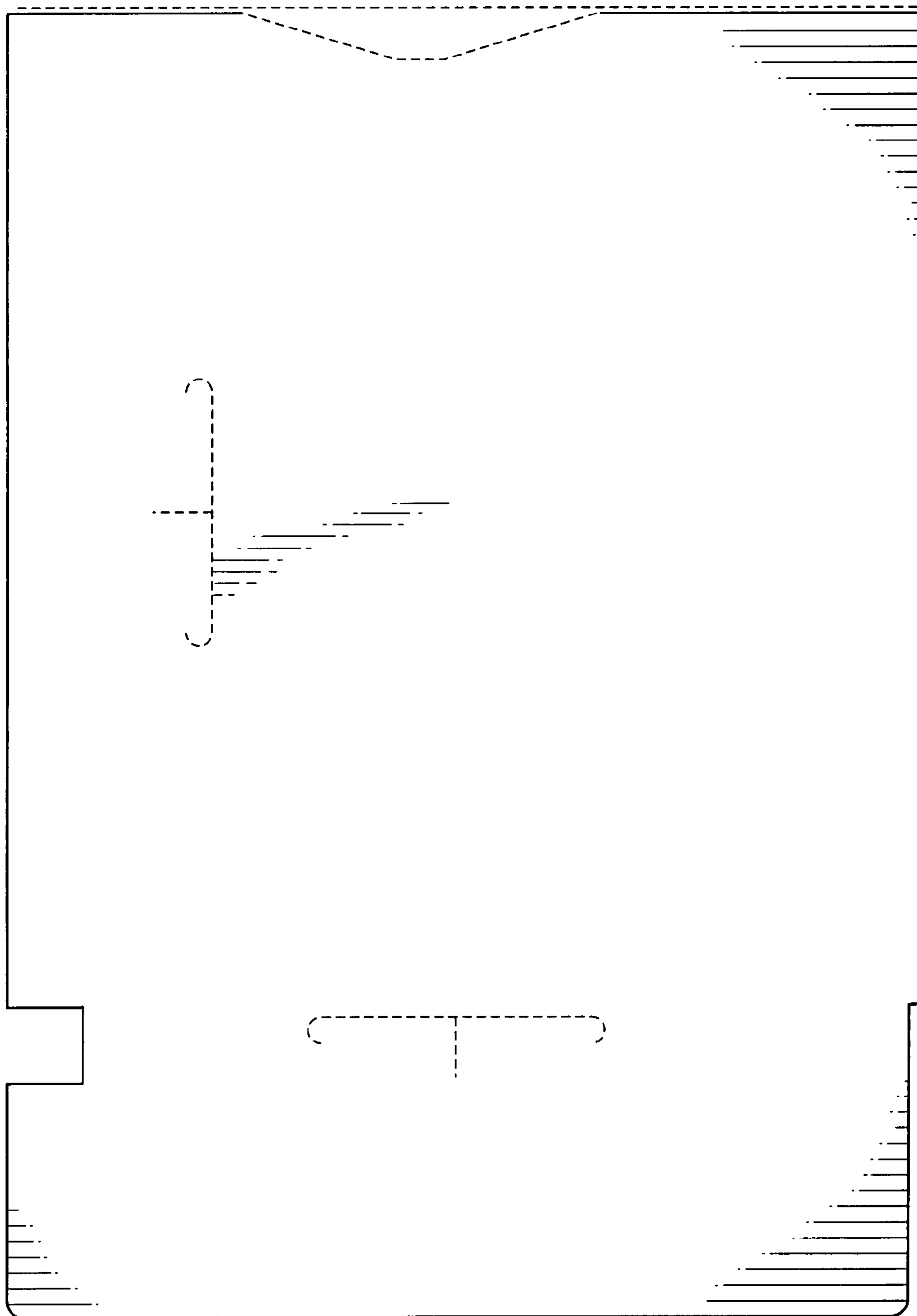

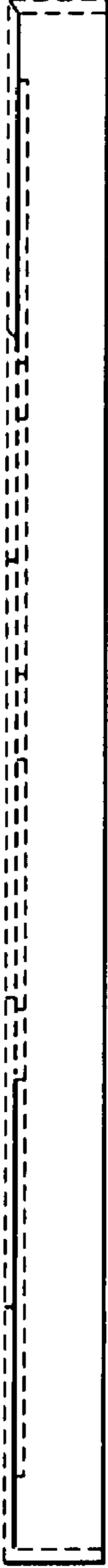

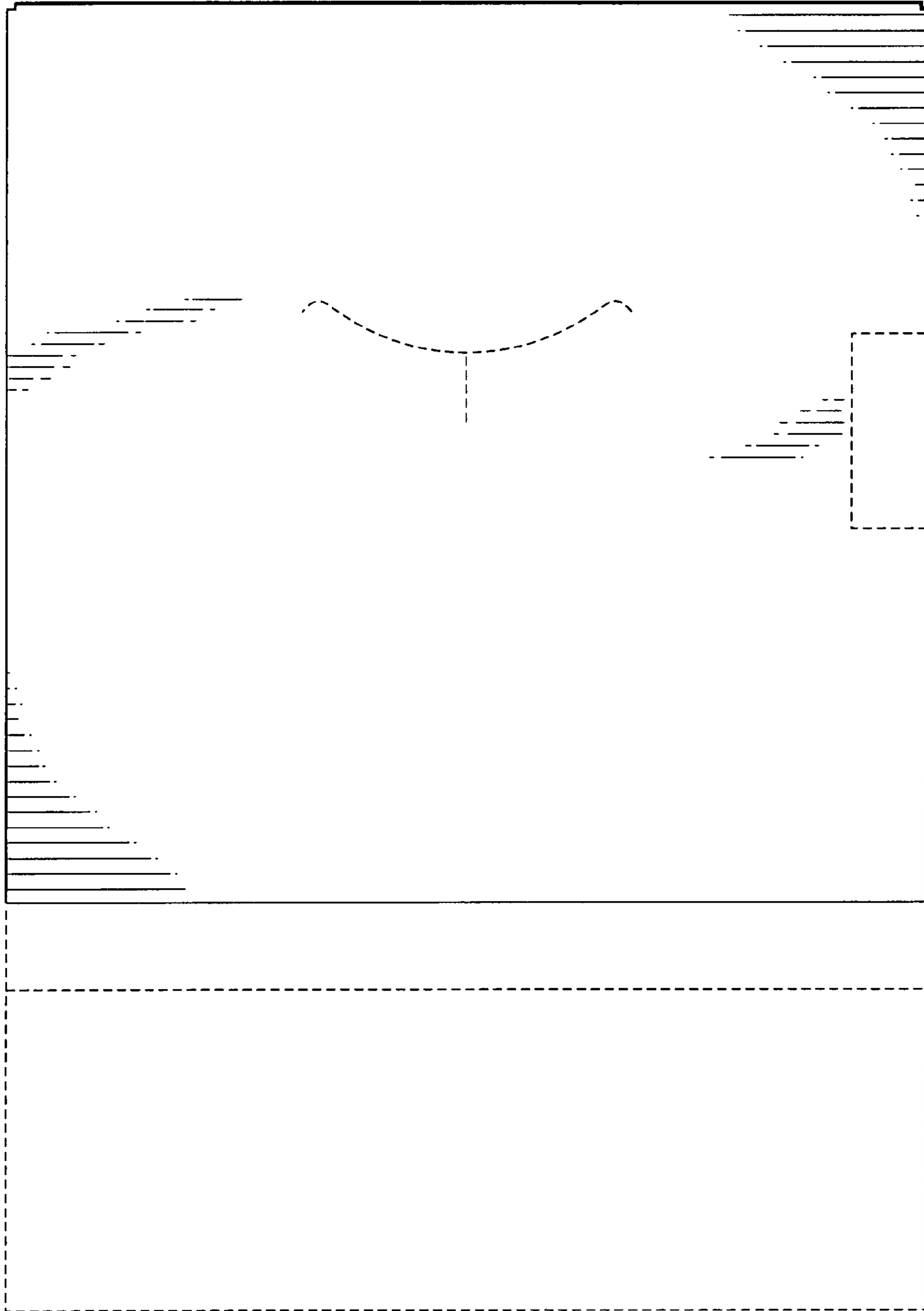

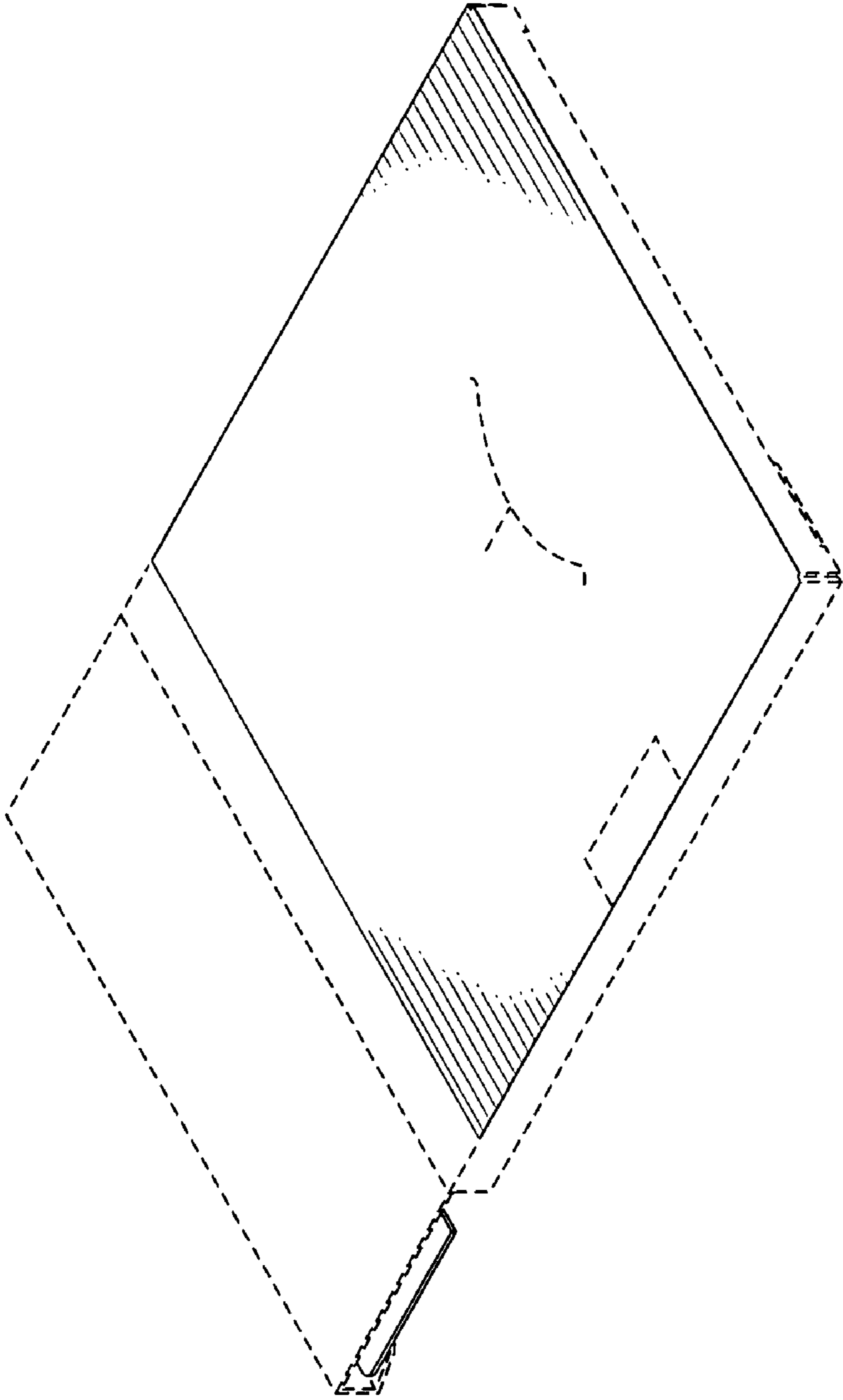

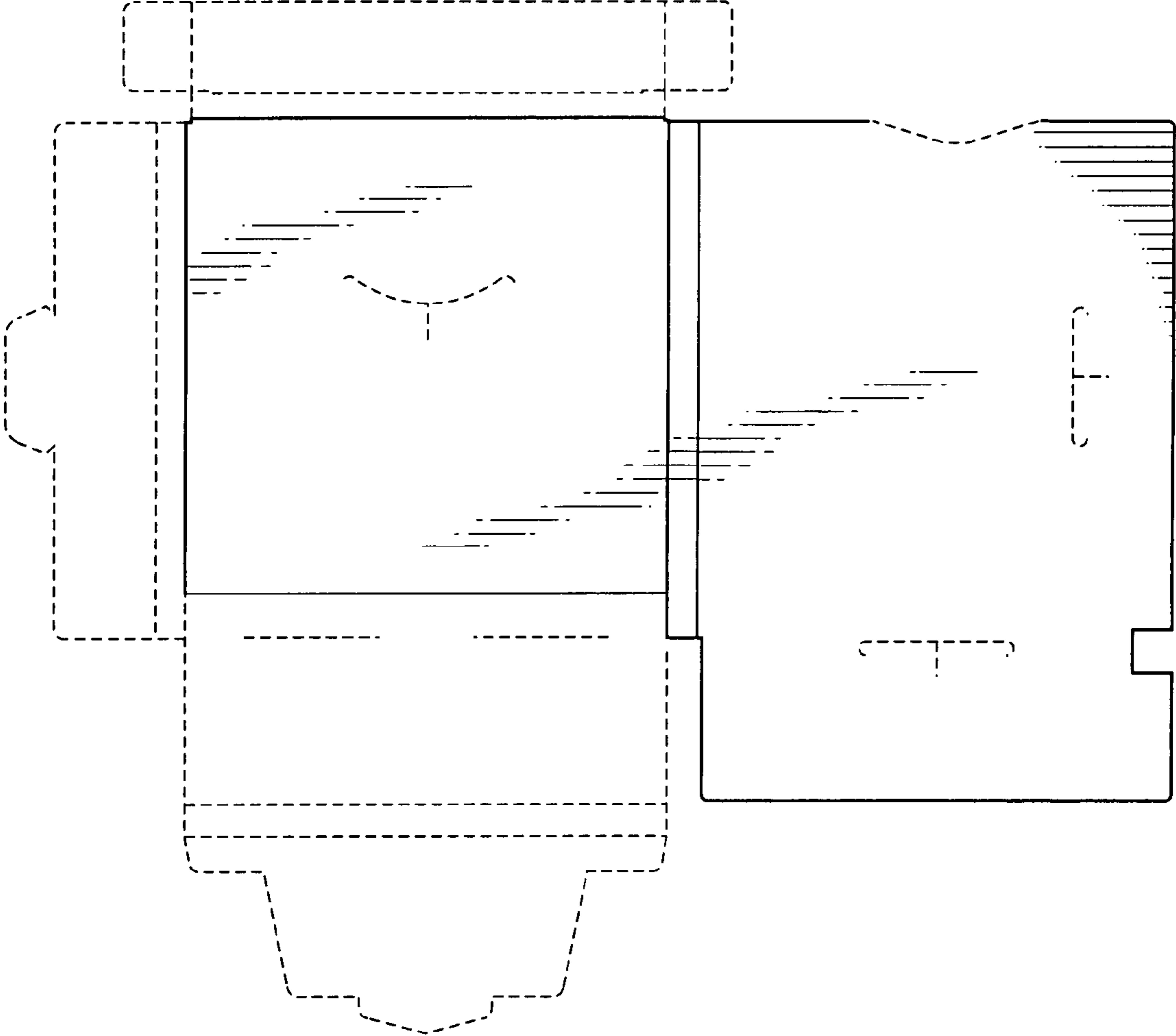

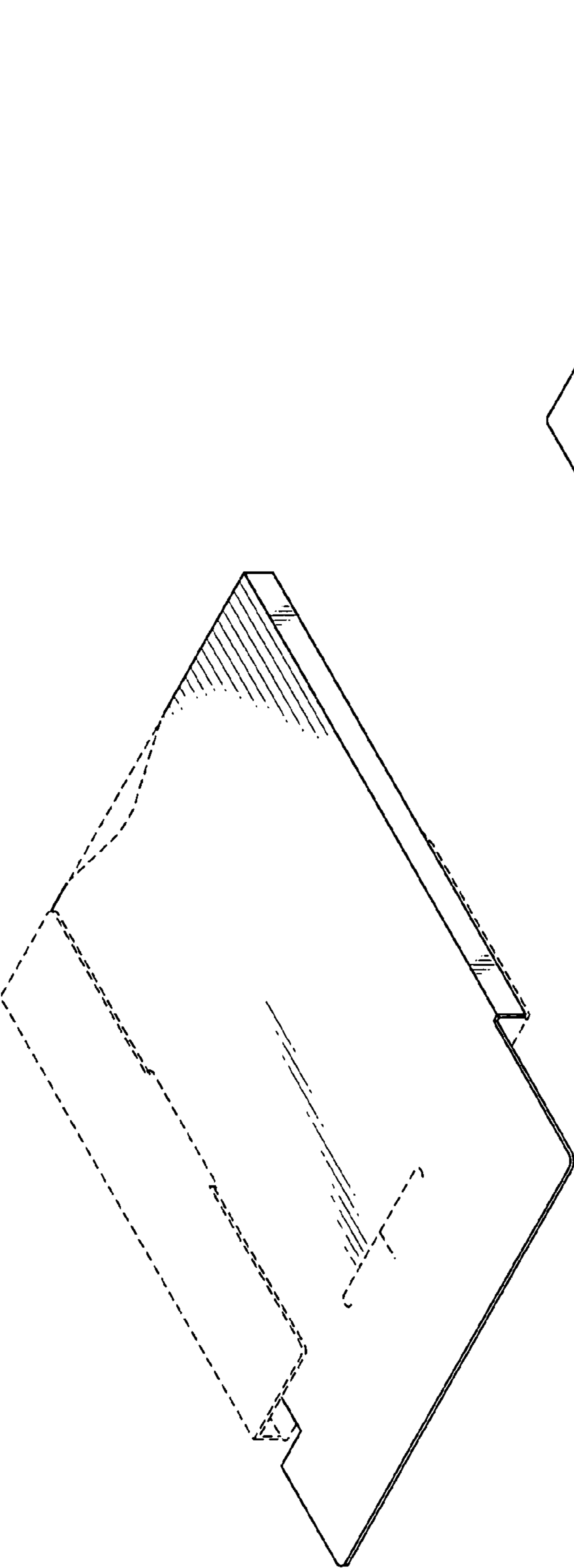

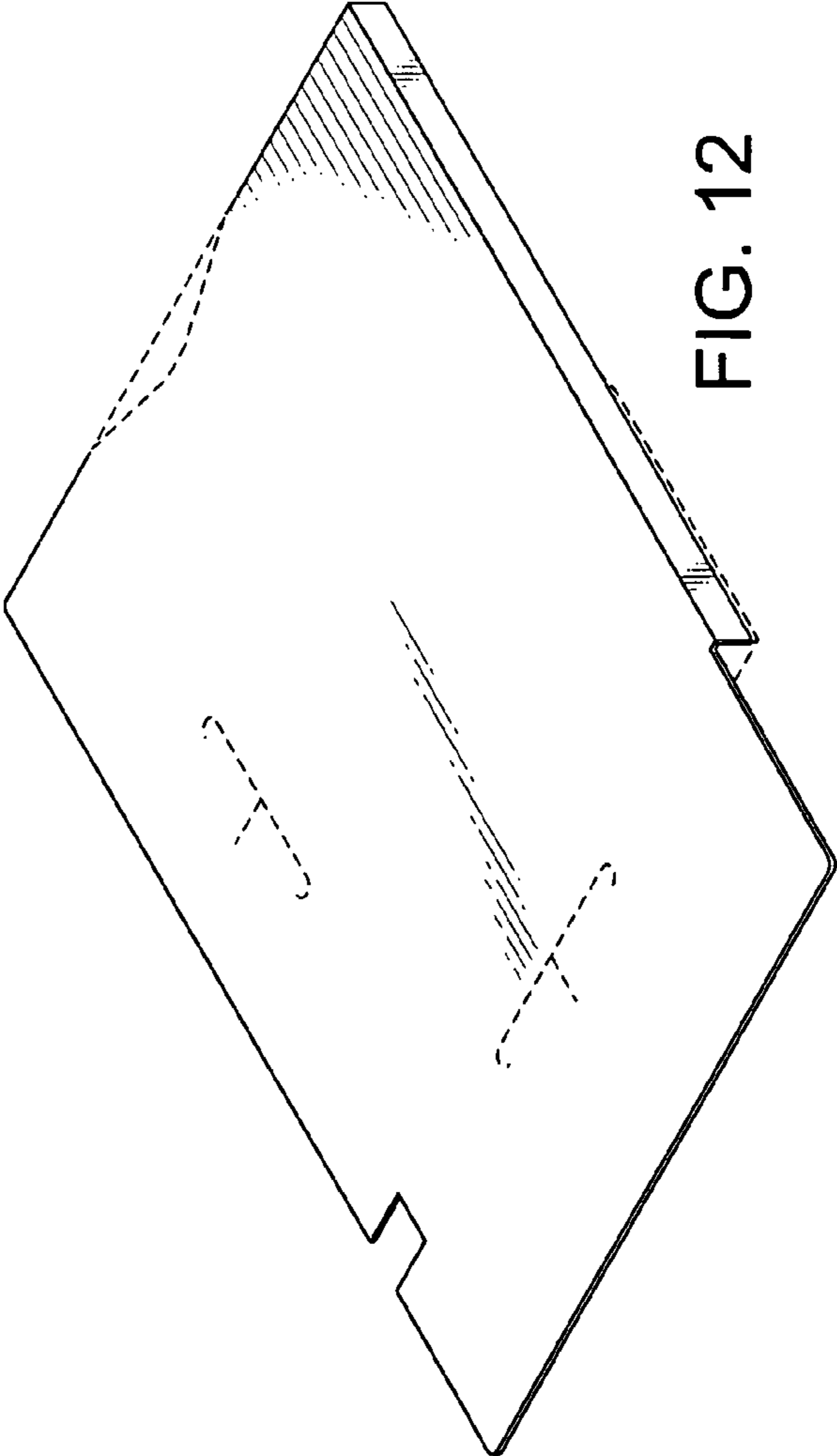

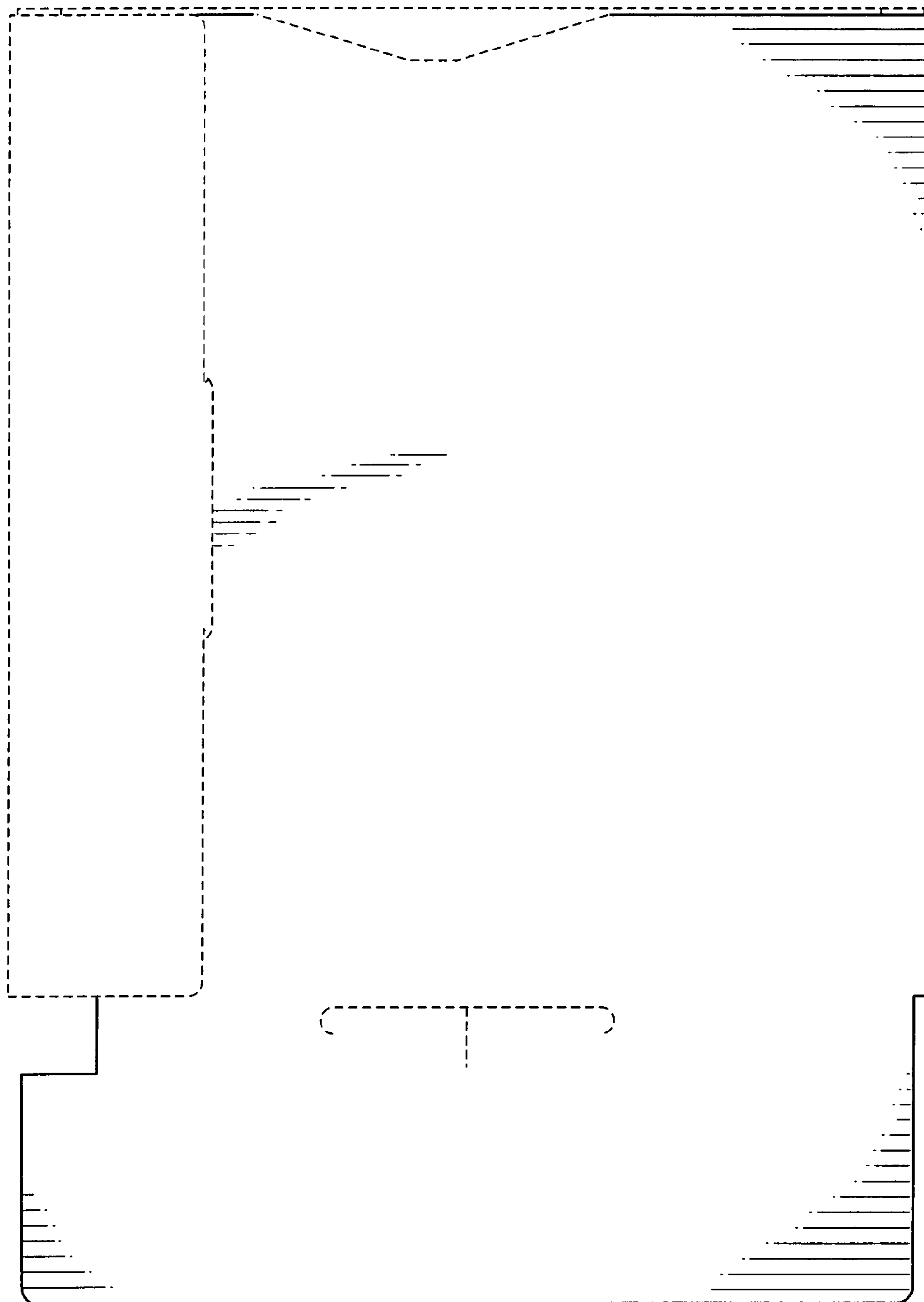

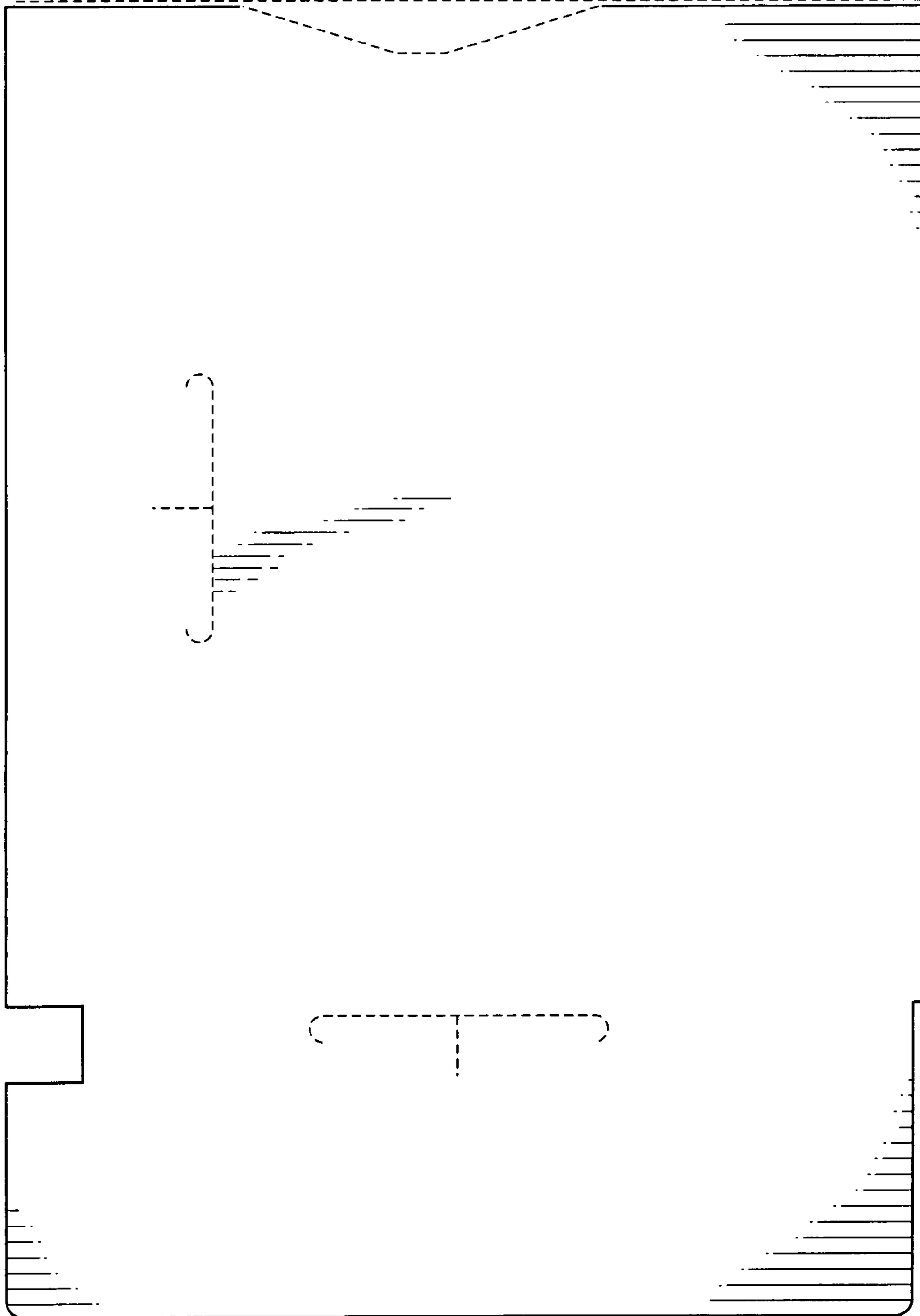

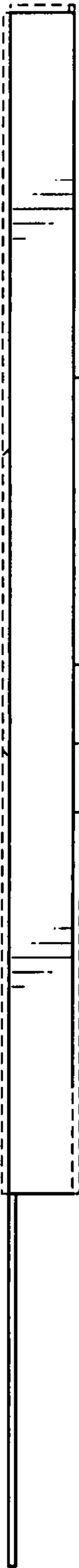

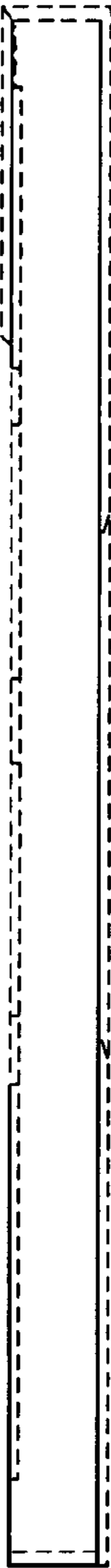

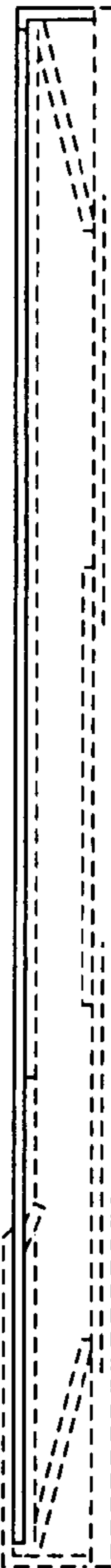

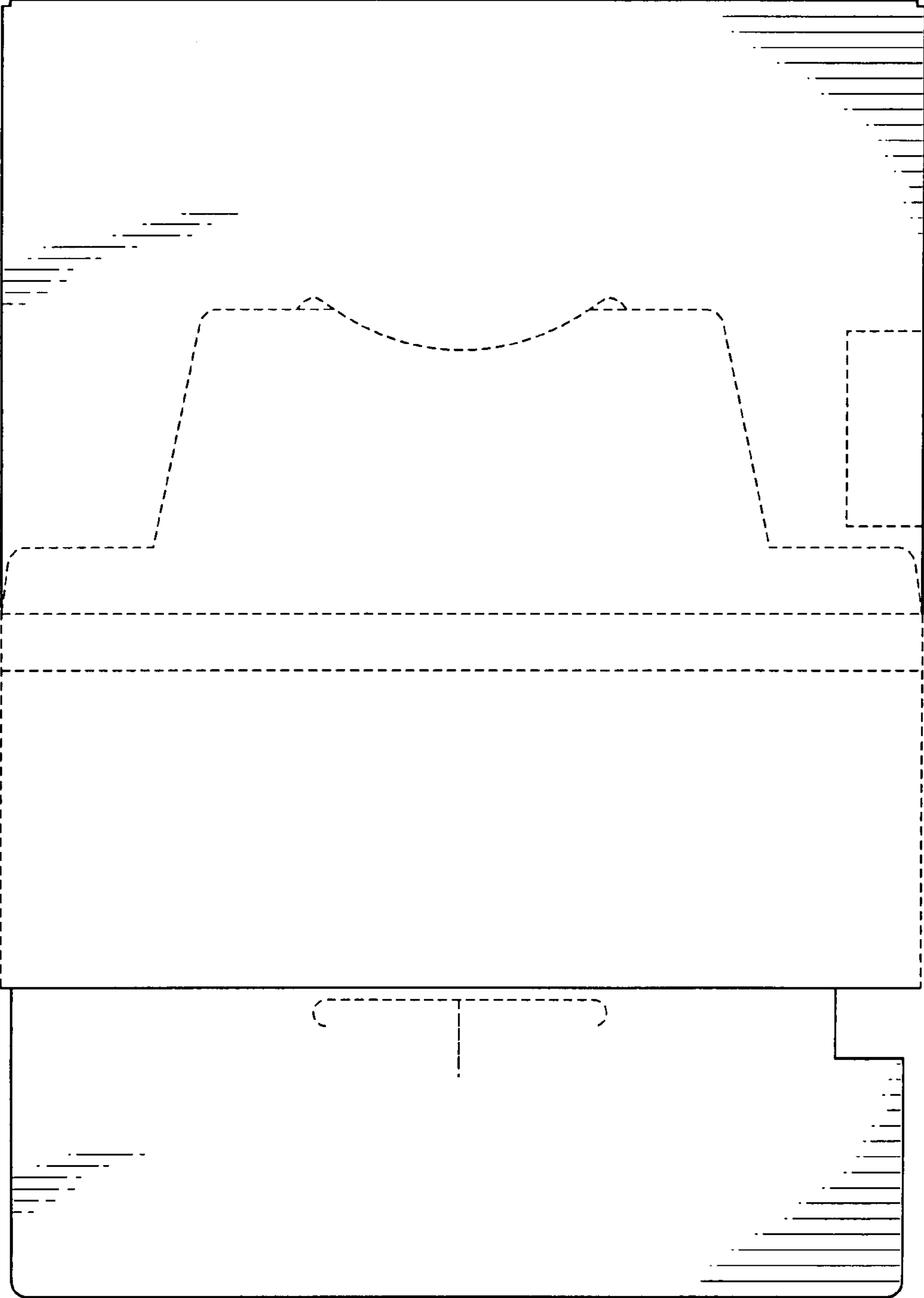

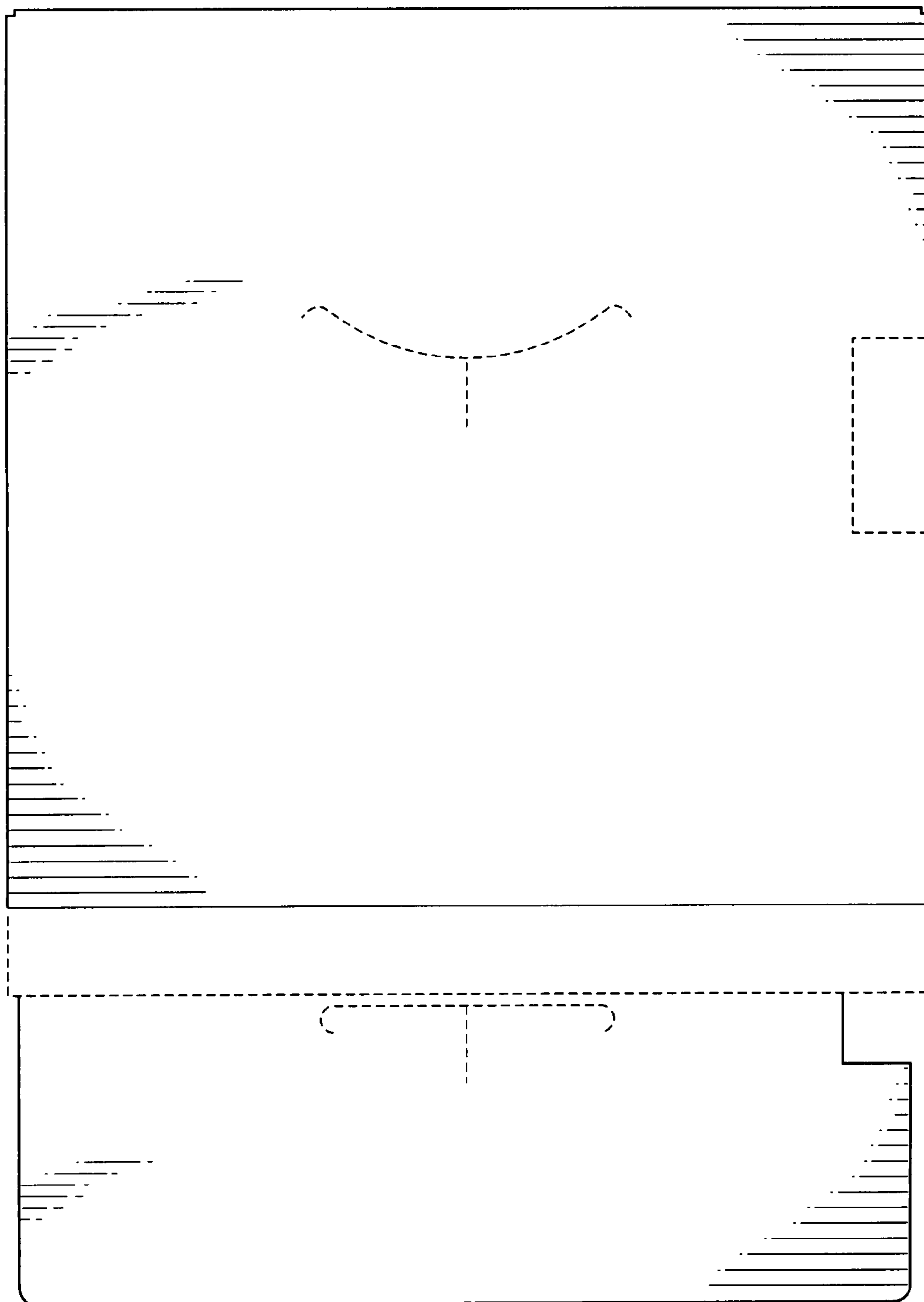

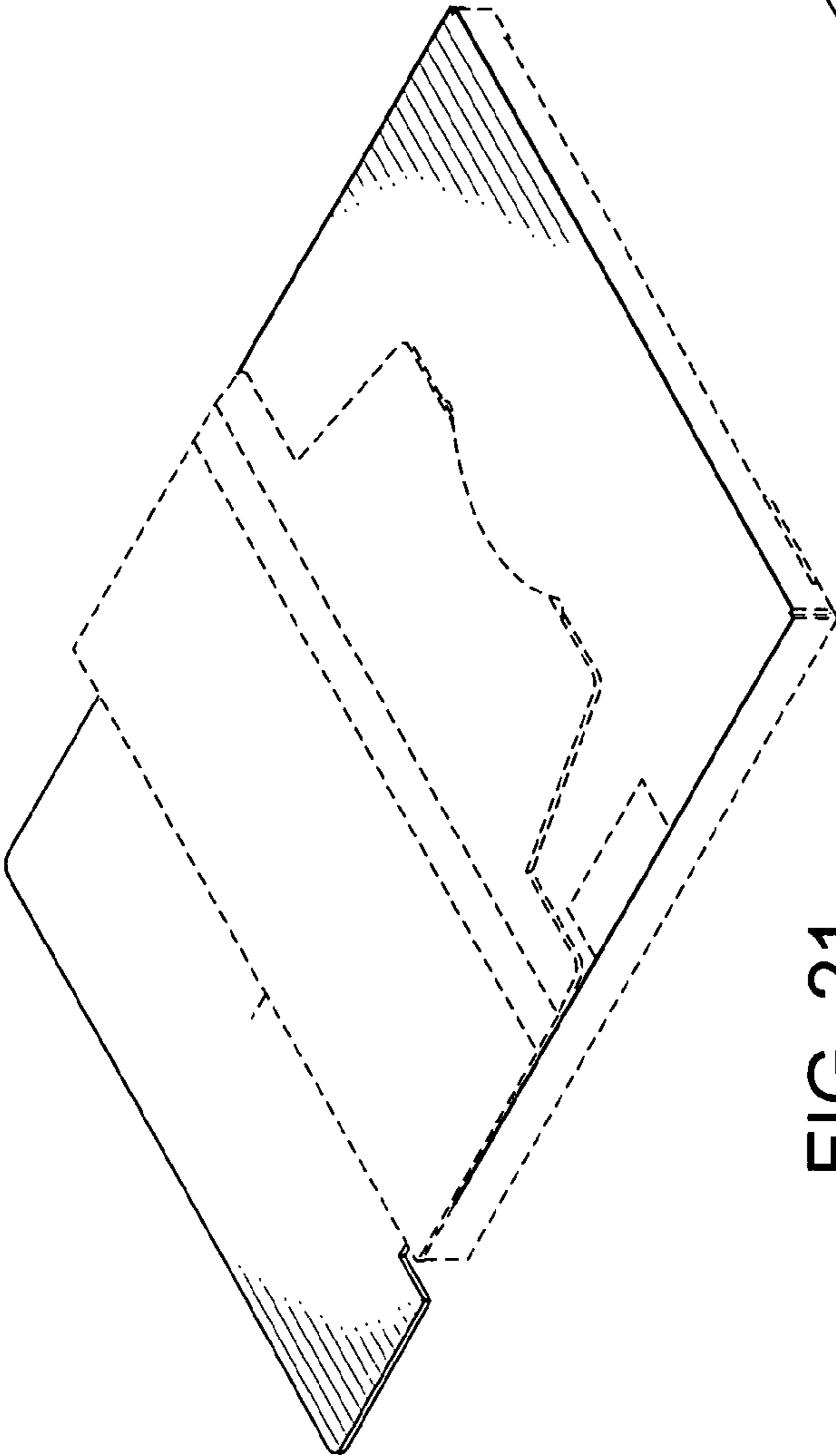

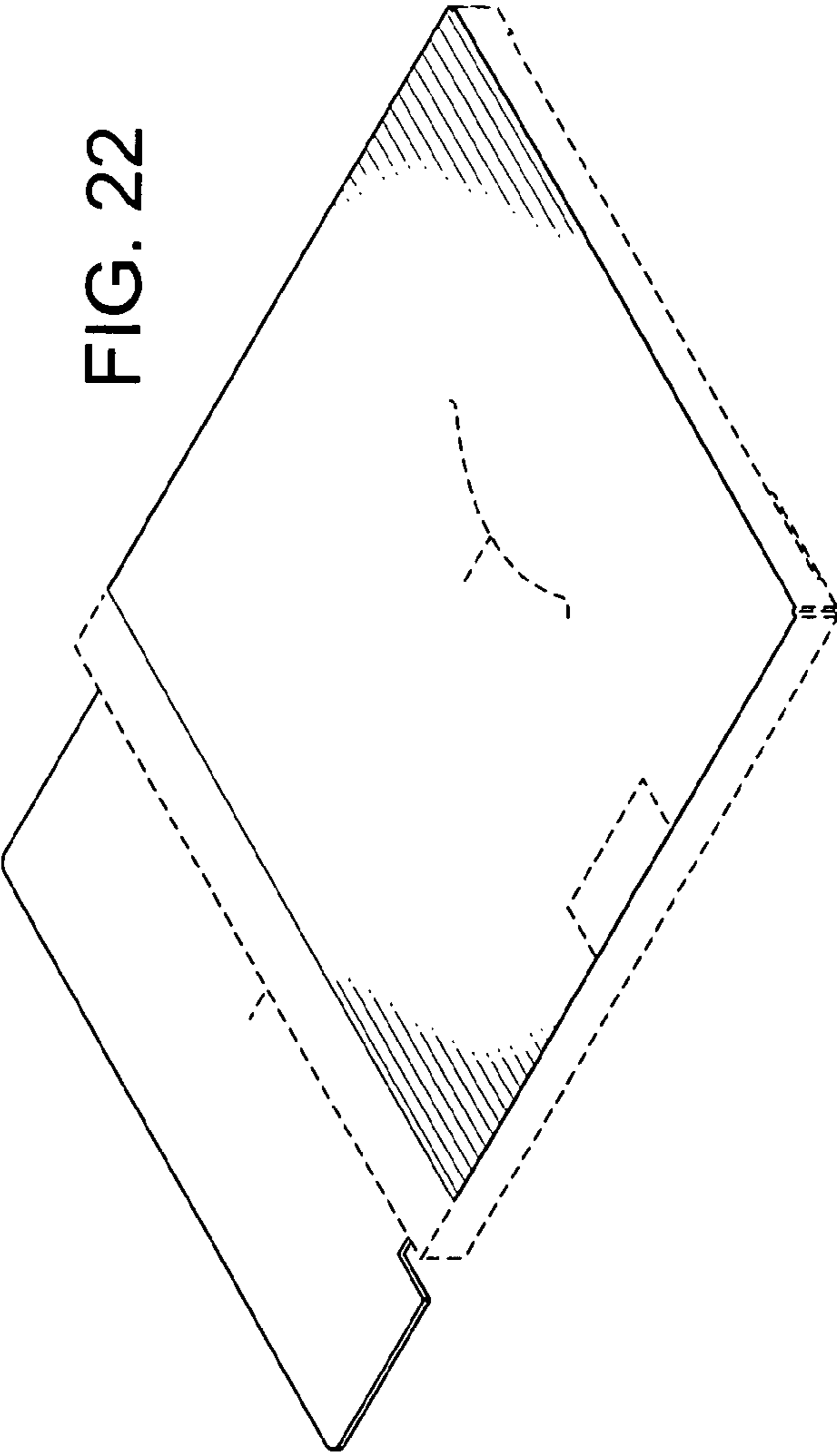
