FIG. 4 is a photograph showing a left side view of the panel;

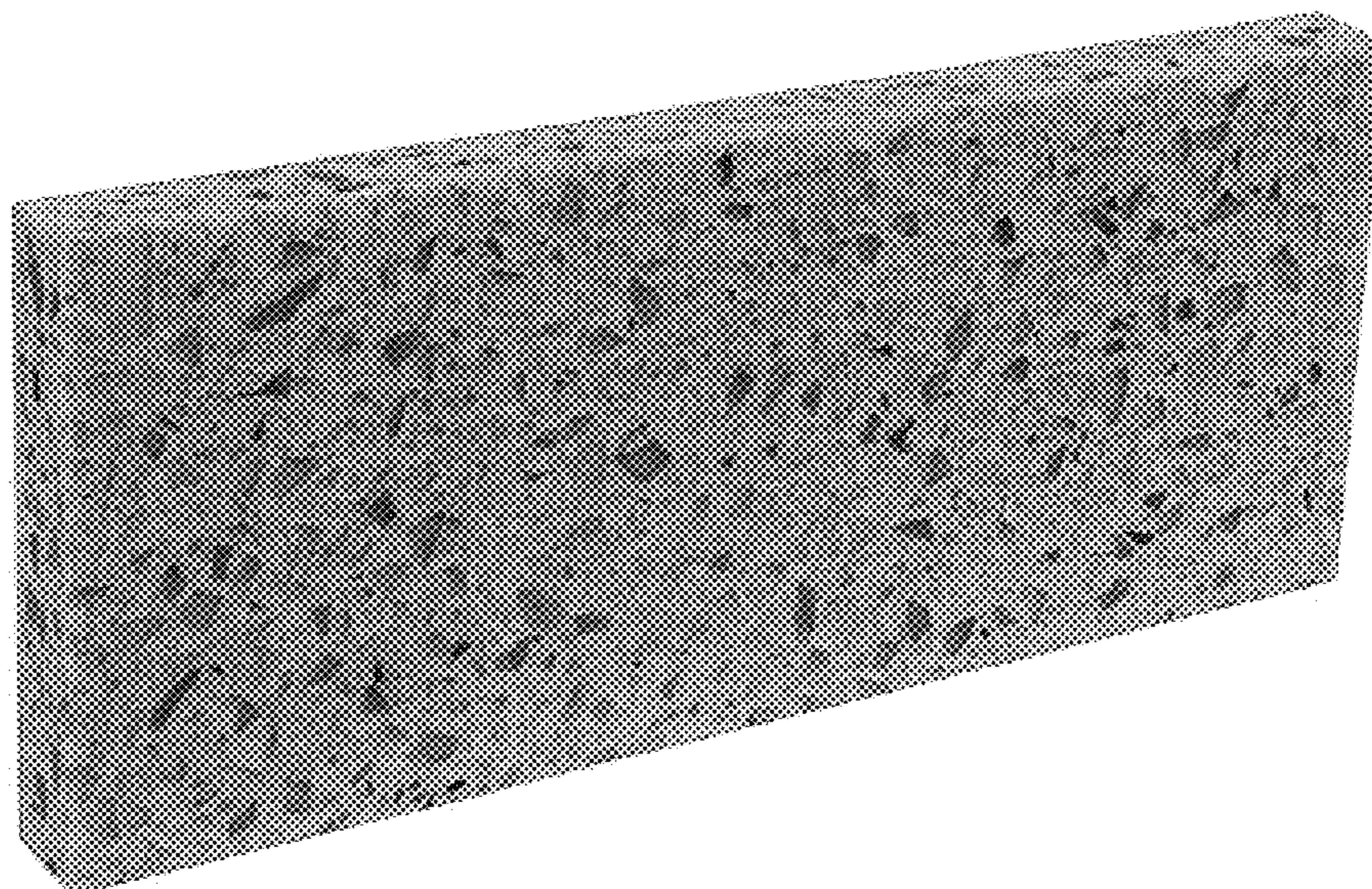
FIG. 5 is a photograph showing a right side view of the panel;

FIG. 6 is a photograph showing a top plan view of the panel;

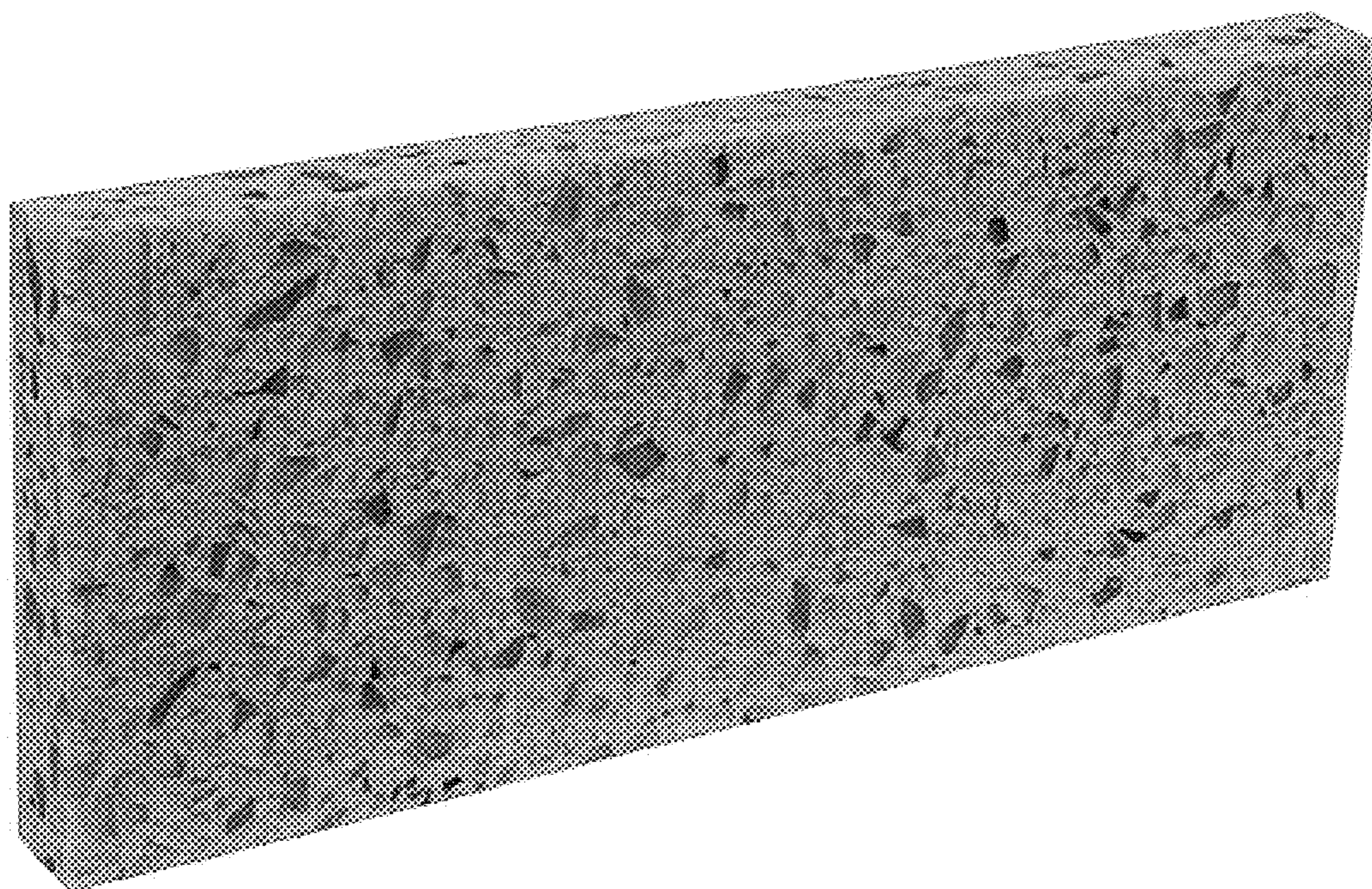
FIG. 7 is a photograph showing a bottom plan view of the panel; and,

FIG. 8 is a photograph showing an enlarged perspective view of a portion of the panel shown in the photograph of FIG. 1.

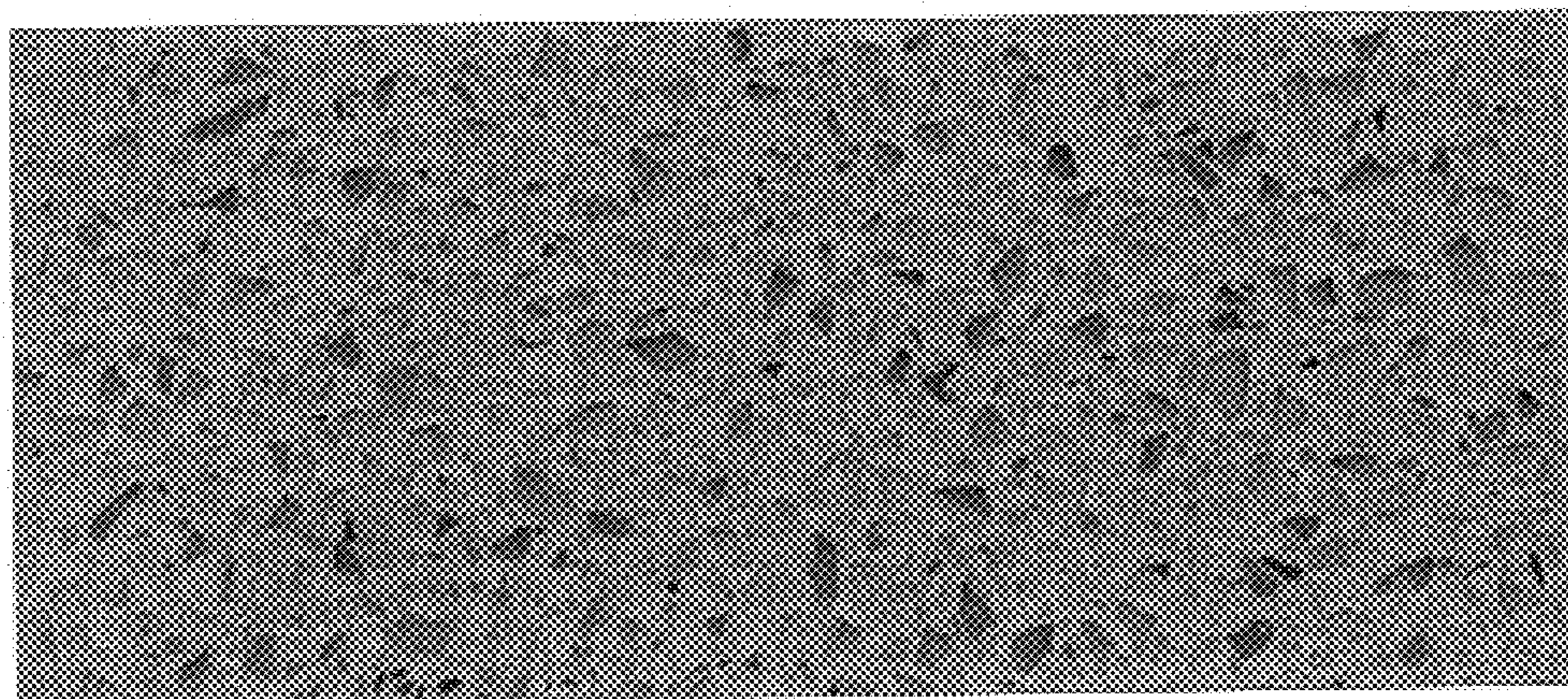

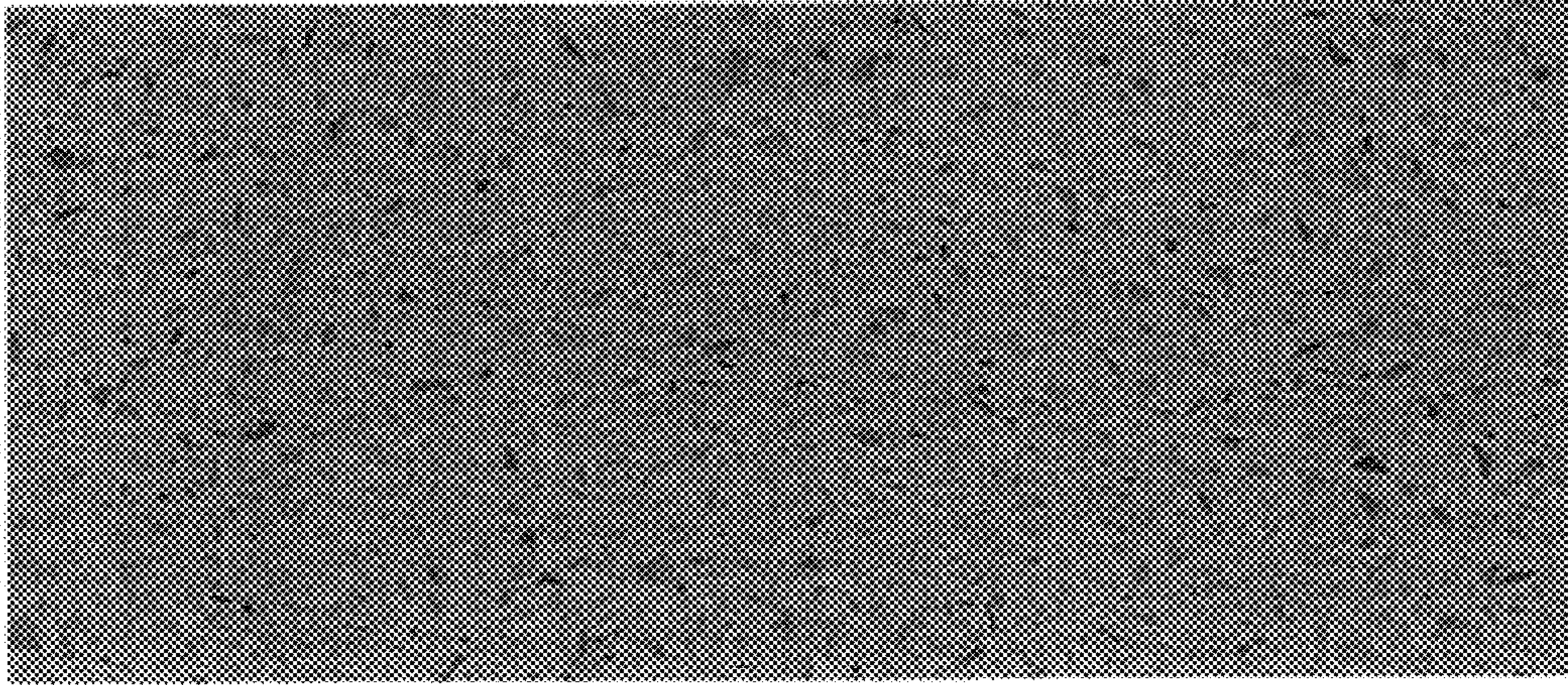

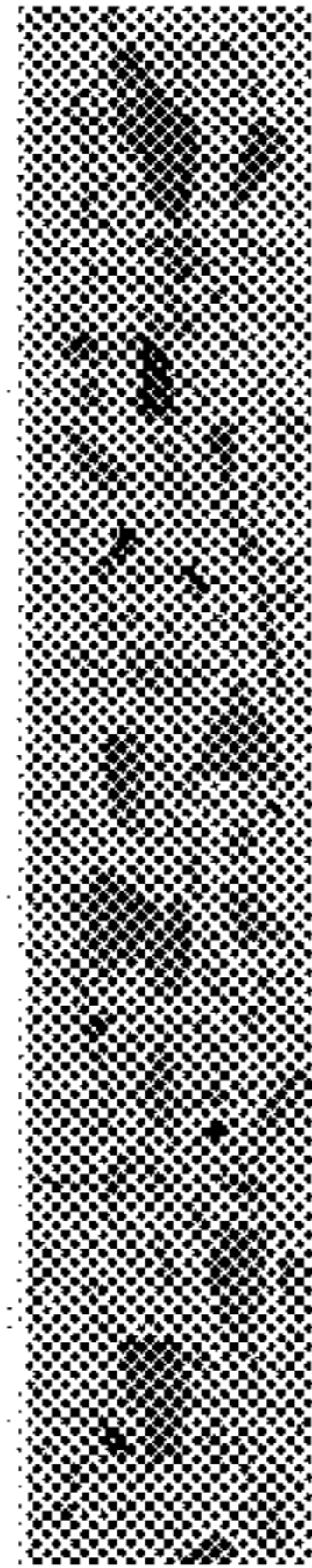
