FIG. 2 is a rear elevational view thereof;

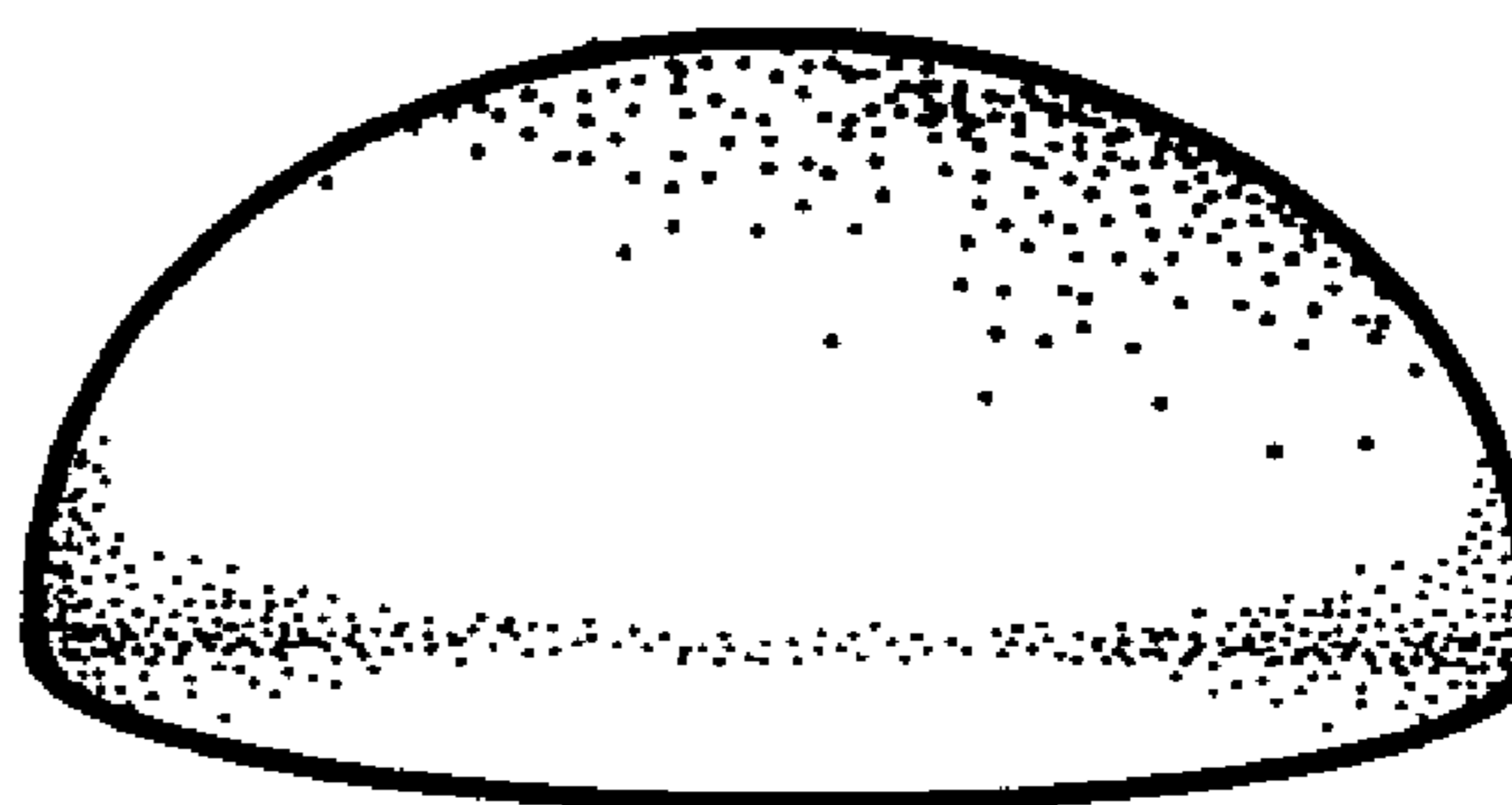
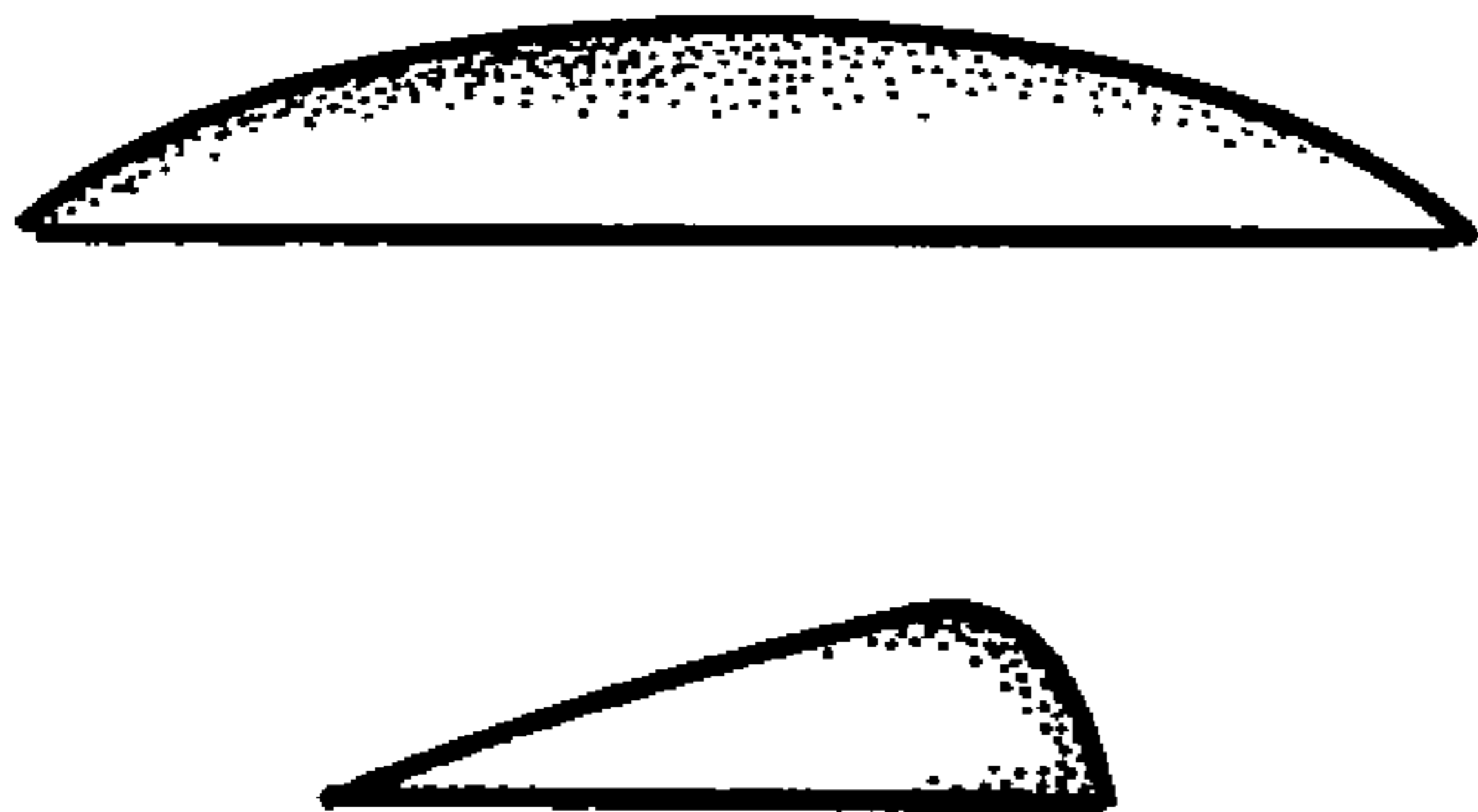
FIG. 3 is a right side view thereof, the left side view being the mirror image thereof;

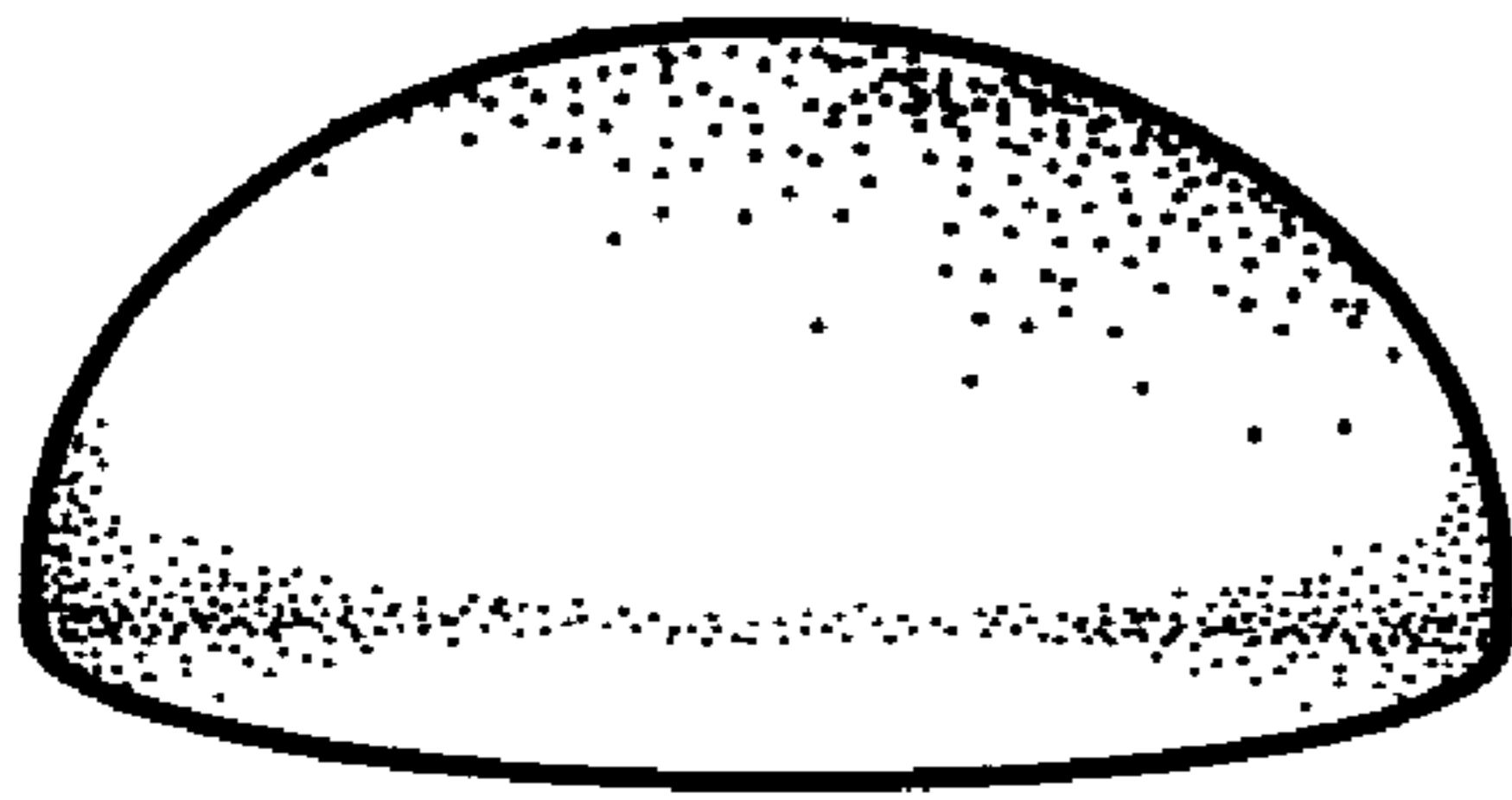

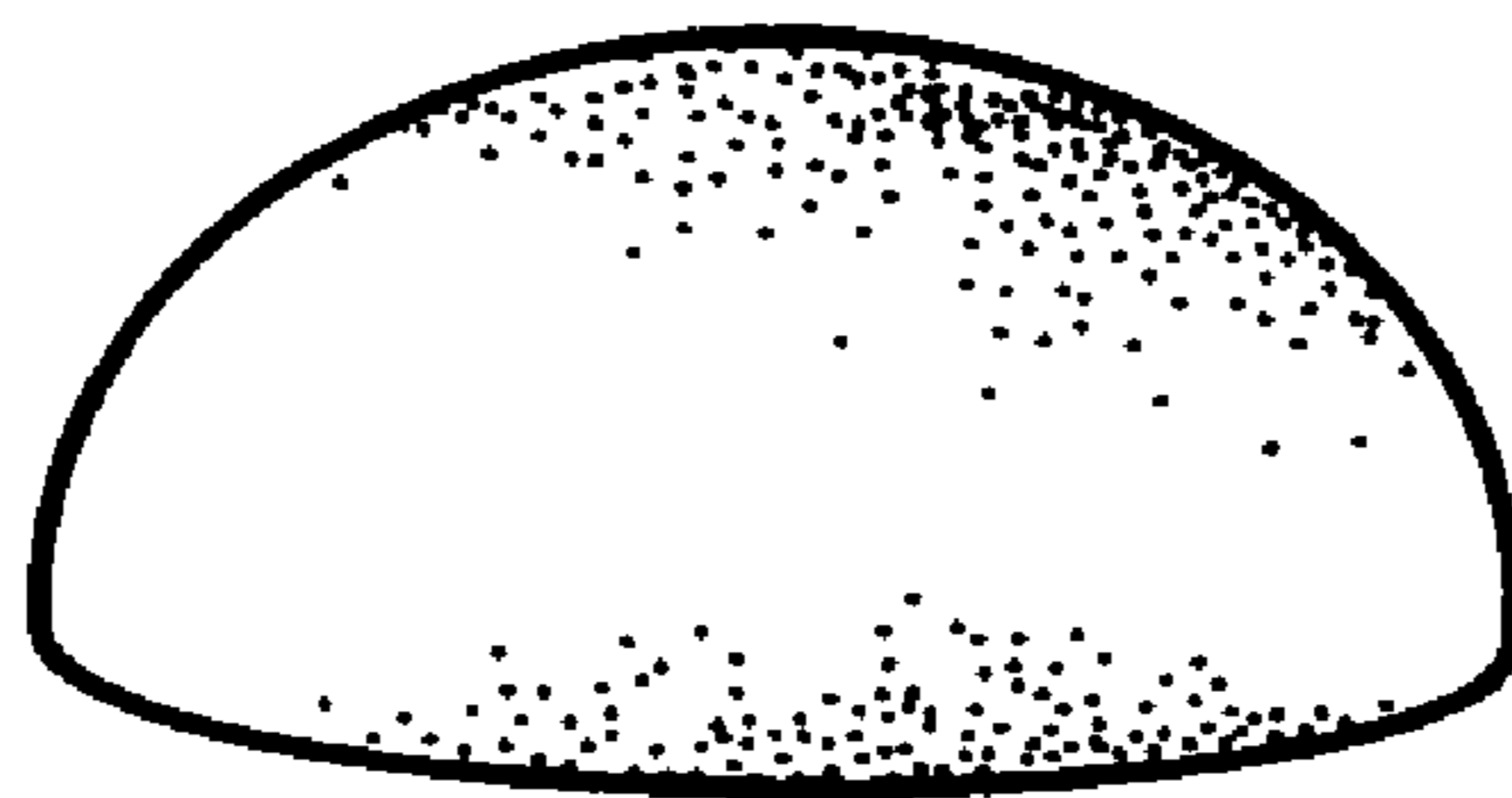

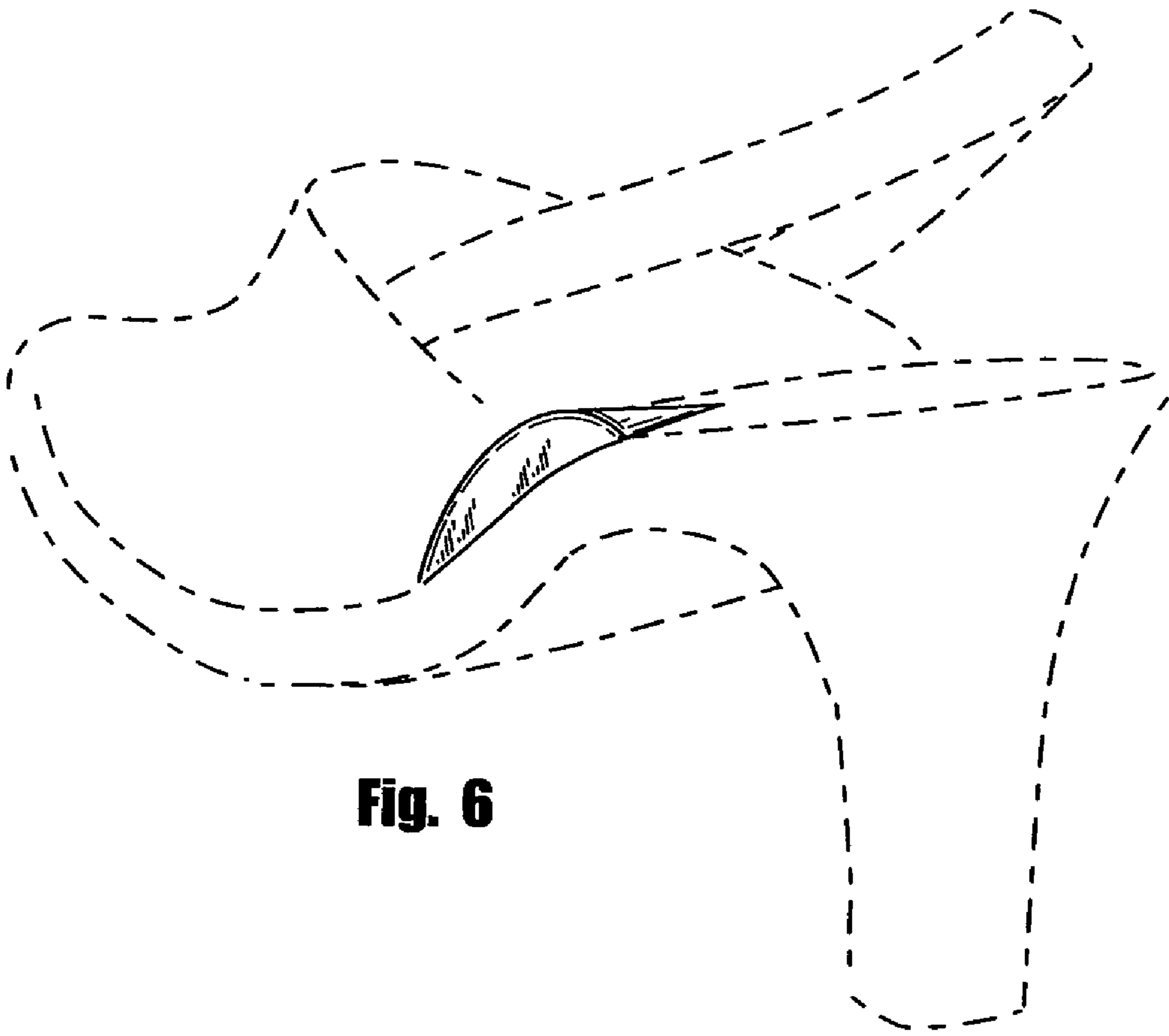
