The ornamental design for a golf shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a golf shoe upper showing our new design;

FIG. 2 is a rear elevational view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a top plan view thereof;

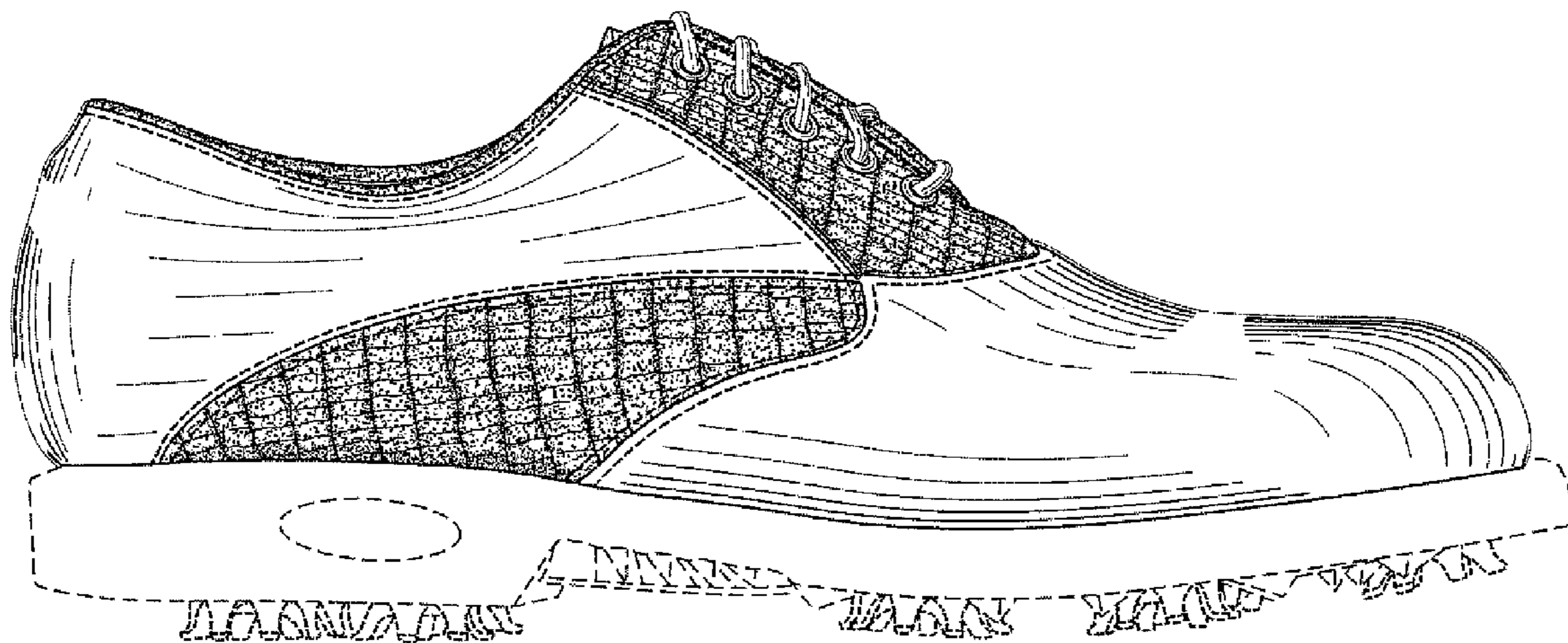
FIG. 5 is a left side elevational view thereof;

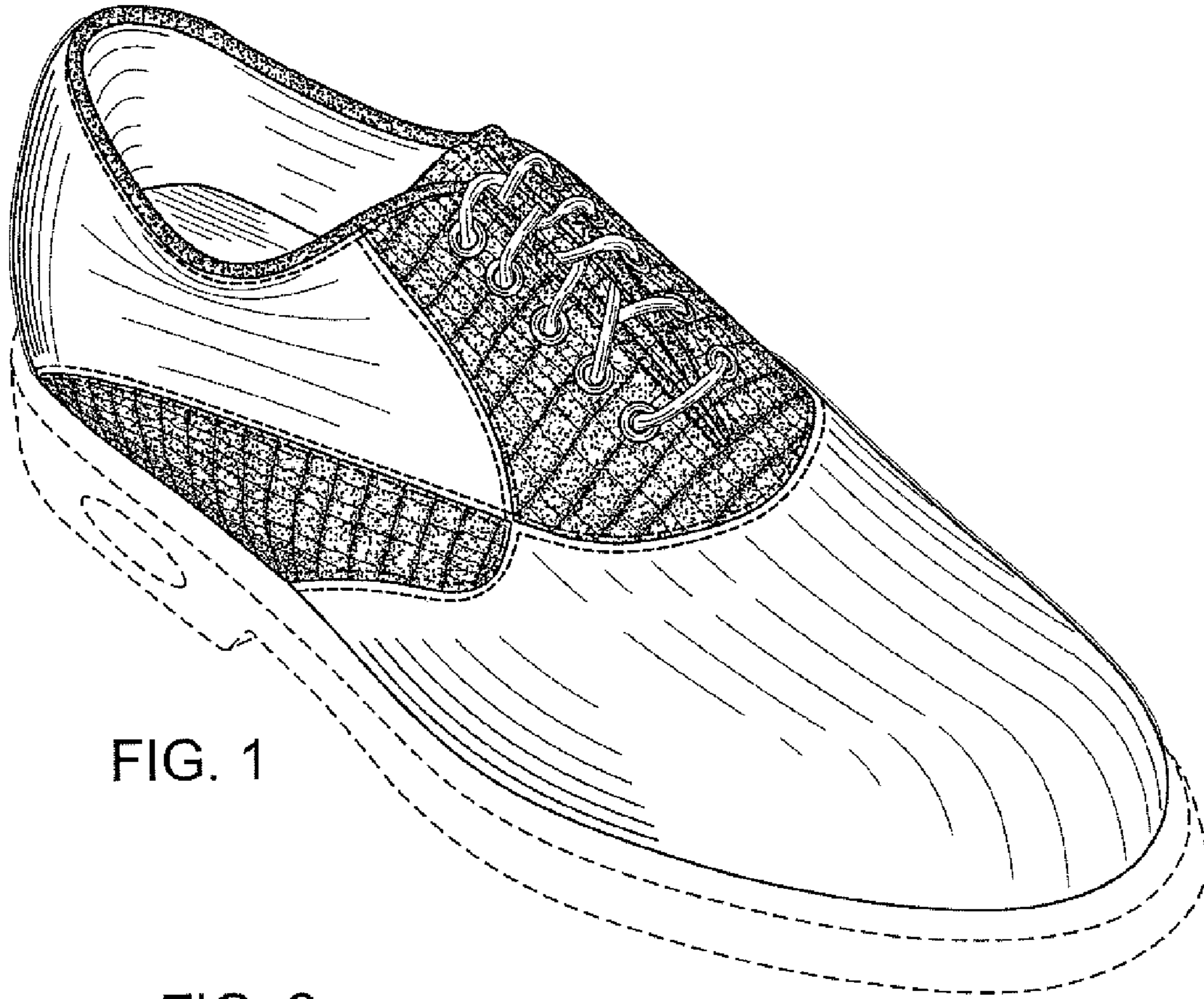

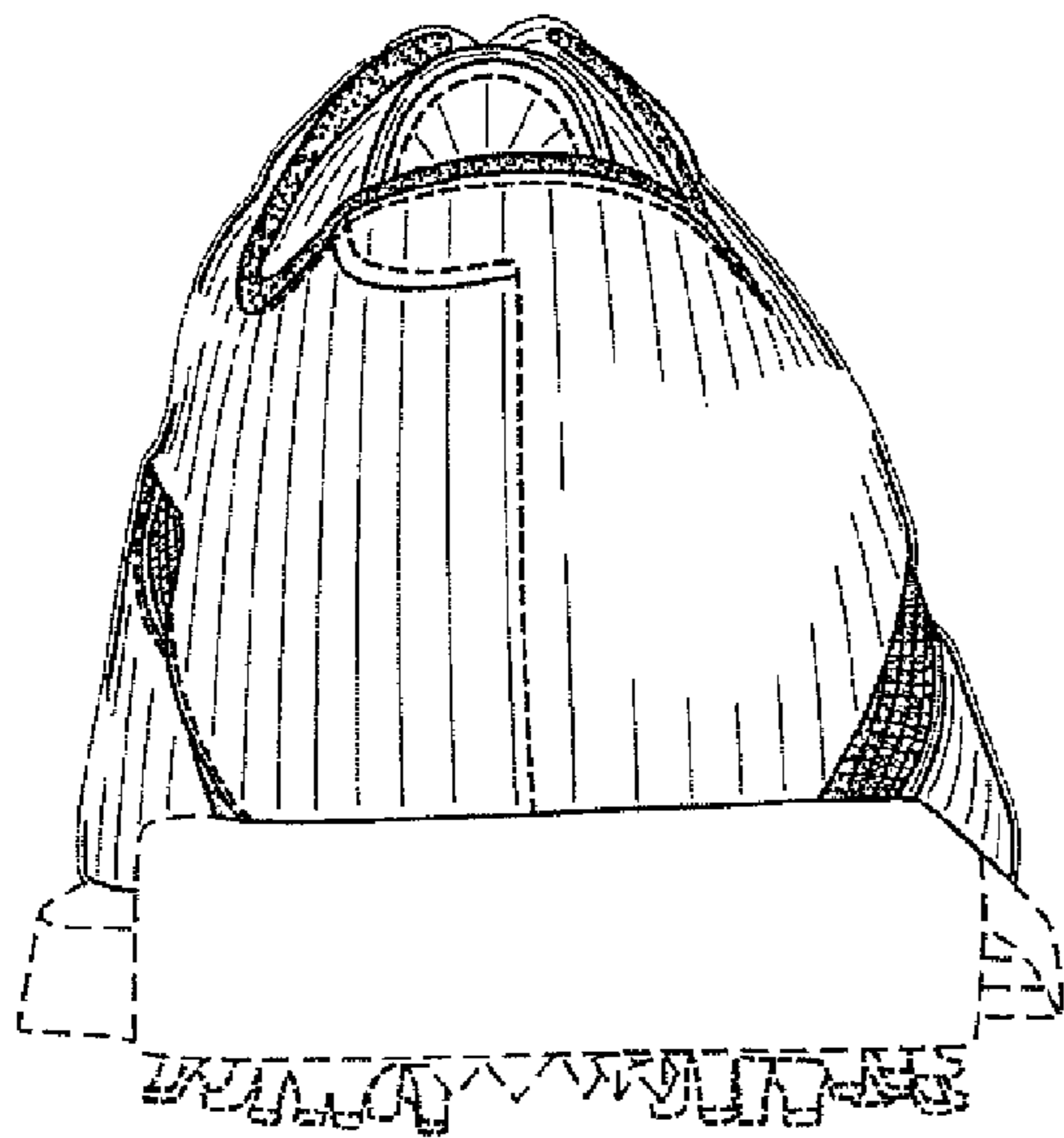
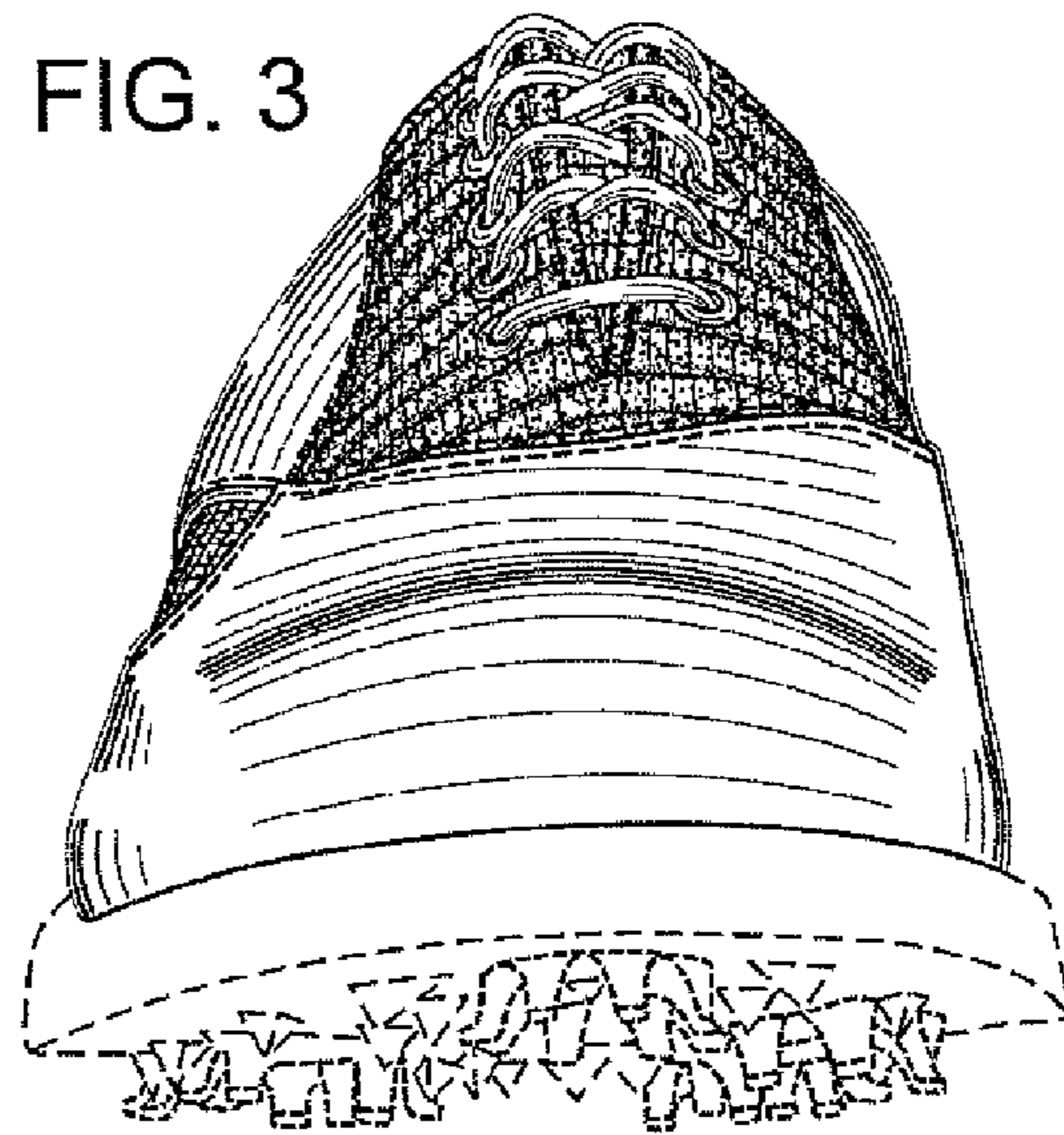

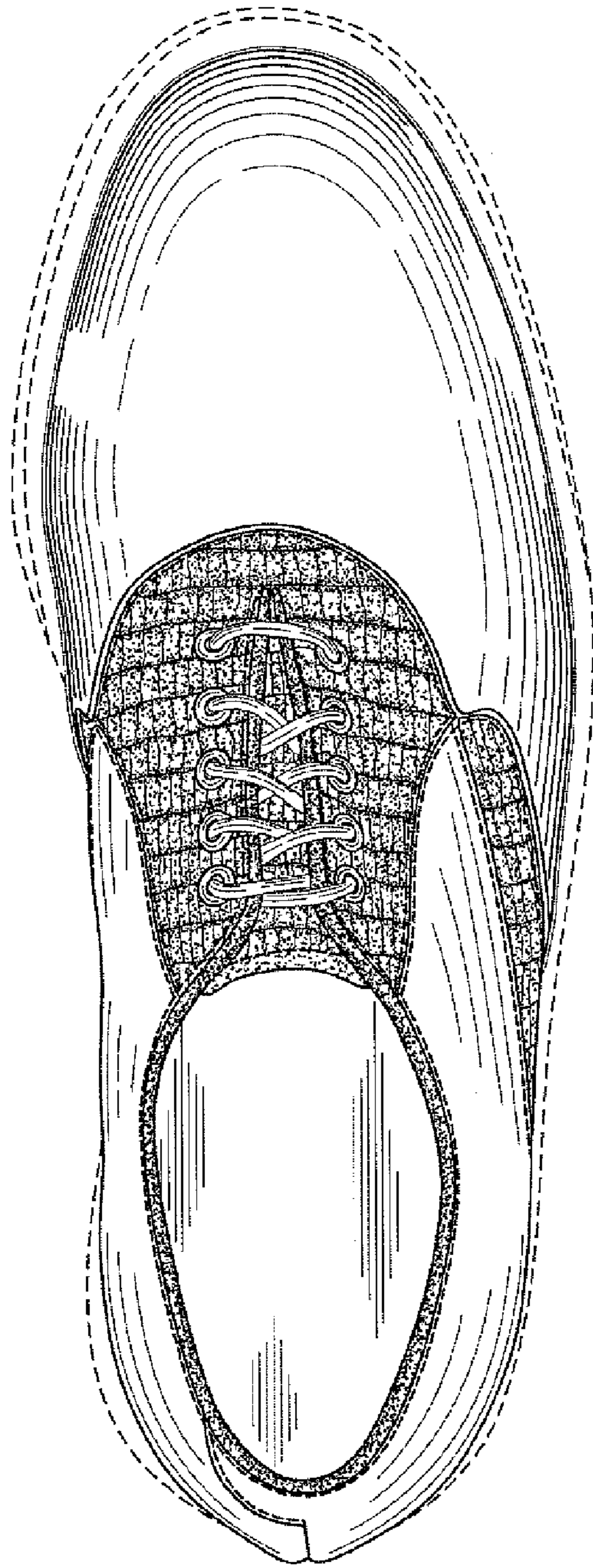

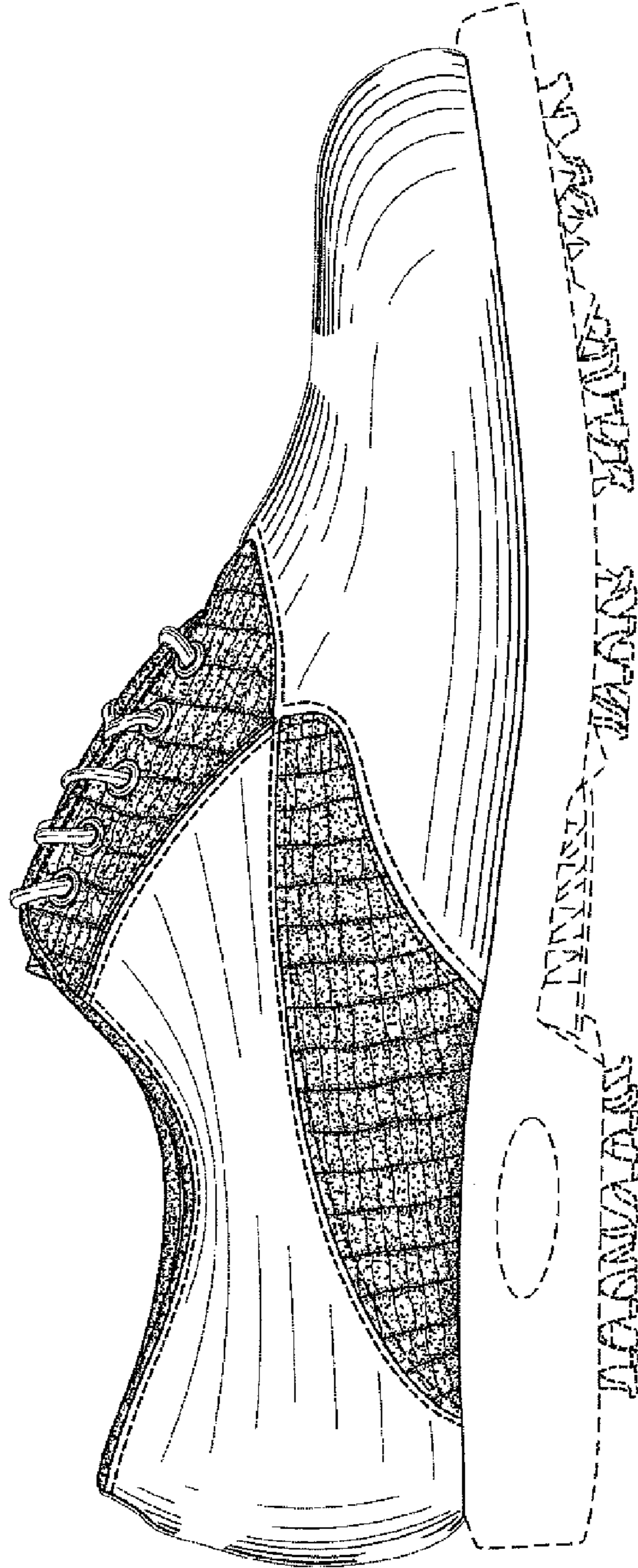

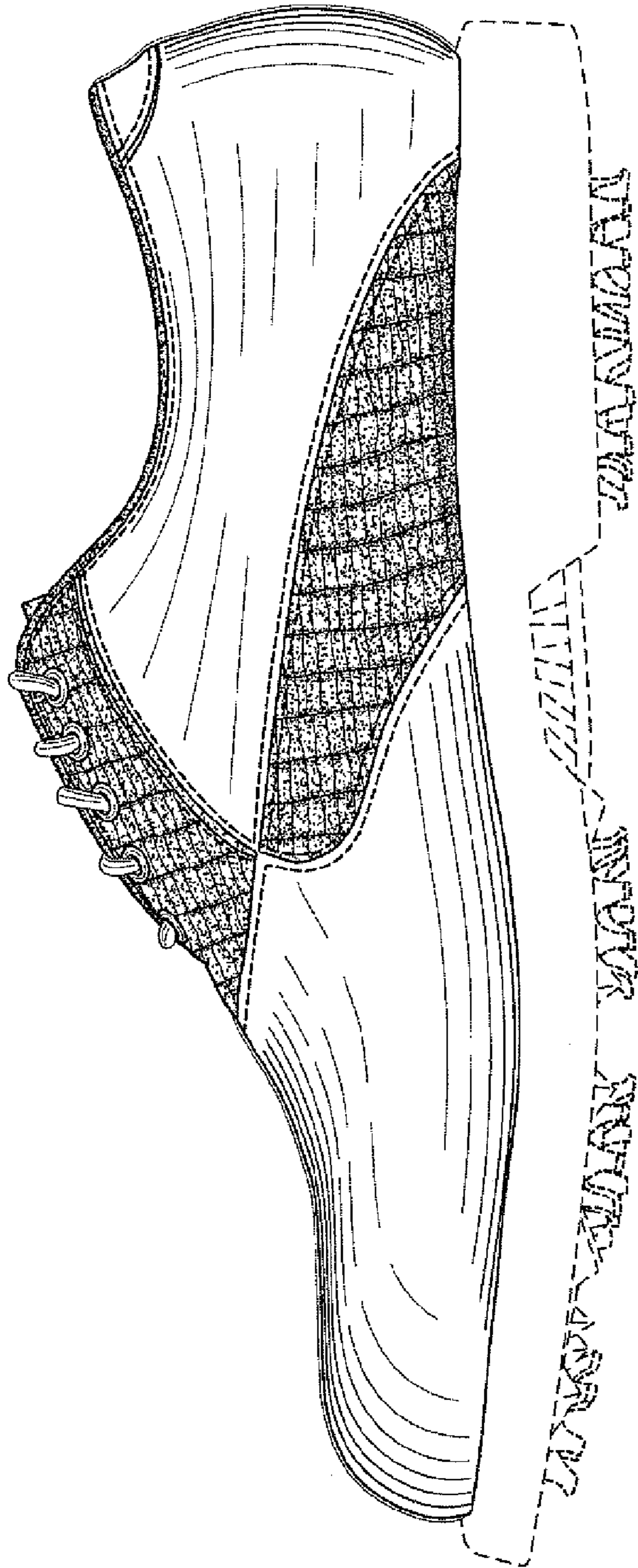

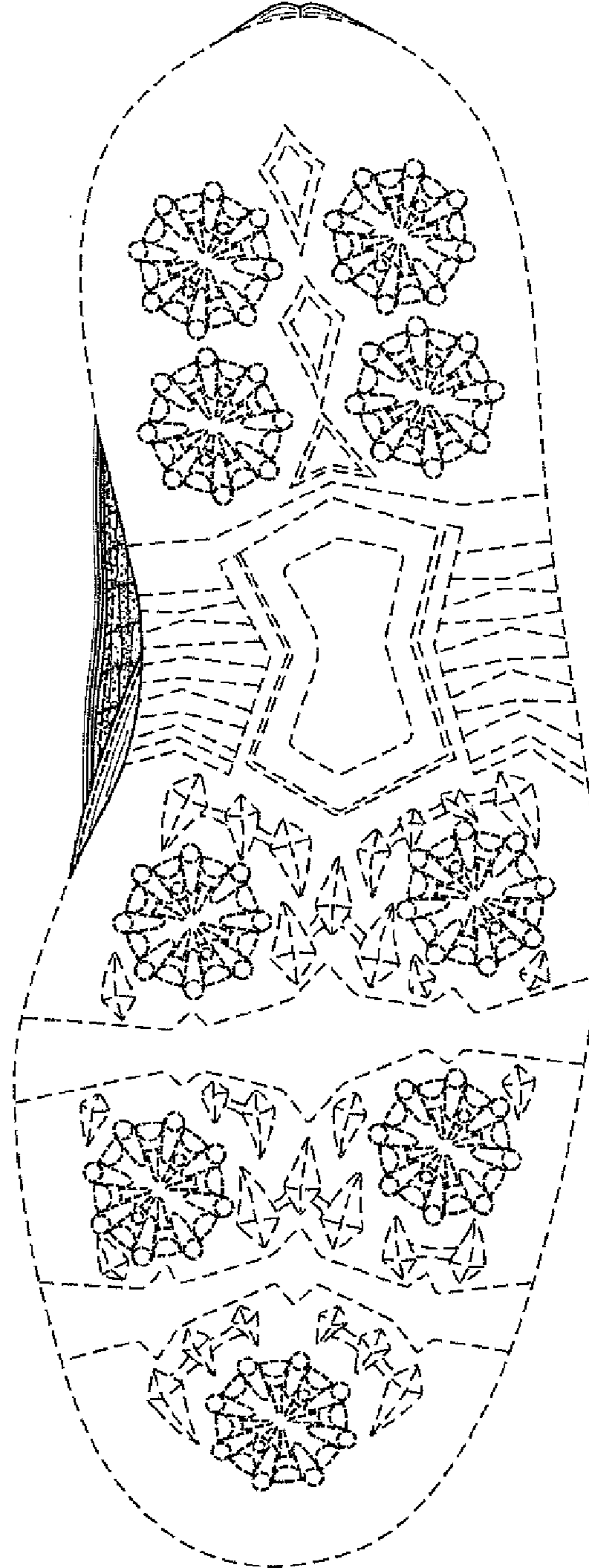
