The ornamental design for a portion of a shoe upper, as shown and described.

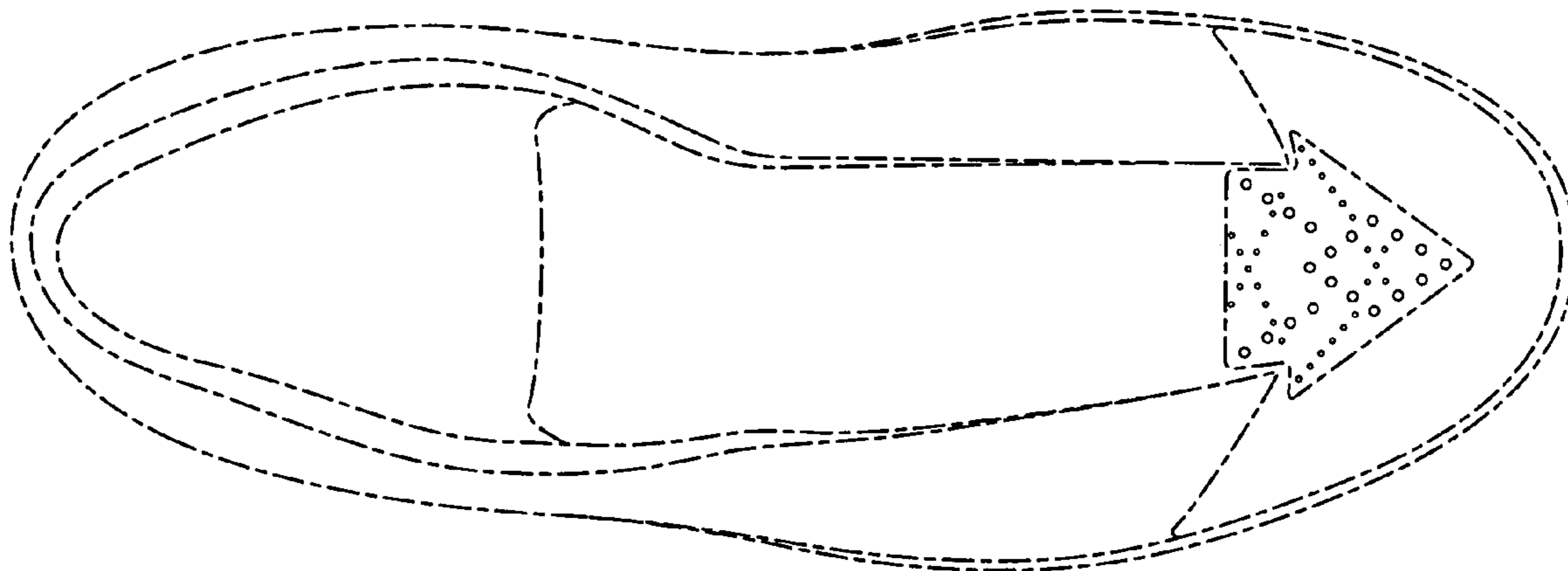
DESCRIPTION

FIG. 1 is a front perspective view of a portion of a shoe upper showing our new design; and,

FIG. 2 is a top view thereof.

The broken line showing immediately adjacent to the shaded area represents an unclaimed boundary of the design. The broken line showing of the remainder of the shoe is for illustrative purposes only and forms no part of the claimed design.

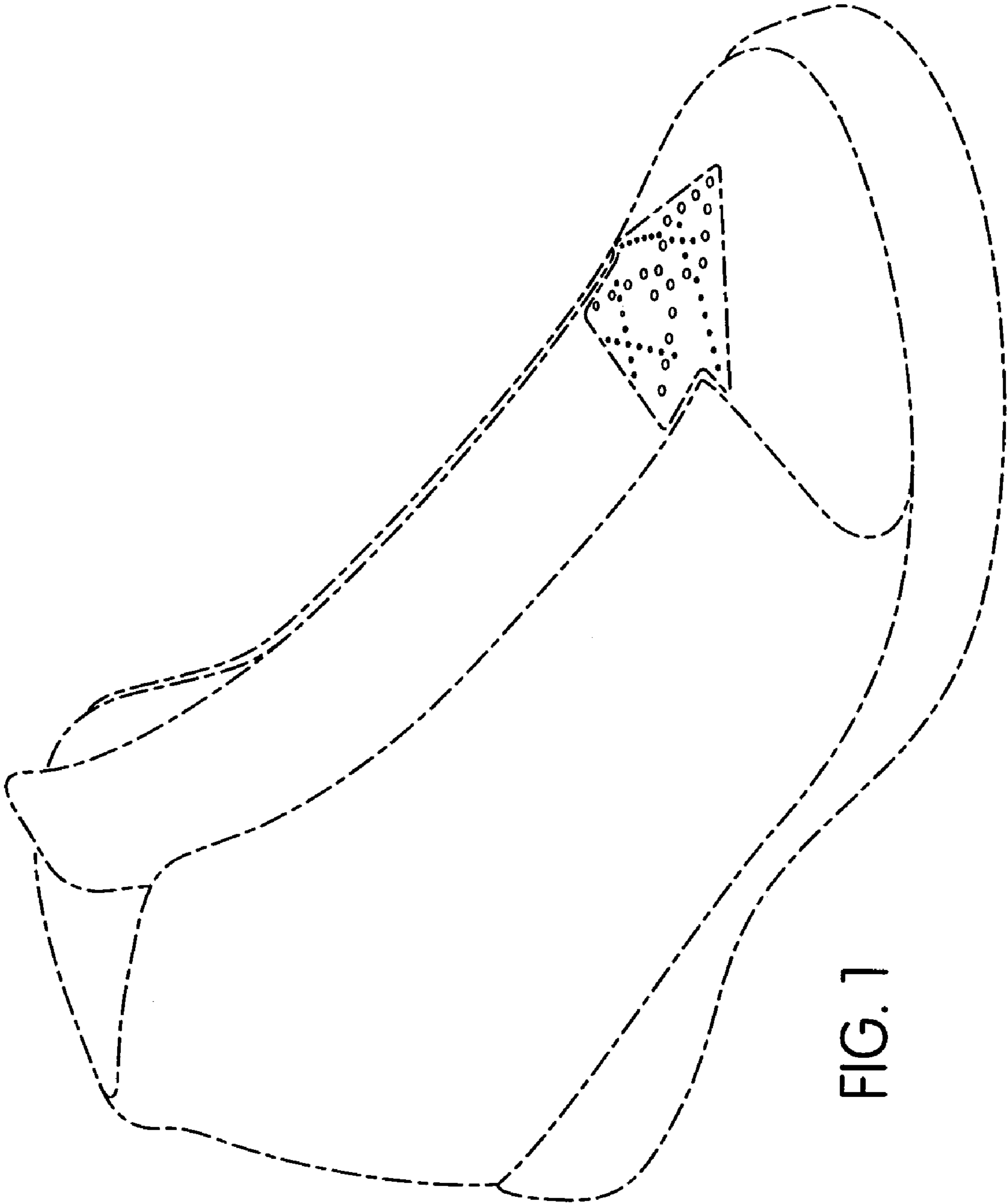

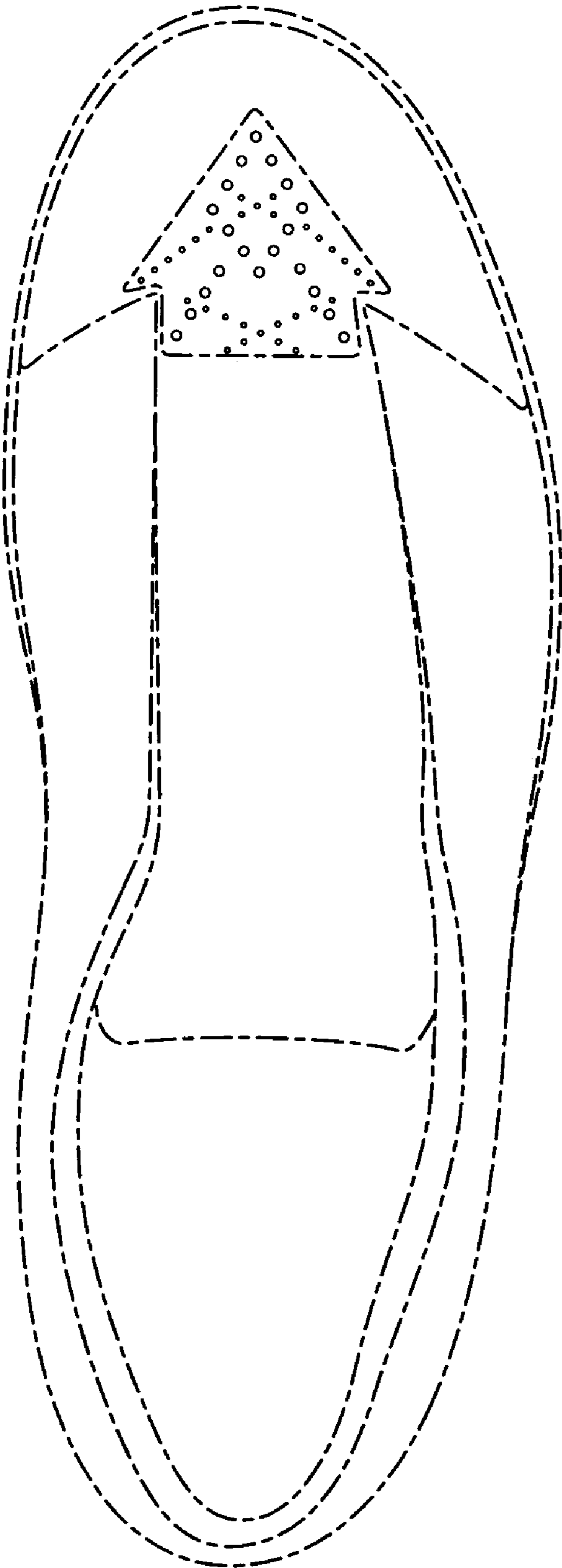
