The ornamental design for an automotive center console arm rest cover, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and left-side perspective view of an automotive center console arm rest cover embodying my new design;

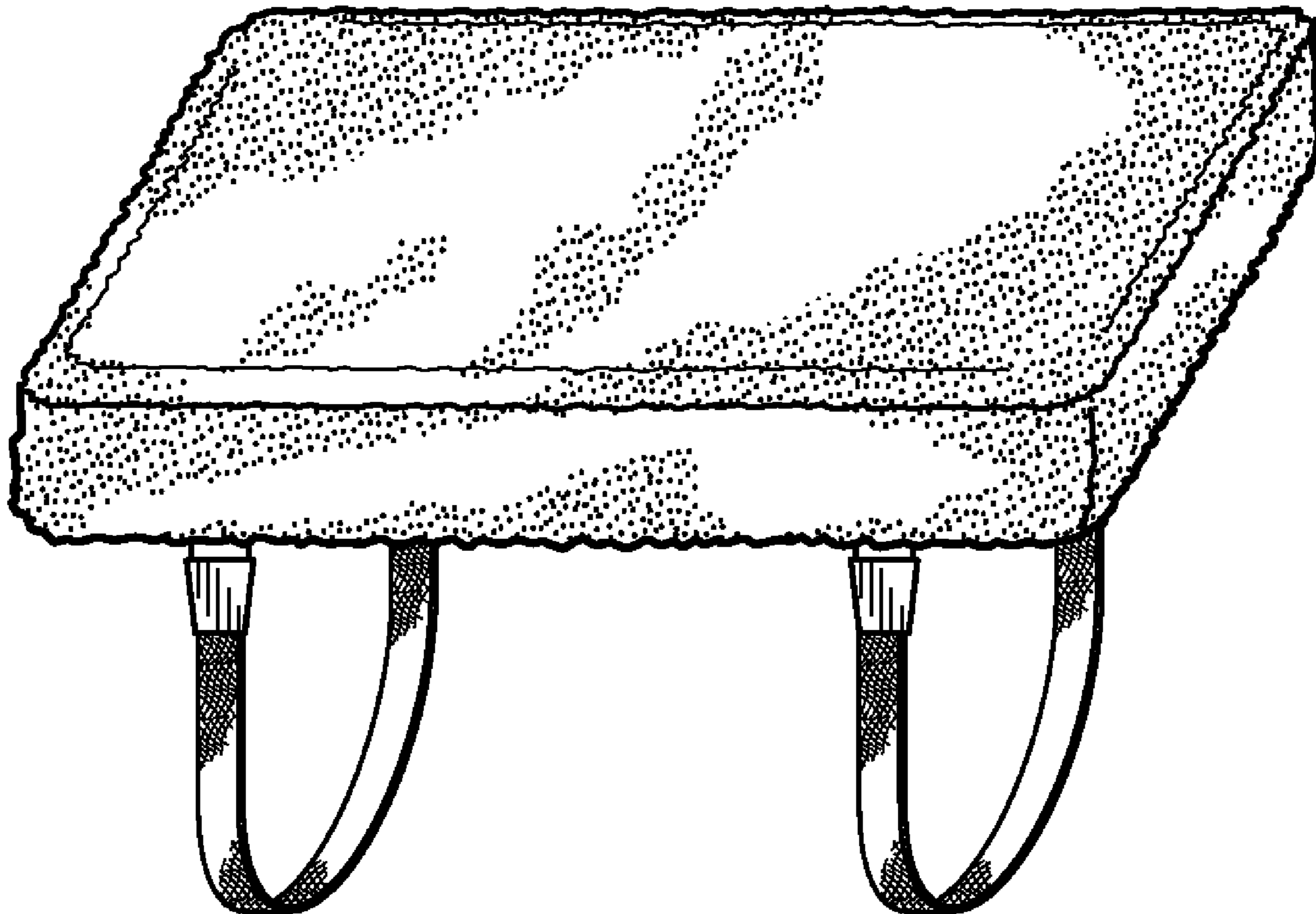
FIG. 2 is a rear elevational view thereof, the front elevational view being a mirror image;

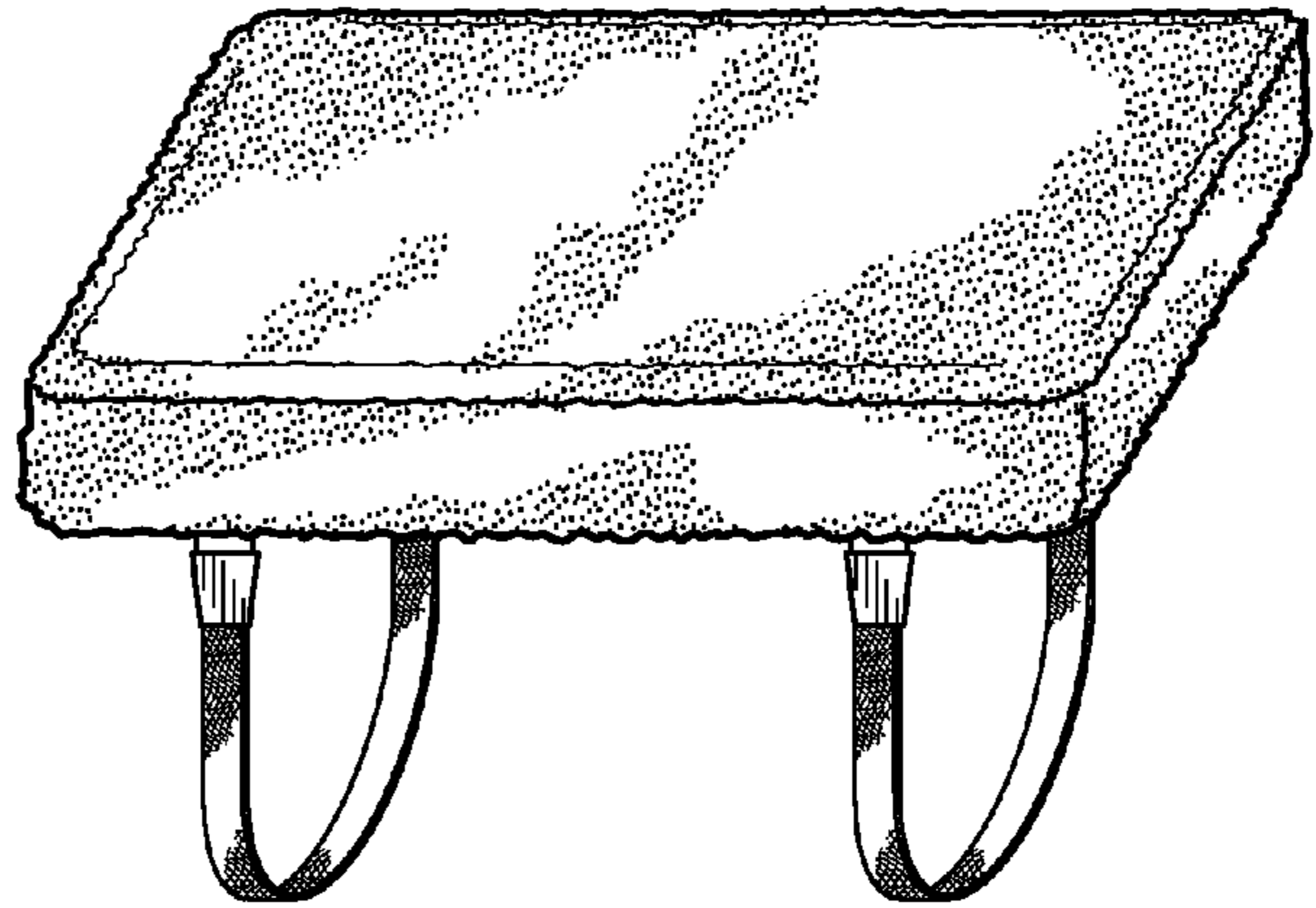

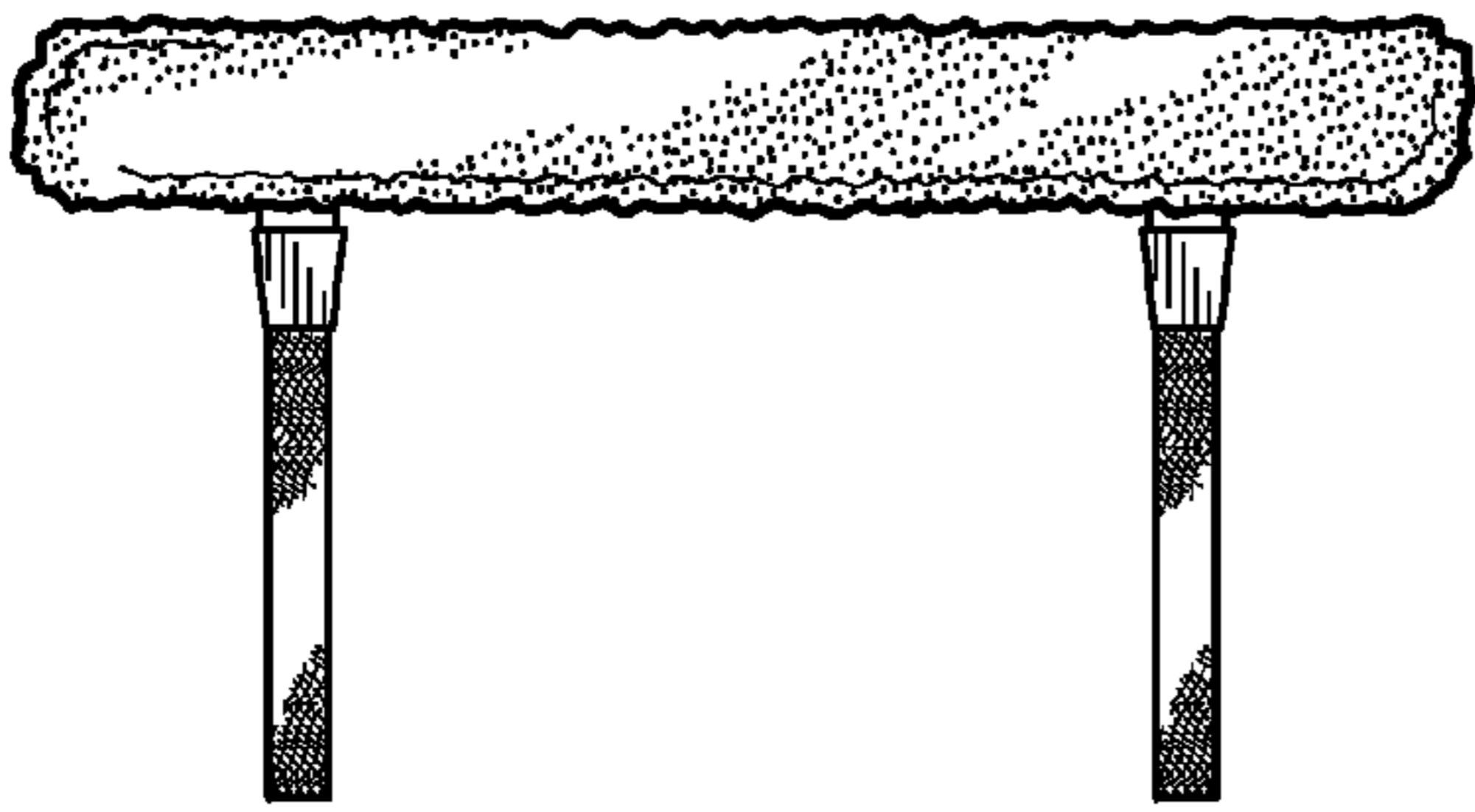

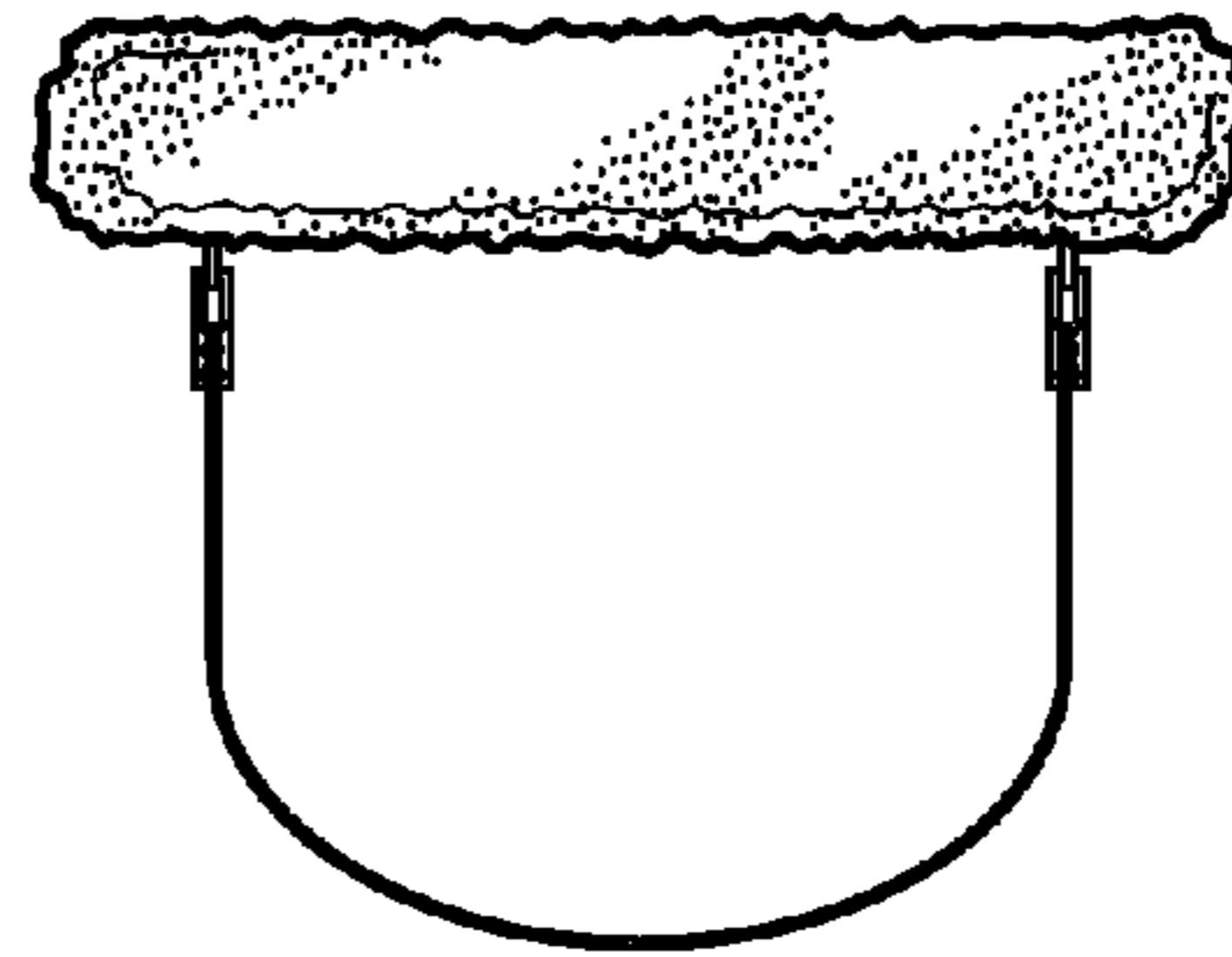

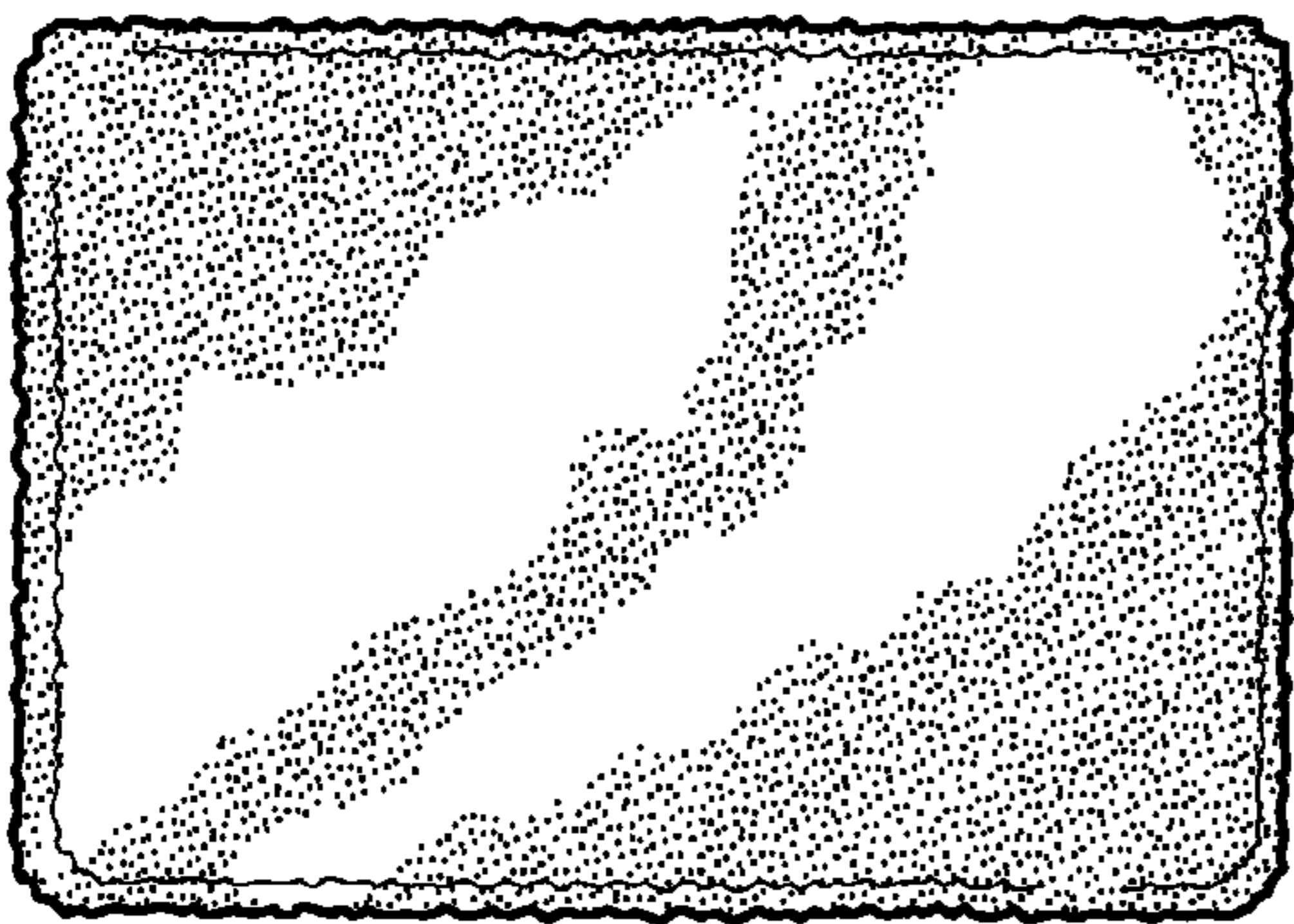

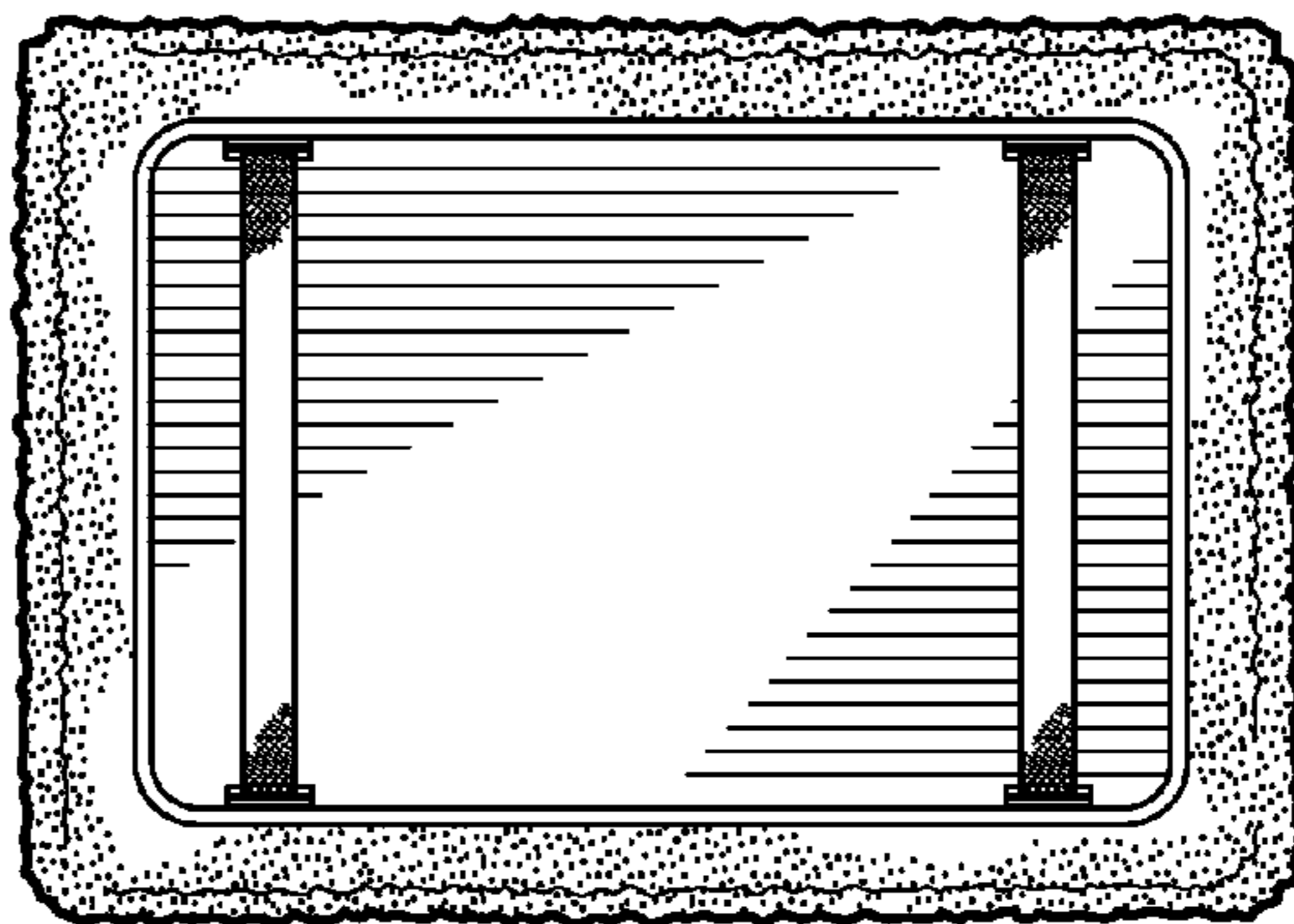
