FIG. 2 is a front view of the support bail of FIG. 1.

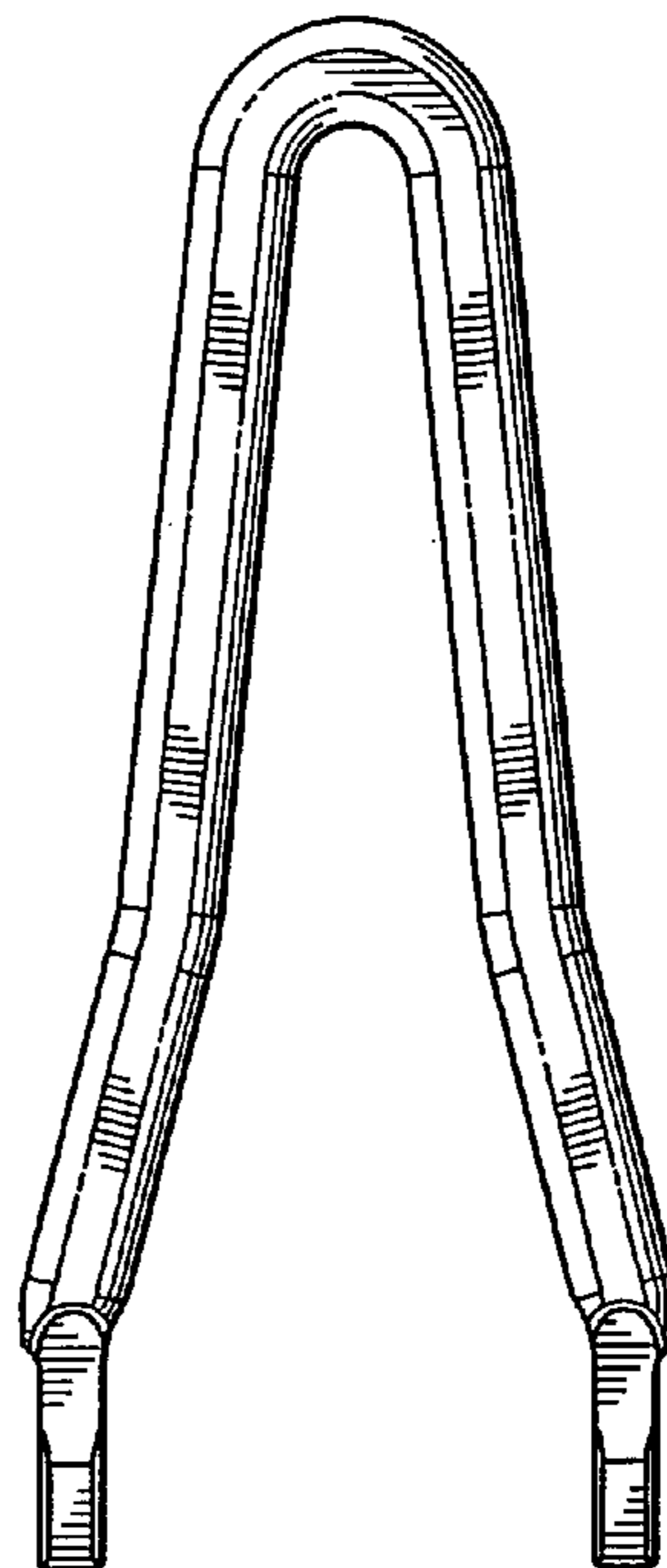
FIG. 3 is a side view of the support bail of FIG. 1 opposite the side of FIG. 1.

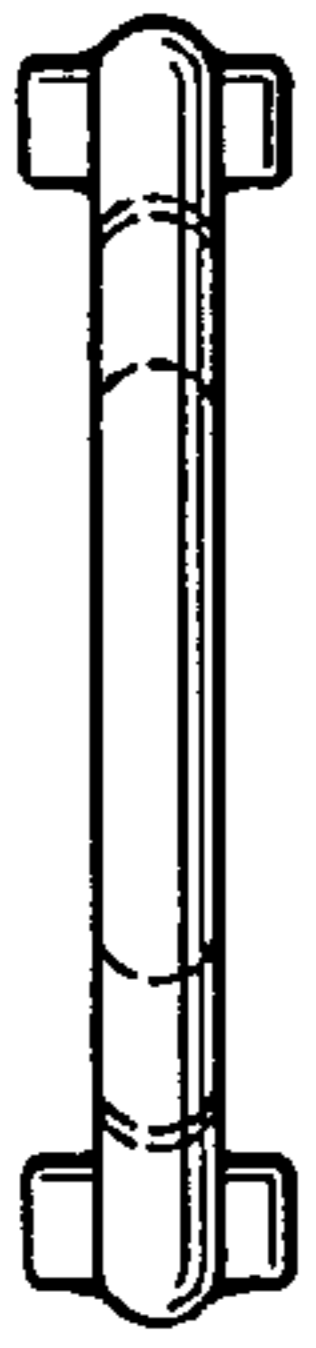

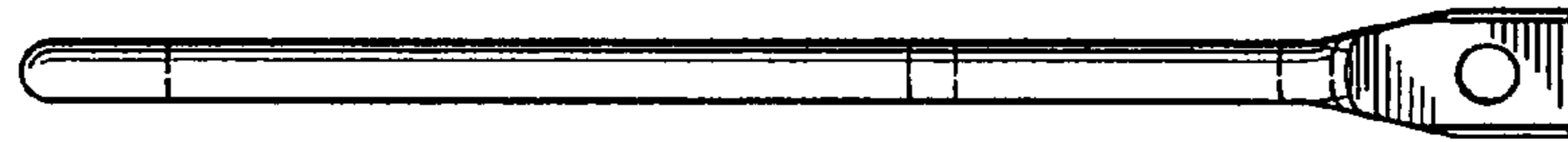

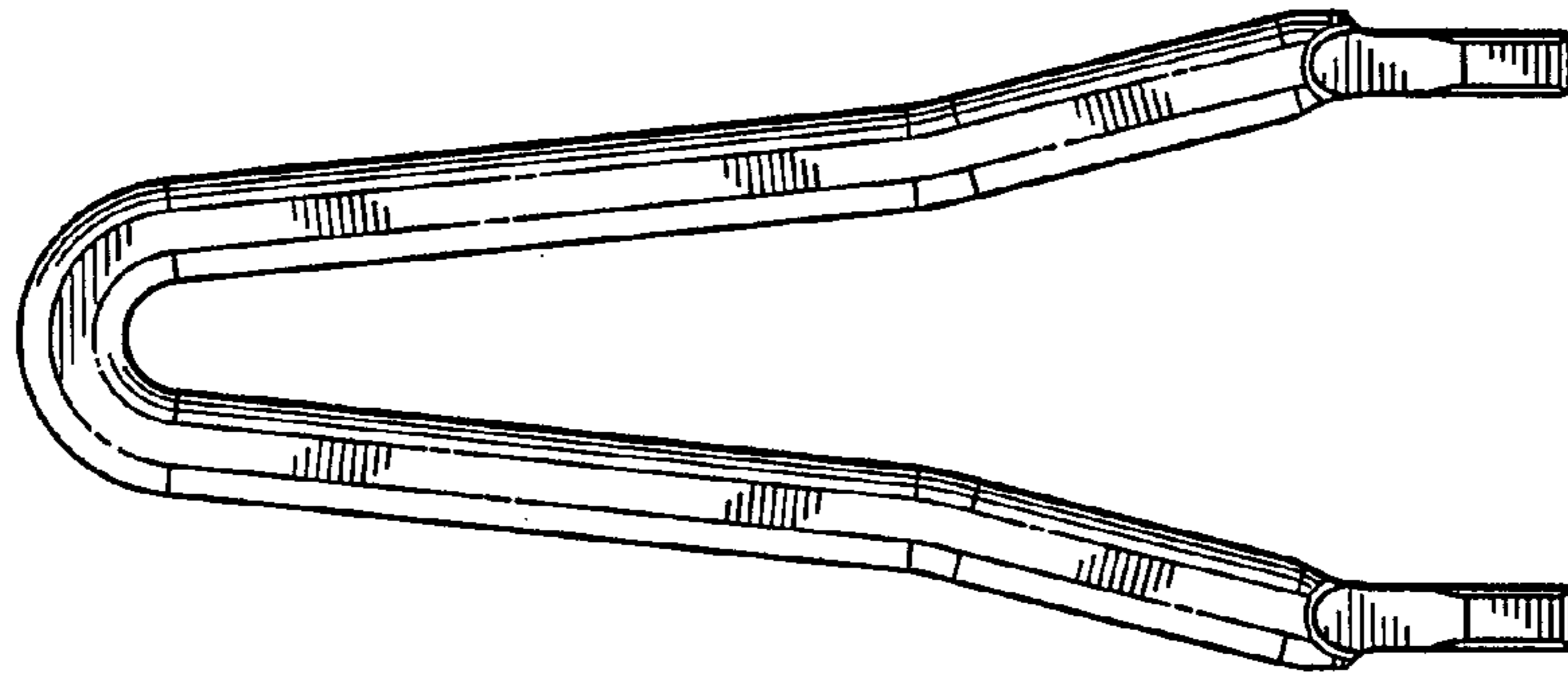

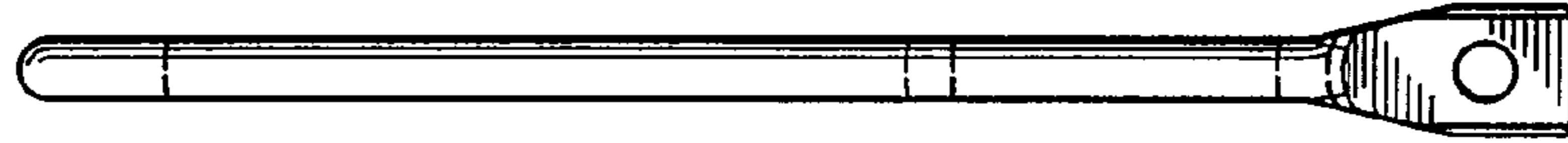

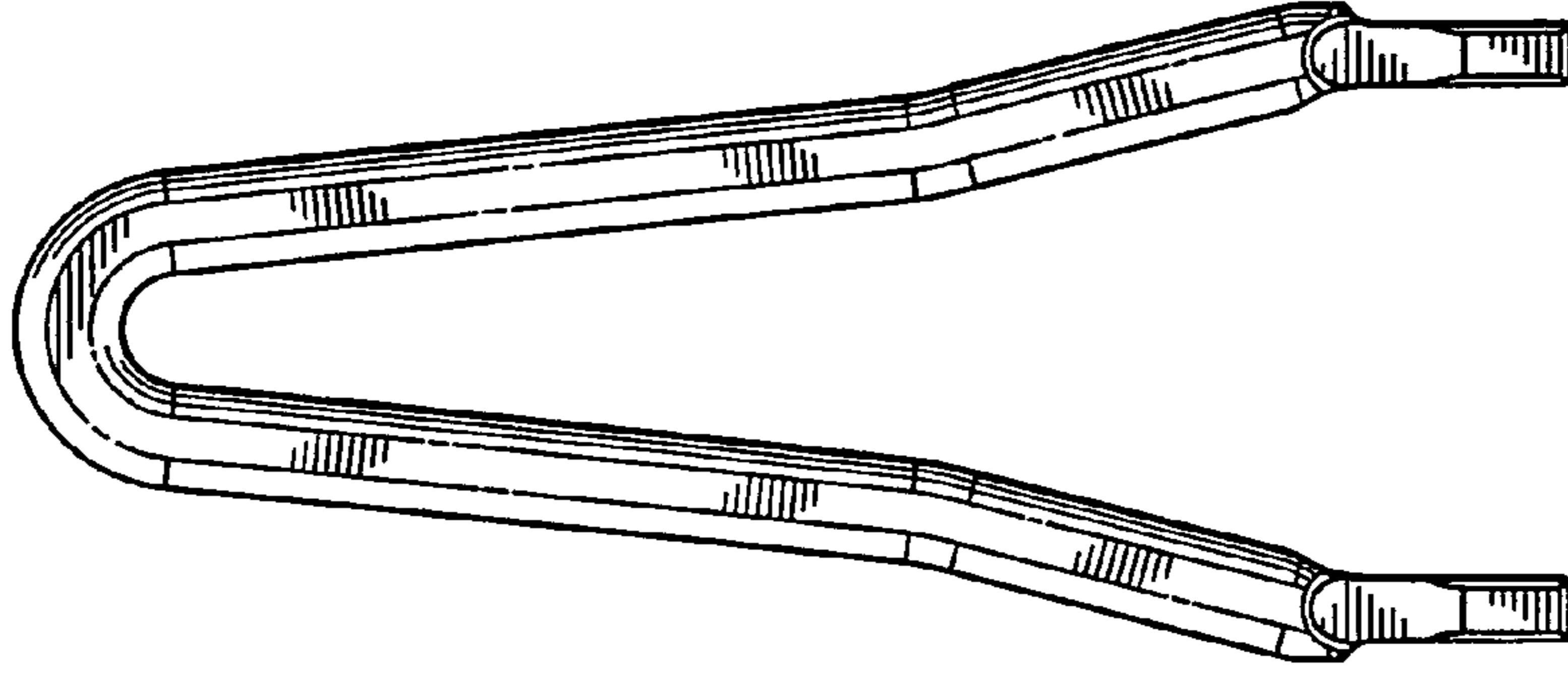

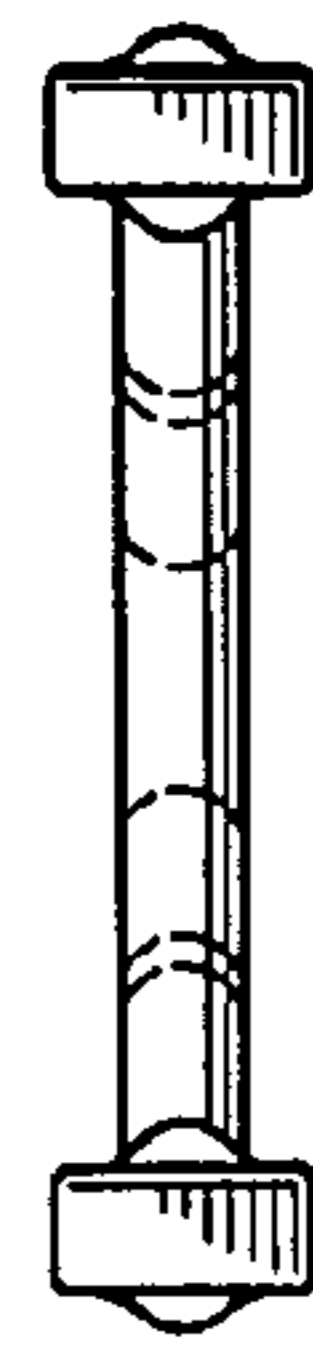
