(57) **CLAIM**

The ornamental design for a combination coat and backpack hook, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a combination coat and backpack hook embodying my design;

FIG. 2 is a front elevational view of the combination coat and backpack hook shown in FIG. 1;

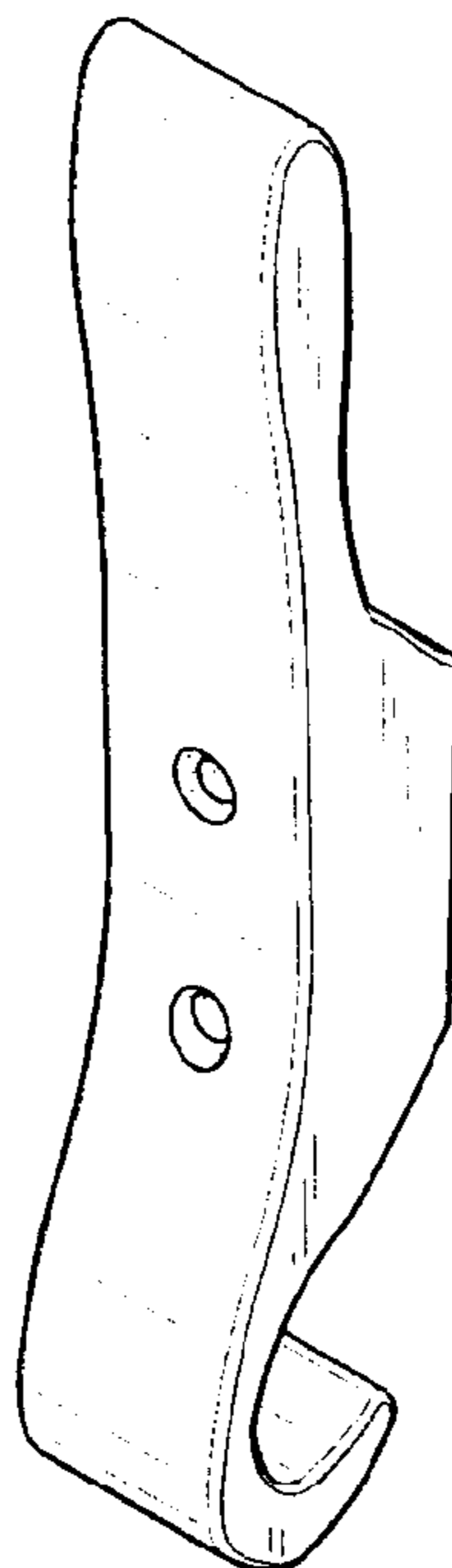
FIG. 3 is a top plan view of the combination coat and backpack hook shown in FIG. 1;

FIG. 4 is a right side elevational view of the combination coat and backpack hook shown in FIG. 1, the left side elevational being a mirror image thereto;

FIG. 6 is a bottom plan view of the combination coat and backpack hook shown in FIG. 1.

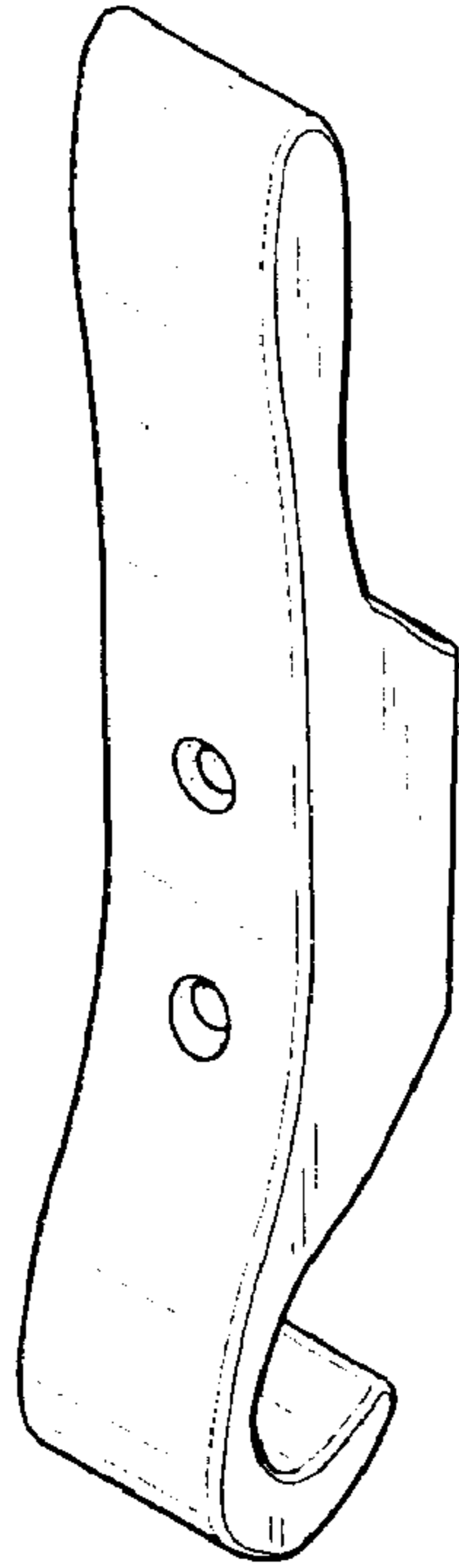

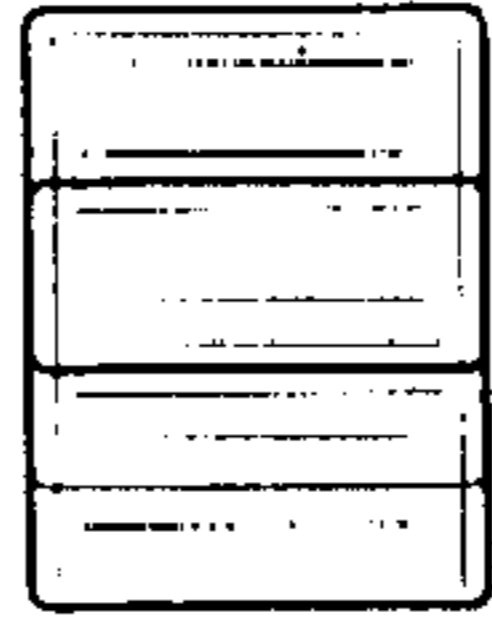

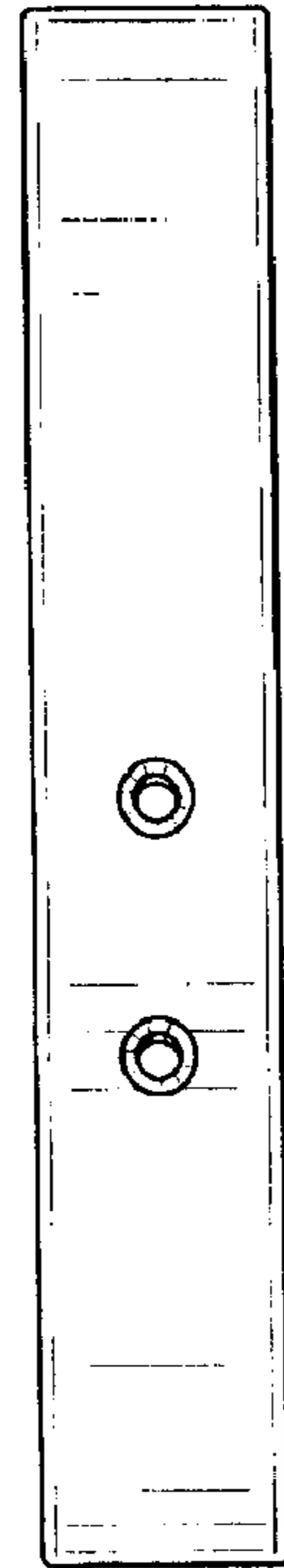

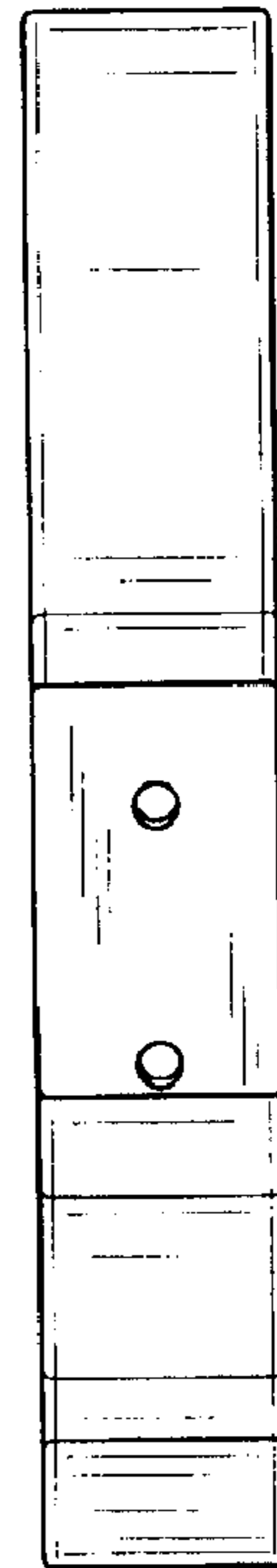

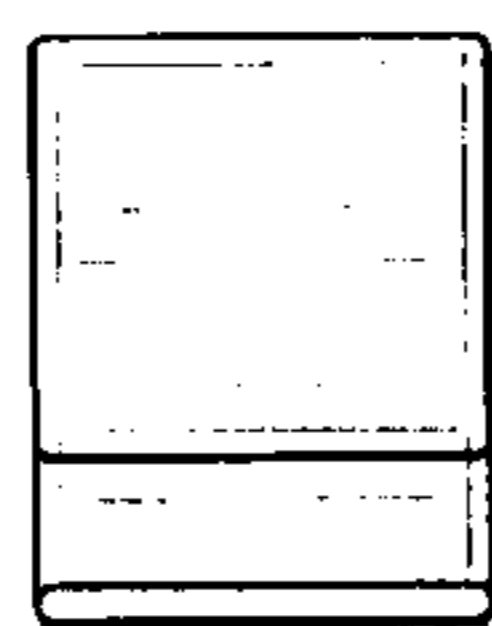
