FIG. 2 is a front view thereof;

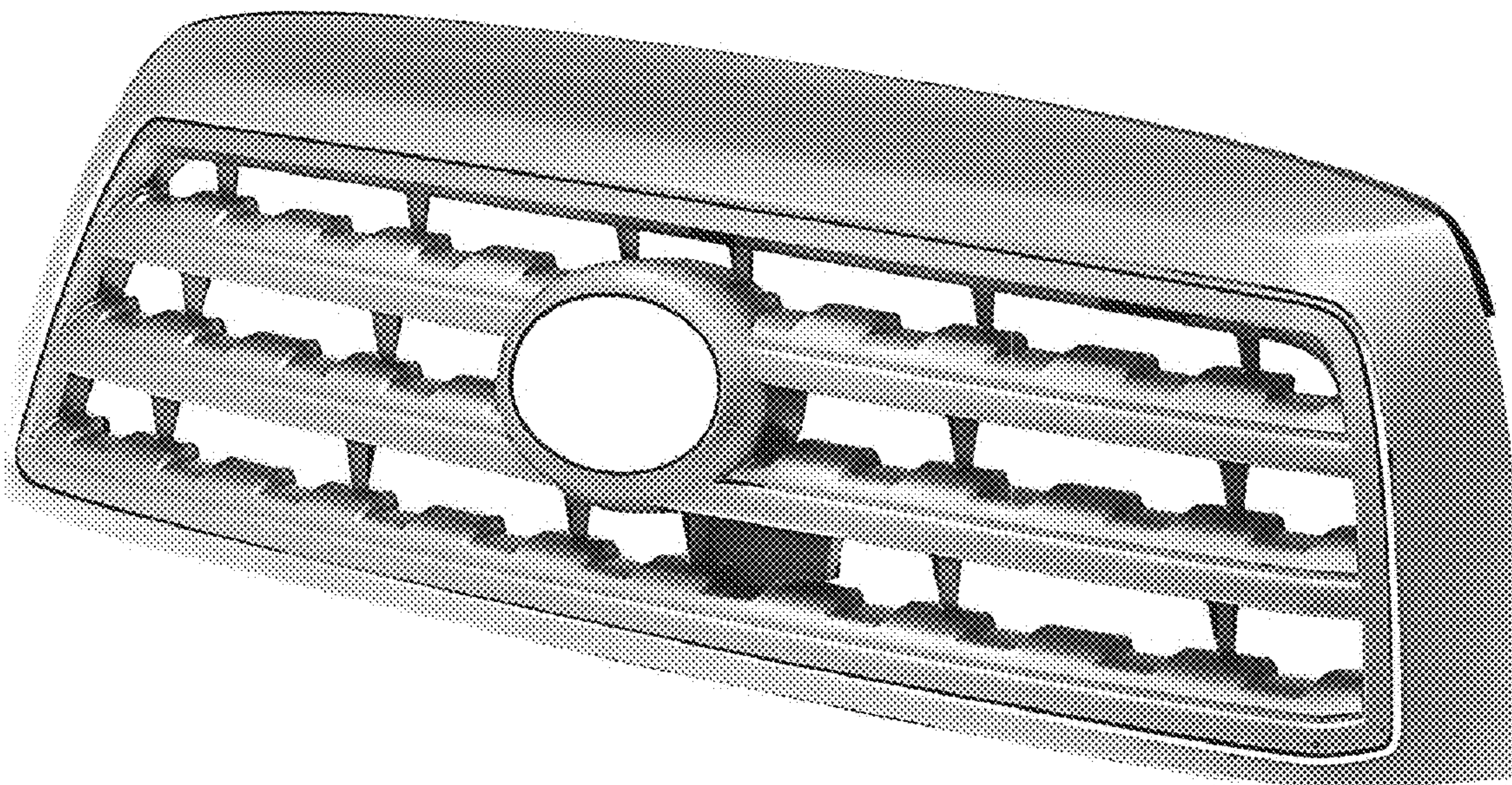
FIG. 3 is a right-side view thereof;

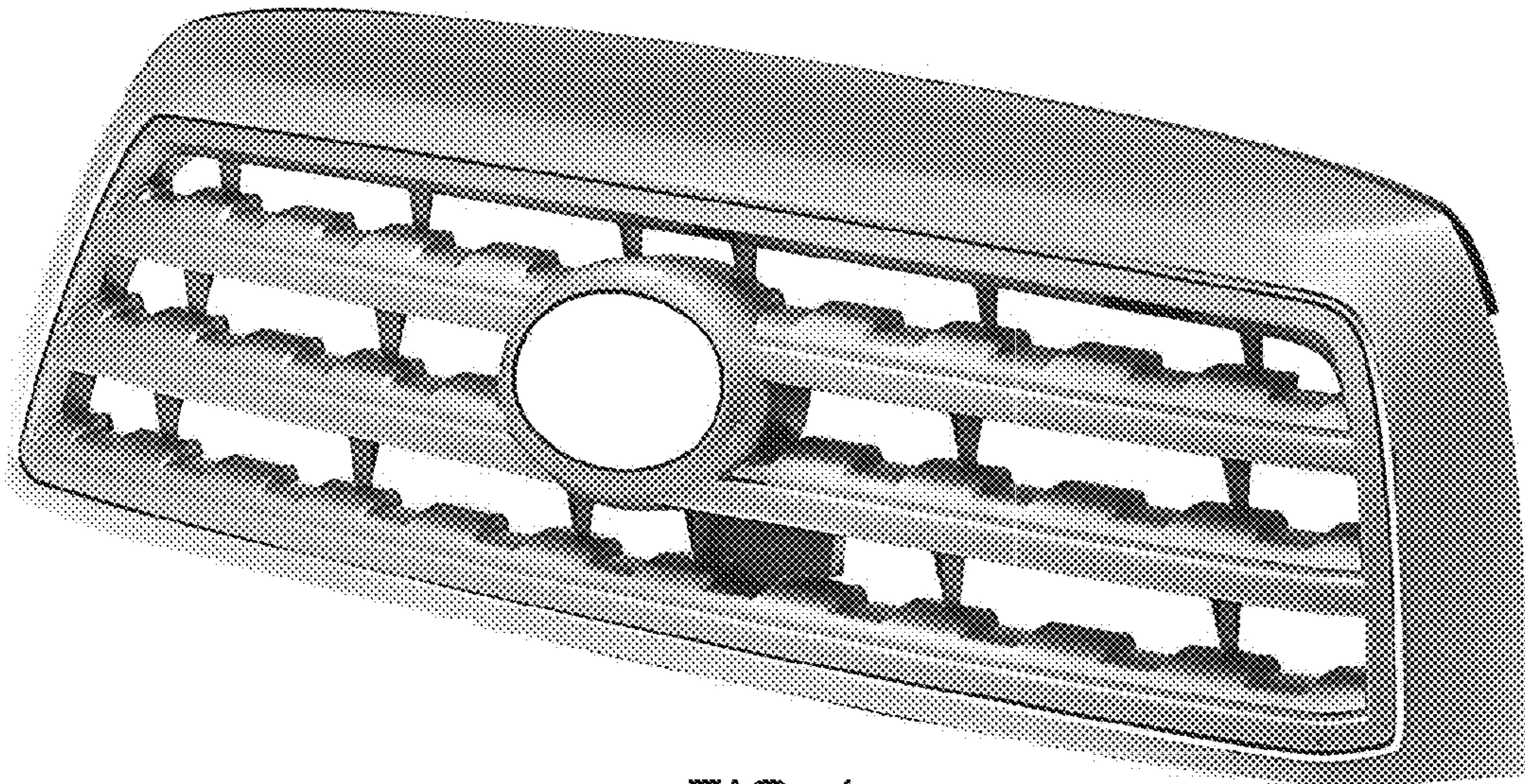

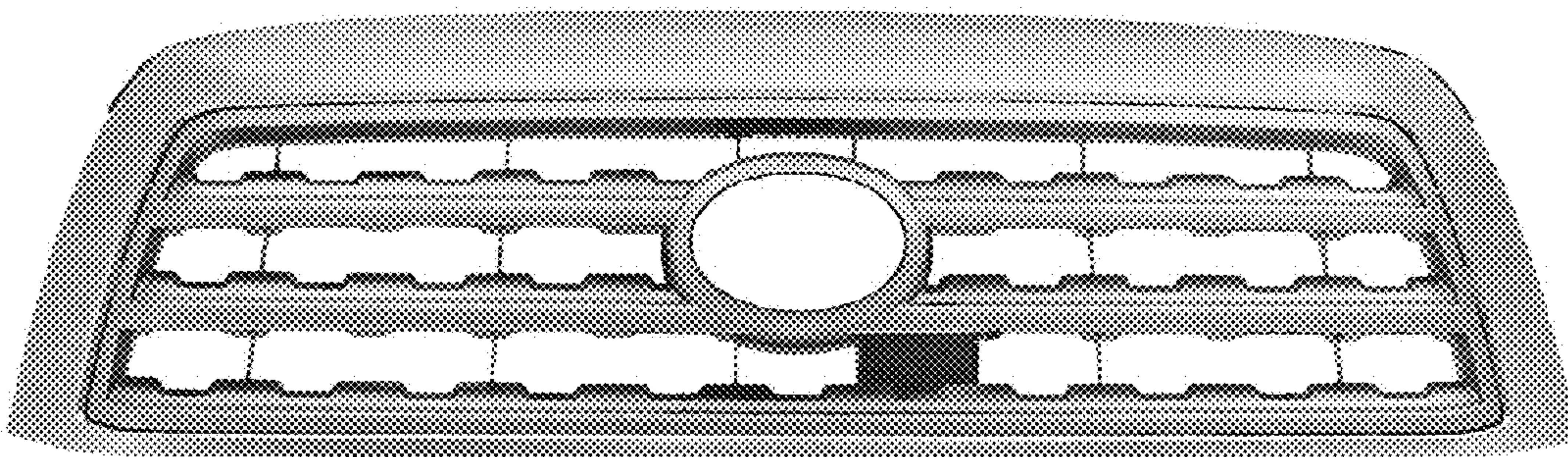

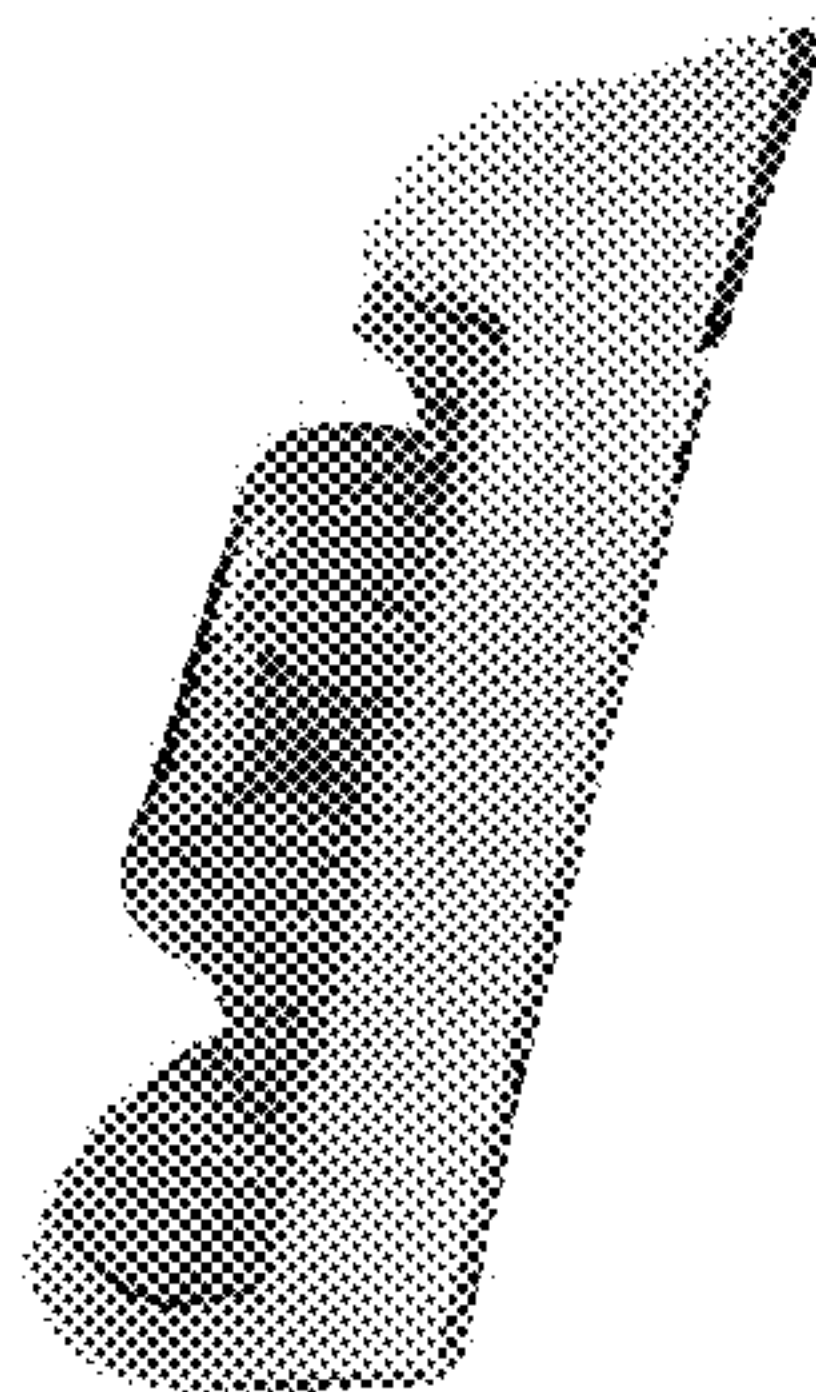

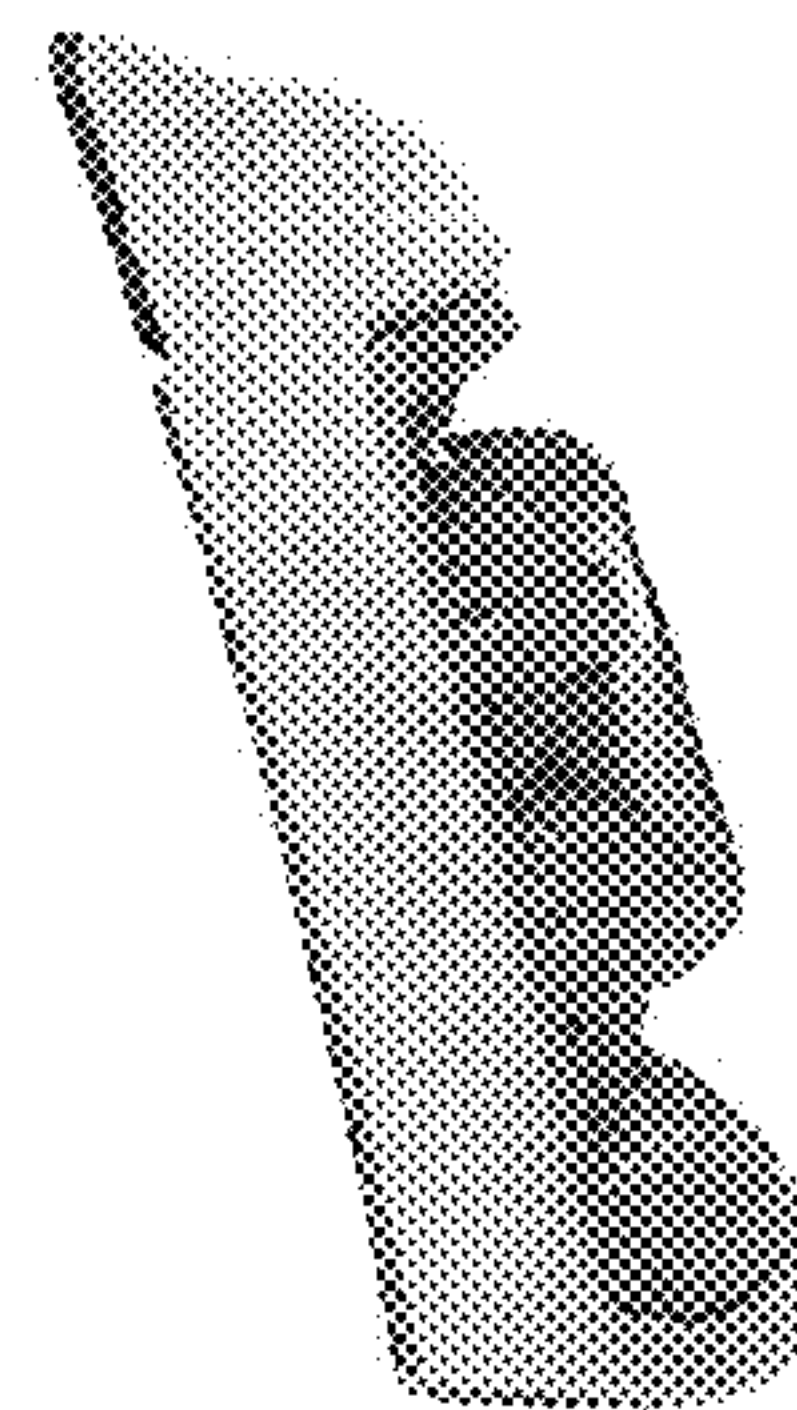

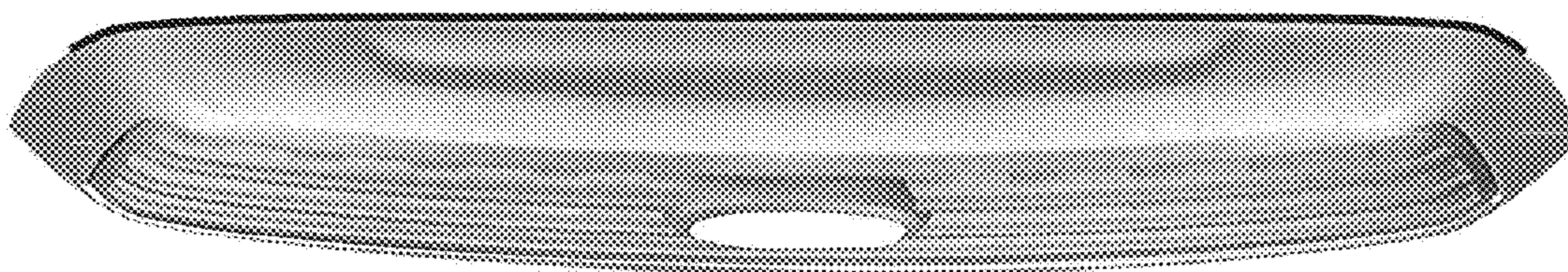
