The ornamental design for a portion of a handset, as shown and described.

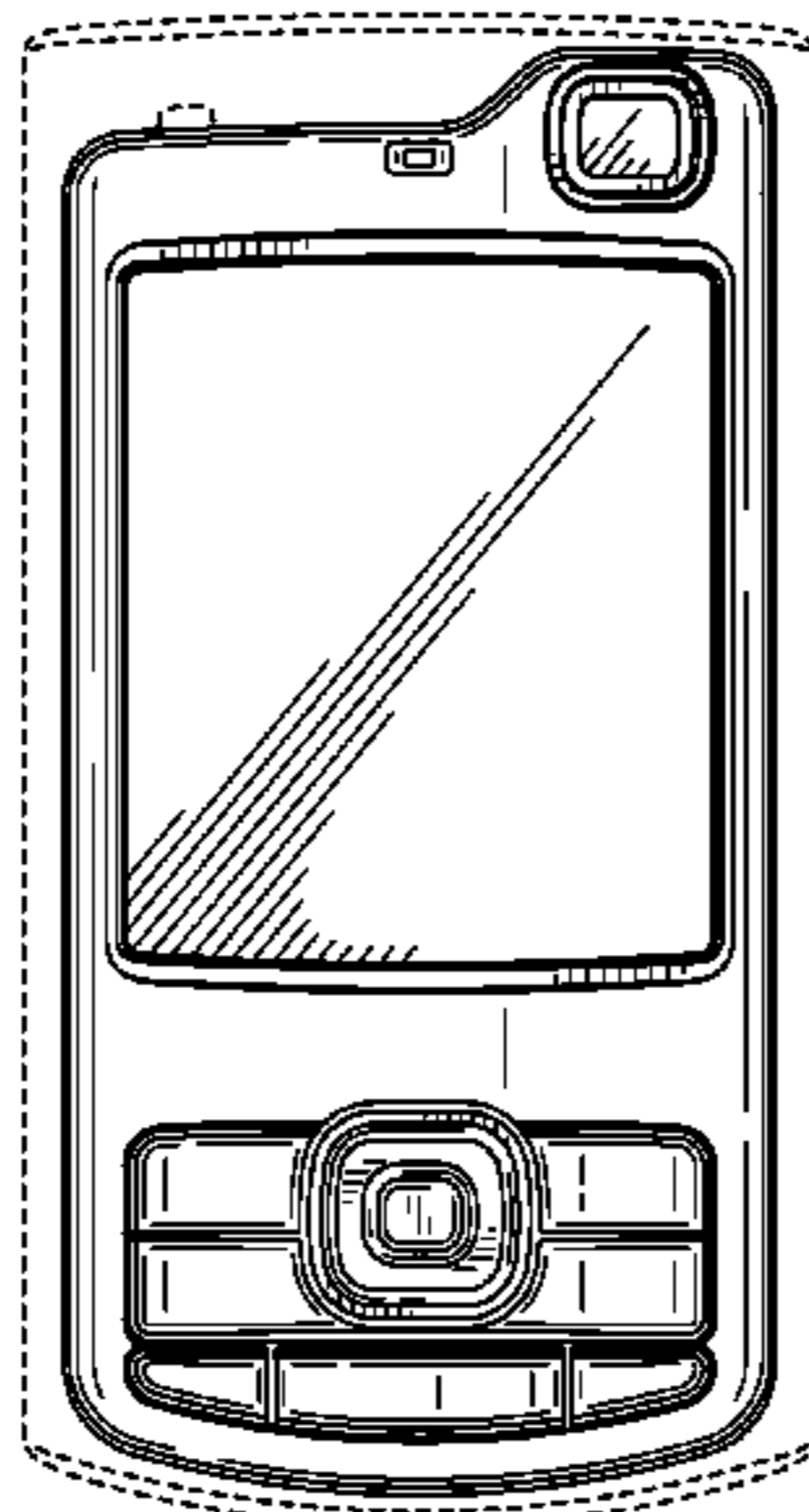
DESCRIPTION

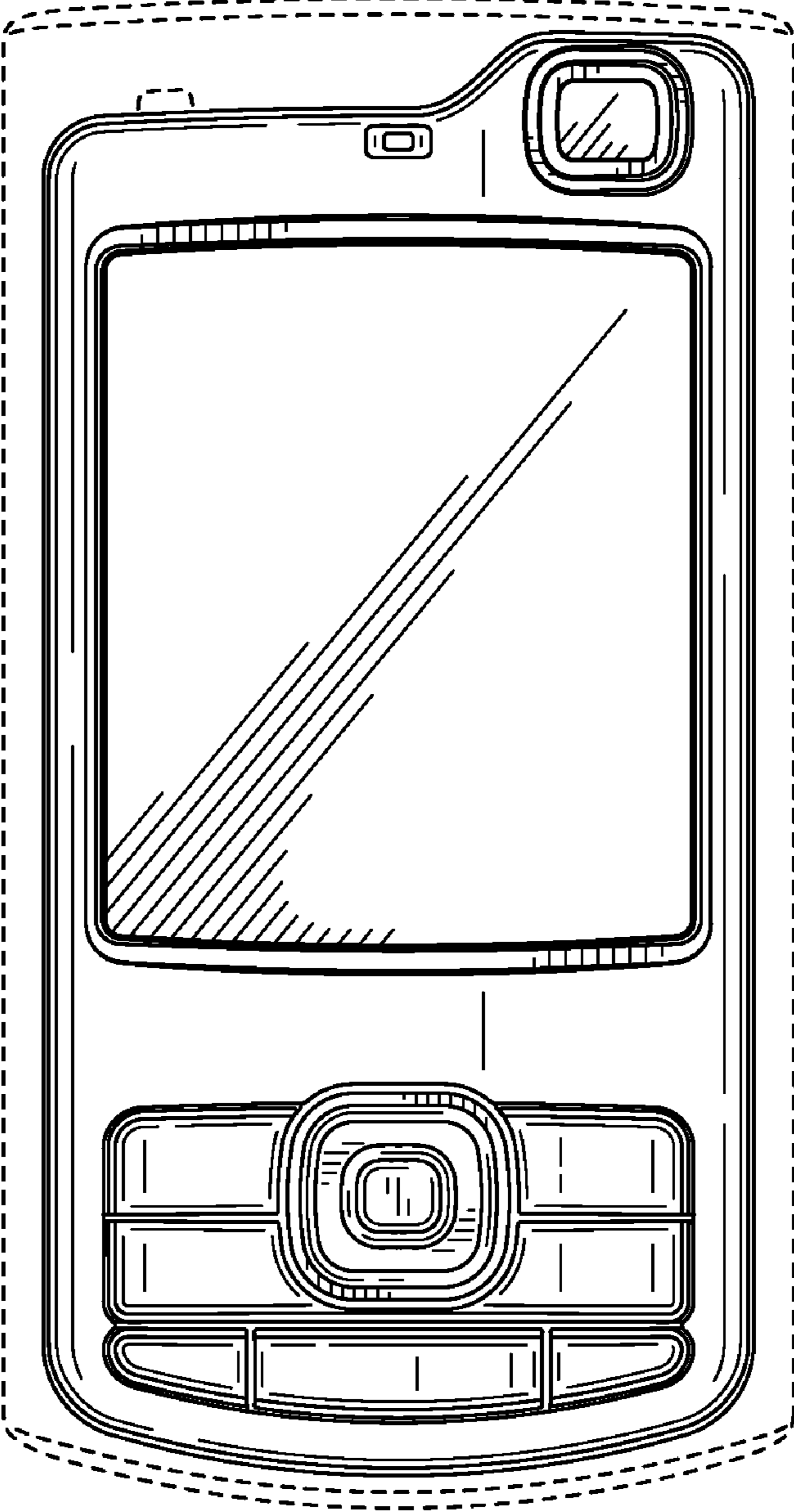
