FIG. 6 is a right side view.

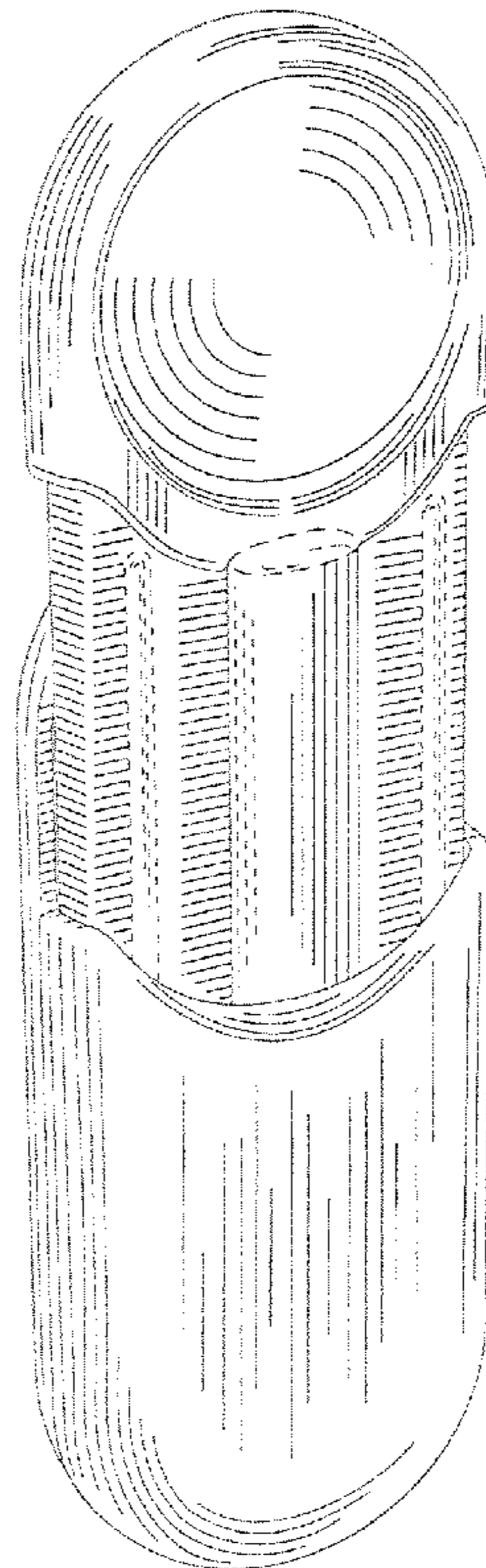
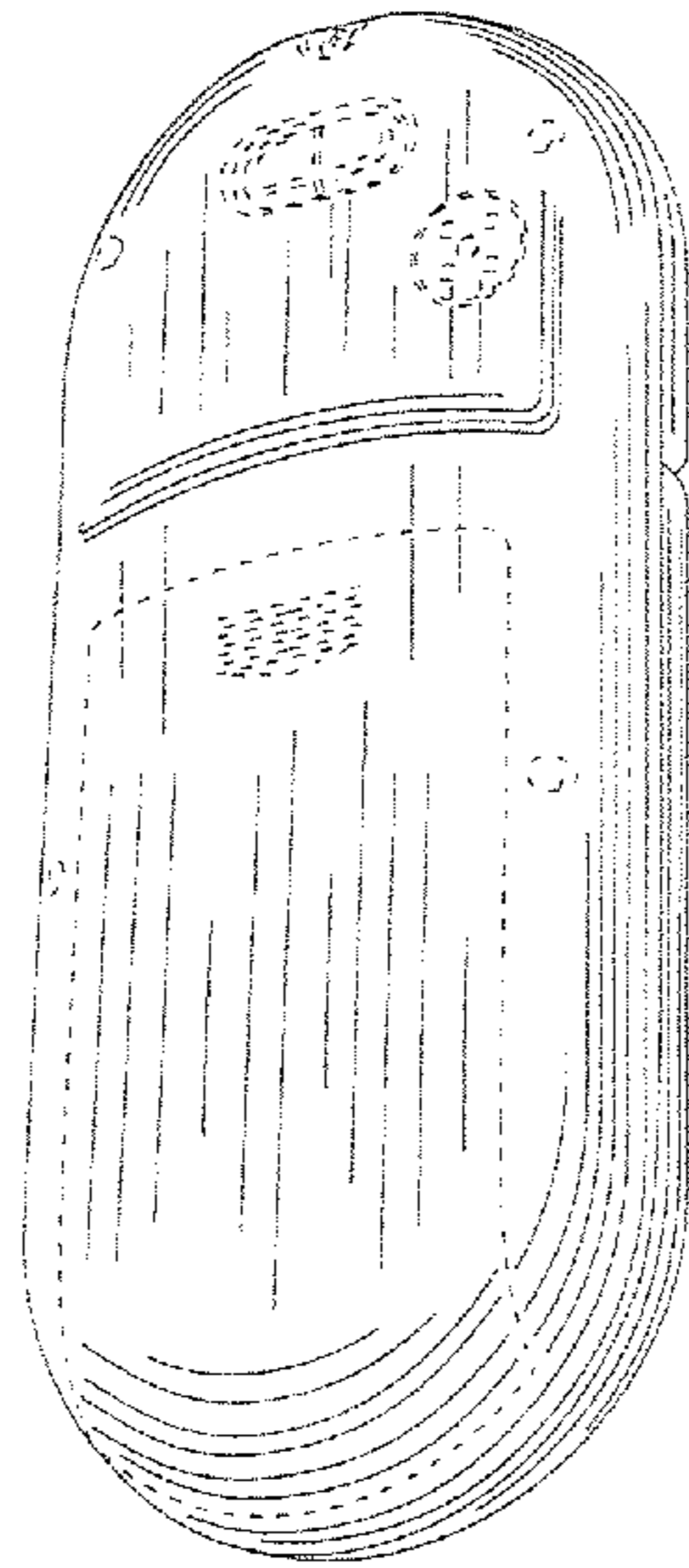
FIG. 7 is a bottom view.

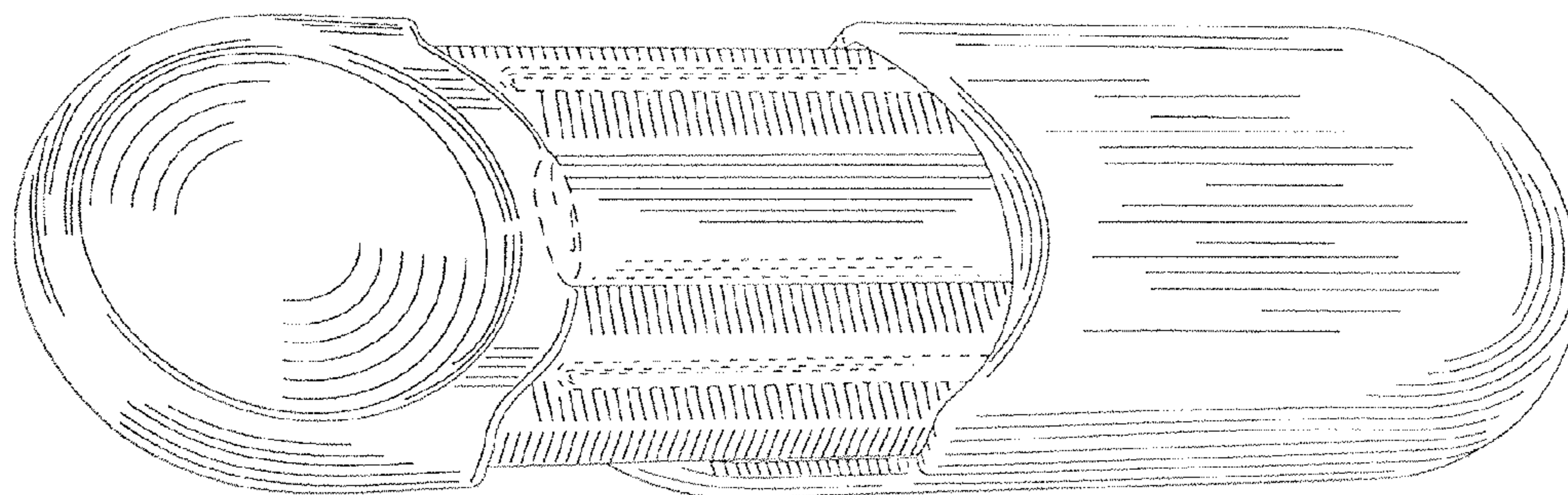

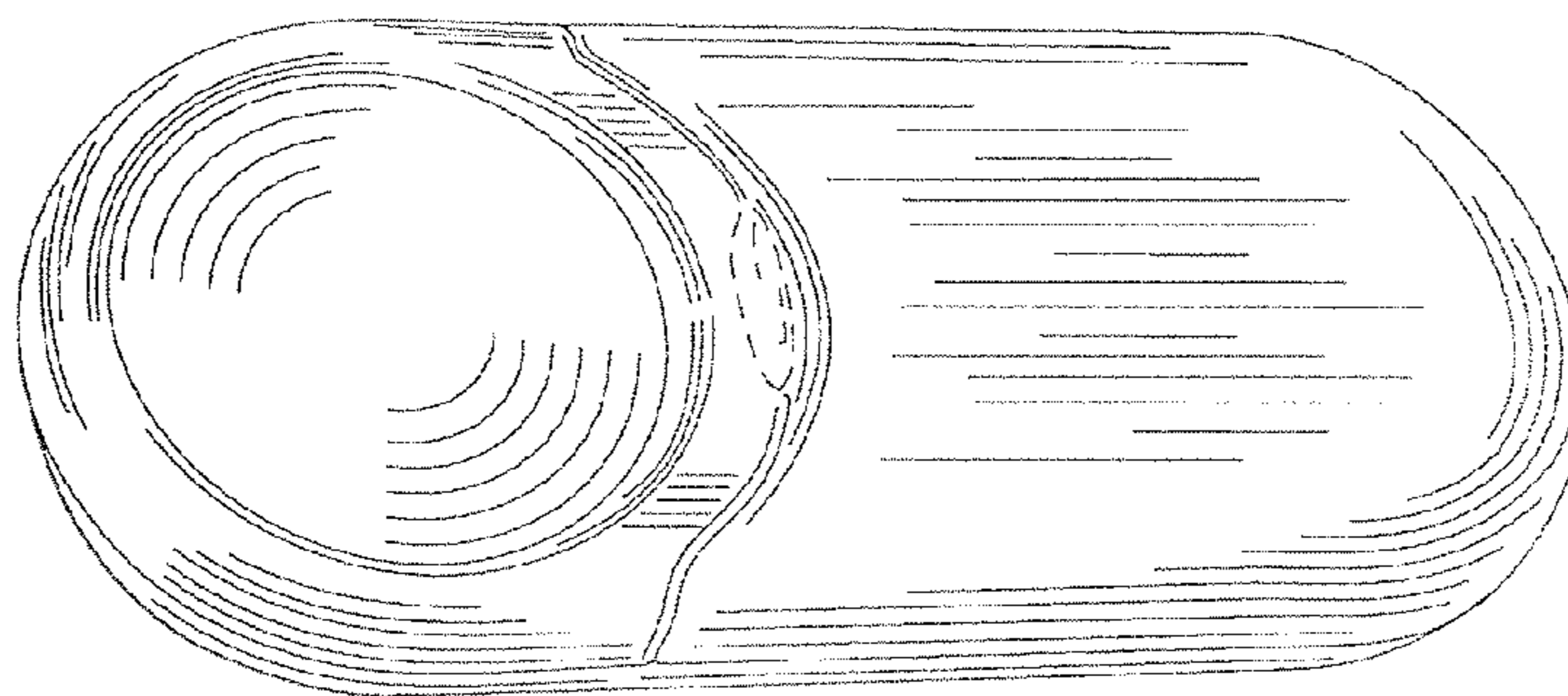

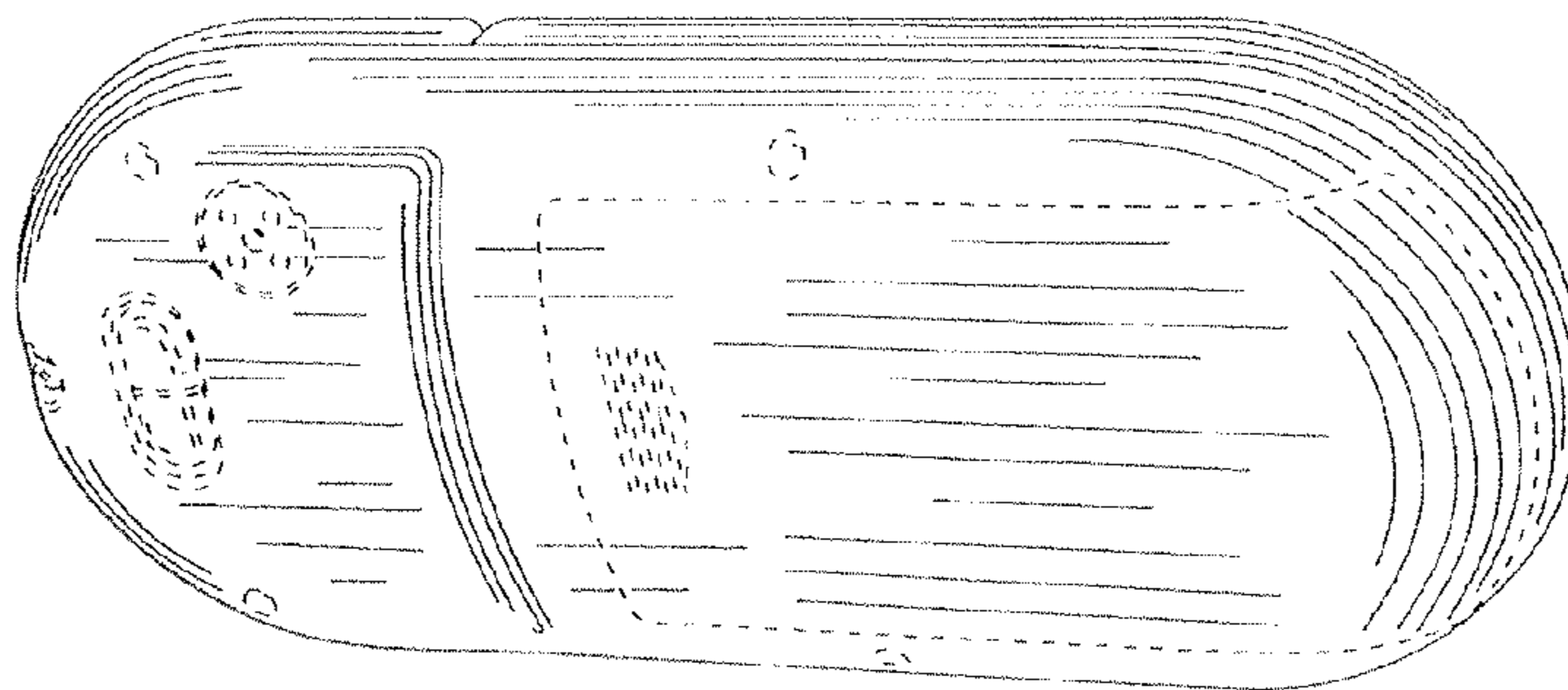

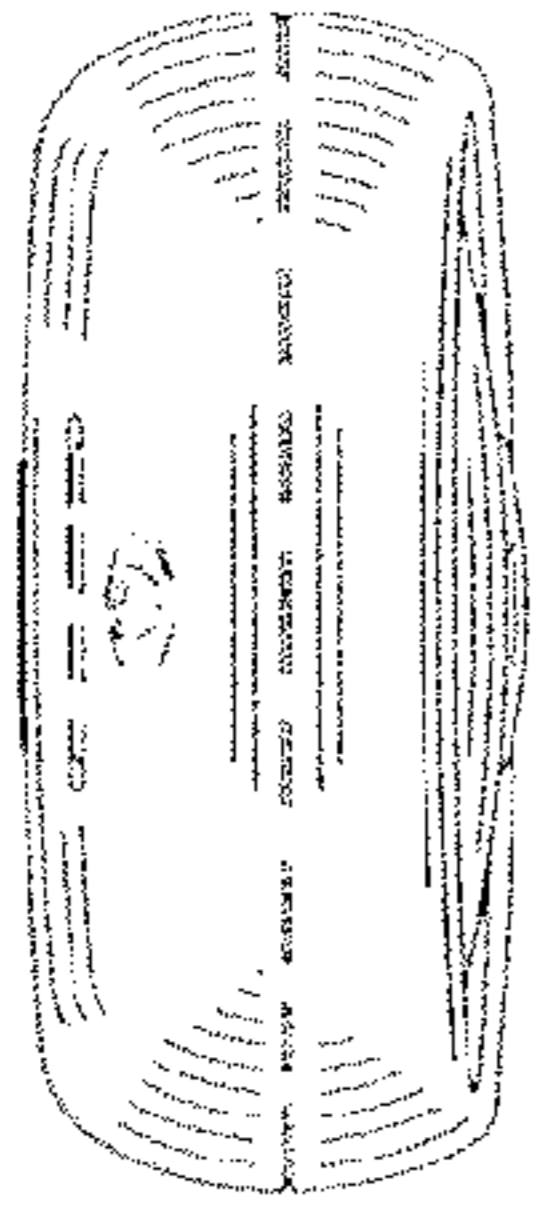

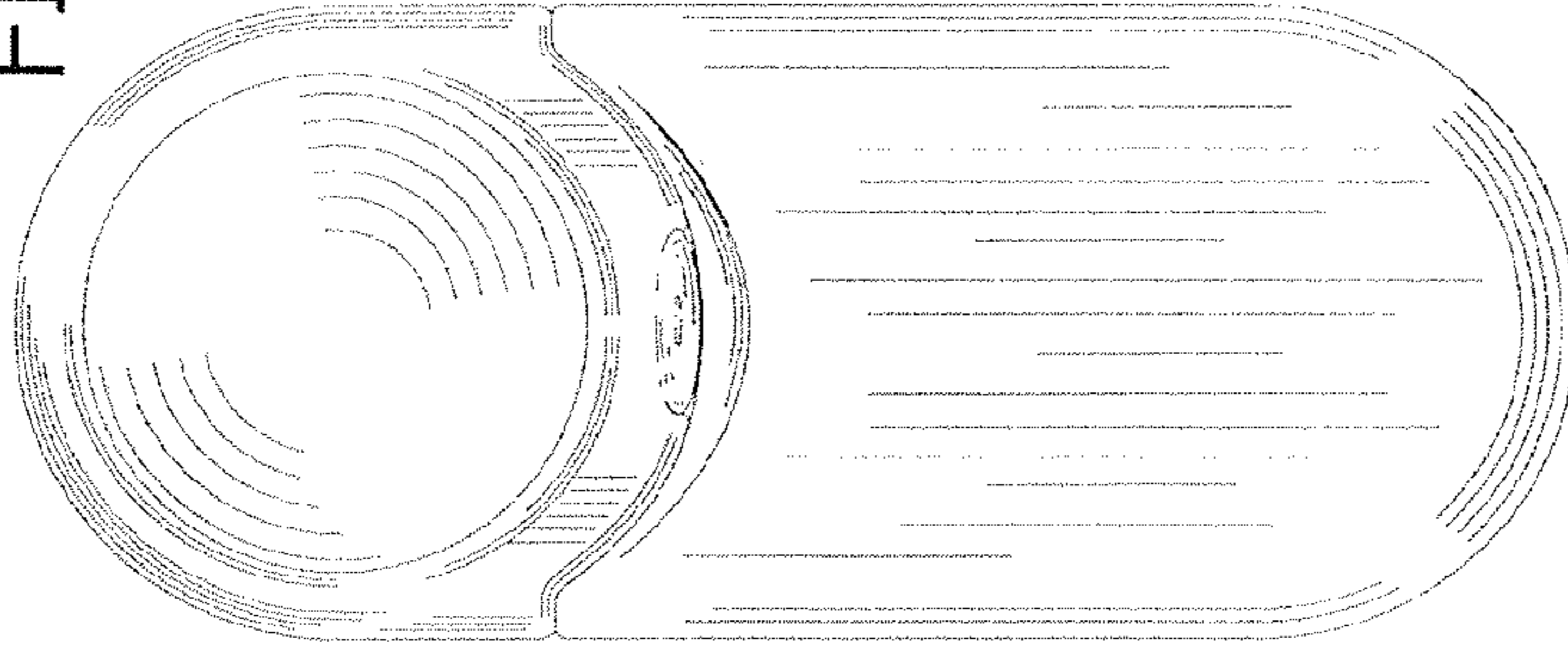

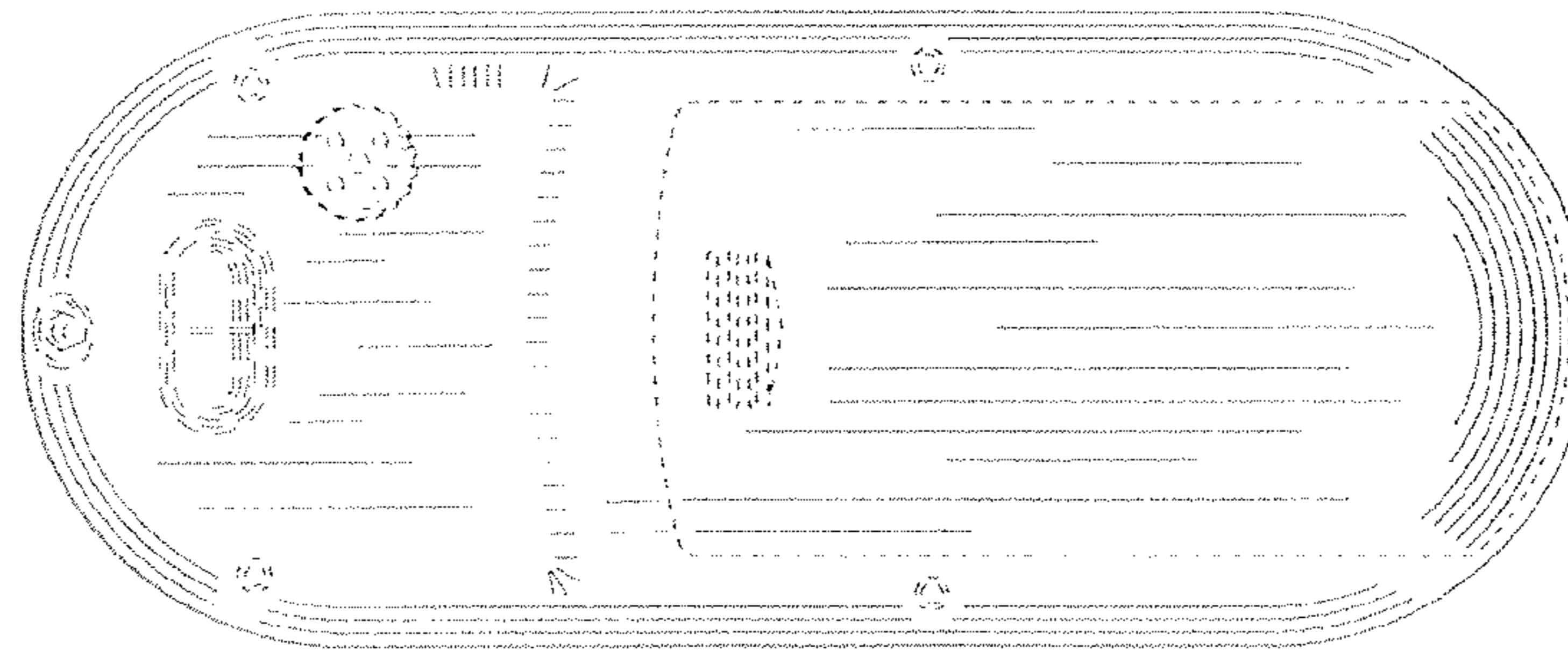

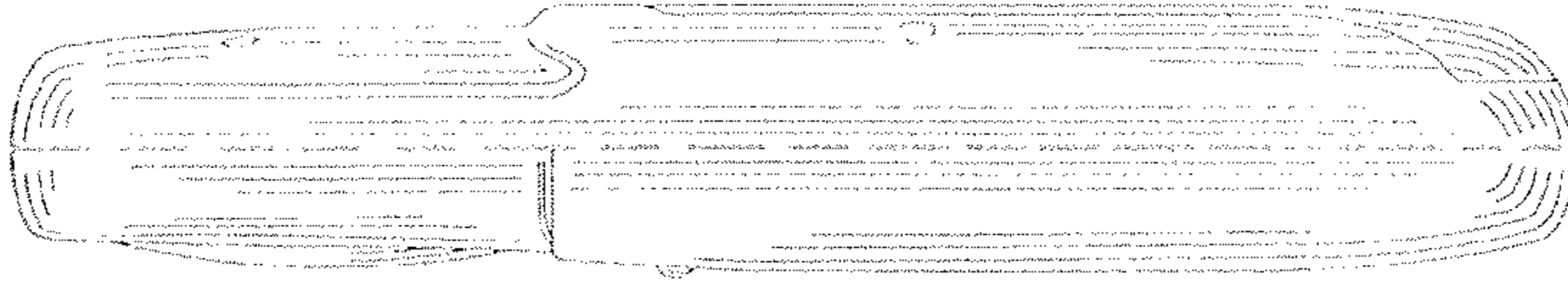

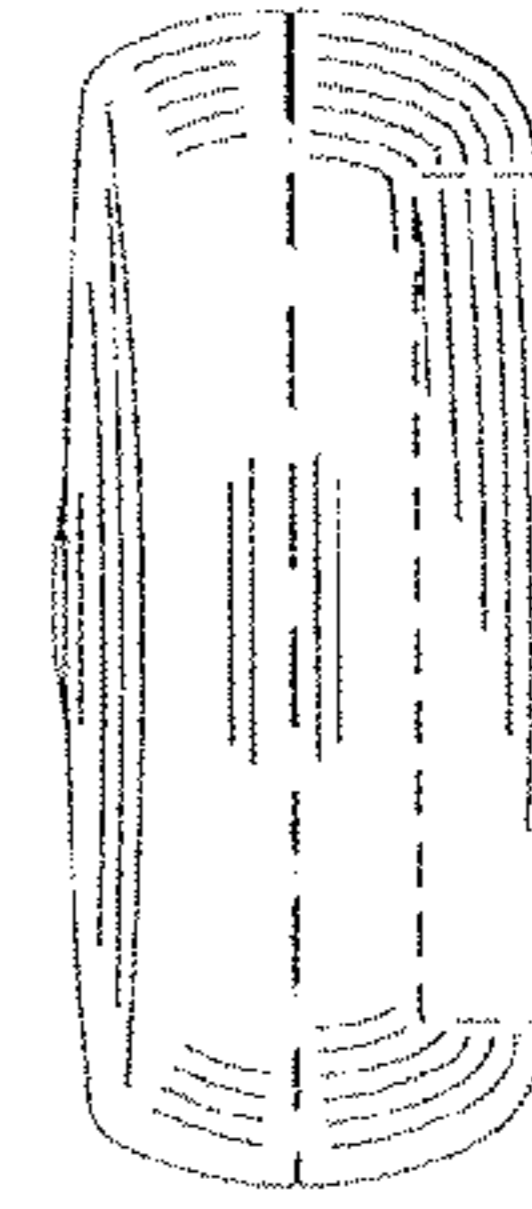
