FIG. 1 is a front perspective view of a pan-tilt camera module showing our new design;

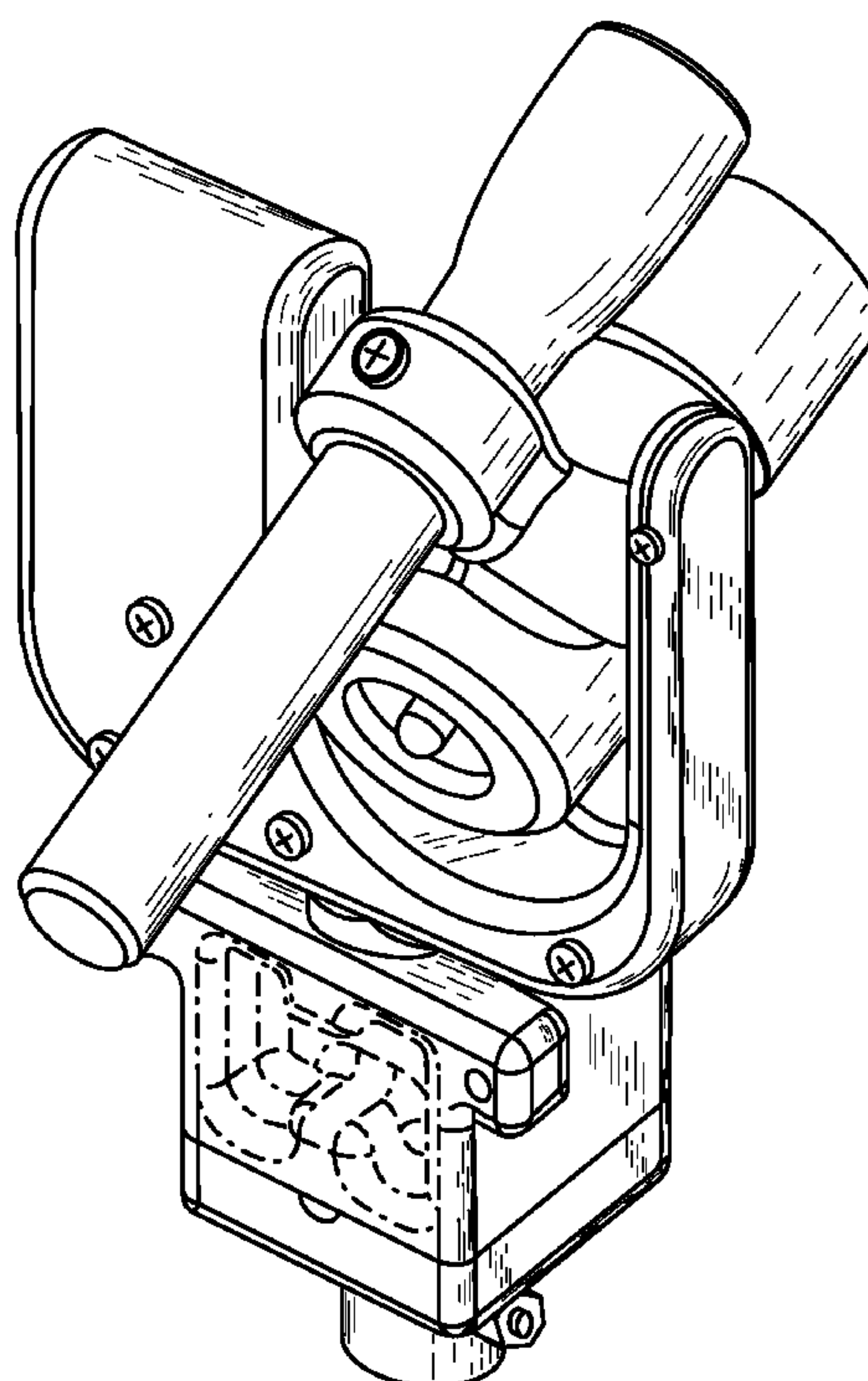
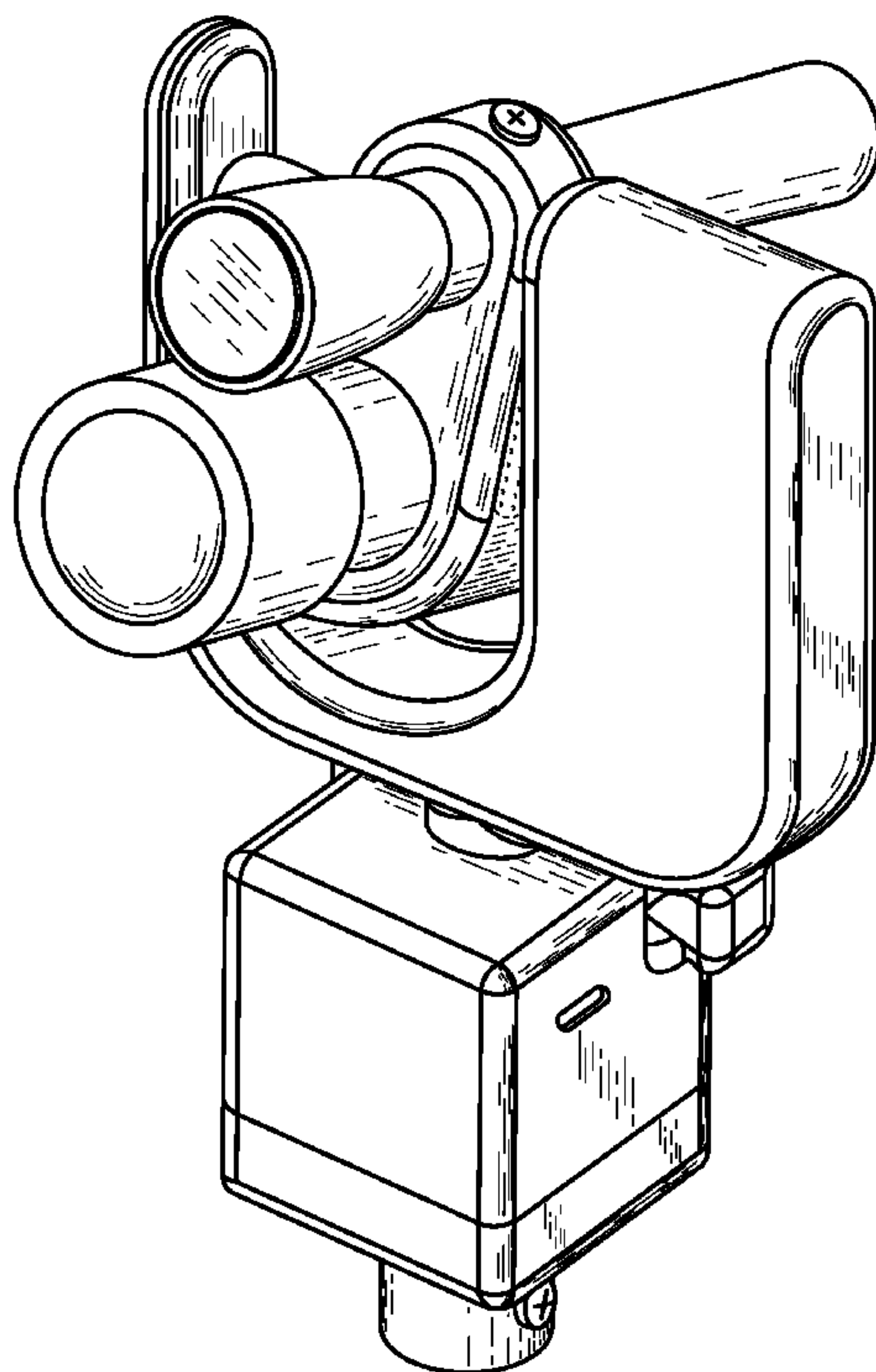
FIG. 2 is a rear perspective view thereof.

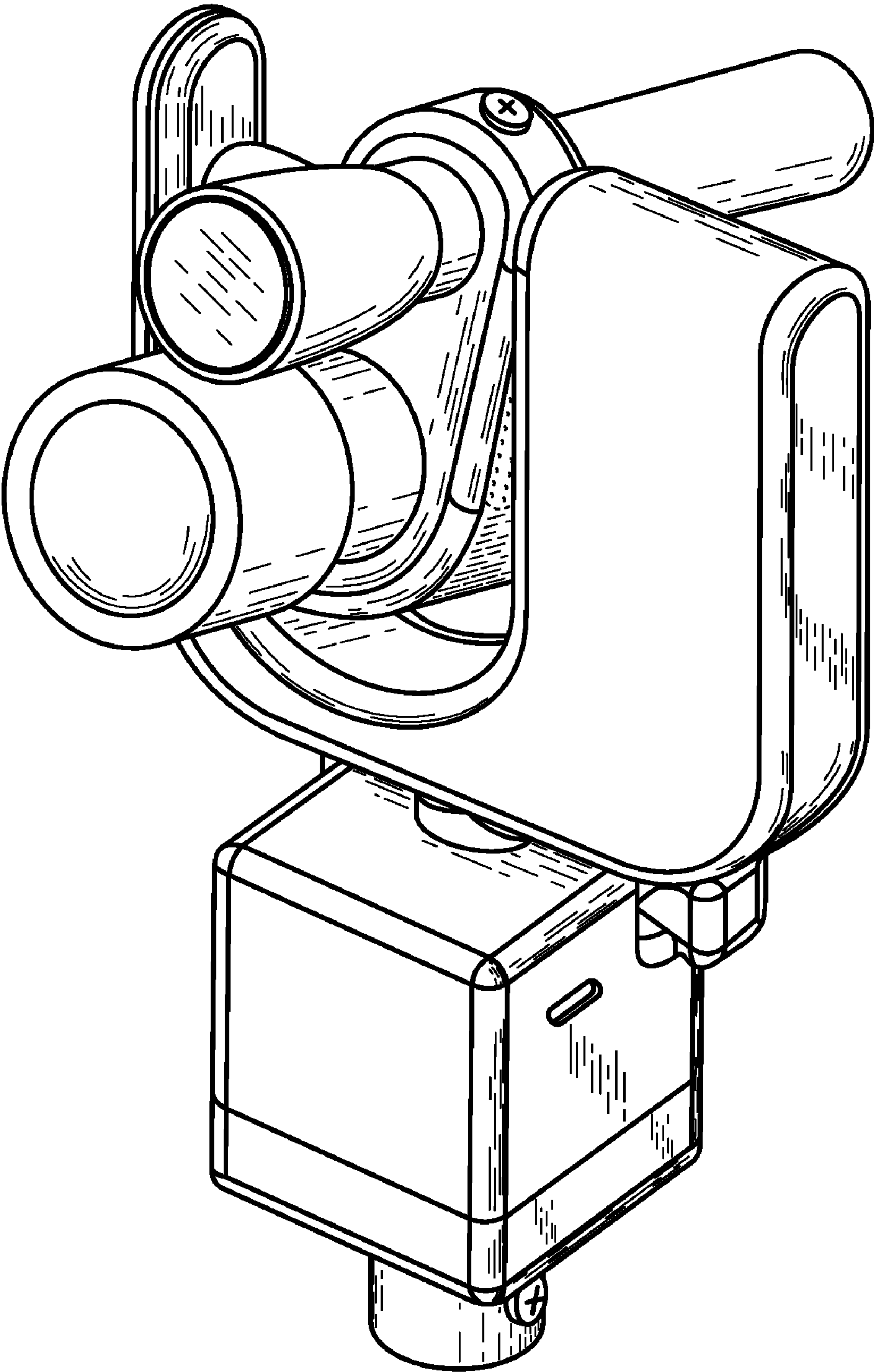

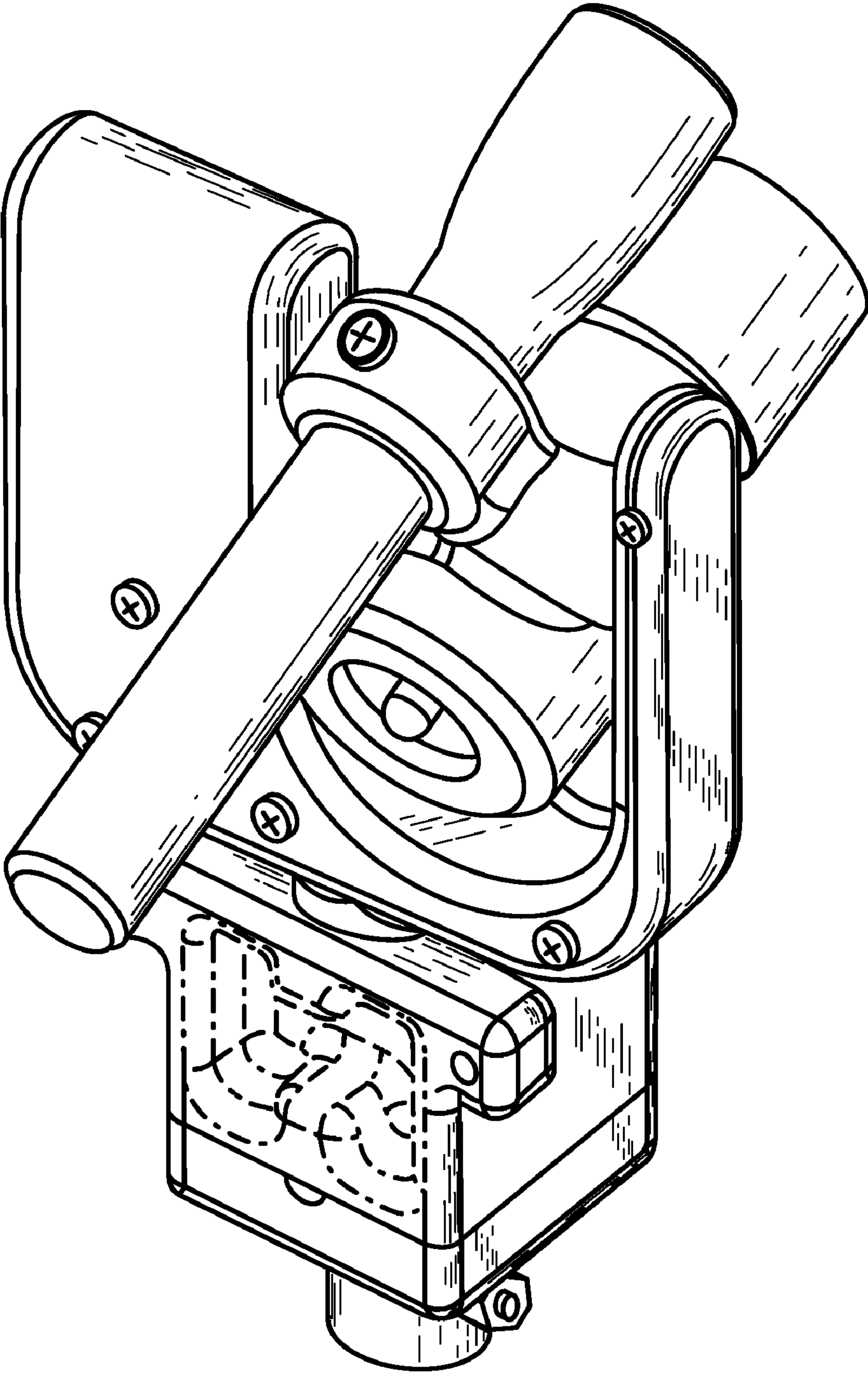

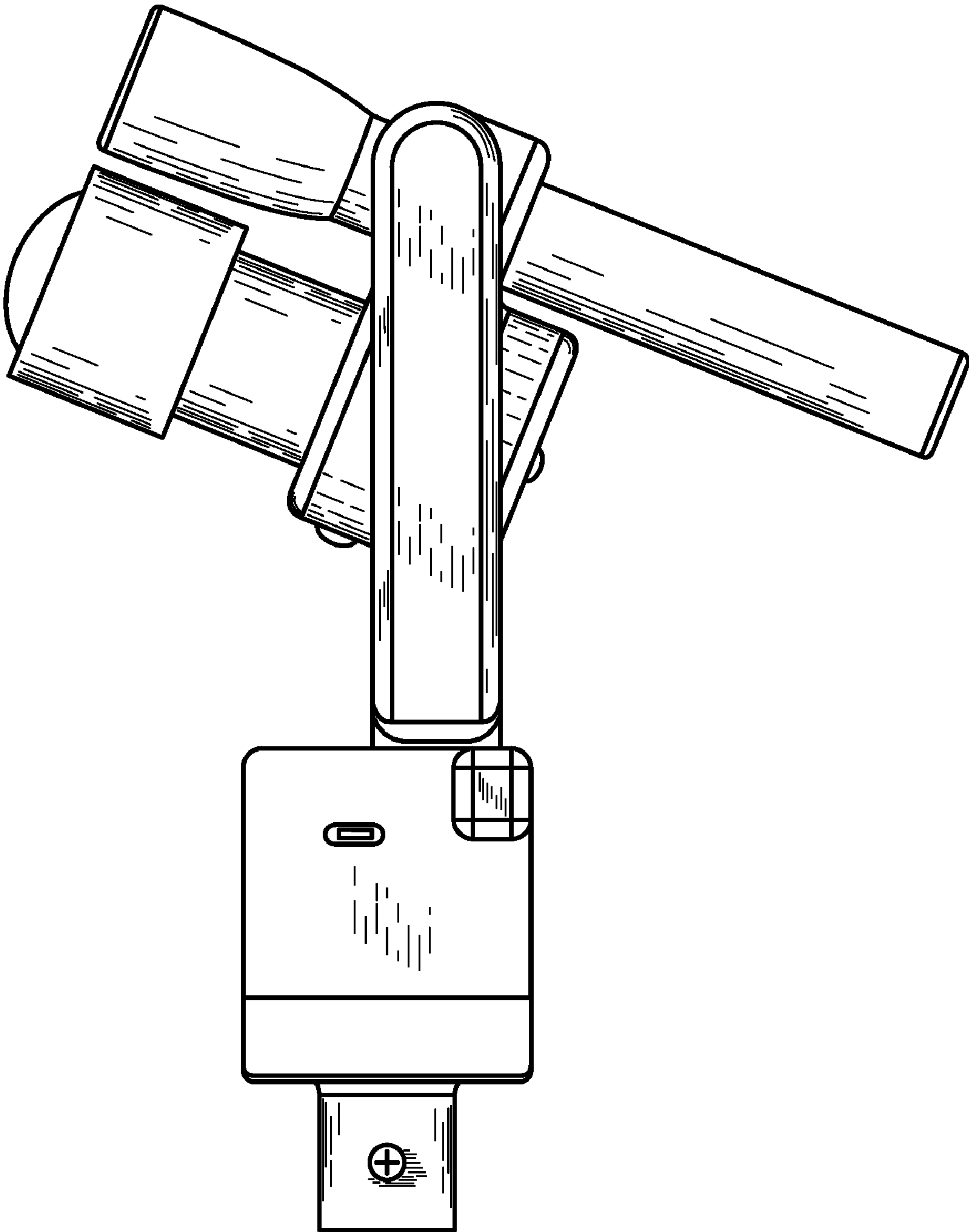

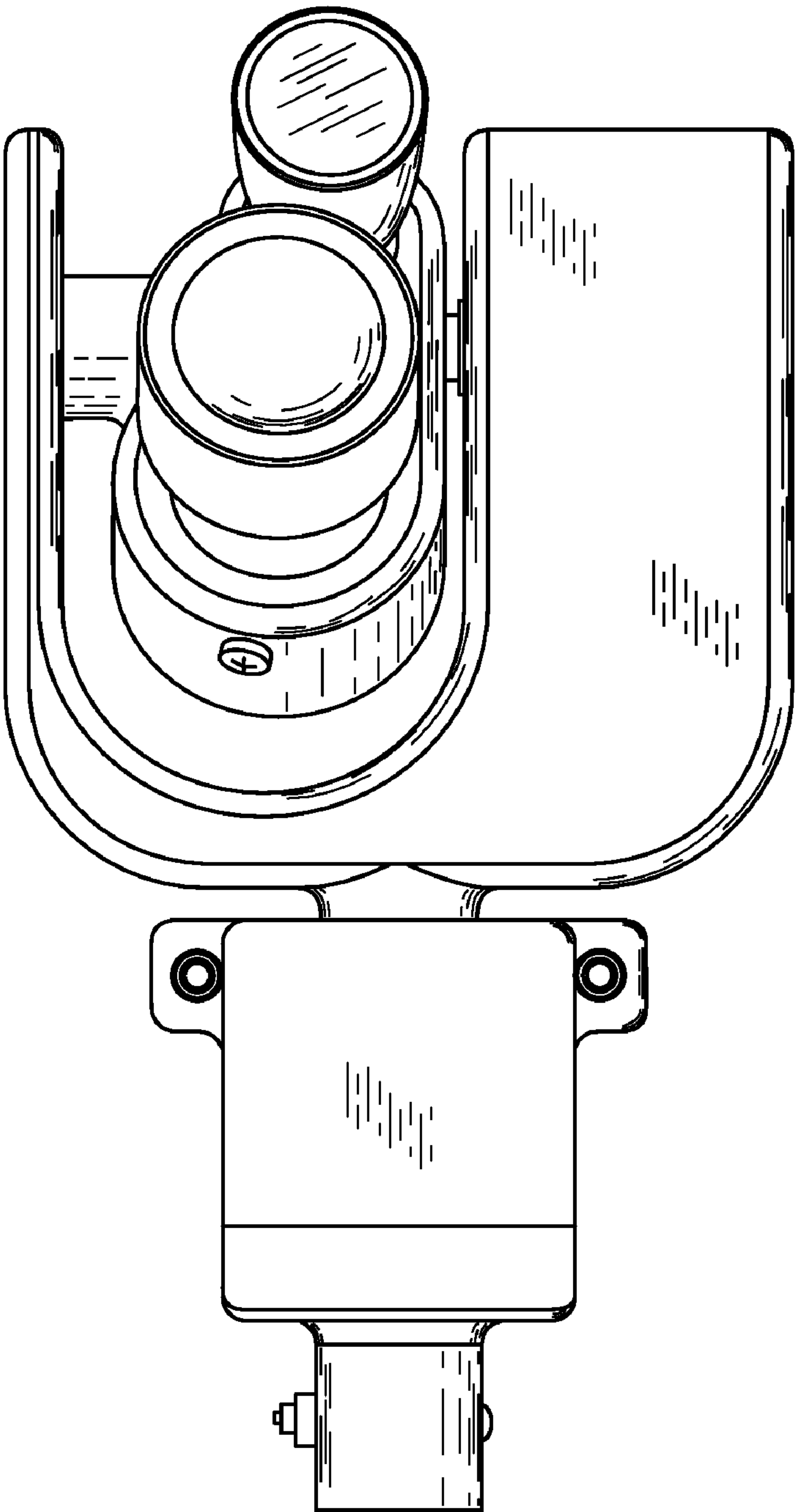
