The ornamental design for a surgical clip, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a surgical clip showing our new design;

FIG. 2 is a front elevational view thereof;

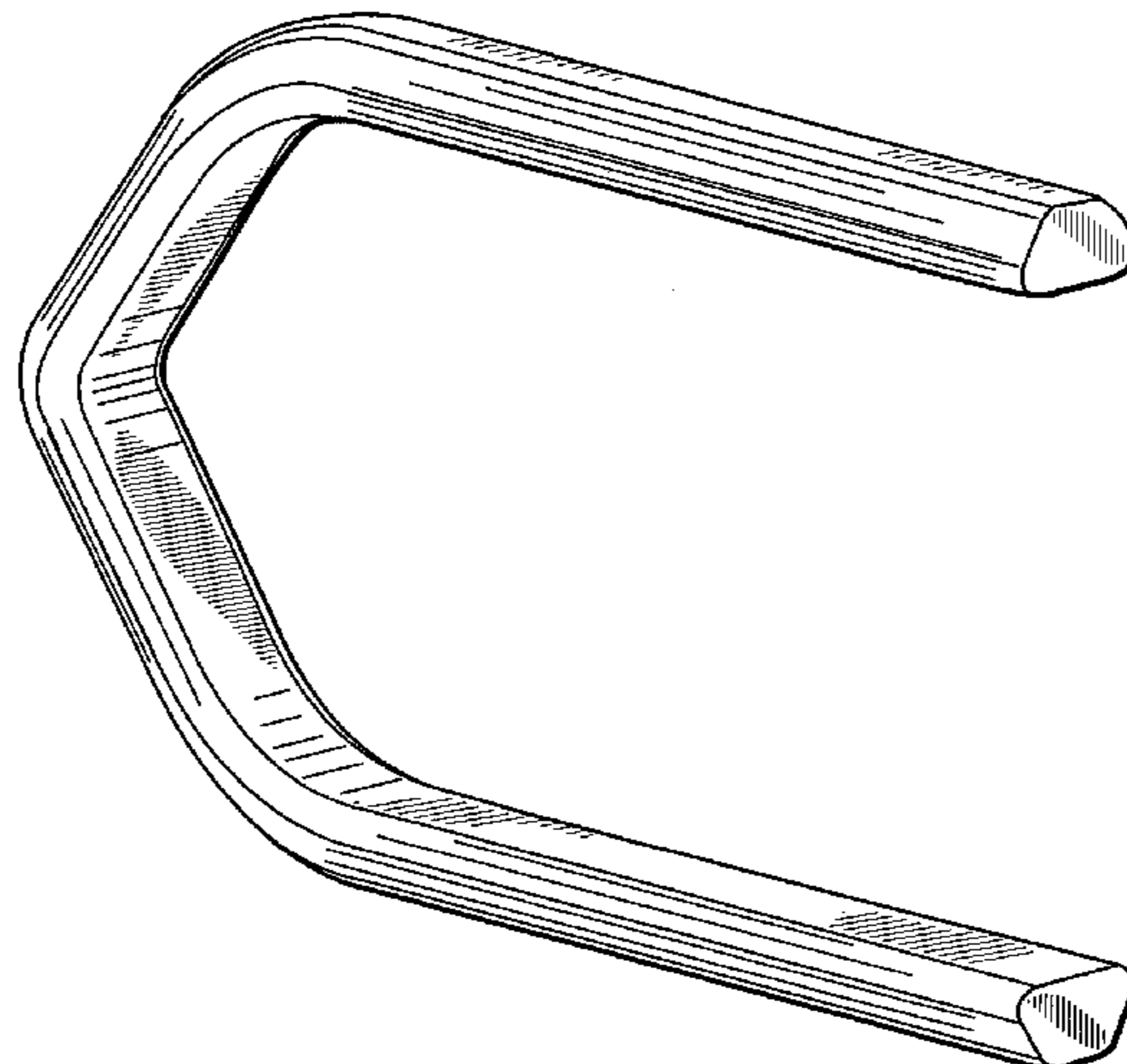
FIG. 3 is a top plan view thereof;

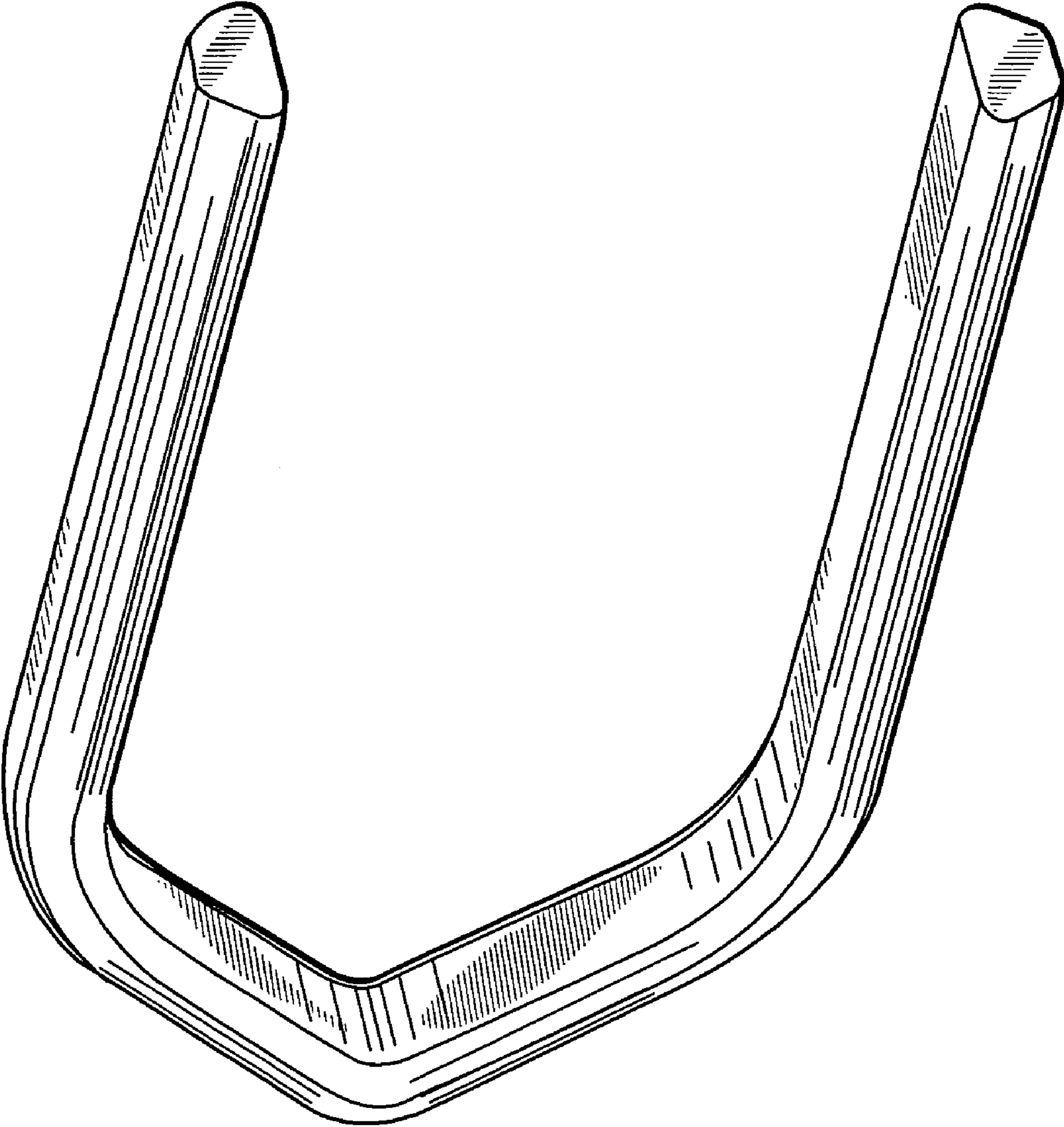

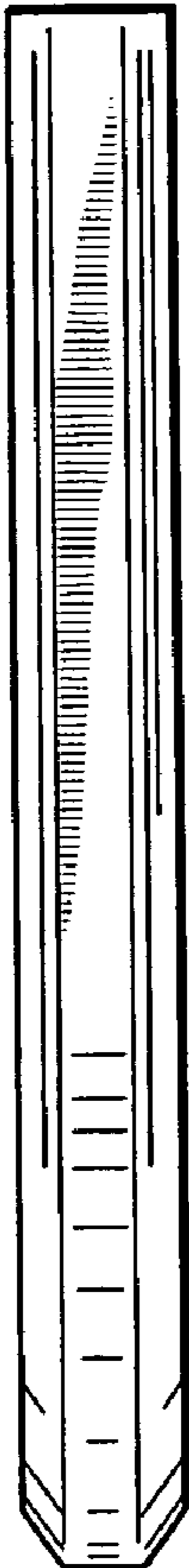

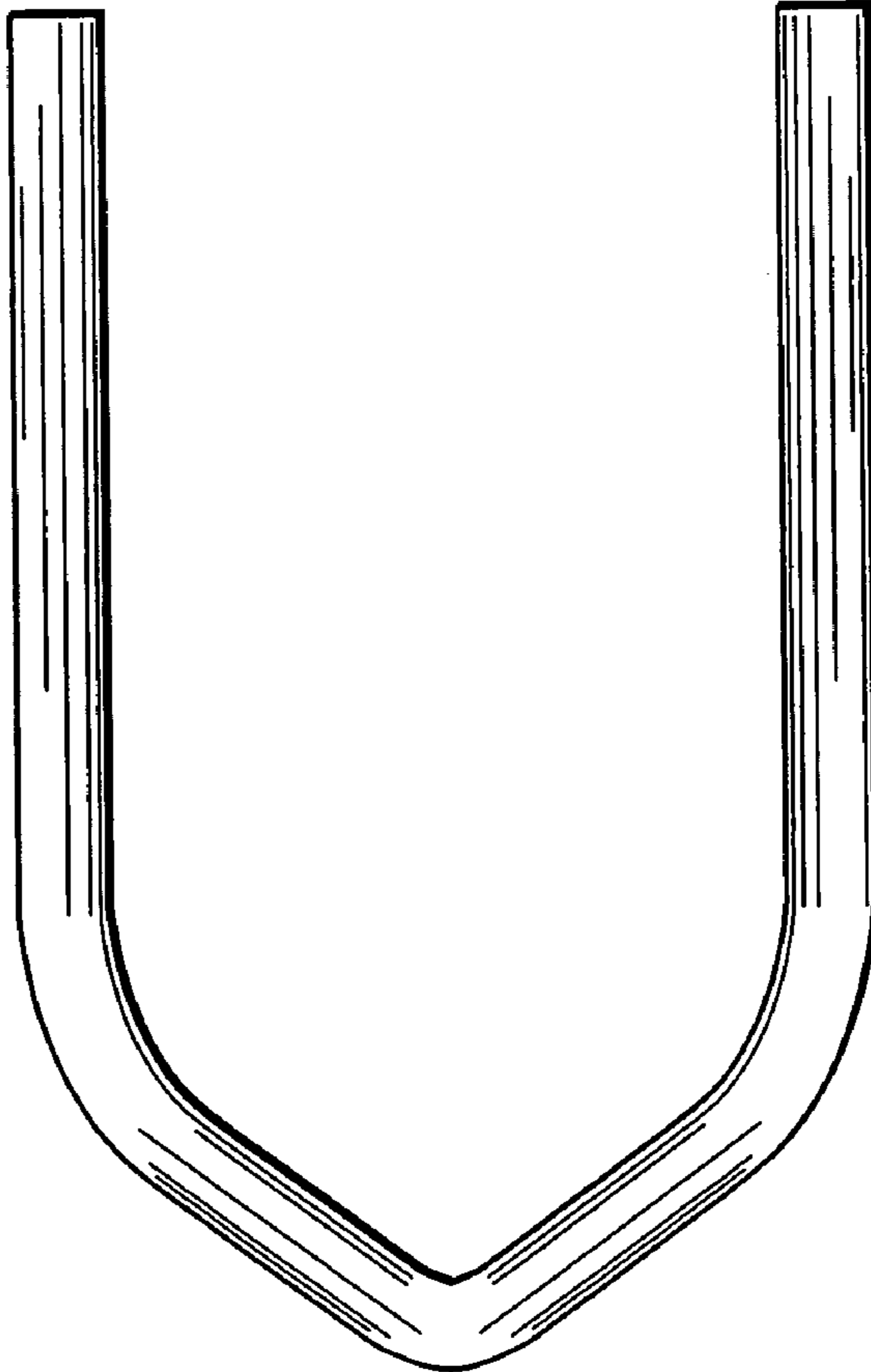

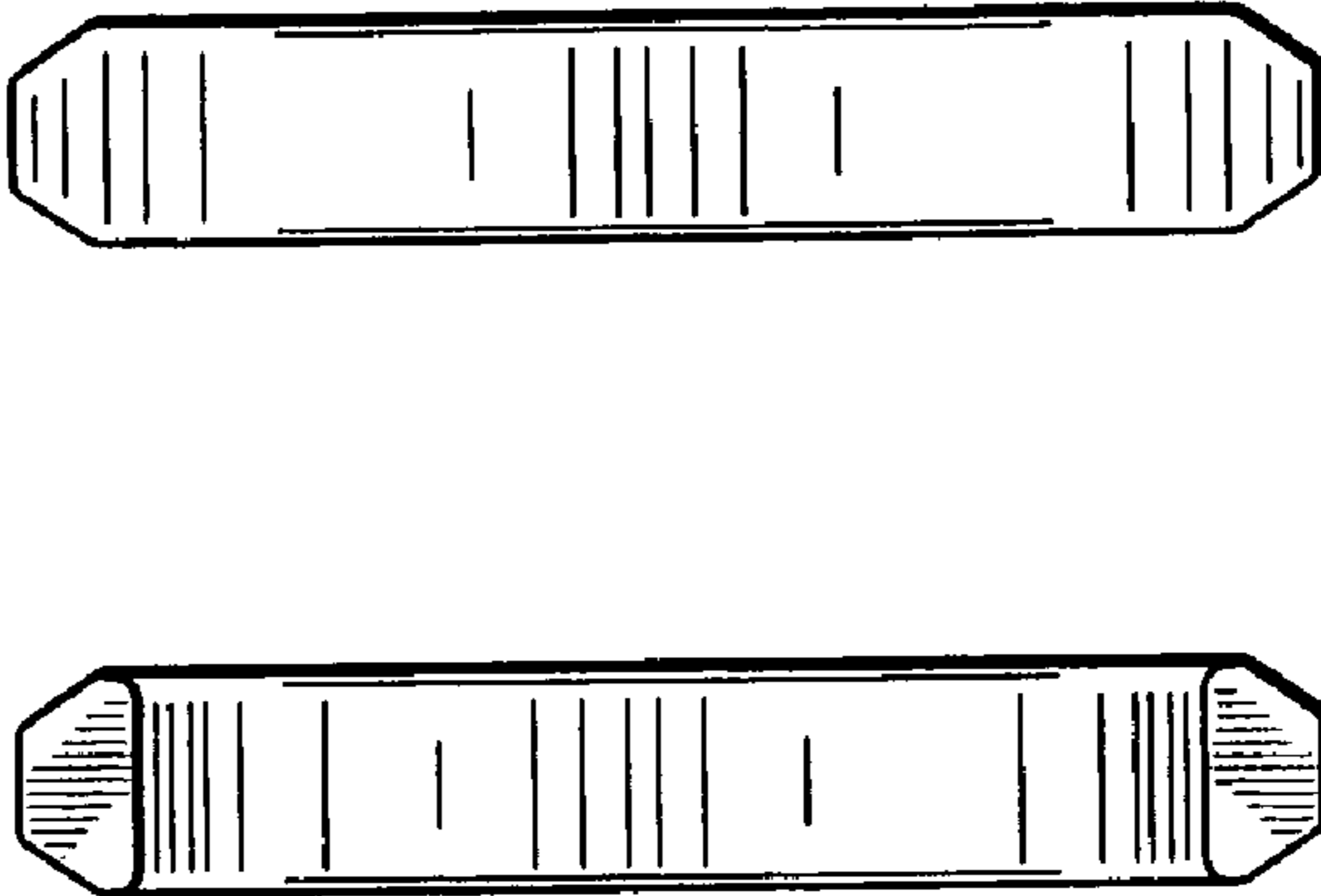


FIG. 4 FIG. 5
