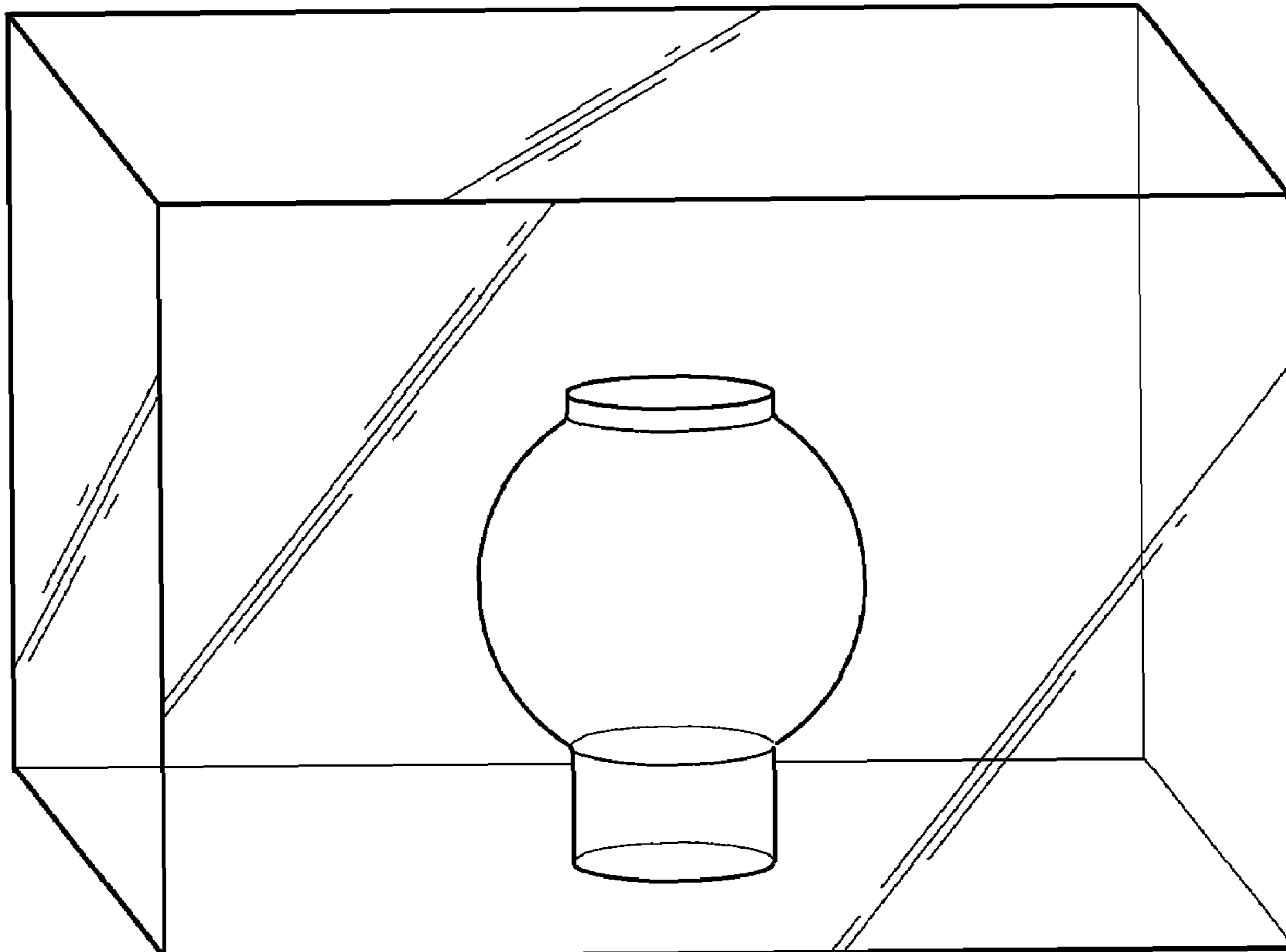
The ornamental design of a combined aquarium and animal exhibit, as shown and described.

**DESCRIPTION**

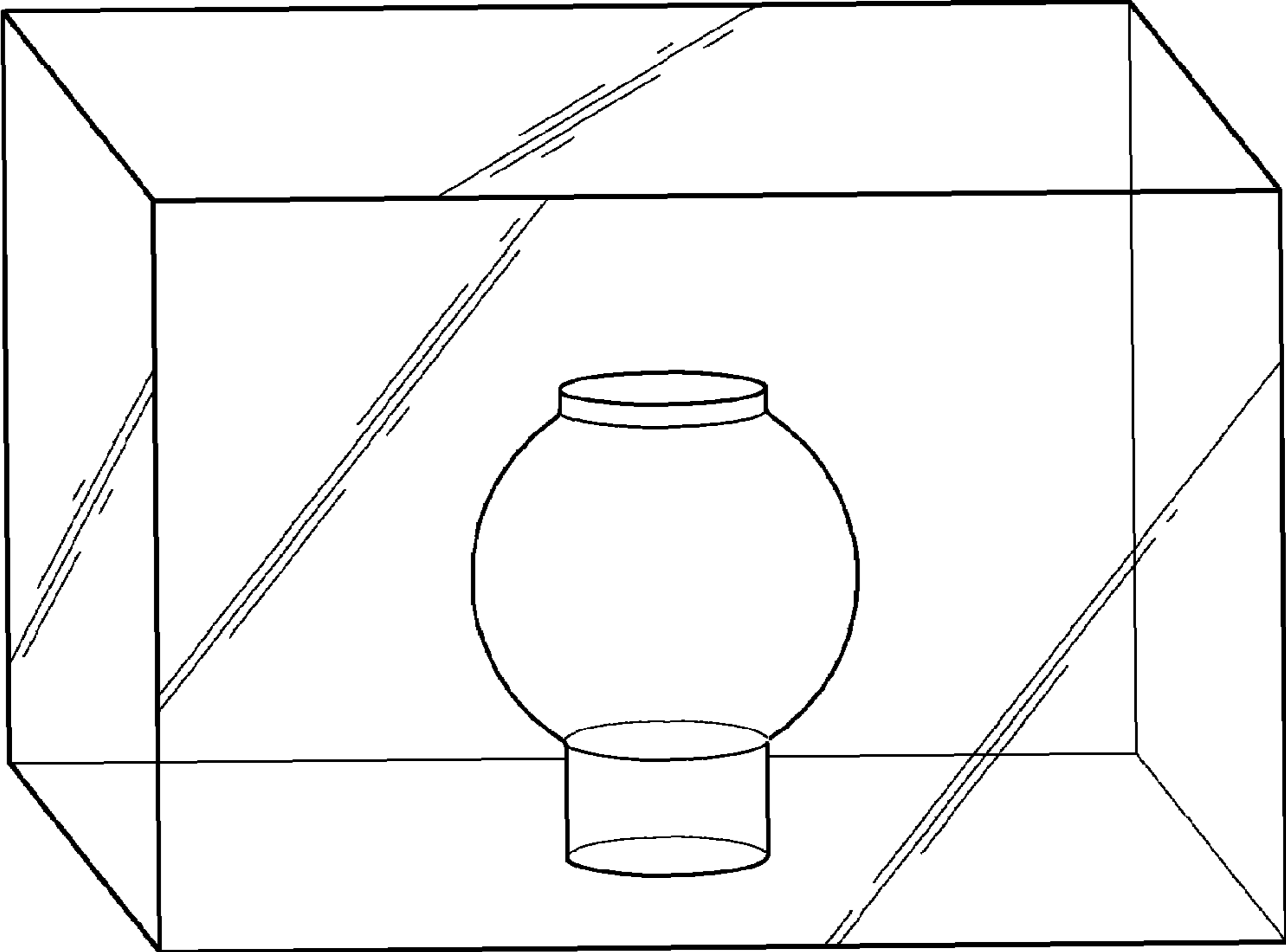
FIG. 1 is a perspective view of a combined aquarium and animal exhibit showing my new design; and,
