The ornamental design for pants, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation of pants showing my new design;

FIG. 2 is a rear elevation thereof;

FIG. 3 is a side elevation thereof;

FIG. 4 is a front elevation of a modified embodiment of the design shown in FIGS. 1 through 3;

FIG. 5 is a rear elevation thereof;

FIG. 6 is a side elevation thereof;

FIG. 7 is a front elevation of a modified embodiment of the design shown in FIGS. 1 through 3;

FIG. 8 is a rear elevation thereof; and,

FIG. 9 is a side elevation thereof.

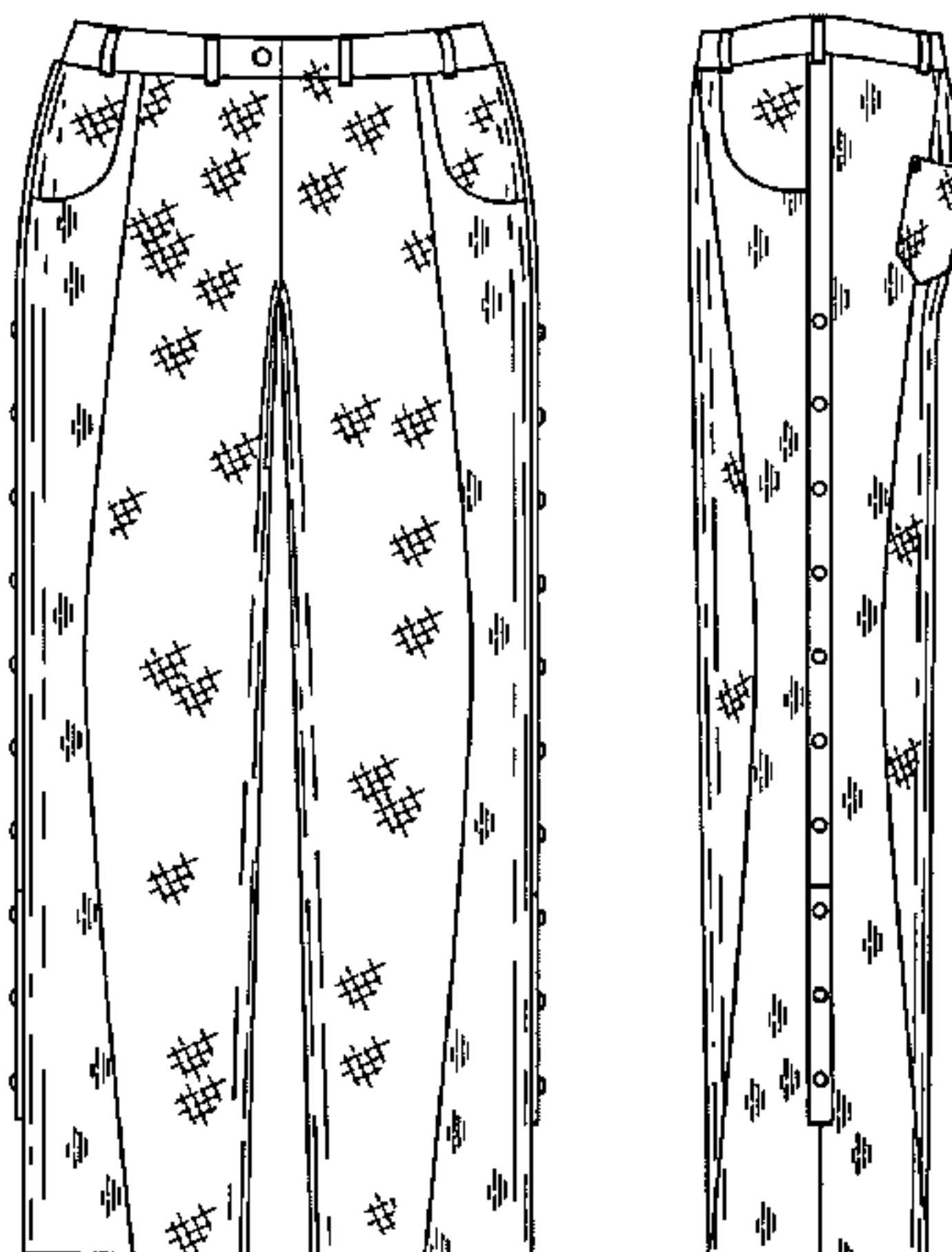

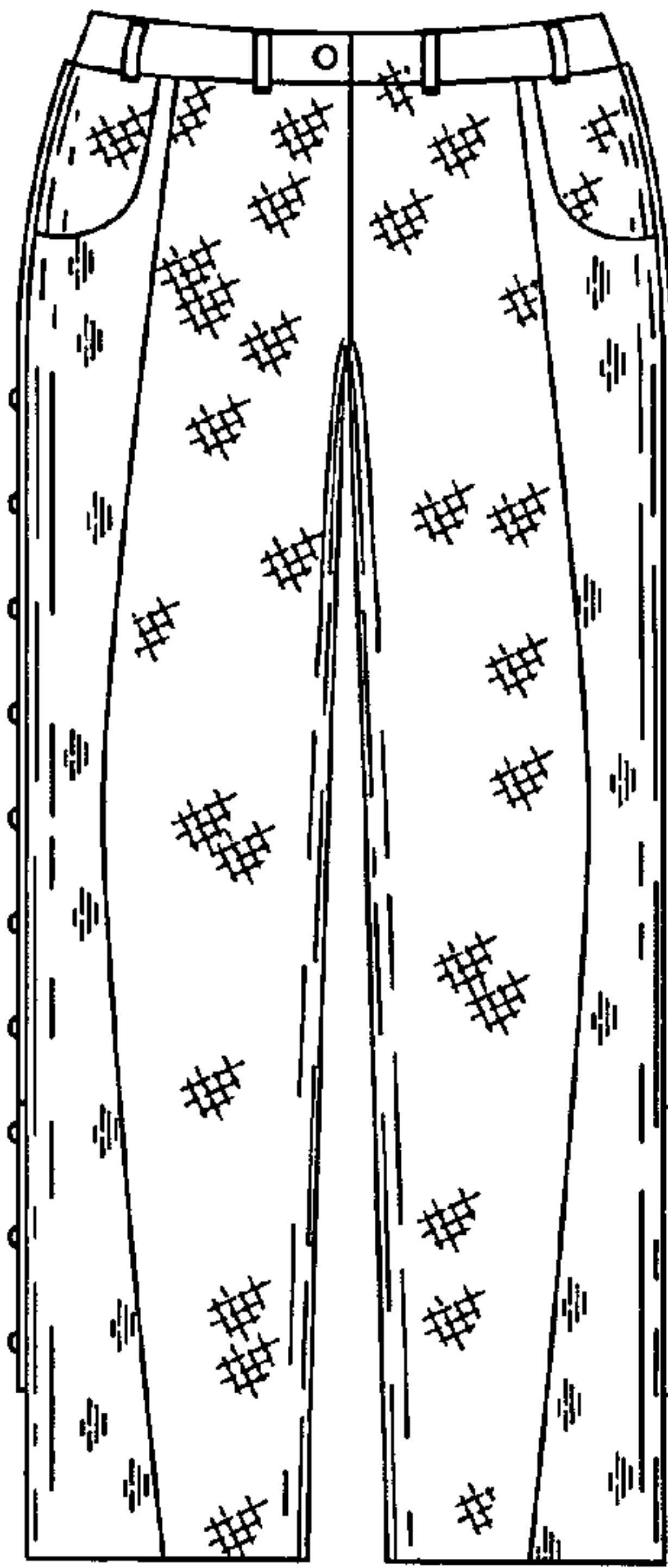

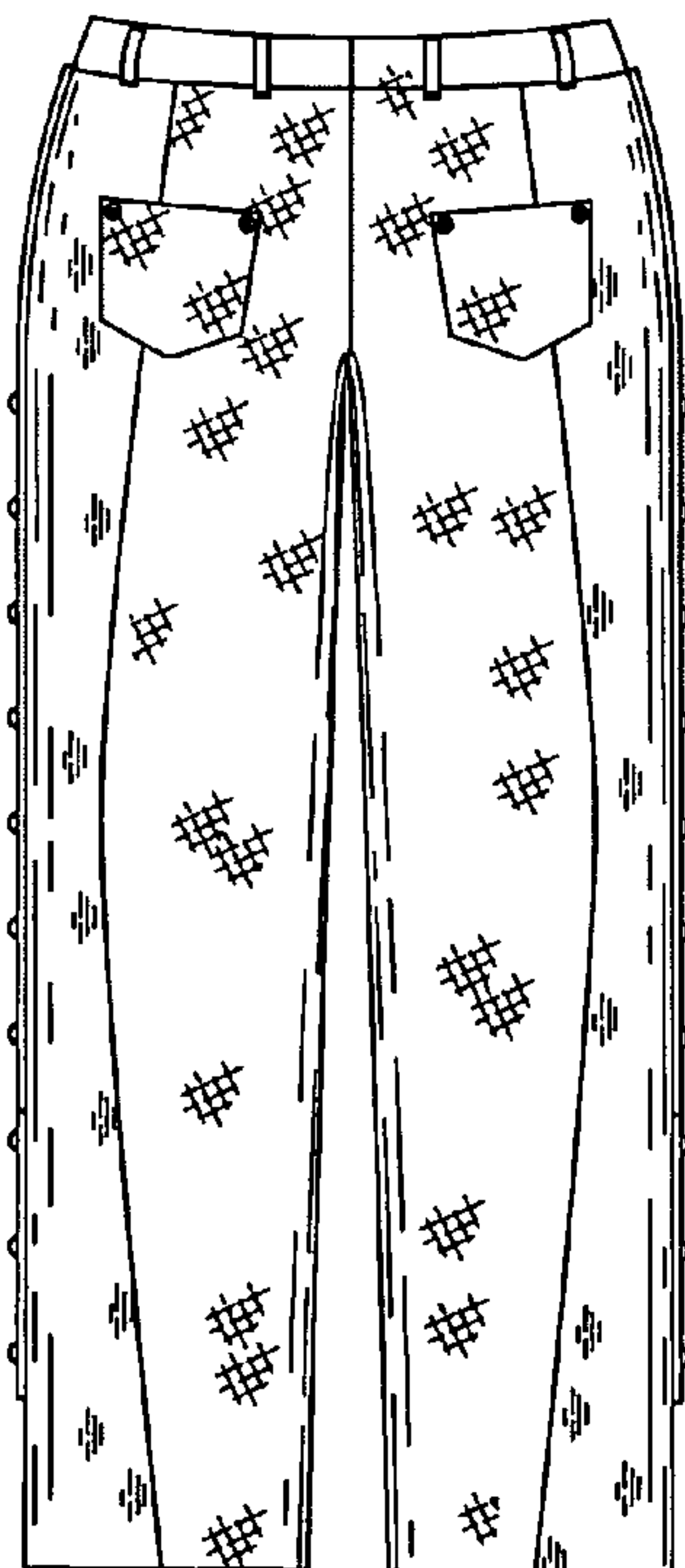

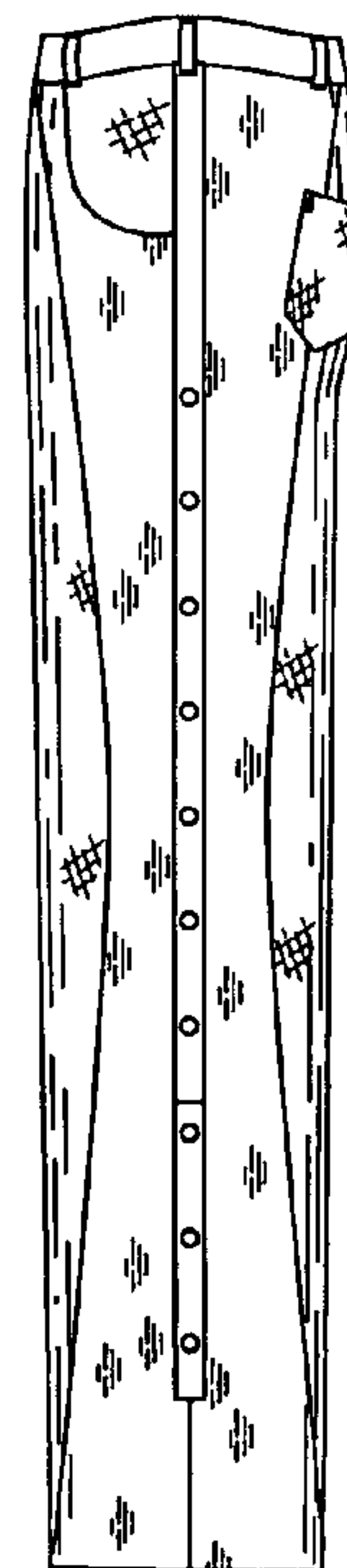

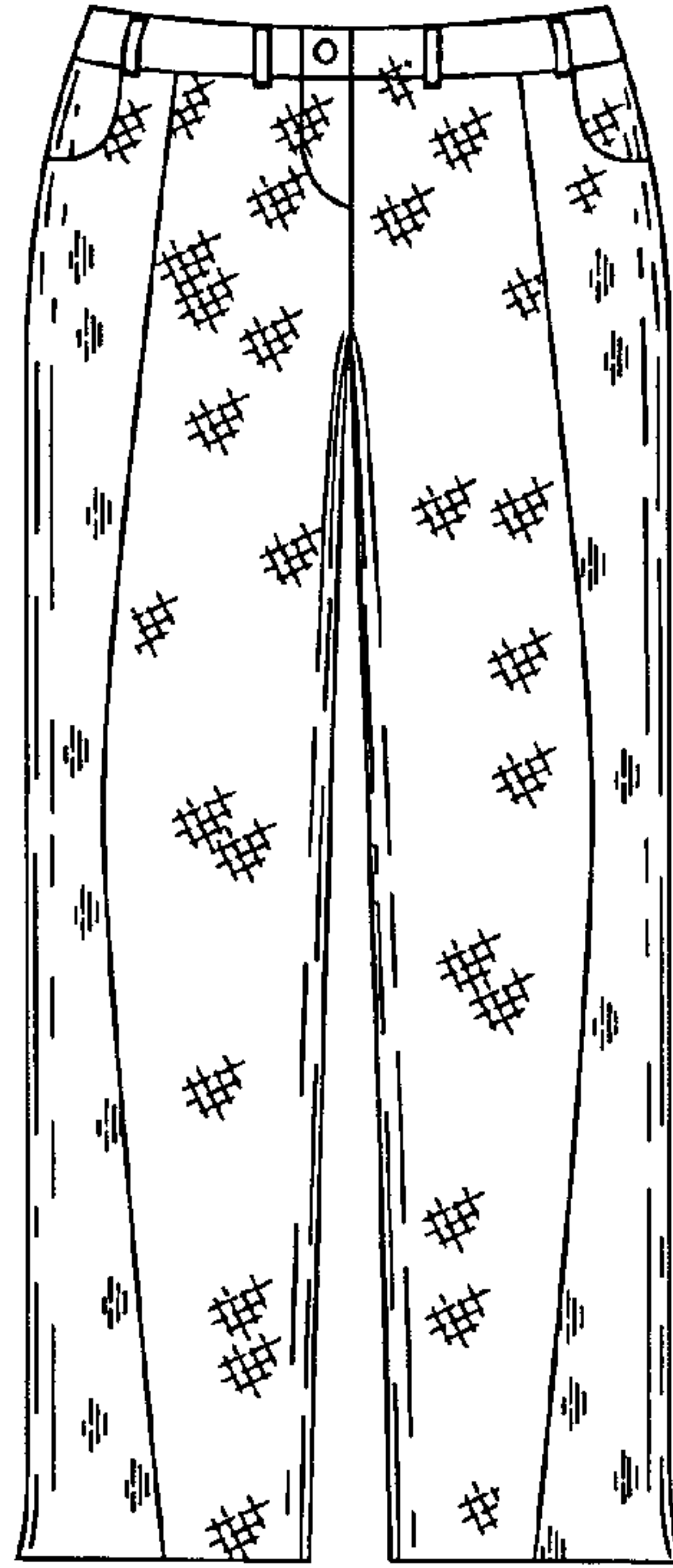

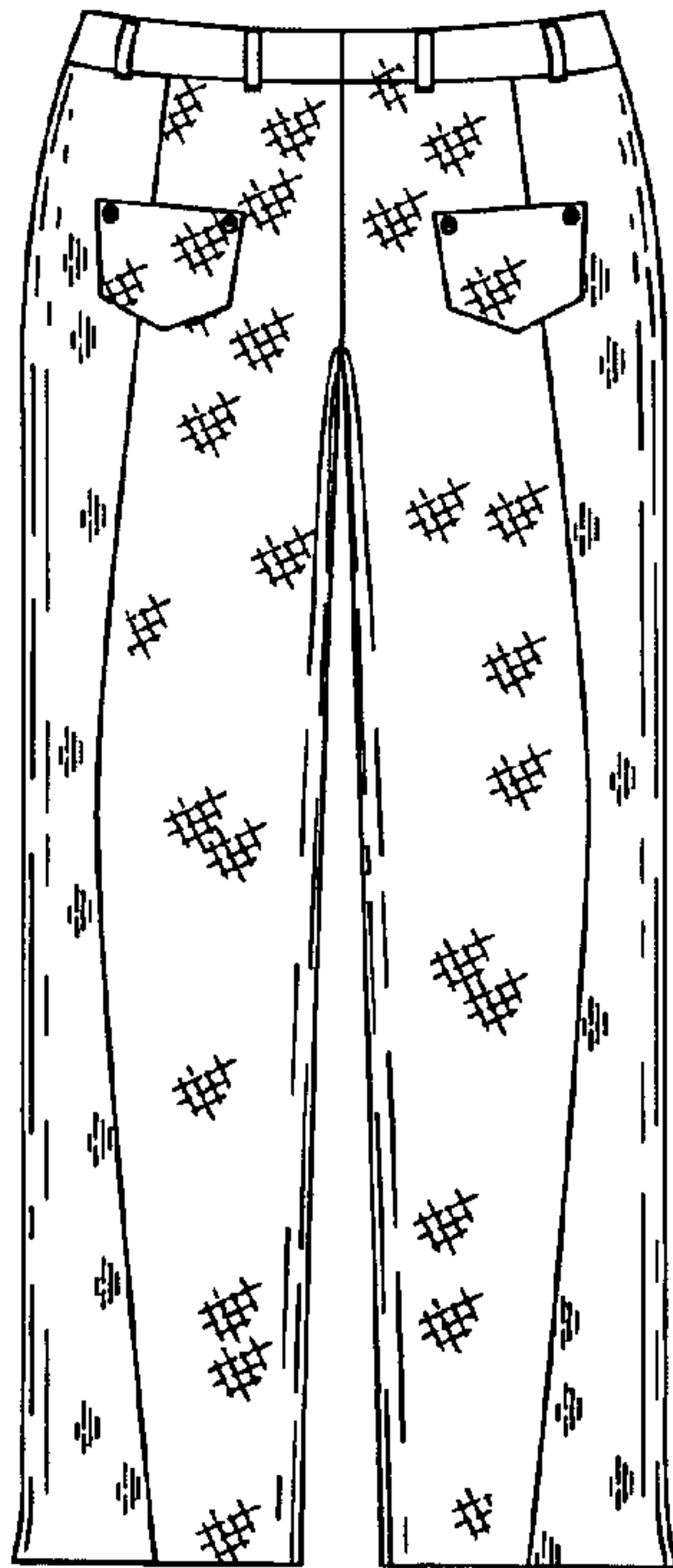

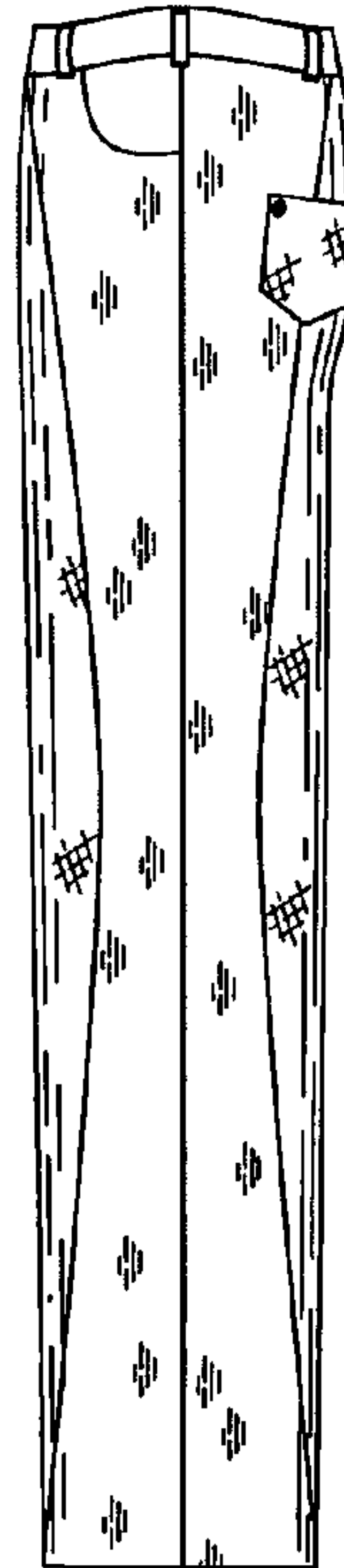

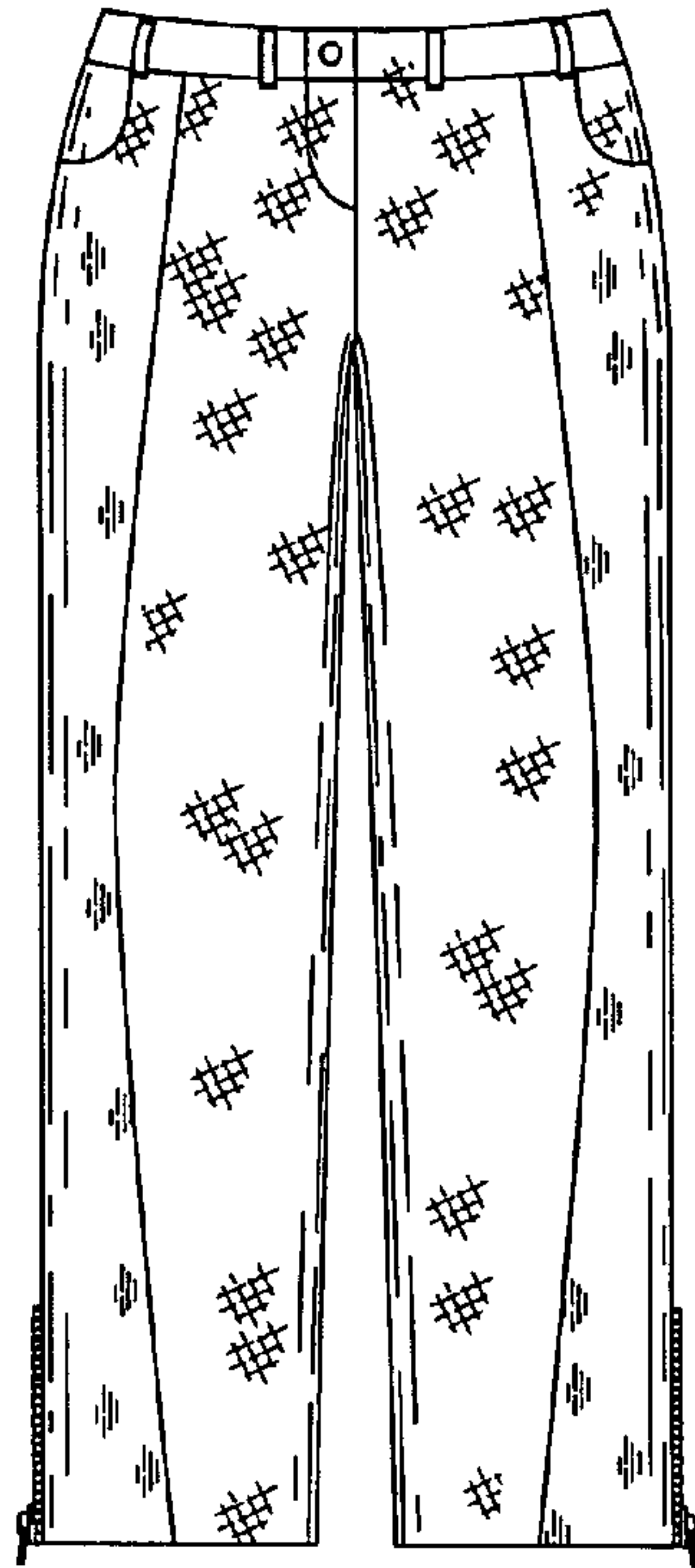

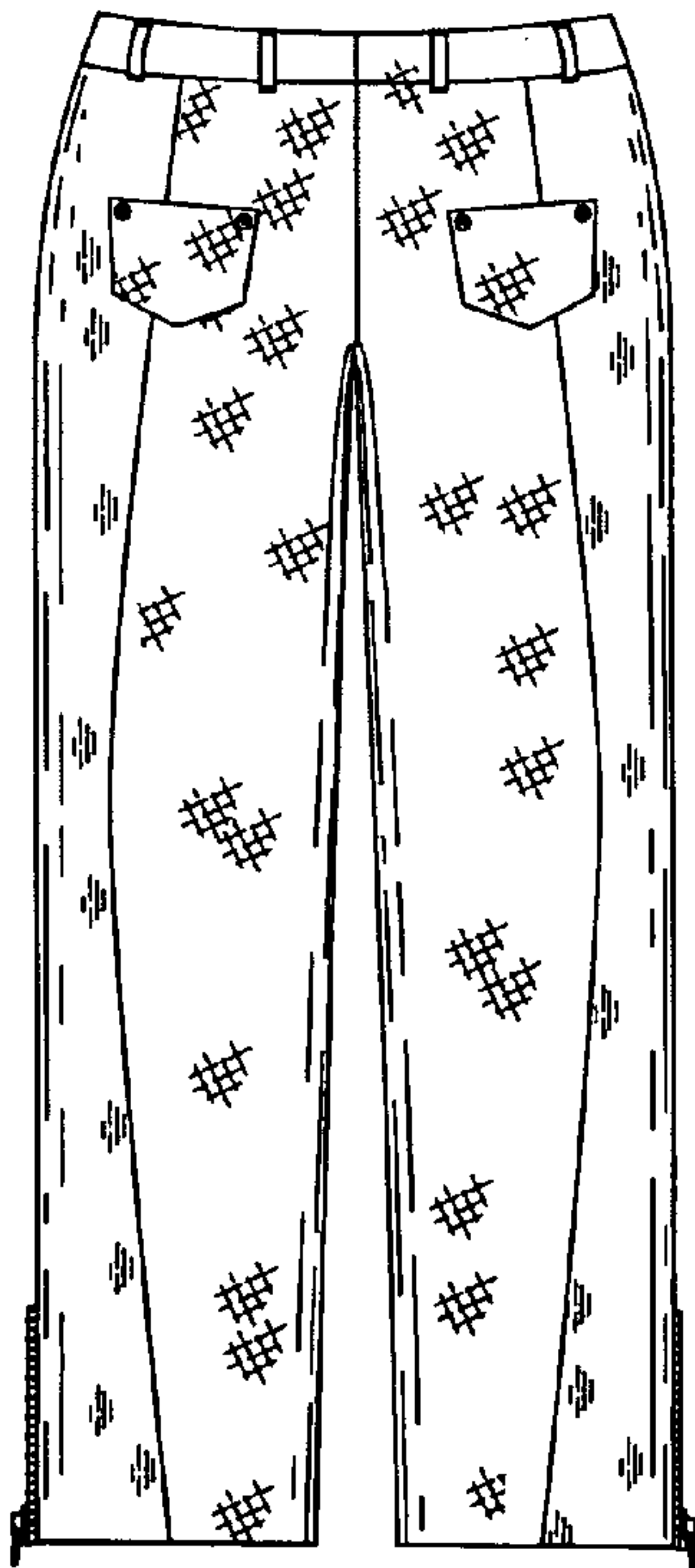
