DESCRIPTION

FIG. 1 is a front elevational view of the trousers, showing our new design;

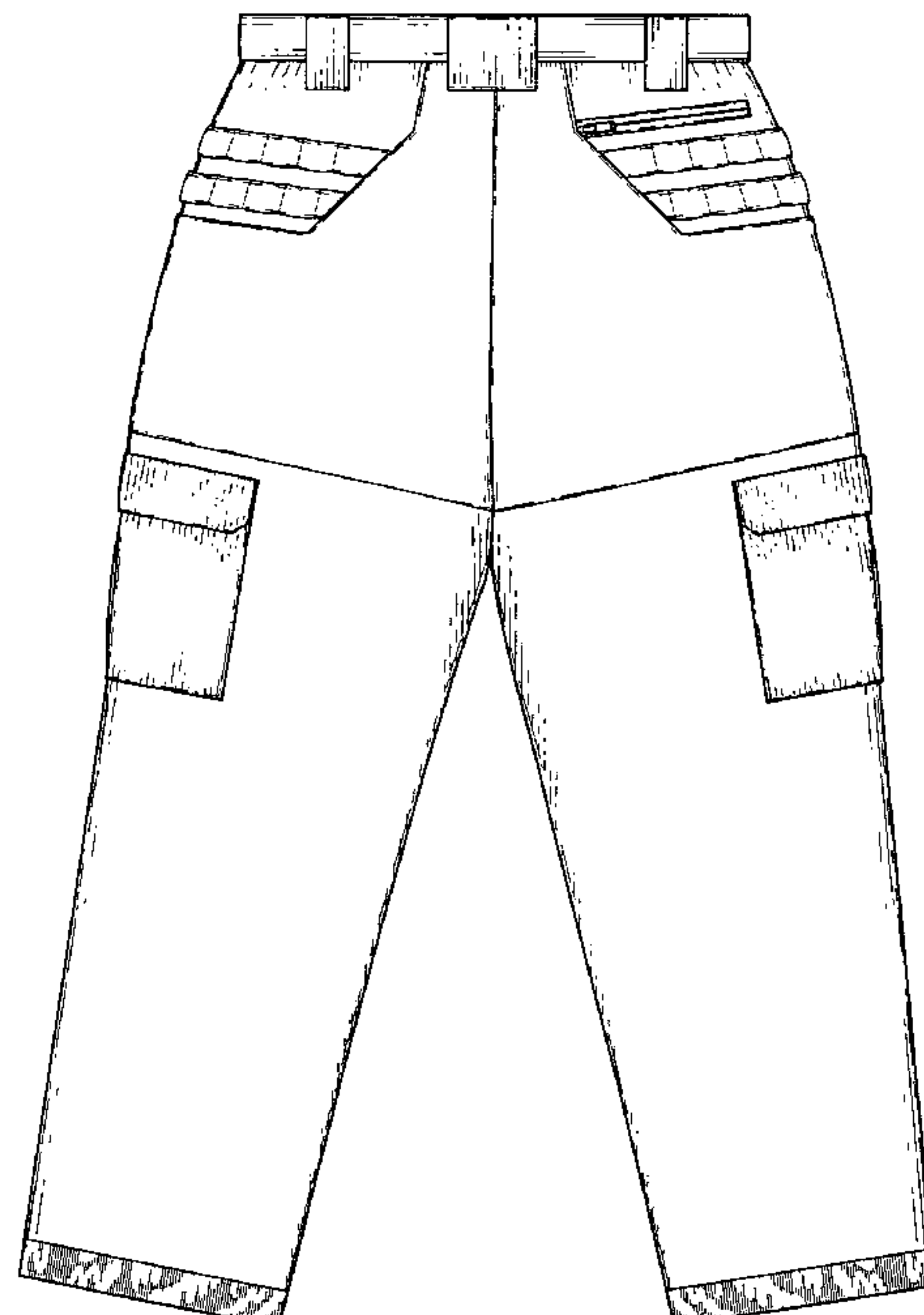
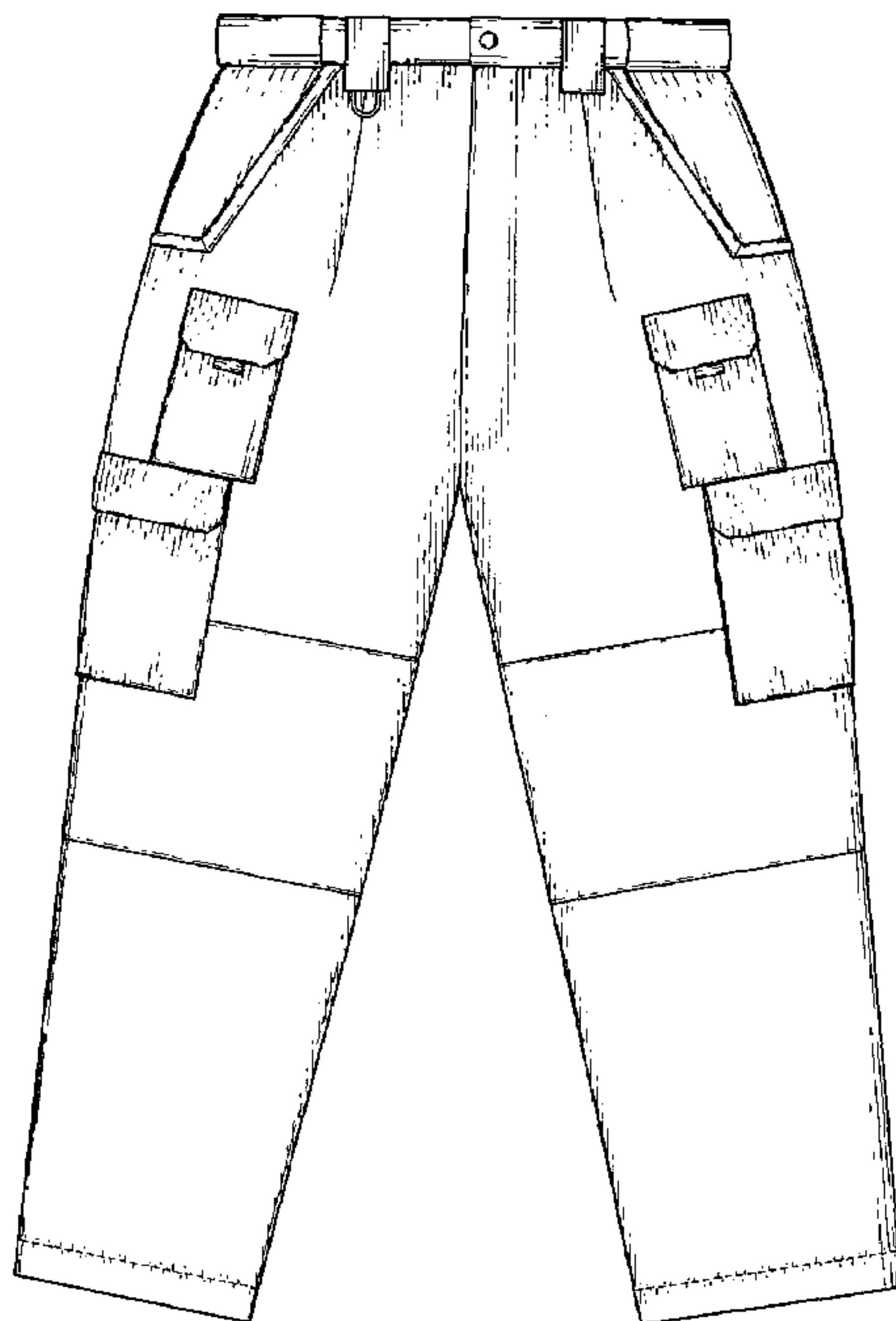
FIG. 2 is a rear elevational view thereof;

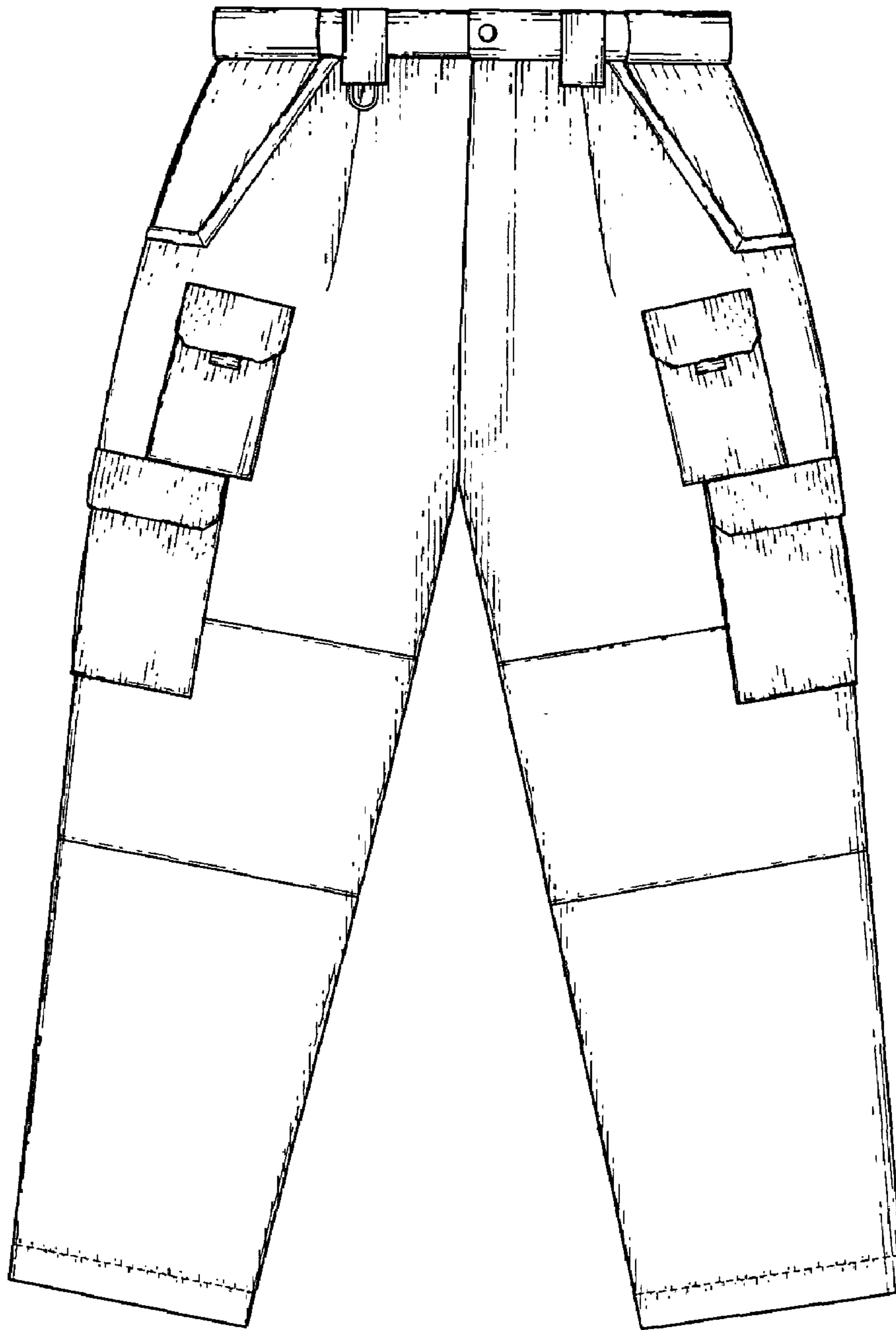

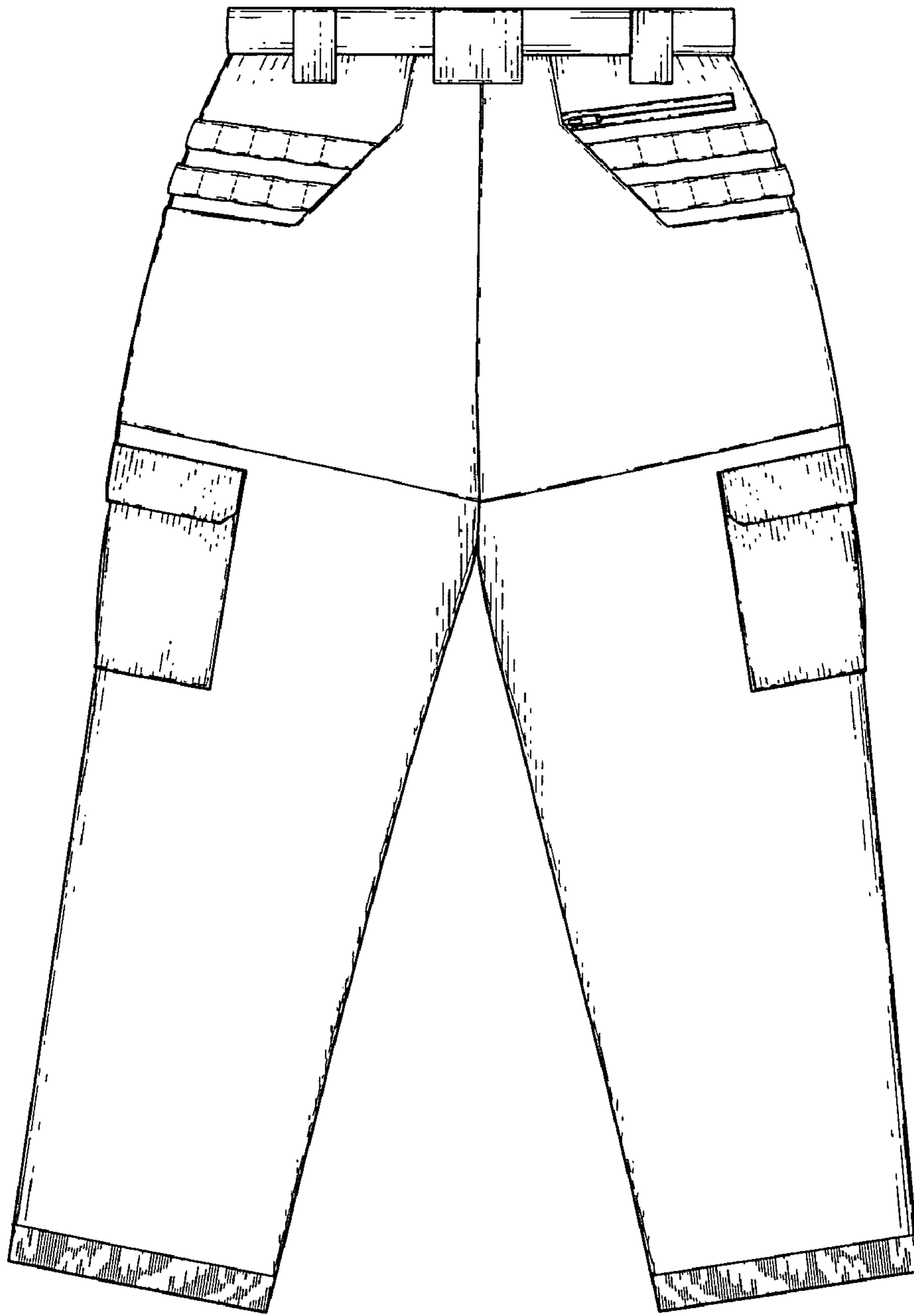

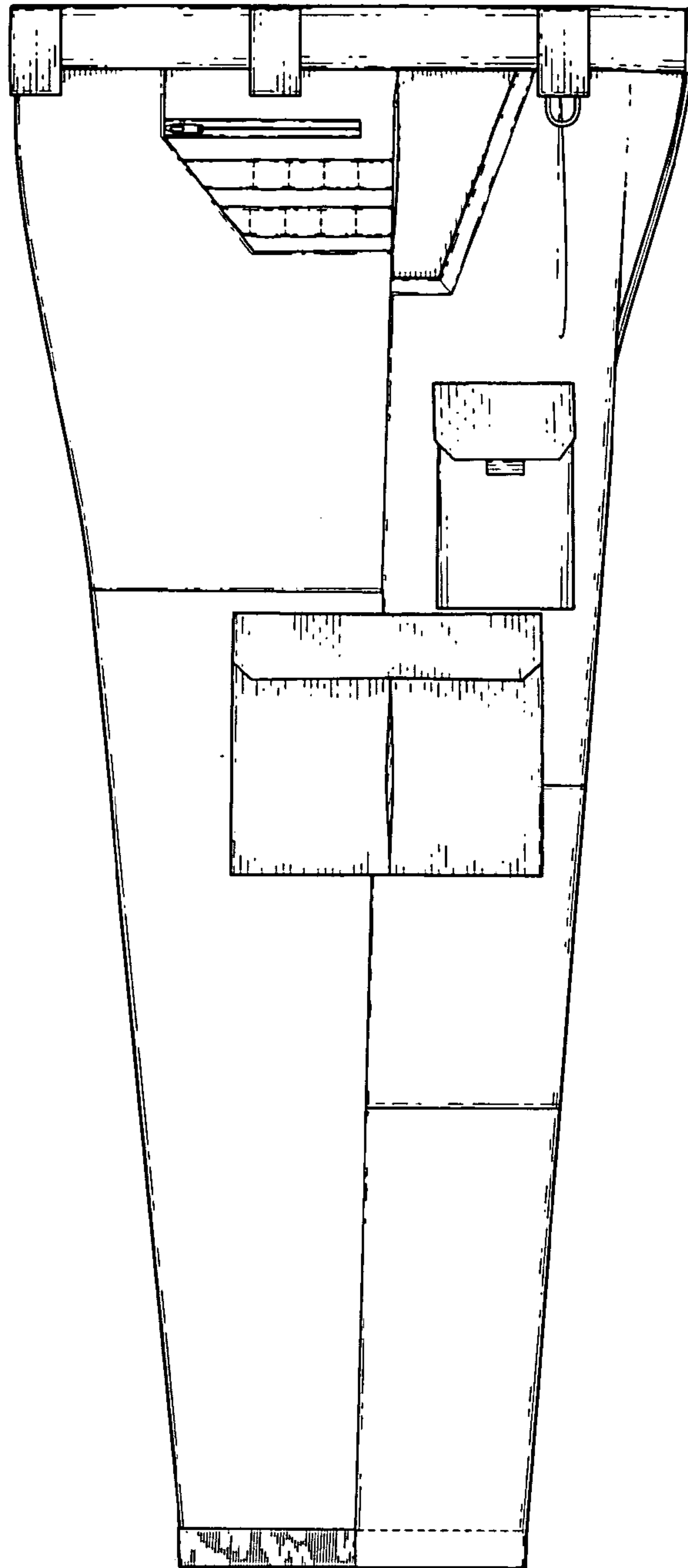

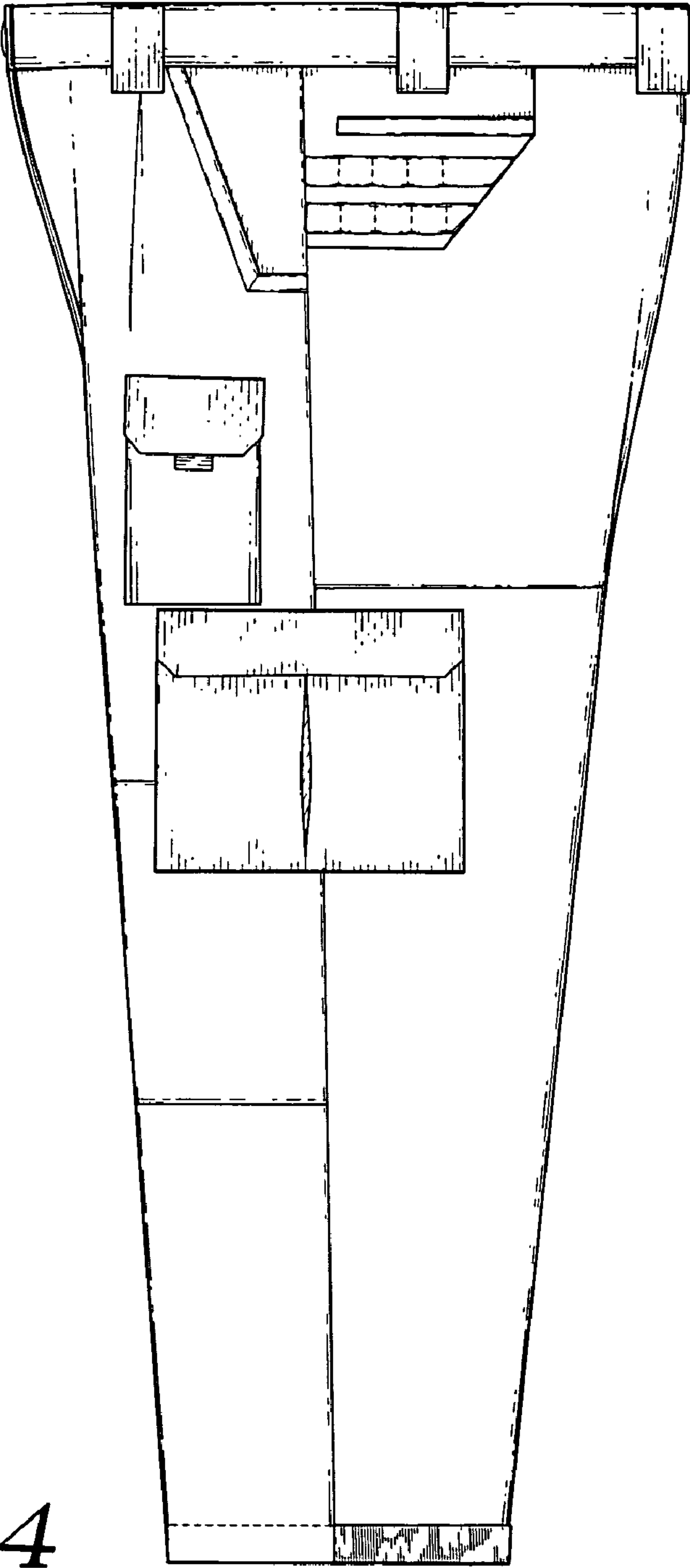
