(57) **CLAIM**

The ornamental design for a decorative piece for handbag handle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of a decorative piece for handbag handle showing my new design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a left side view thereof, with the right side view being a mirror image;

FIG. 5 is a top view thereof, with the bottom view being the same; and

FIG. 6 is a front perspective view thereof shown in environment.

FIG. 7 is a front perspective view of a second embodiment of a decorative piece for handbag handle;

FIG. 8 is a front view thereof;

FIG. 9 is a rear view thereof;

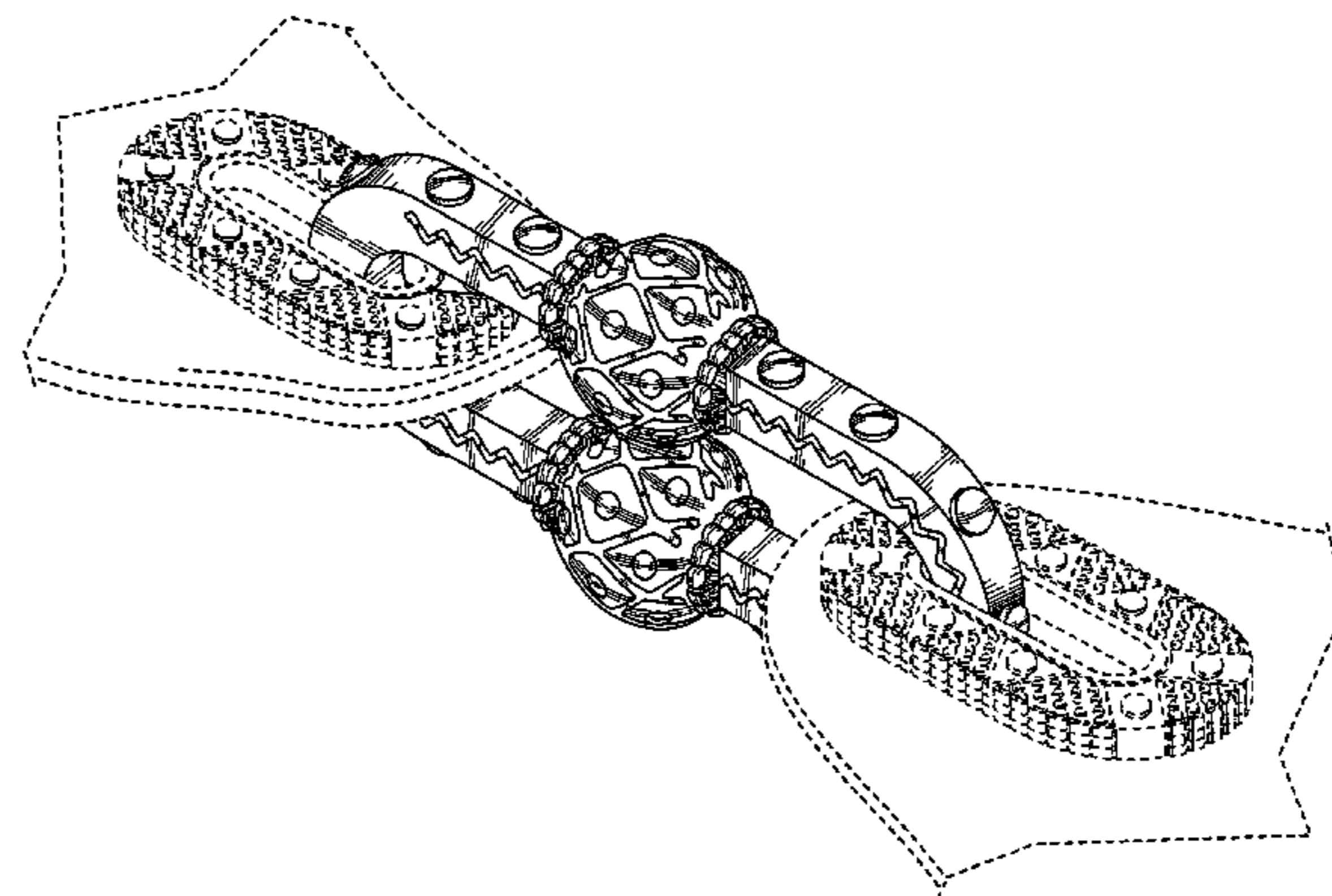
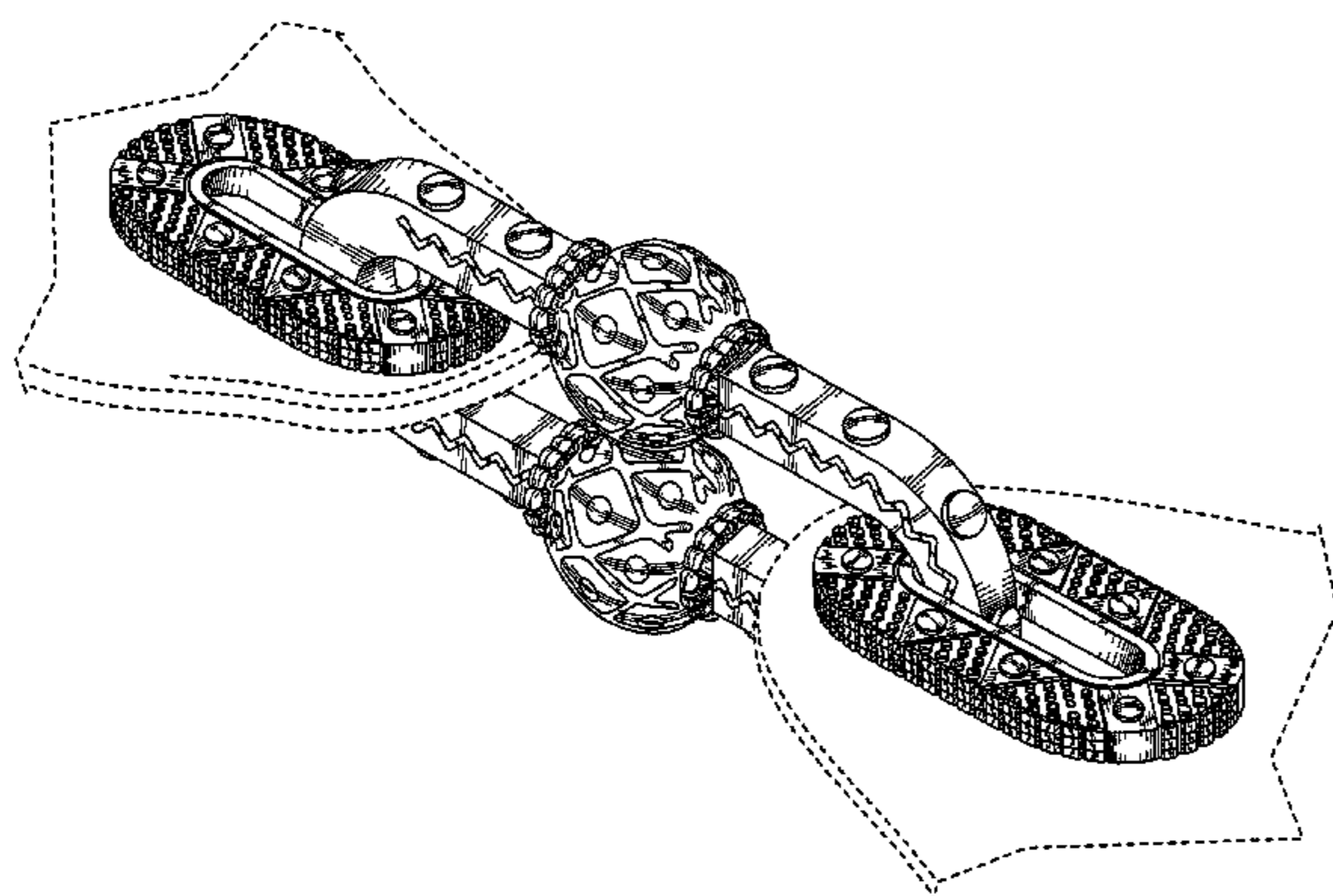
FIG. 10 is a left side view thereof, with the right side view being a mirror image;

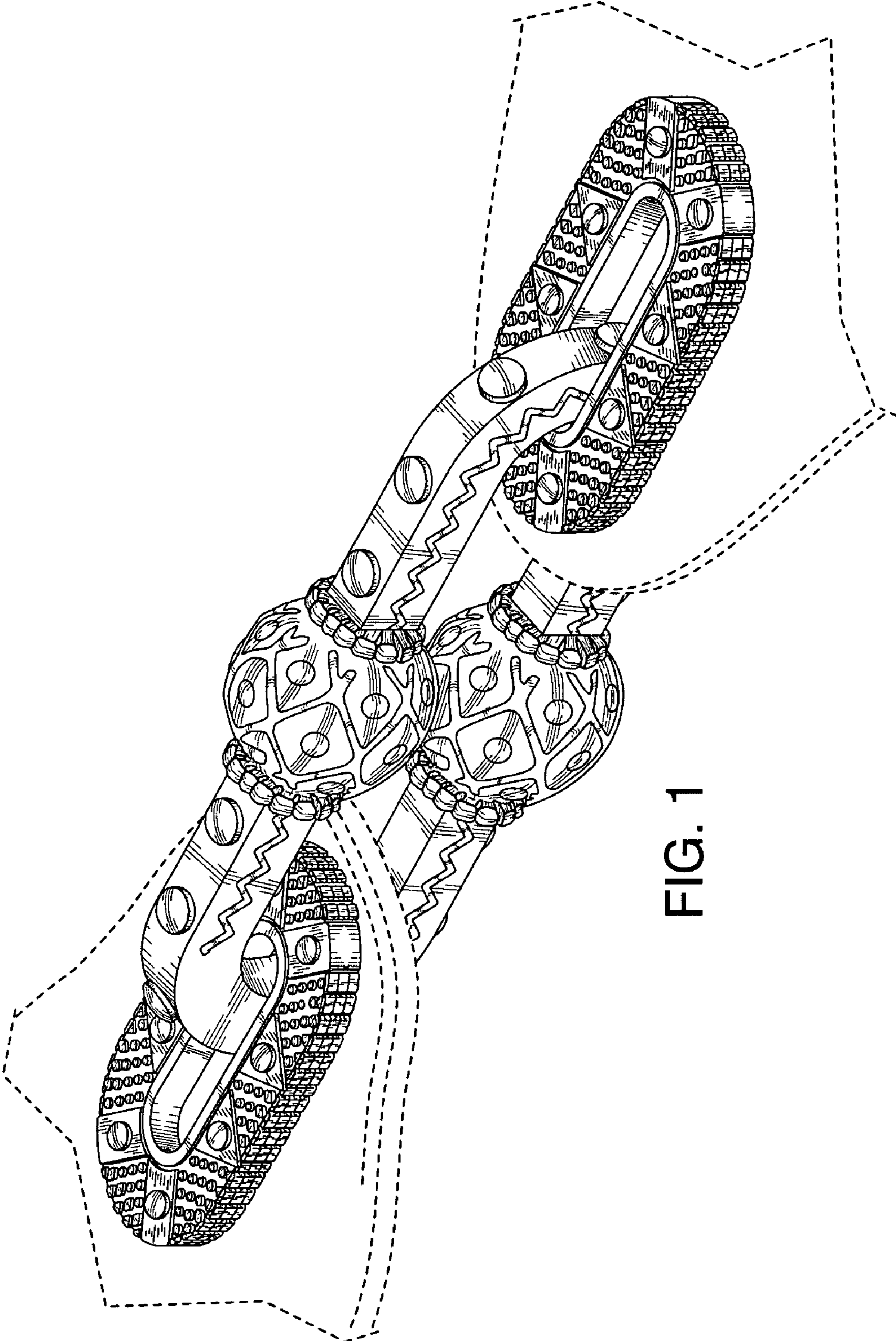

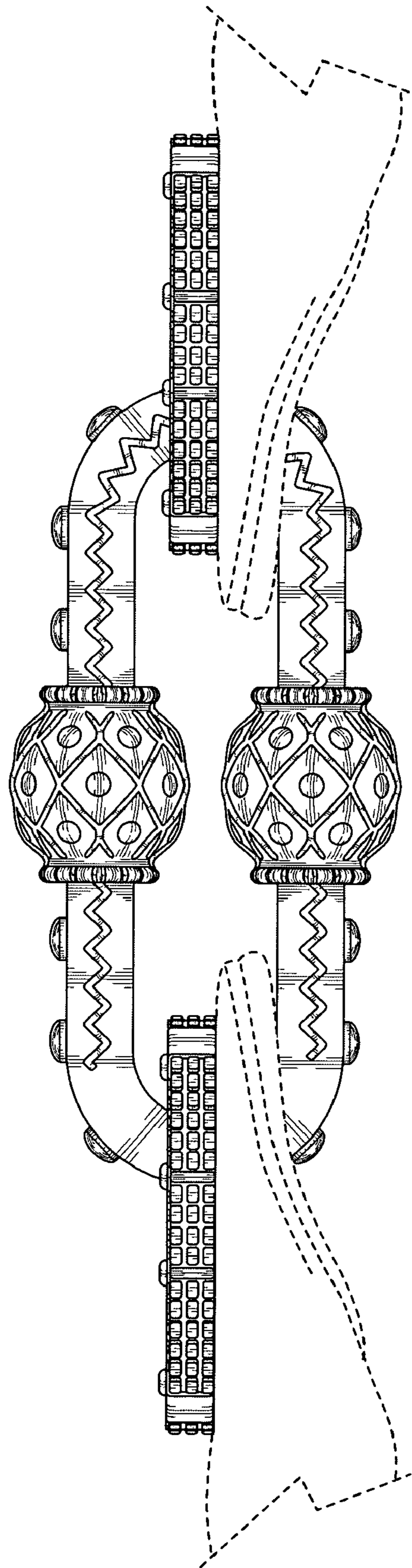

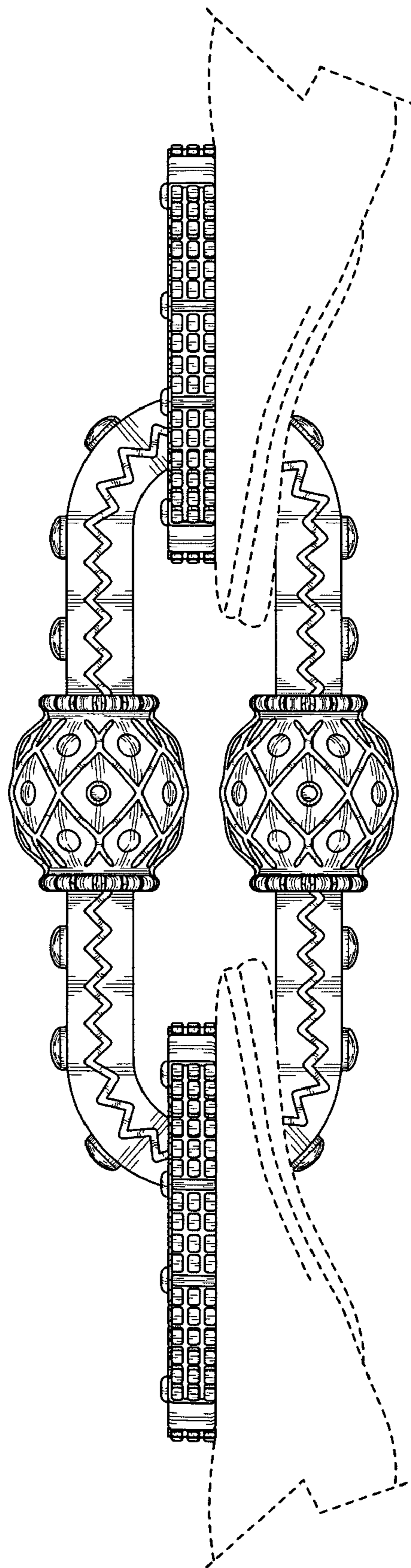

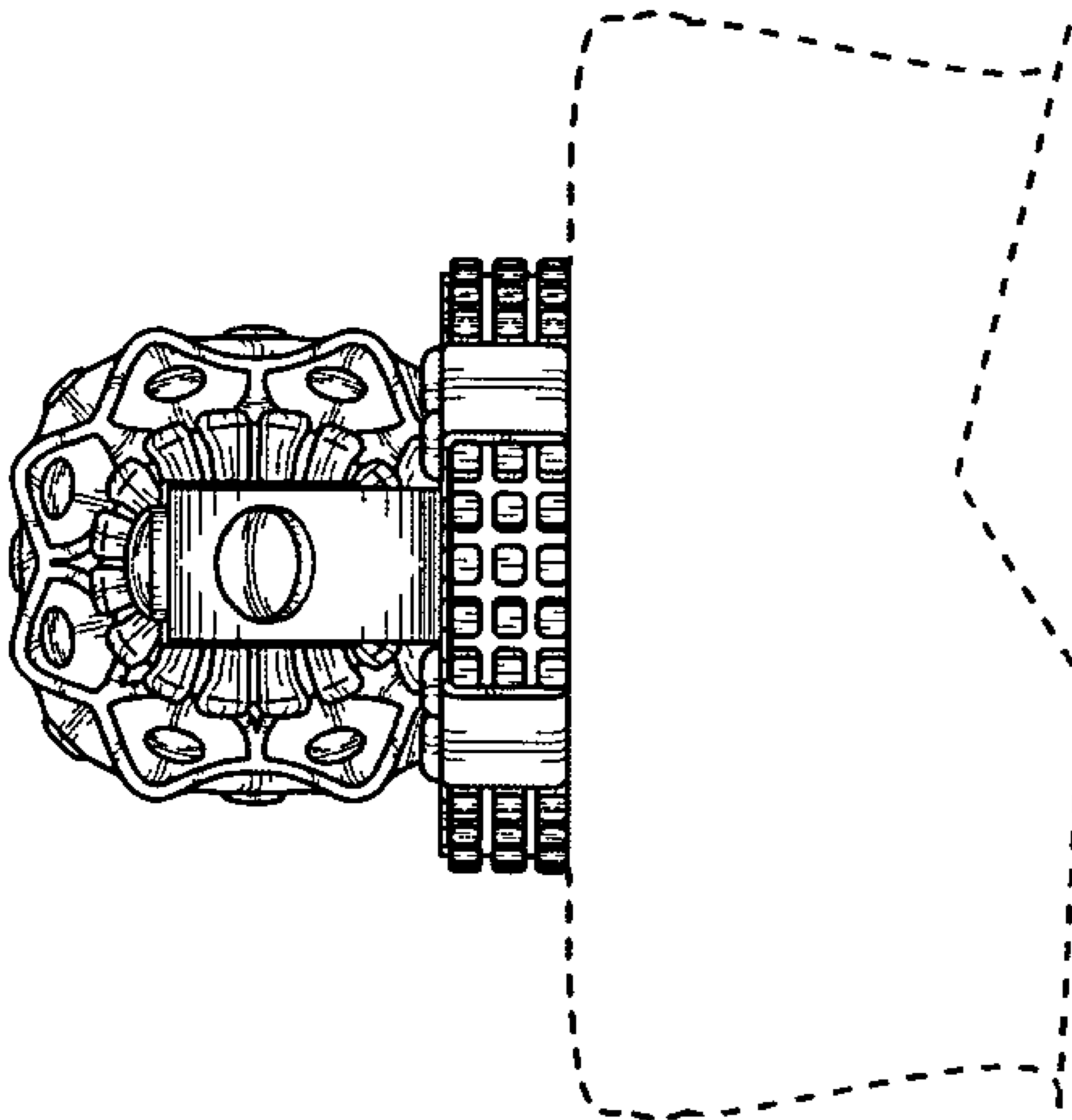

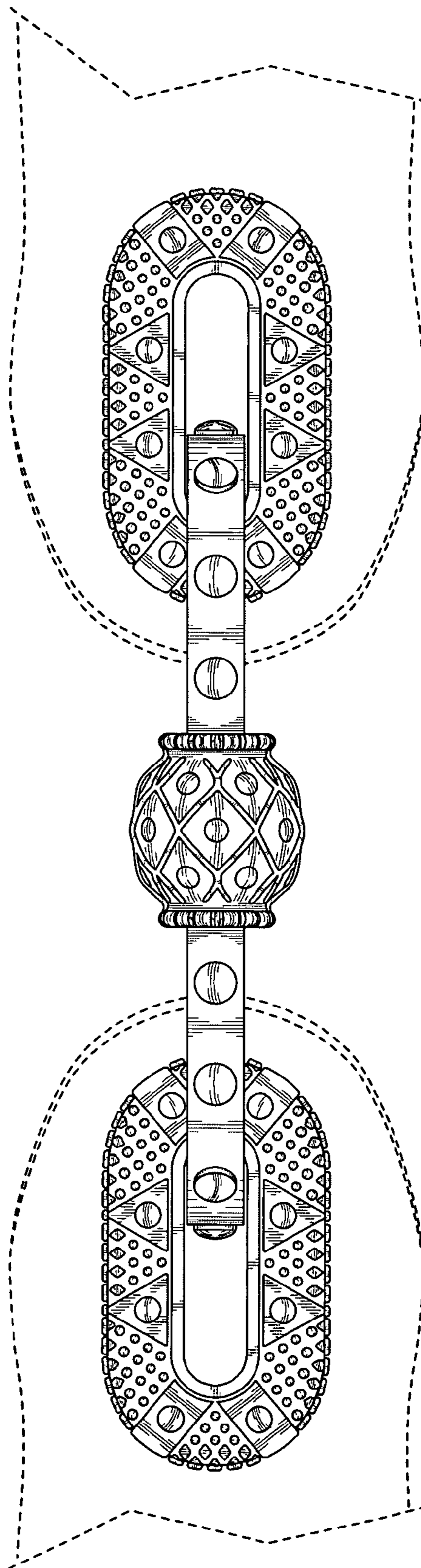

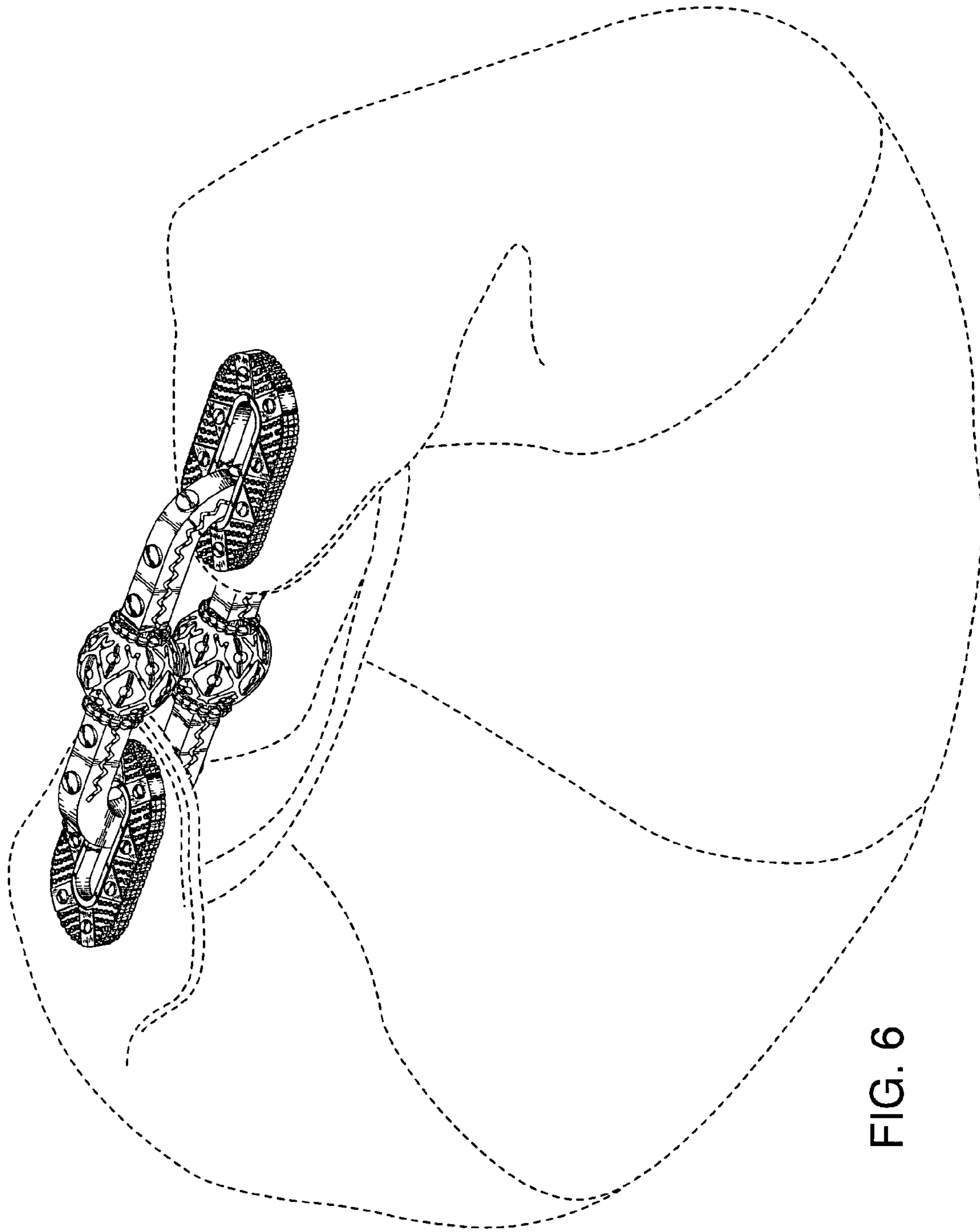

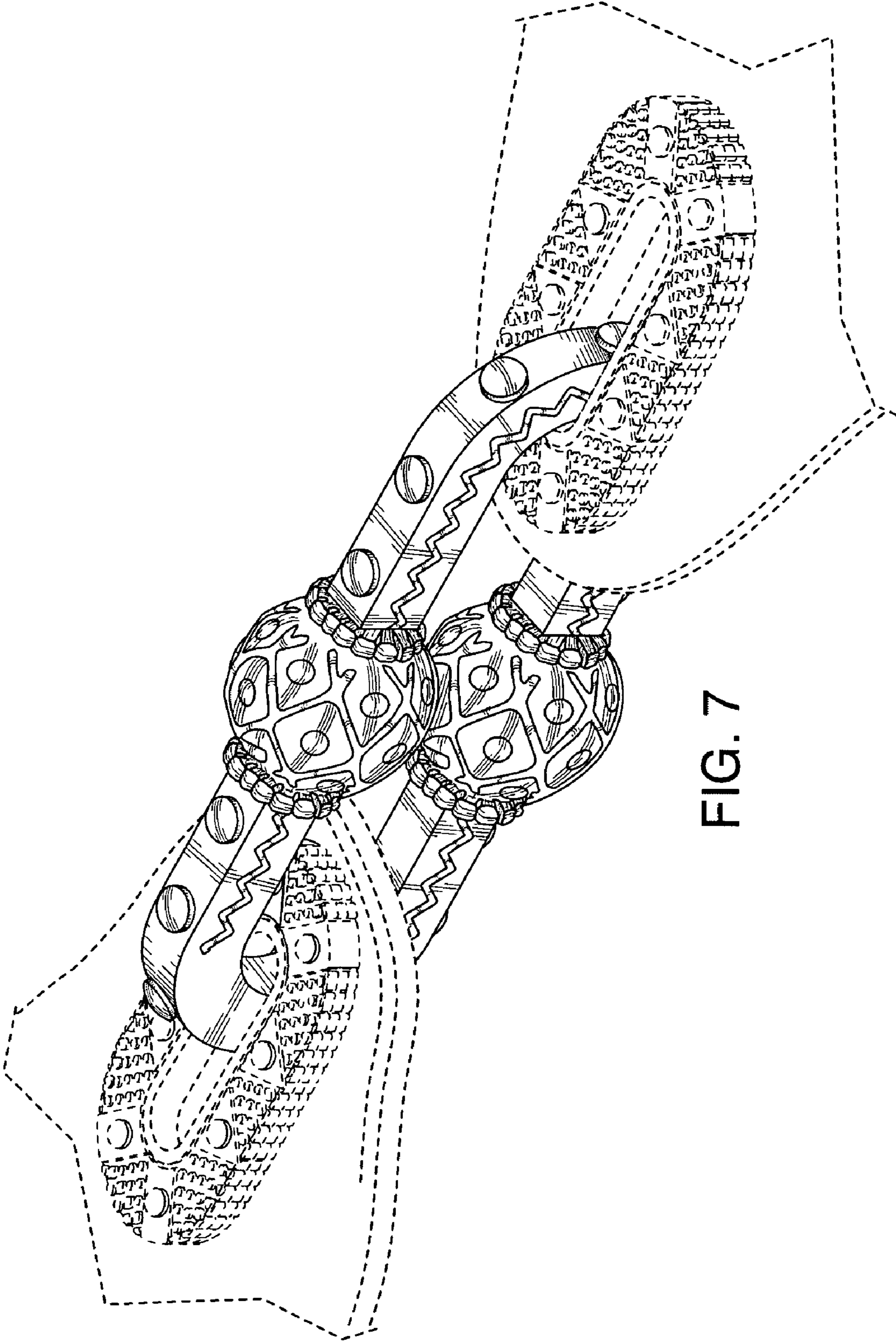

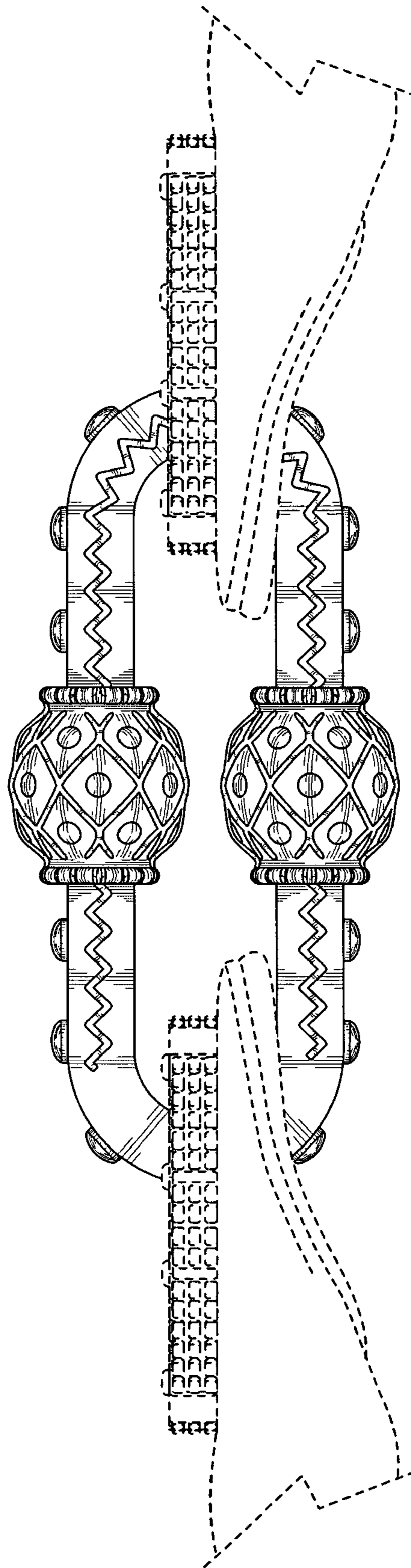

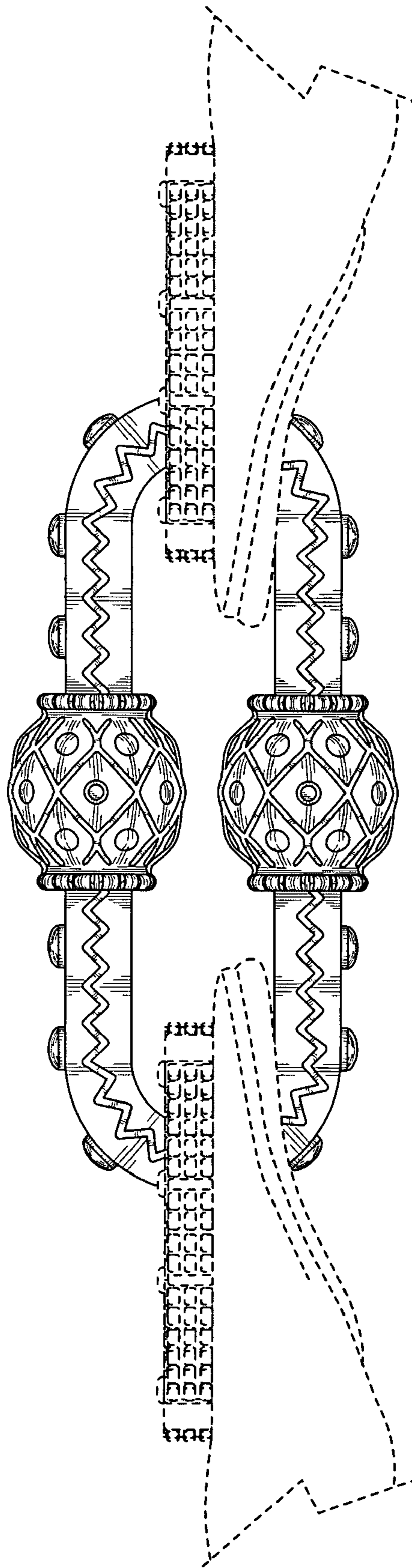

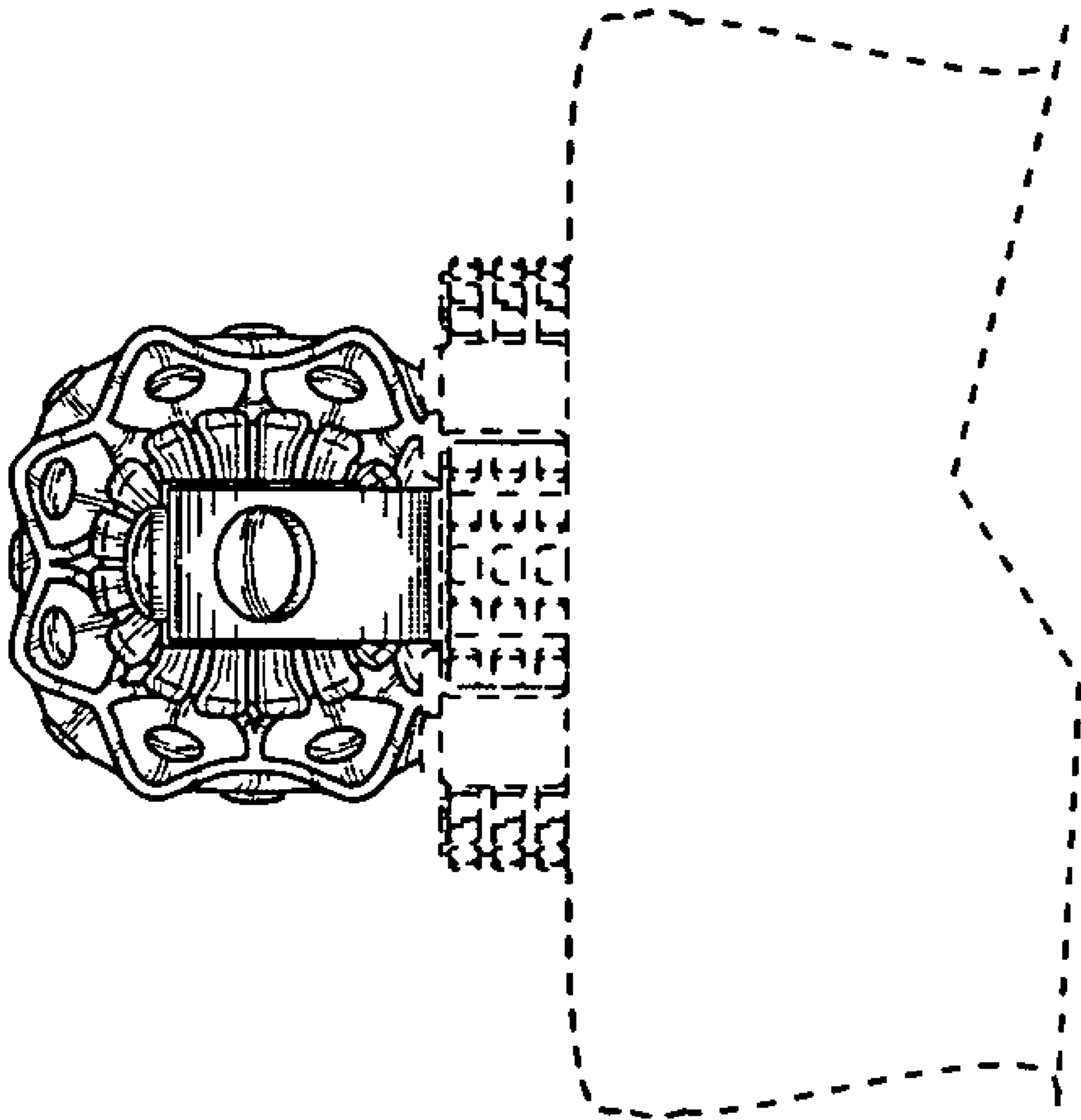

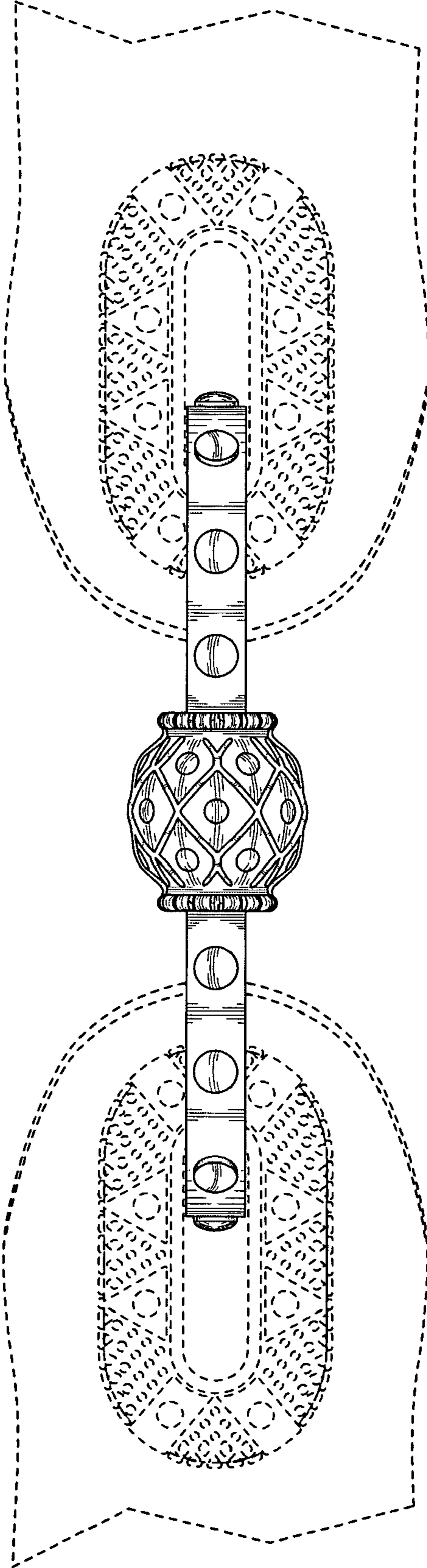

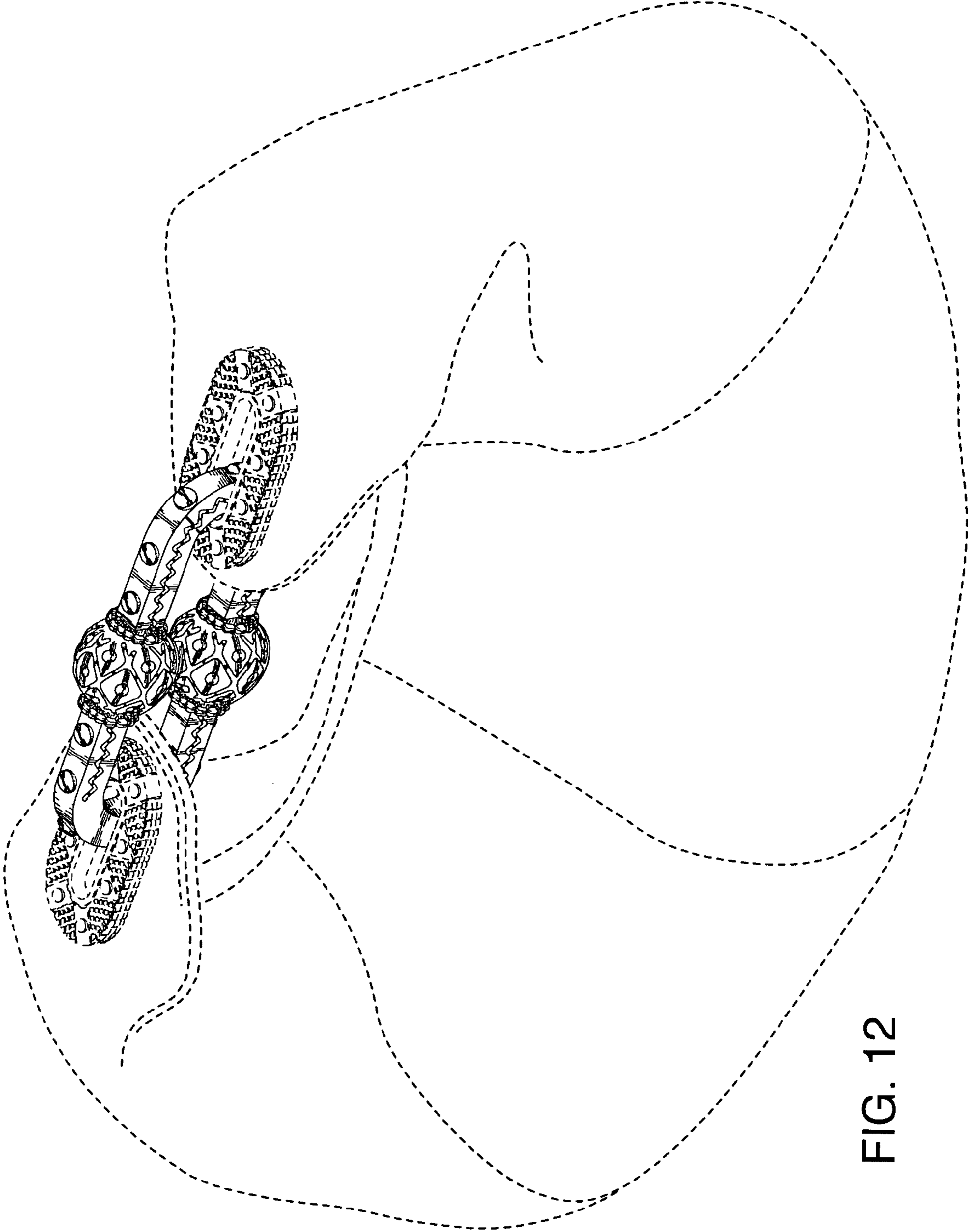
