(57) **CLAIM**

The ornamental design for a paint brush cover, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a paint brush cover according to the design of the present invention;

FIG. 2 is a front view of the cover;

FIG. 3 is a back view of the cover;

FIG. 4 is a left side view of the cover;

FIG. 5 is a right side view of the cover;

FIG. 6 is a top view of the cover;

FIG. 7 is a bottom view of the cover; and,

FIG. 8 is a reference drawing of the cover in use.

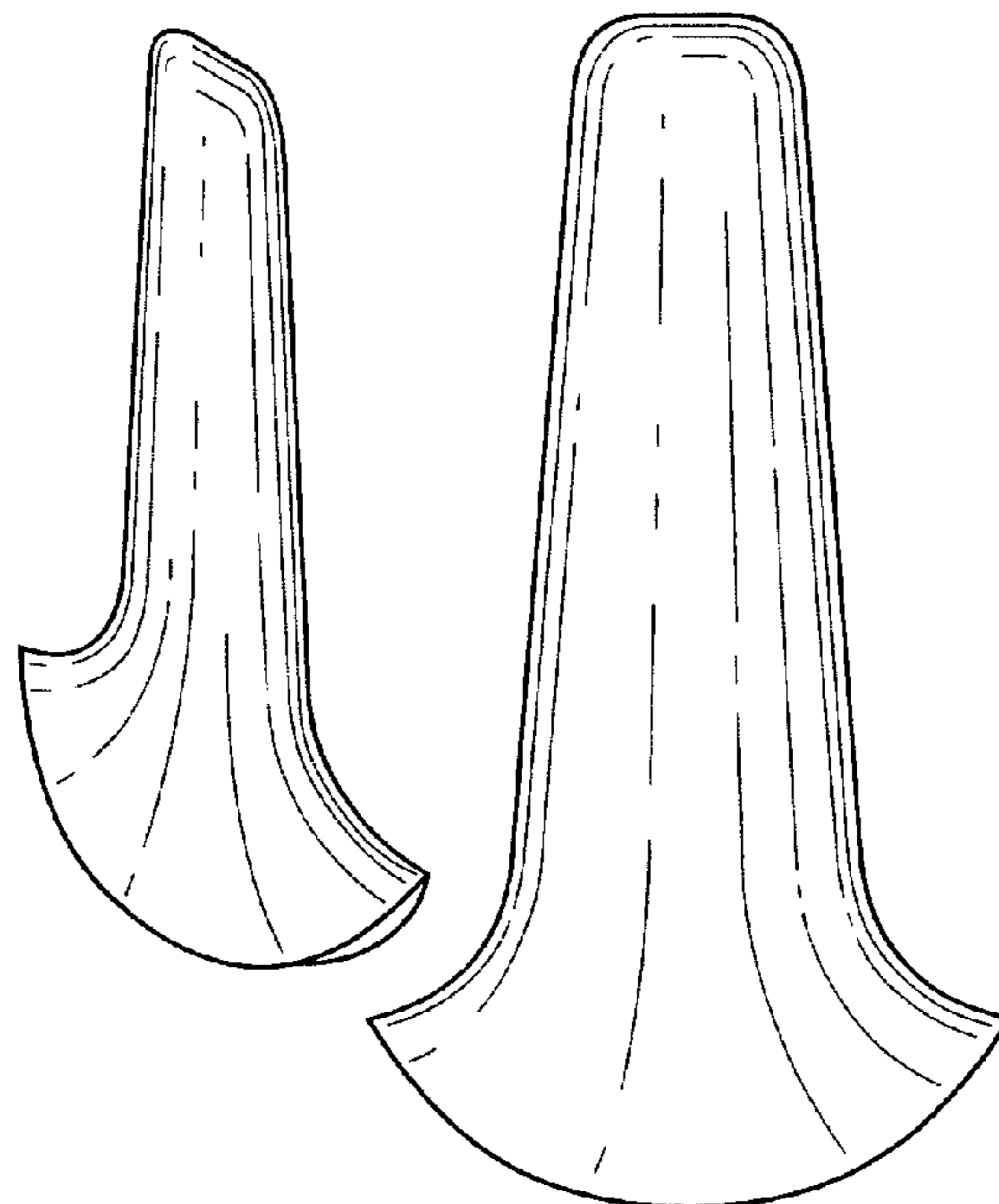

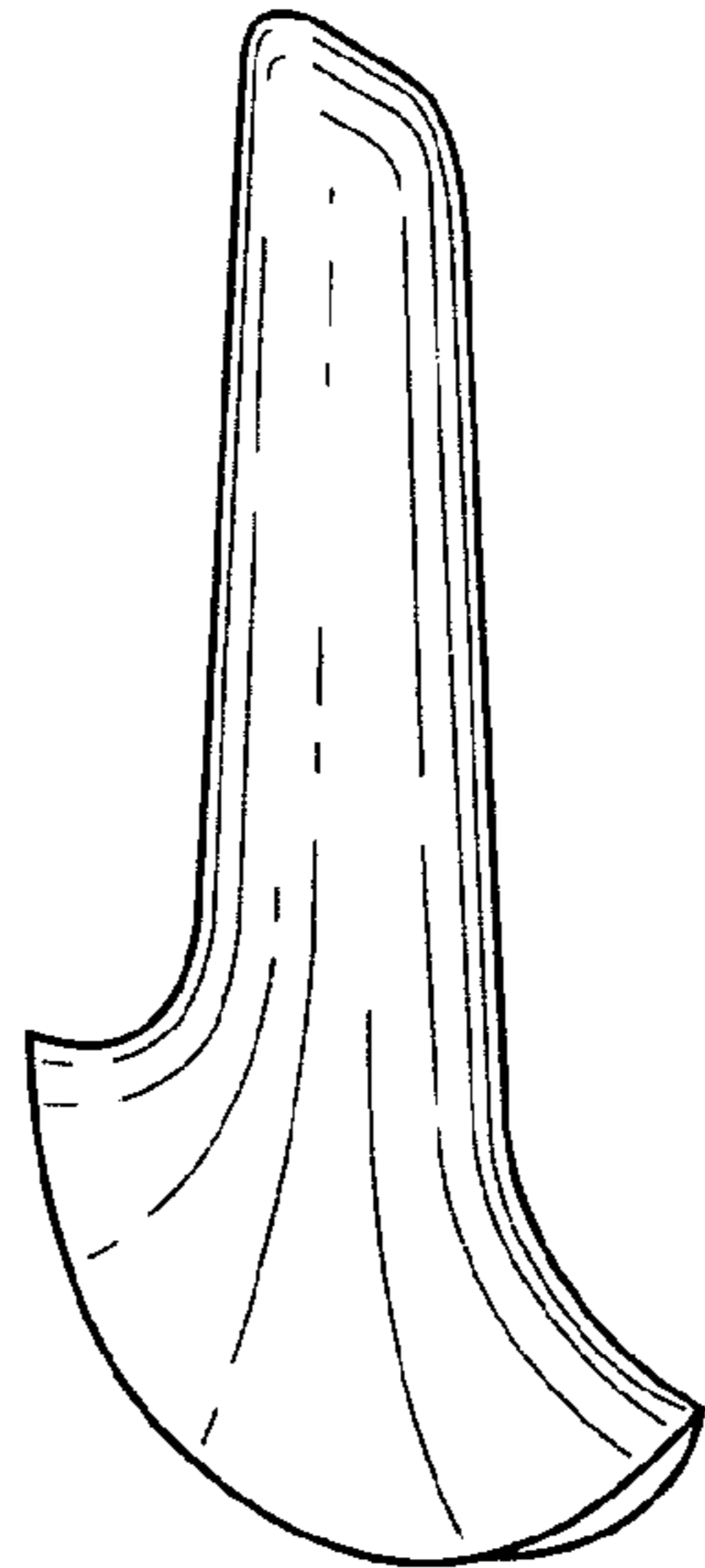

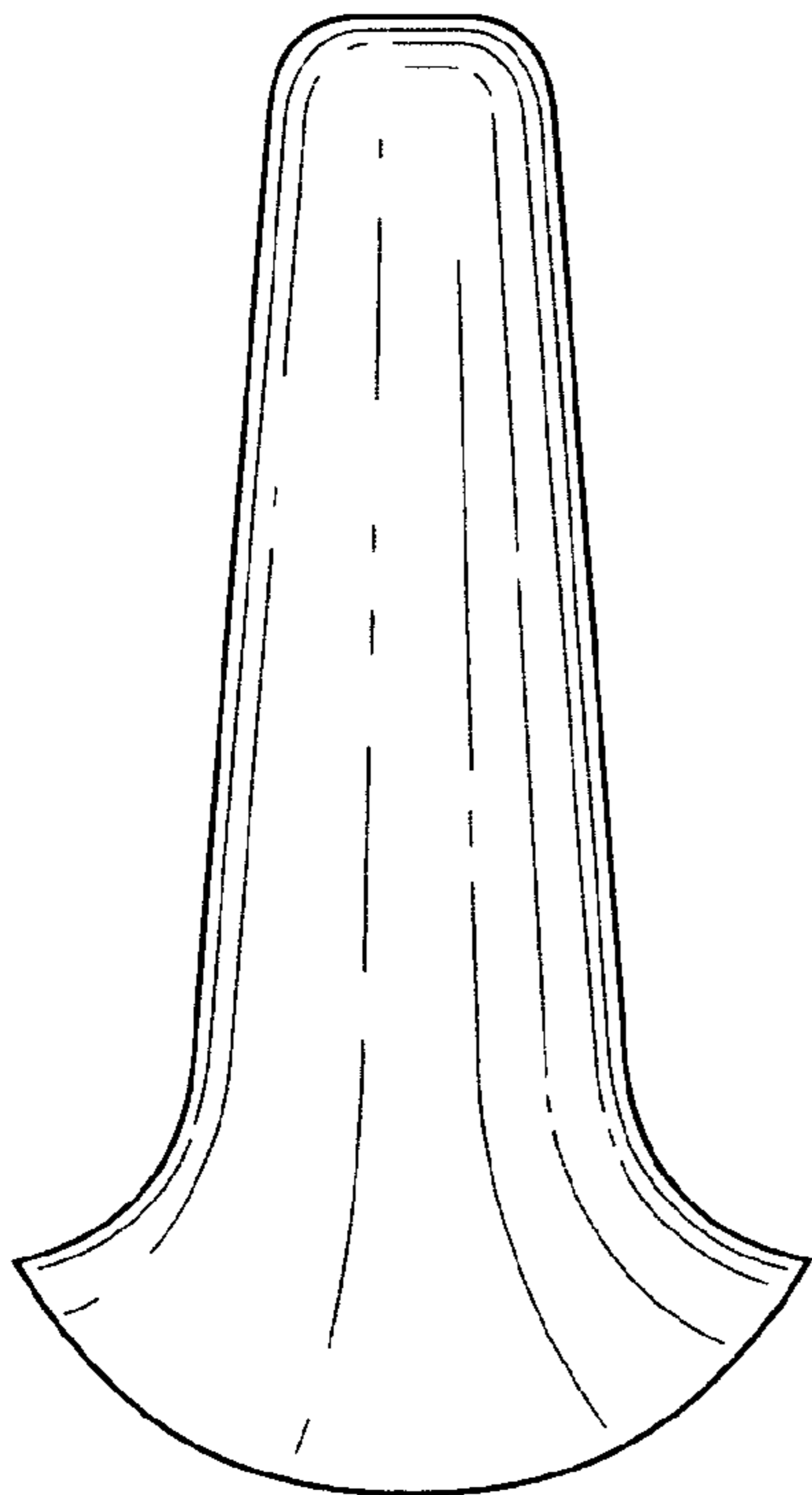

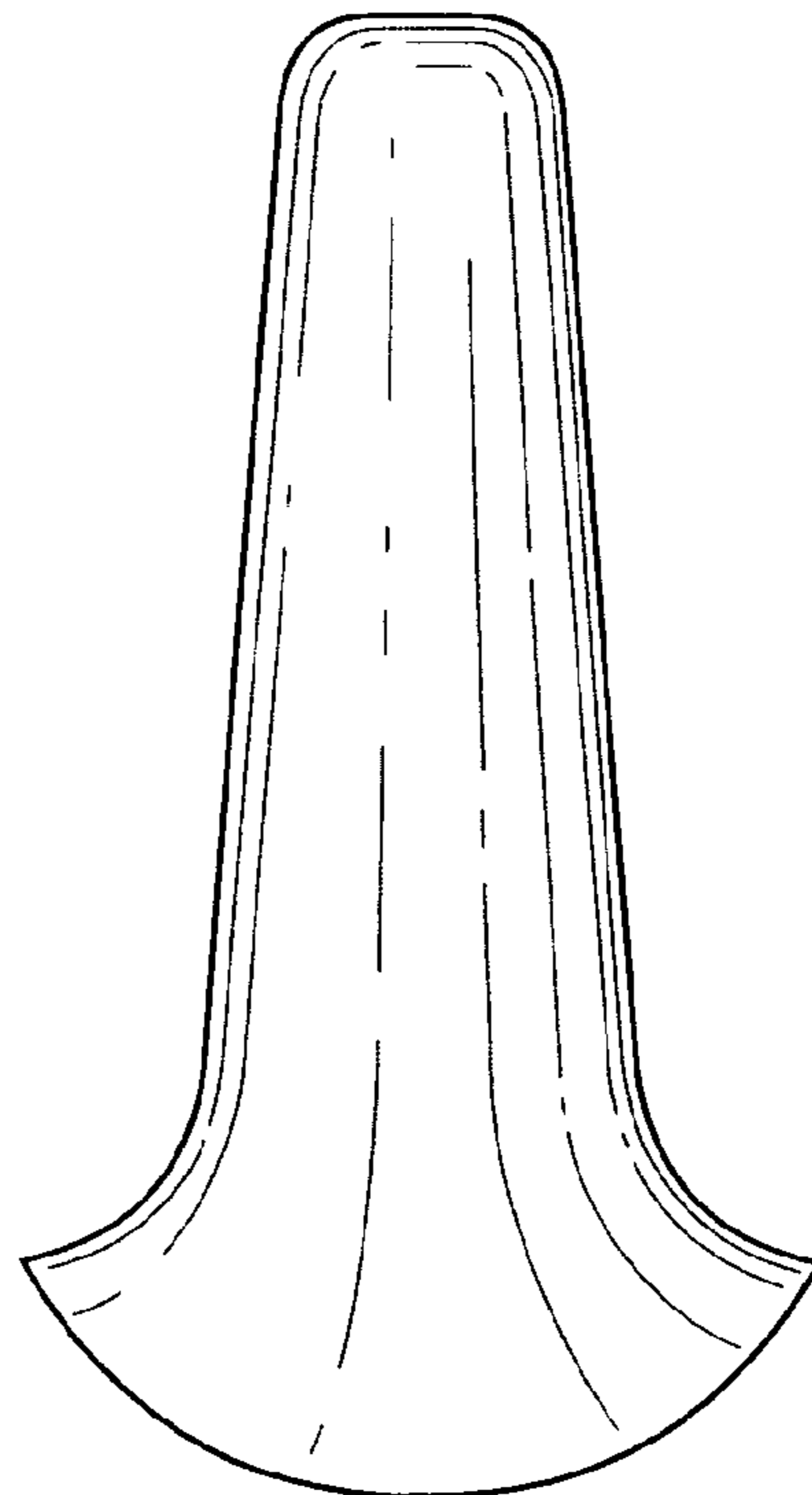
