FIG. 1 is a perspective view of a beverage container showing my new design;

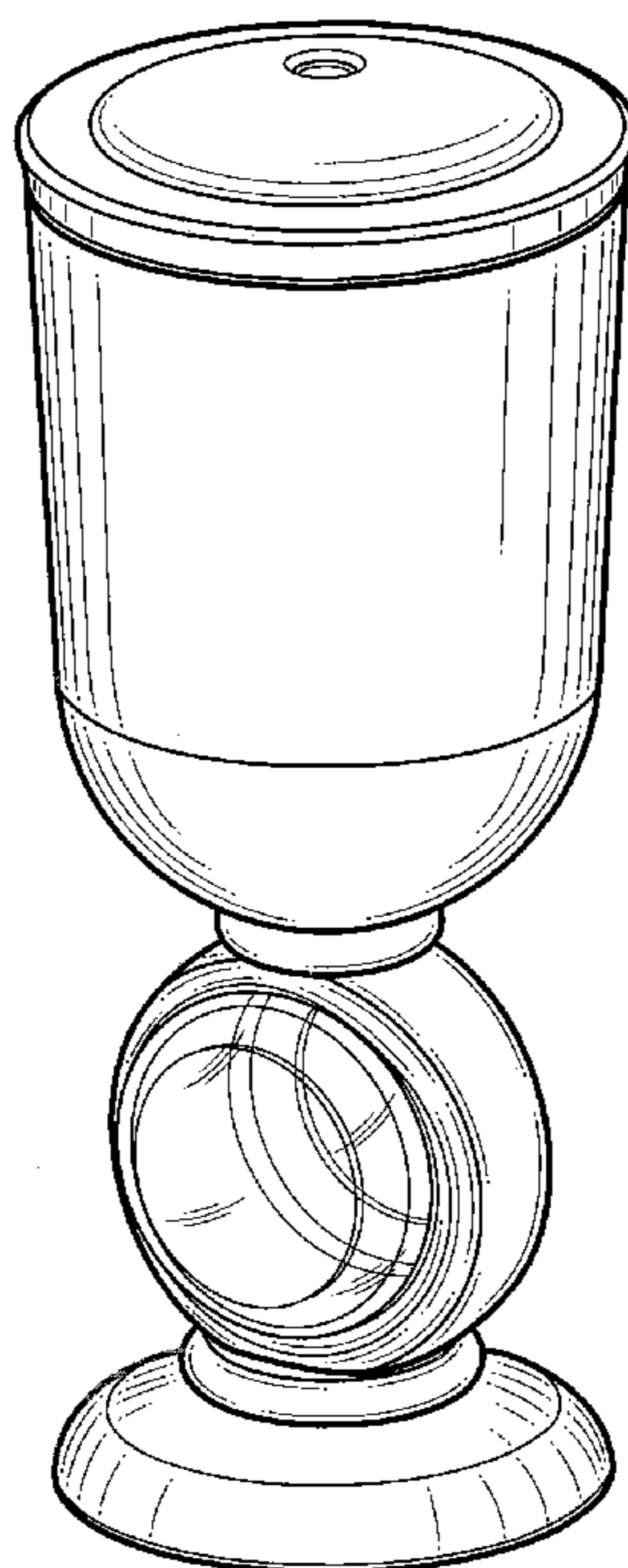
FIG. 2 is a right side elevational view thereof, the left side being identical;

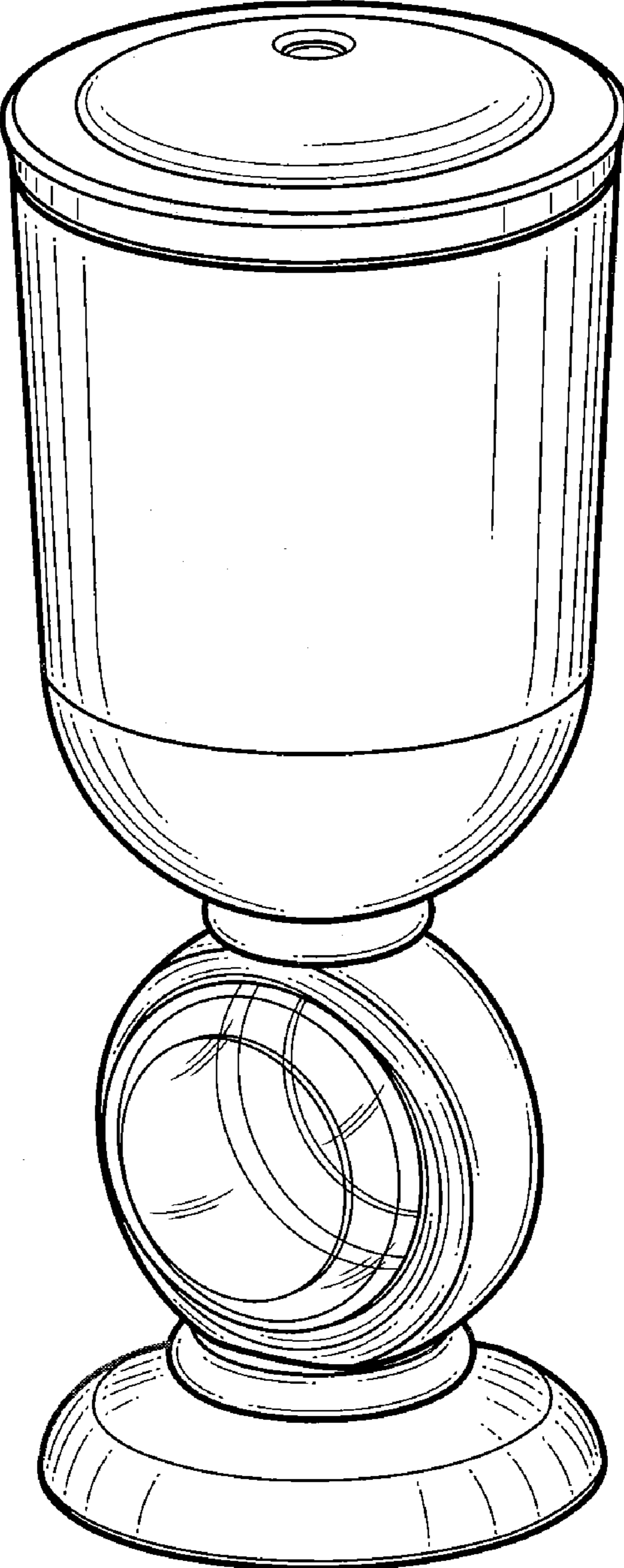

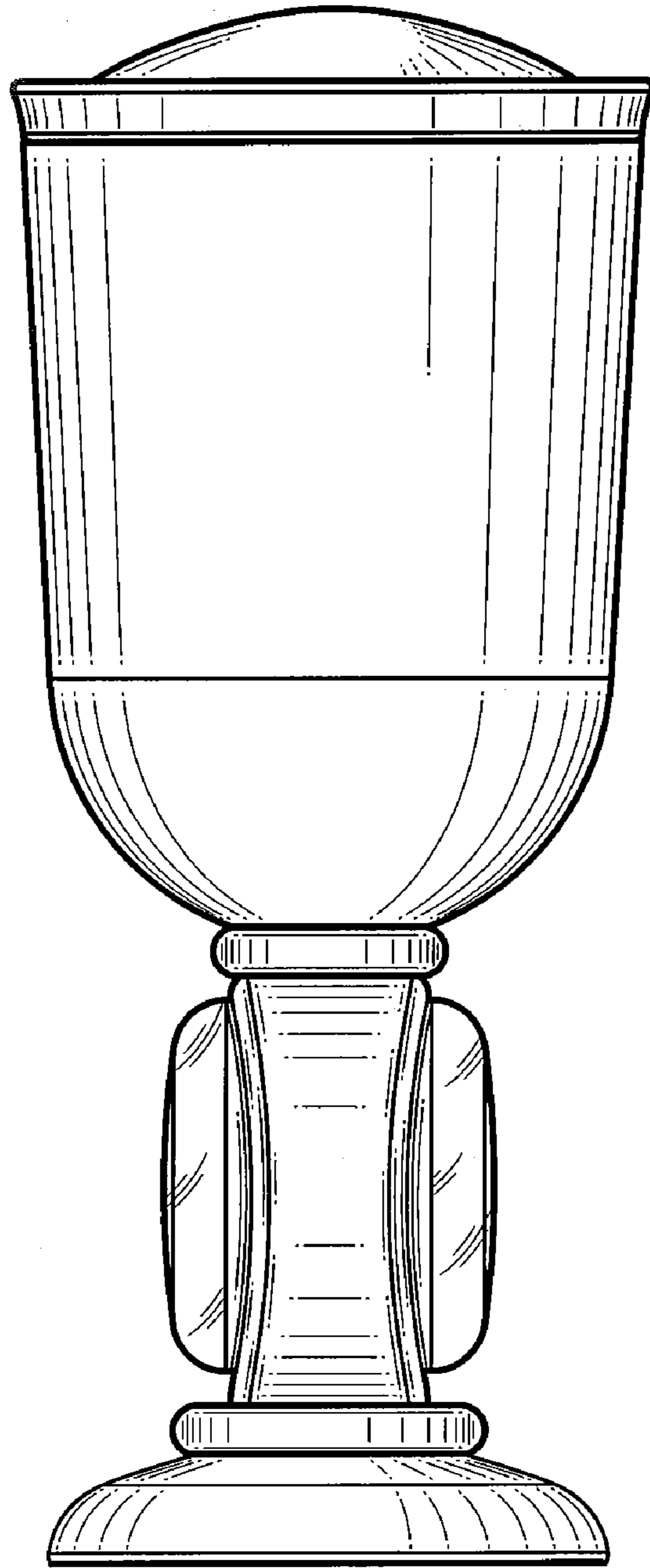

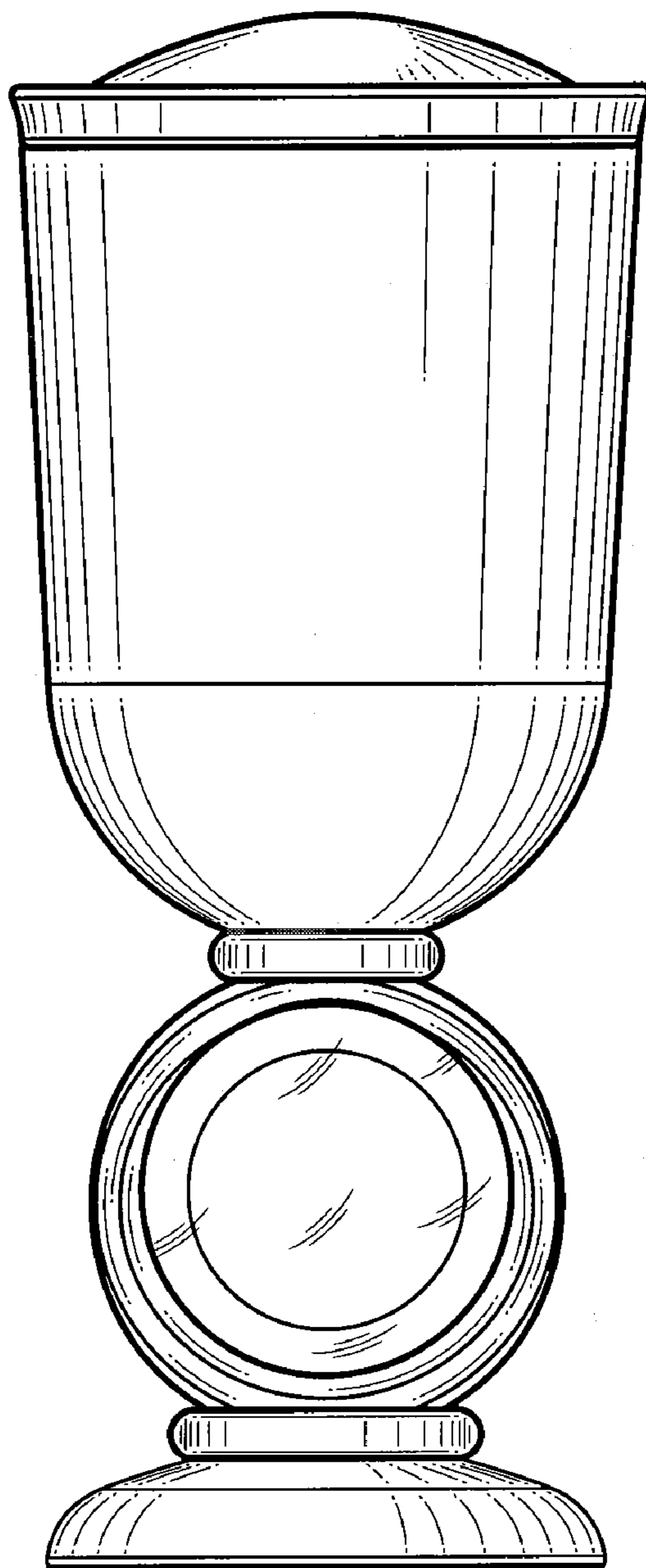

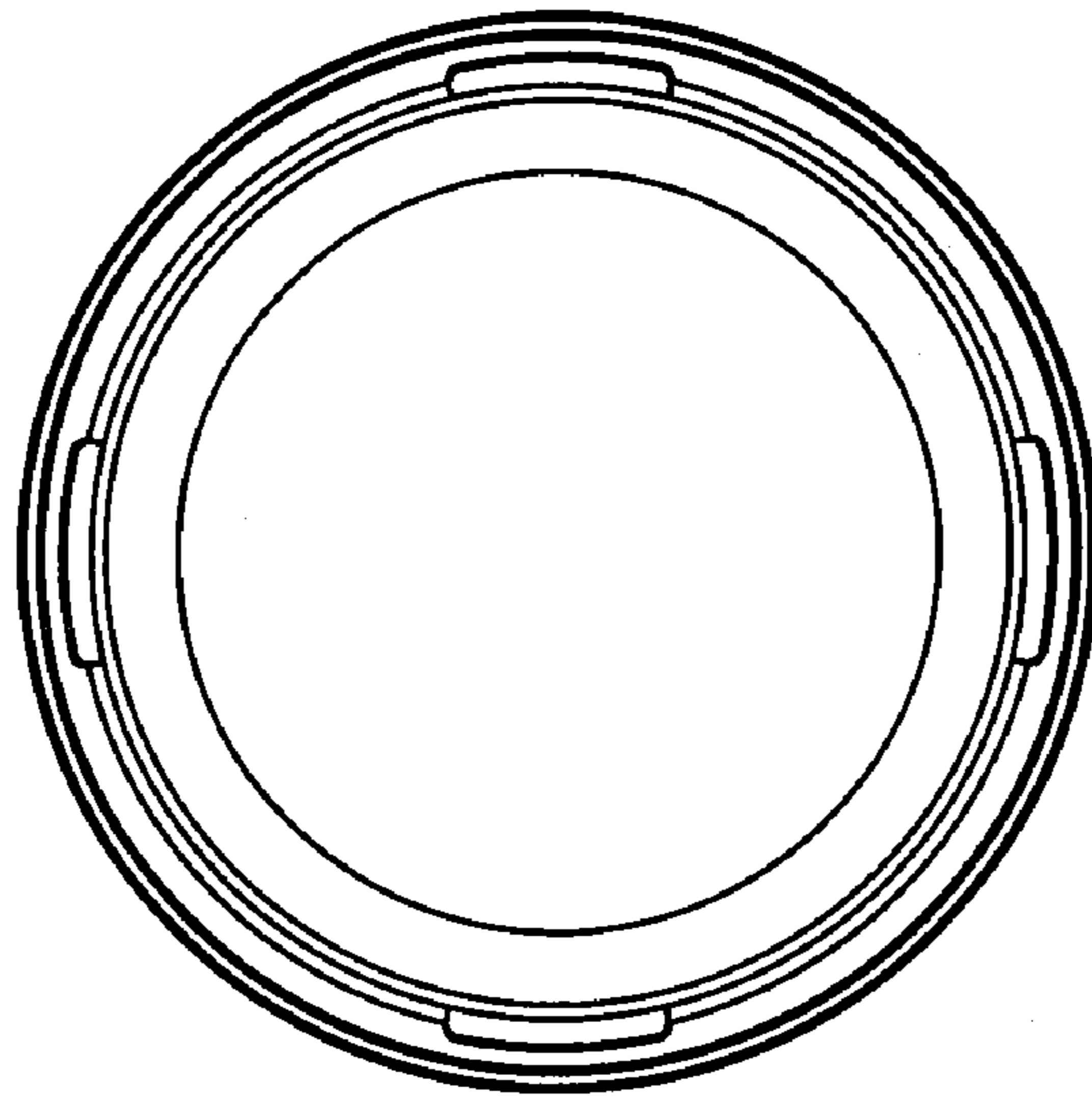

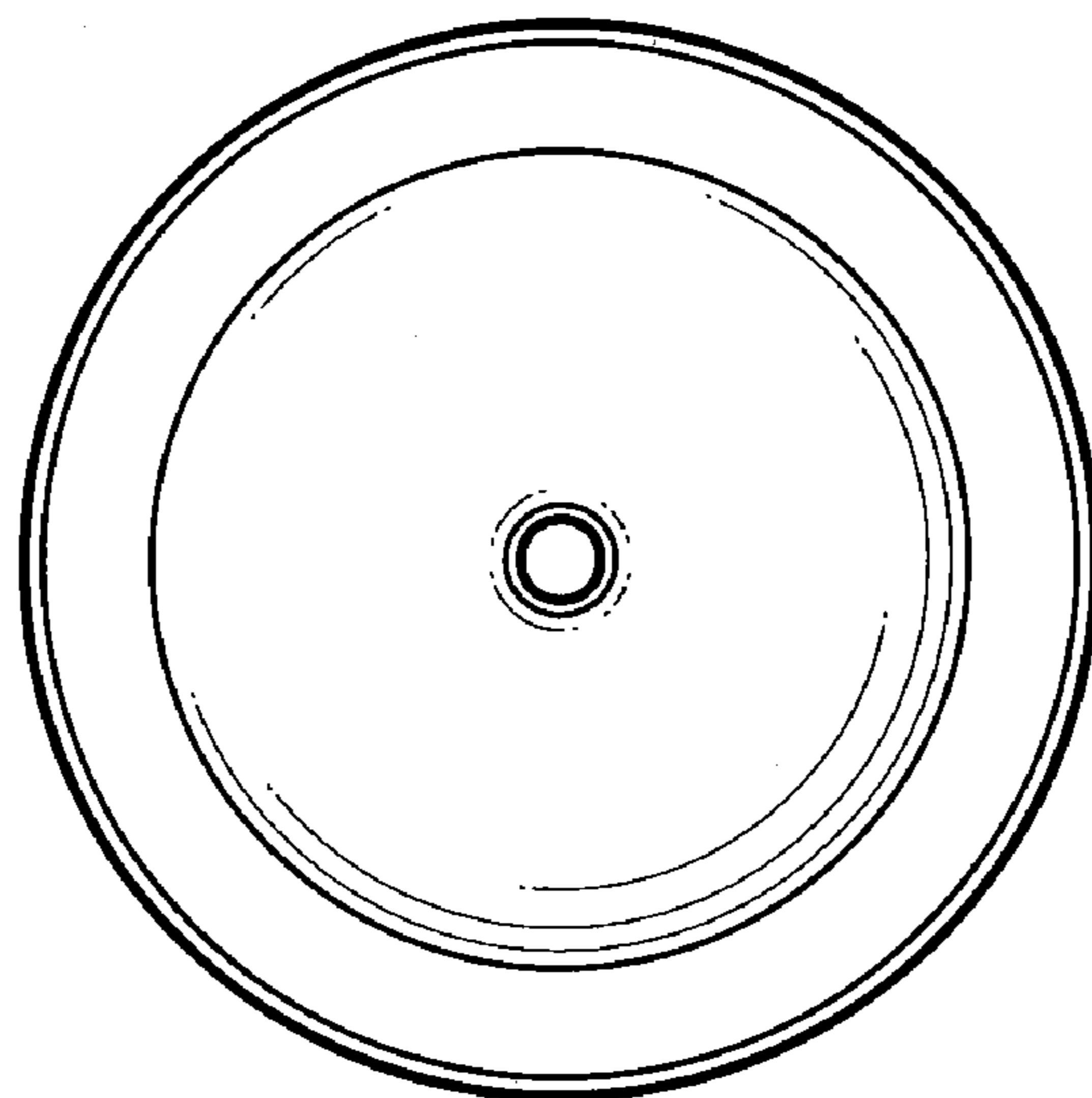
