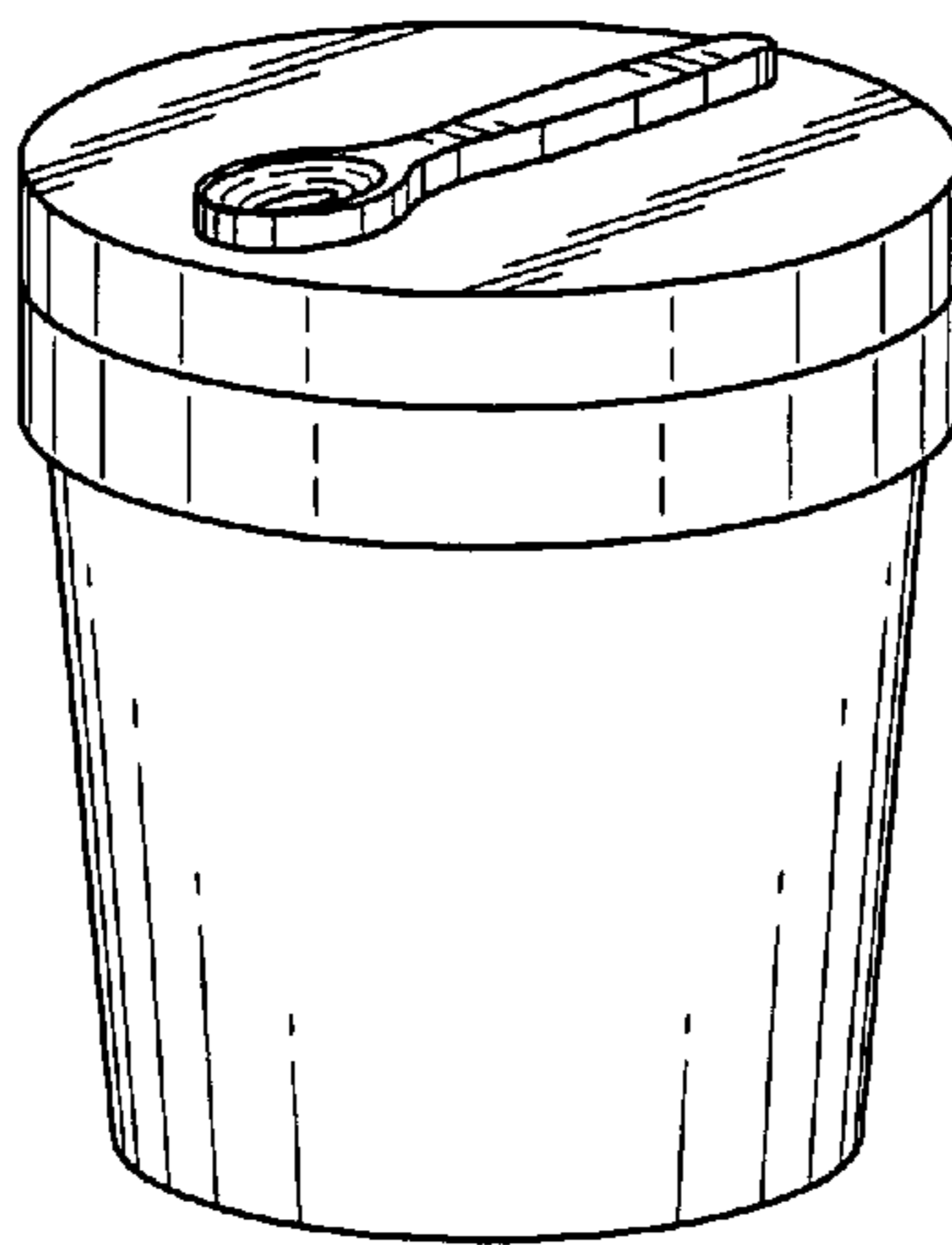
(57) **CLAIM**

The ornamental design for an insulated apparatus for storing and serving ice cream, as shown and described.

**DESCRIPTION**

- FIG. 1 is a perspective view of an insulated apparatus for storing and serving ice cream;
- FIG. 2 is a front view of the insulated apparatus for storing and serving ice cream of FIG. 1;
- FIG. 3 is a top view of the insulated apparatus for storing and serving ice cream of FIG. 1;
- FIG. 4 is a bottom view of the insulated apparatus for storing and serving ice cream of FIG. 1;
- FIG. 5 is one end view of the insulated apparatus for storing and serving ice cream of FIG. 1; and,

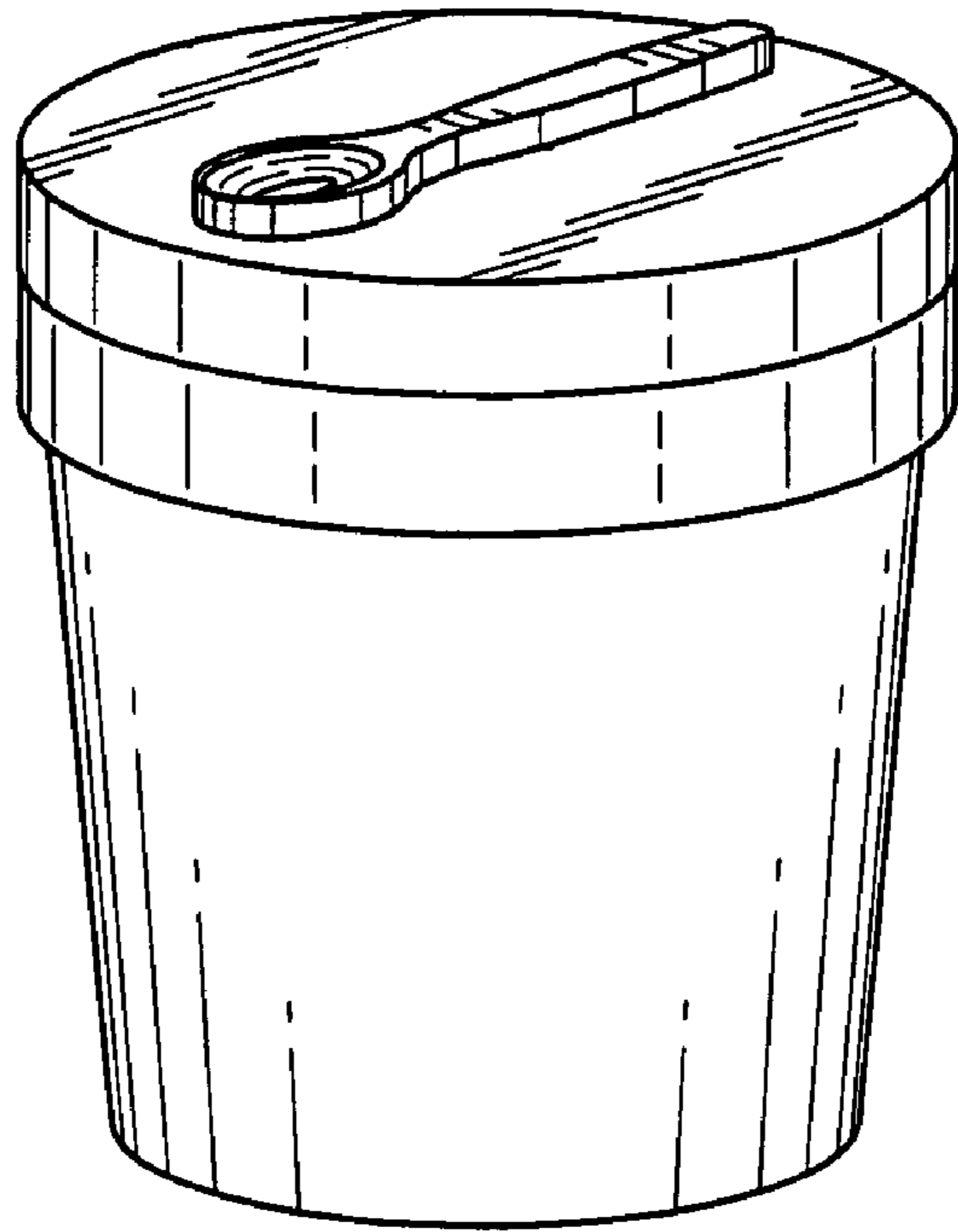

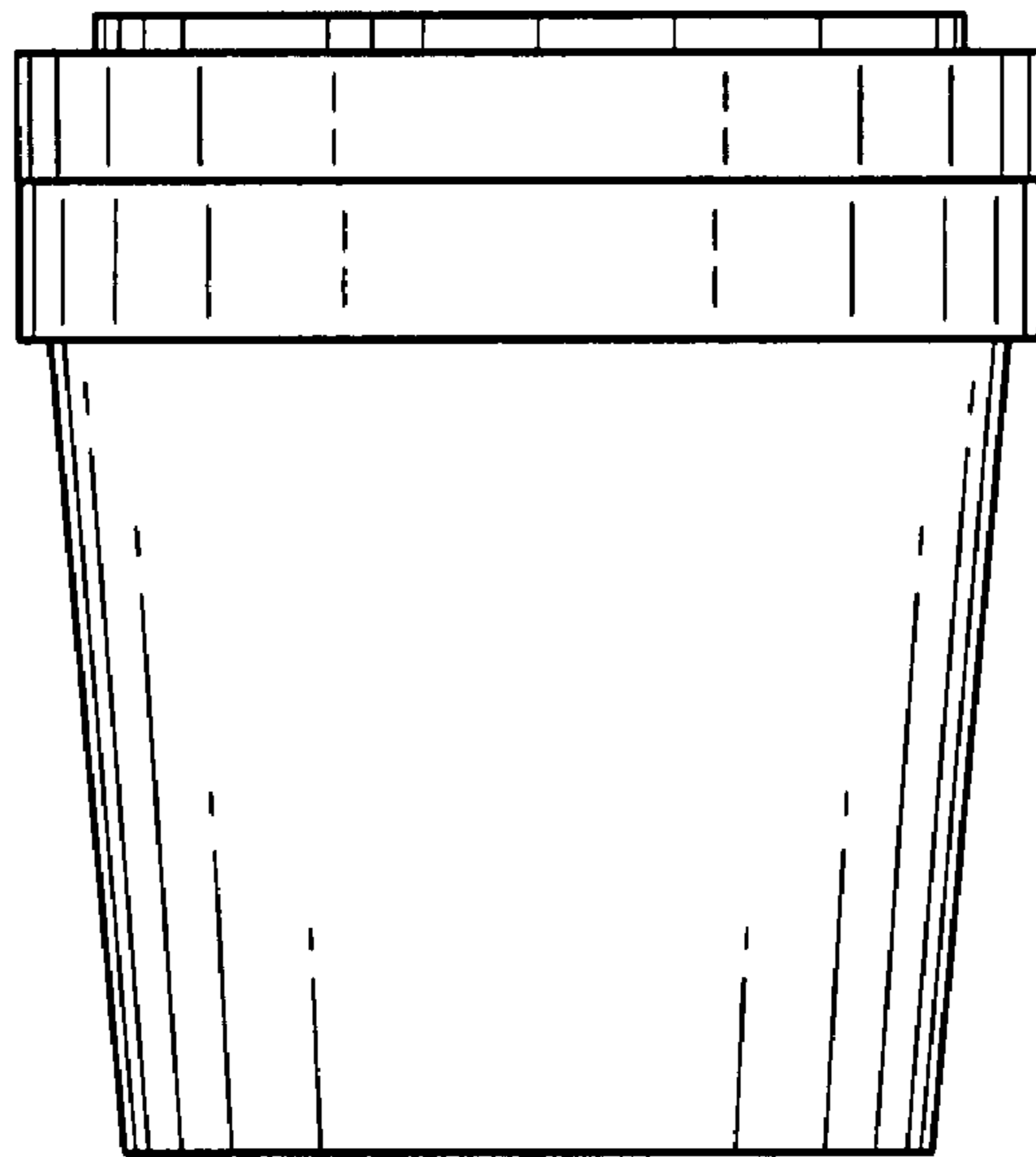
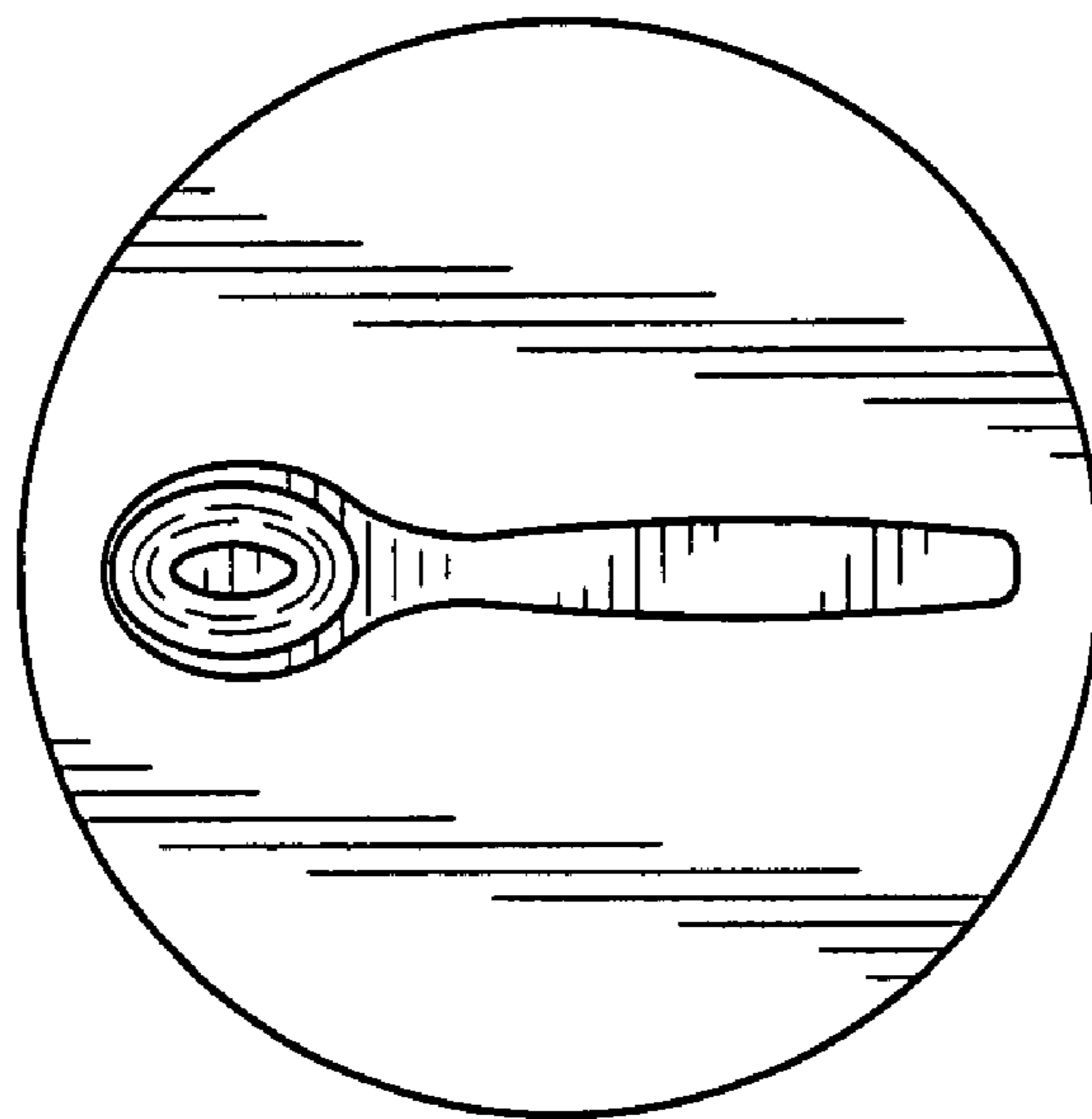
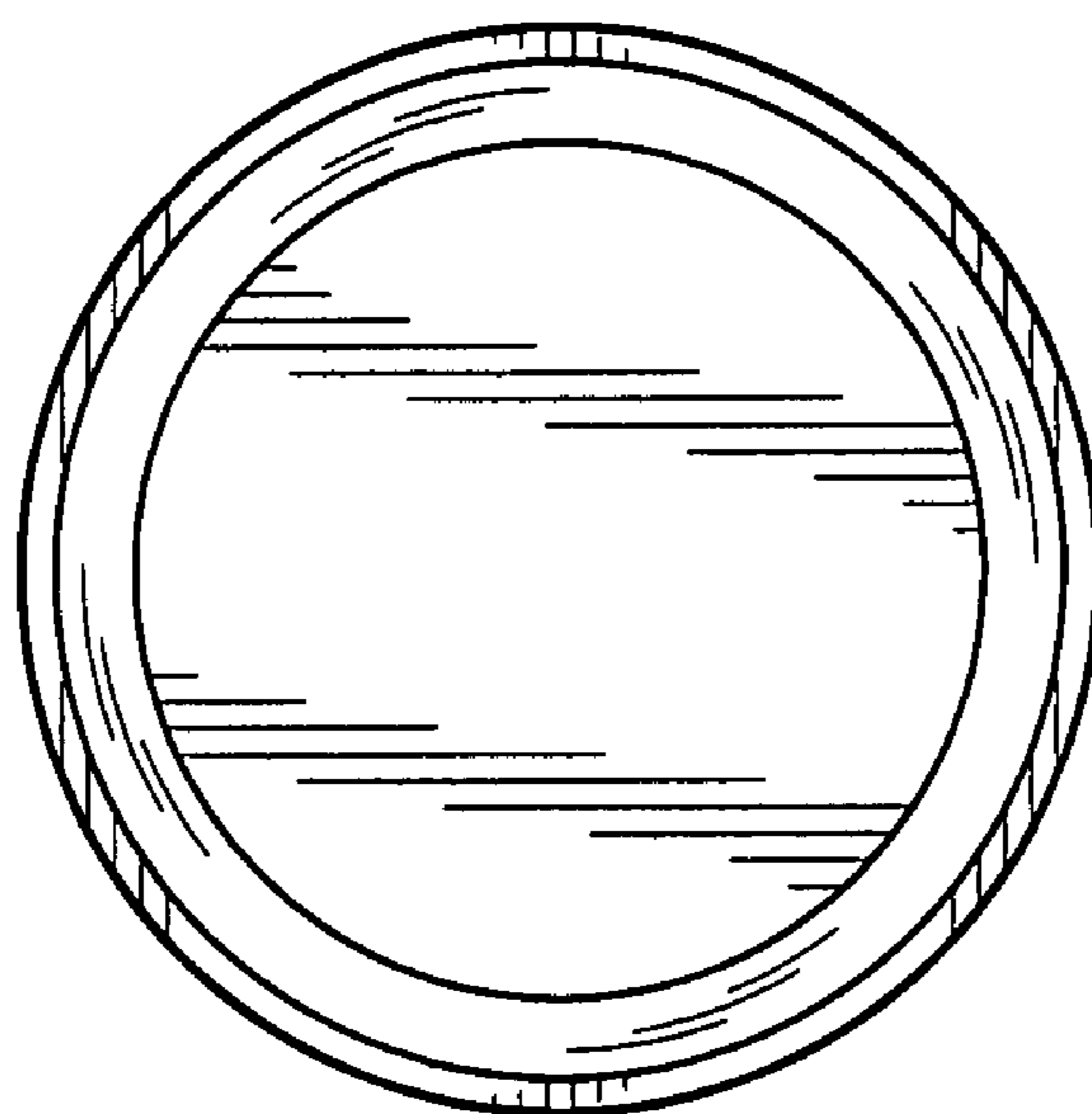


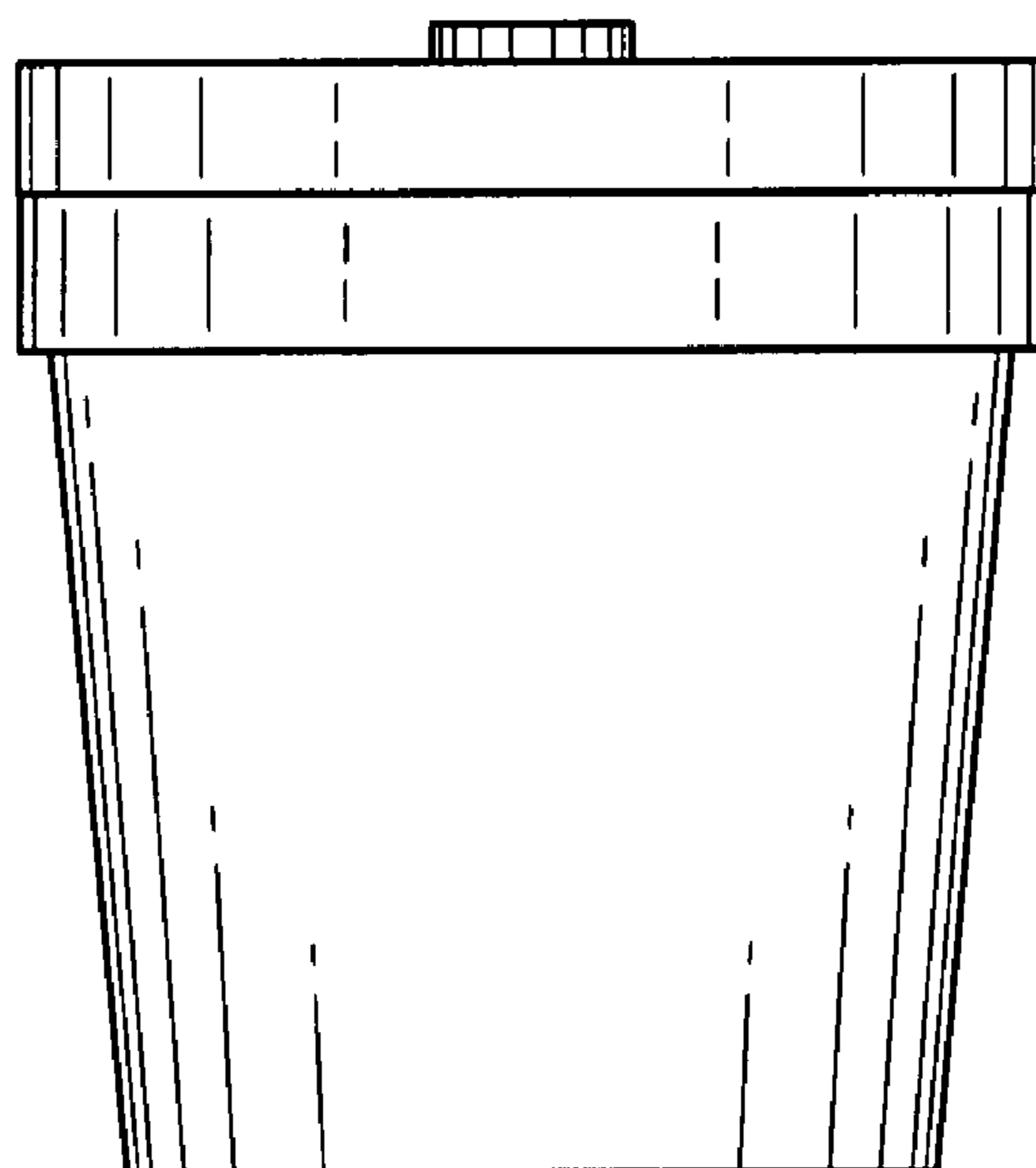

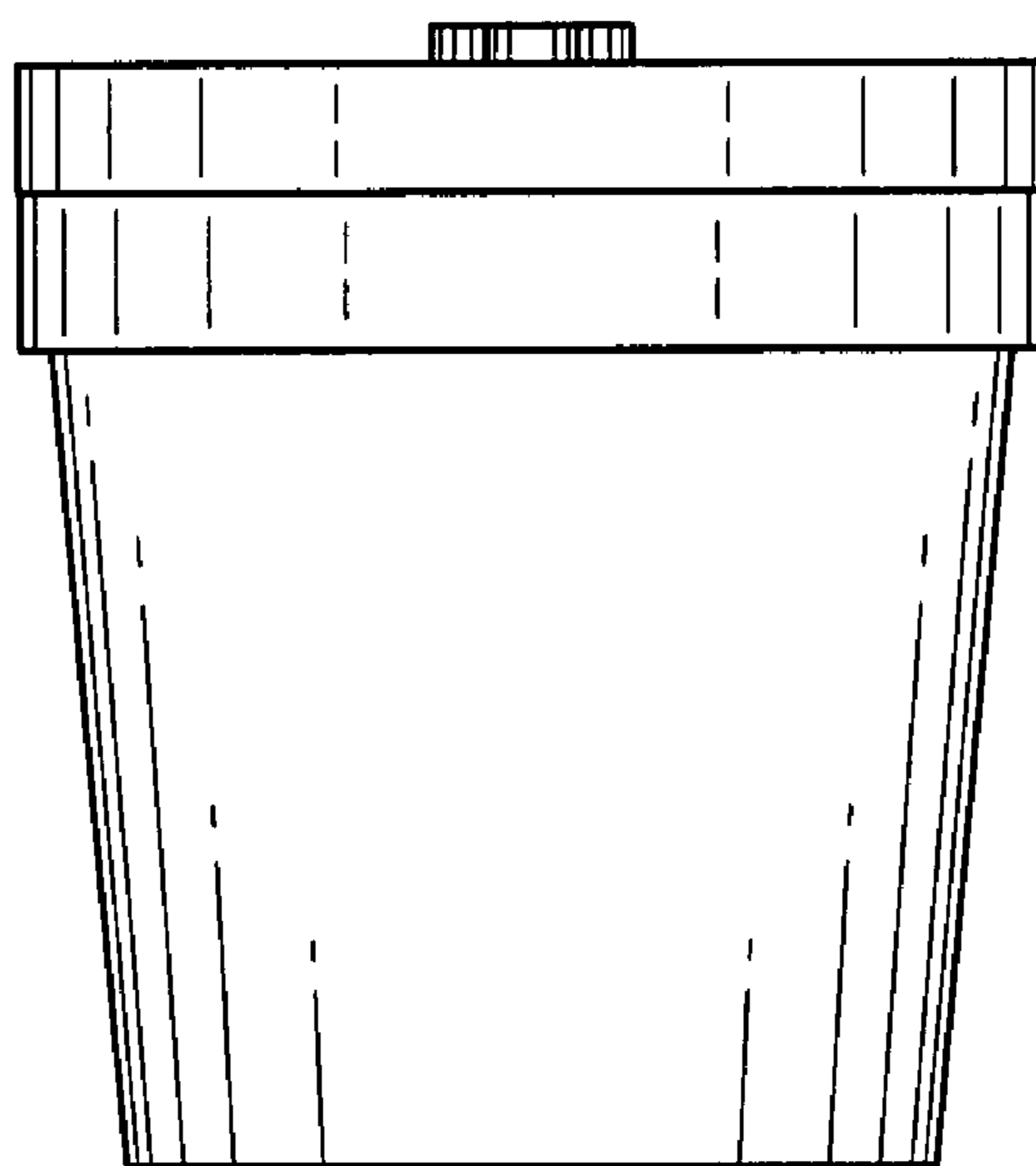
