(57) **CLAIM**

The ornamental design for a twisted grip tool handle, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a twisted grip tool handle;

FIG. 2 is a rear view of the twisted grip tool handle of FIG. 1;

FIG. 3 is a left side view of the twisted grip tool handle of FIG. 1;

FIG. 4 is a bottom end view of the twisted grip tool handle of FIG. 1; and,

FIG. 5 is a top end view of the twisted grip tool handle of FIG. 1.

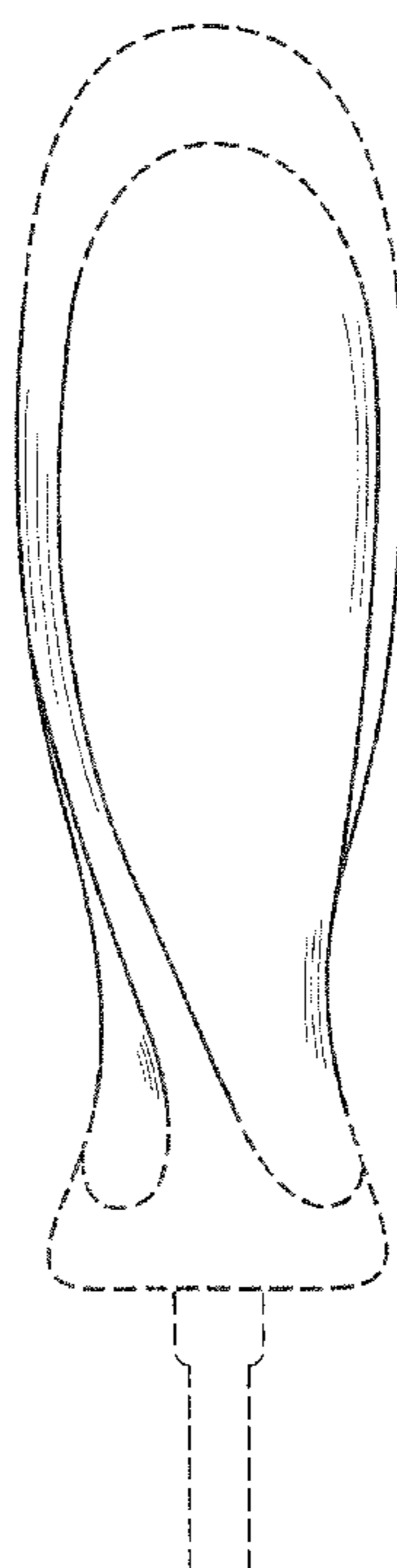

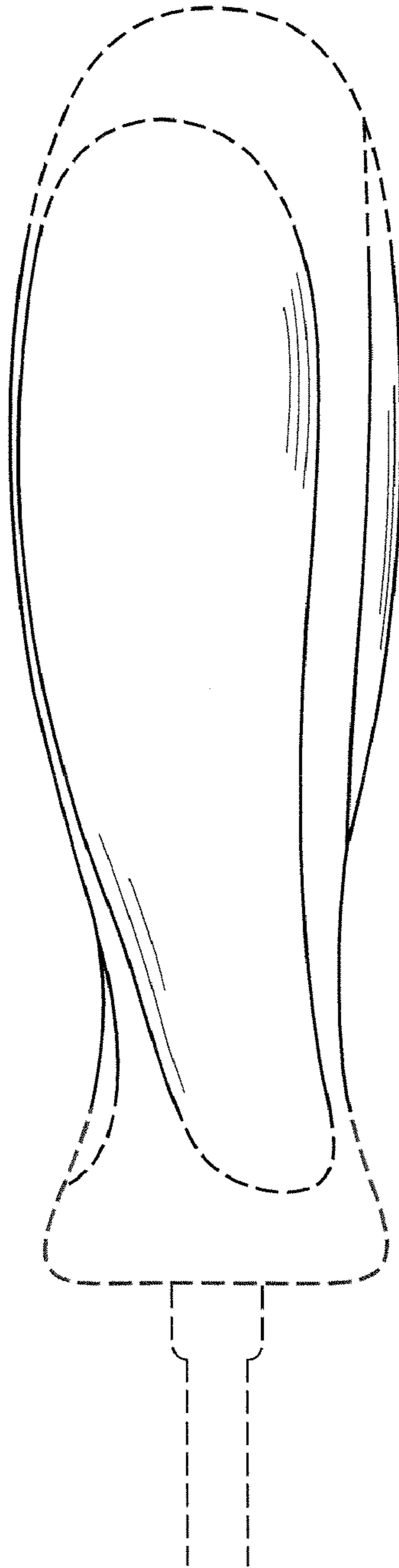

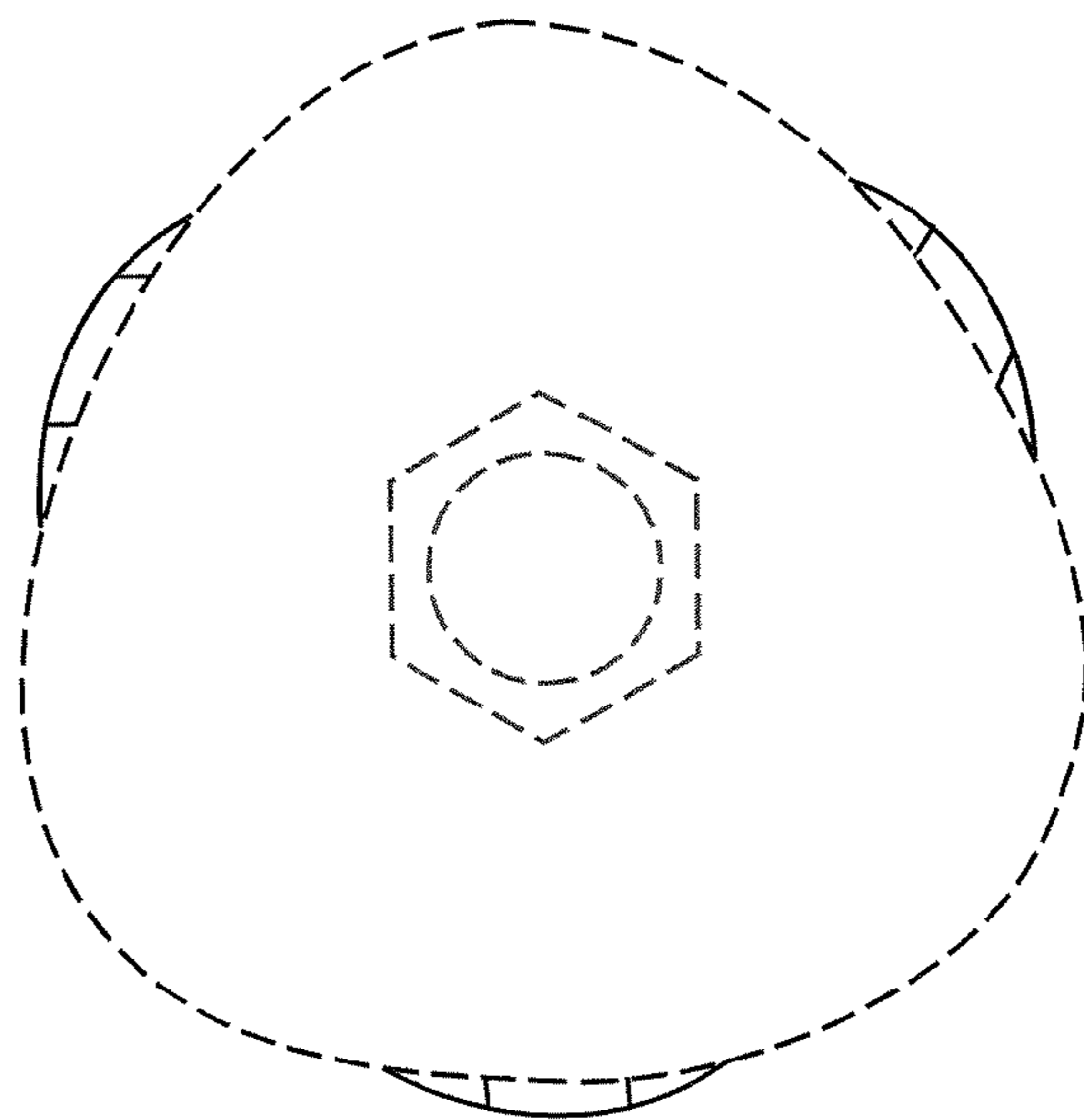

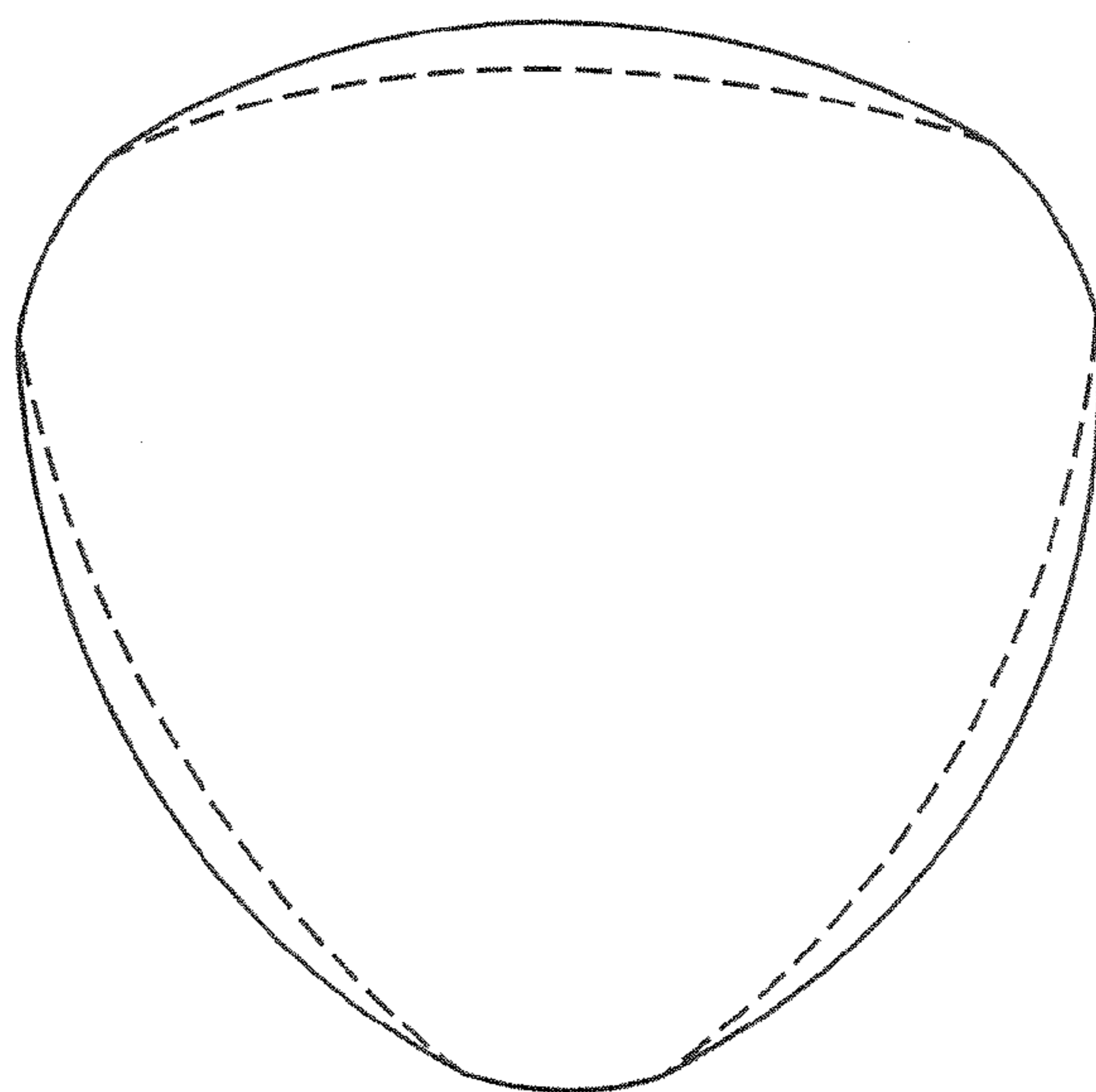
