DESCRIPTION

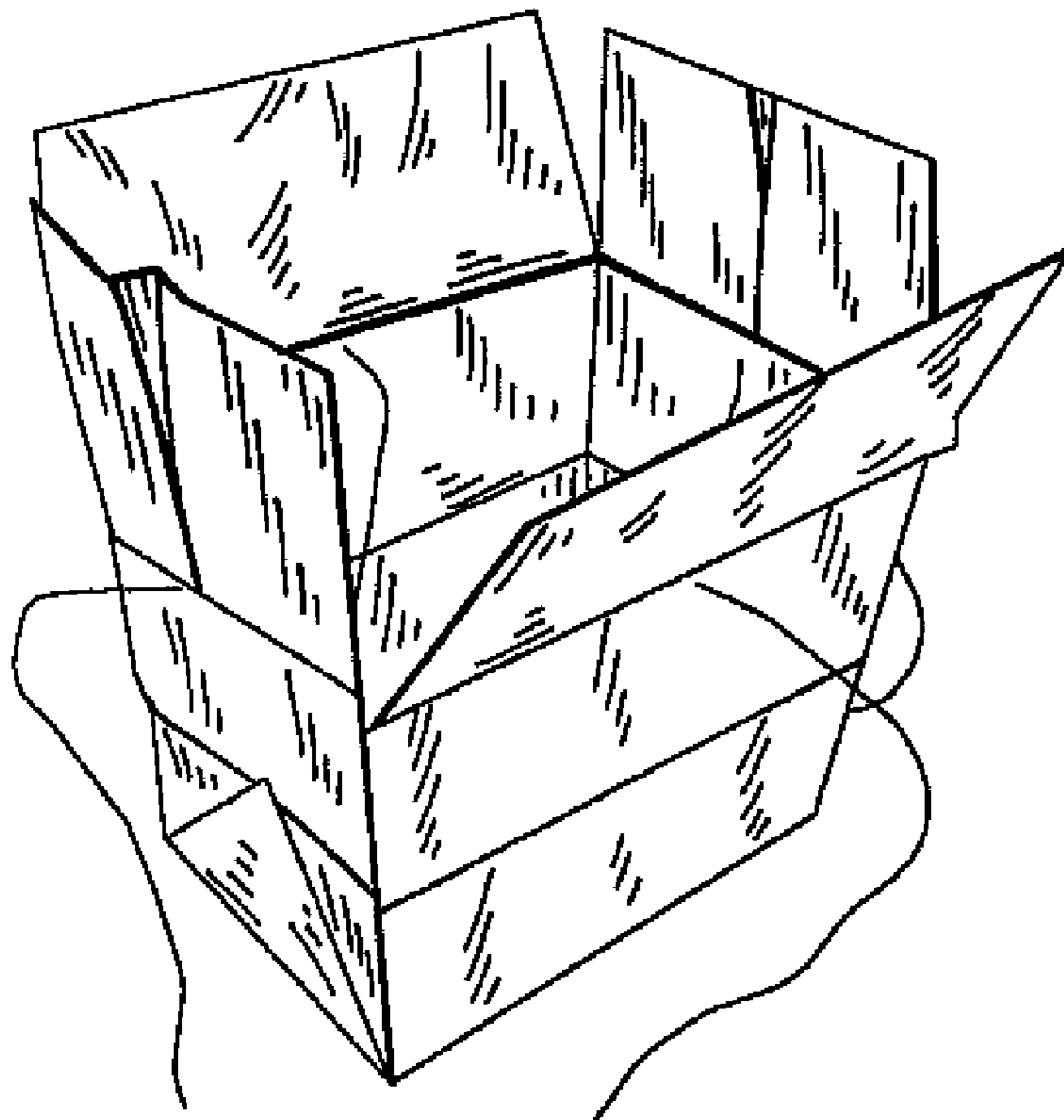
FIG. 1 is a top front left side perspective view of a paper bag showing my new design.

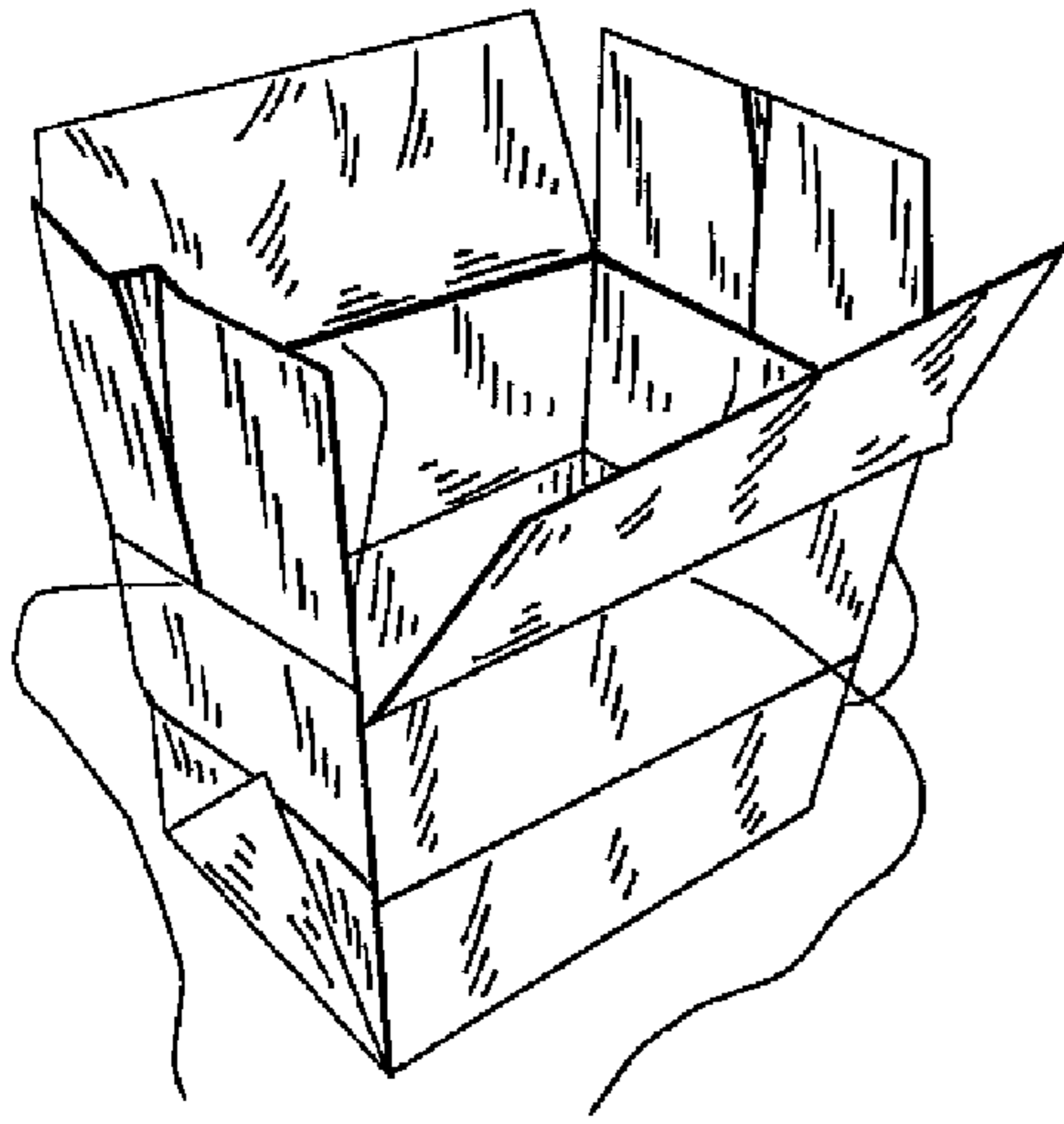

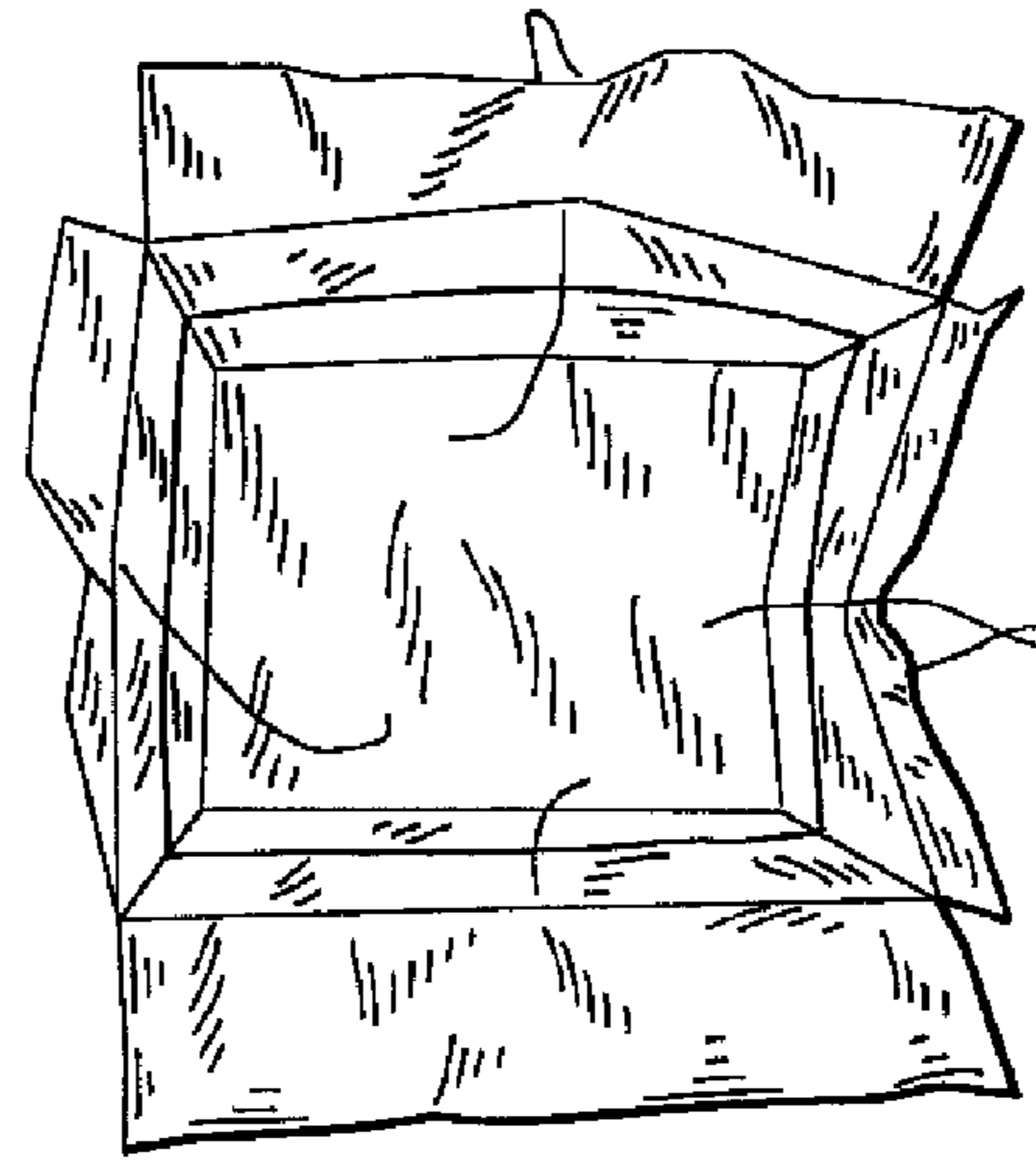

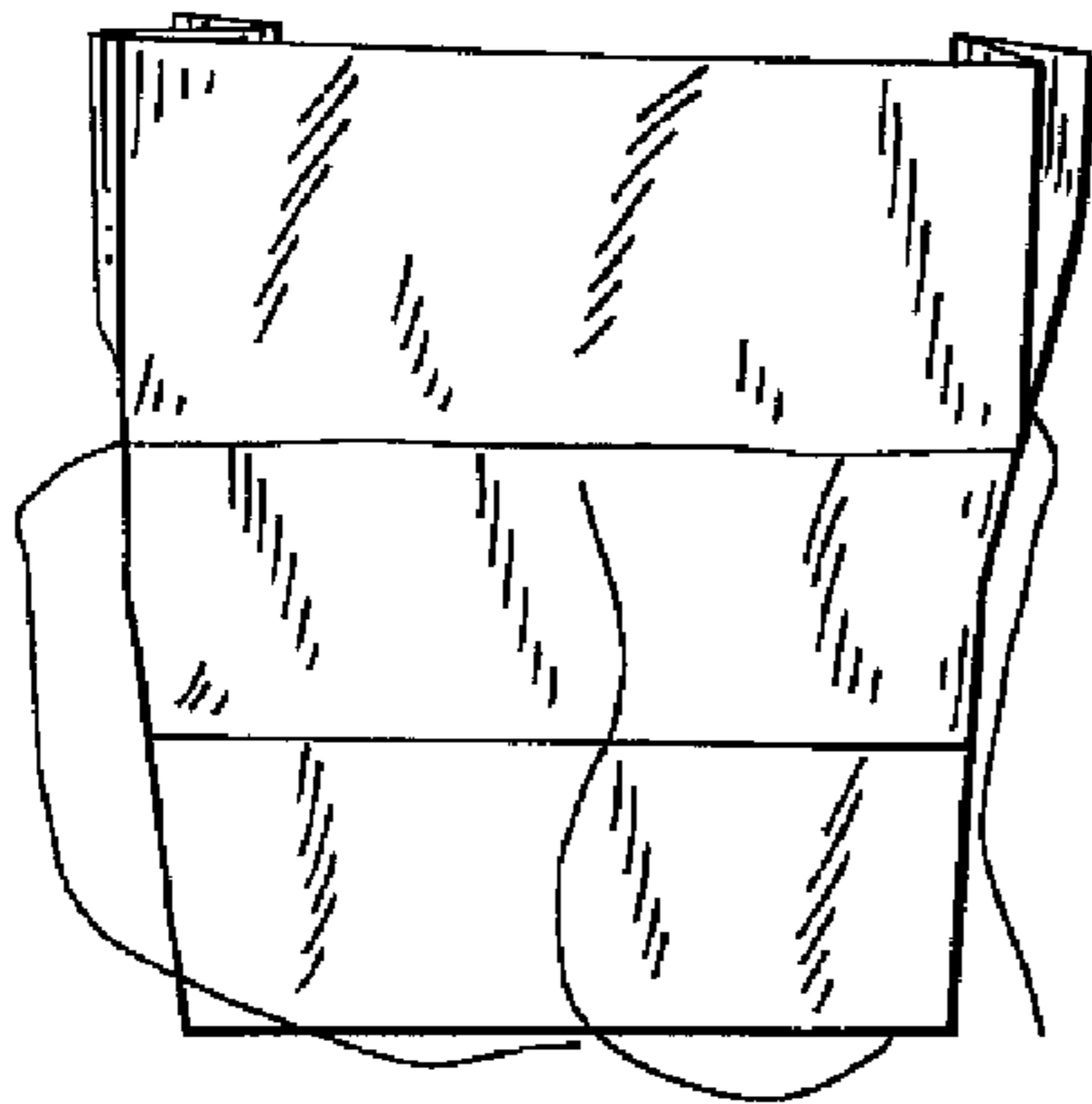

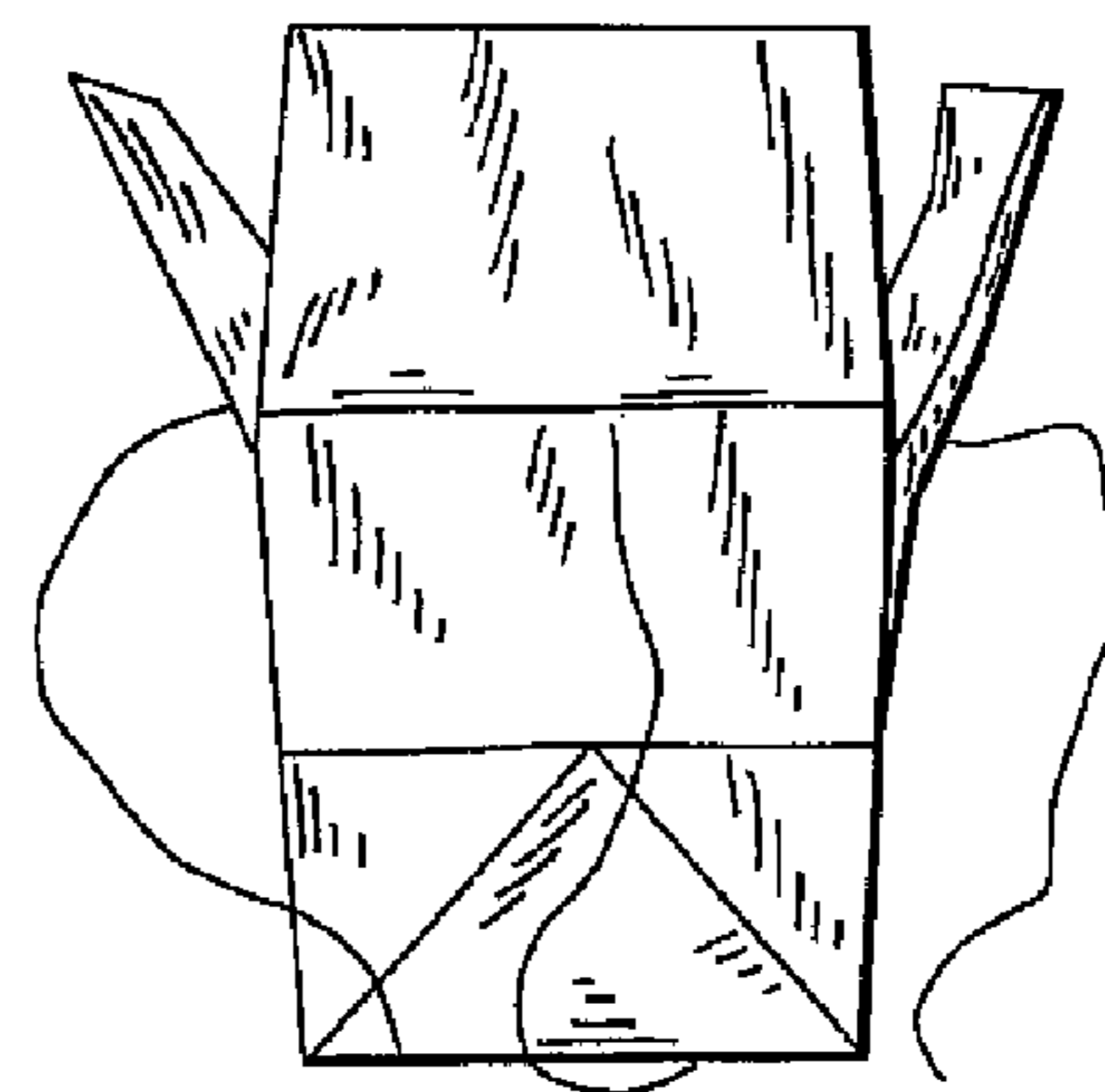
