DESCRIPTION

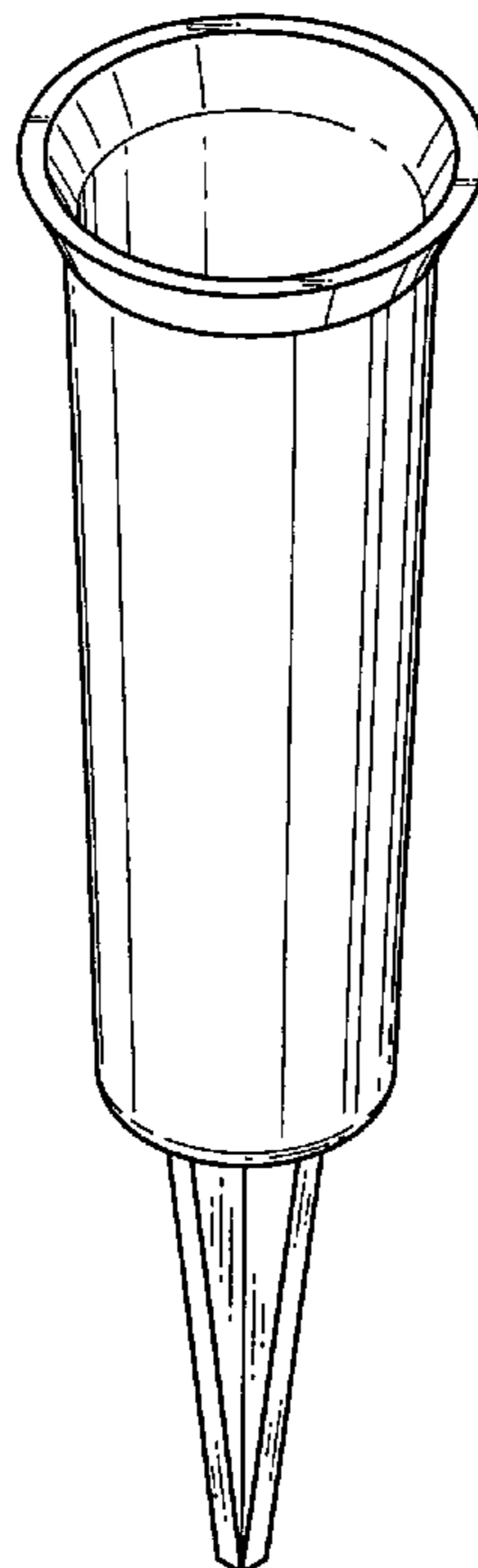
FIG. 1 is a perspective view of a flower vase stake, showing my new design;

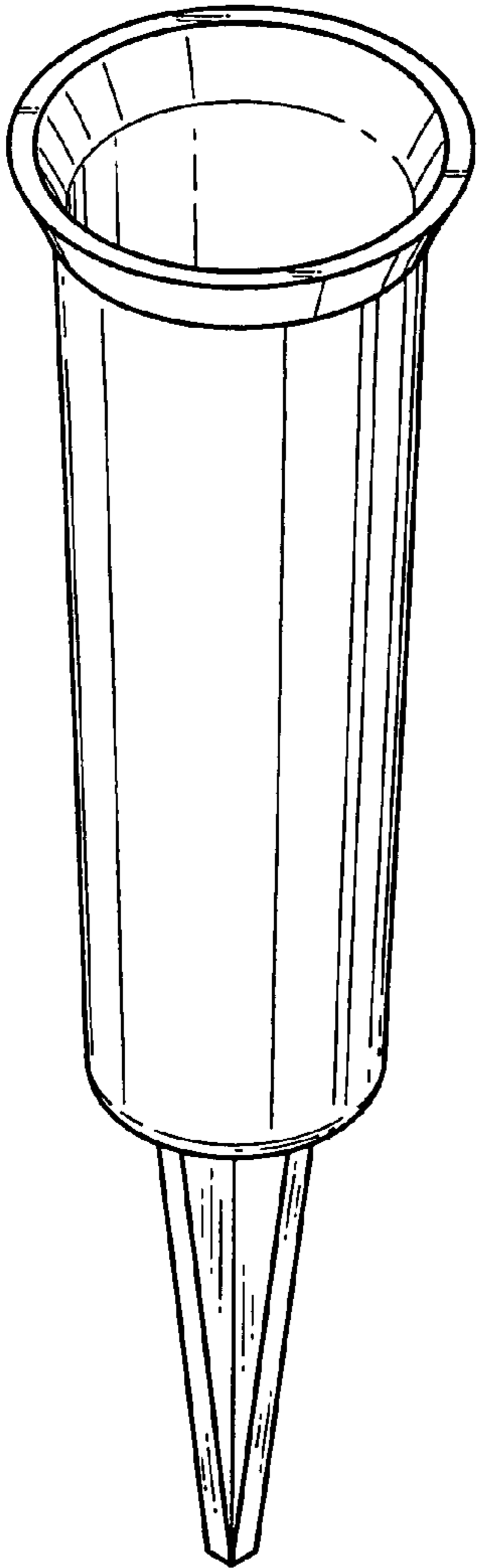

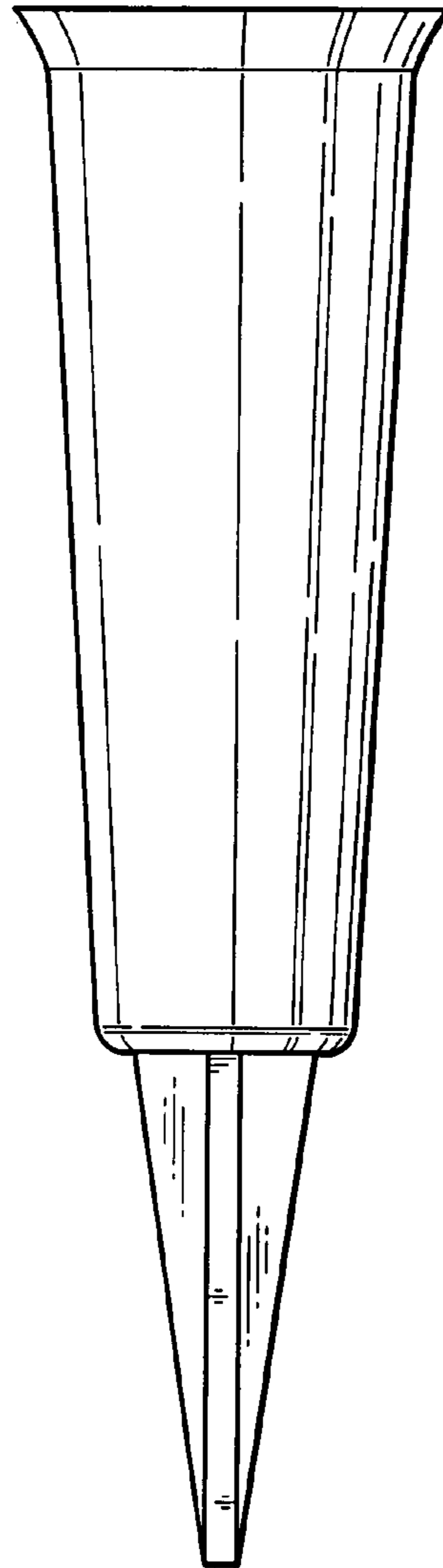

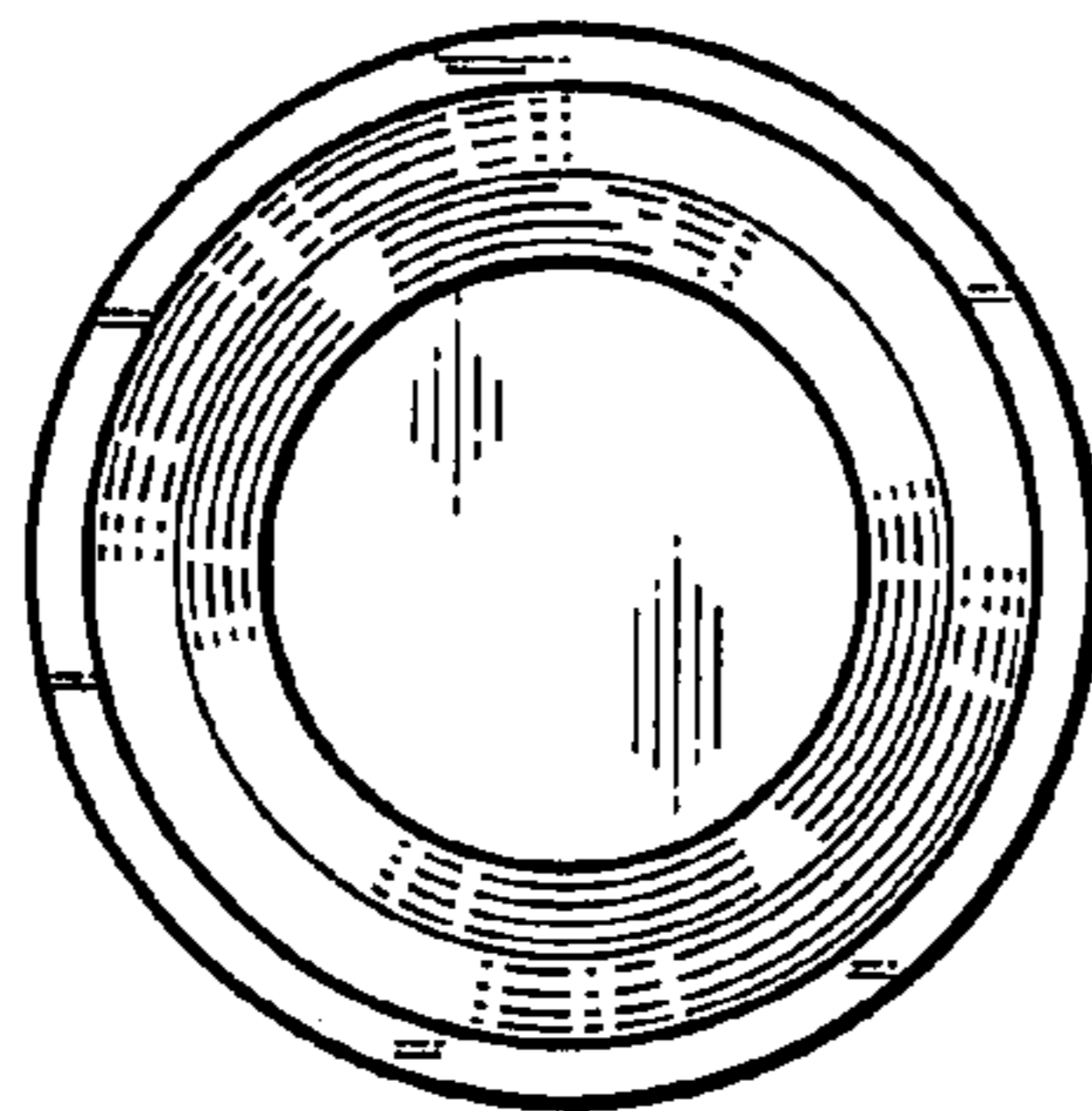

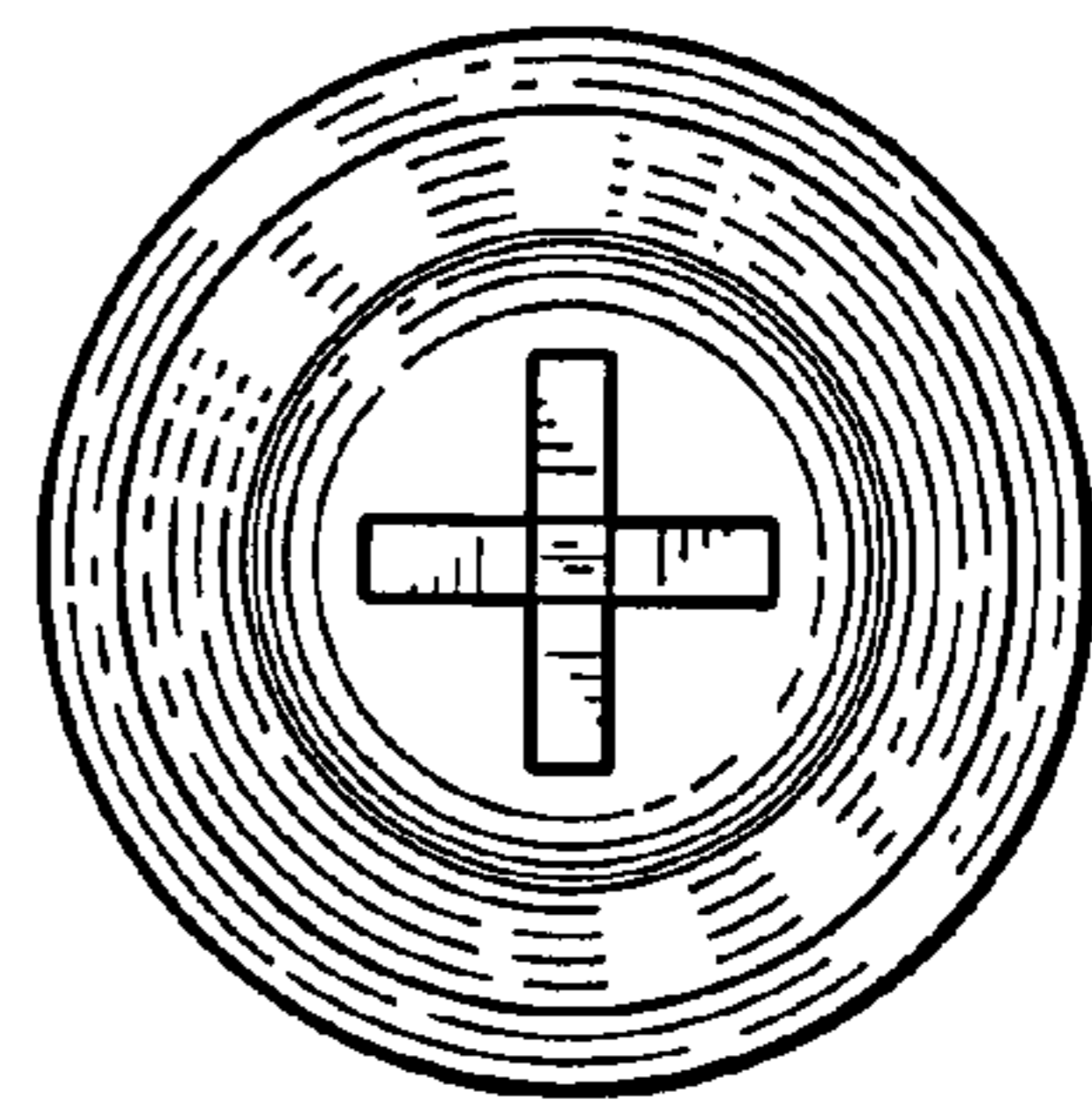
