The new design for a strap holder, as shown and described
herein.

DESCRIPTION

FIG. 1 is a rear elevation view of a first embodiment of a strap
holder of the present invention also showing in broken lines,
straps of an article of women's clothing and a decorative
accessory that are not a part of the present invention;

FIG. 2 is a top plan view of the first embodiment;

FIG. 3 is a side elevation view of the first embodiment;

FIG. 4 is a bottom plan view of the first embodiment;

FIG. 5 is an elevation view of a first end of the first embodi-
ment of my strap holder; and,

FIG. 6 is an elevation view of a second end of the first
embodiment of my strap holder.

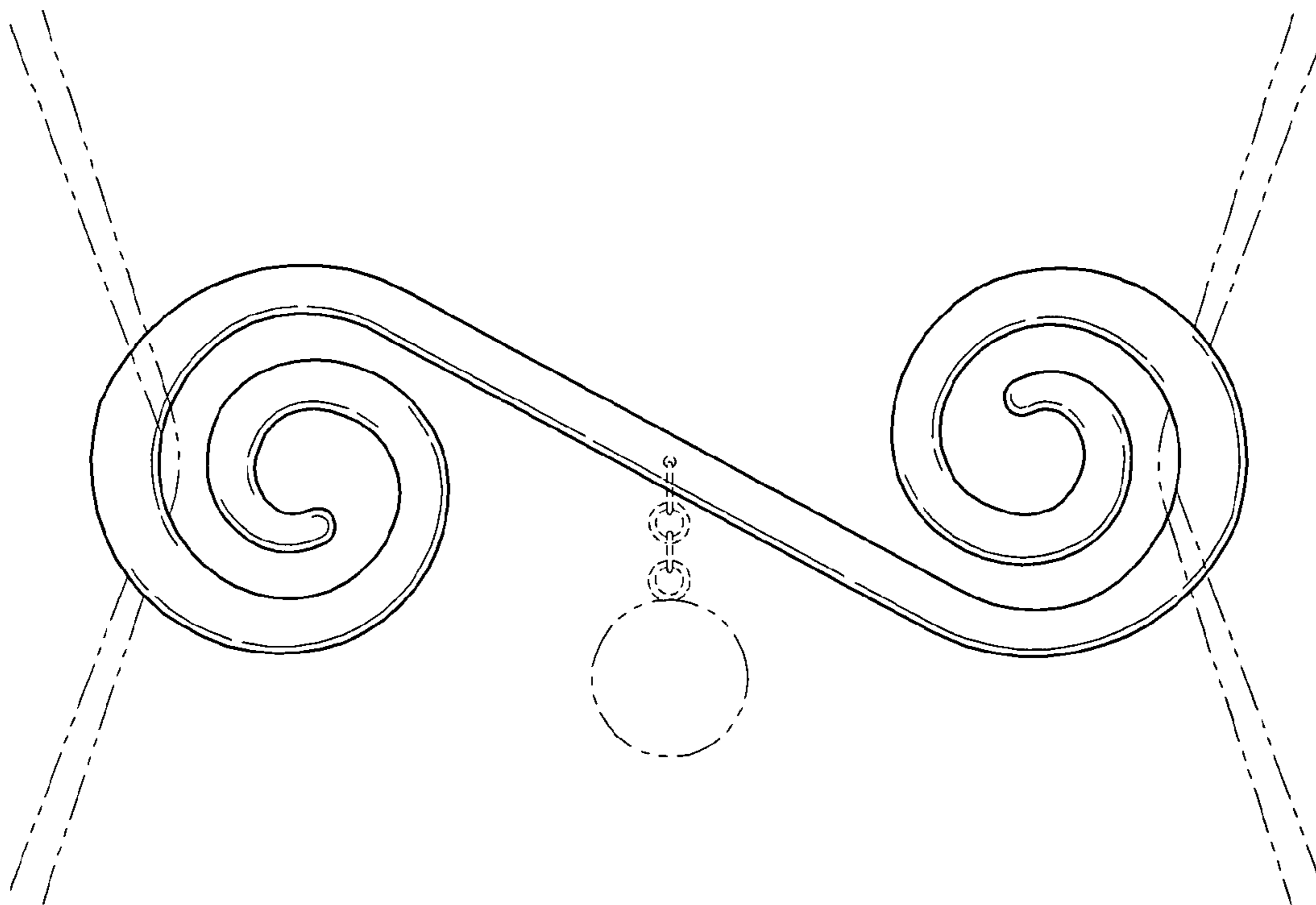

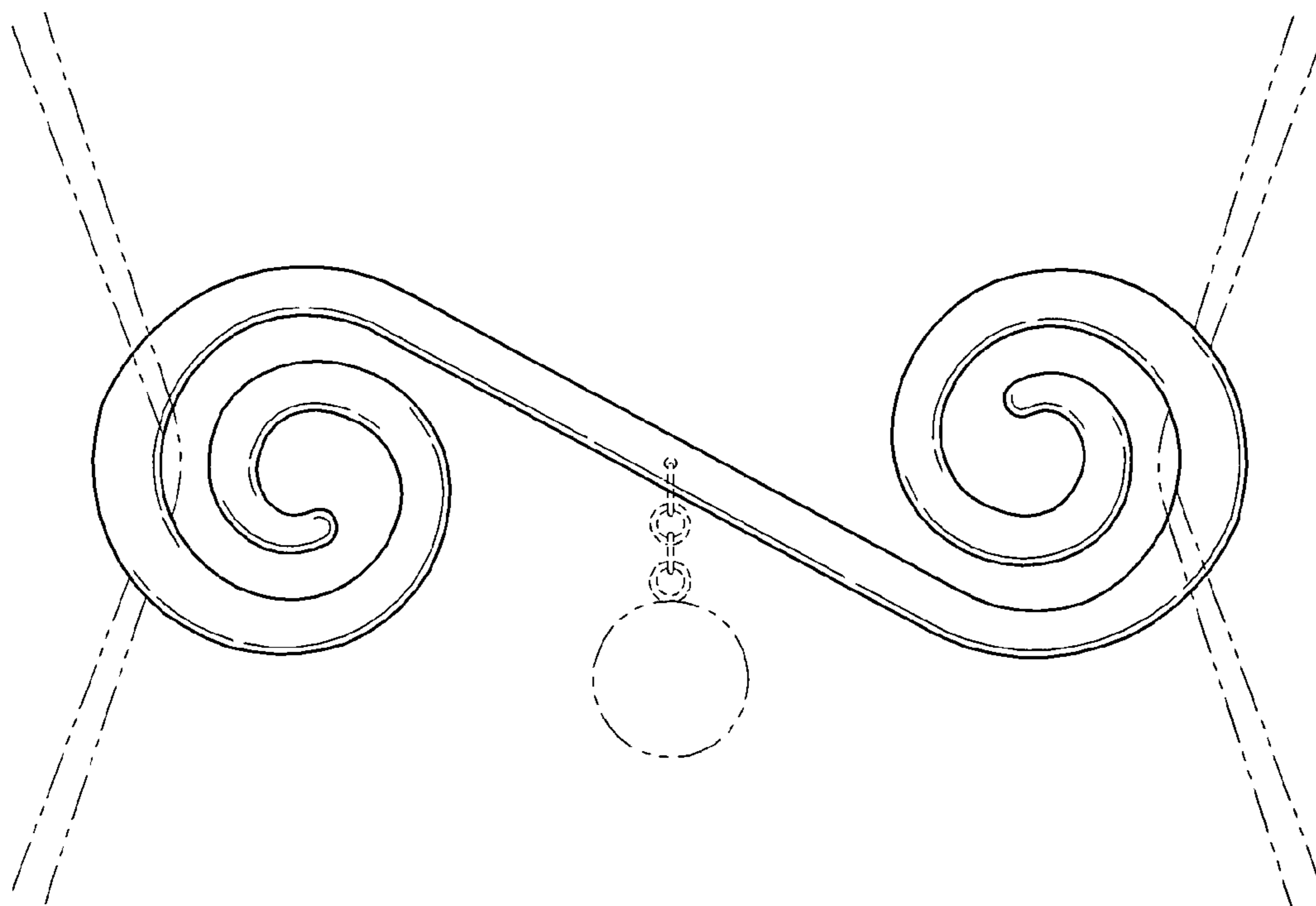

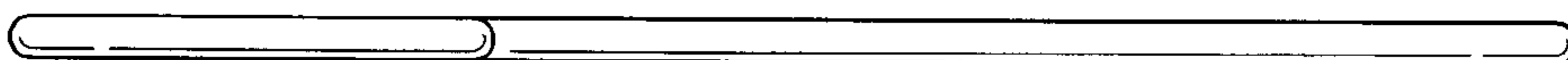

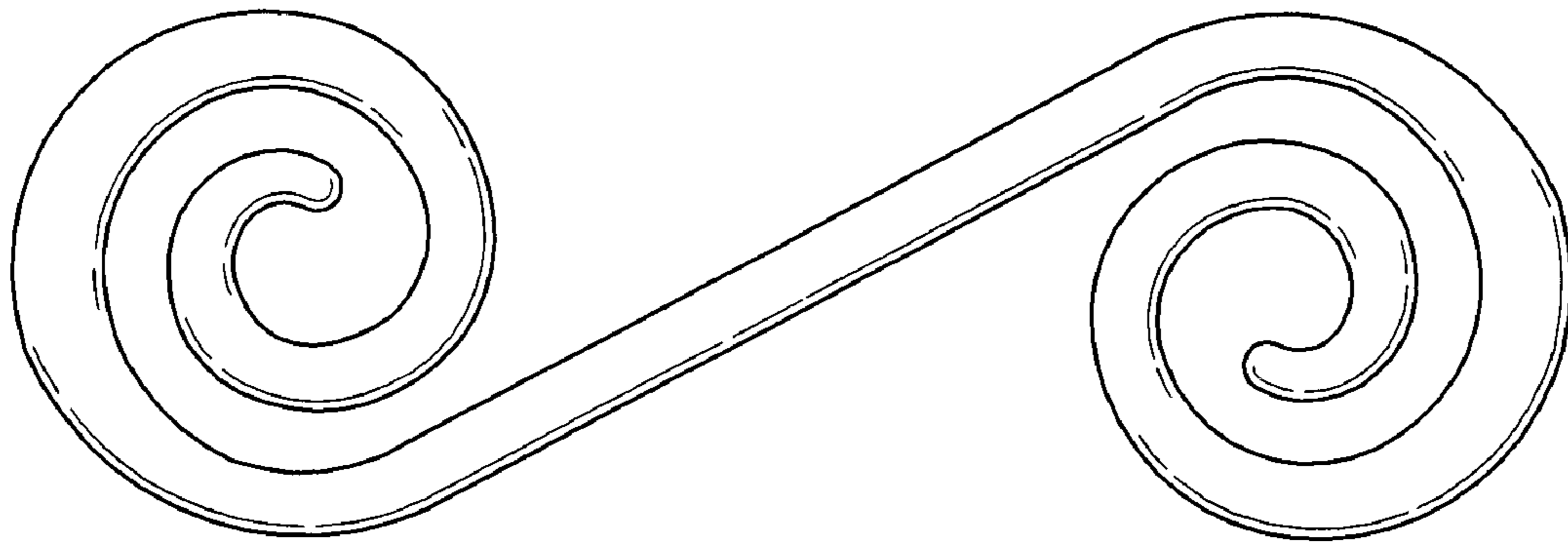
