FIG. 1 is a front view of a detachably mounted extension for a sun visor of a vehicle showing my new design;

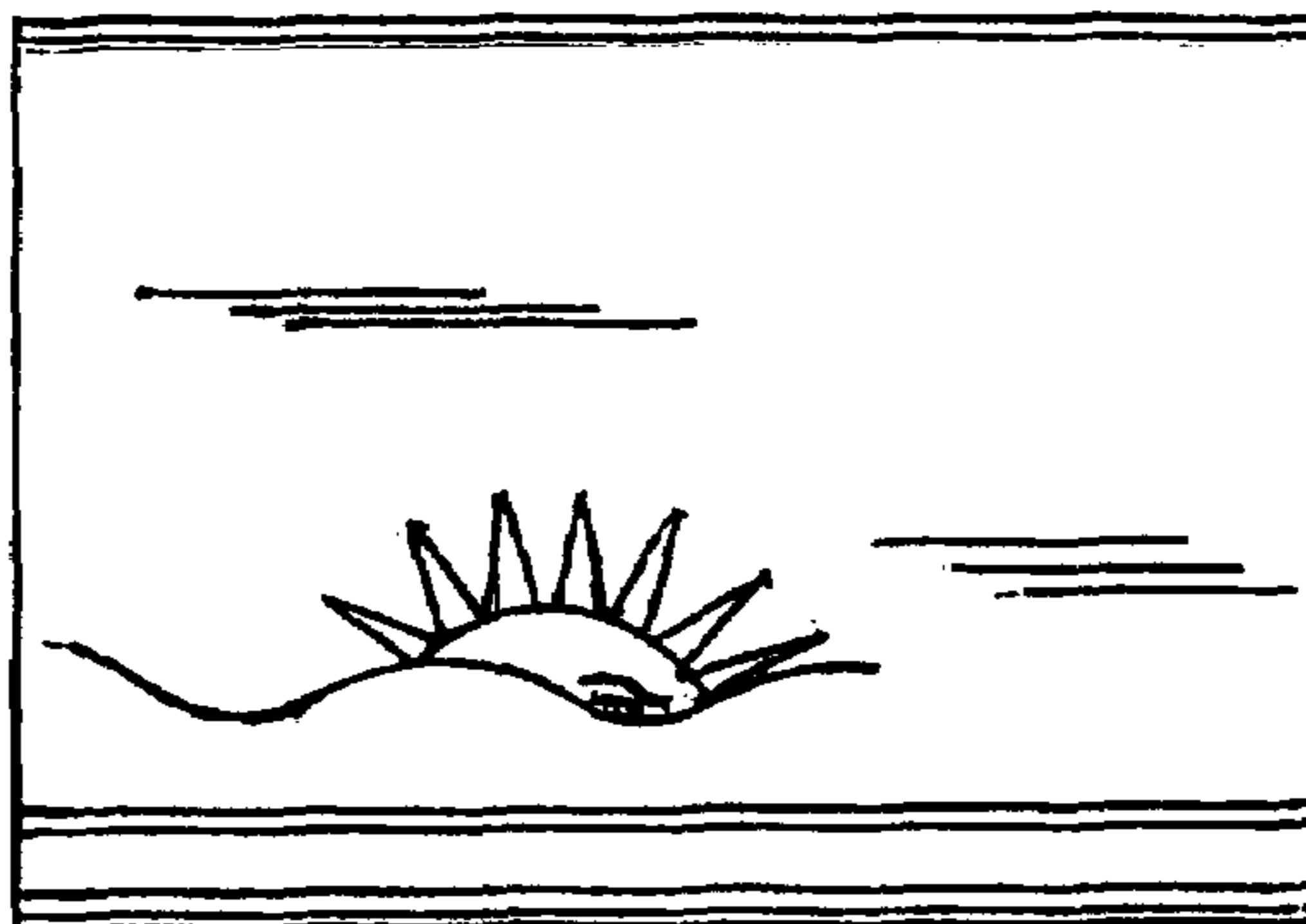
FIG. 2 is bottom view thereof;

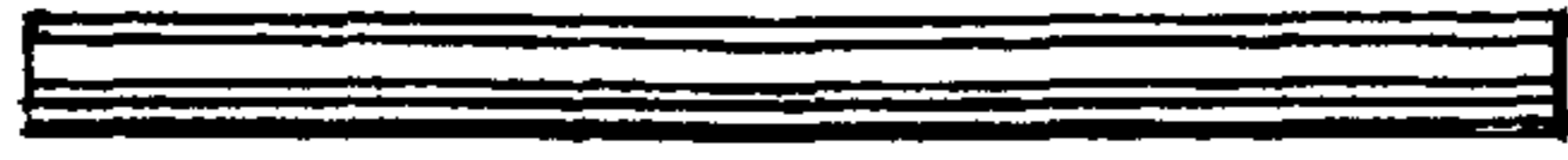

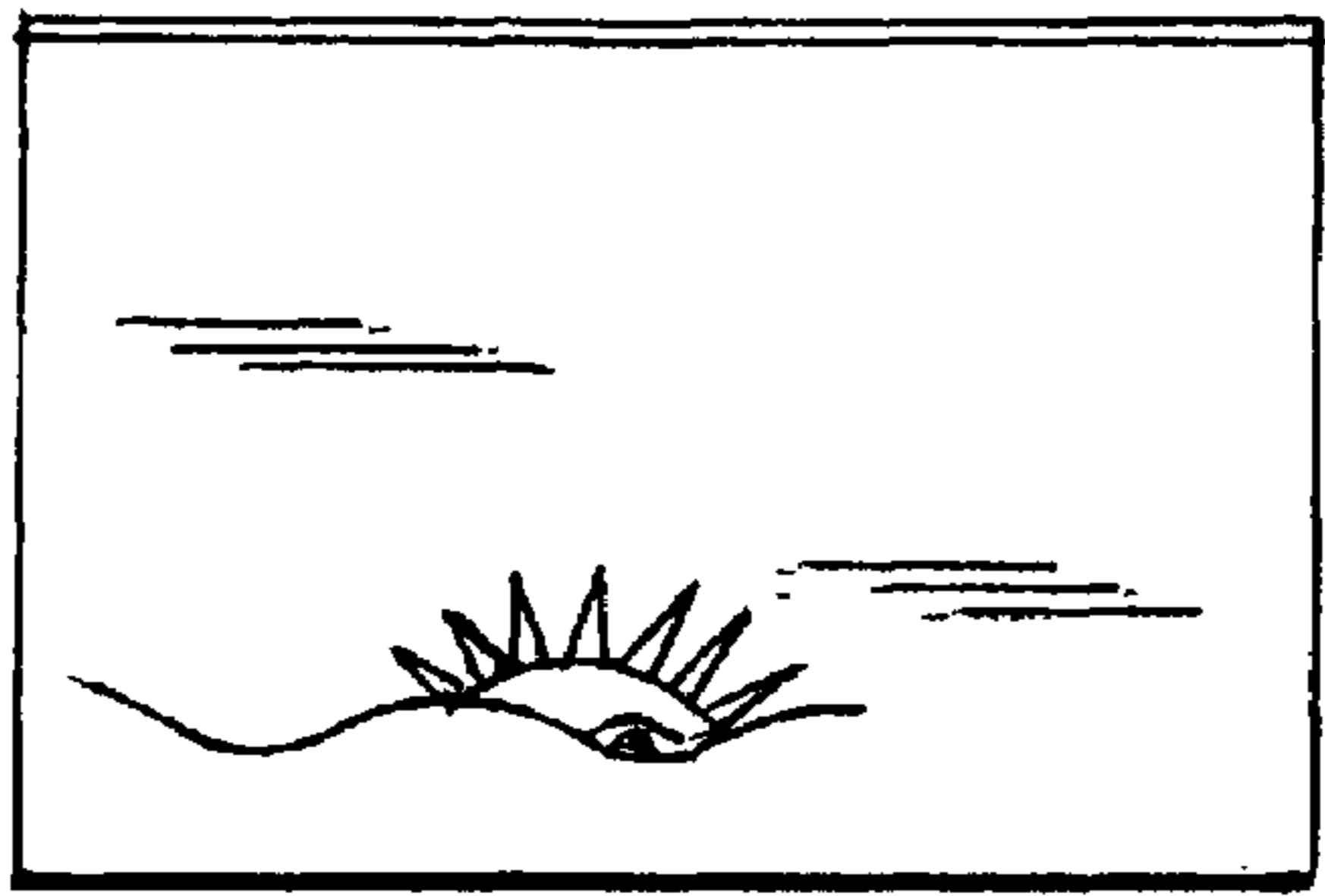

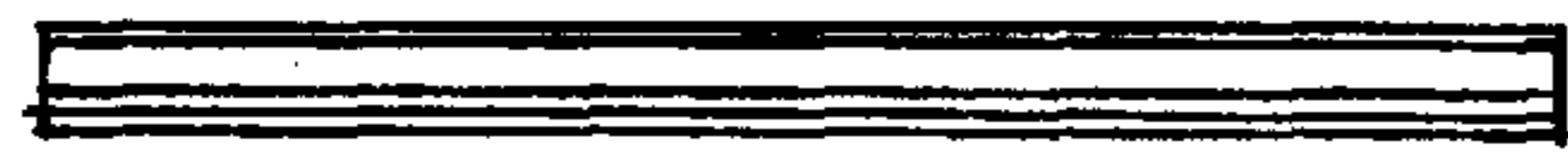

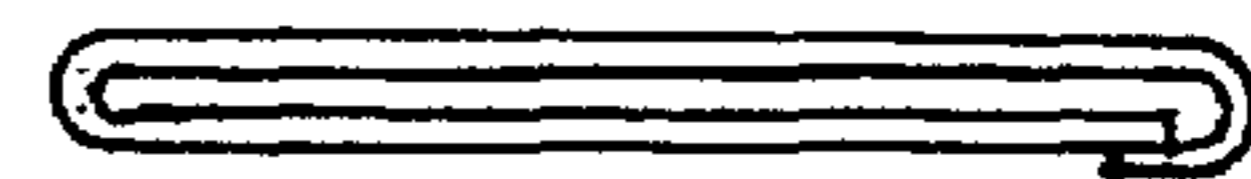

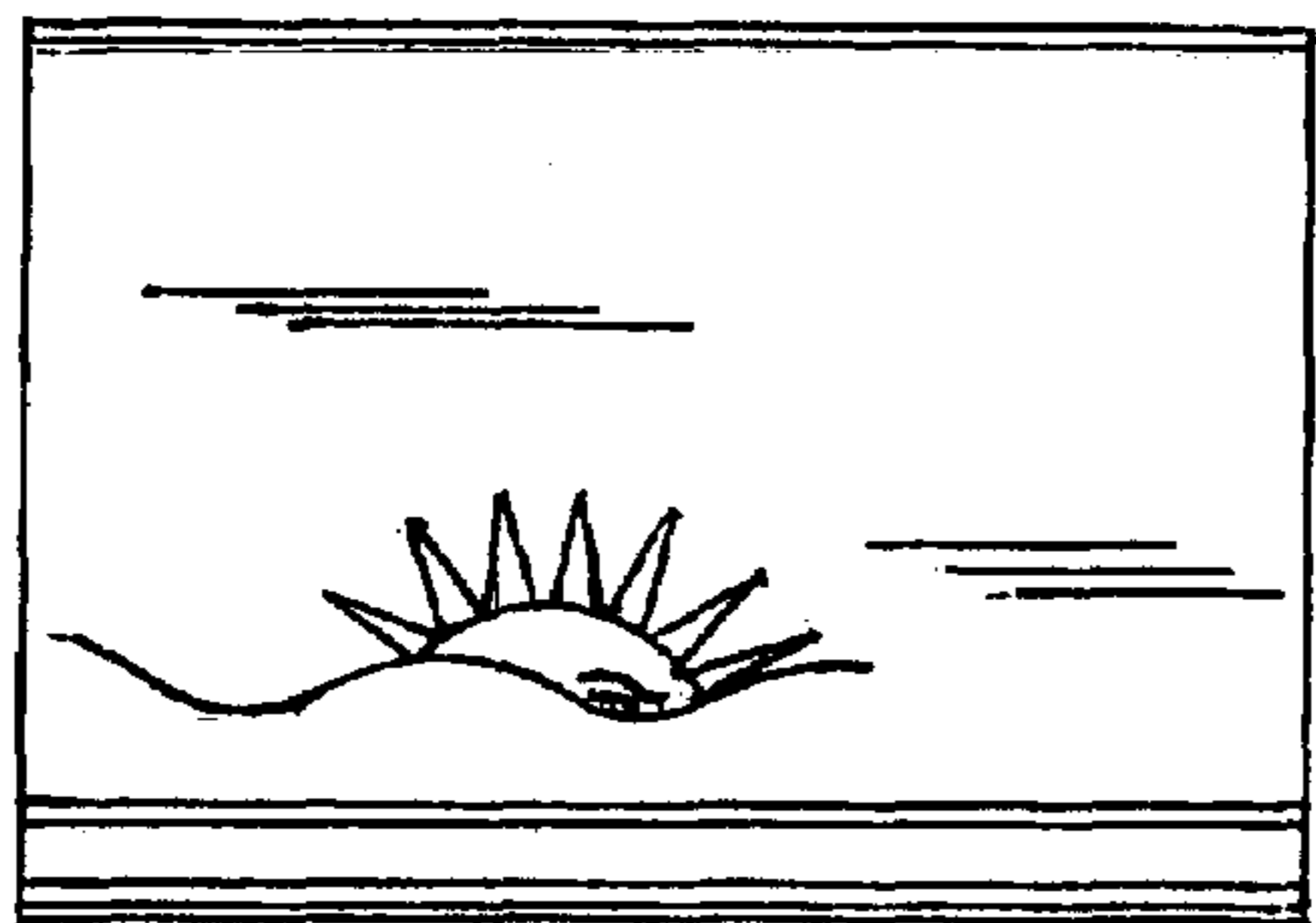
