The ornamental design for a pen, as shown and described.

DESCRIPTION

FIG. 1 is a lower front left perspective view of a pen showing our new design;
FIG. 2 is an upper rear right perspective view of the pen shown in FIG. 1, with the pen cap removed and placed on the opposite end of the pen;
FIG. 3 is an exploded lower front right perspective view of the pen shown in FIG. 1;
FIG. 4 is a top plan view of the pen shown in FIG. 1;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a left side elevation view thereof;
FIG. 7 is a front elevation view thereof;
FIG. 8 is a right side elevation view thereof; and,
FIG. 9 is a rear elevation view thereof.

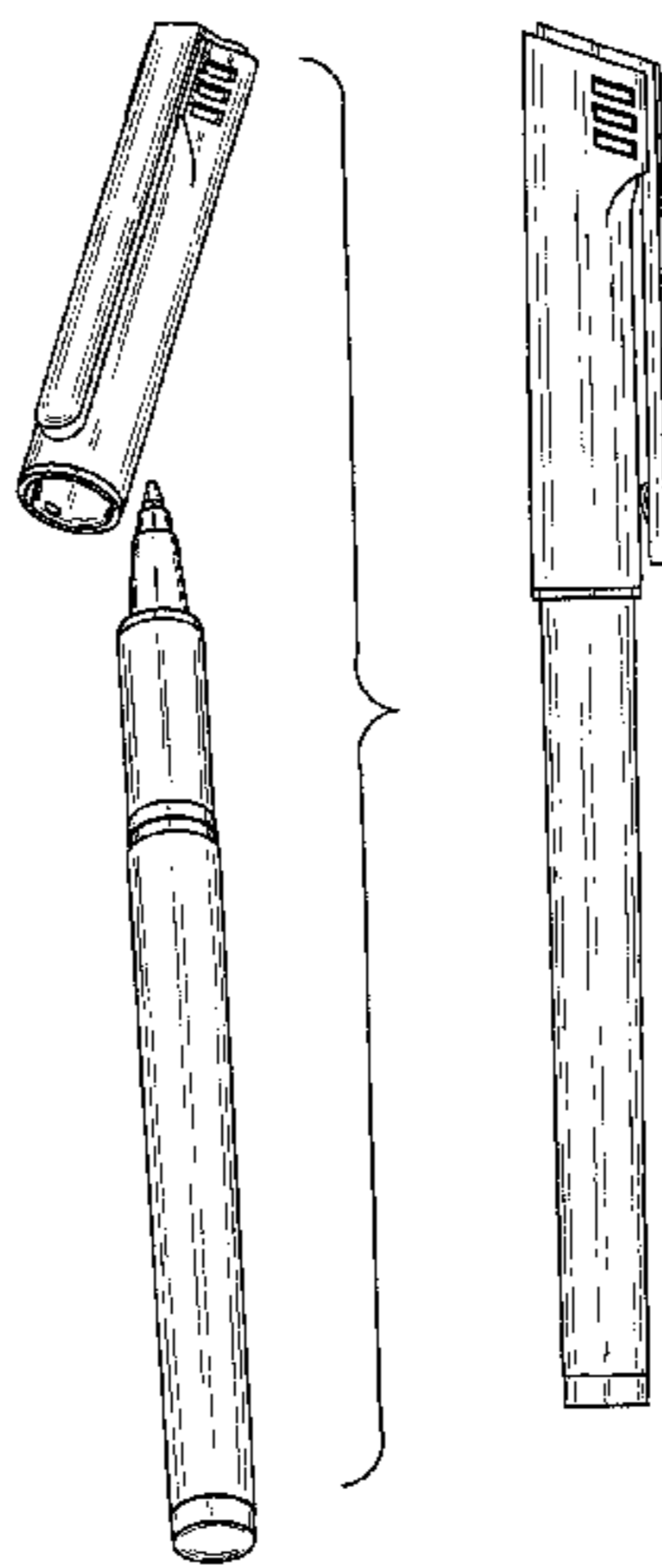

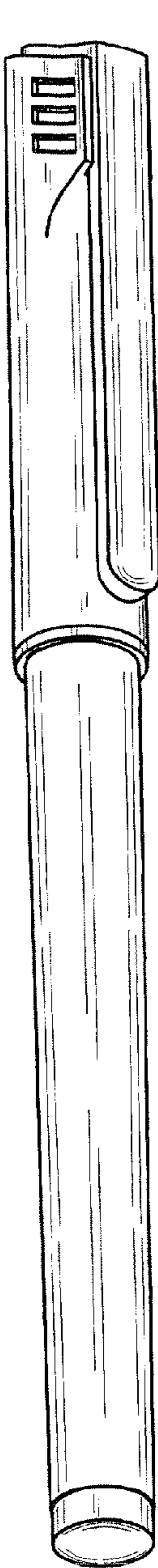
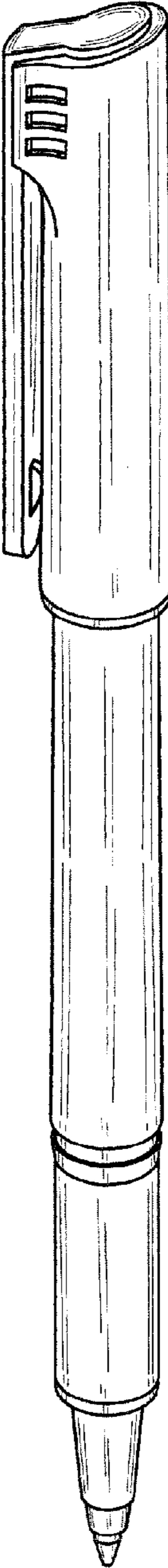

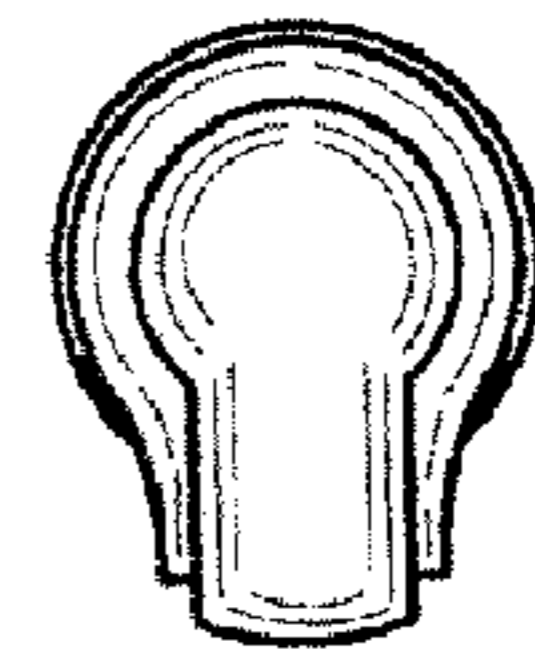
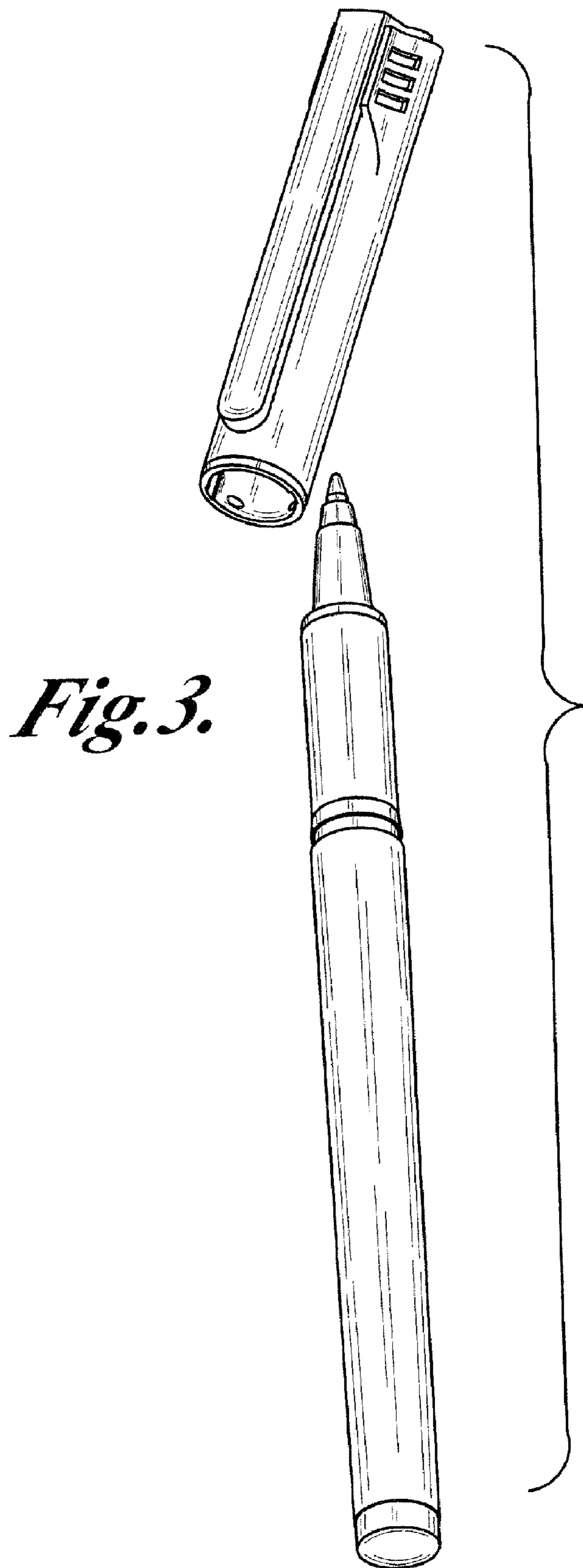

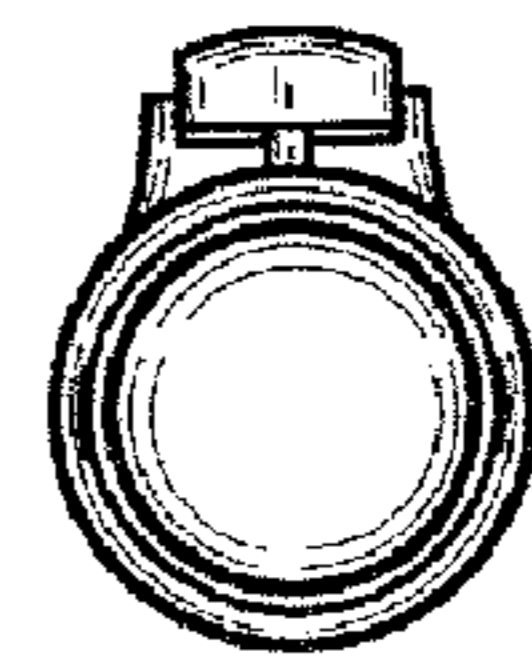

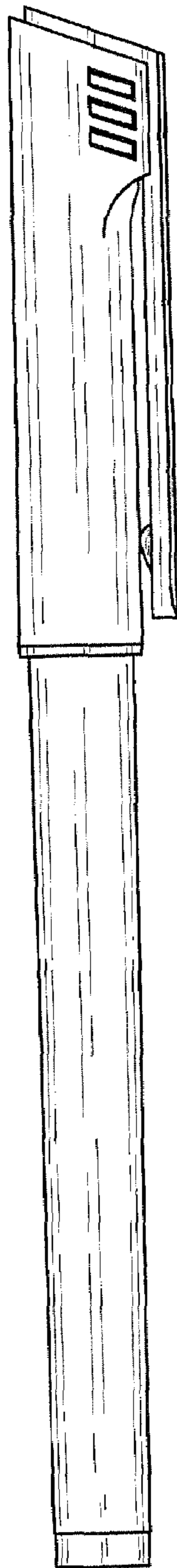

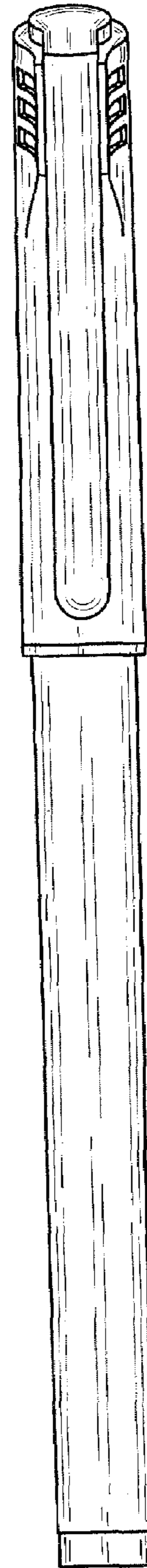

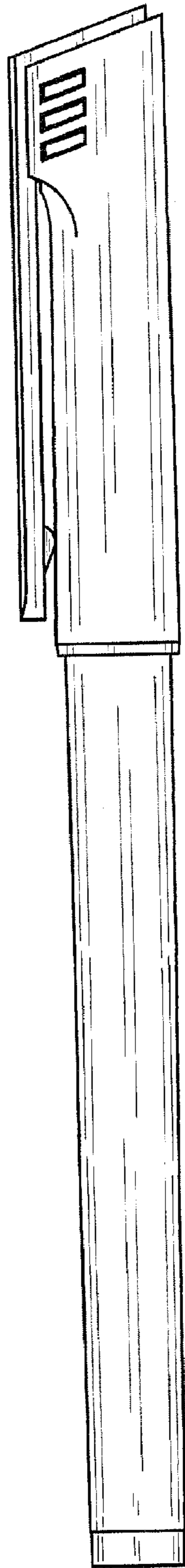

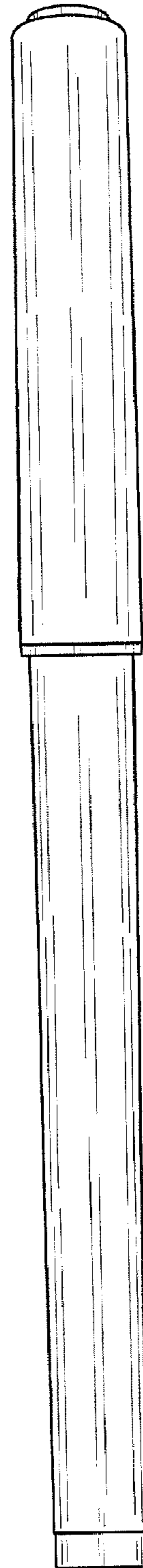
