(57) **CLAIM**

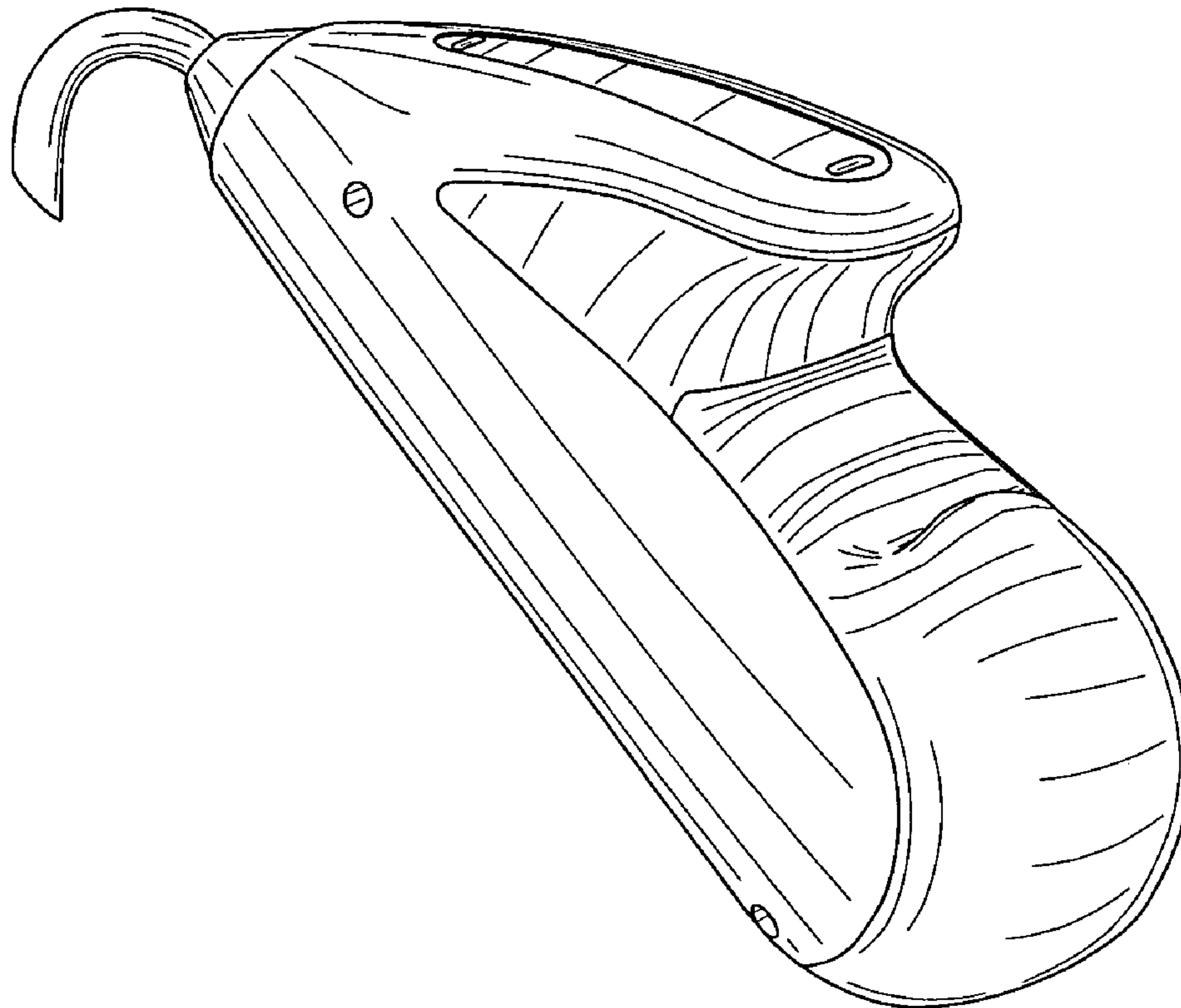
What is claimed is the ornamental design for a hearing aid, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a new design for a hearing aid; FIG. 2 is a side view of the hearing aid shown in FIG. 1, the opposite side being a mirror image.

FIG. 3 is a top view of the hearing aid shown in FIG. 1; and, FIG. 4 is a bottom view of the hearing aid shown in FIG. 1.

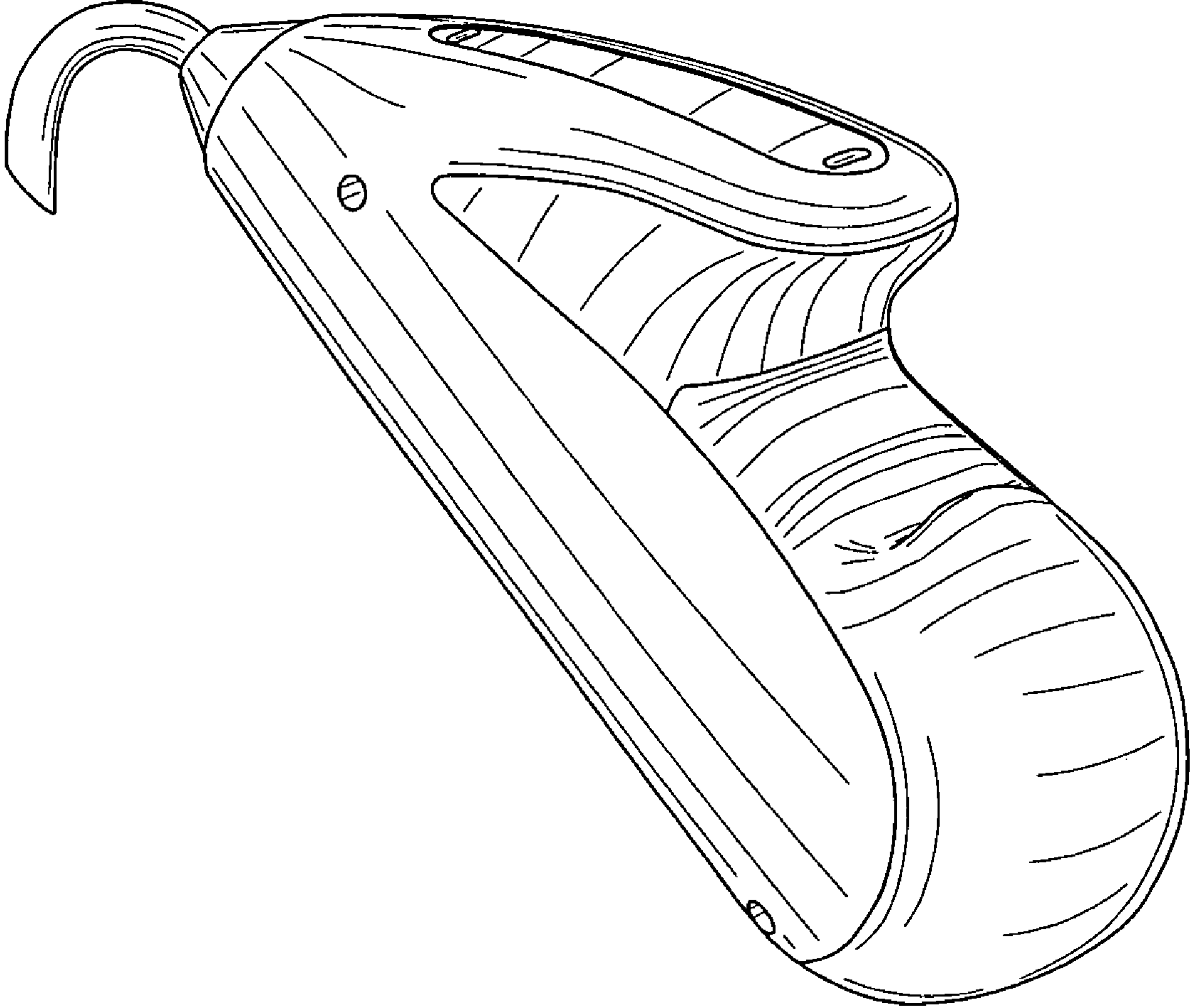

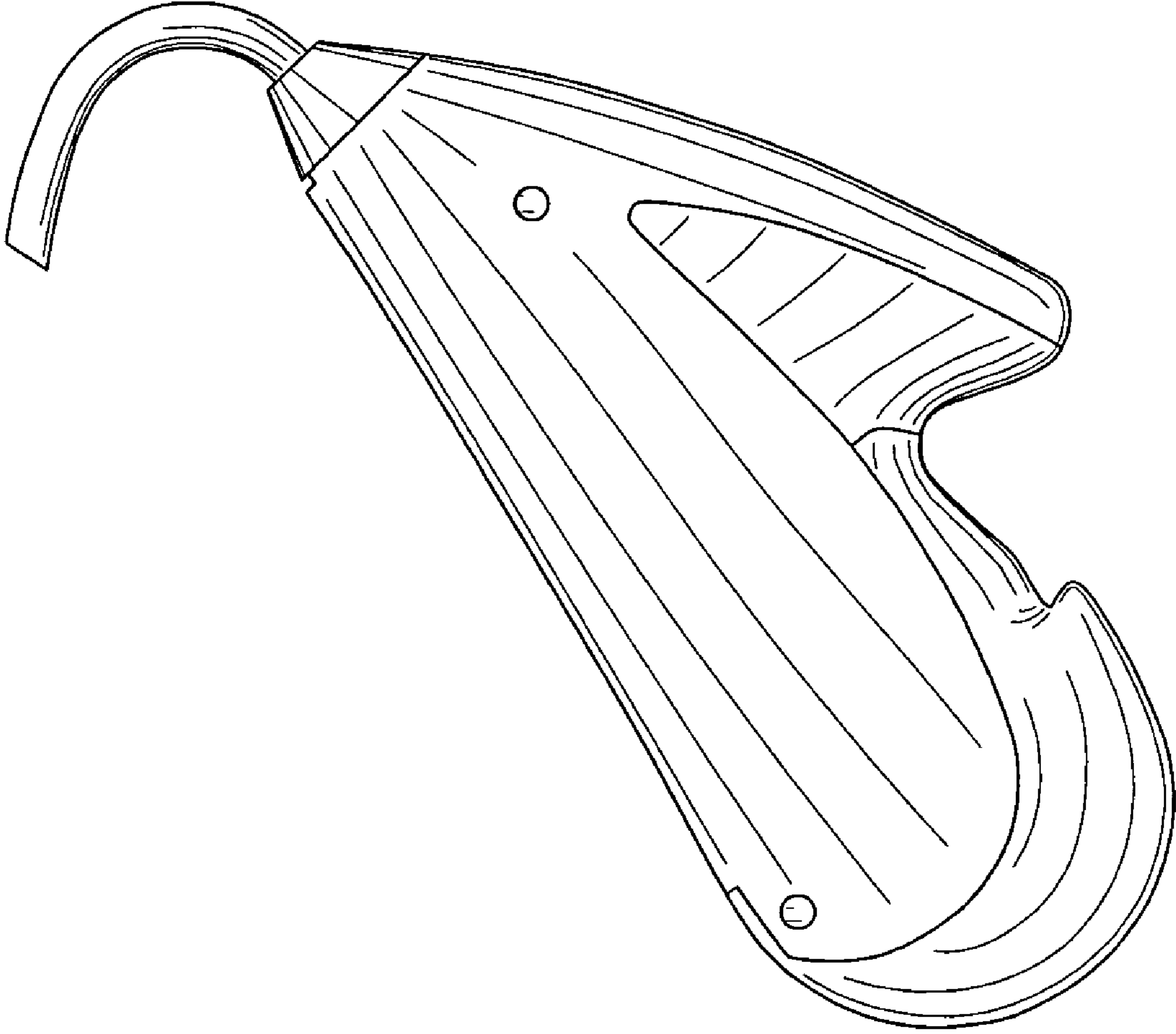

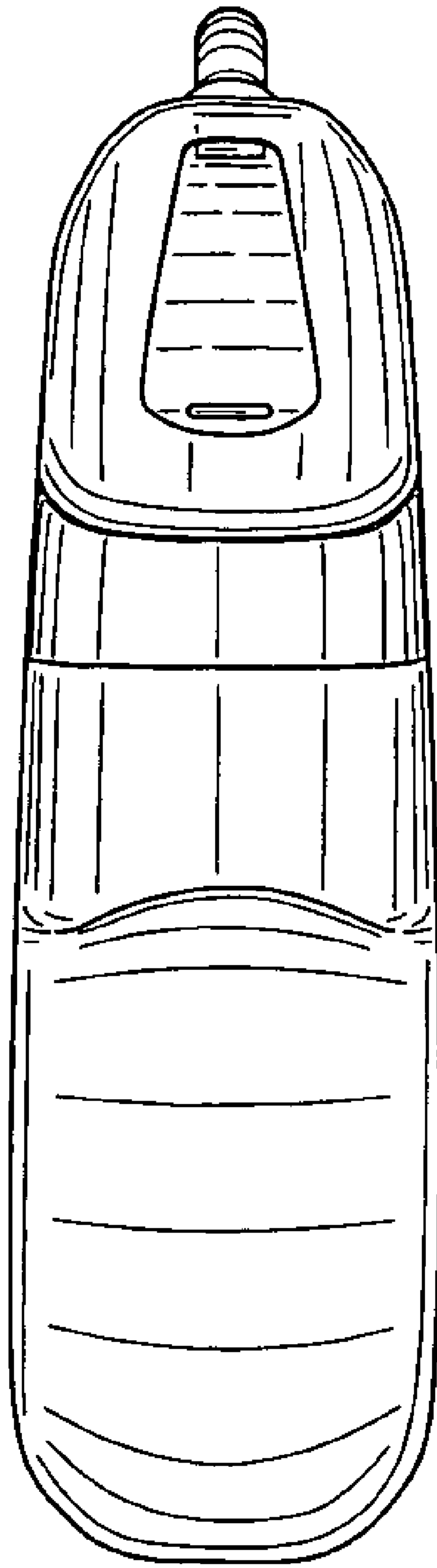

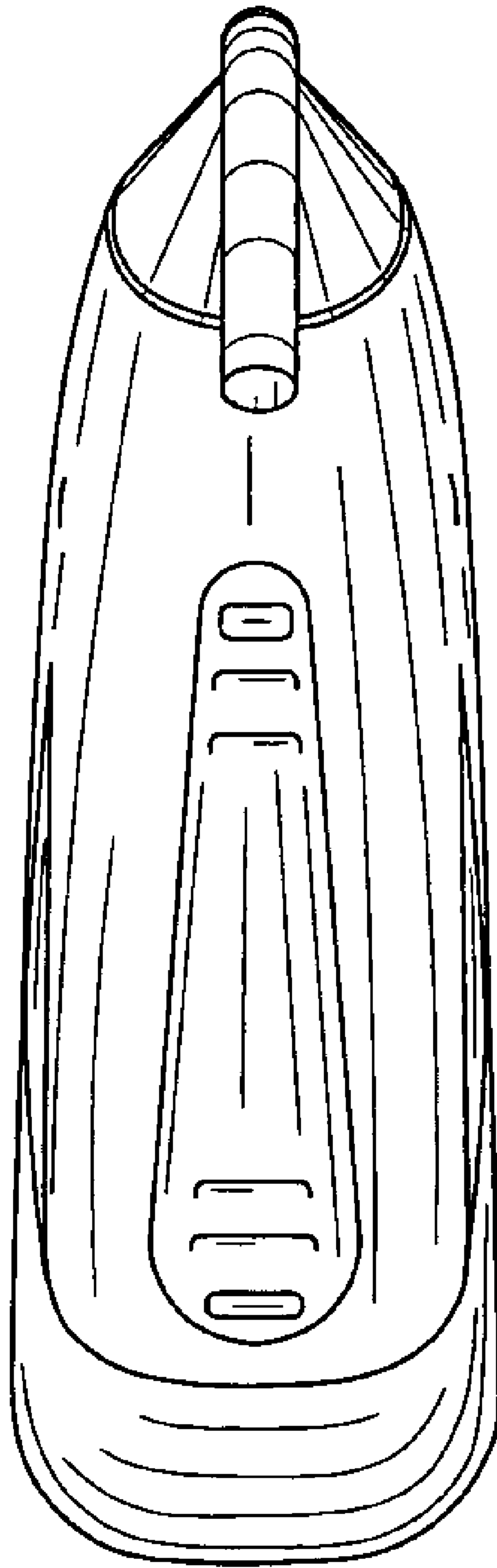
