DESCRIPTION

FIG. 1 is a perspective view of a light object showing our design;

FIG. 2 is a front view of the light object of FIG. 1;

FIG. 3 is a right side elevational view of the light object of FIG. 1, the left side elevational view being a mirror image thereof;

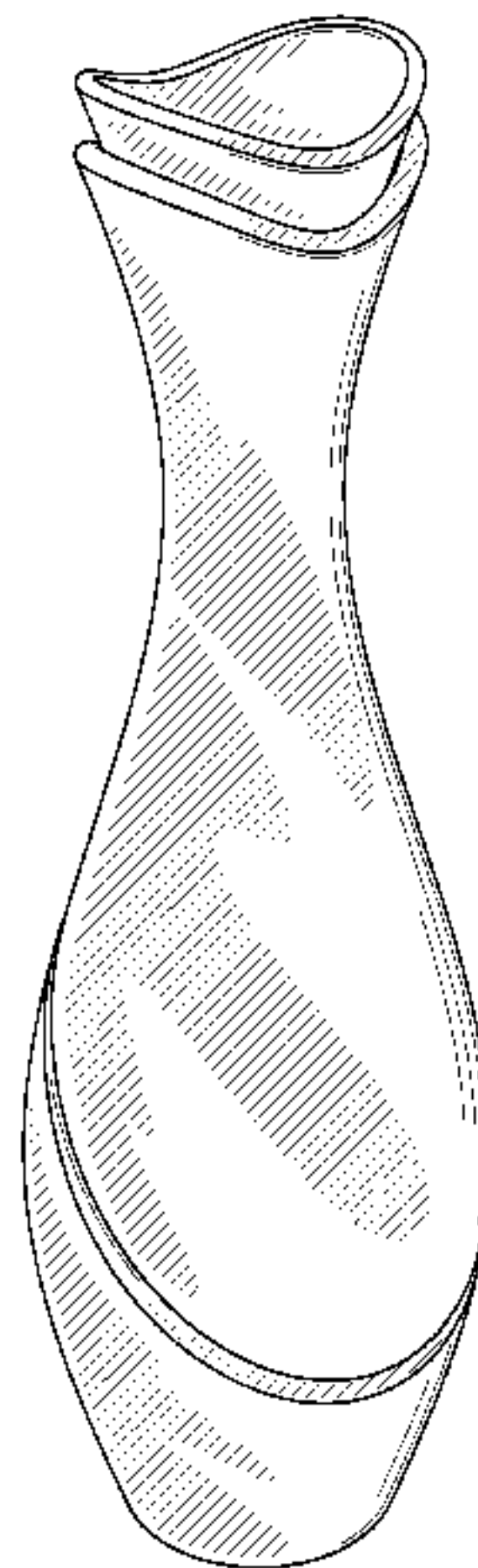
FIG. 4 is a top view of the light object of FIG. 1;

FIG. 5 is a rear view of the light object of FIG. 1; and,

FIG. 6 is a bottom view of the light object of FIG. 1.

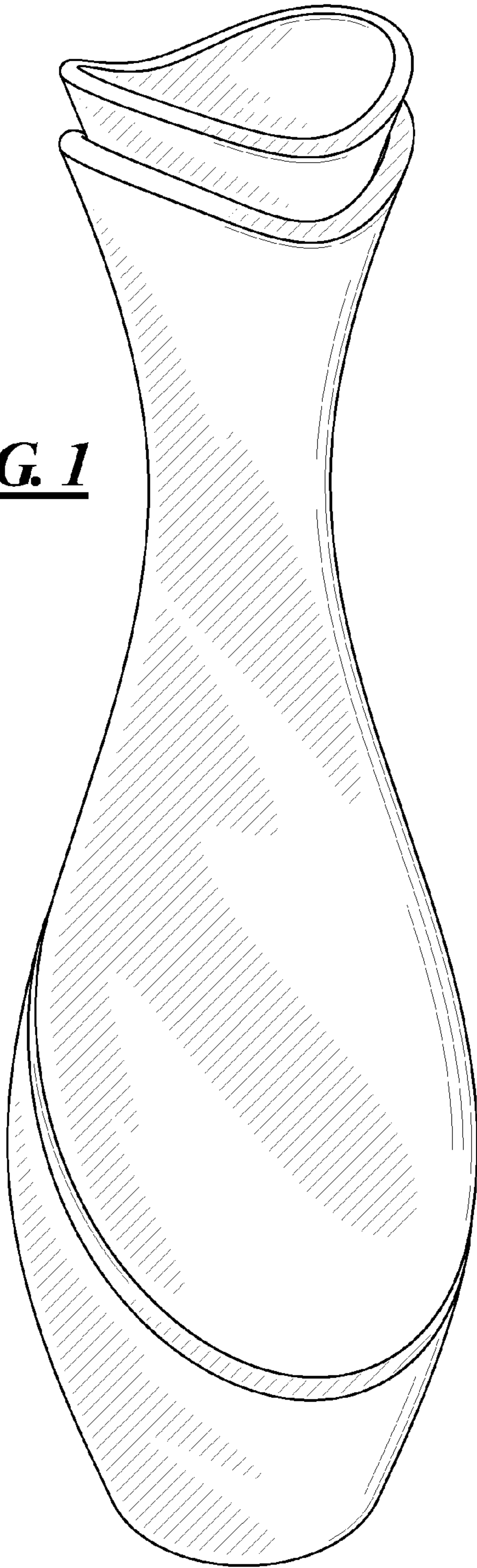

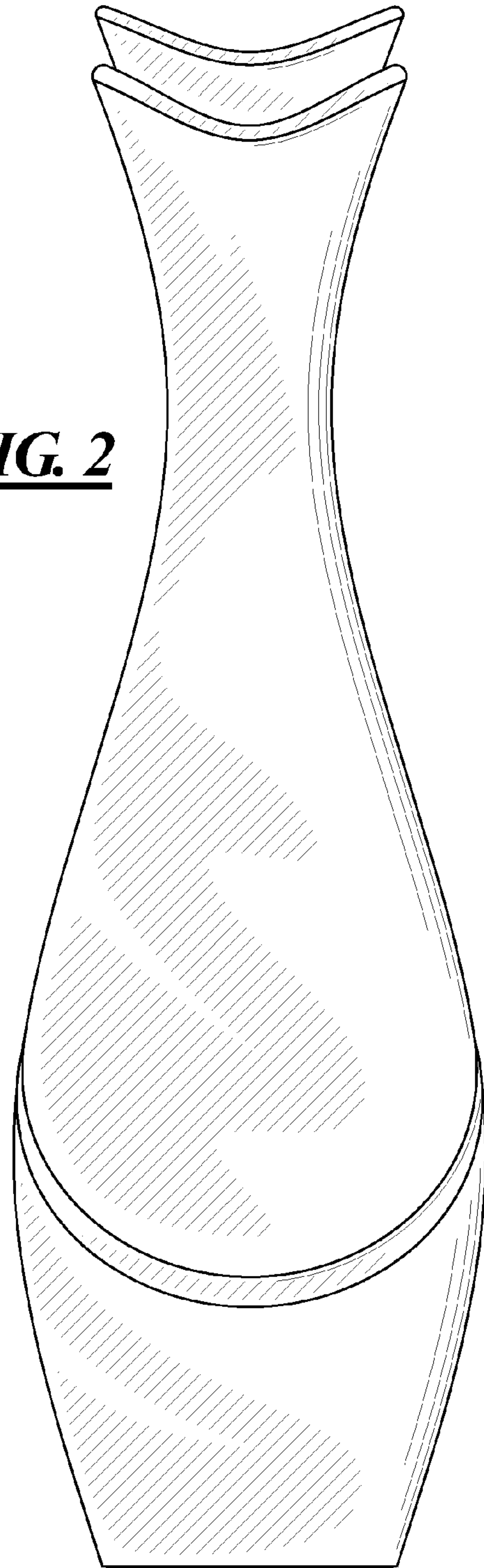

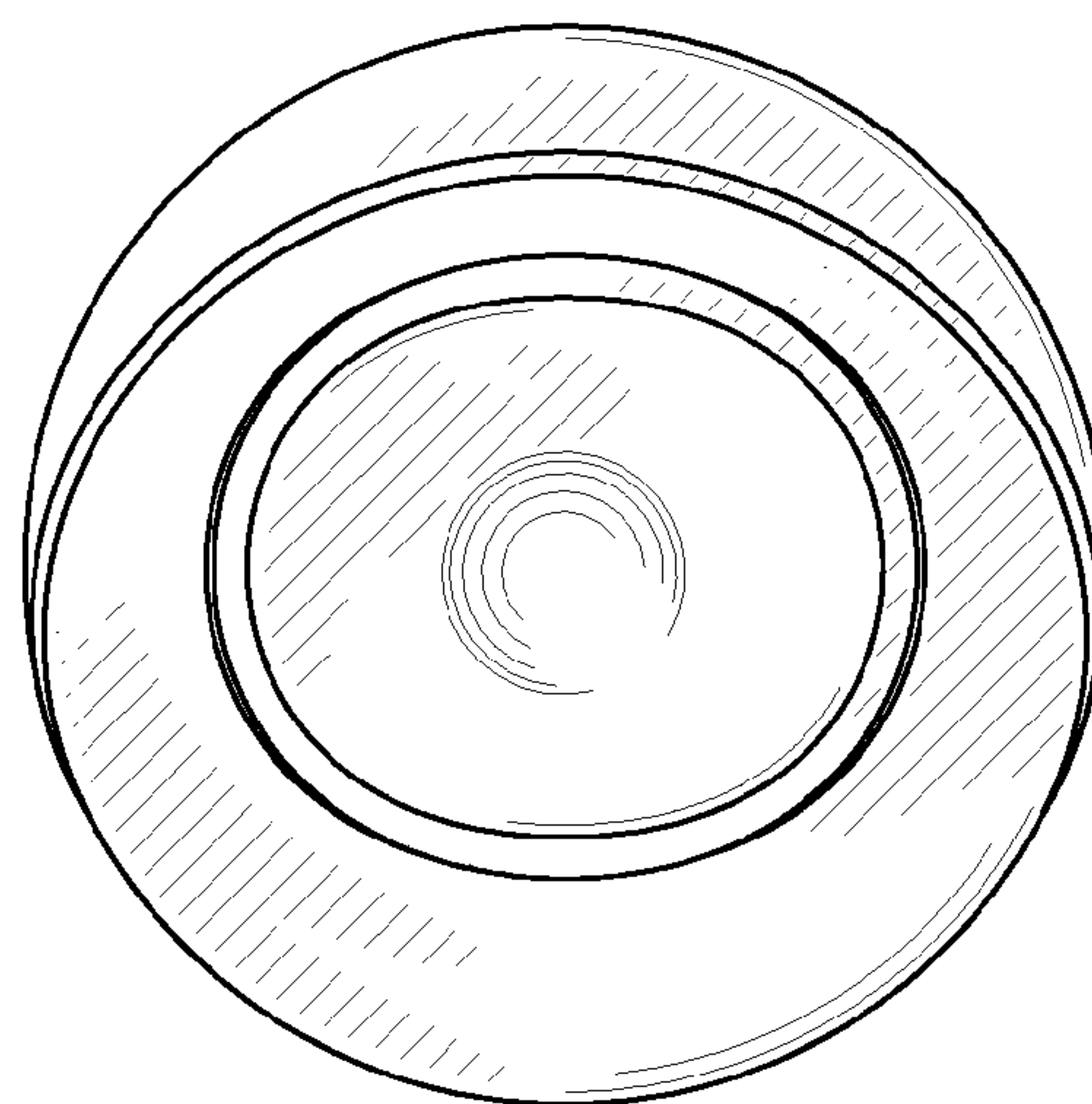
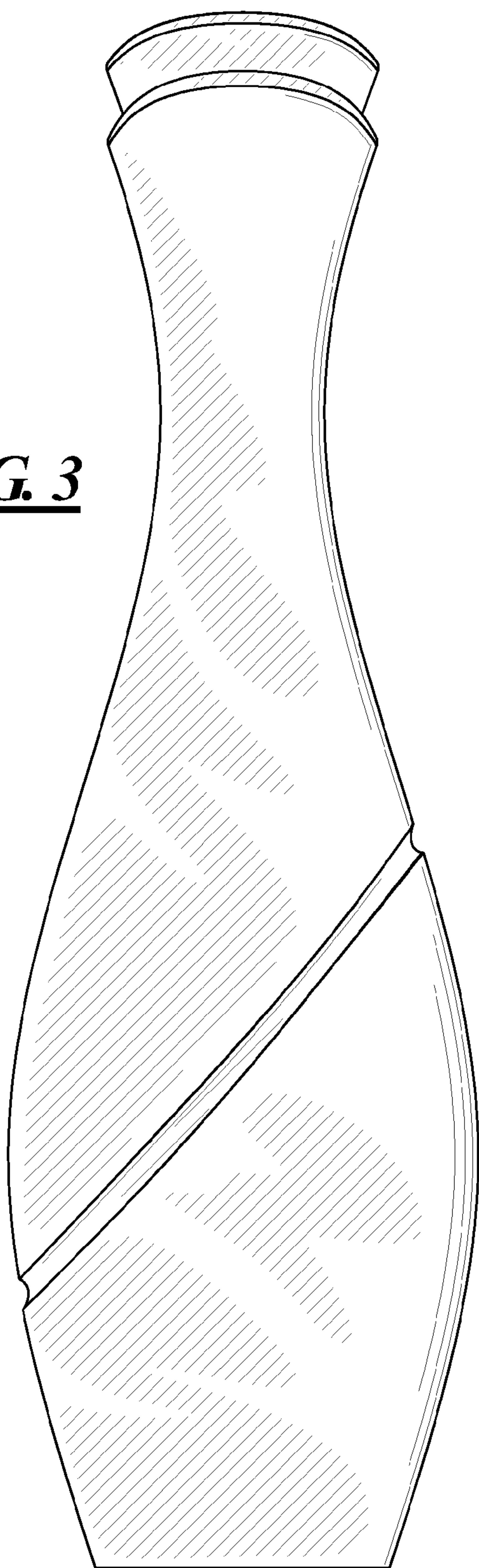

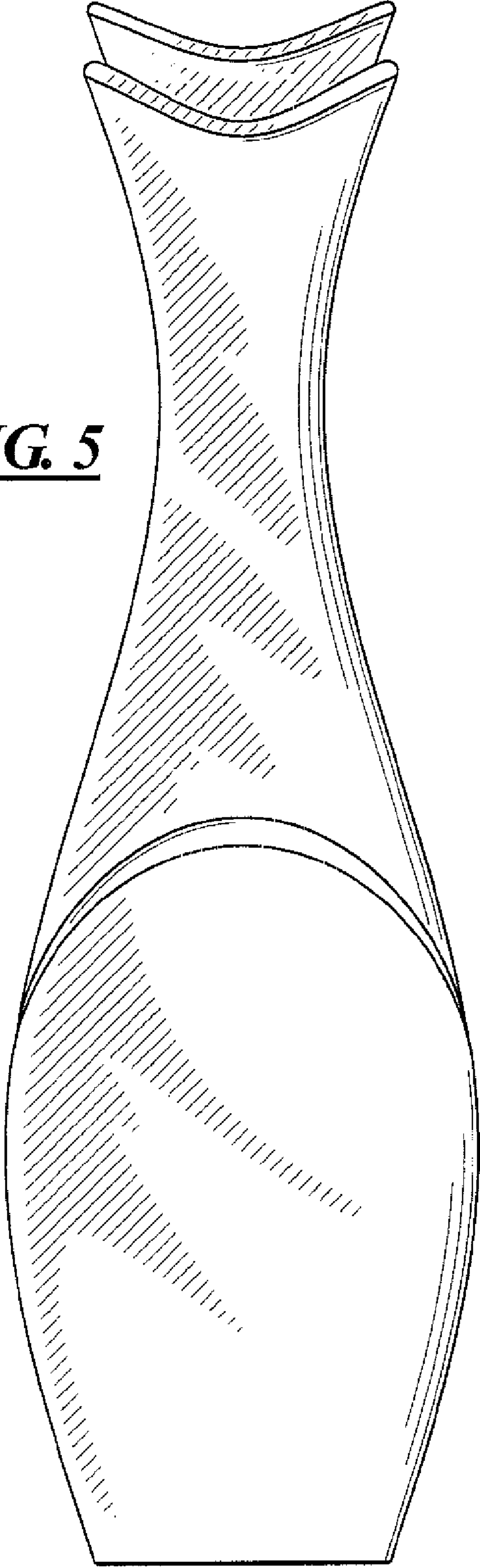
