(57) **CLAIM**

We claim the ornamental design for a spray gun washer console, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first embodiment of the spray gun washer console;

FIG. 2 is a side view, the opposite side view being a mirror image;

FIG. 3 is a rear view;

FIG. 4 is a top view;

FIG. 5 is a front perspective view;

FIG. 6 is a front view of a second embodiment of the design, with a cover shown in a first position;

FIG. 7 is a side view, the opposite side view being a mirror image;

FIG. 8 is a rear view;

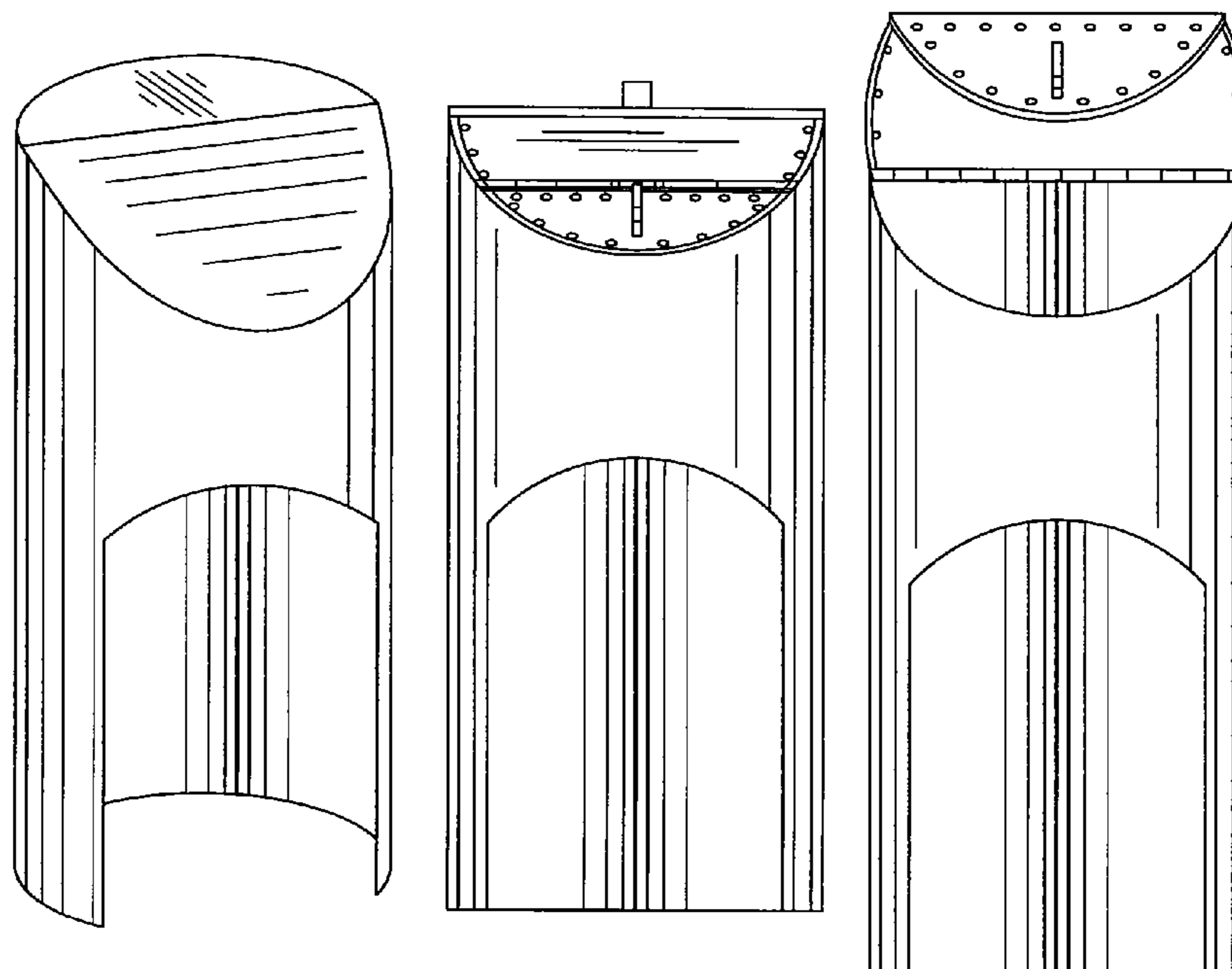
FIG. 9 is a top view;

FIG. 10 is a front view with the cover shown in a second position; and,

FIG. 11 is a side view, the opposite side view being a mirror image.

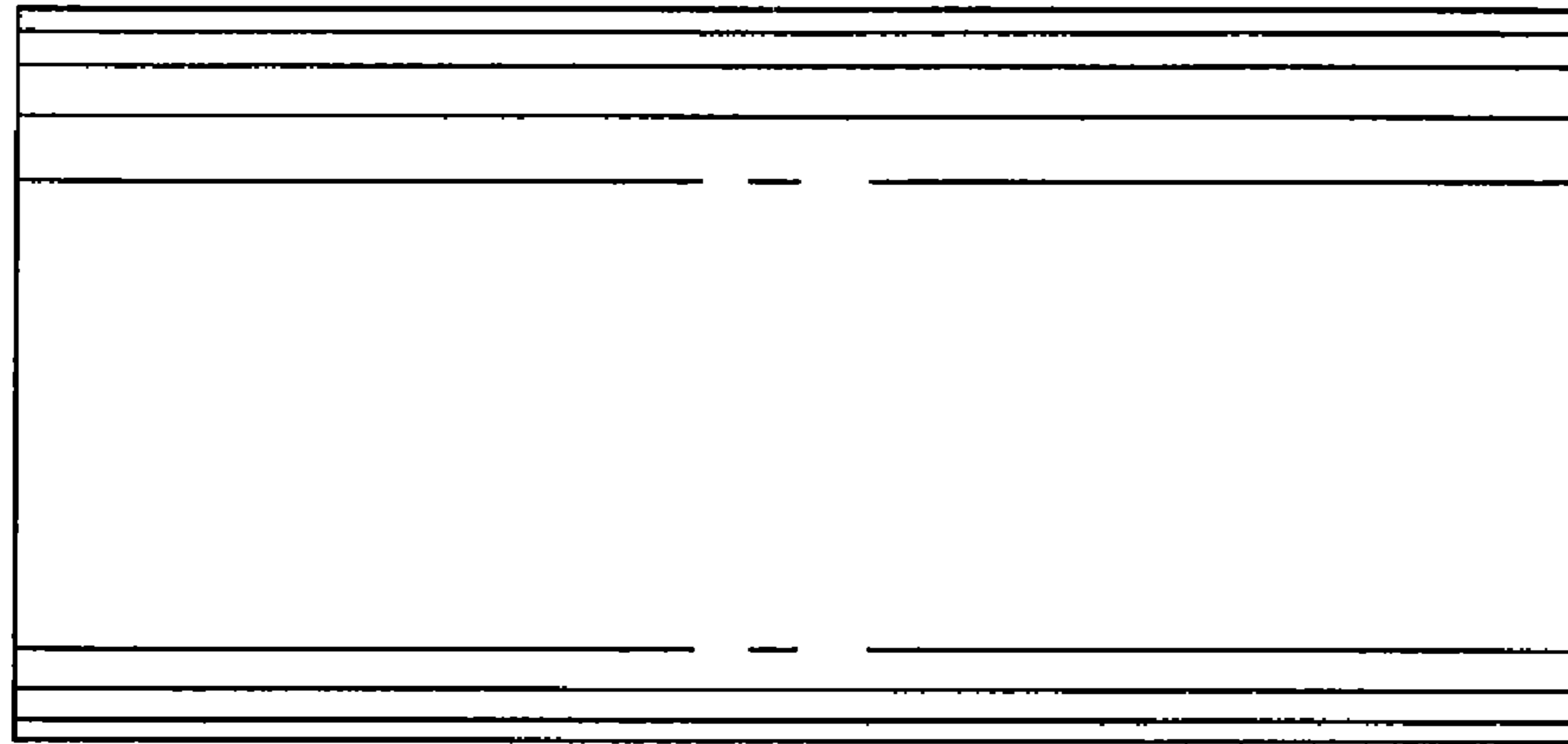

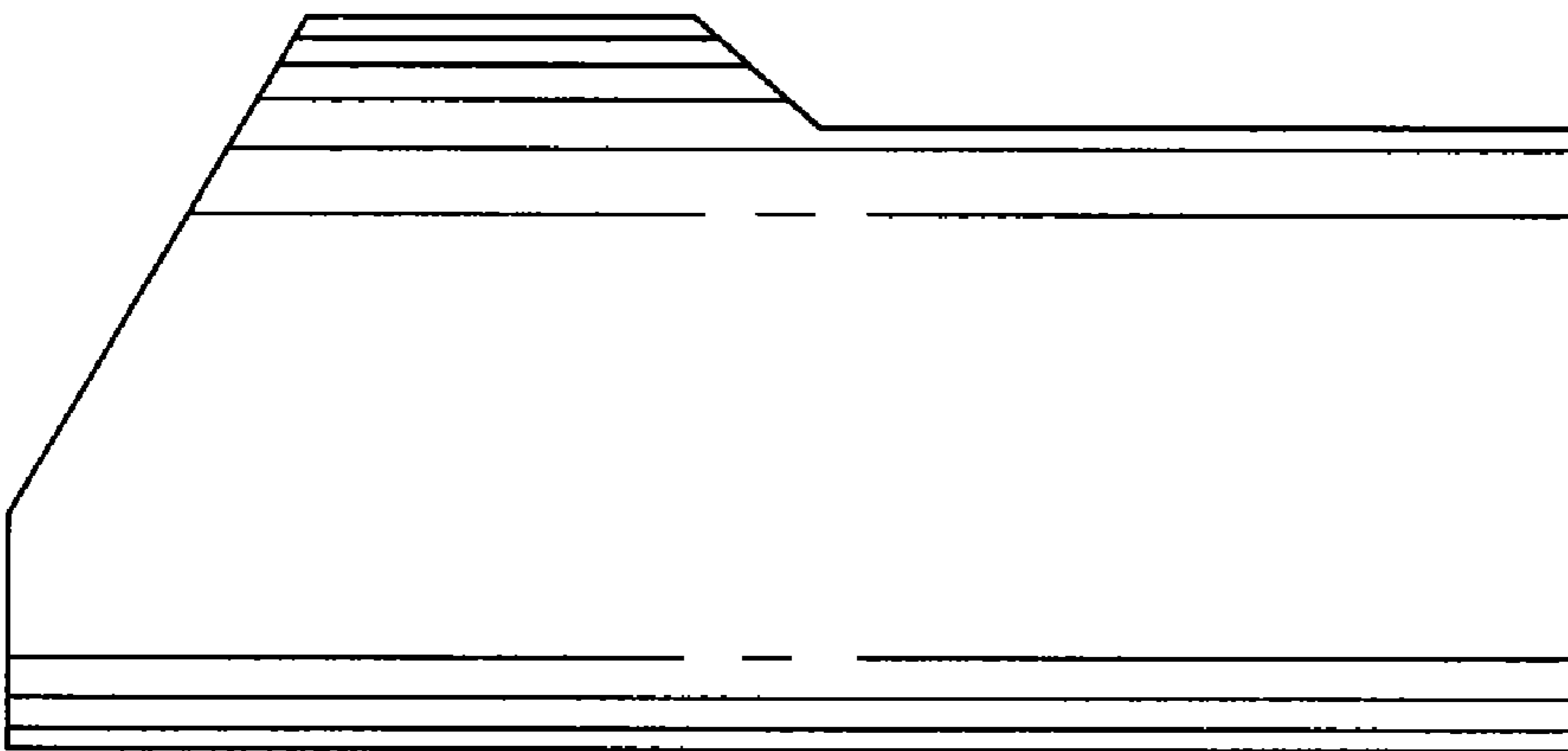

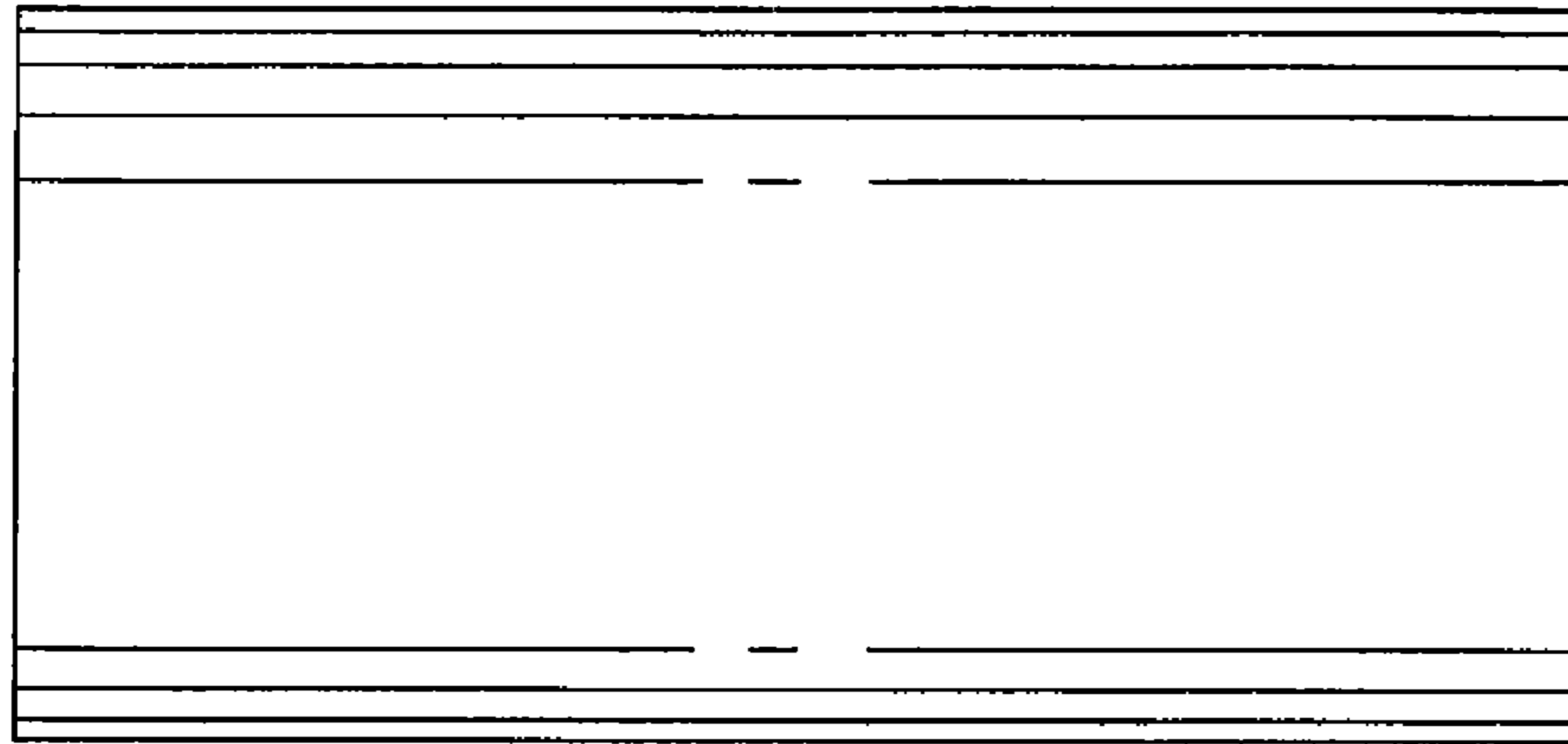

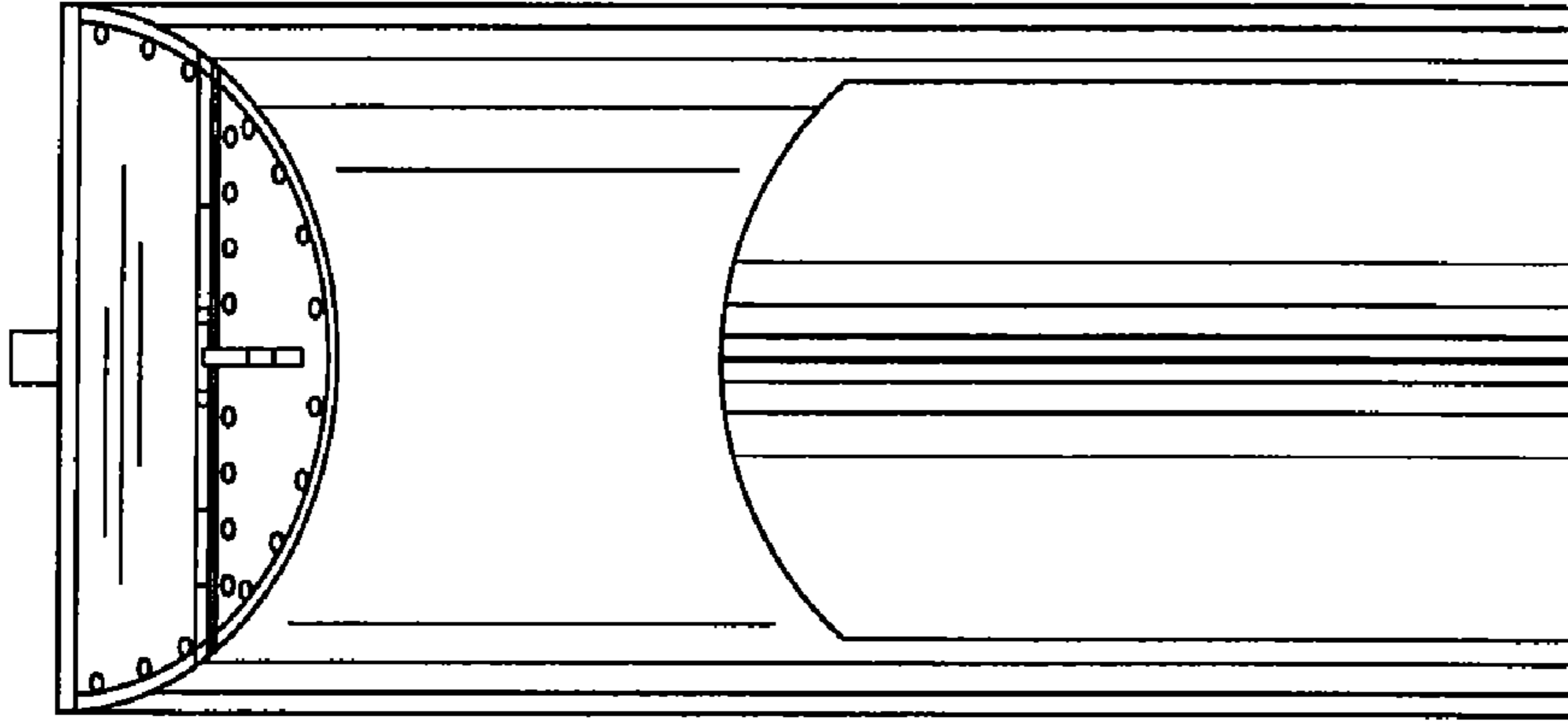

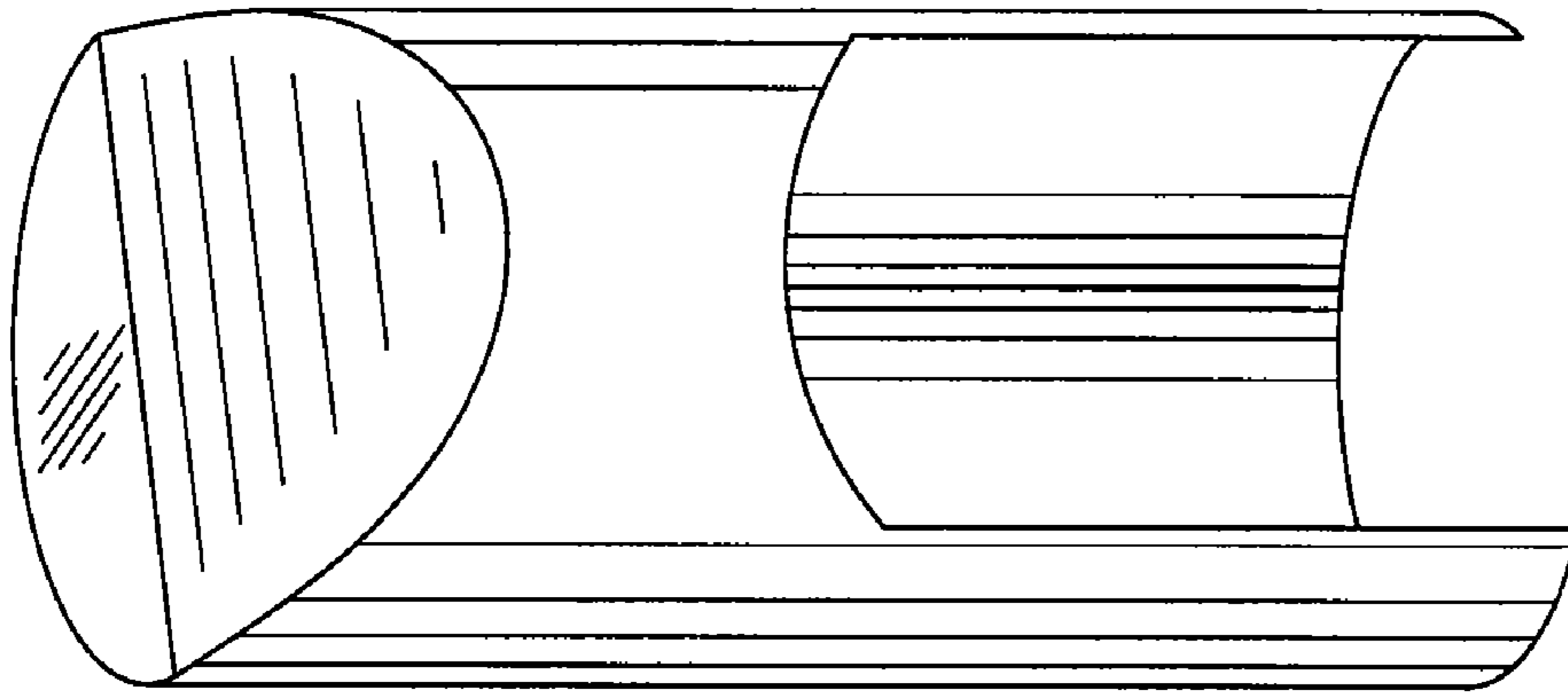

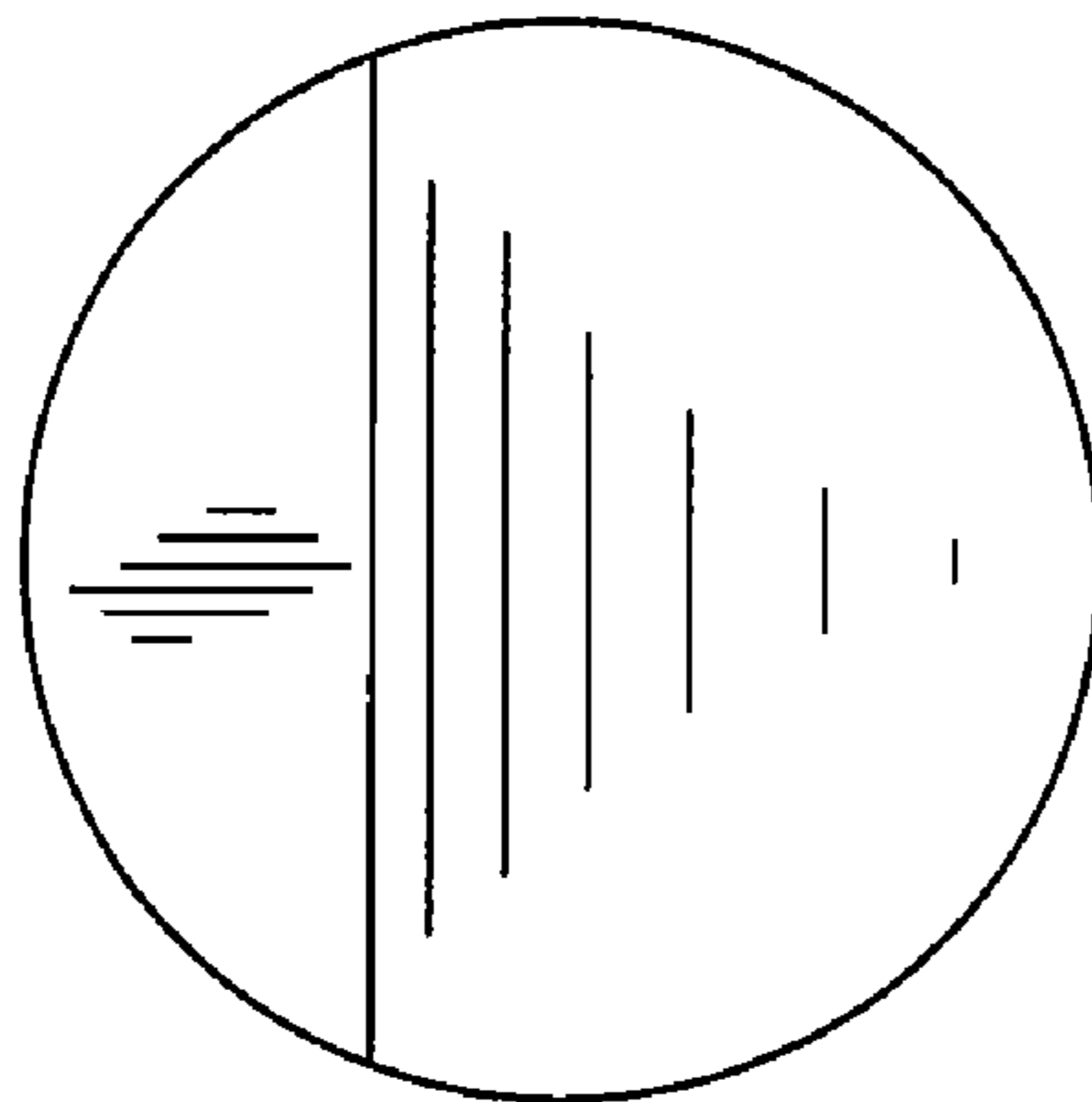

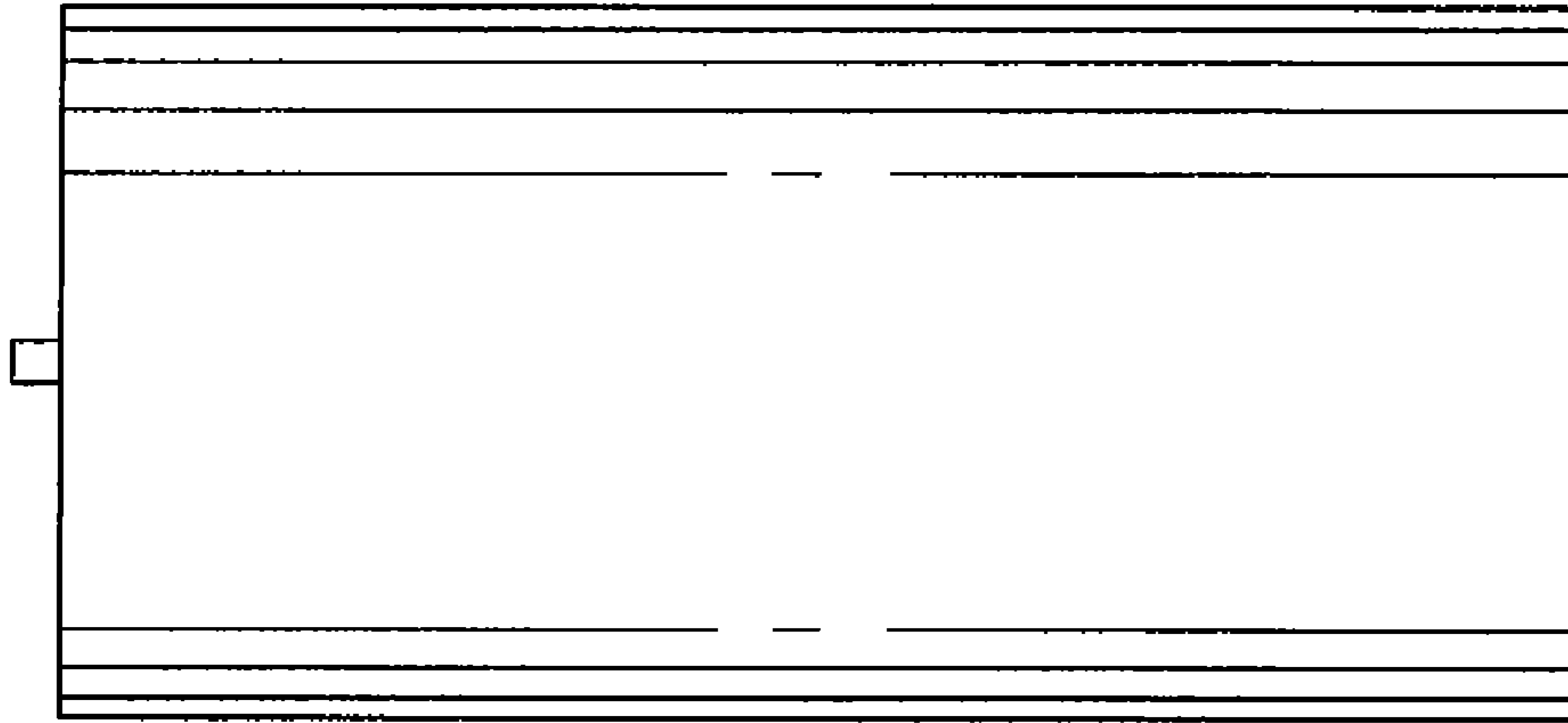

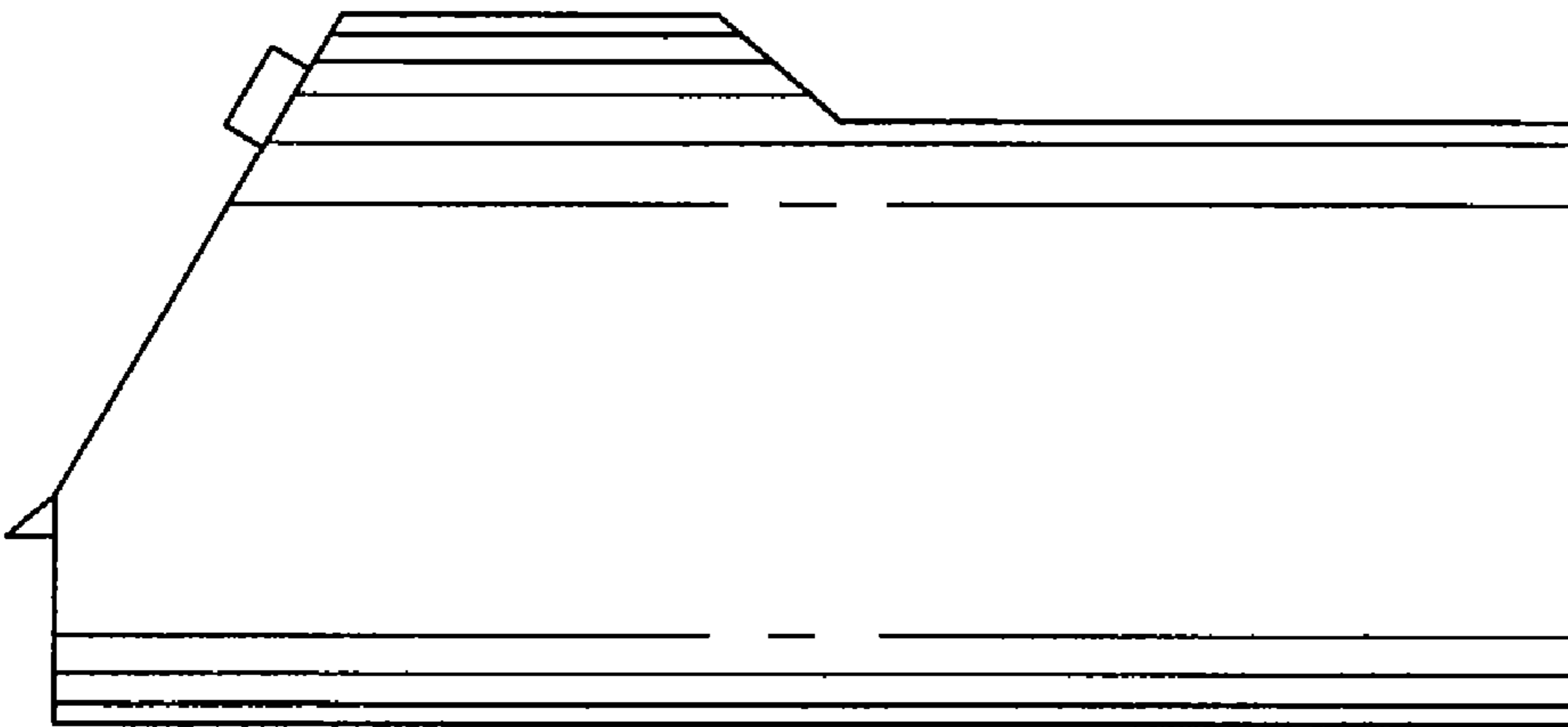

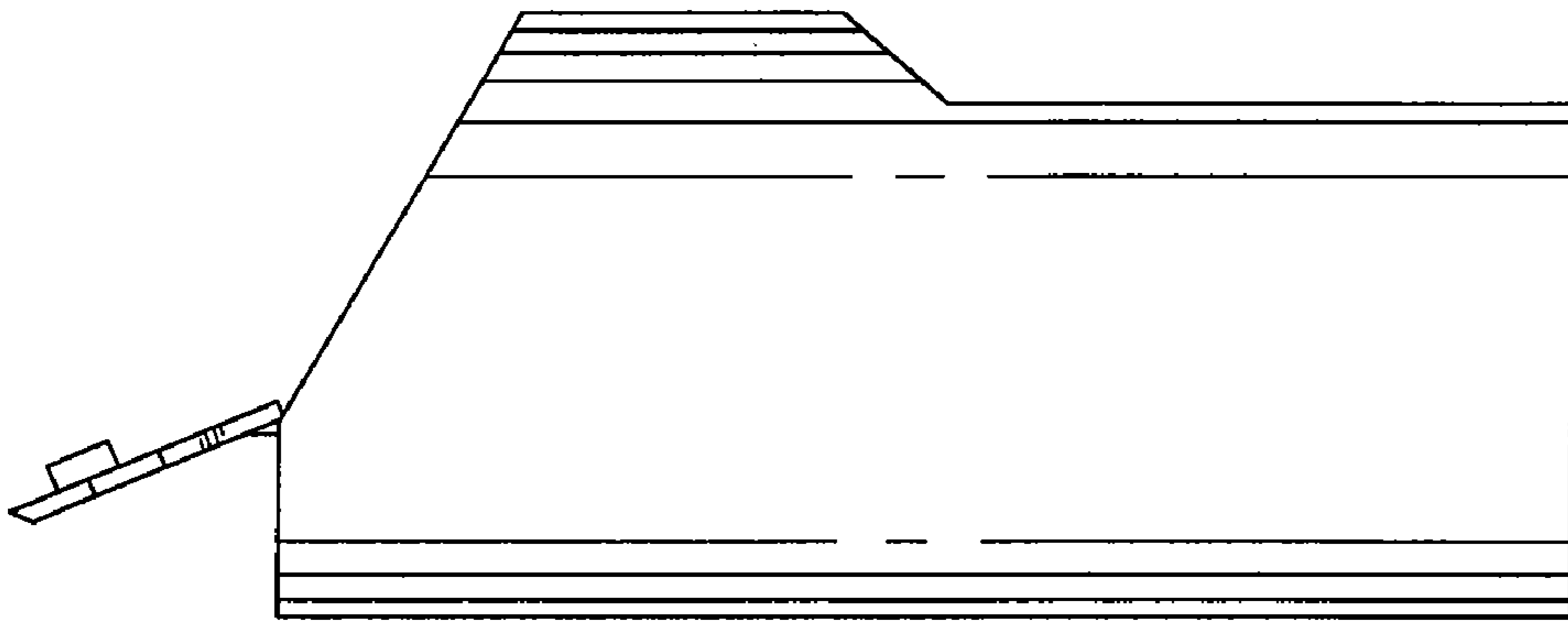

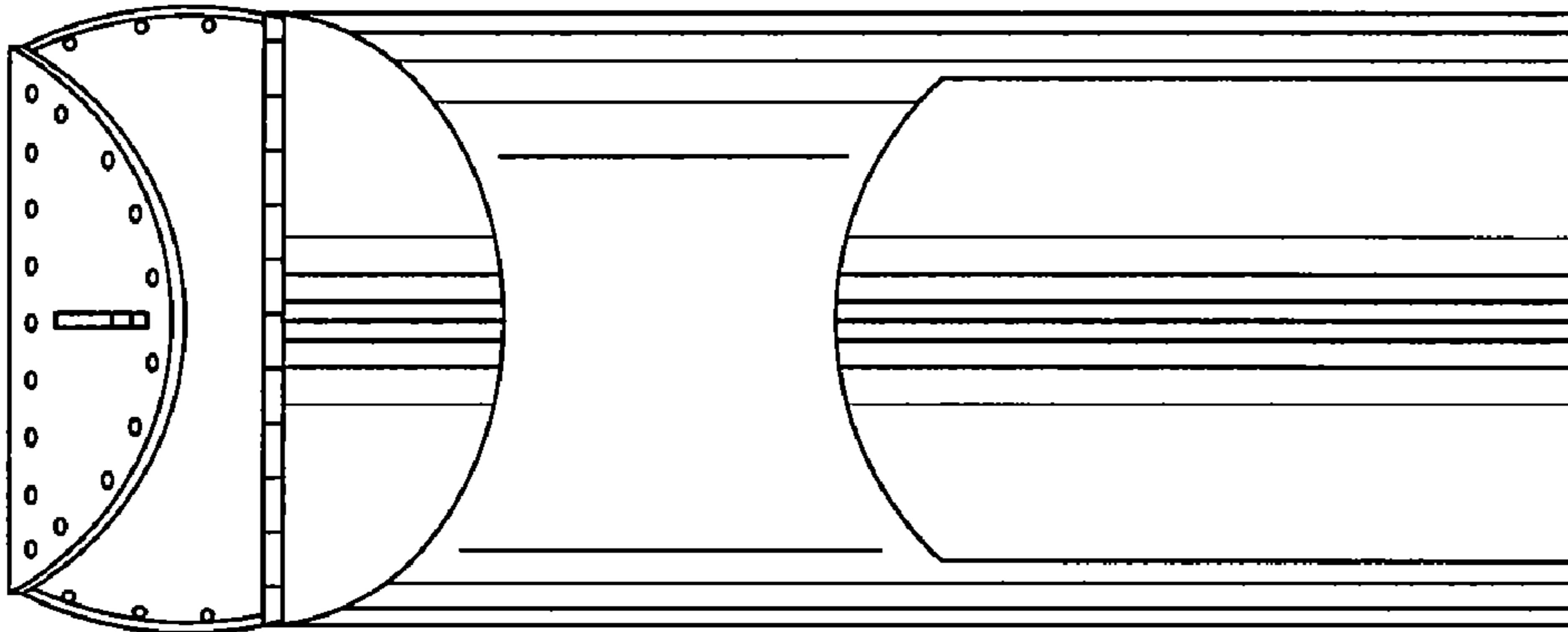

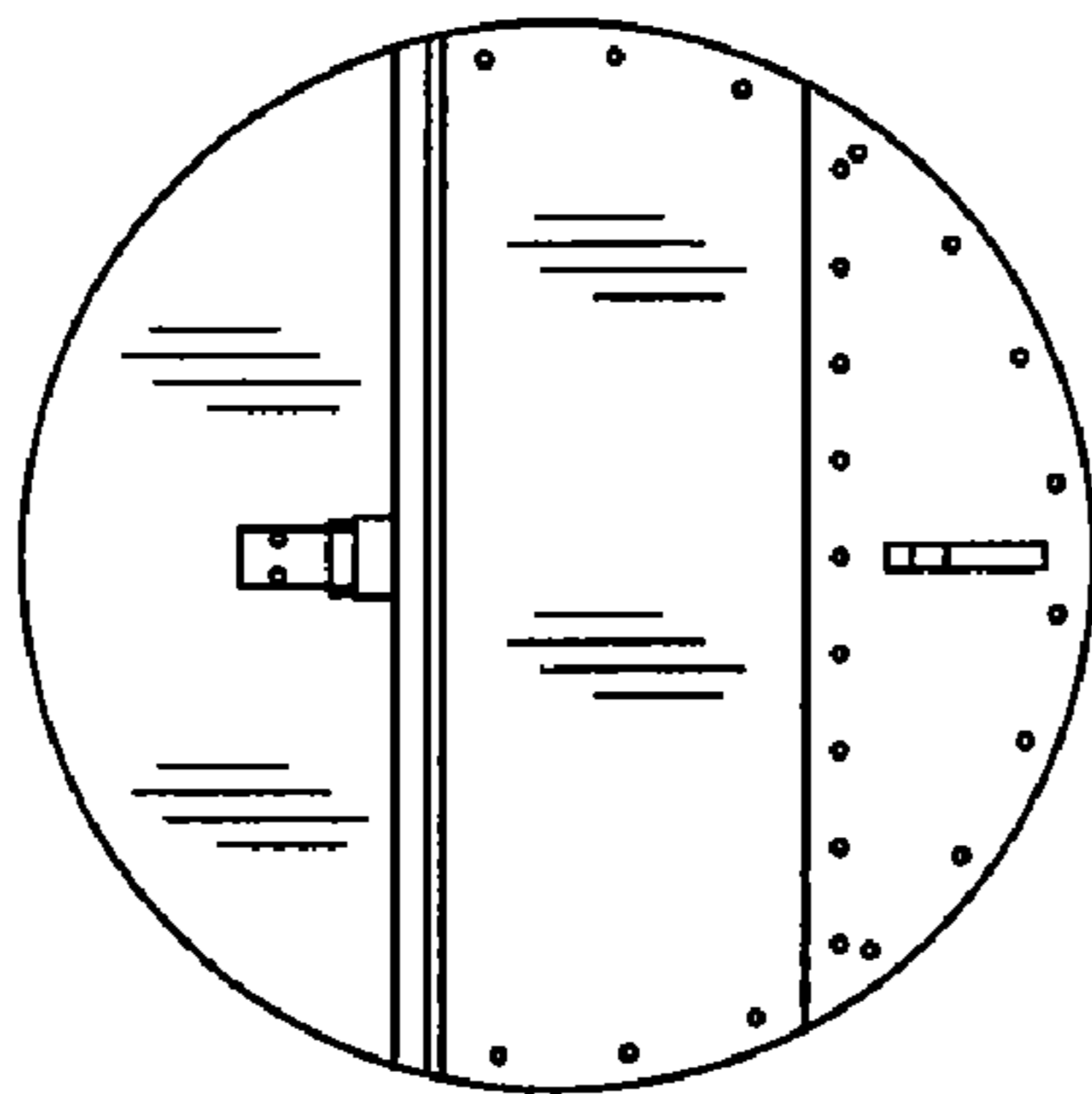
