The ornamental design for an popcorn cob, as shown and described.

DESCRIPTION

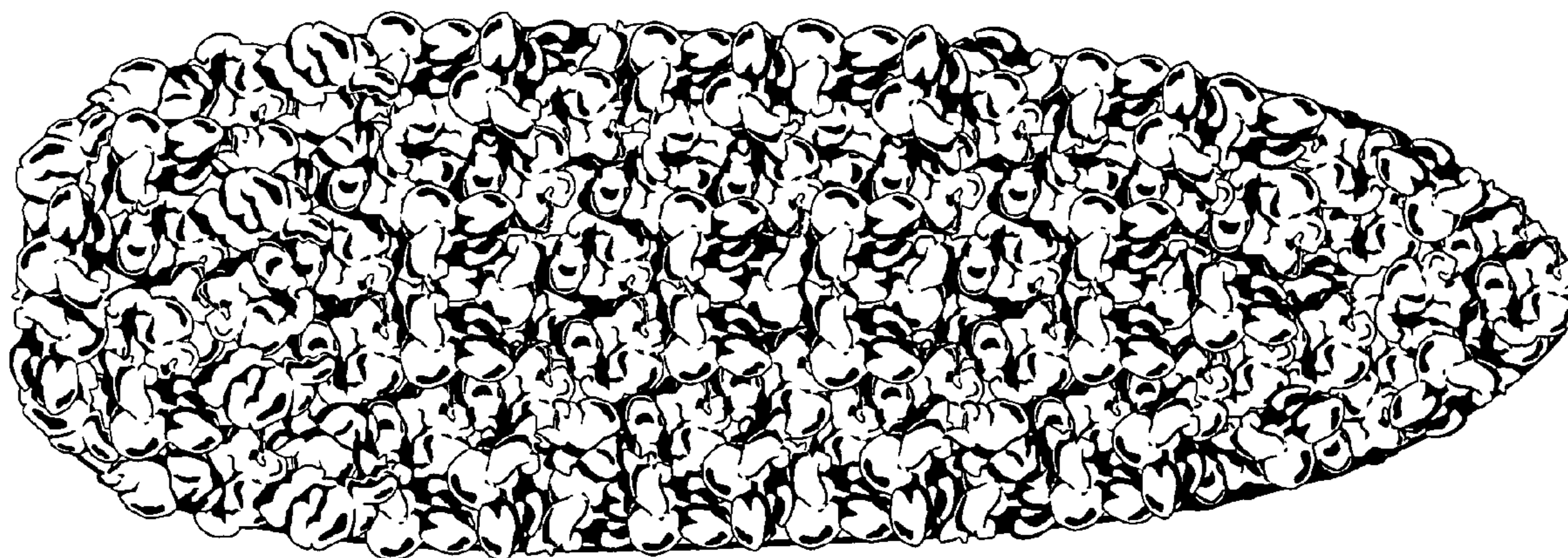

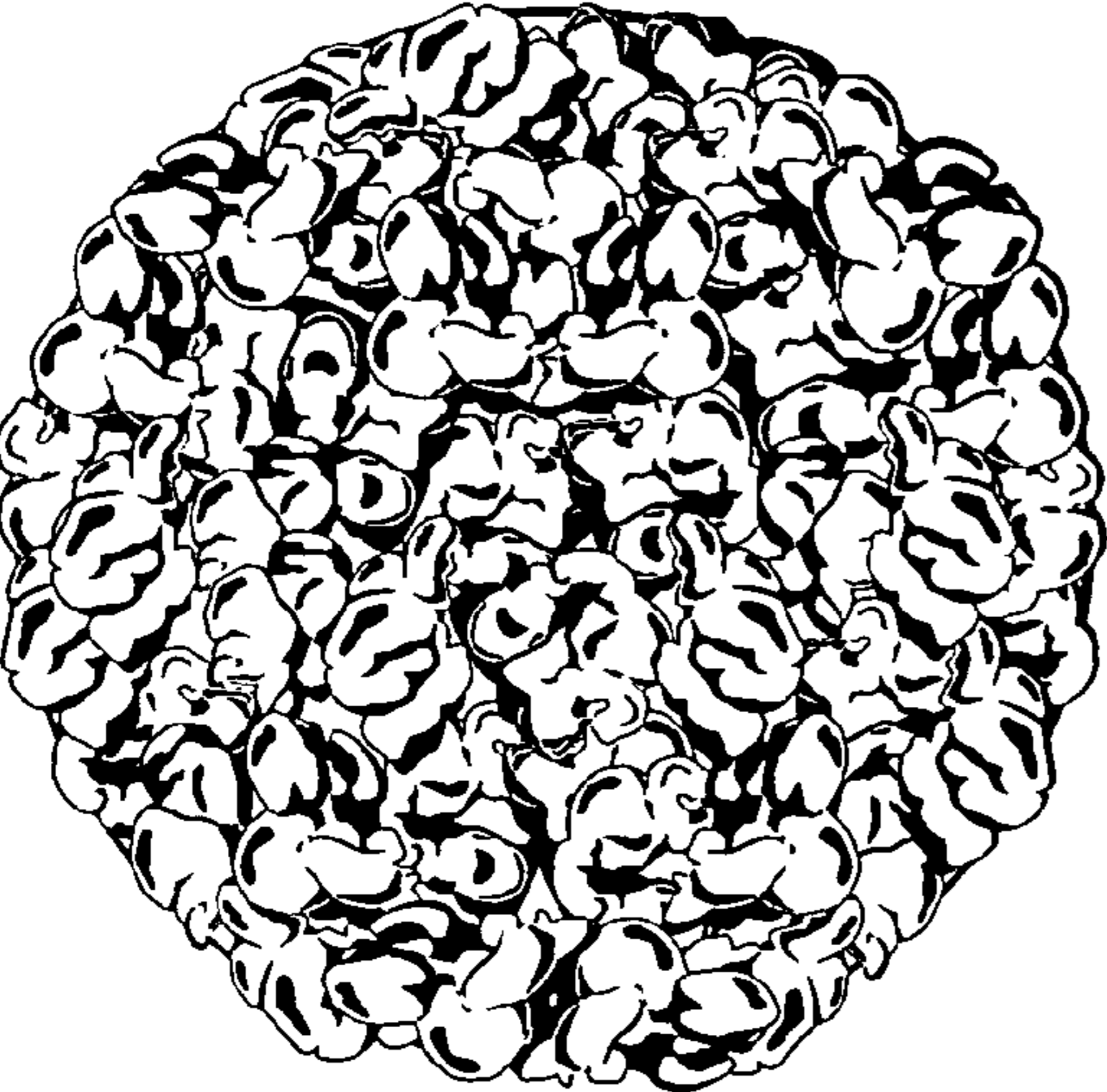

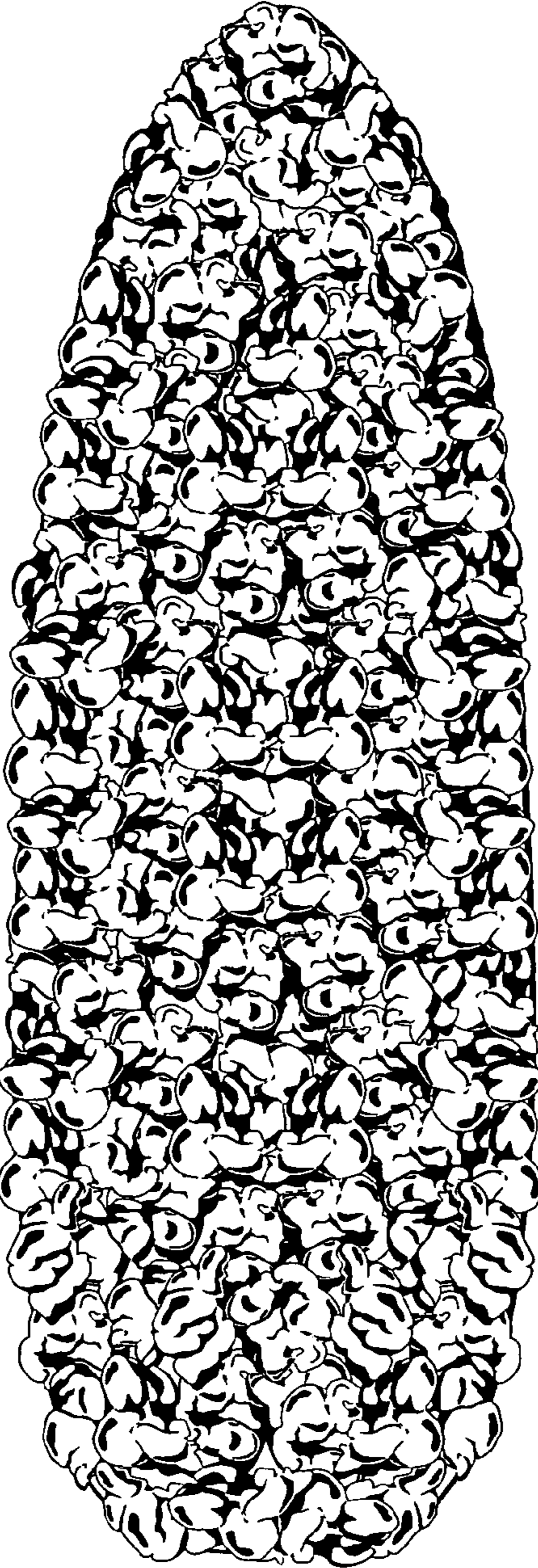
