(57) **CLAIM**

The ornamental design for a surface ornamentation for furniture, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a surface ornamentation for furniture in accordance with the present invention, shown in a particular environment;

FIG. 2 is a top view of the surface ornamentation of FIG. 1; FIG. 3 is a front view of the surface ornamentation shown in an alternate environment;

FIG. 4 is a right side view of the surface ornamentation of FIG. 3, the left side view being a mirror image thereof;

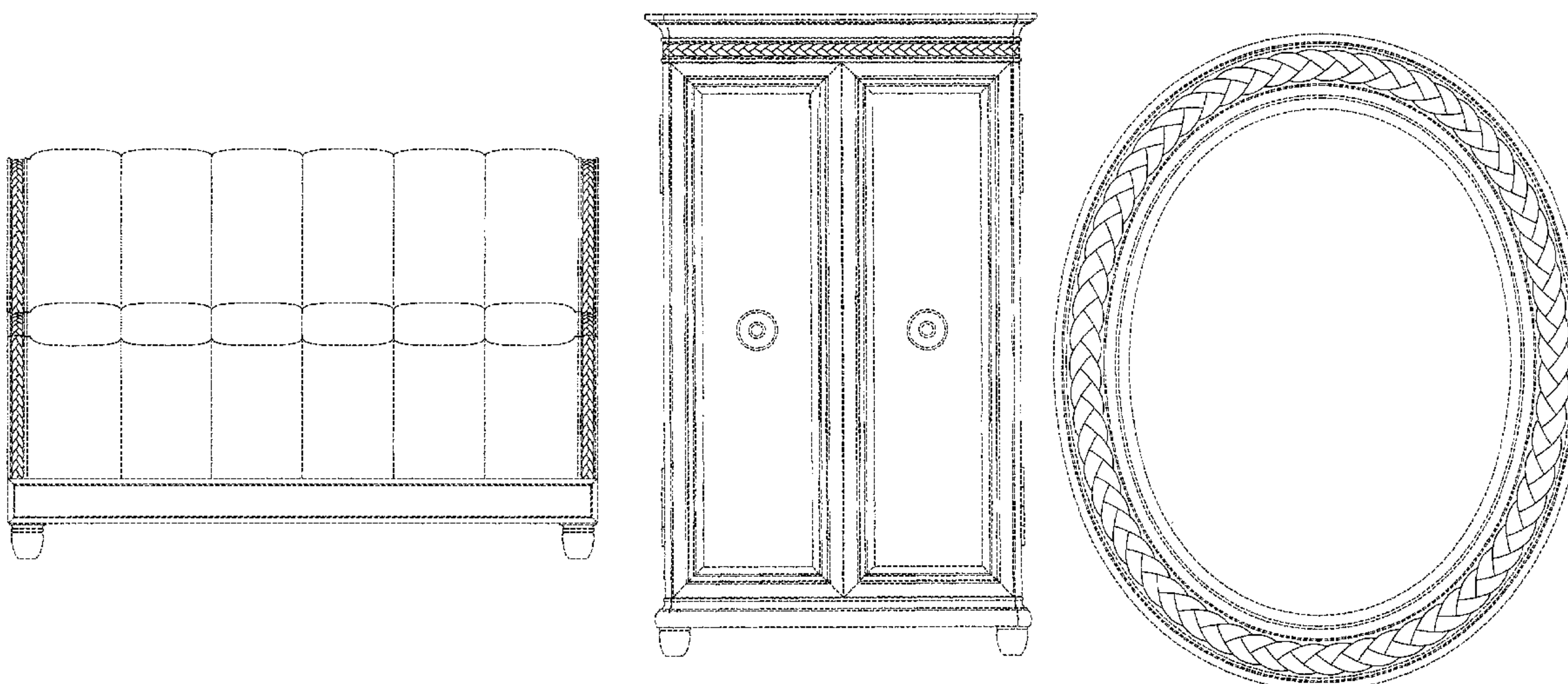
FIG. 5 is a front view of the surface ornamentation shown in a further alternate environment;

FIG. 6 is a front view of the surface ornamentation shown in a still further alternate environment; and,

FIG. 7 is a right side view of the surface ornamentation of FIG. 6, the left side view being a mirror image thereof.

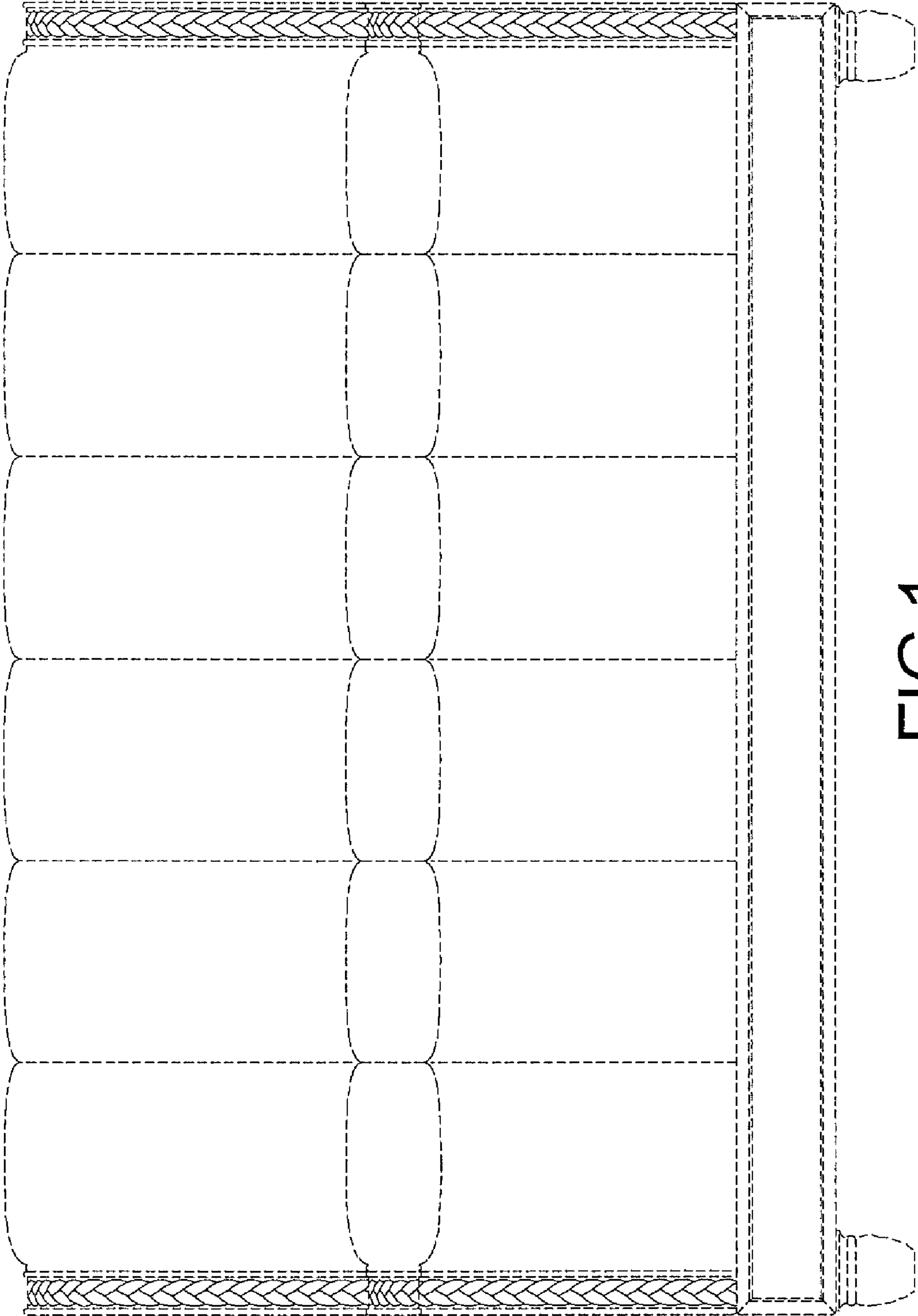

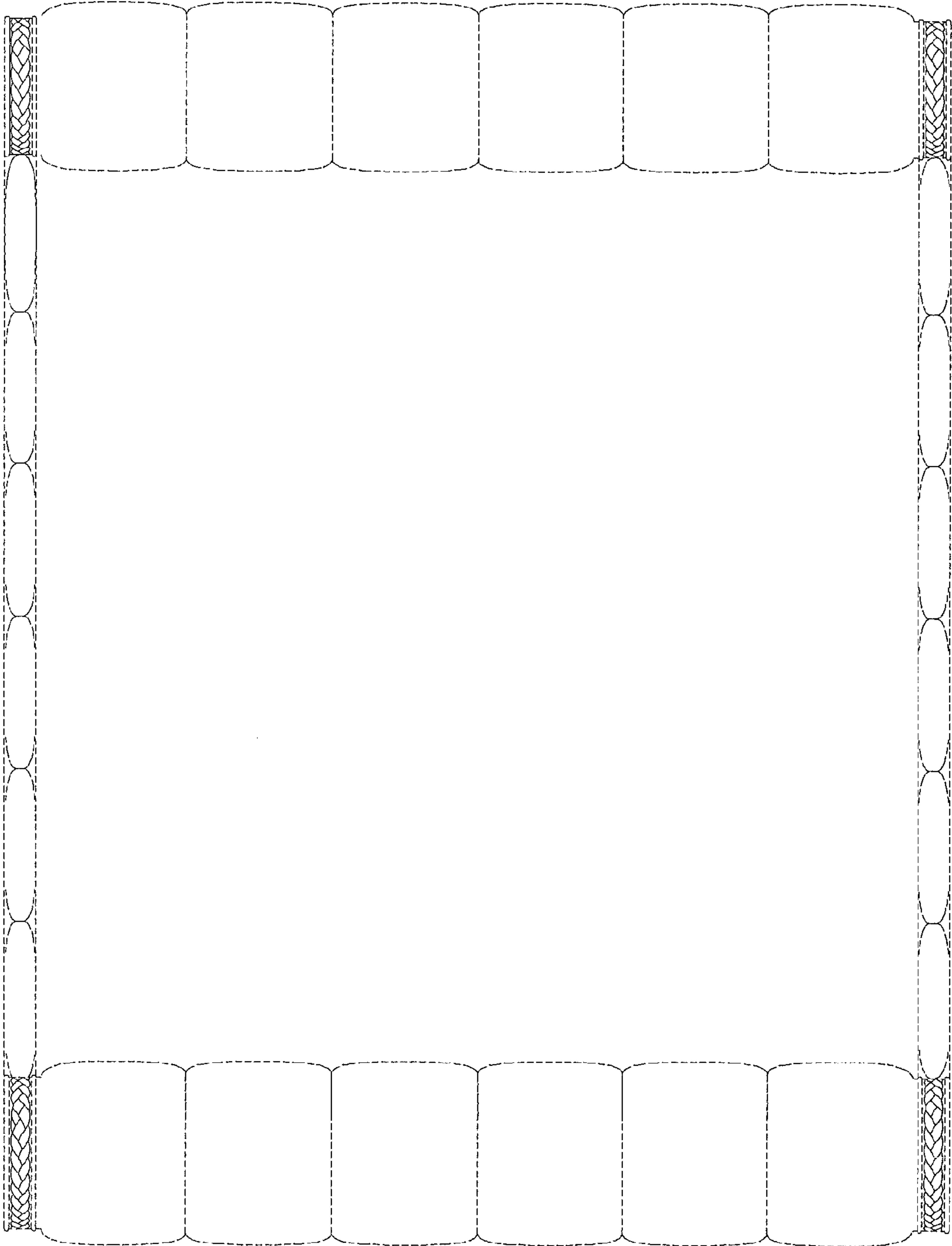

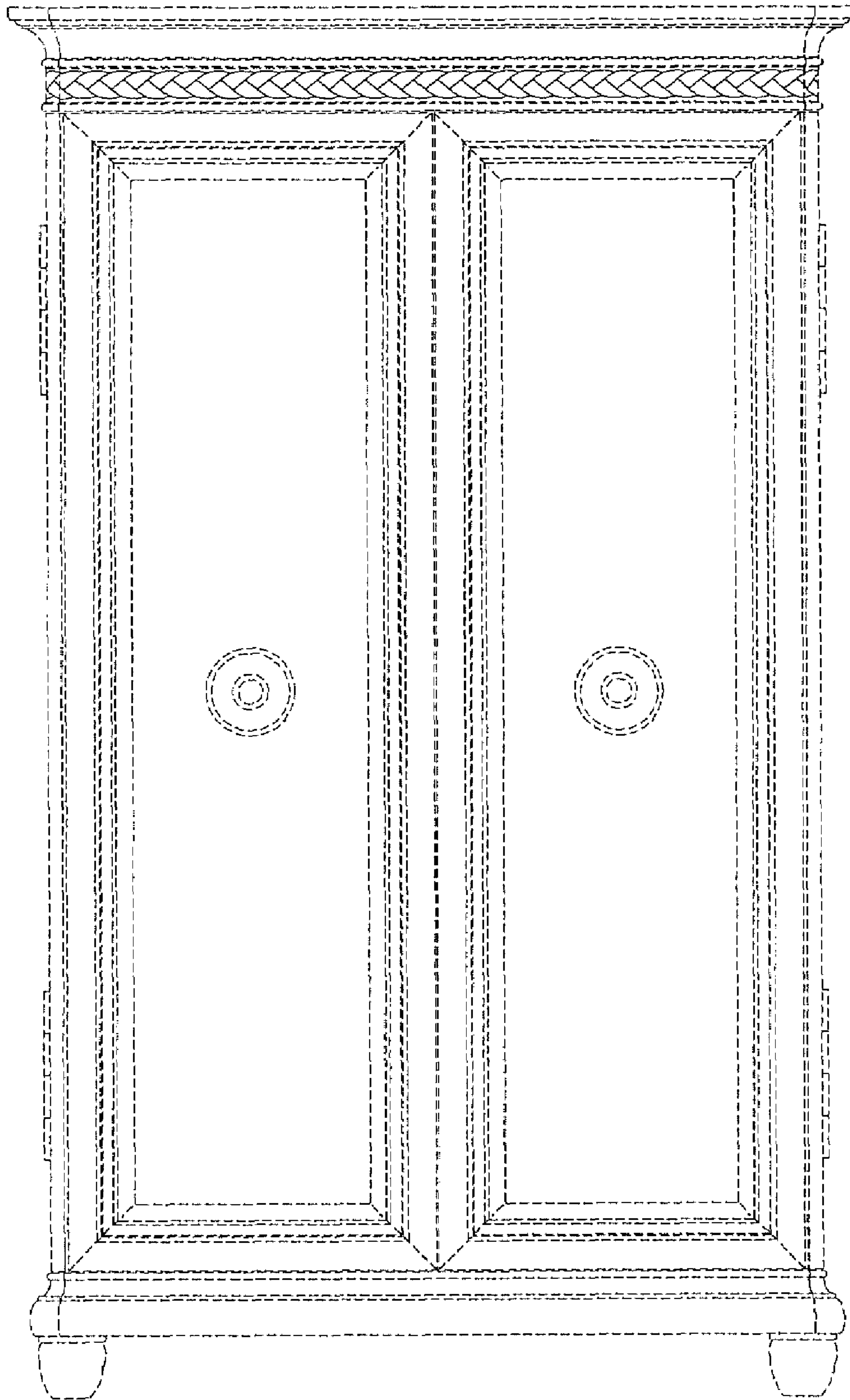

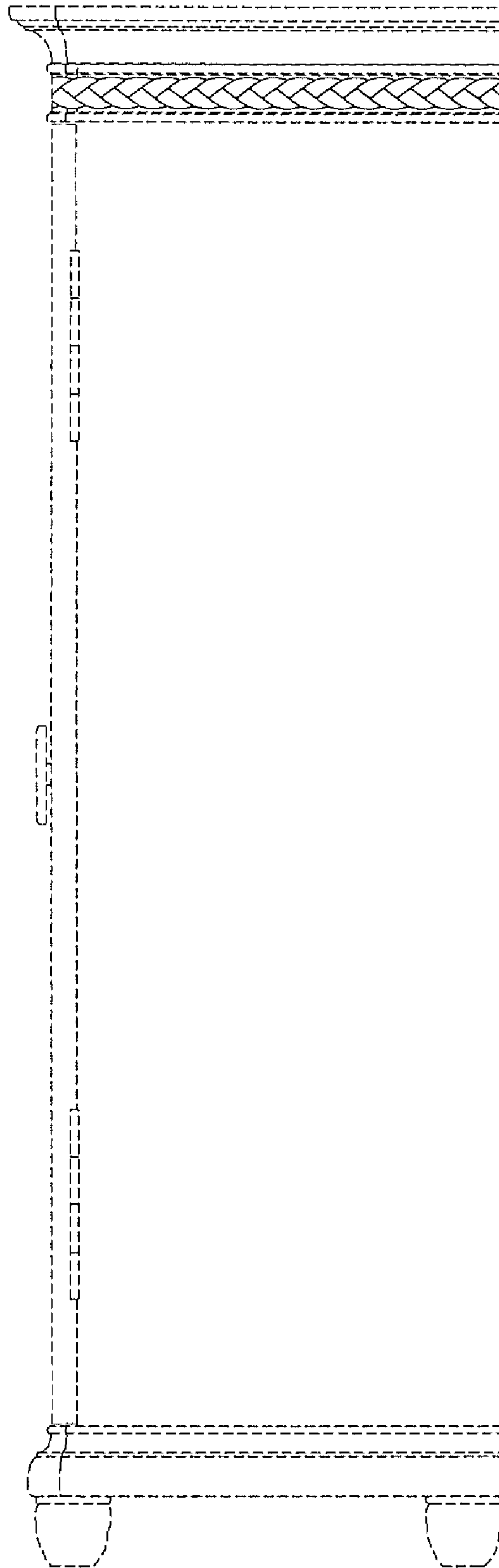

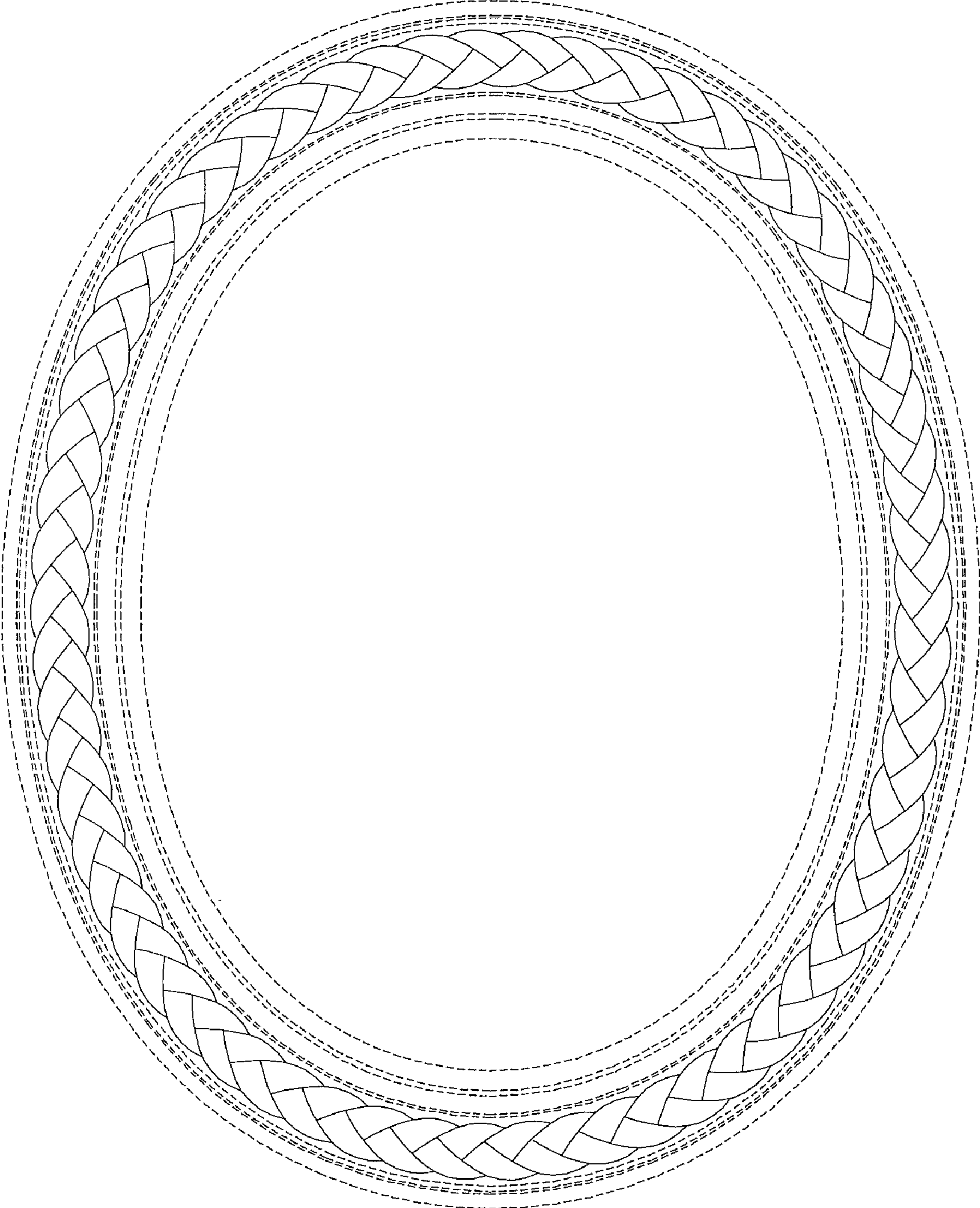

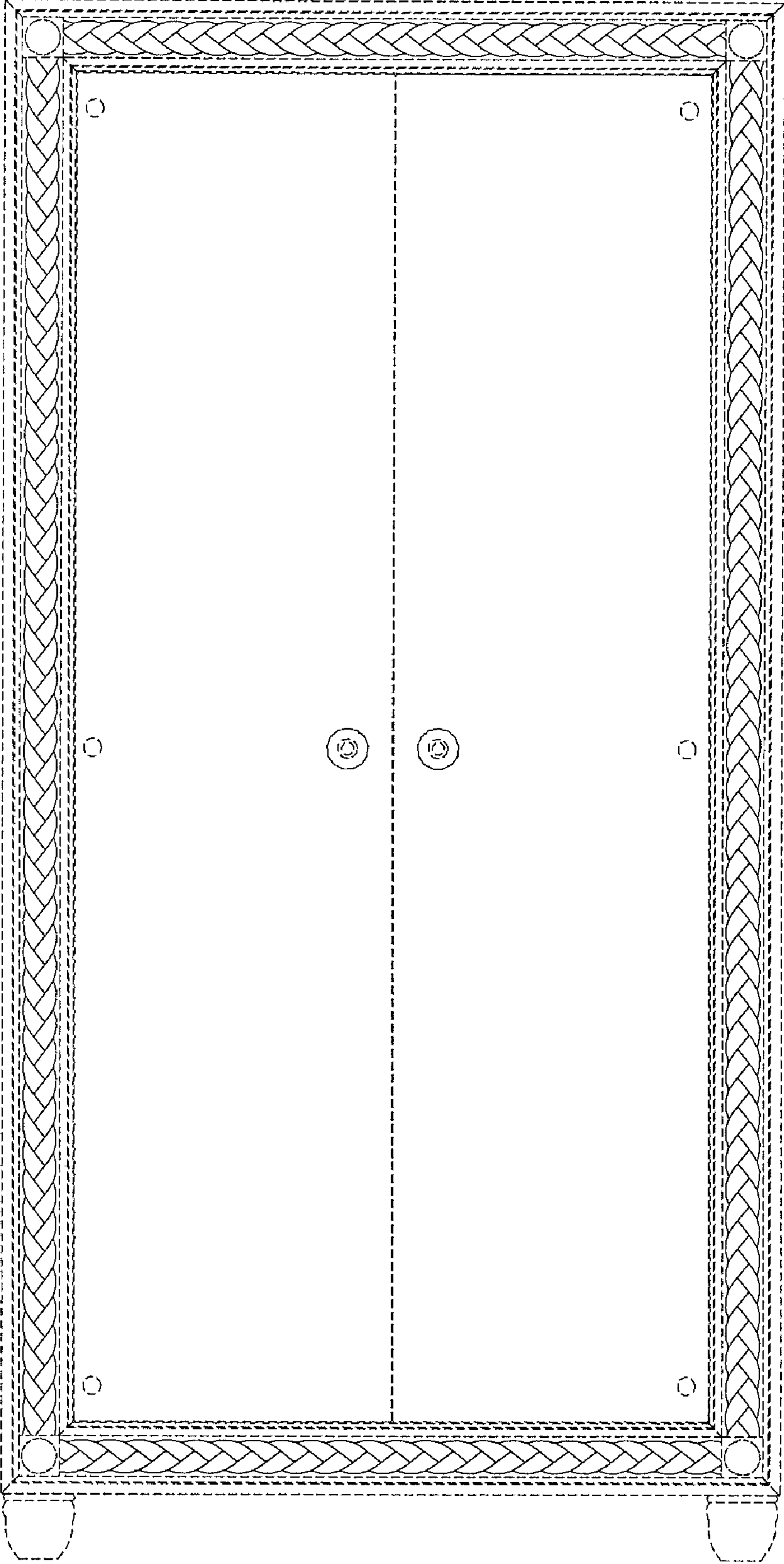

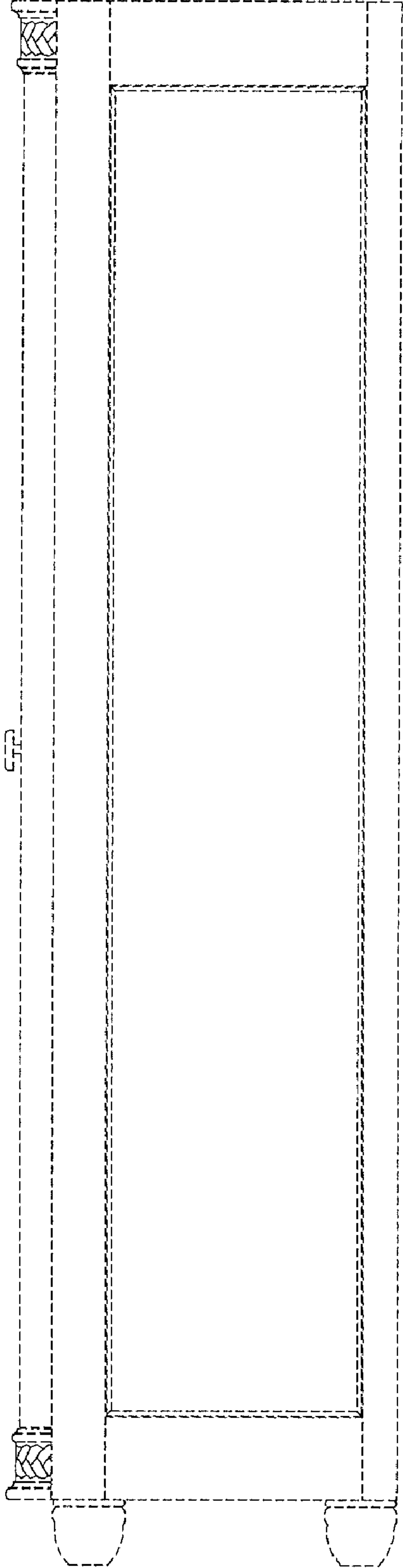
