The ornamental design for a coffee machine, as shown and described.

DESCRIPTION

FIG. 1 is a front-perspective view of a coffee machine in accordance with my new design;

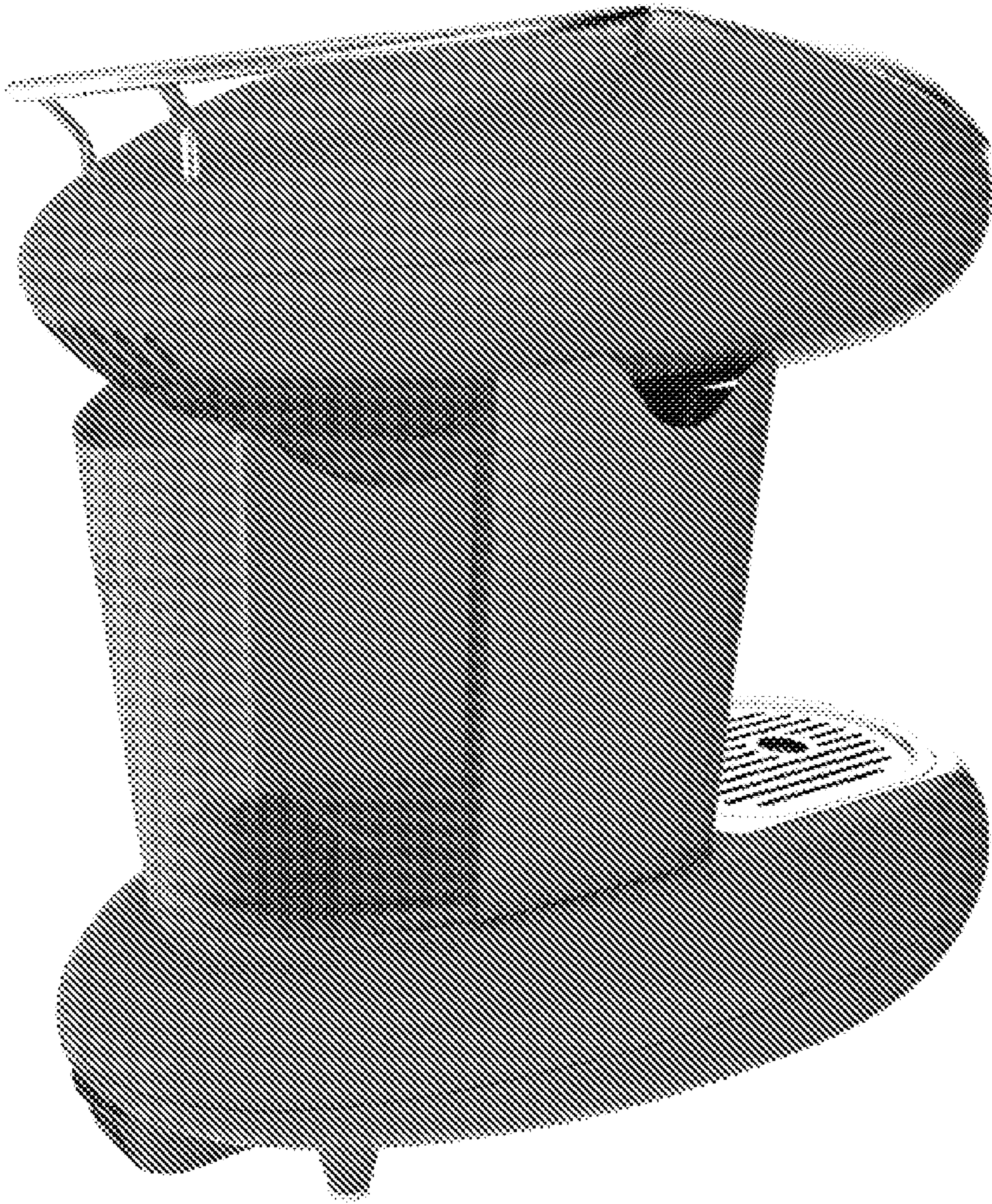

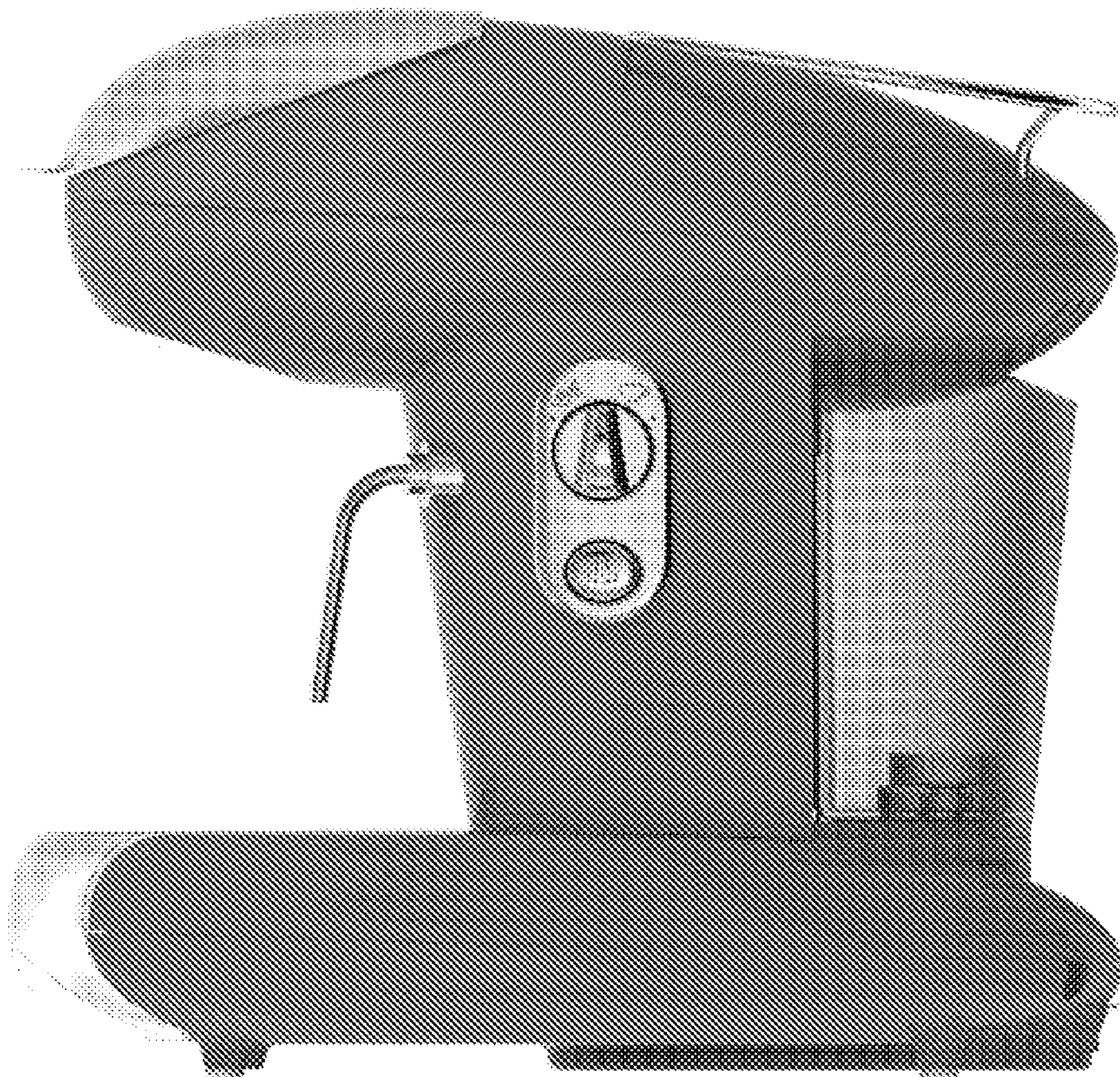

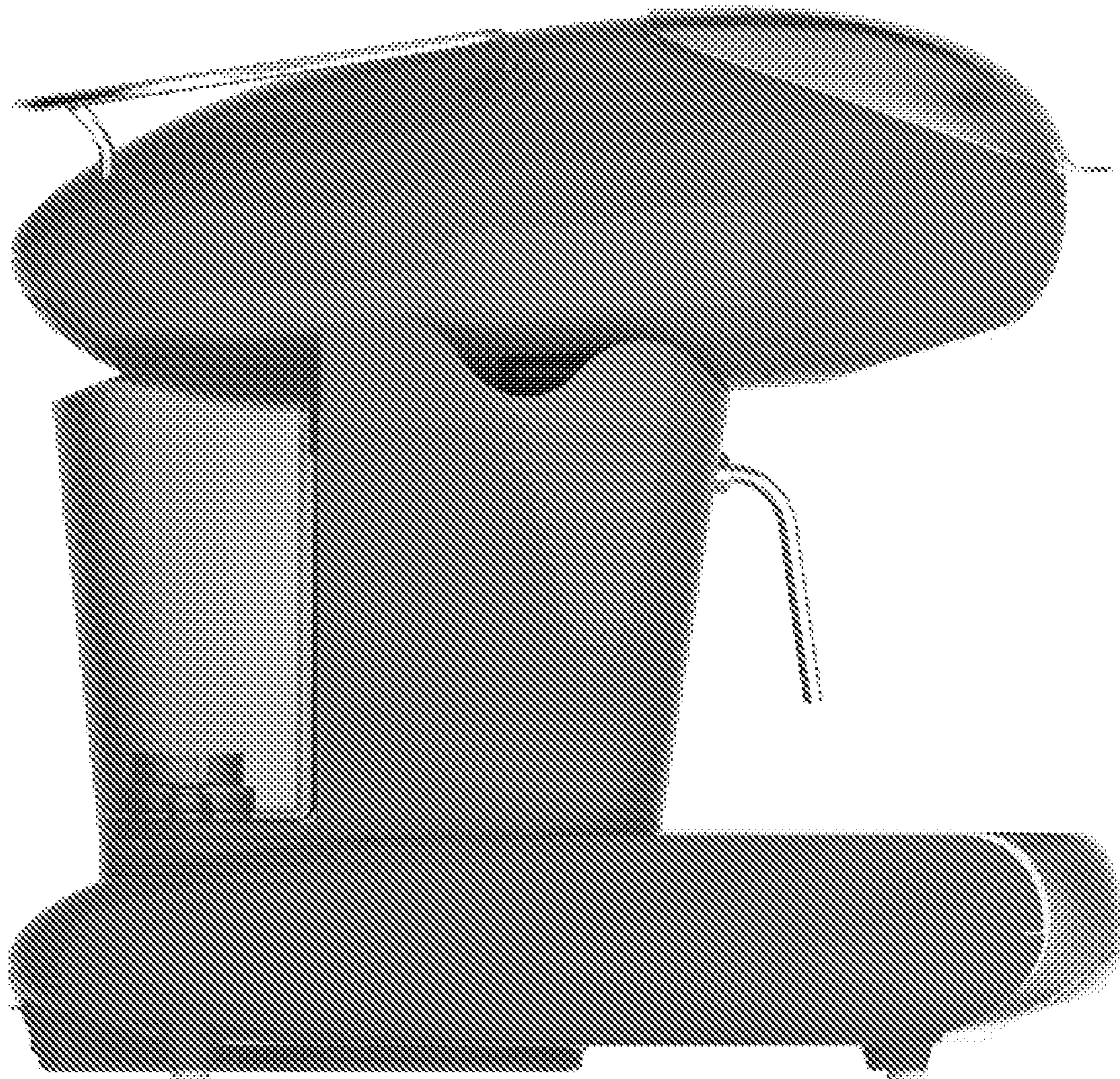

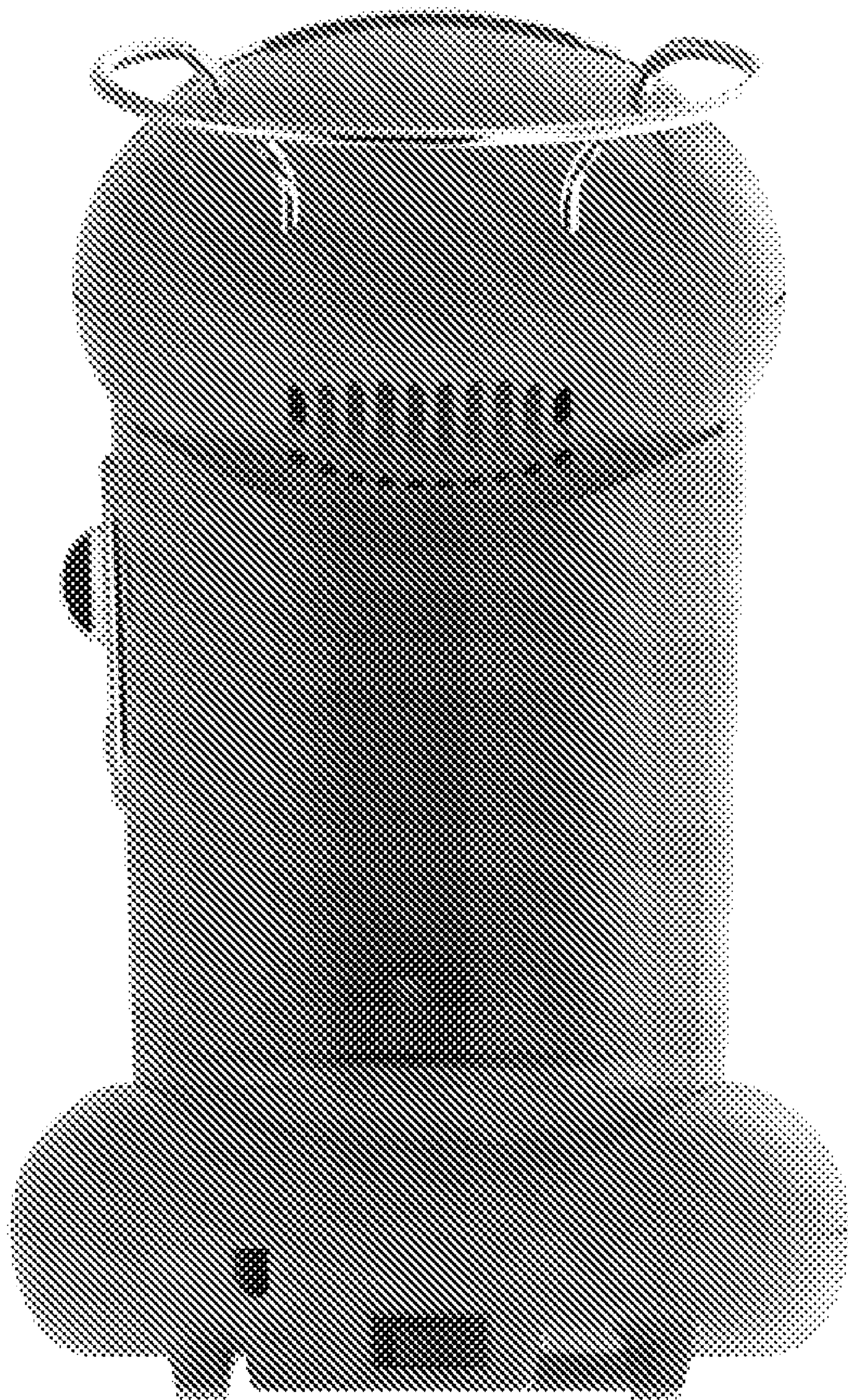

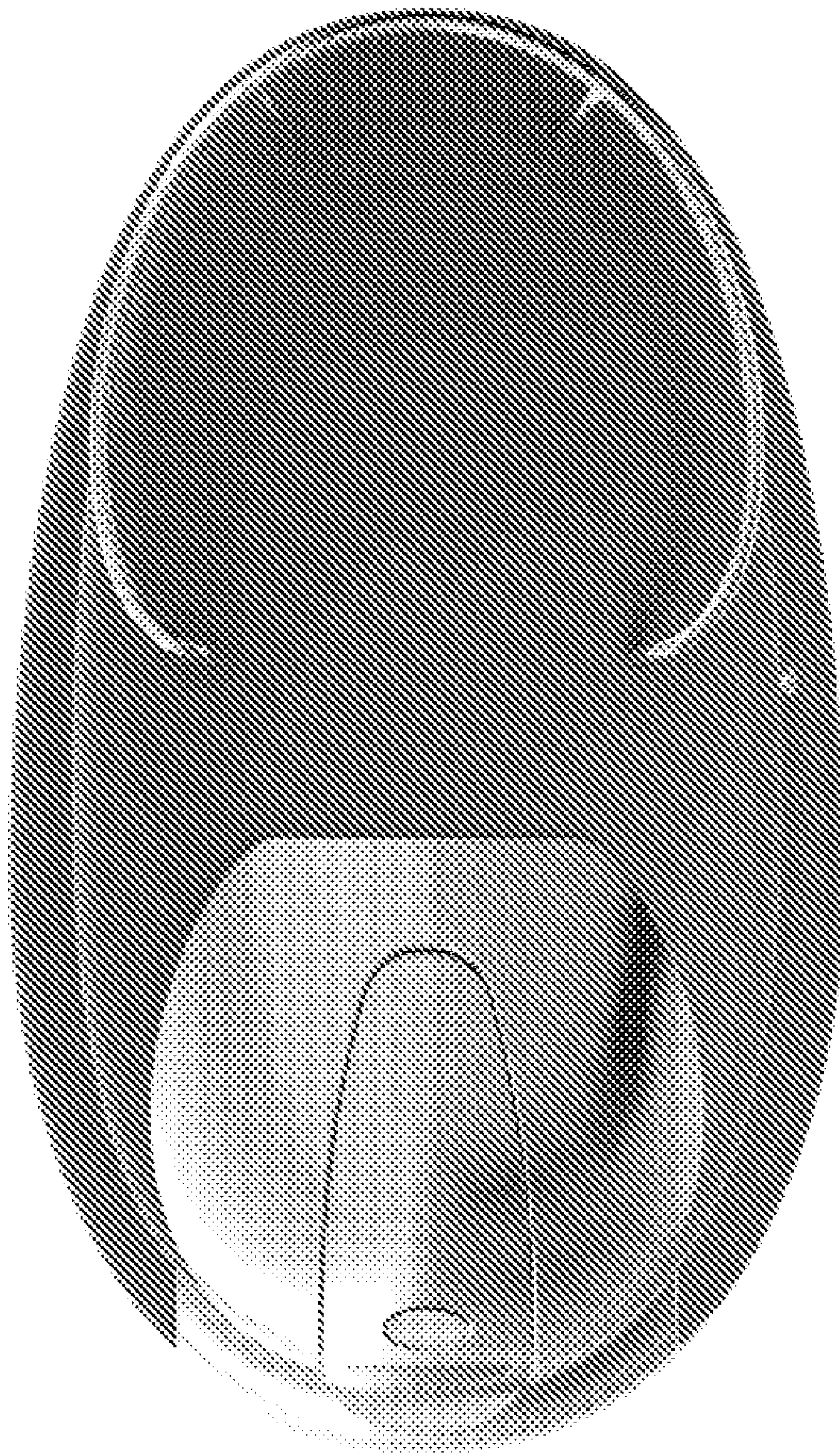

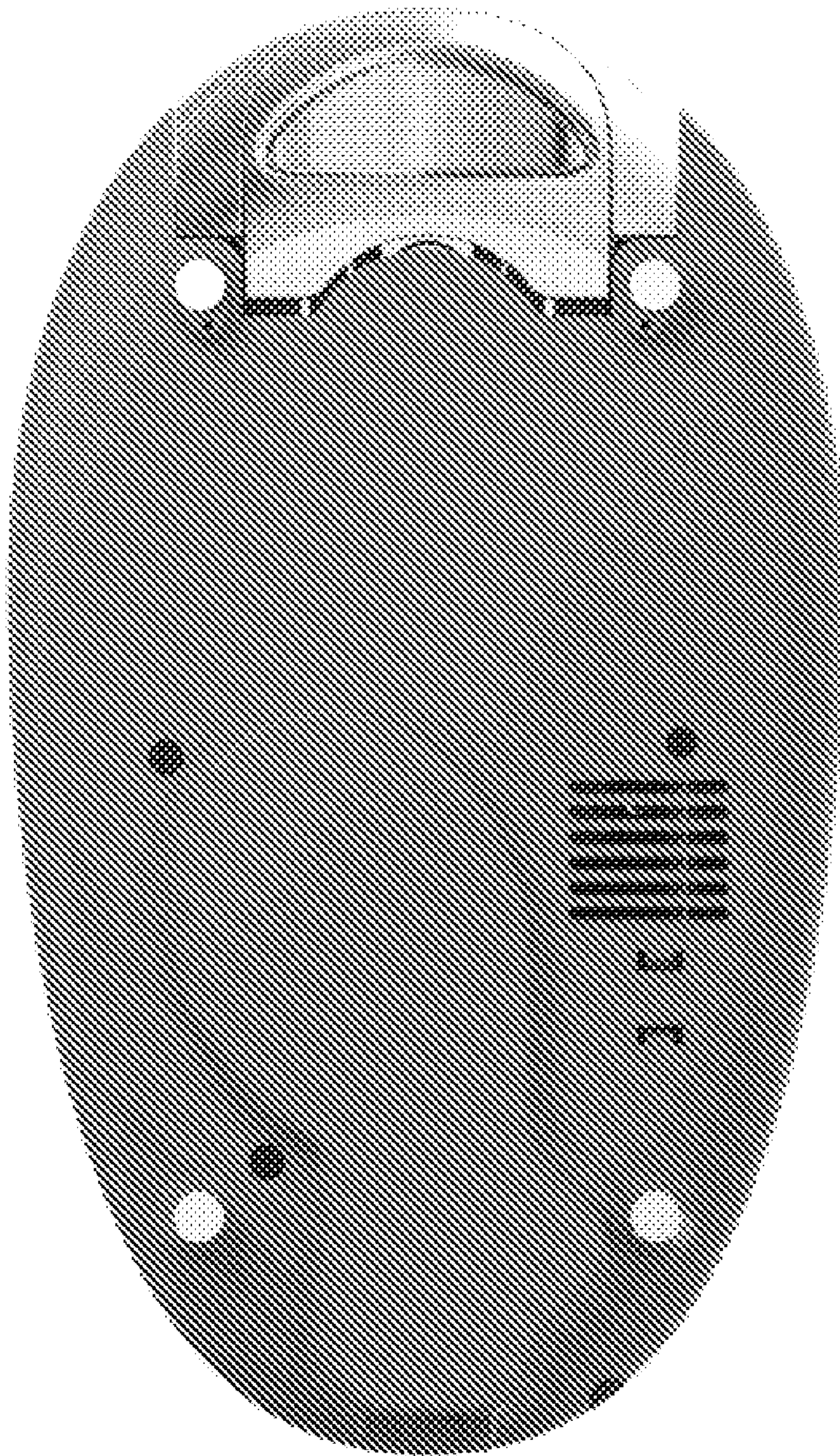
