FIG. 2 is a front elevation view of the sliding door handle depicted in FIG. 1 the undisclosed rear is not part of the claimed design;

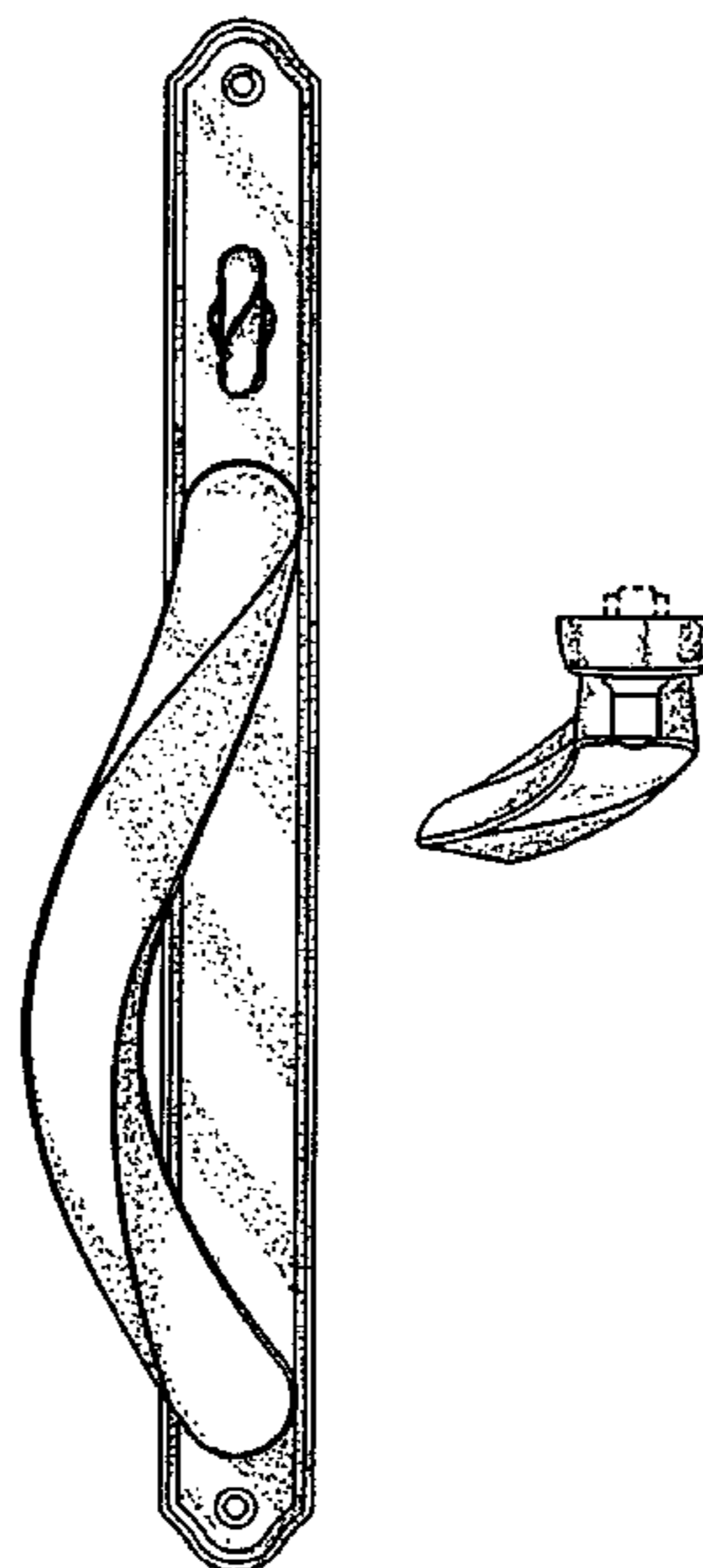
FIG. 3 is an opposing side elevation view of the sliding door handle depicted in FIG. 1;

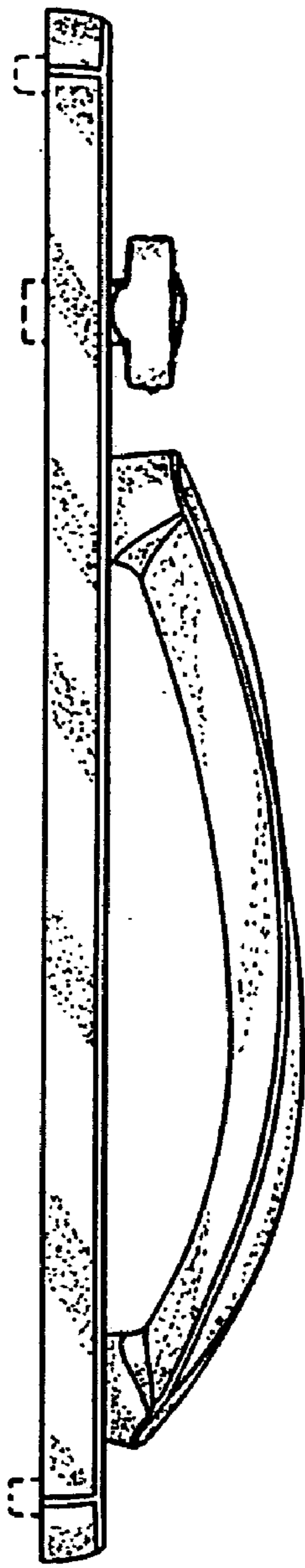

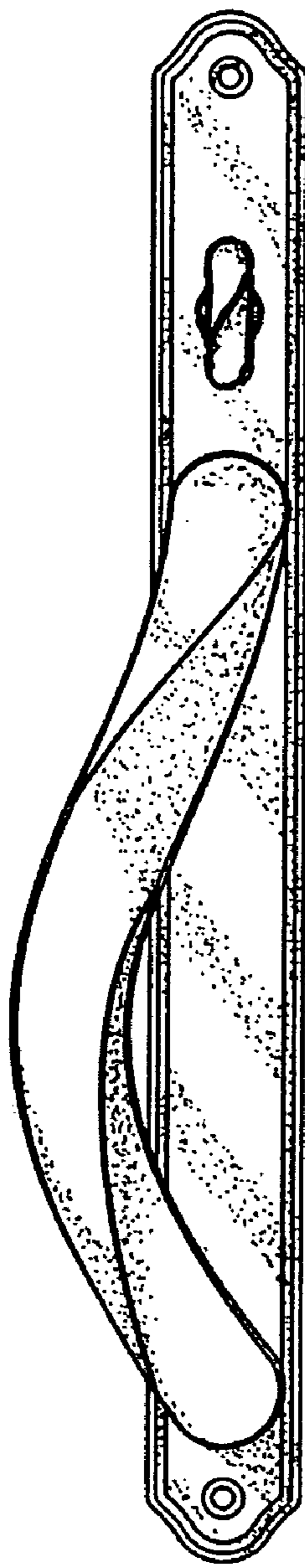

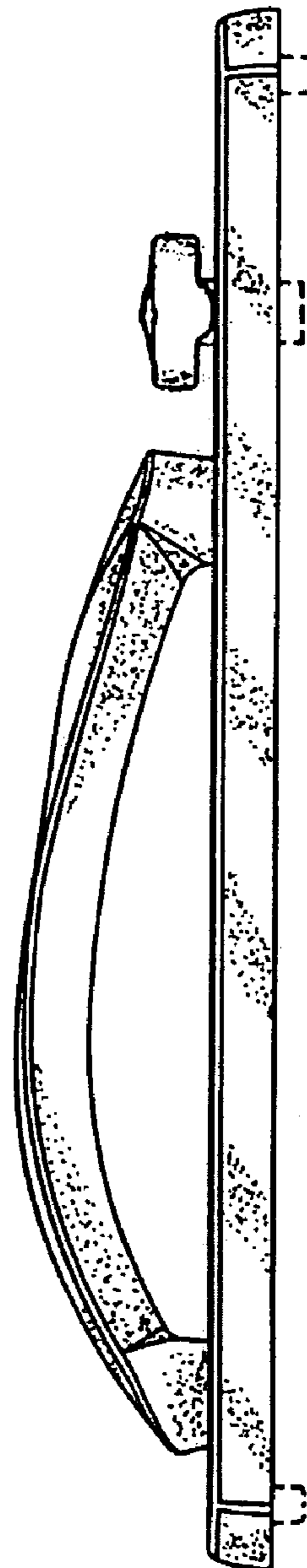

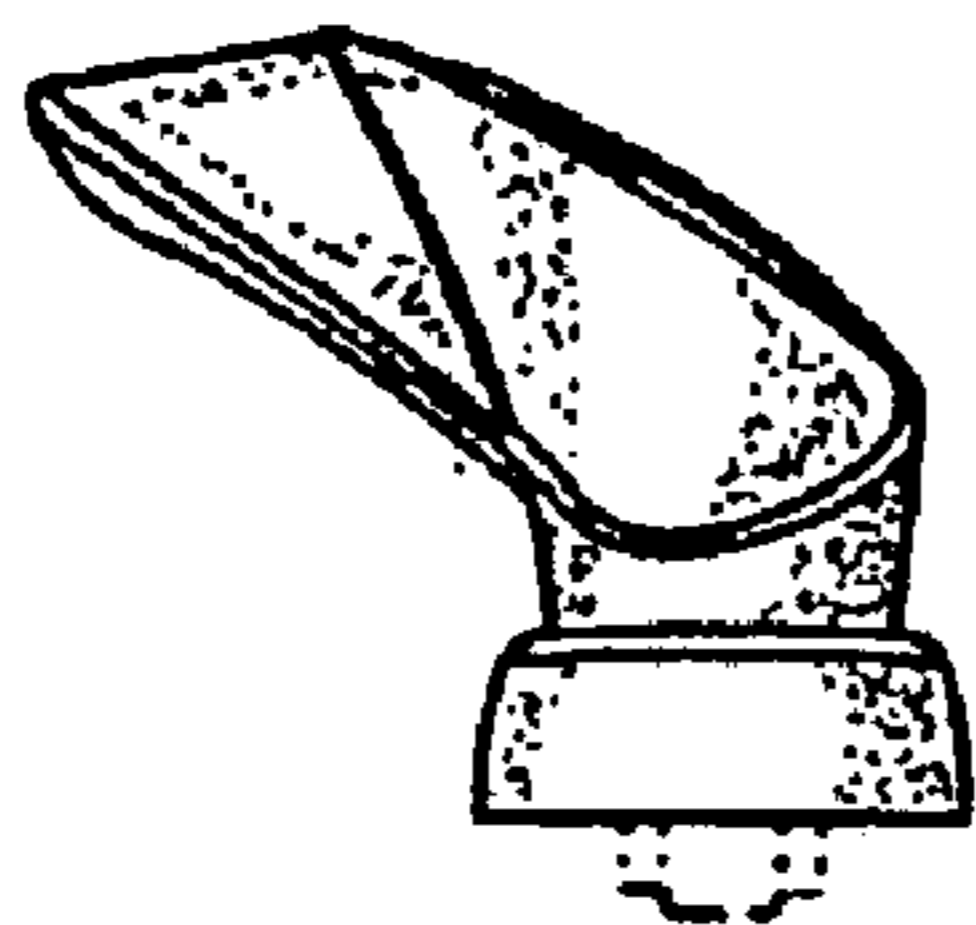

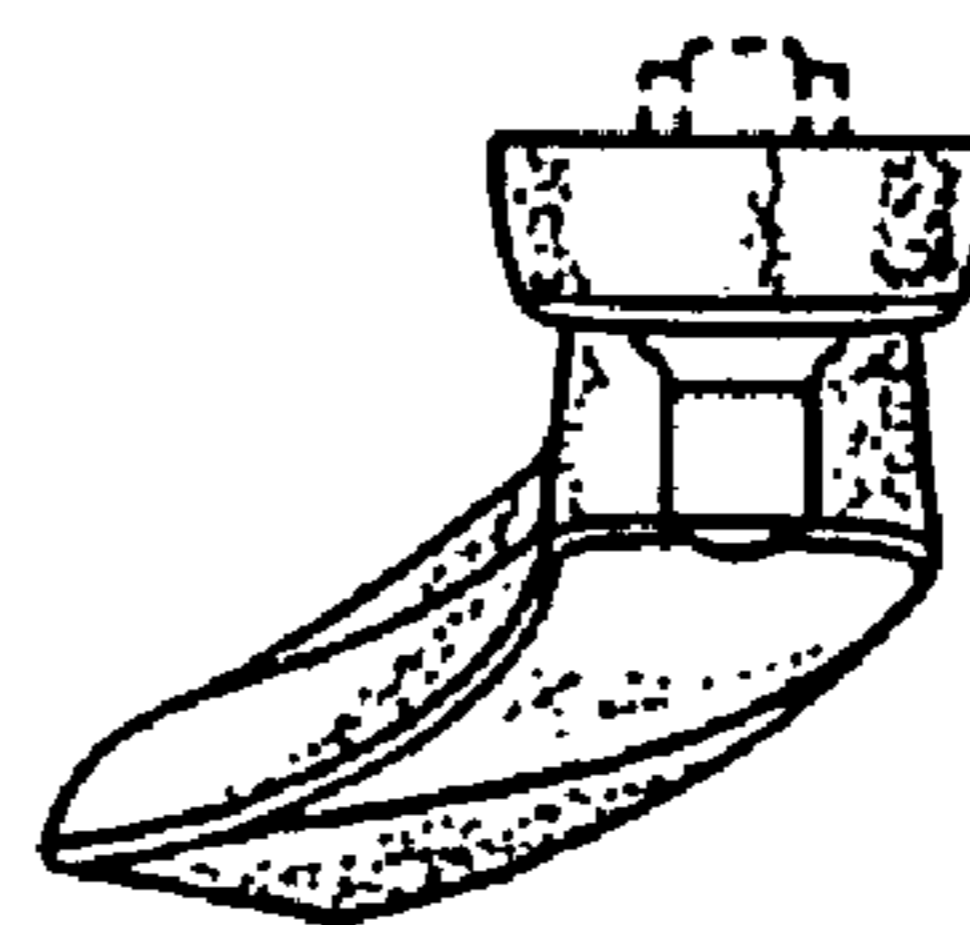
