DESCRIPTION

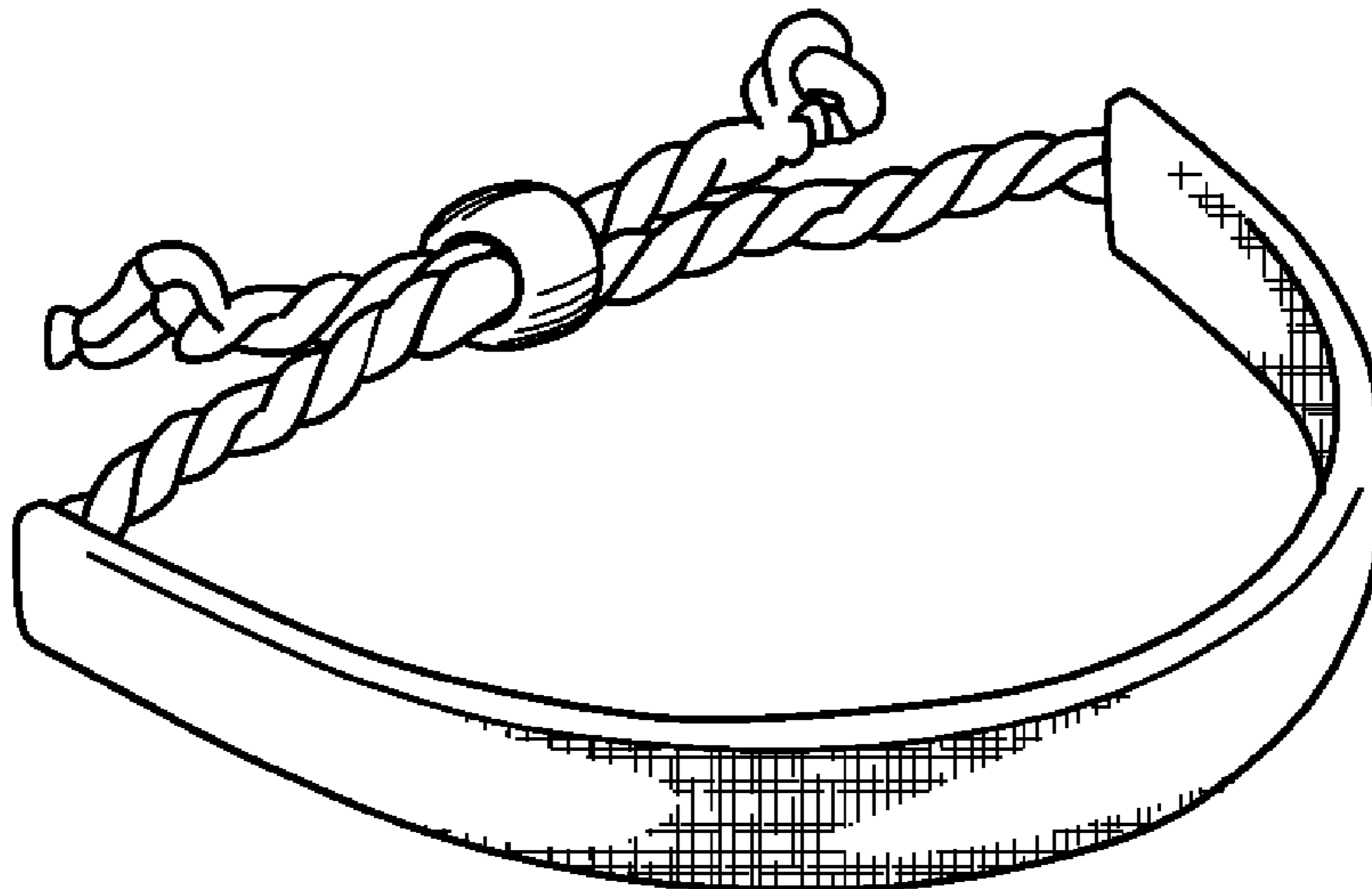
FIG. 1 is a perspective view of a First Embodiment of the bracelet, showing my new design;

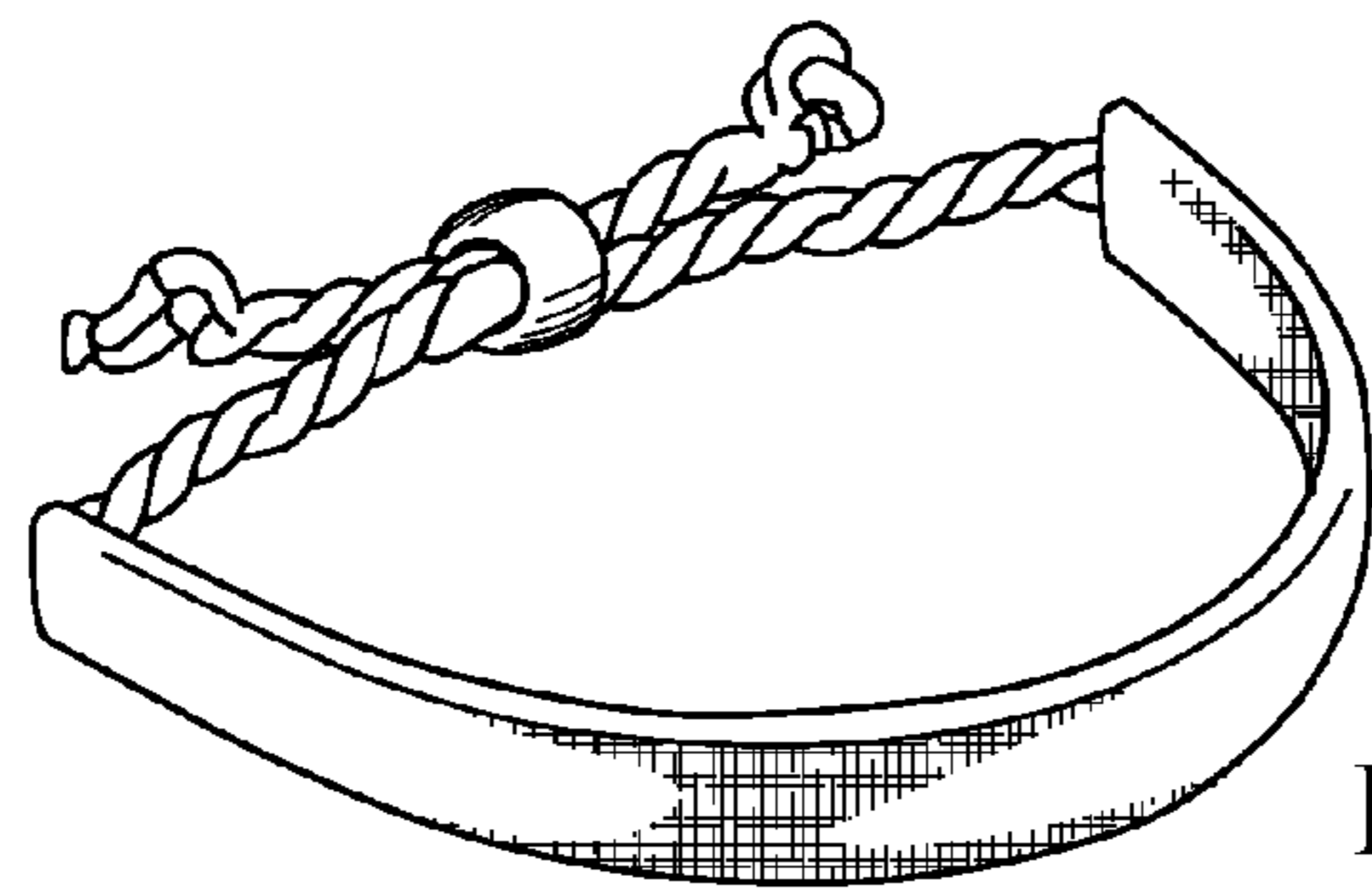

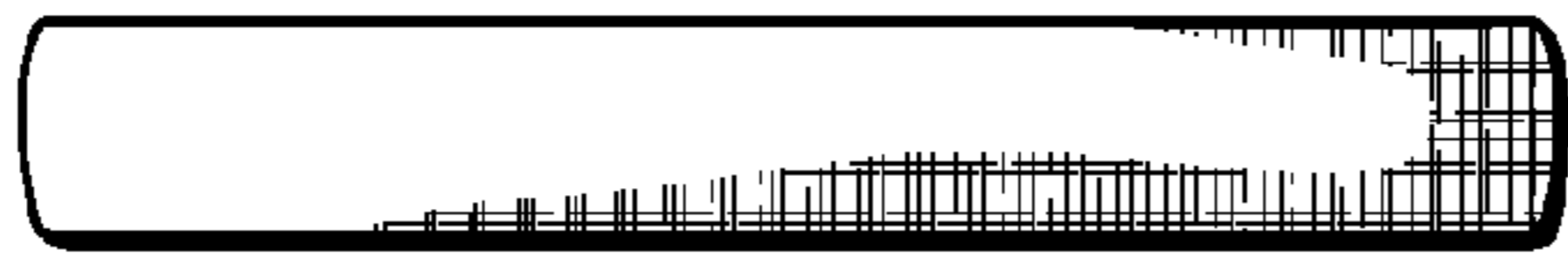

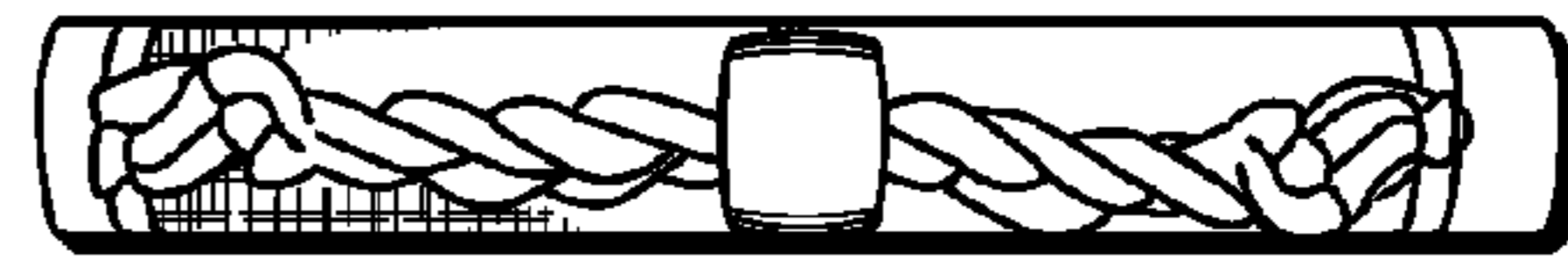

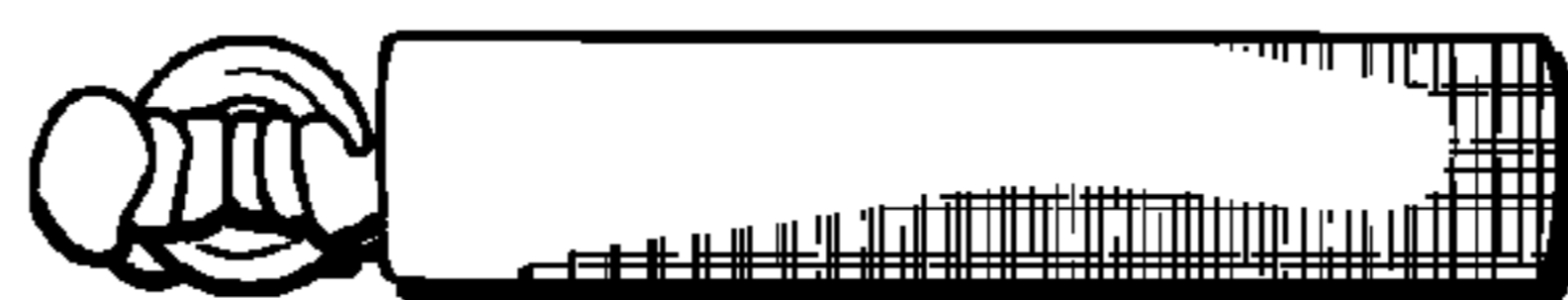

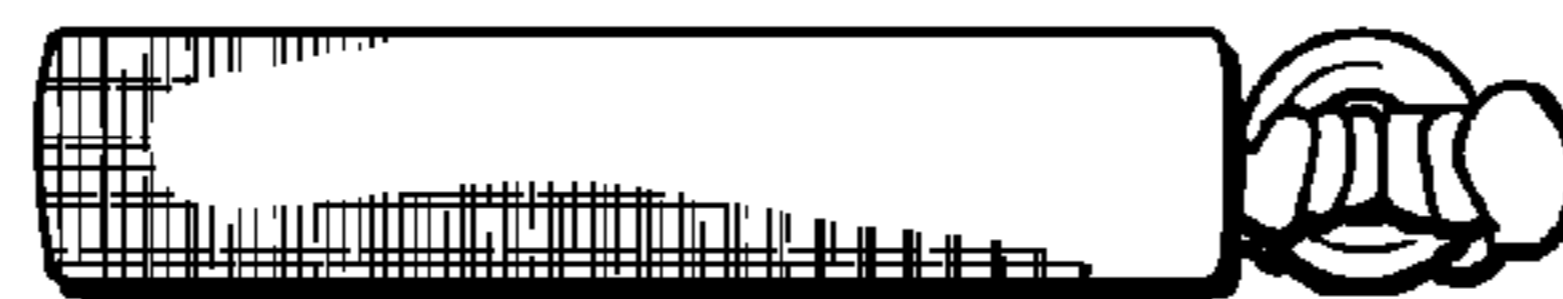

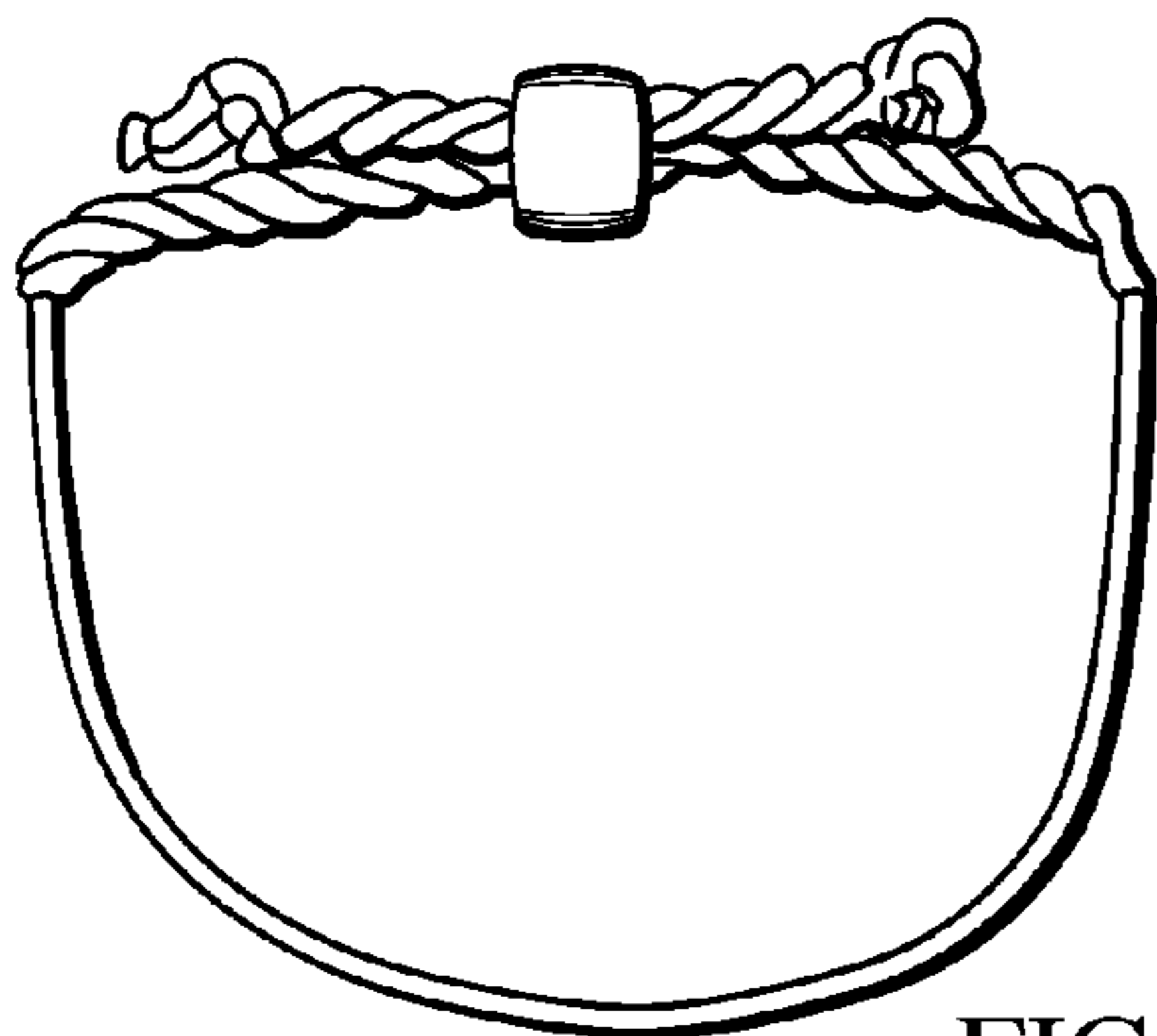

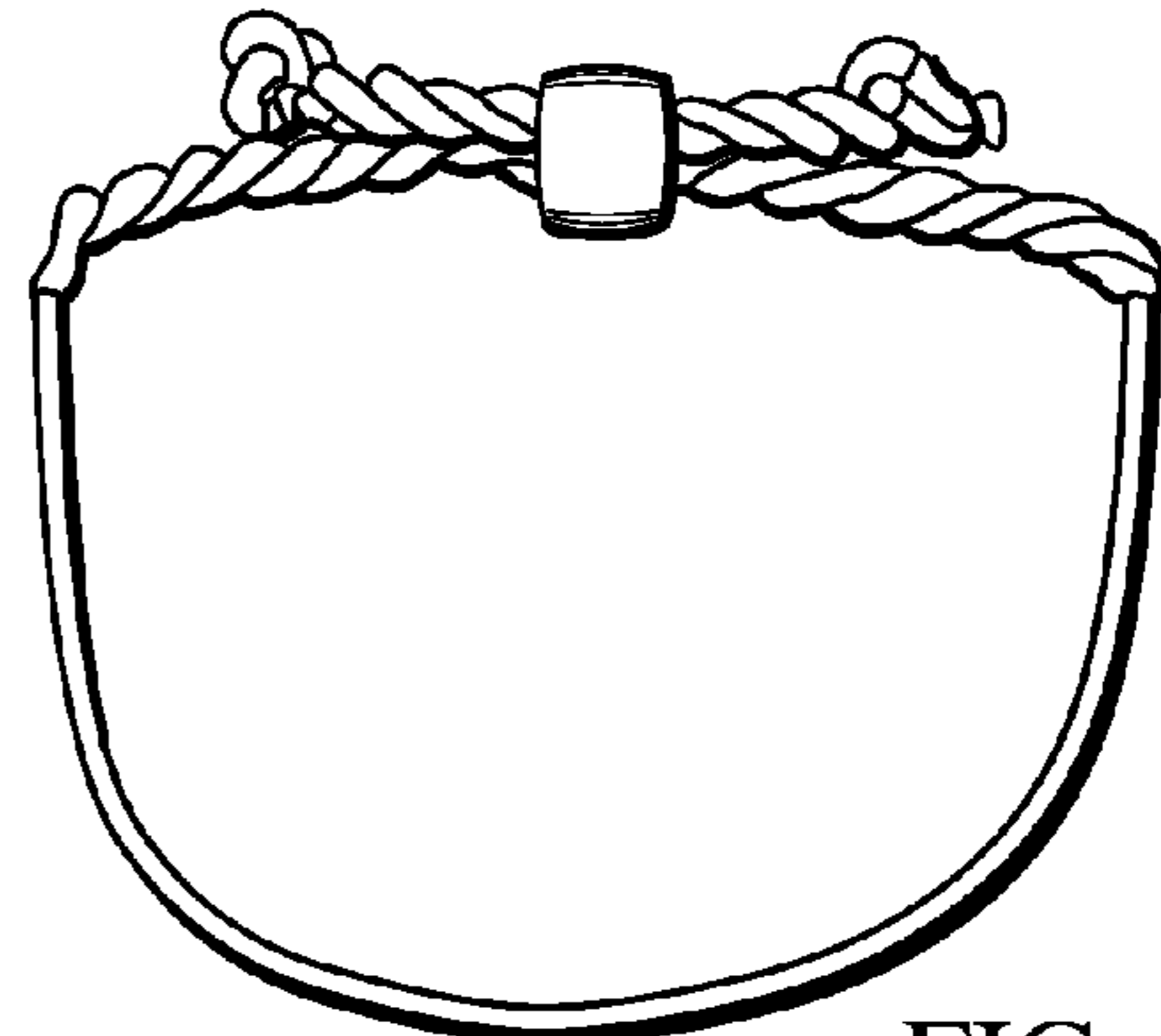

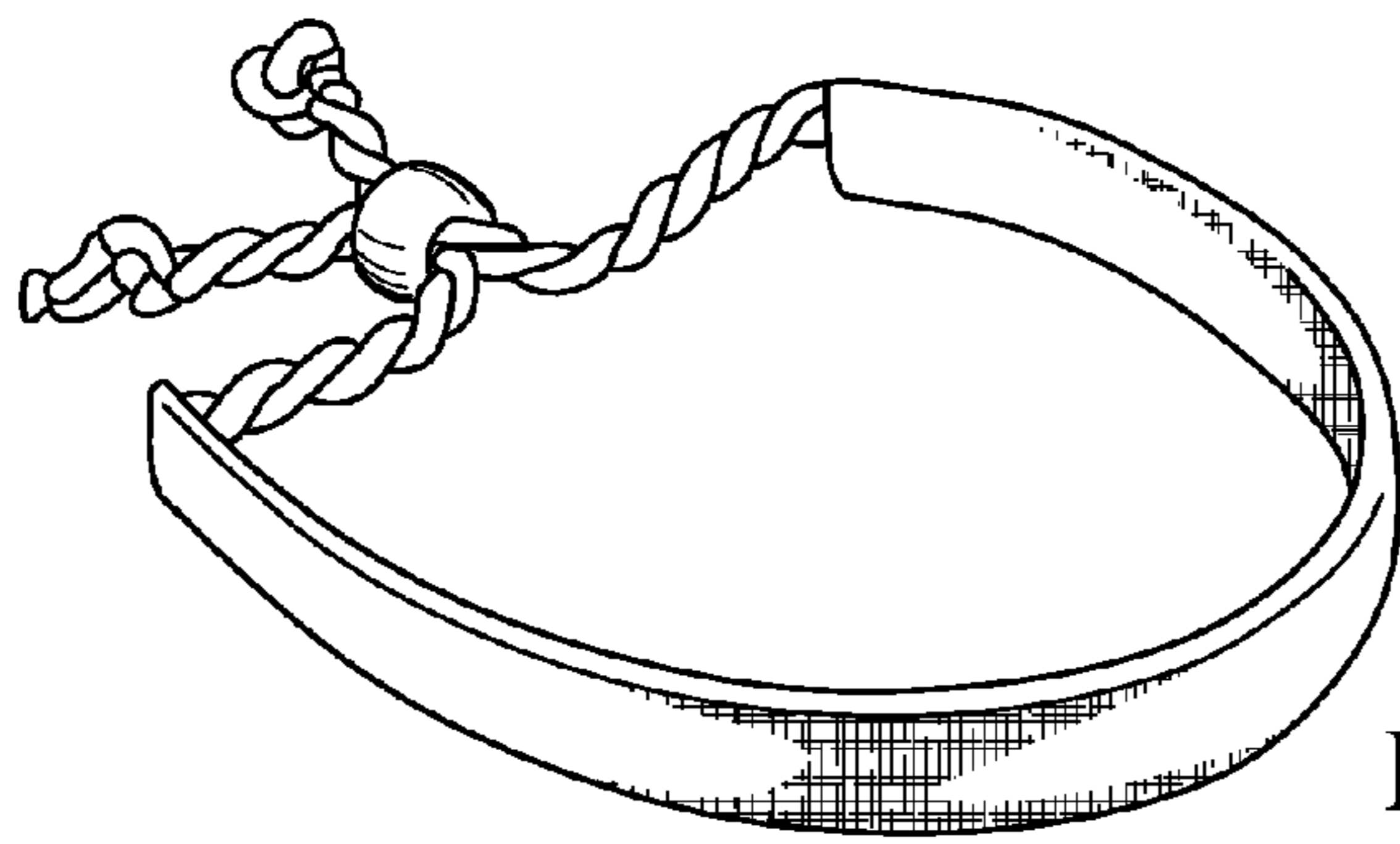

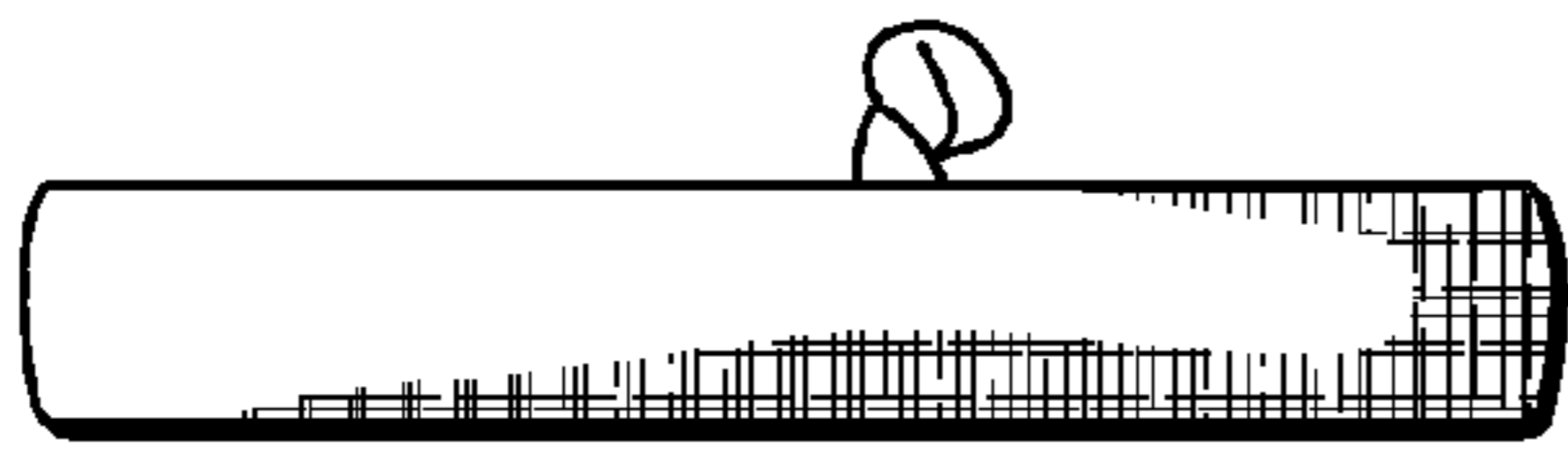

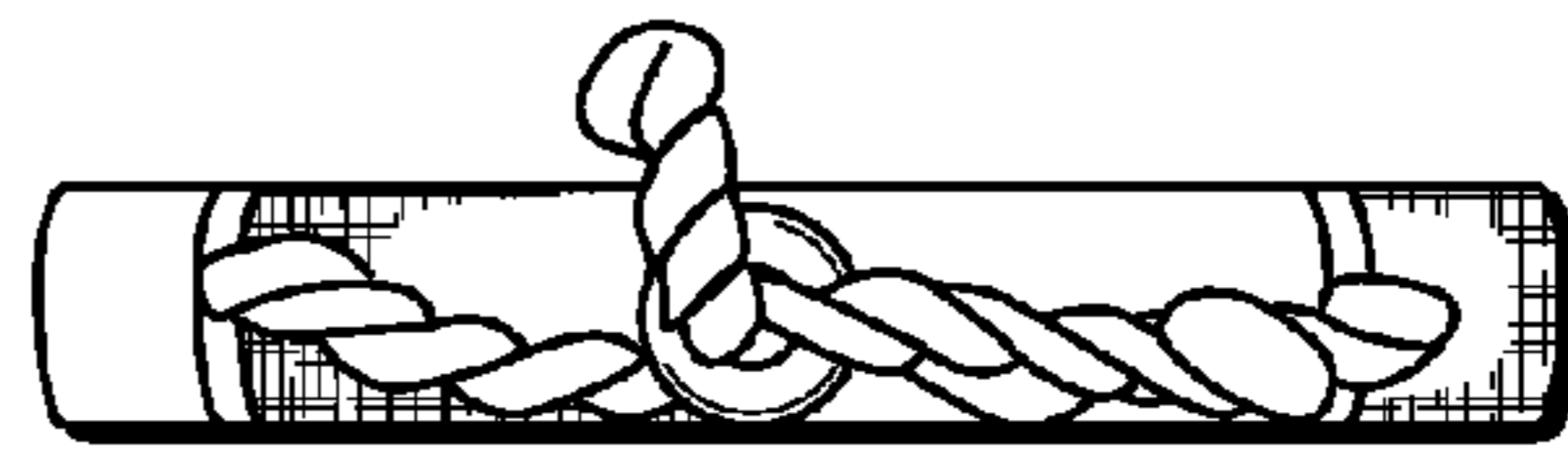

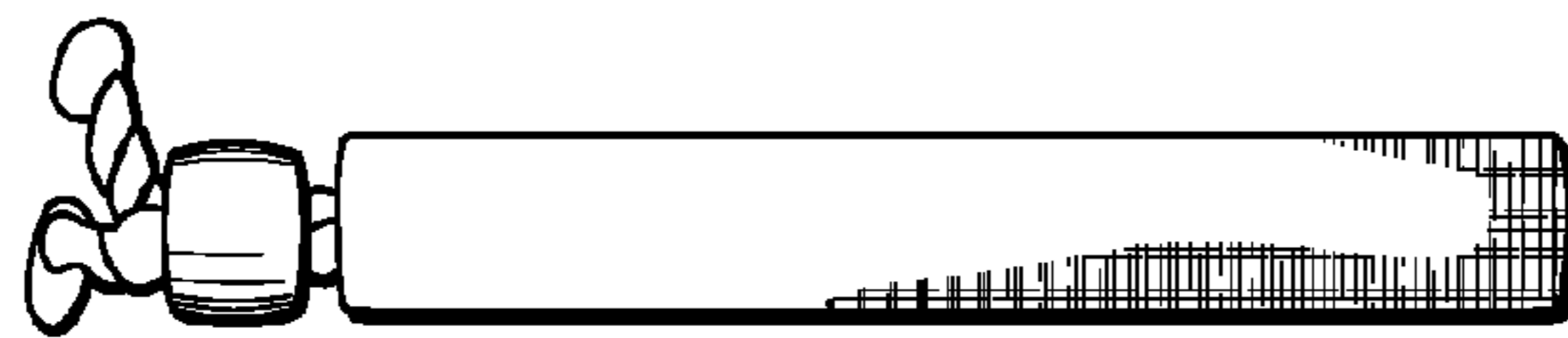

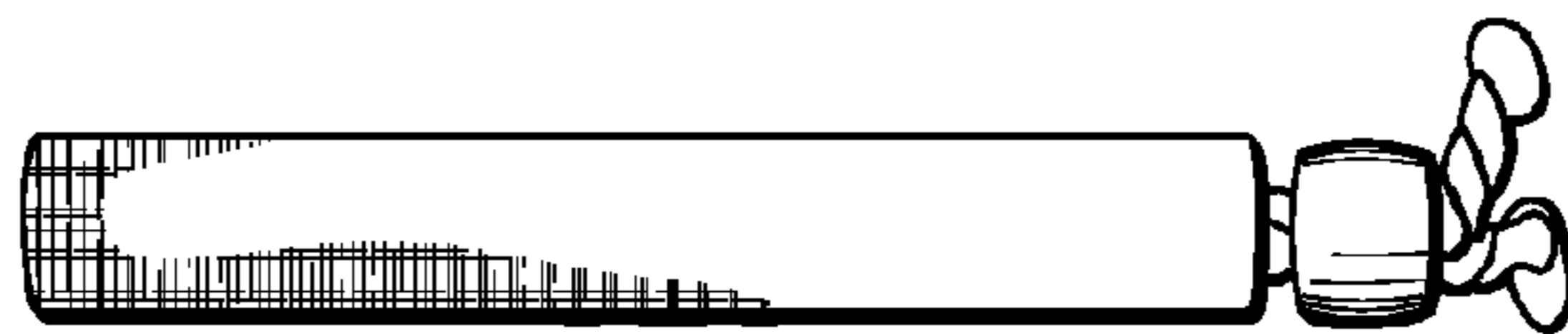

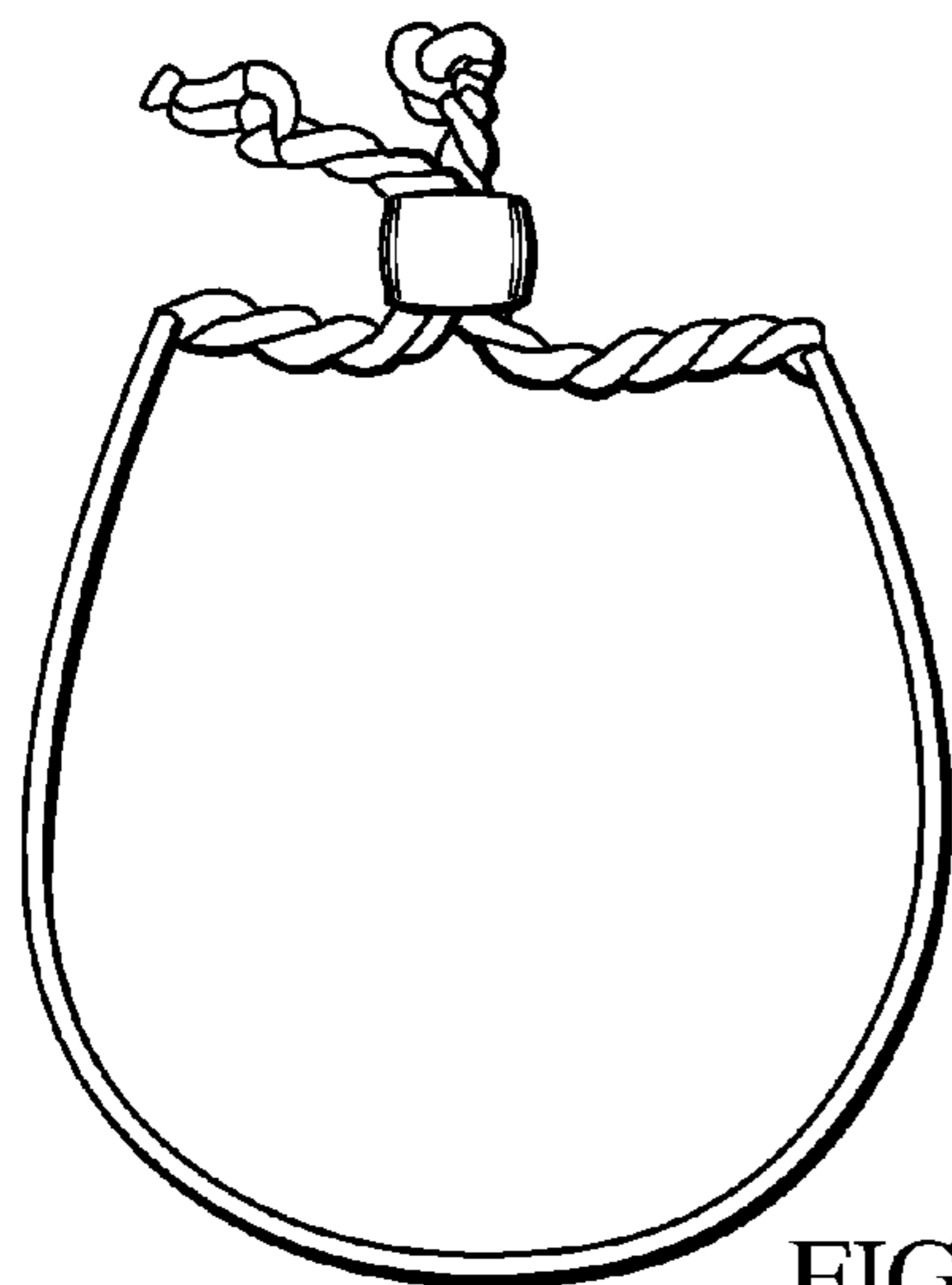

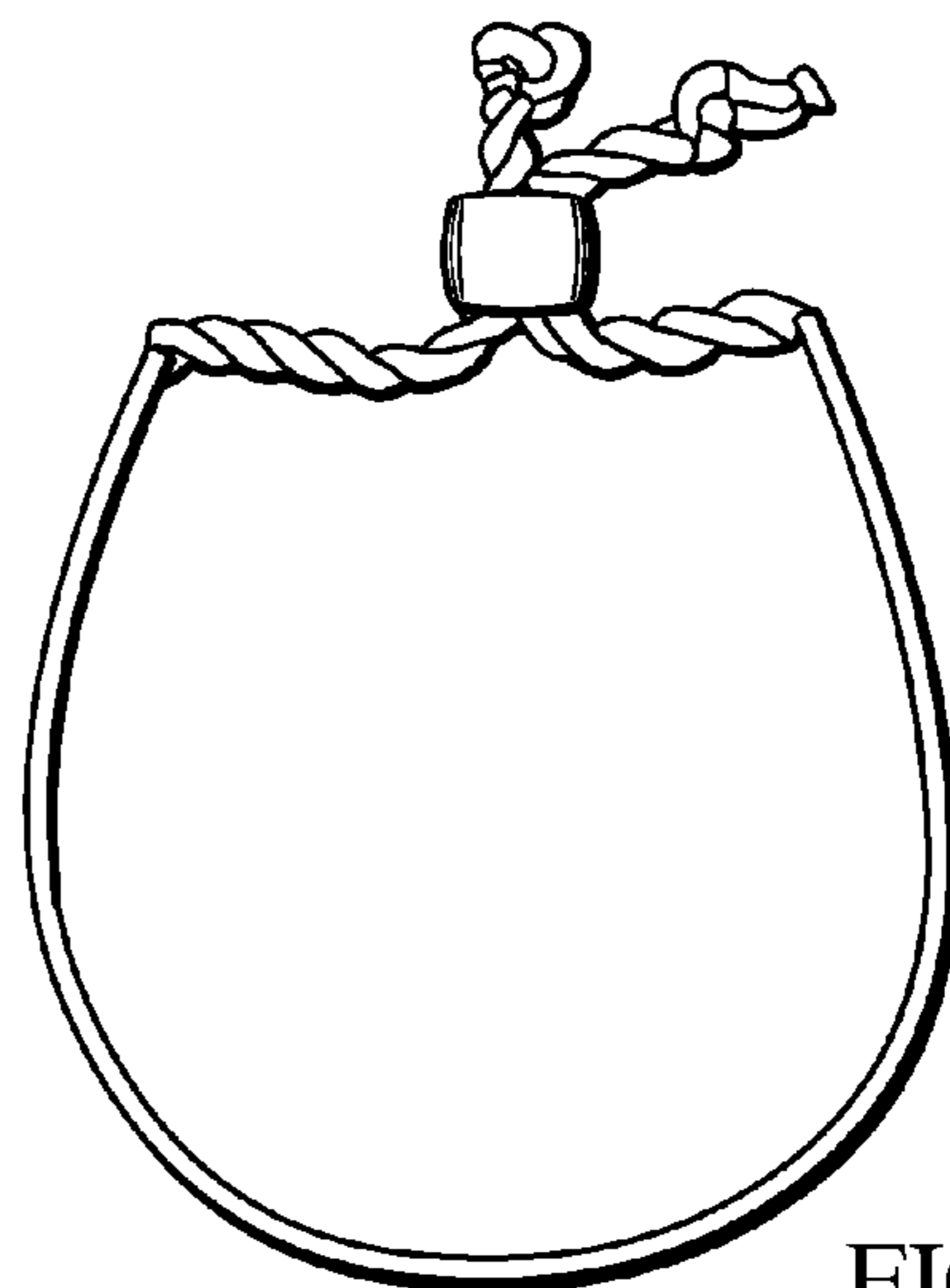
