FIG. 6 is a left side view thereof.

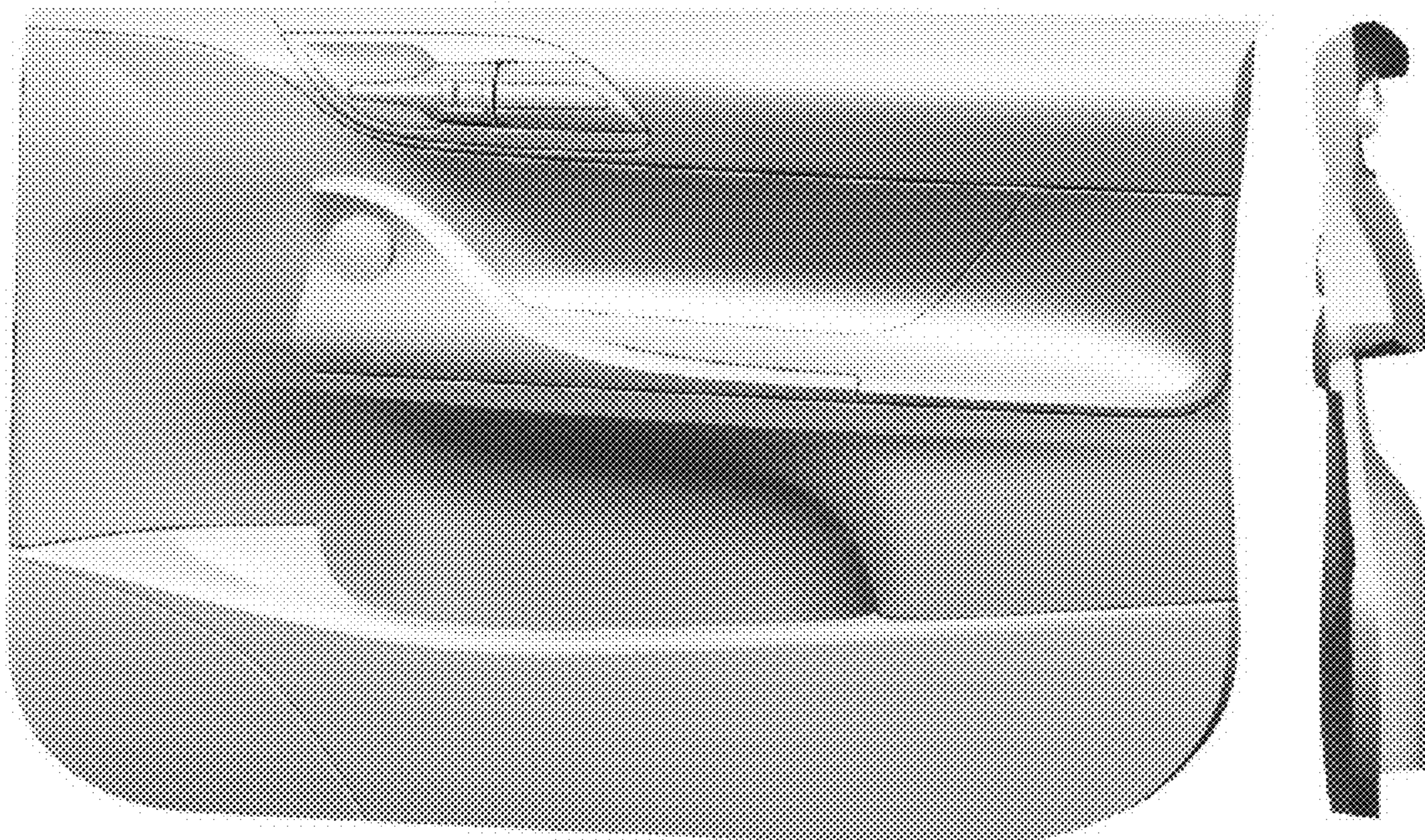
The rear of the interior door panel is not seen during ordinary

includes a mirror image of the embodiment depicted.

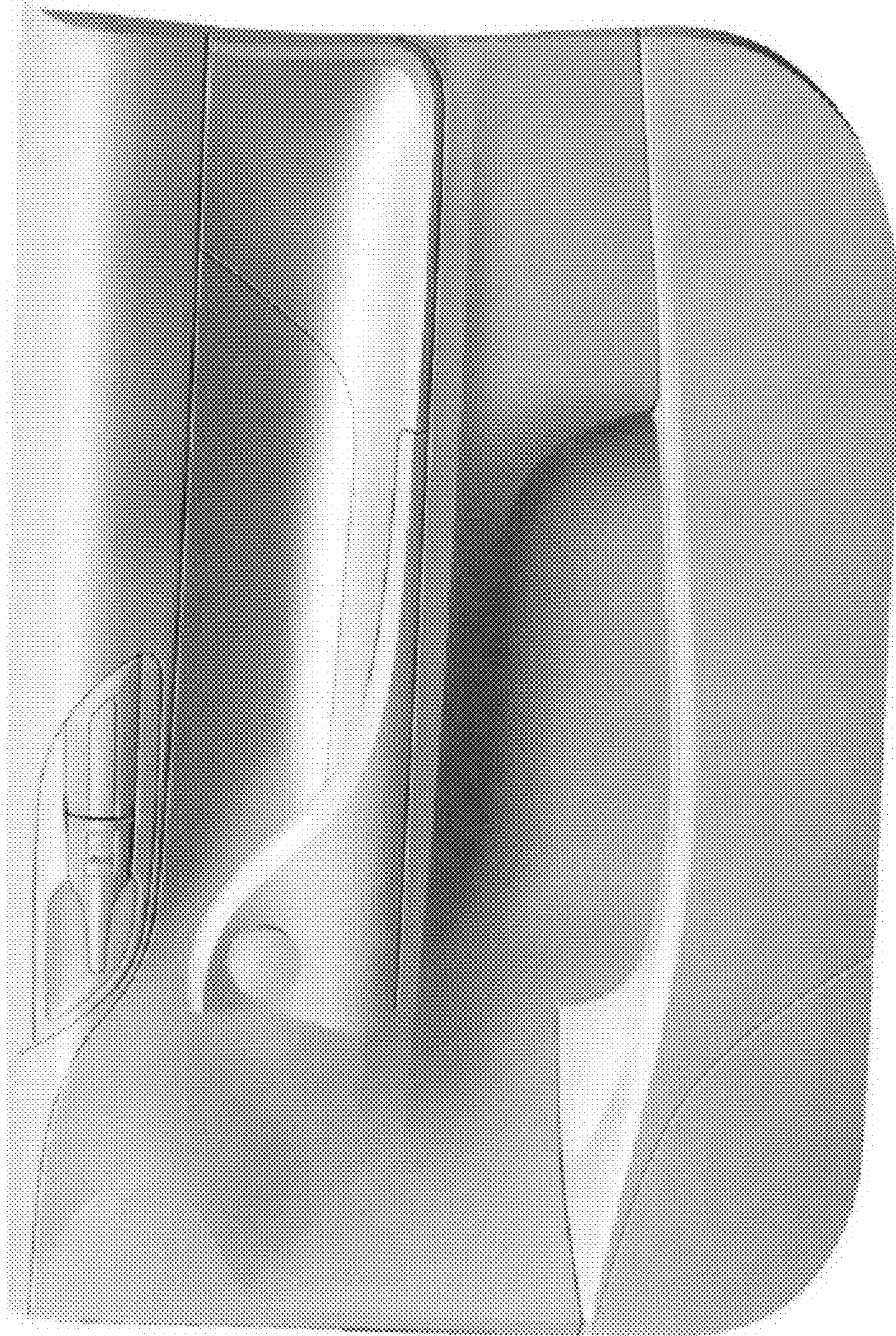

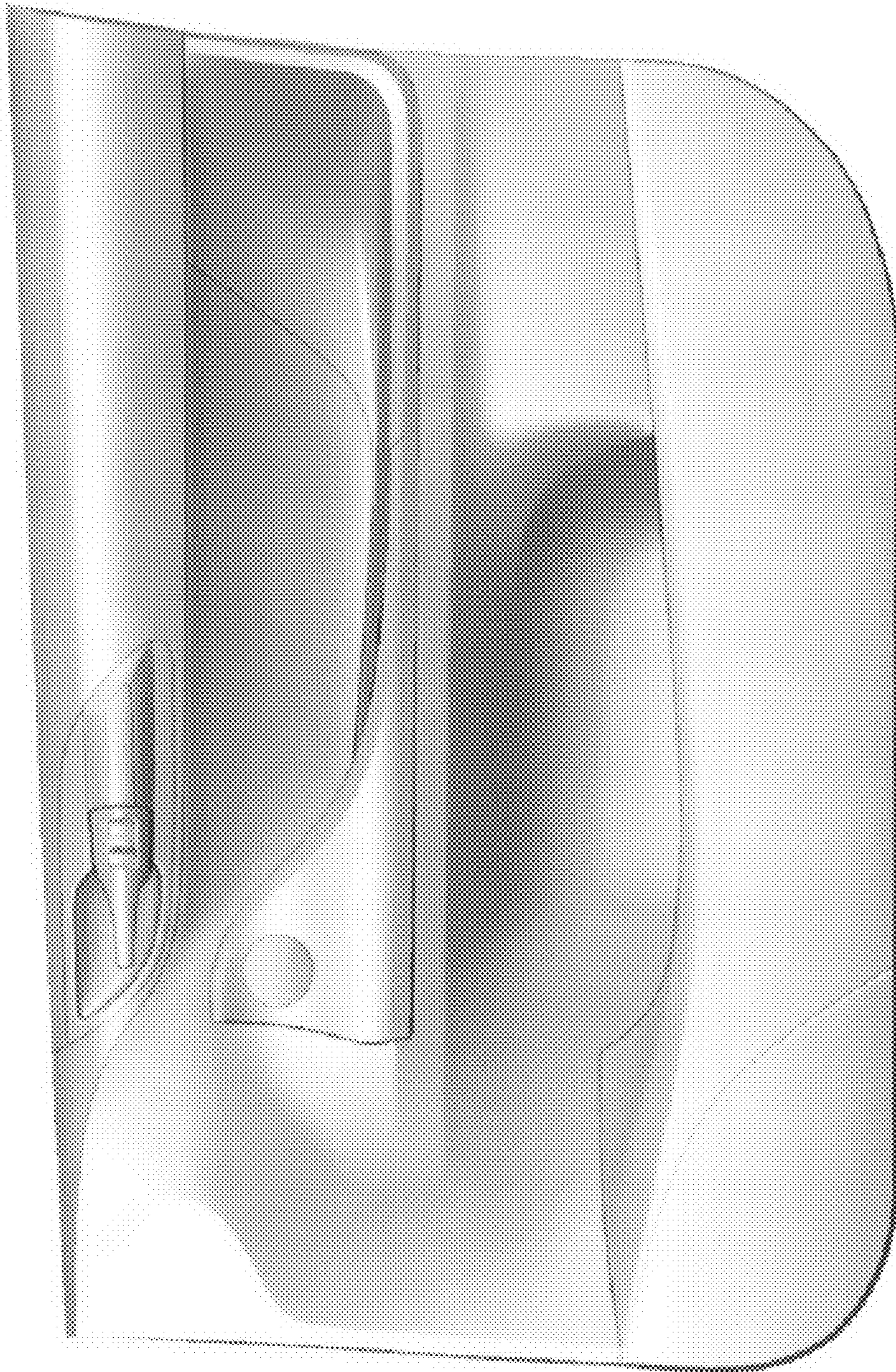
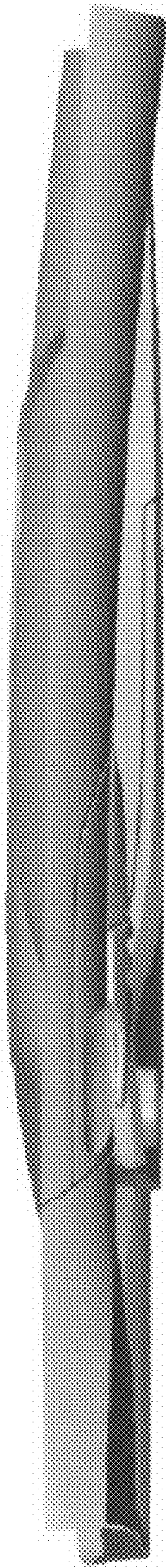
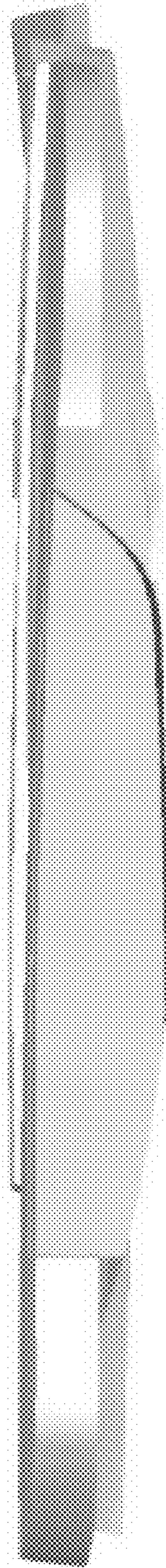

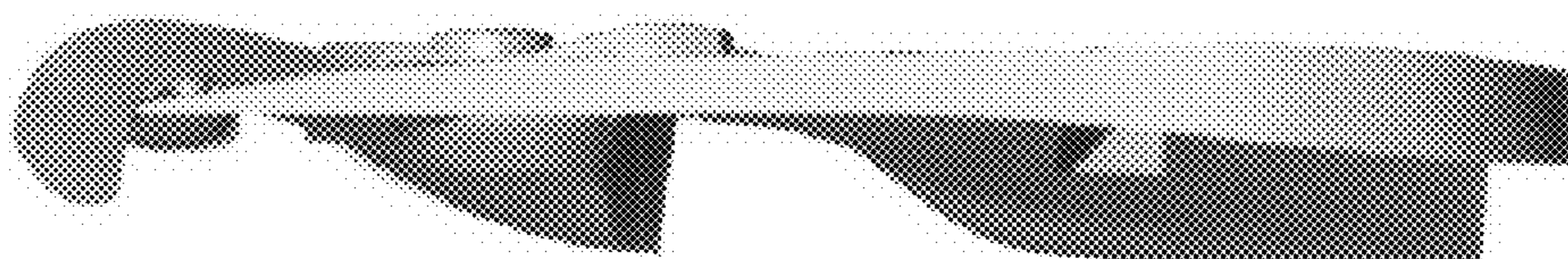

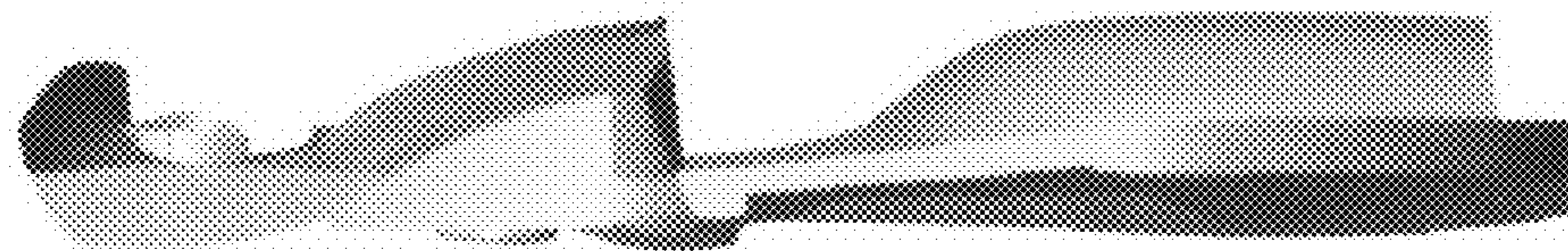
