(57) **CLAIM**

The ornamental design for a side window molding for an automobile, as shown and described.

DESCRIPTION

FIG. 1 is a left front perspective view of a side window for an automobile showing our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a left side view thereof; and,

FIG. 7 is a right side view thereof.

Our design includes the mirror image of the embodiment depicted.

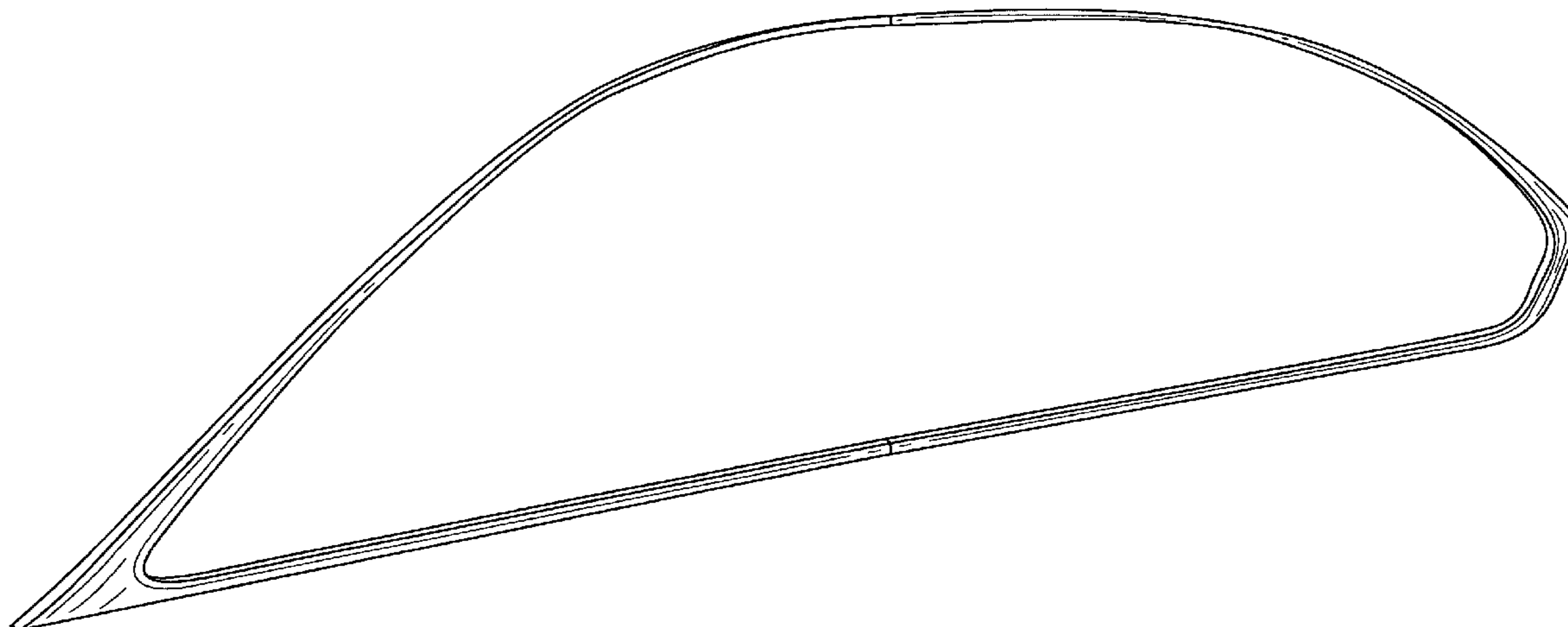

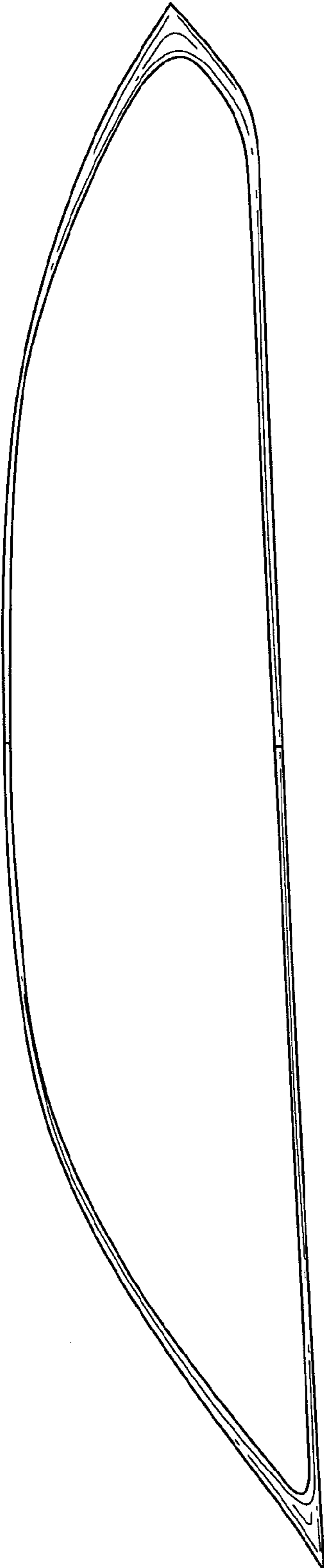

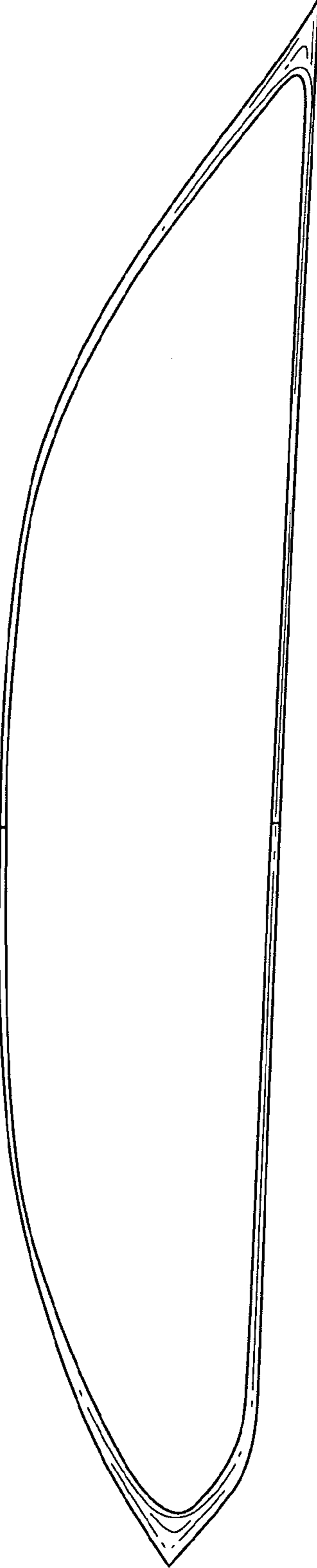

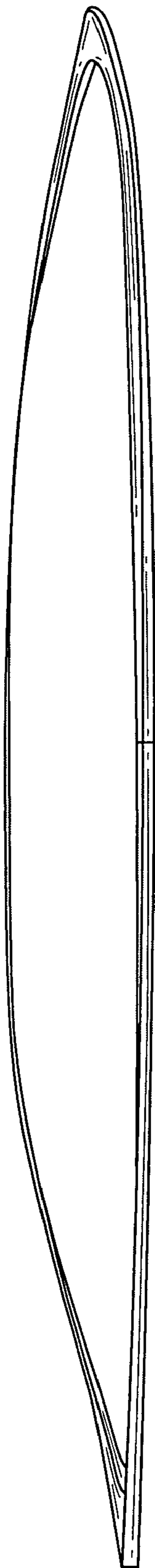

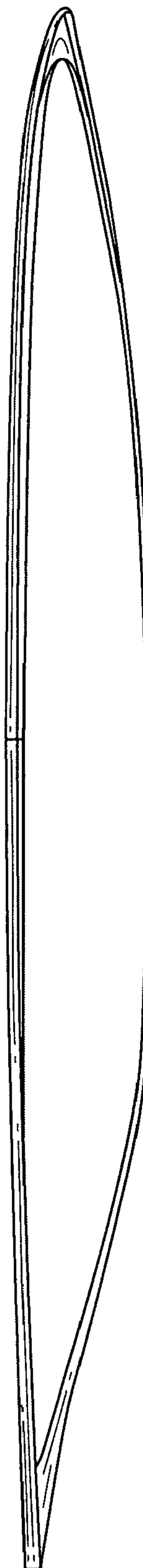

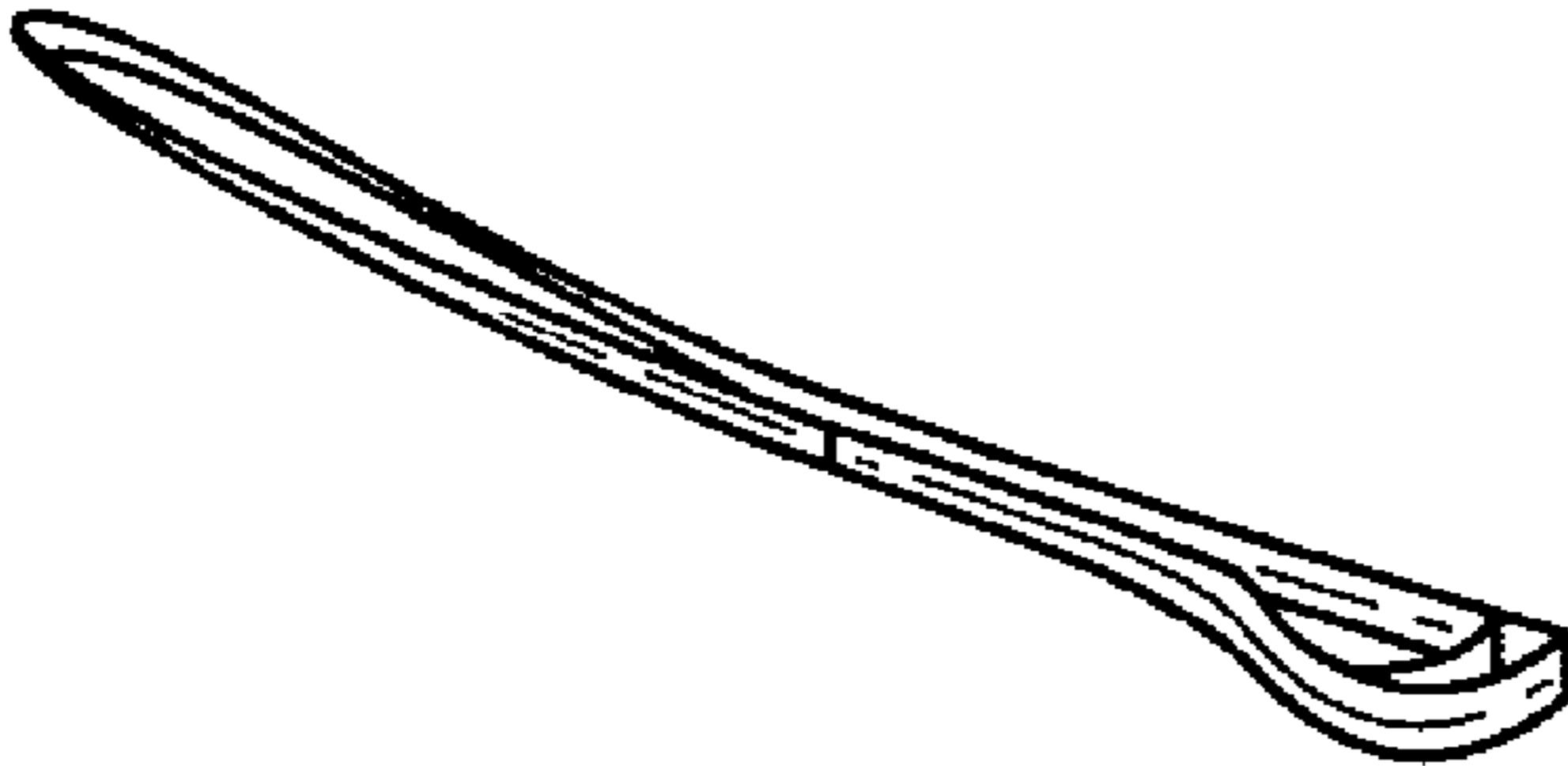
