FIG. 35 is an end elevational view thereof;

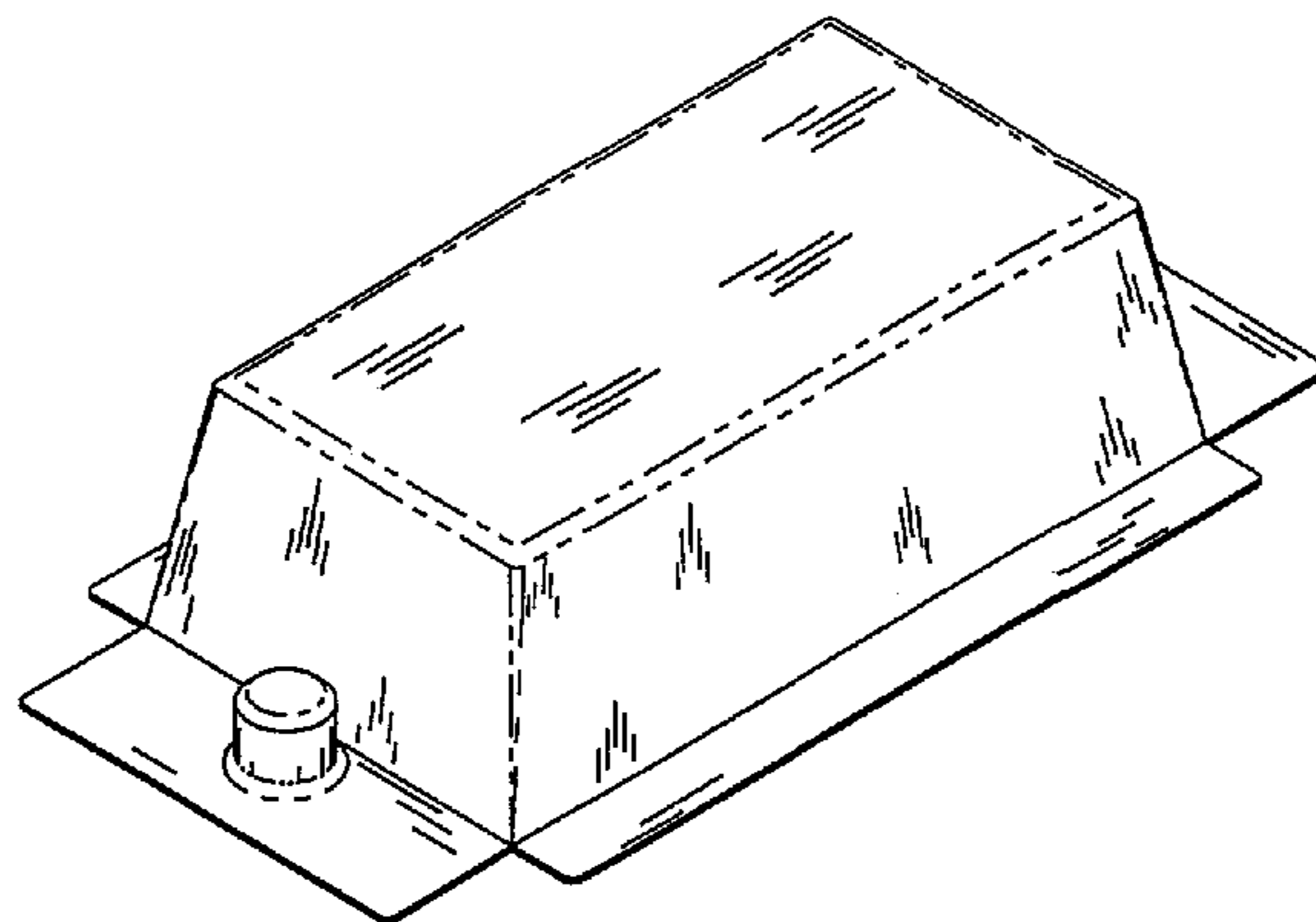


FIG. **36** is a perspective view of an eighth embodiment thereof, the only difference from that of the first embodiment is that of transparency;

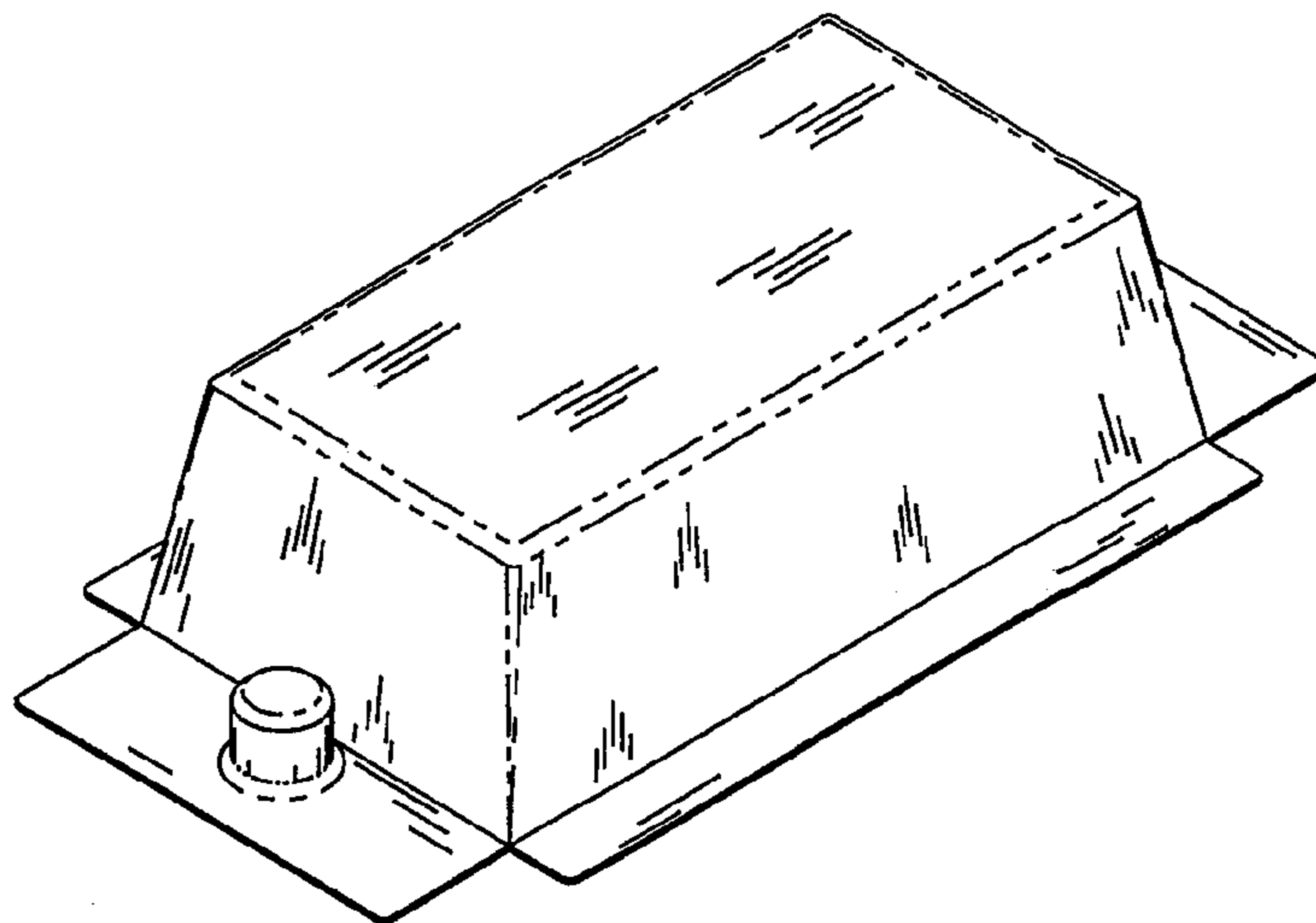

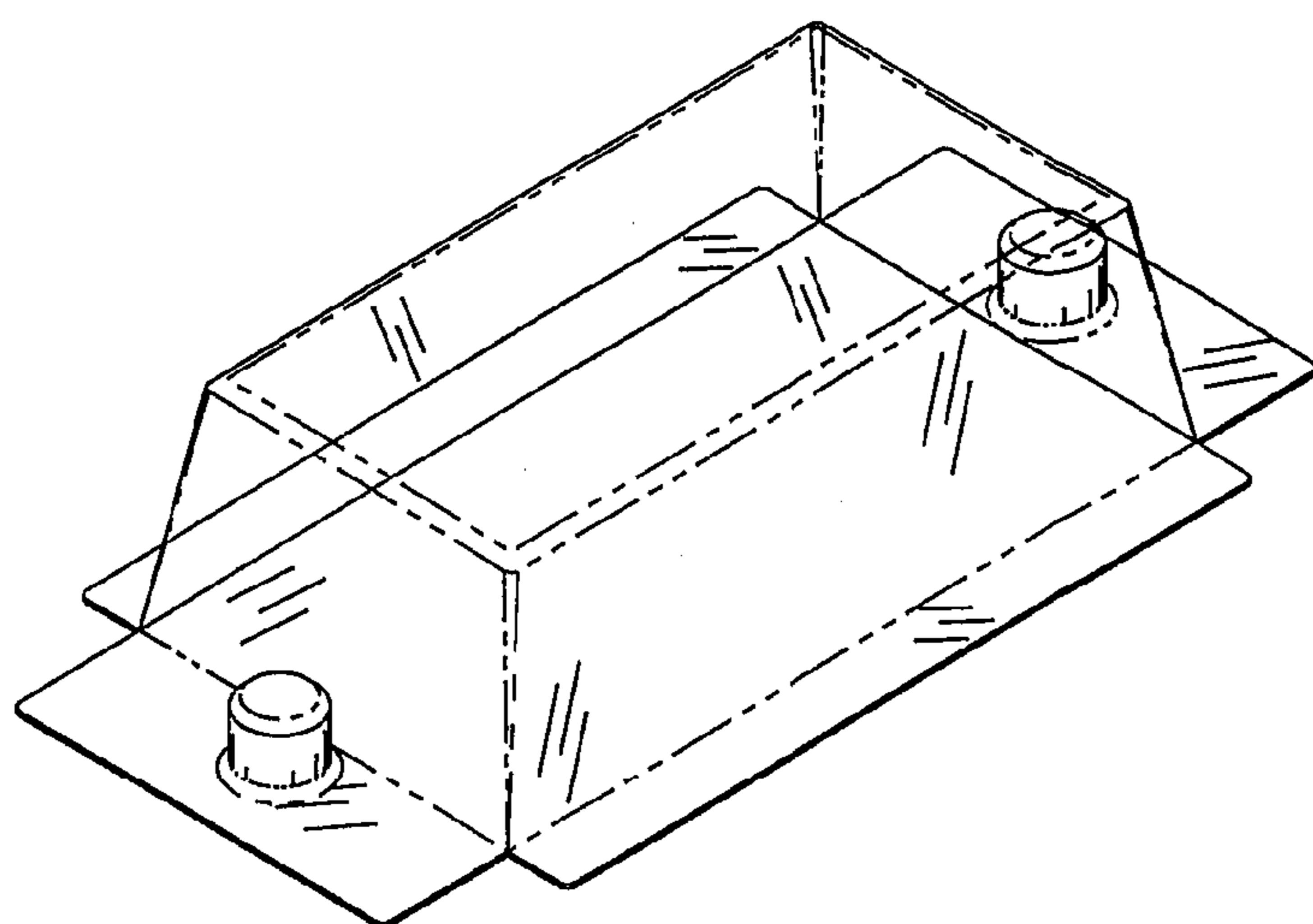

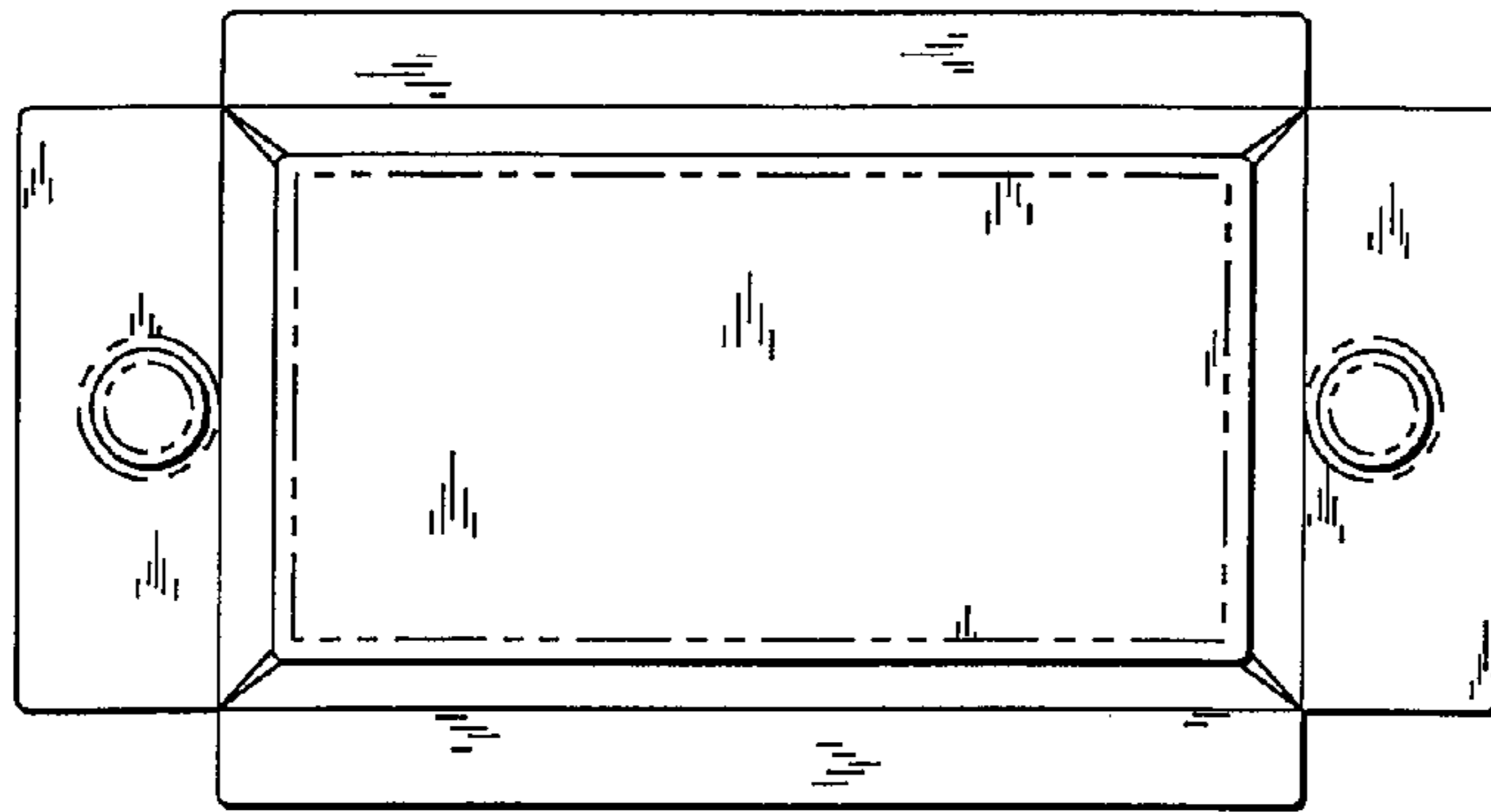

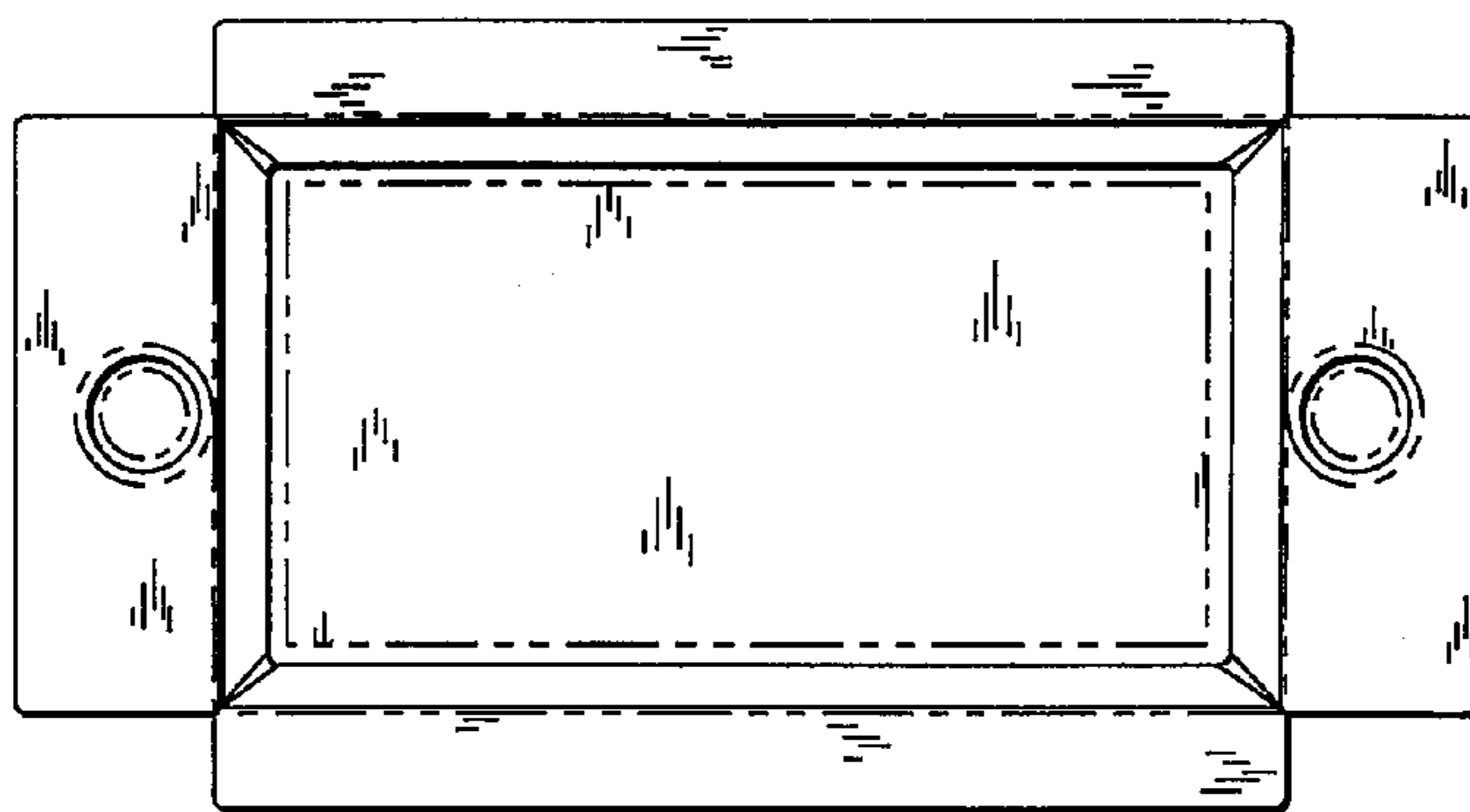

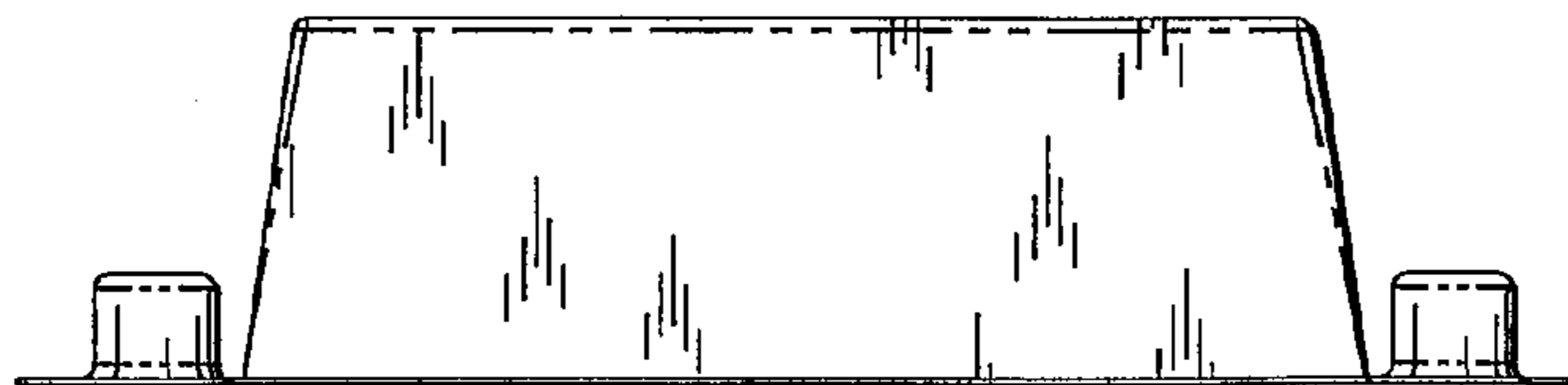

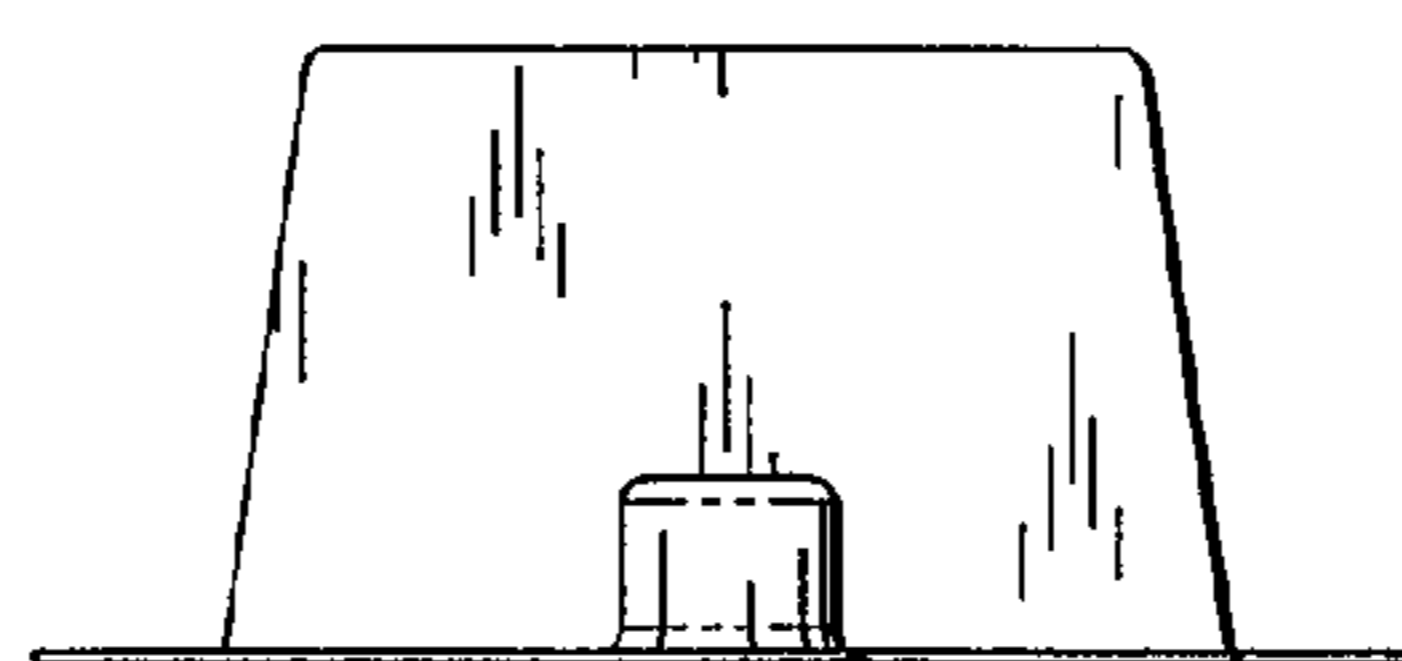

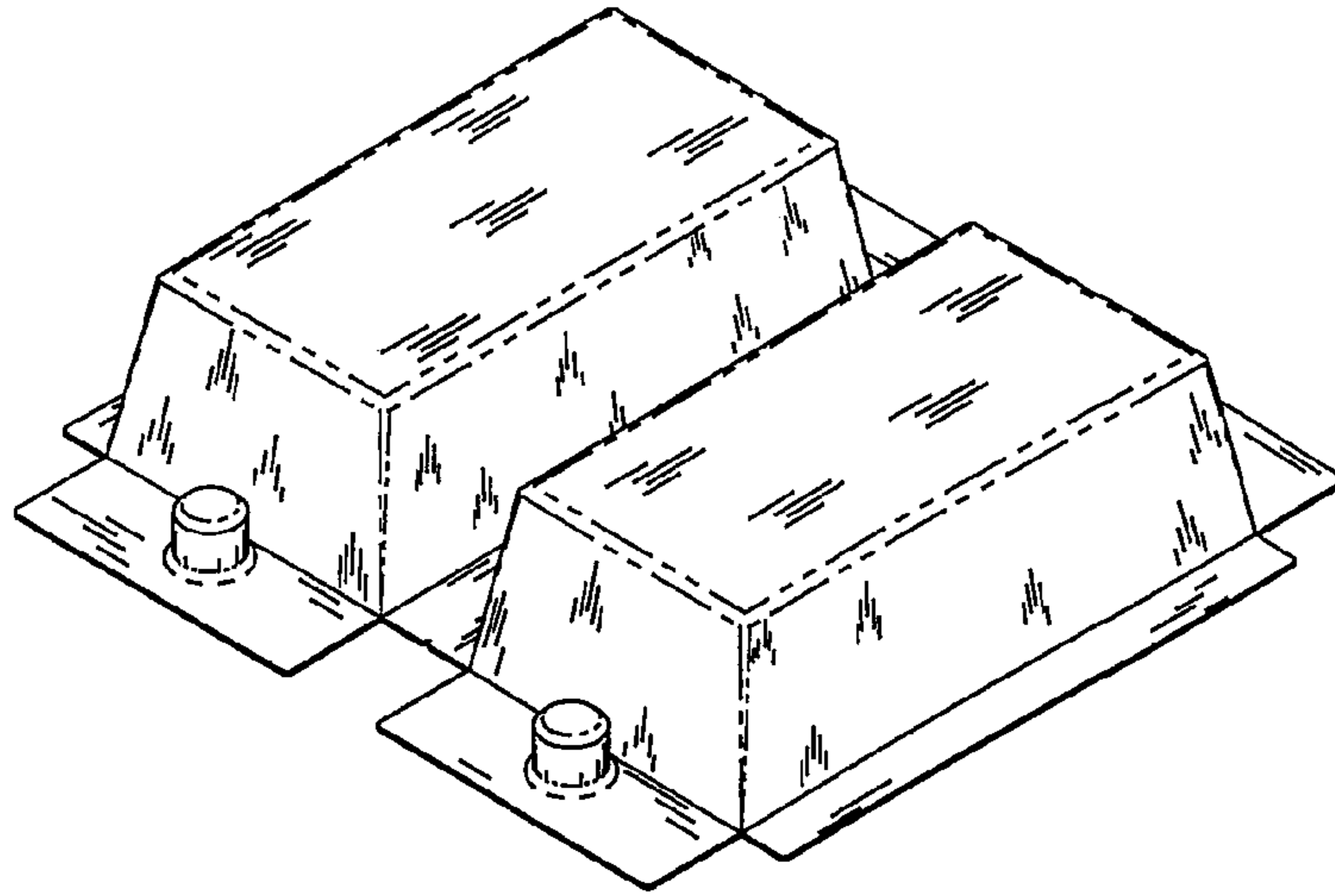

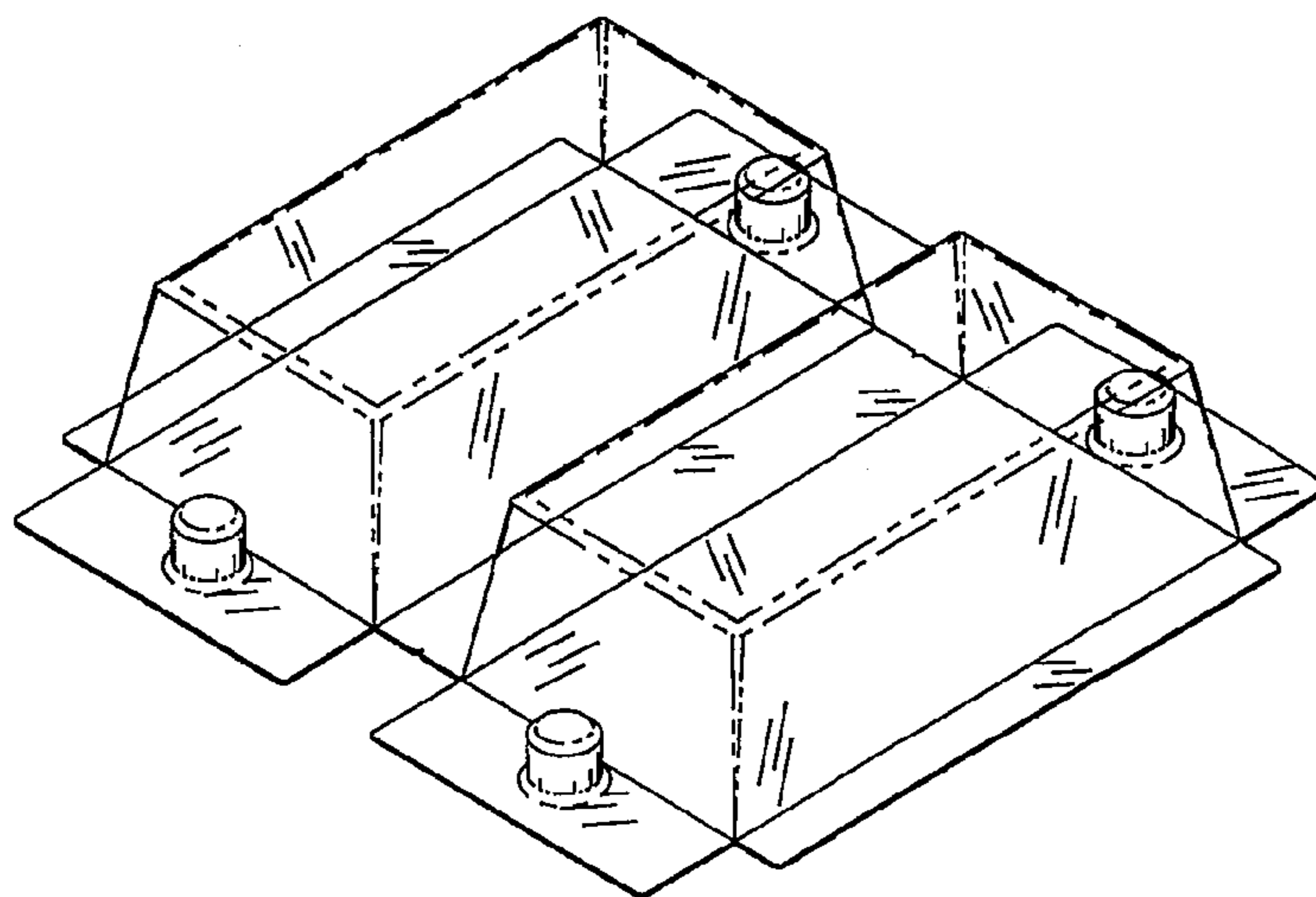

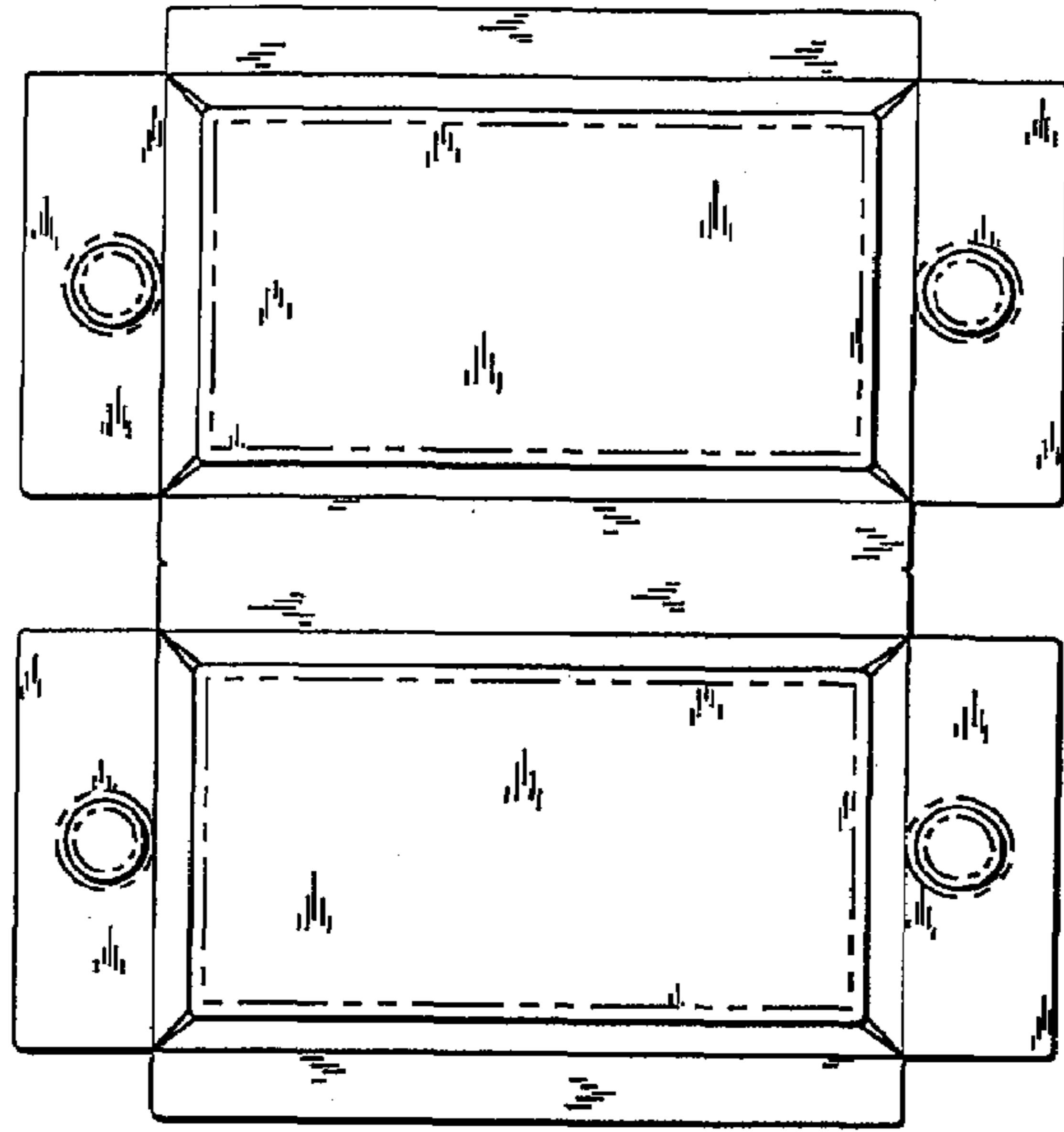

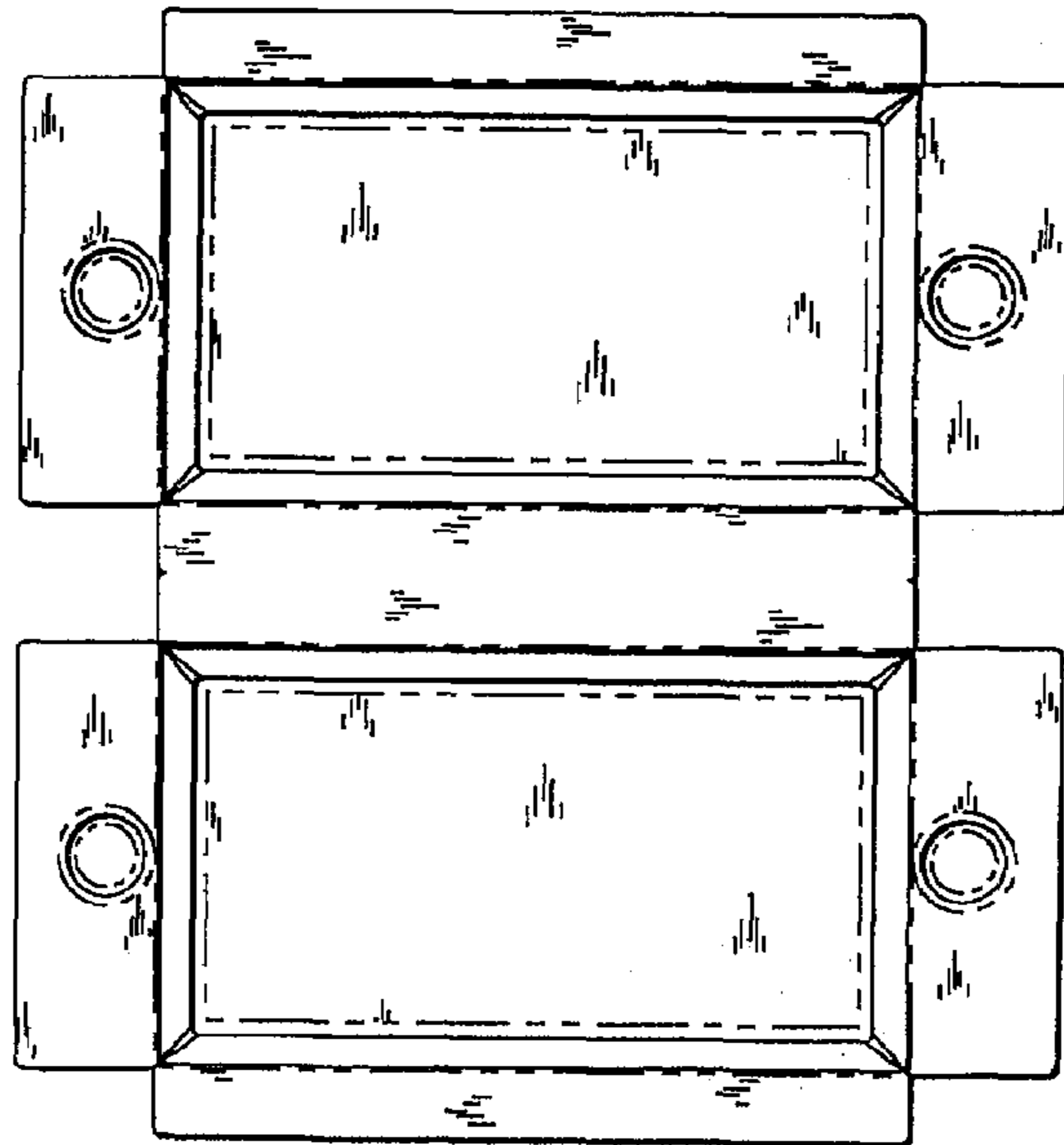

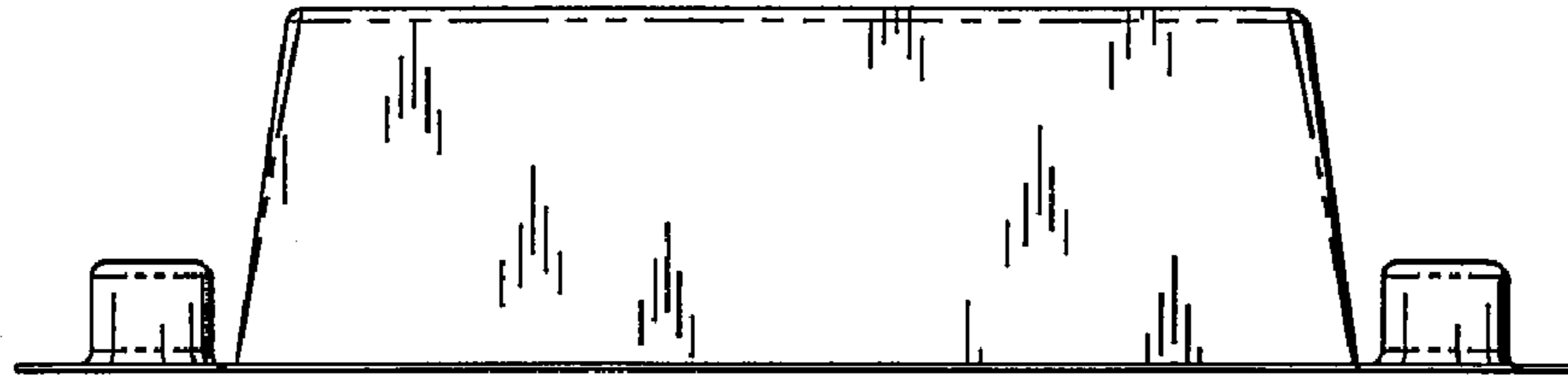

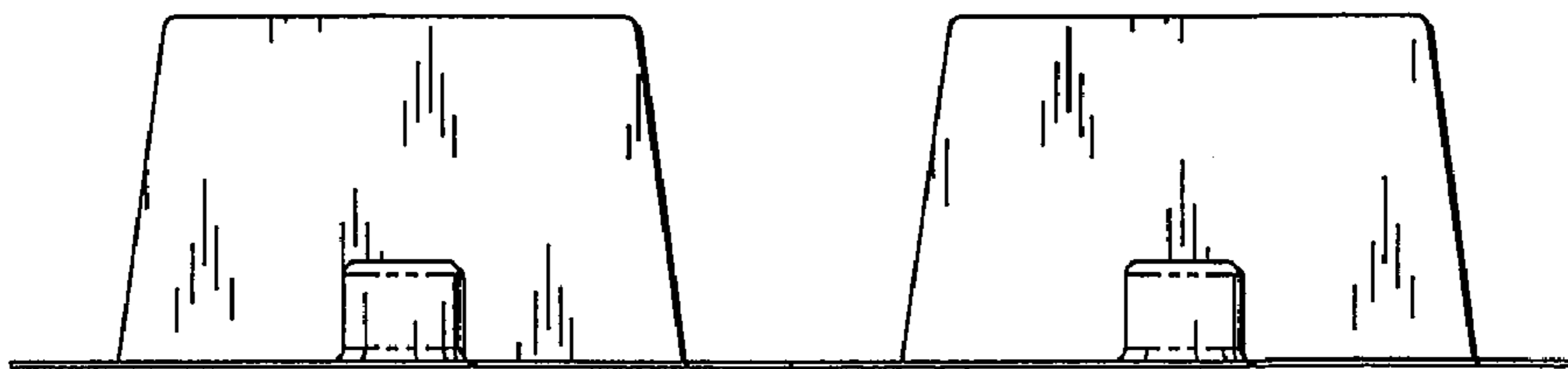

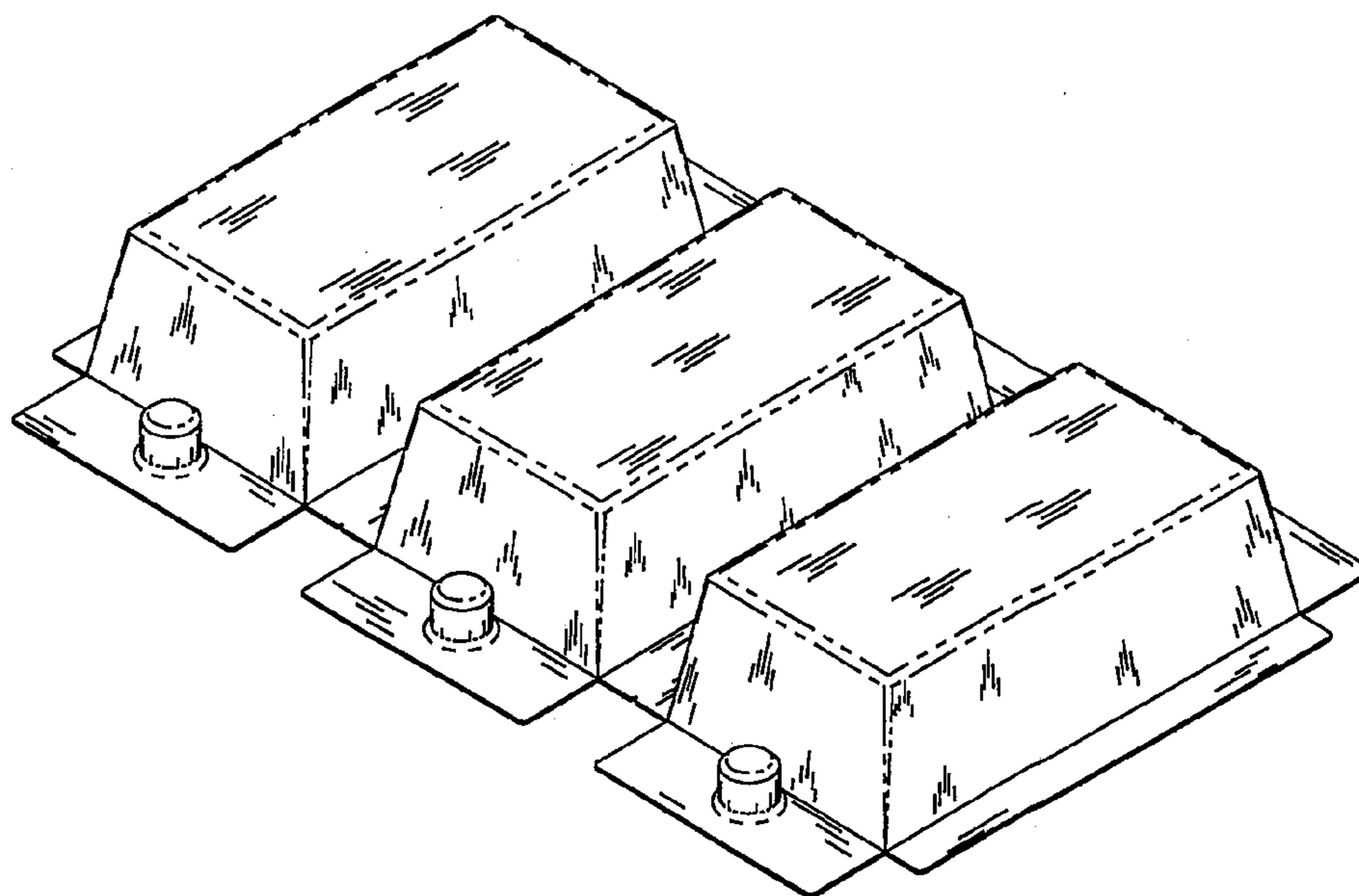

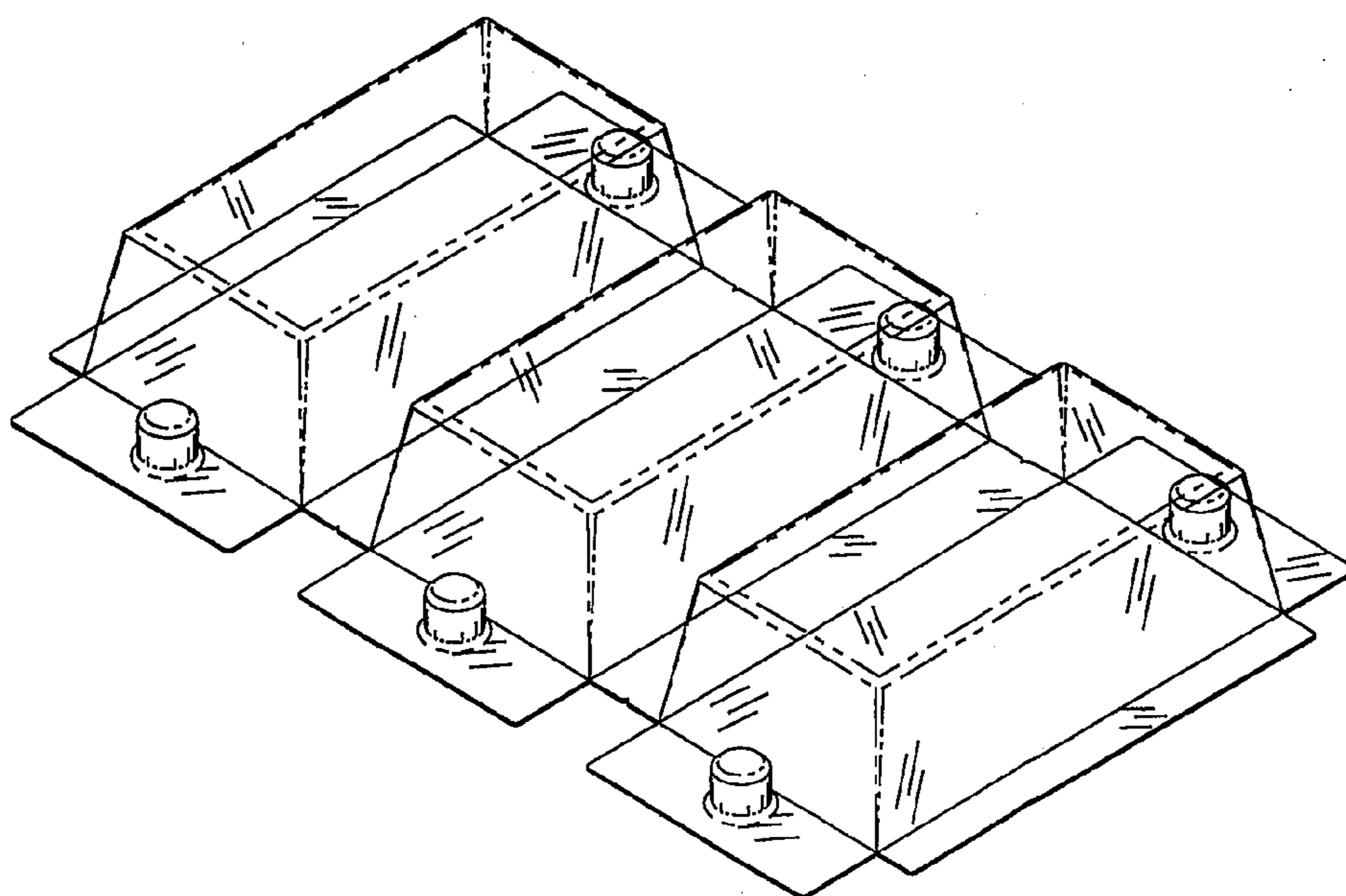

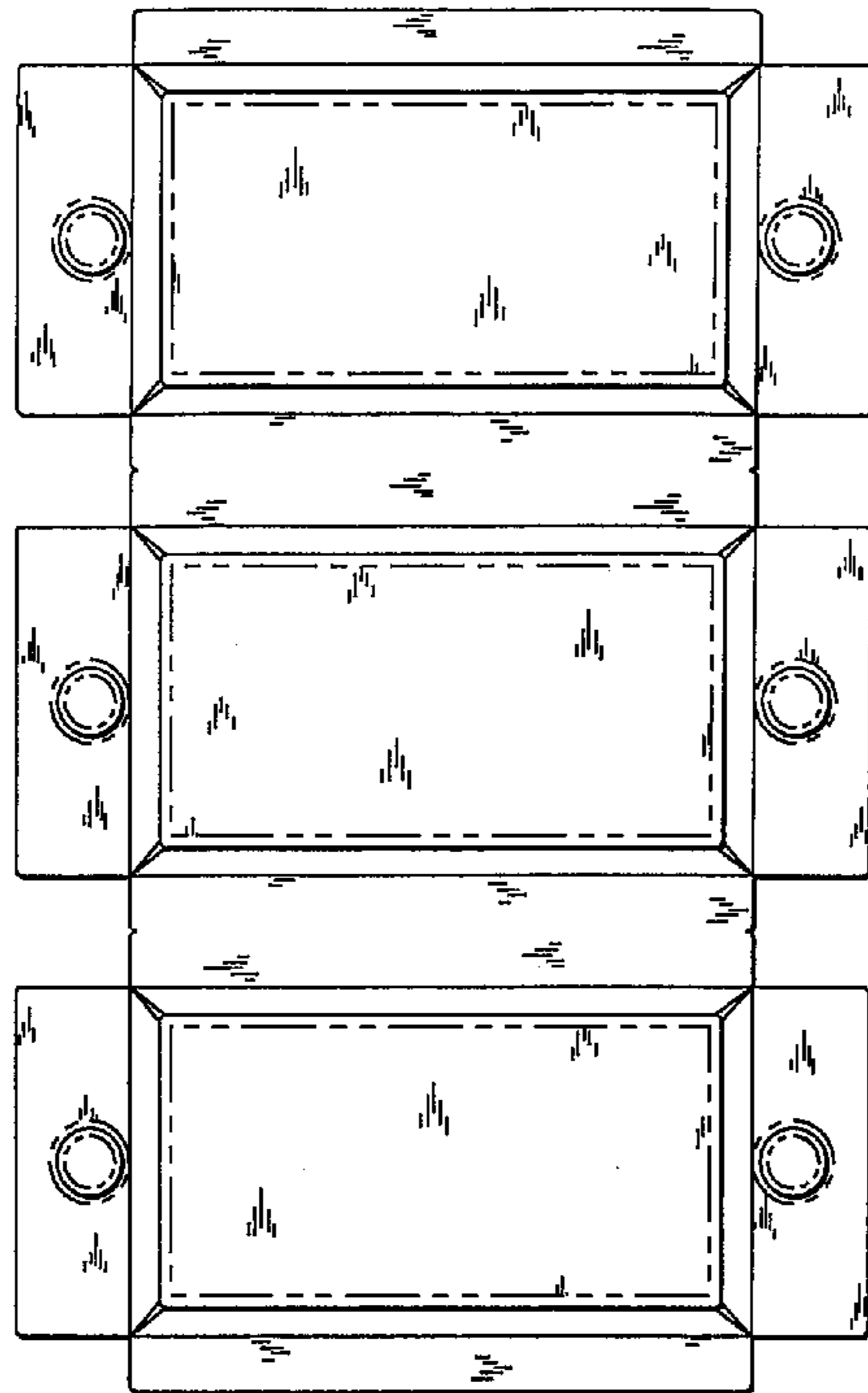

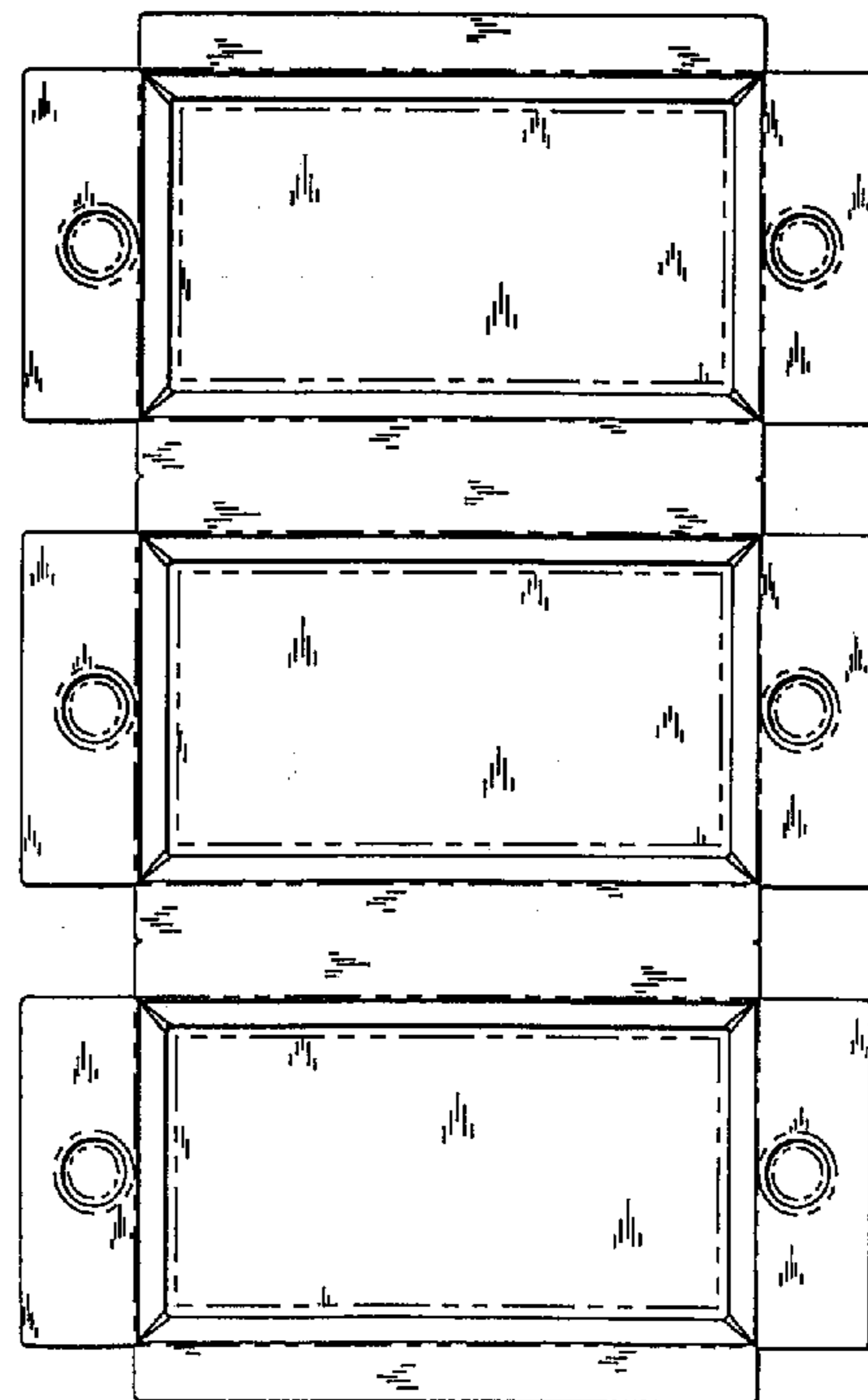

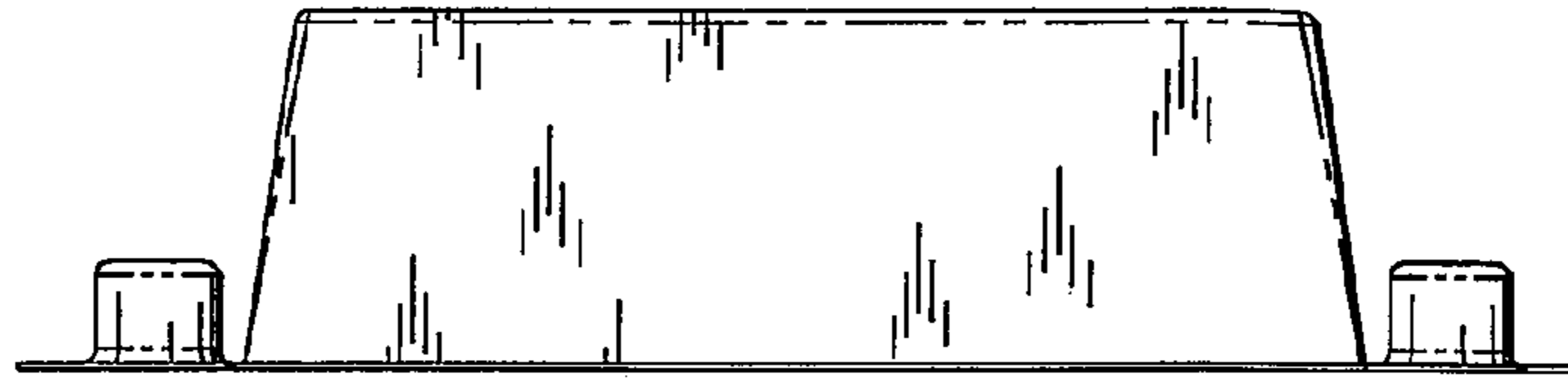

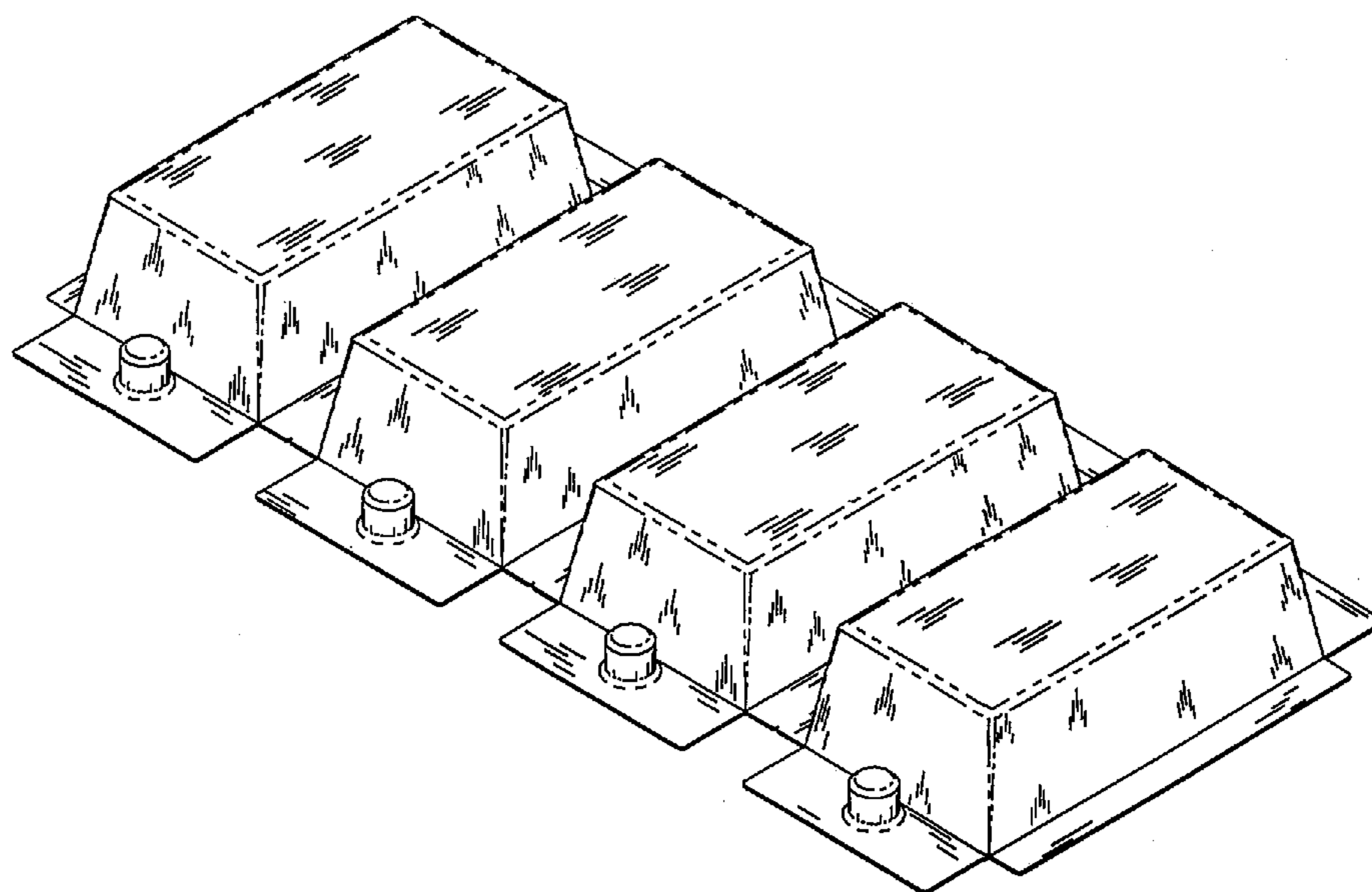

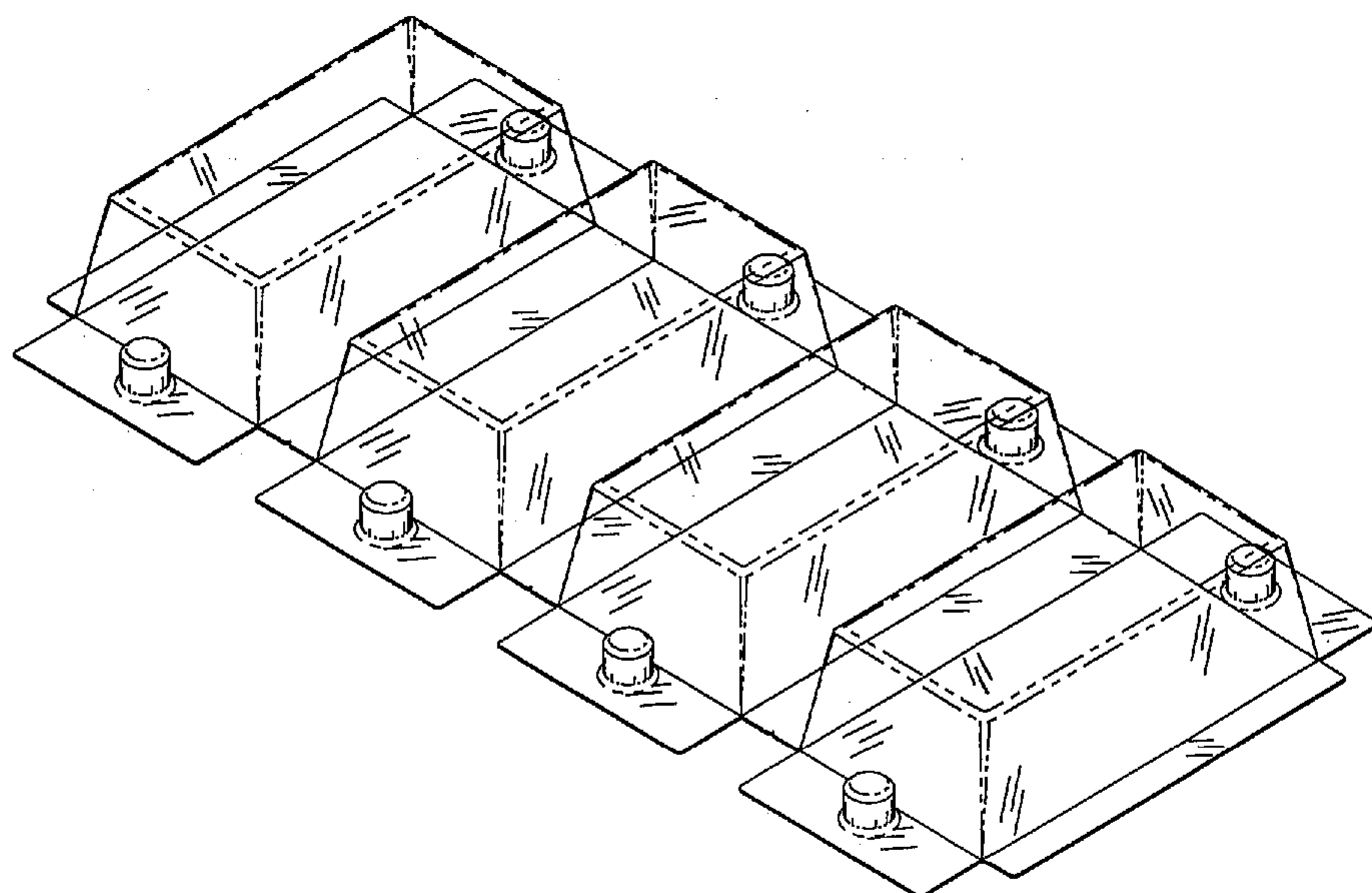

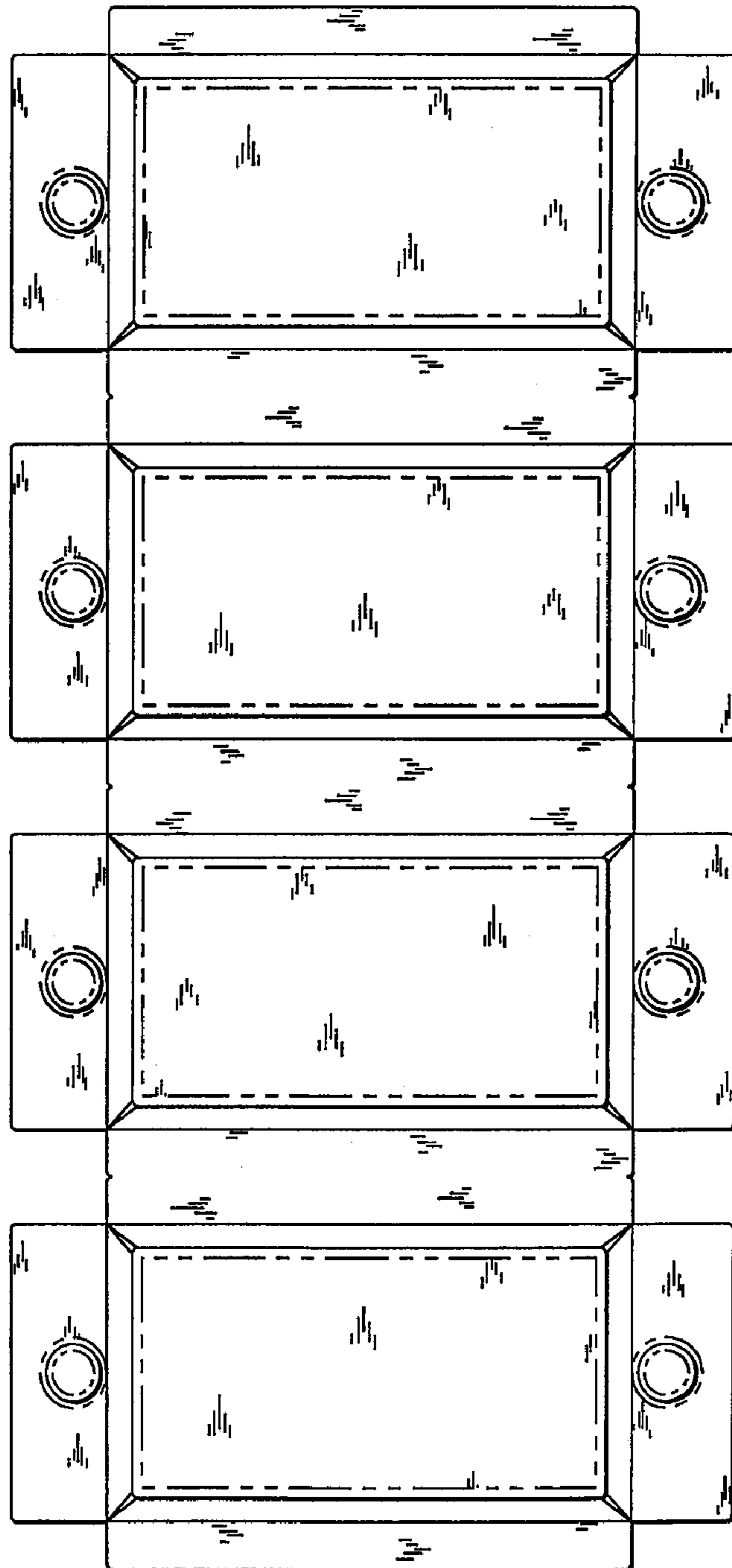

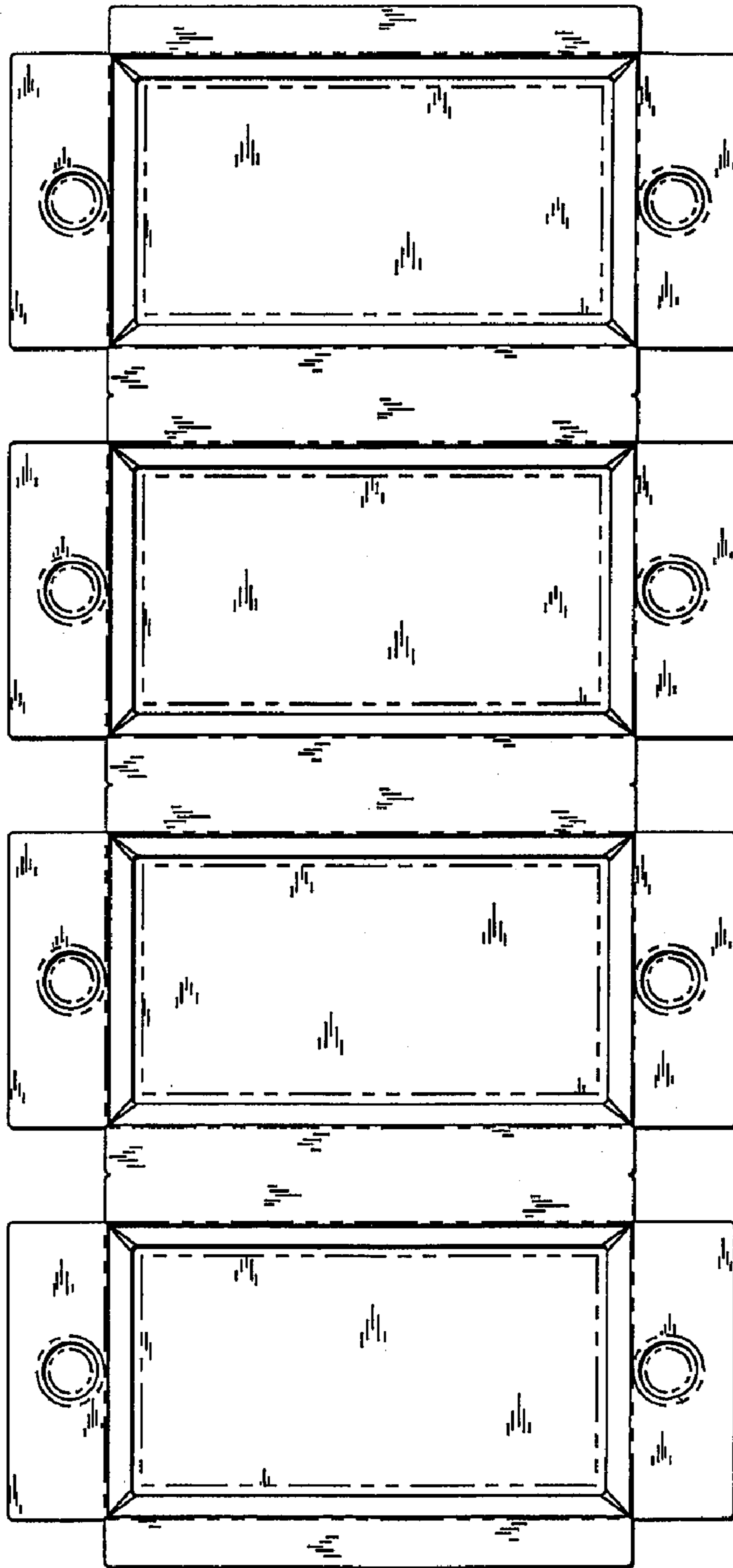

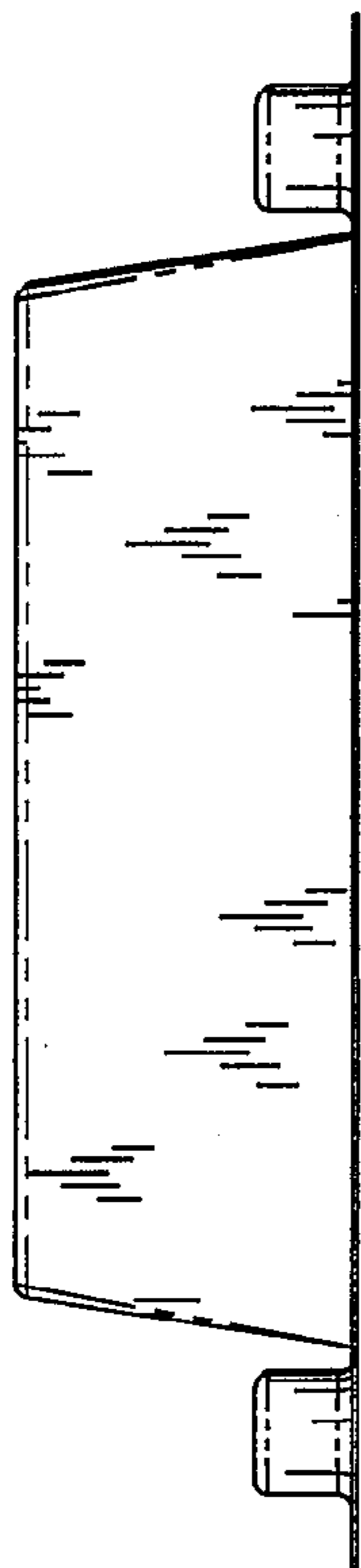

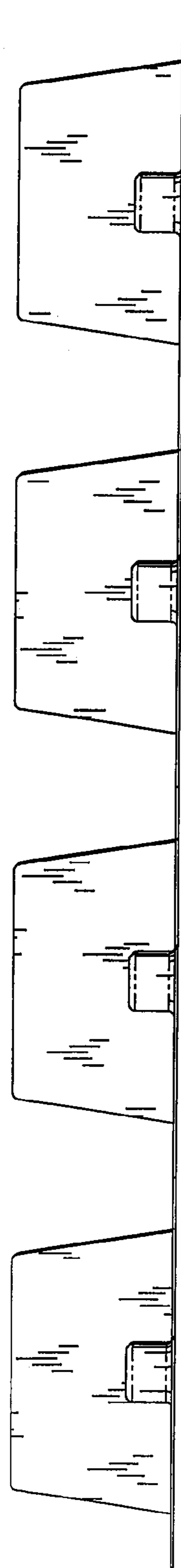

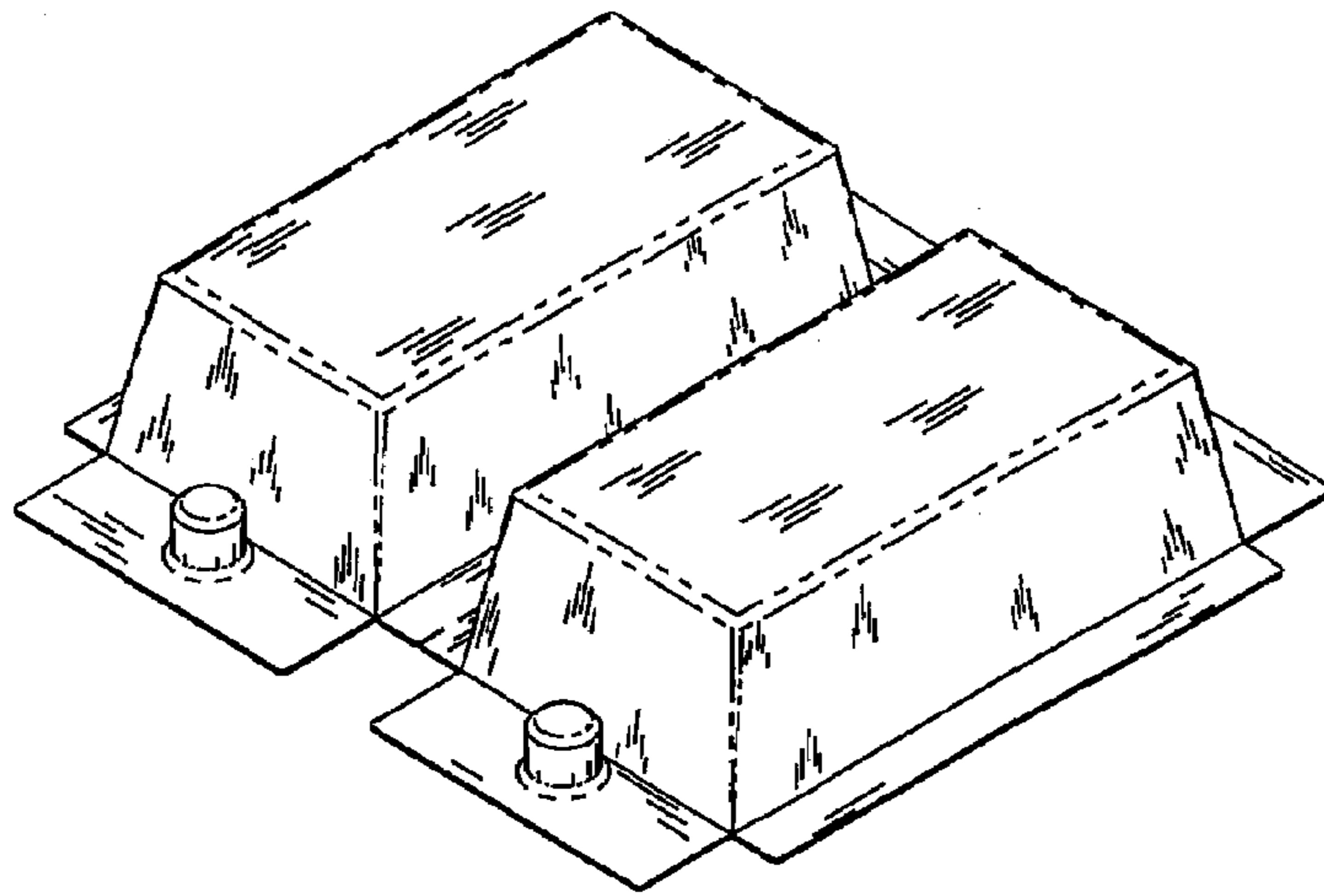

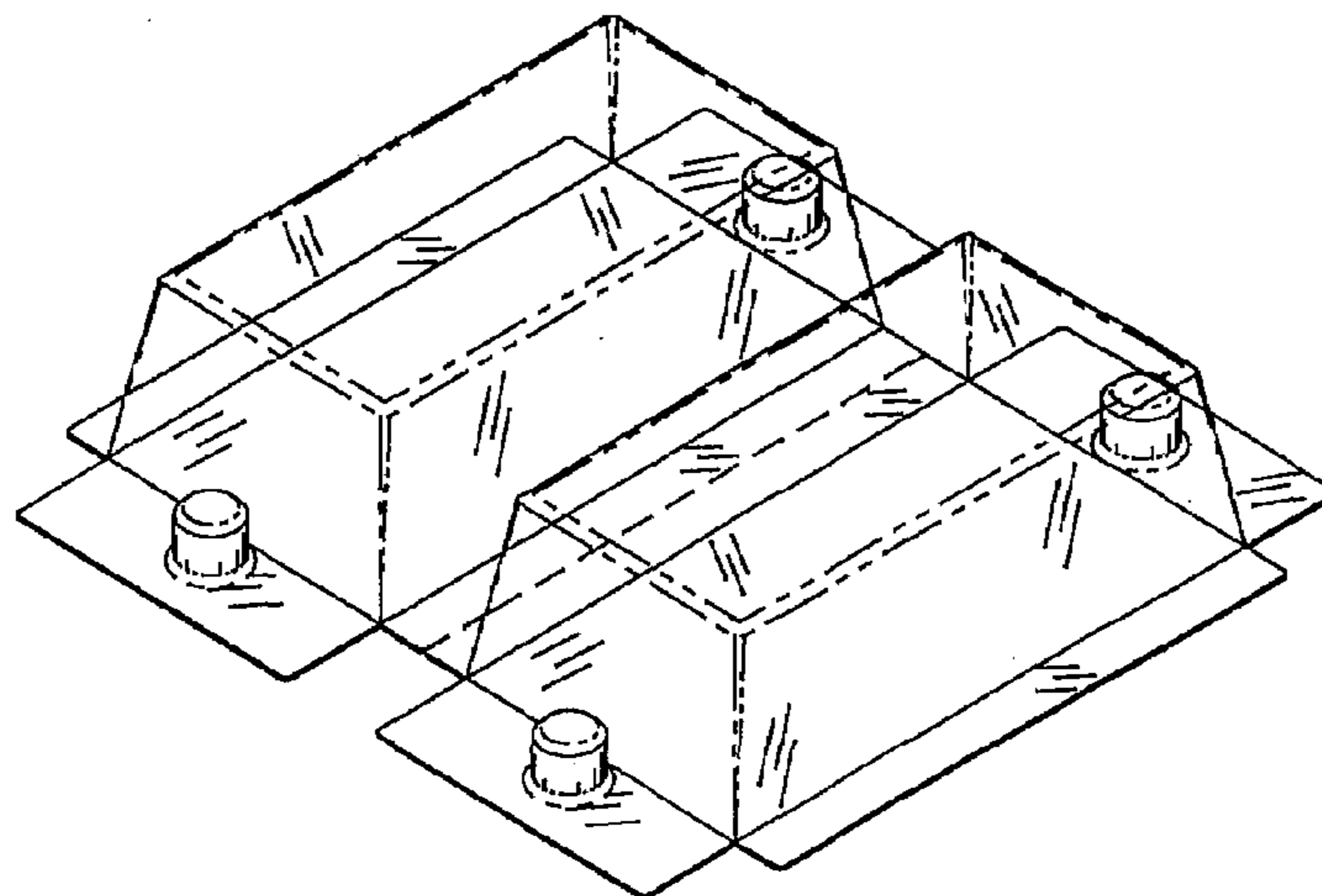

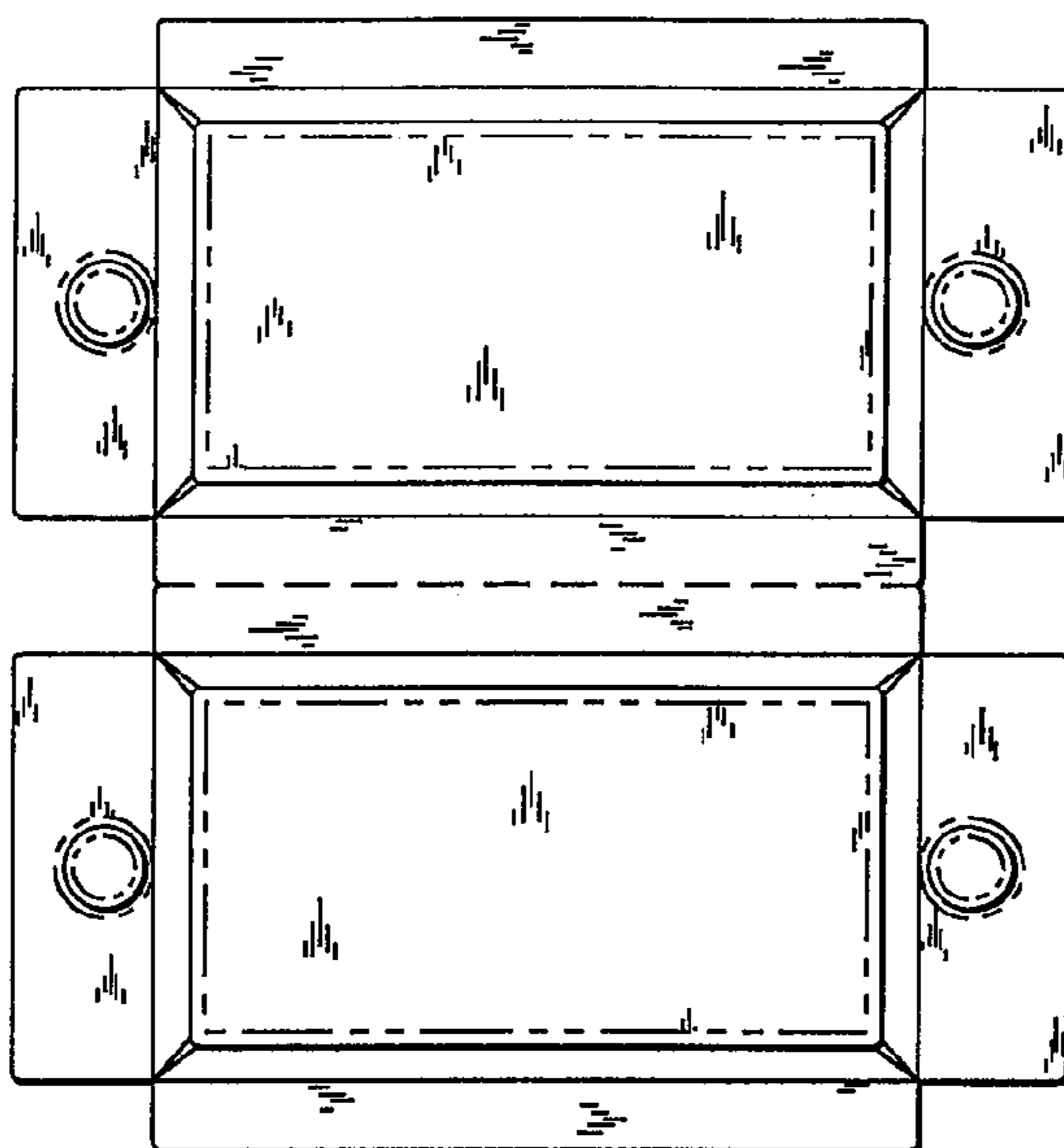

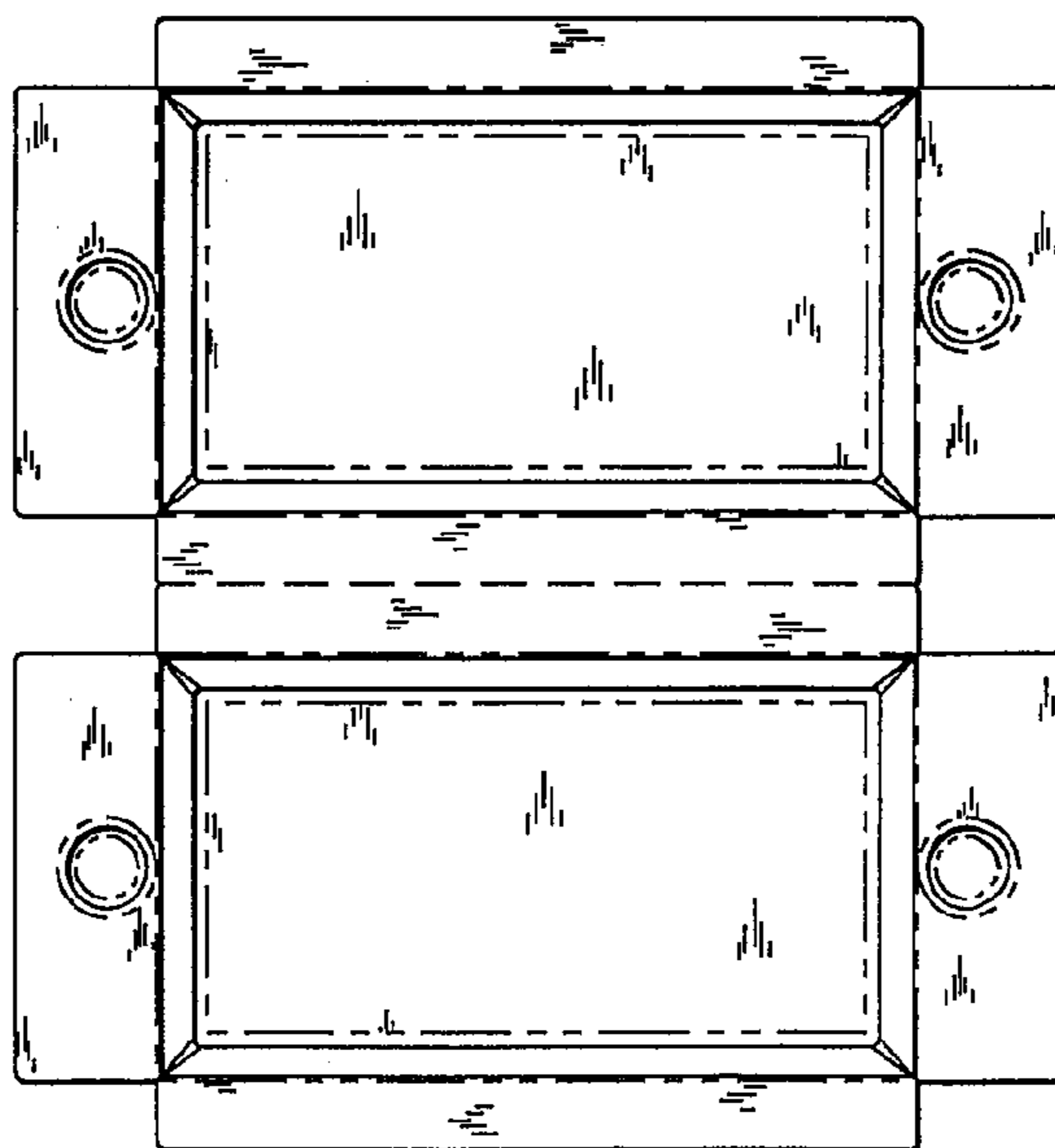

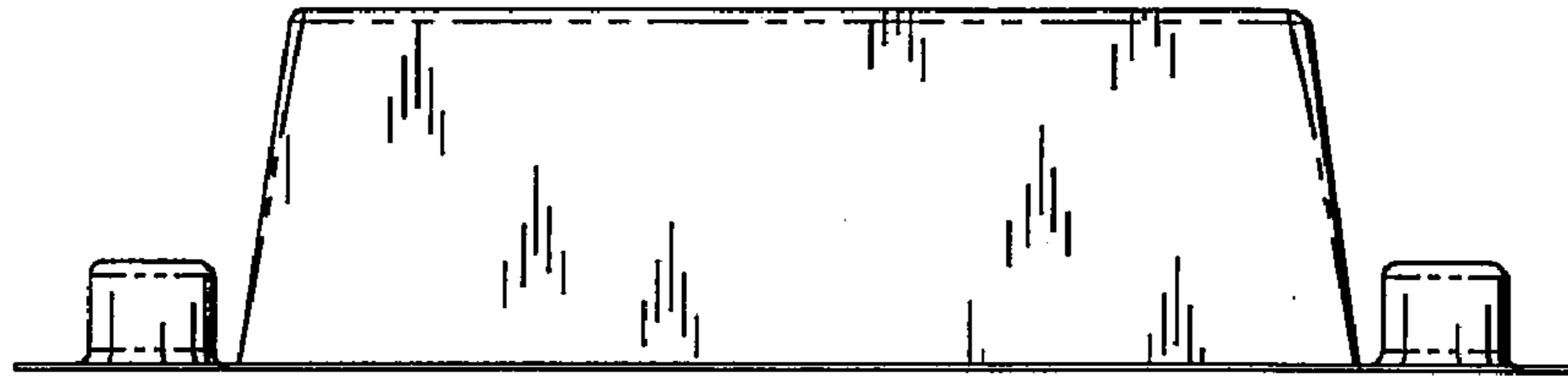

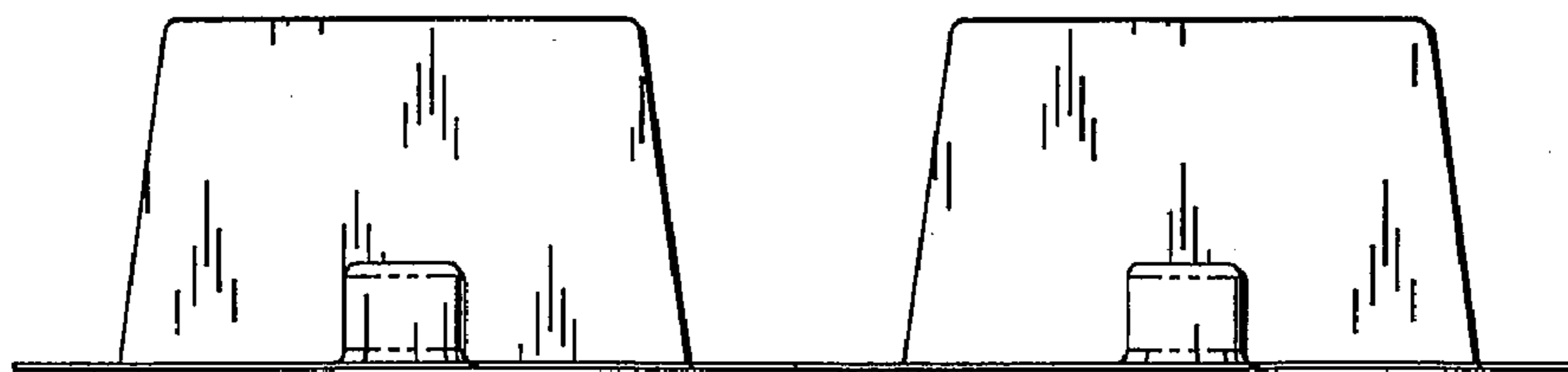

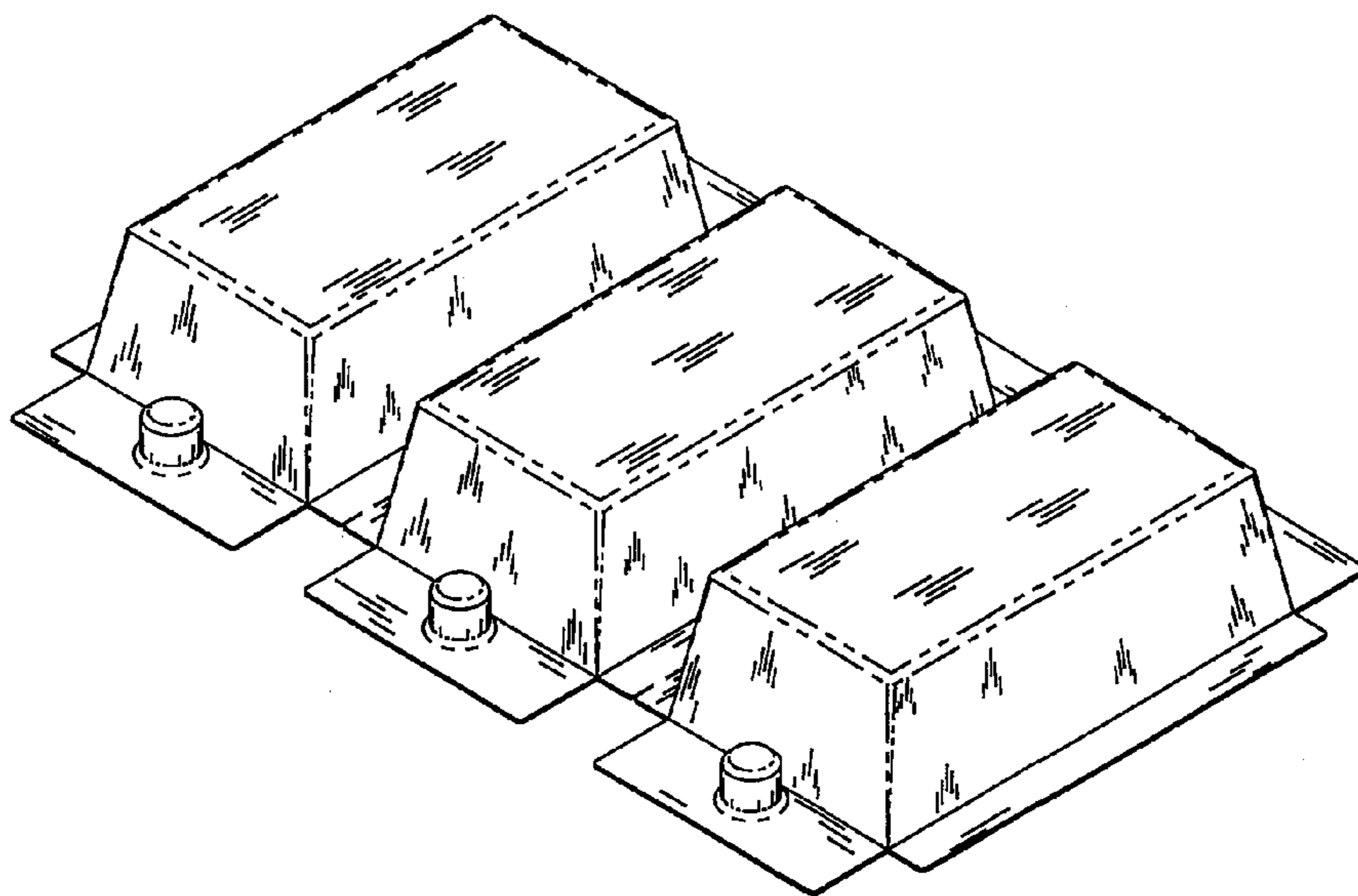

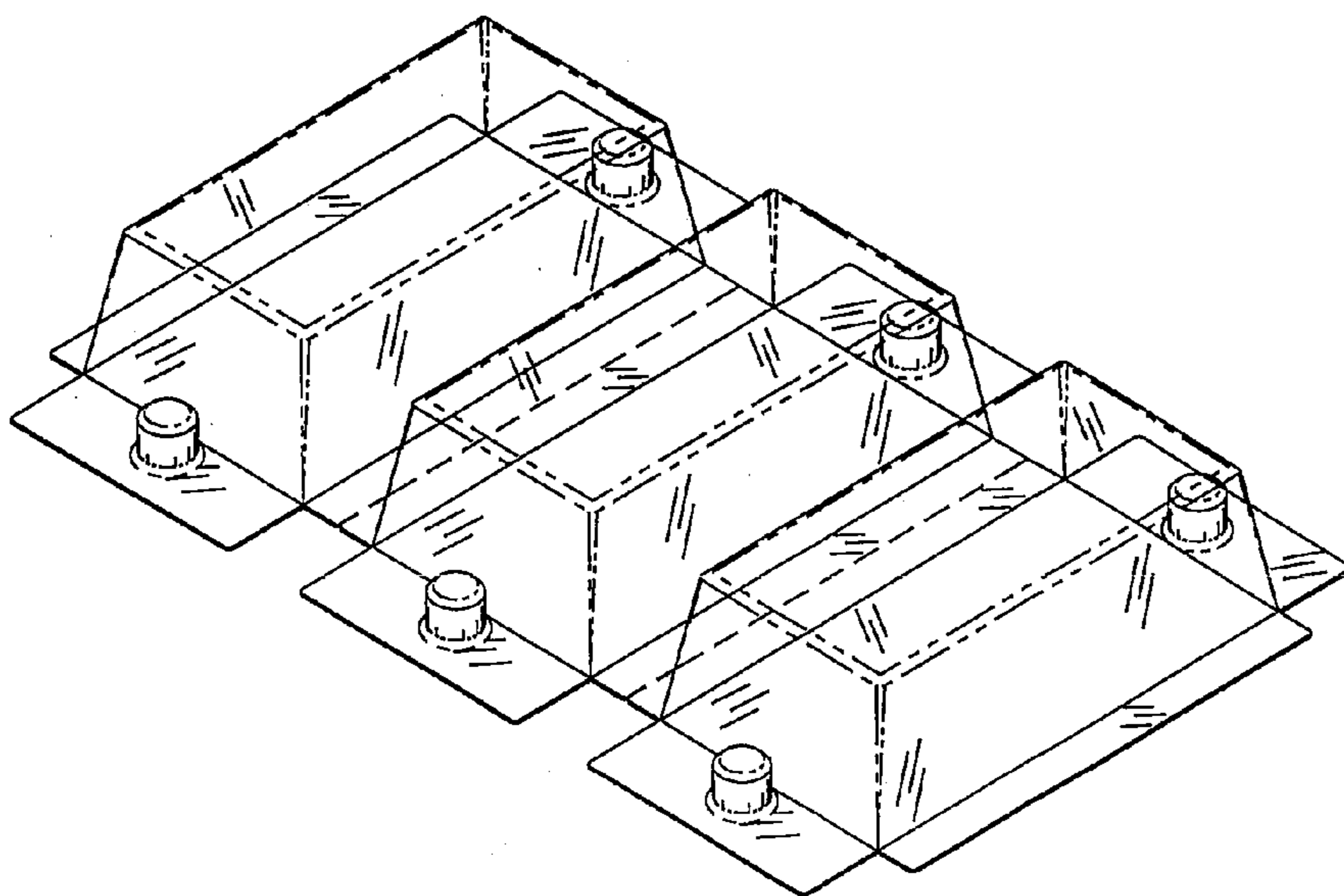

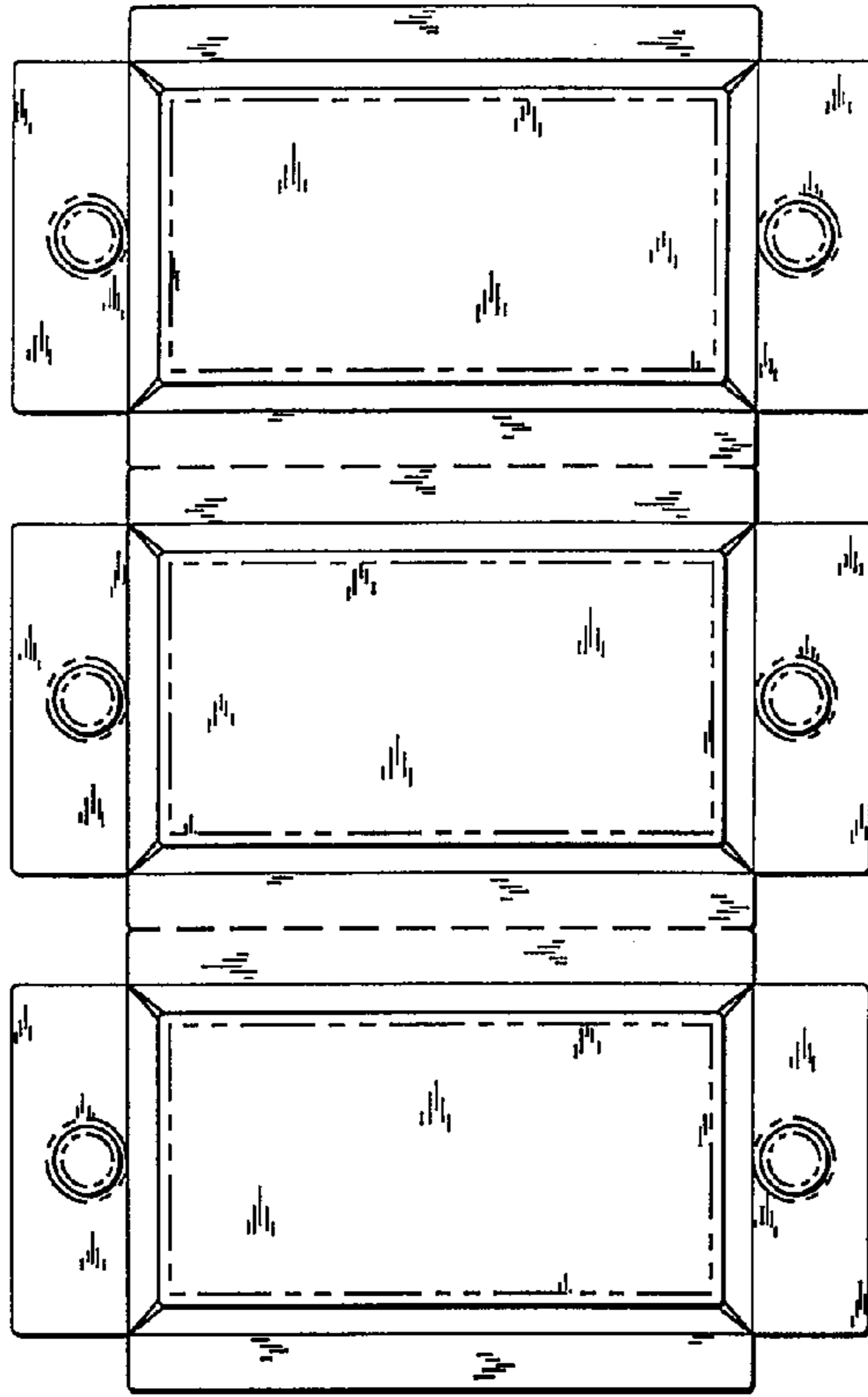

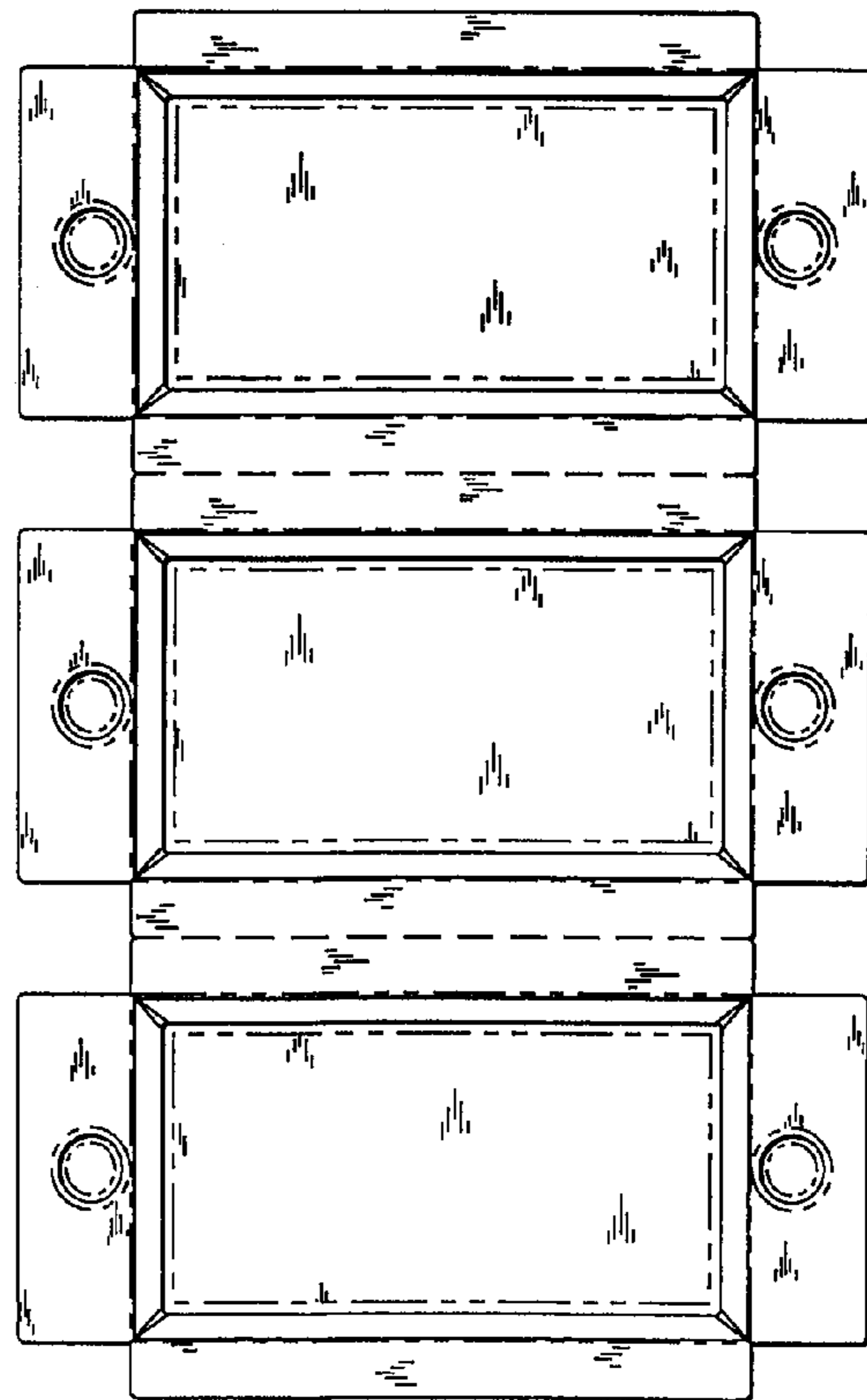

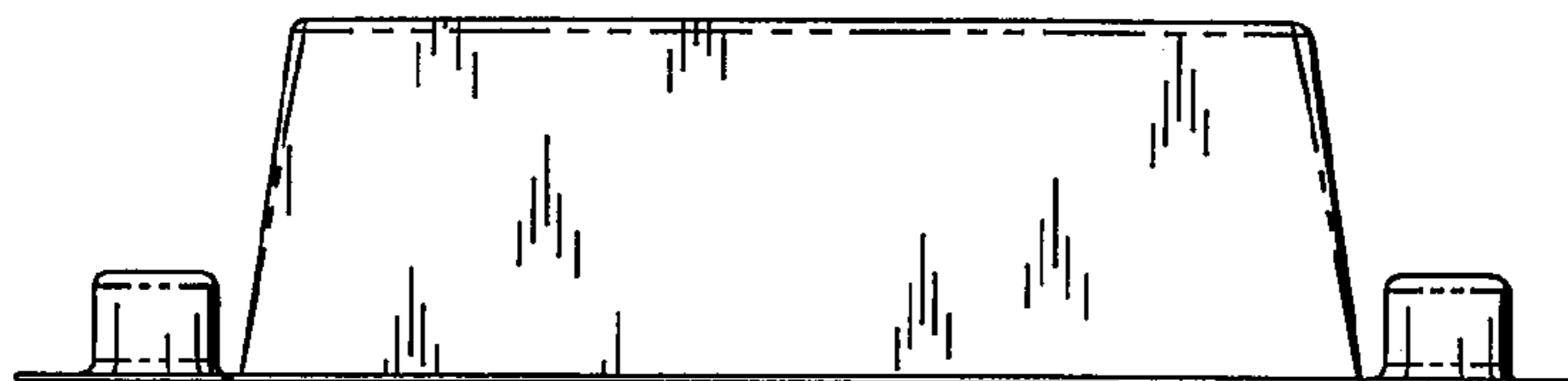

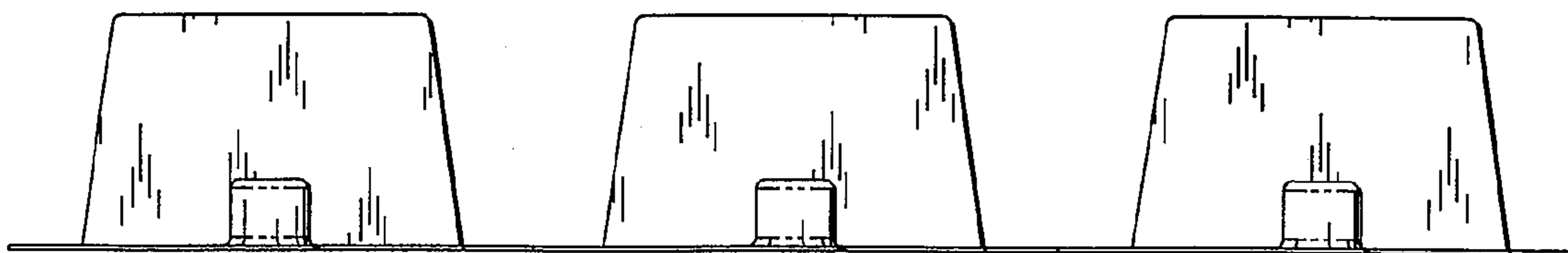

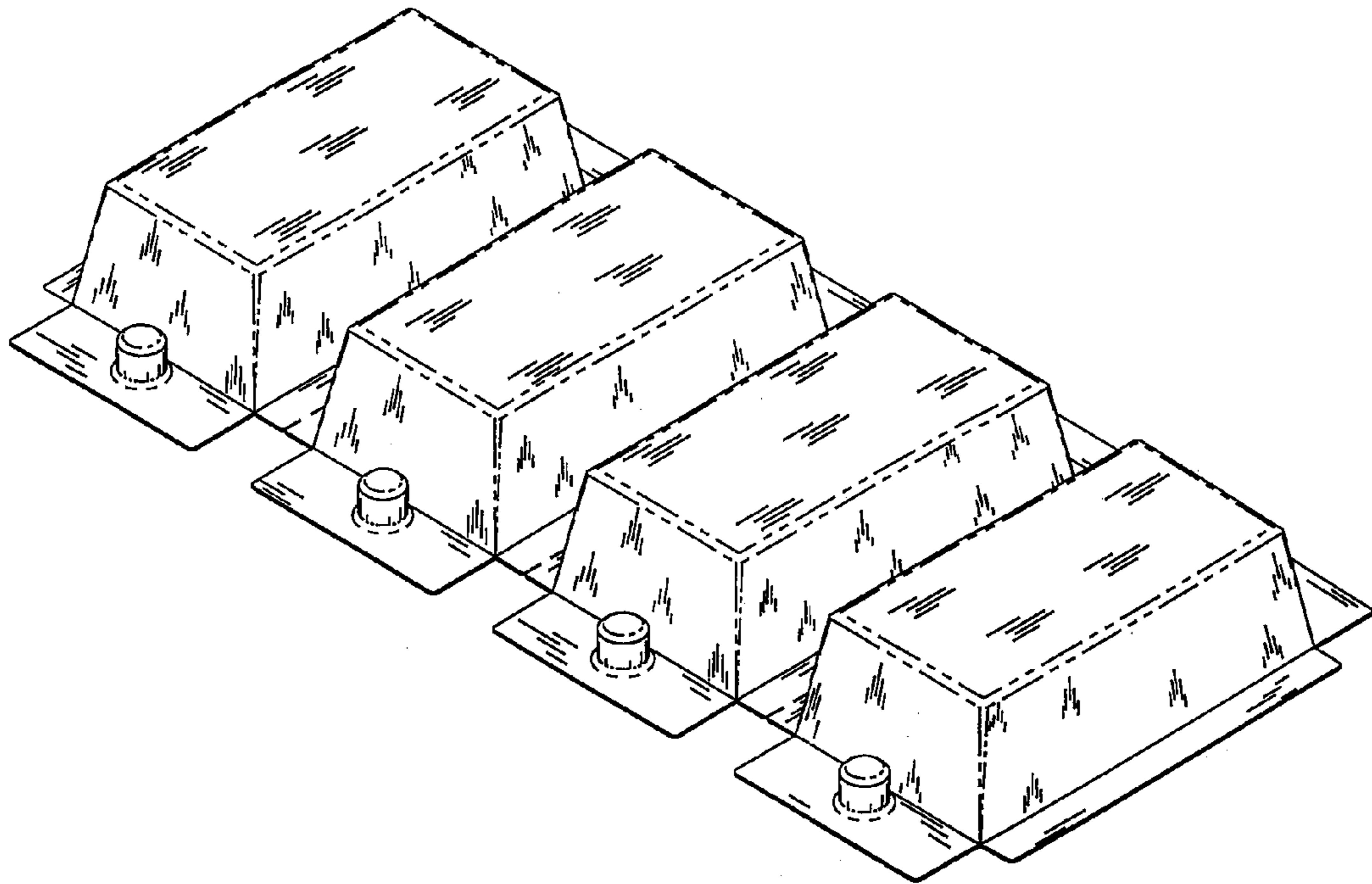

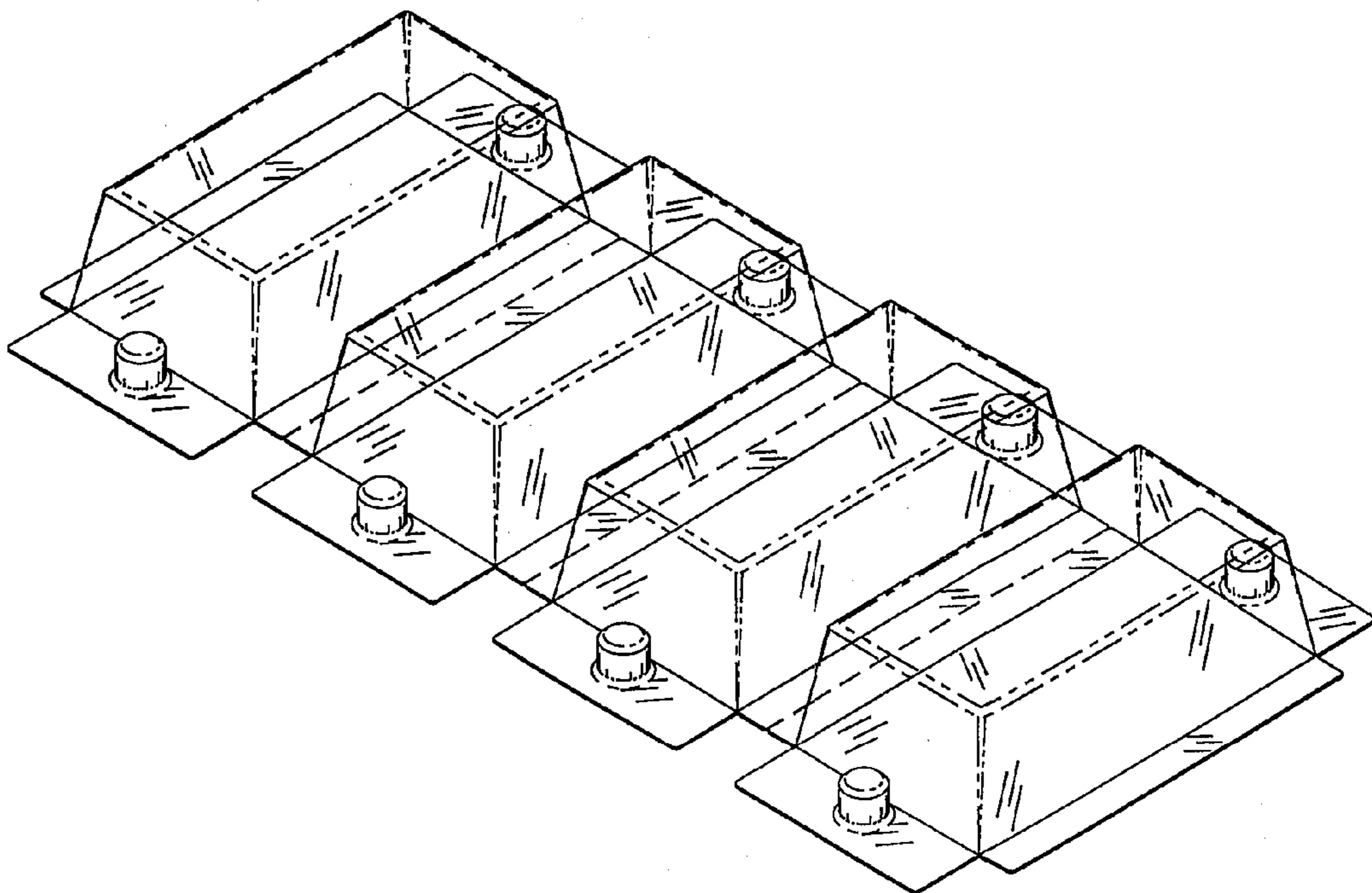

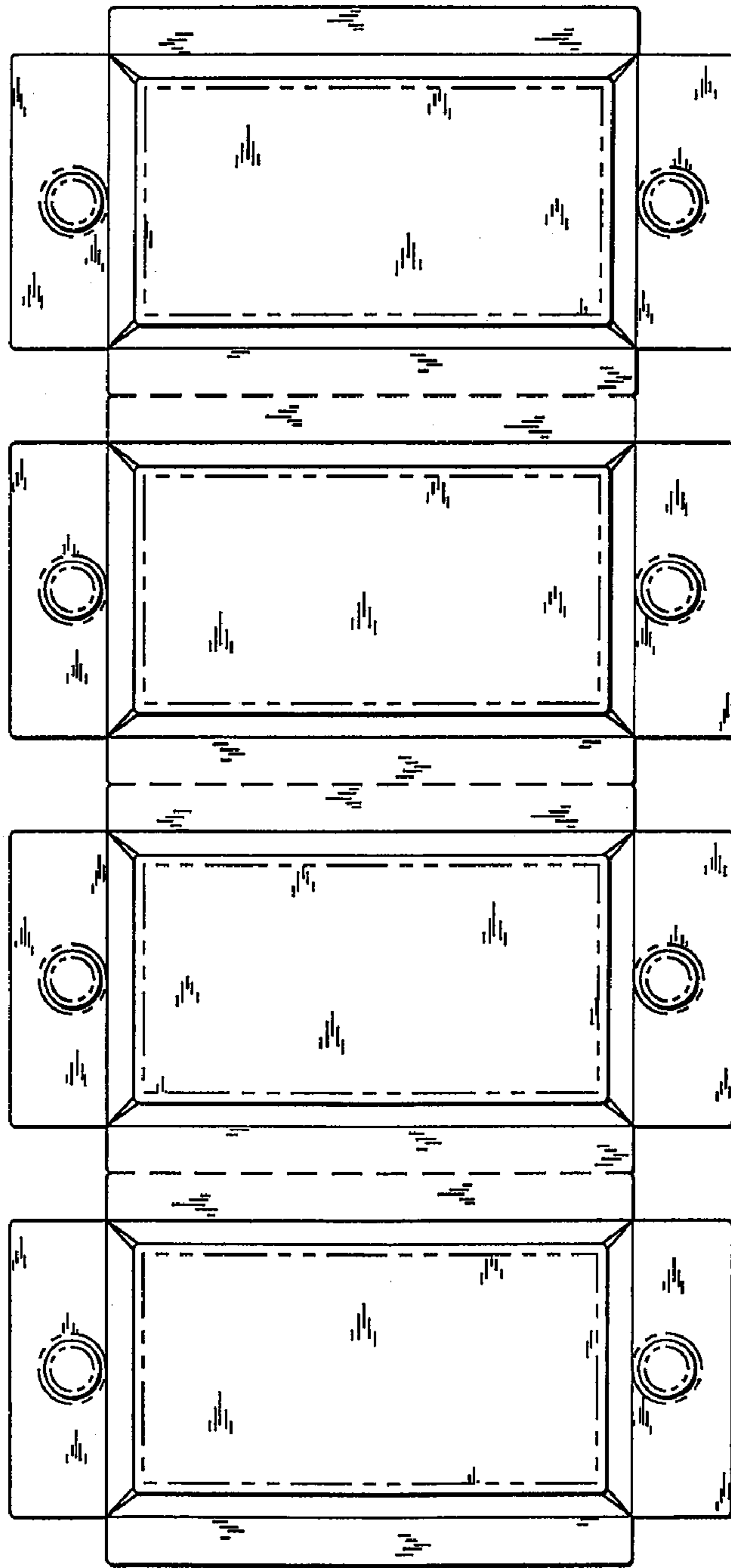

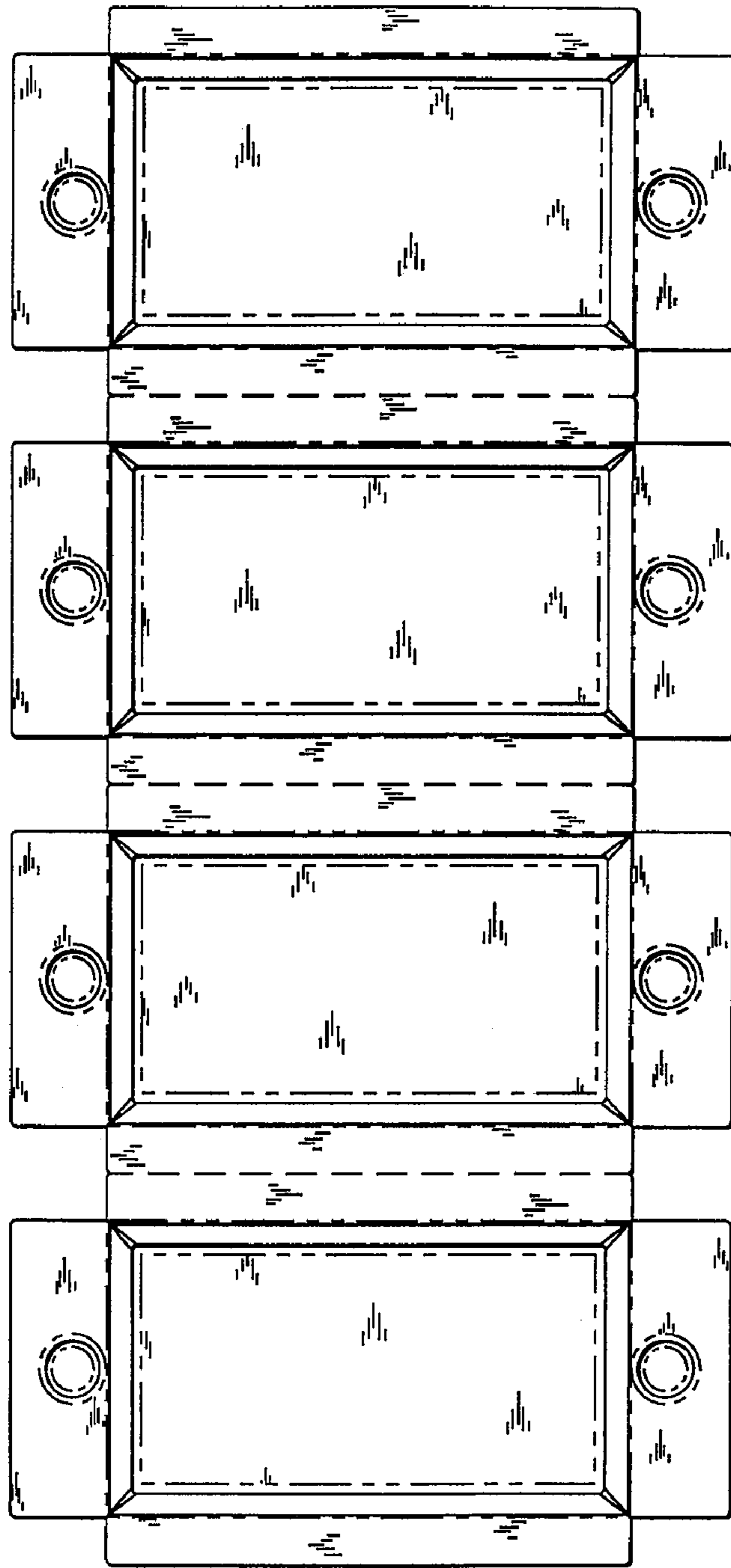

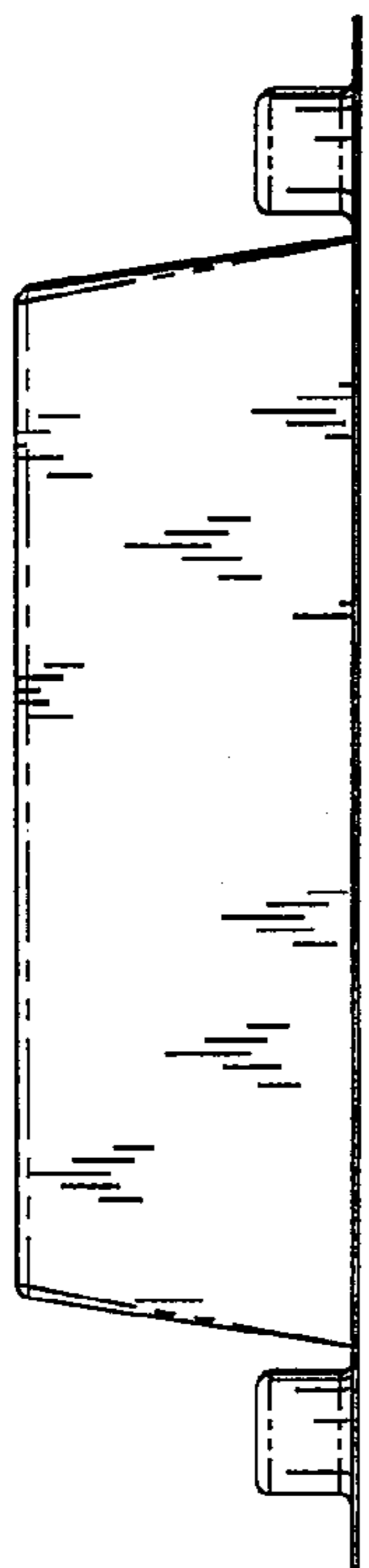

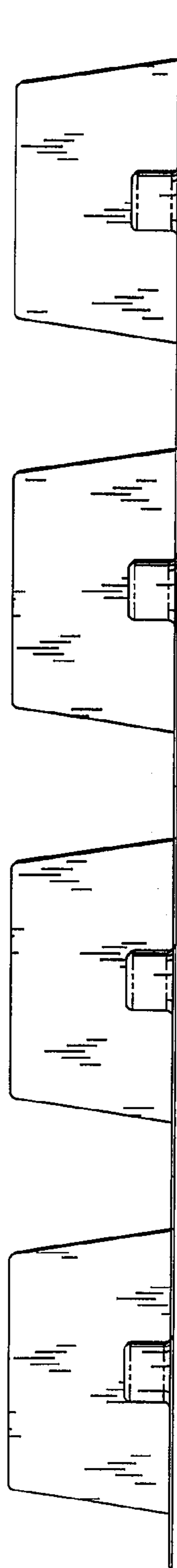
