FIG. 7 is a bottom plan view thereof; and,

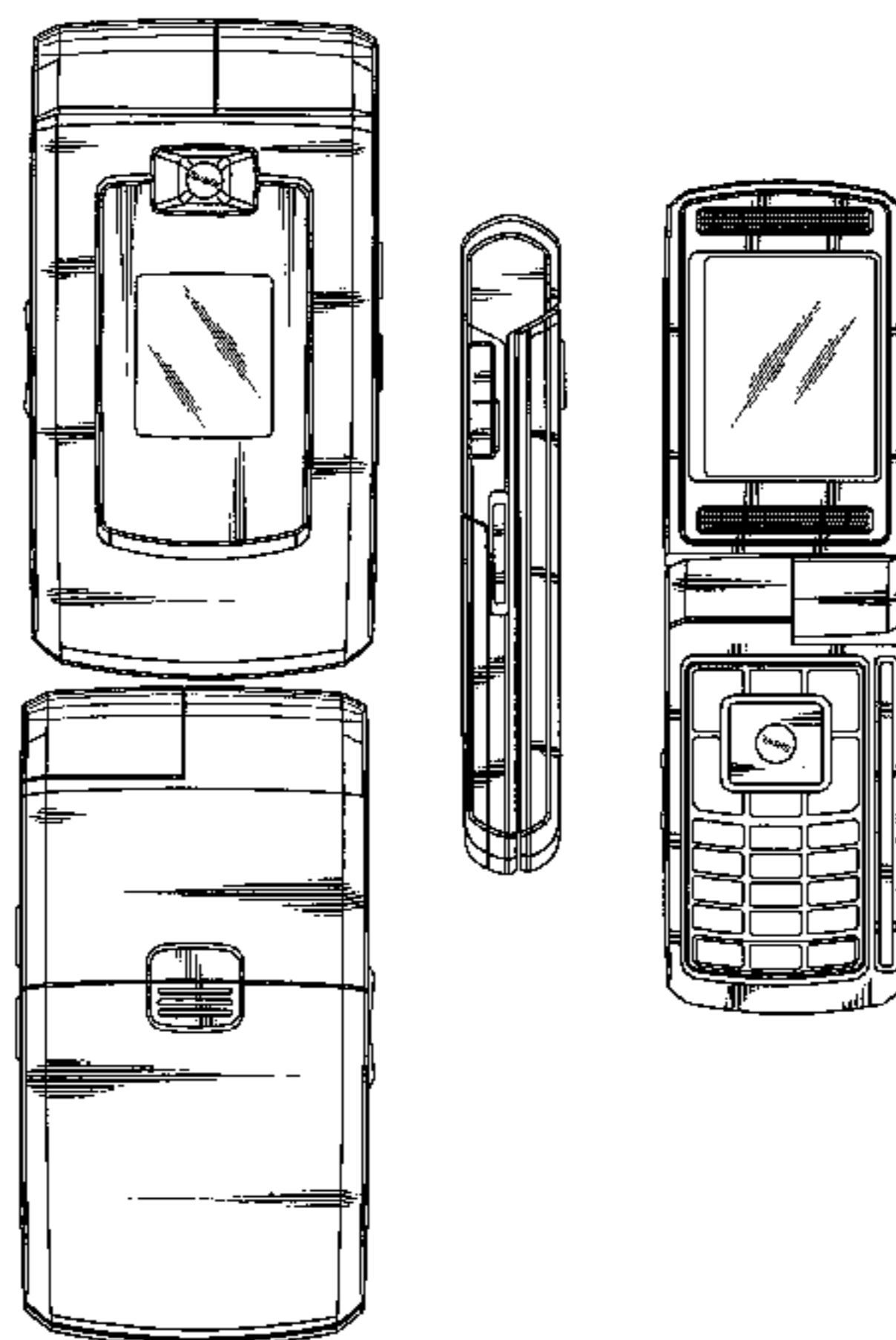
FIG. 8 is a front elevational view of the cellular phone according to our new design in a state in which the folder of the cellular phone is opened upward.

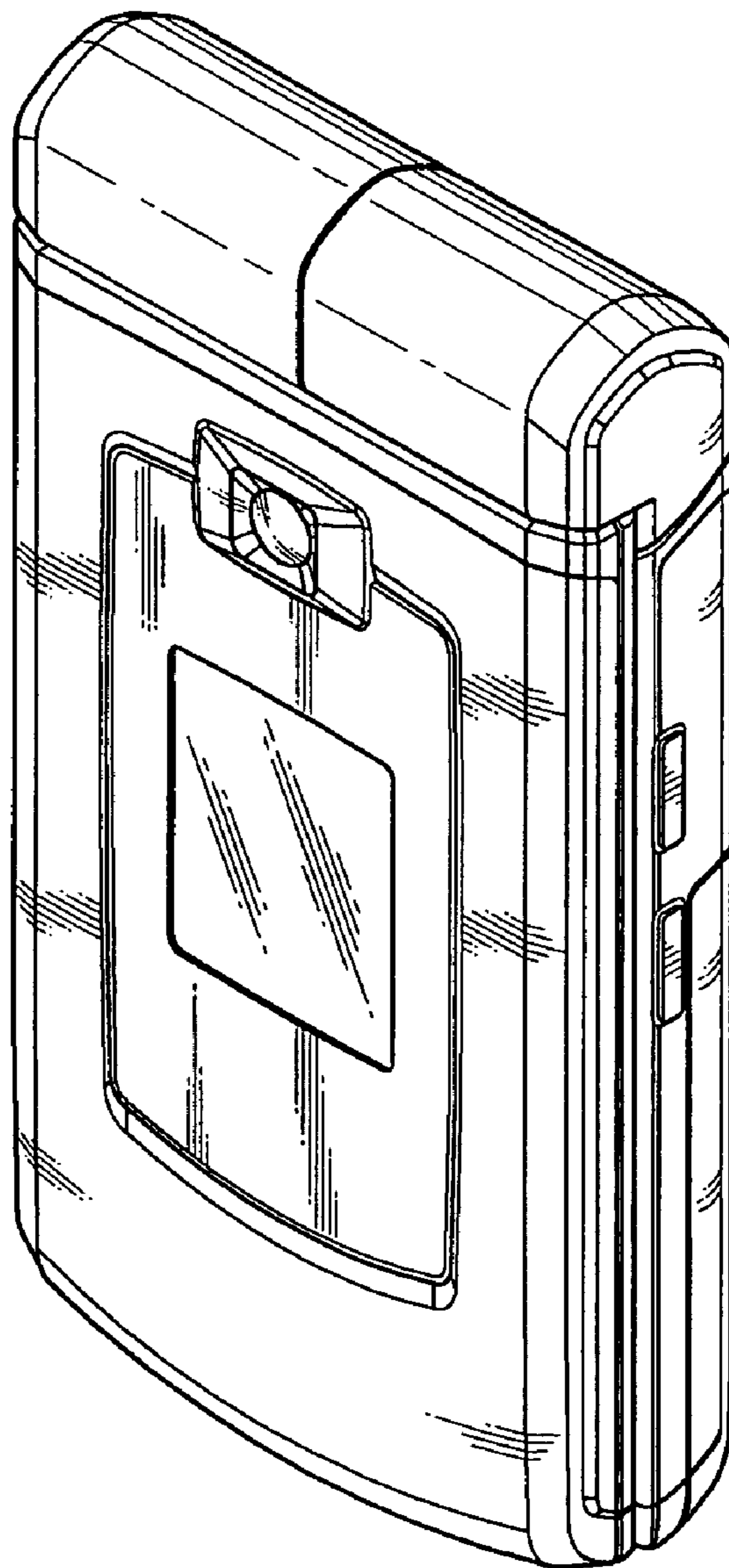

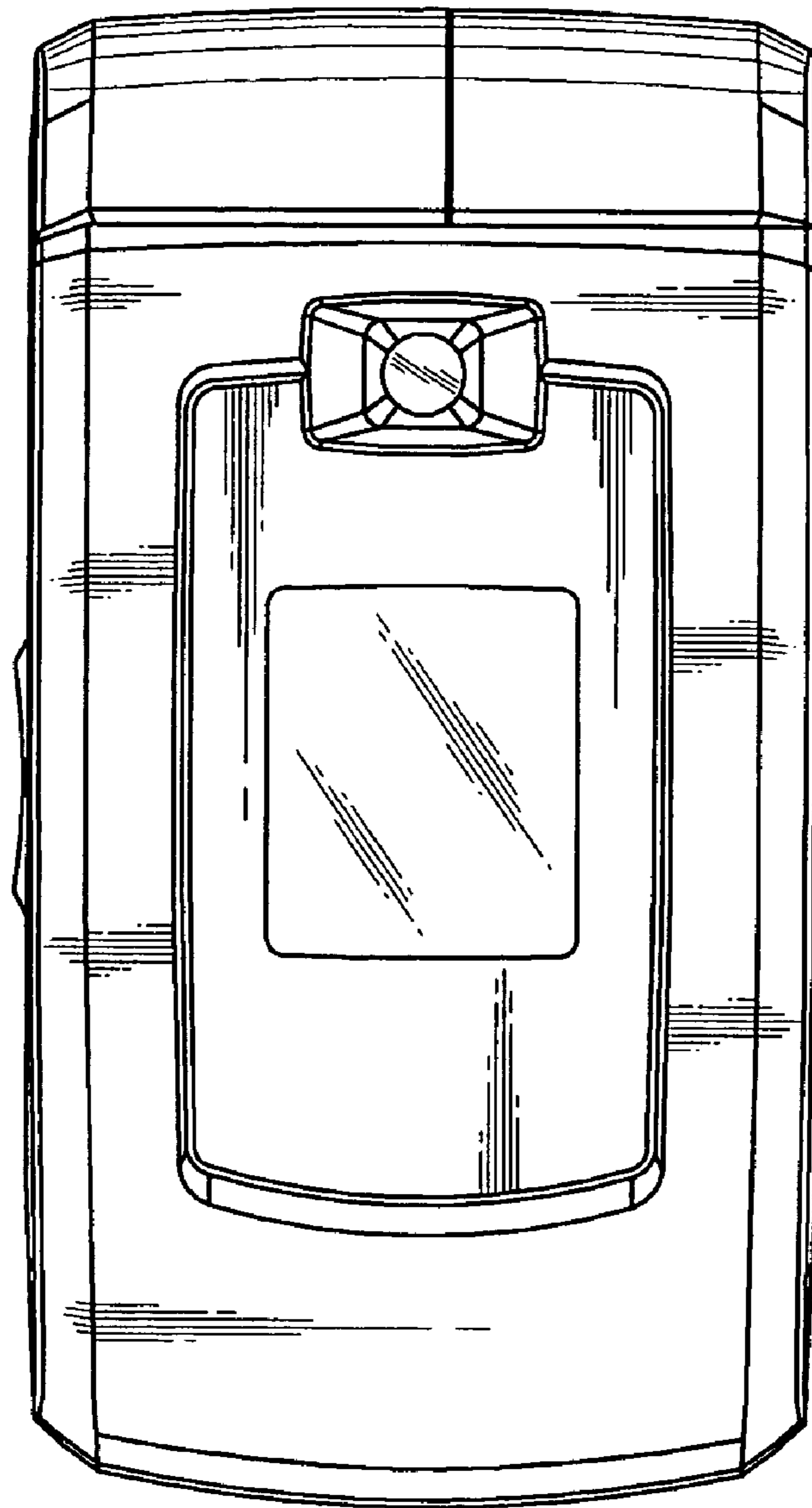

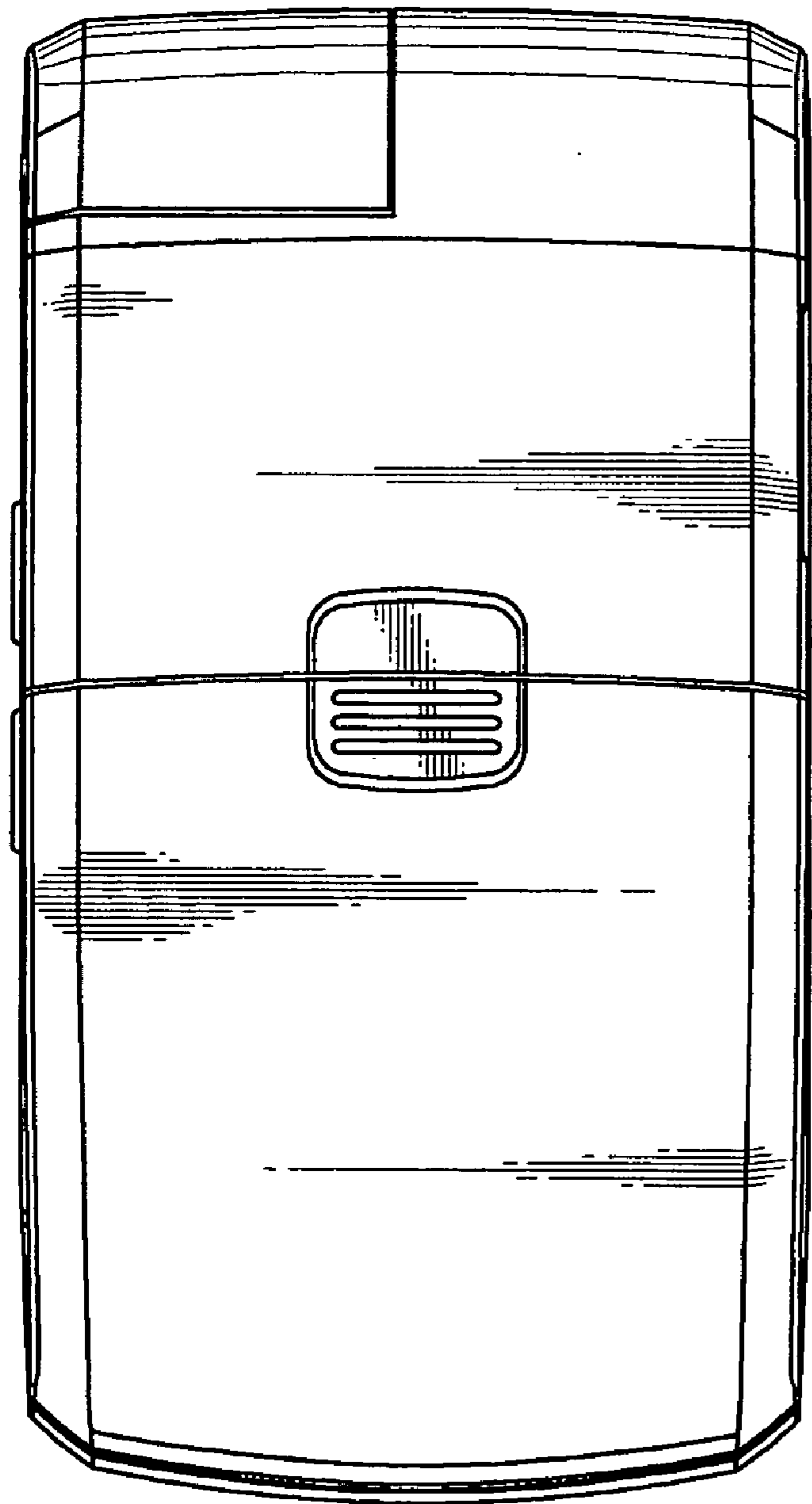

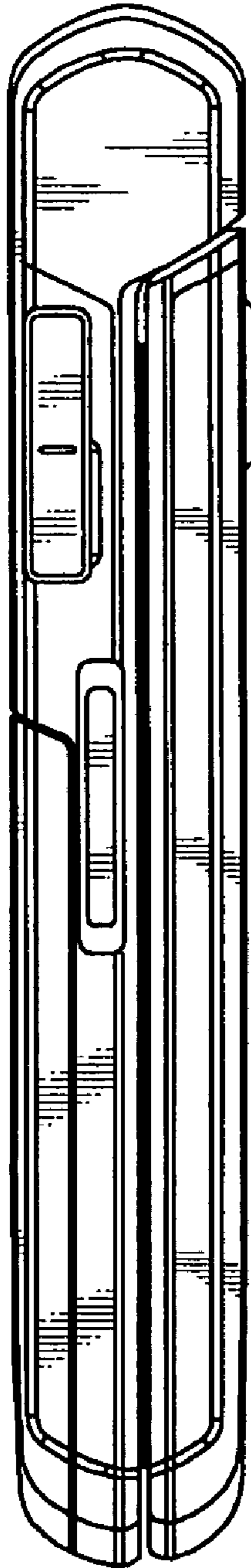

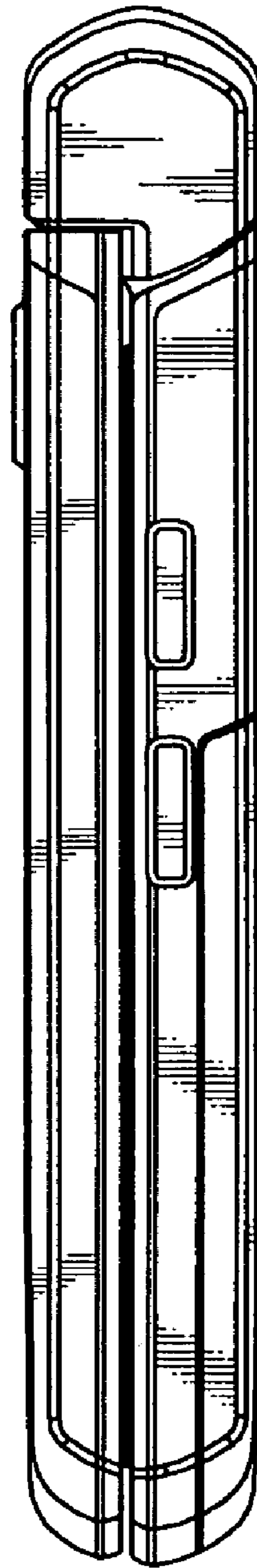

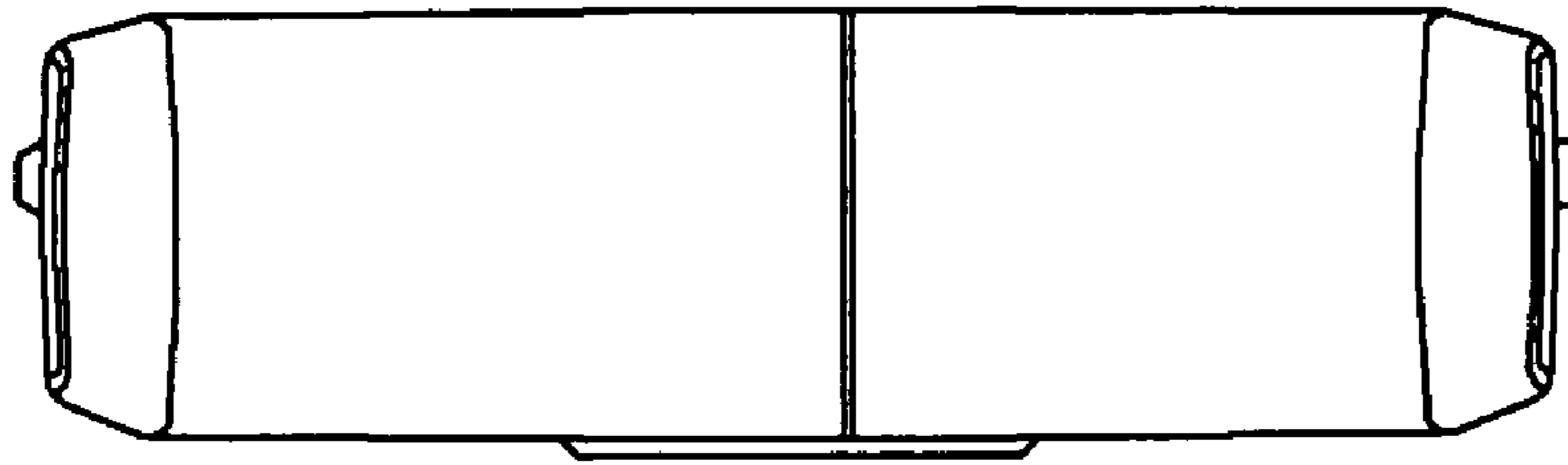

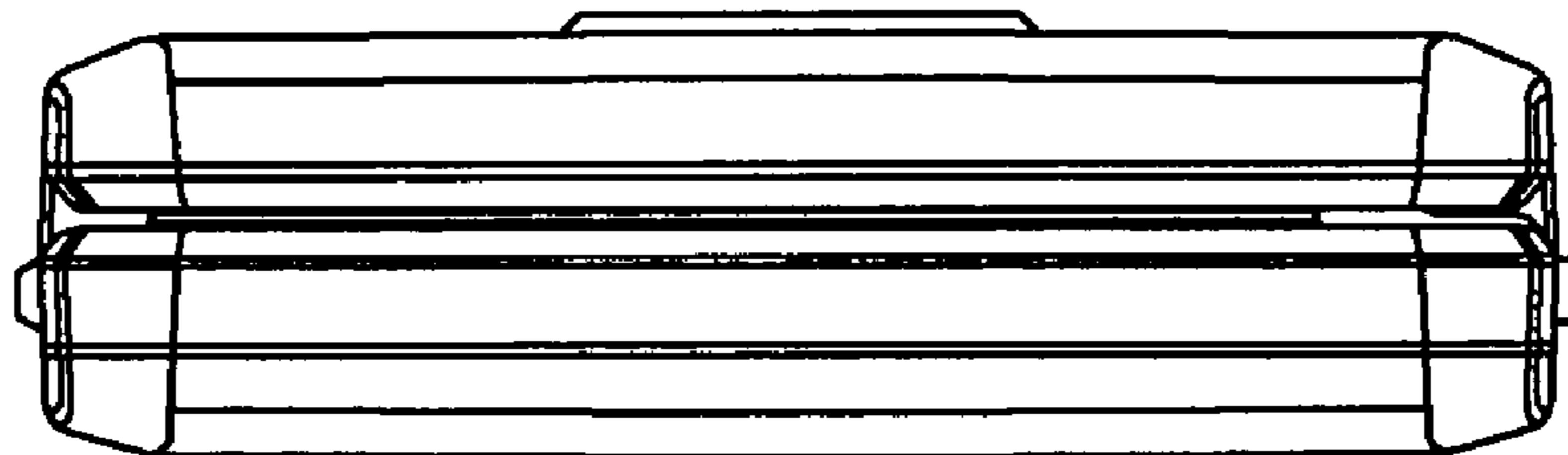
