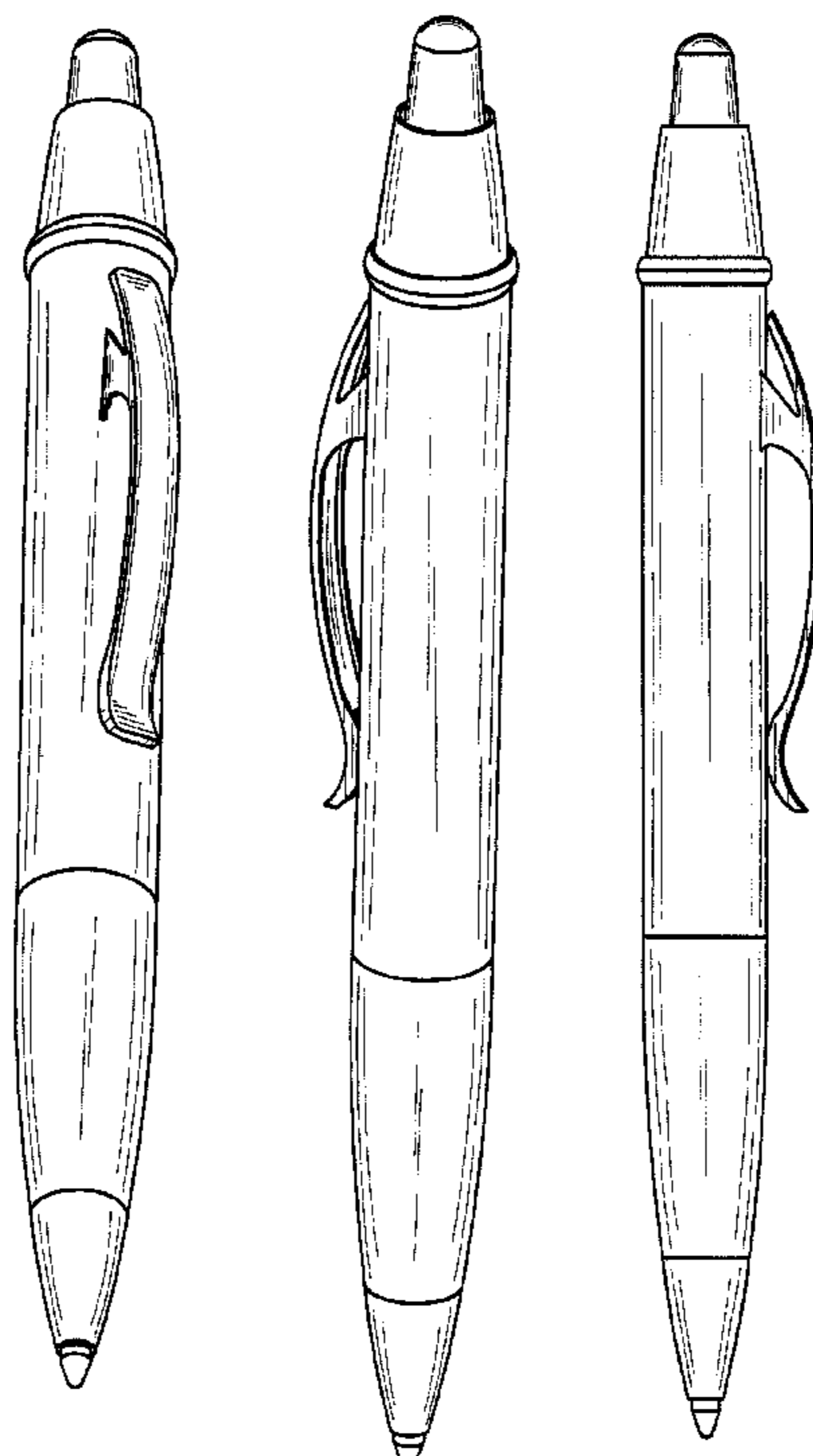
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front left perspective view of a pen showing our new design;
FIG. 2 is rear right perspective view of the pen shown in FIG. 1;
FIG. 3 left side elevation view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a front elevation view thereof;

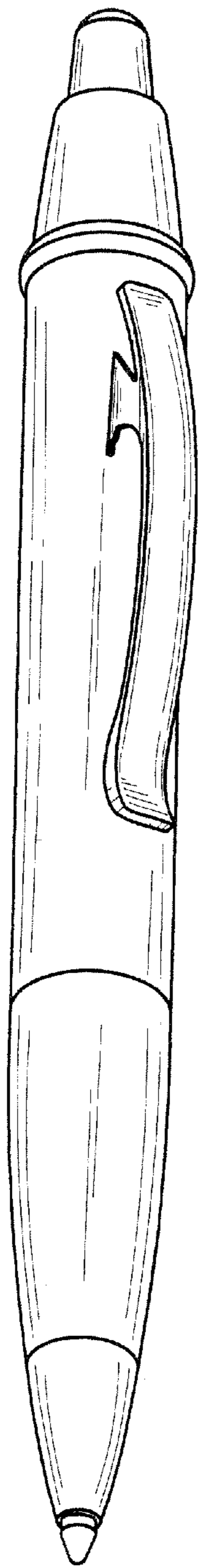

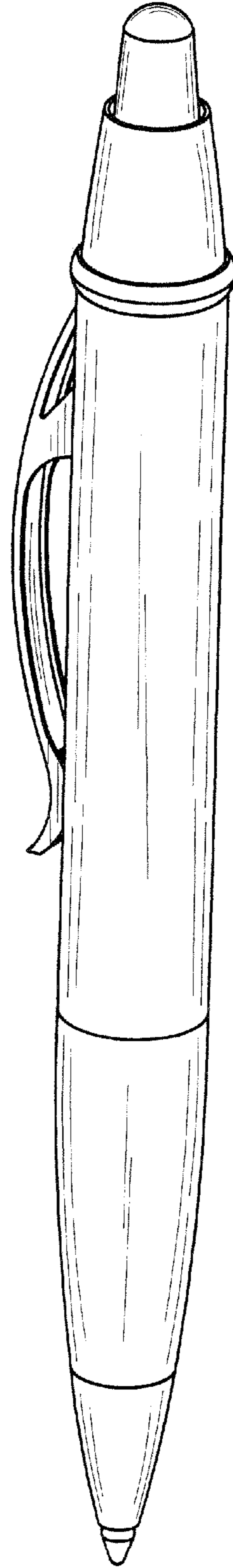

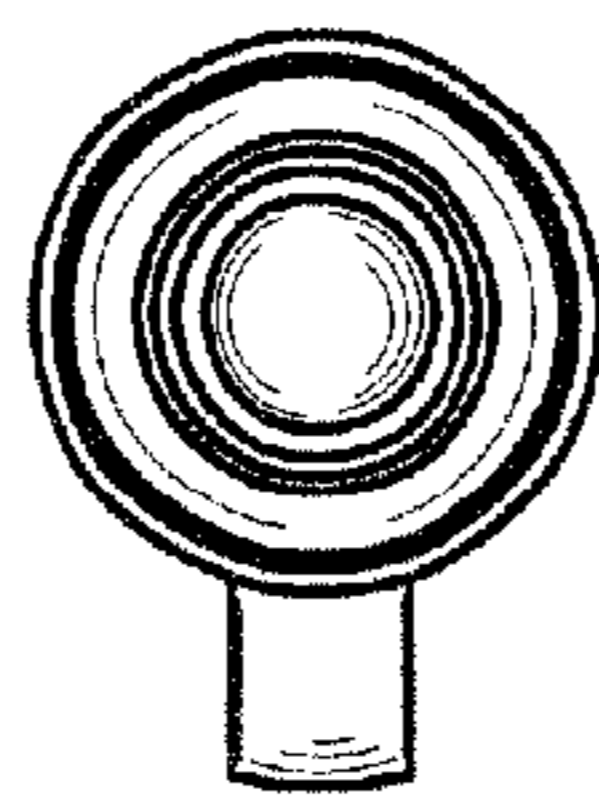
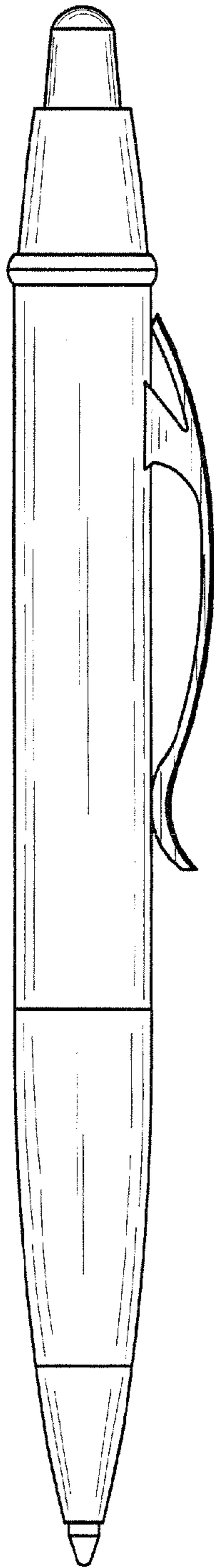
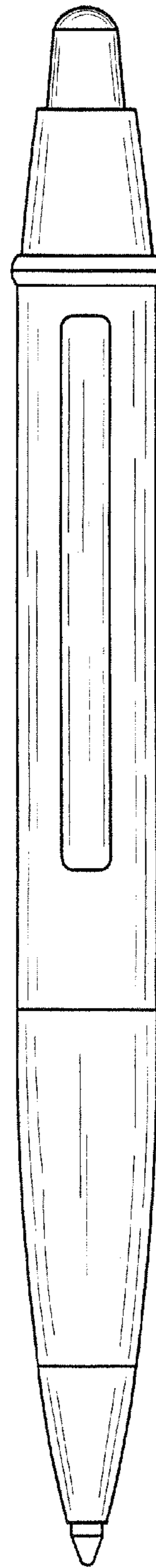

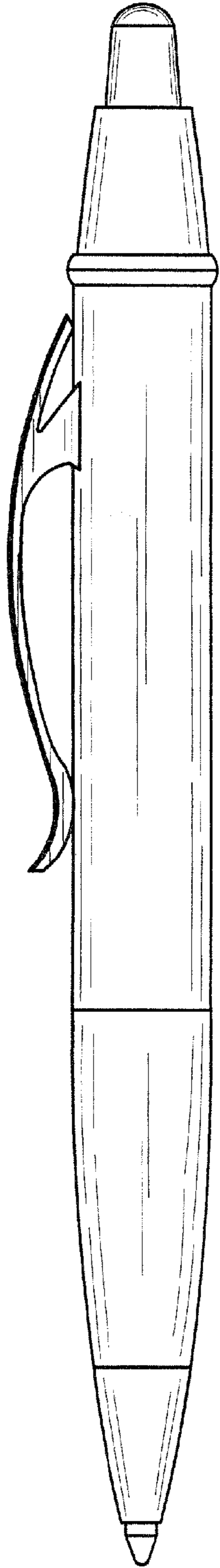

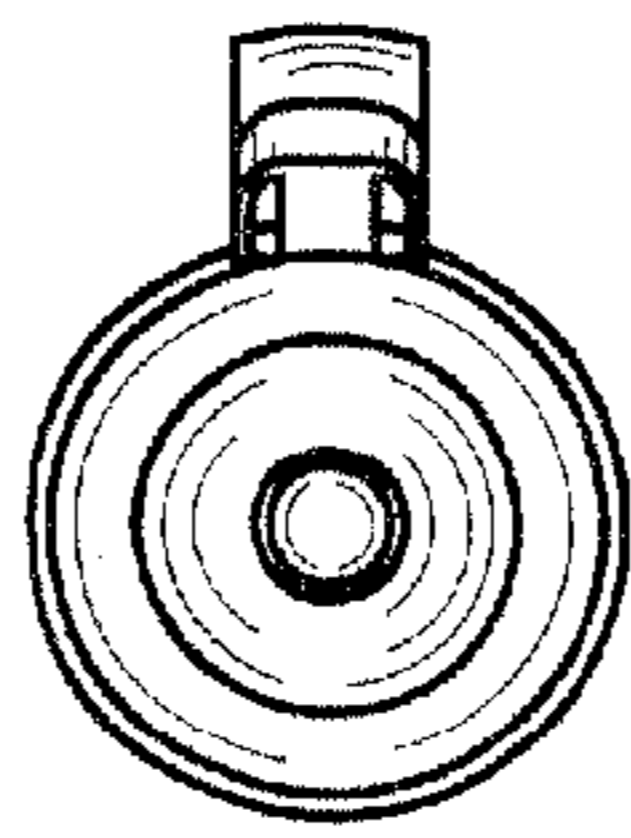

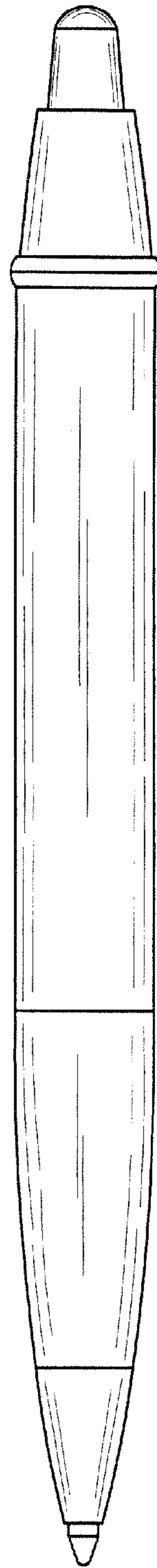
