(57) **CLAIM**

The ornamental design for a rocking toothbrush sanitizer, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a rocking toothbrush sanitizer of the present invention;

FIG. 2 is another perspective thereof;

FIG. 3 is a reduced front elevation view thereof showing without the environment;

FIG. 4 is a reduced rear elevation view thereof showing without the environment;

FIG. 5 is a reduced left side elevation view thereof showing without the environment;

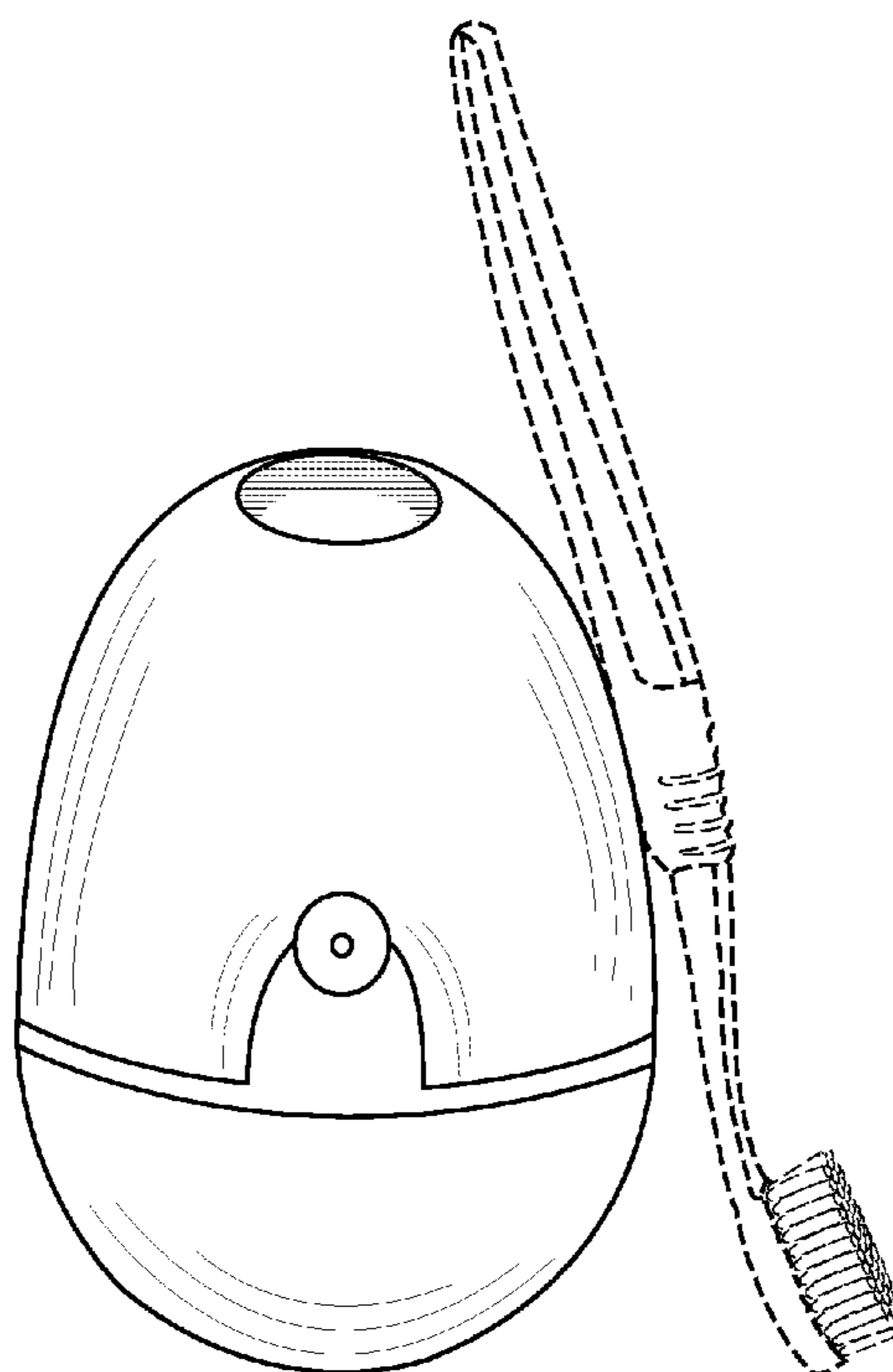
FIG. 6 is a reduced right side elevation view thereof showing without the environment;

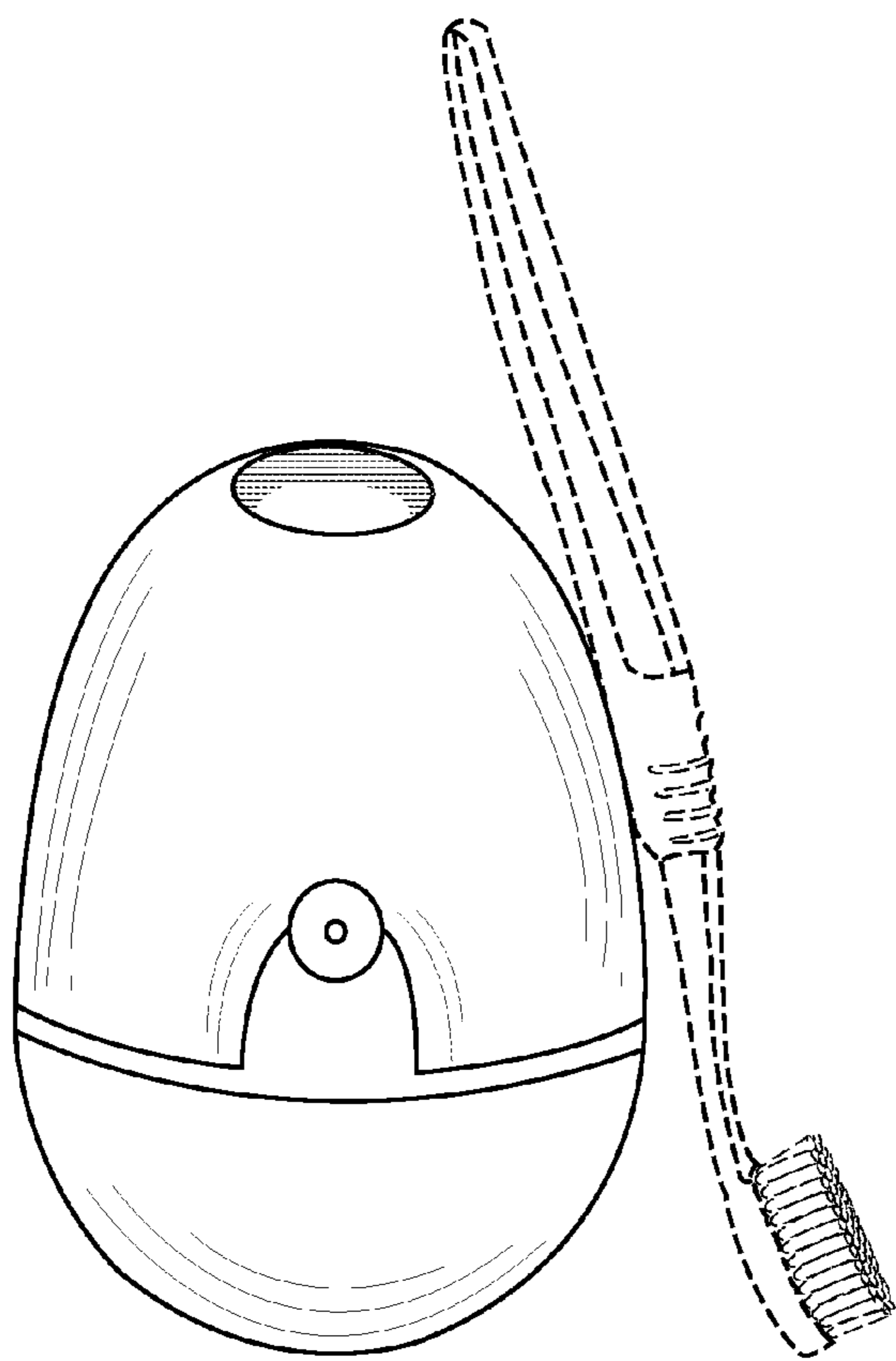

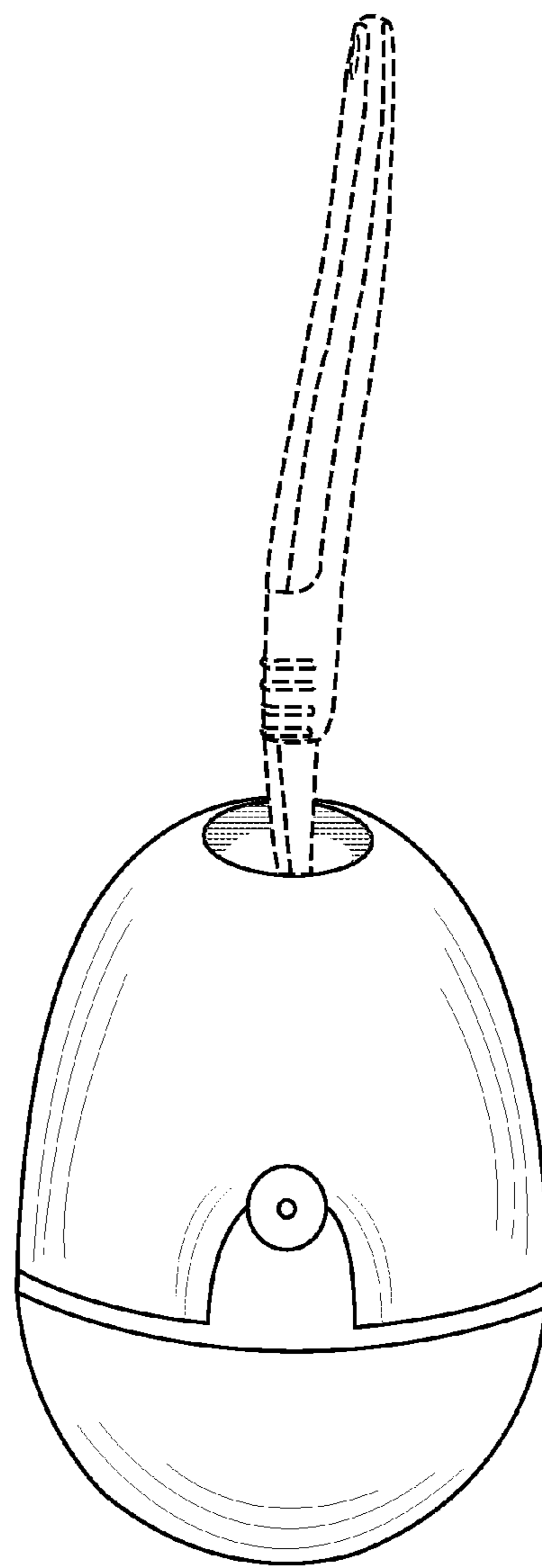

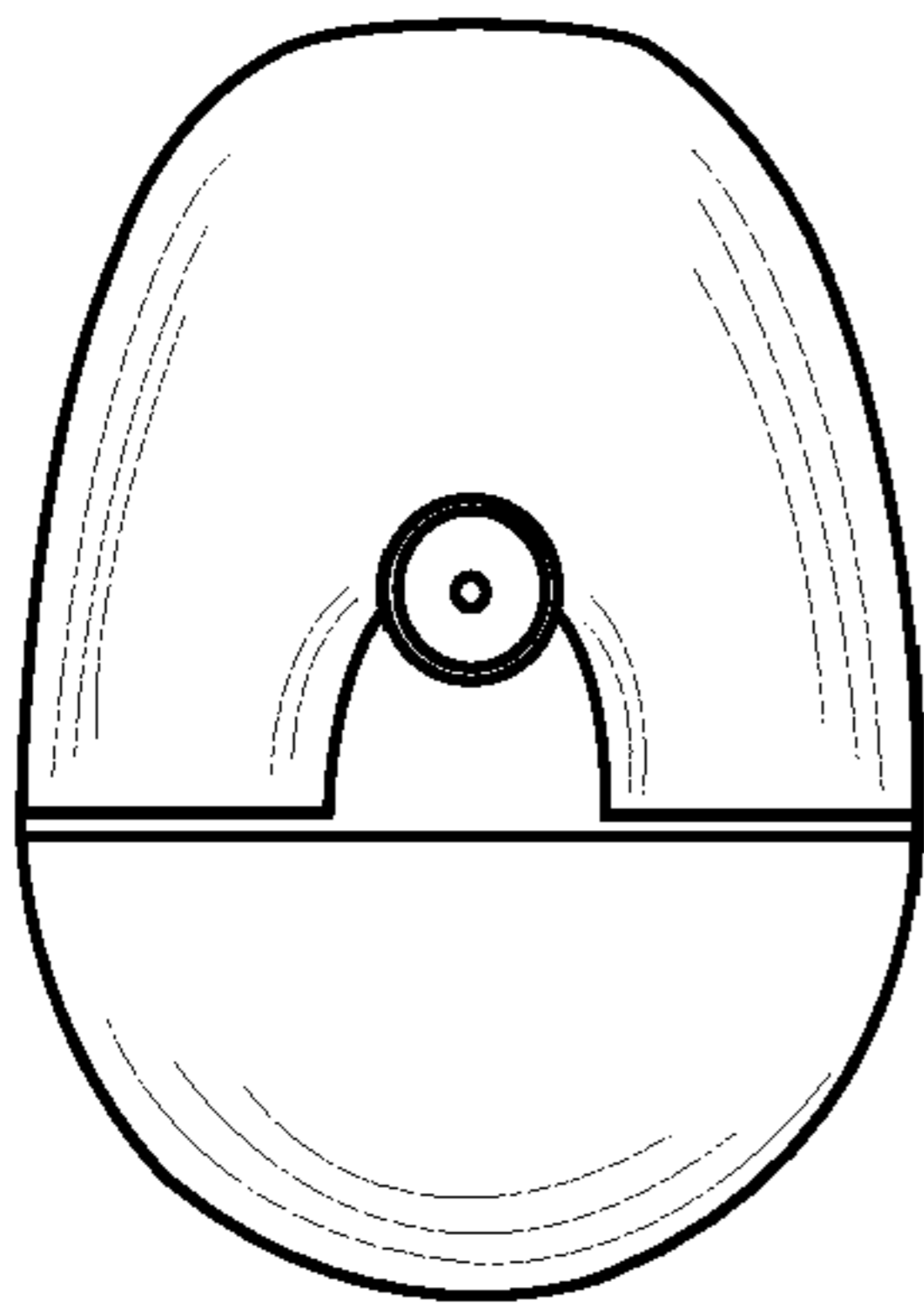

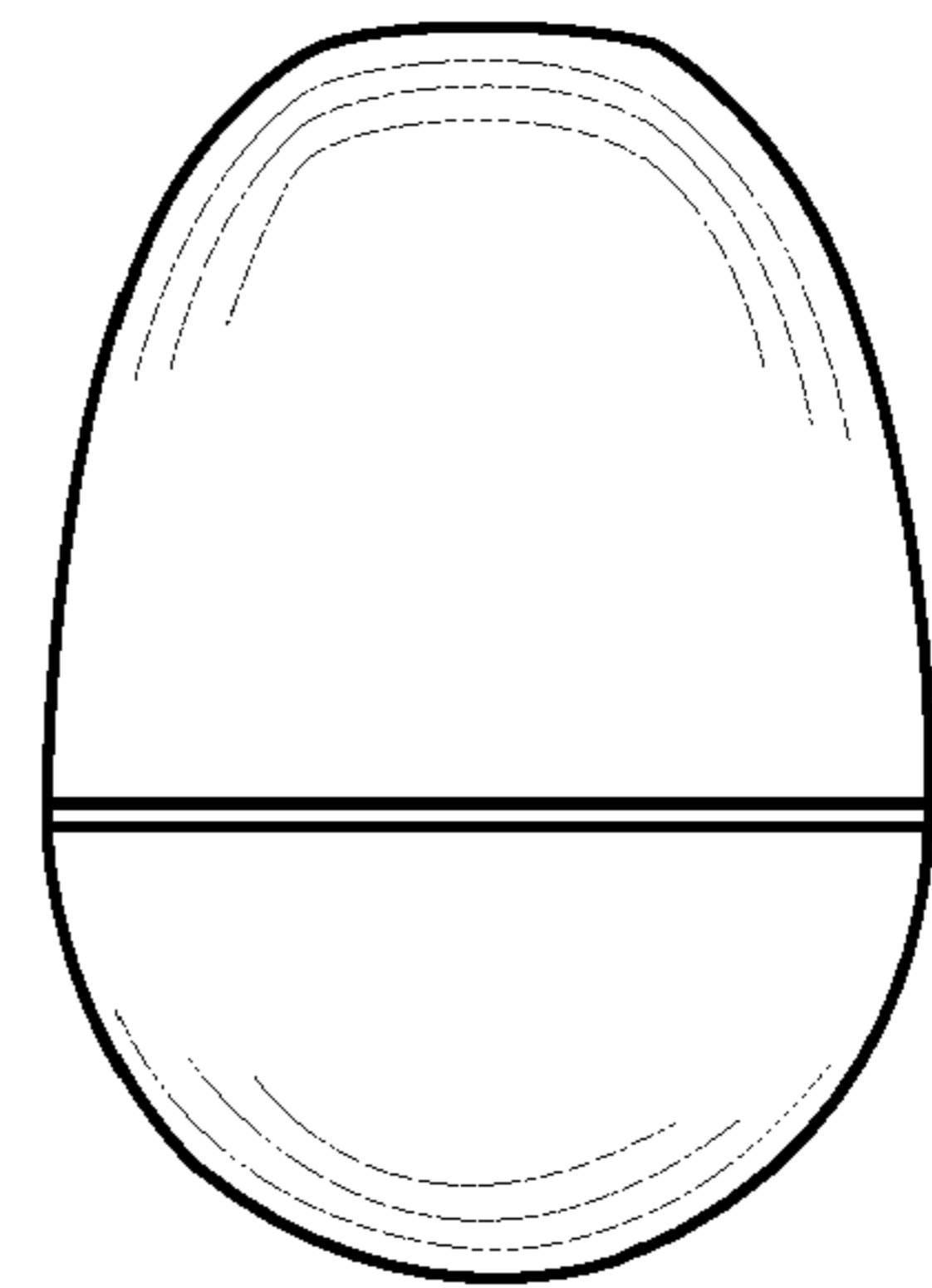

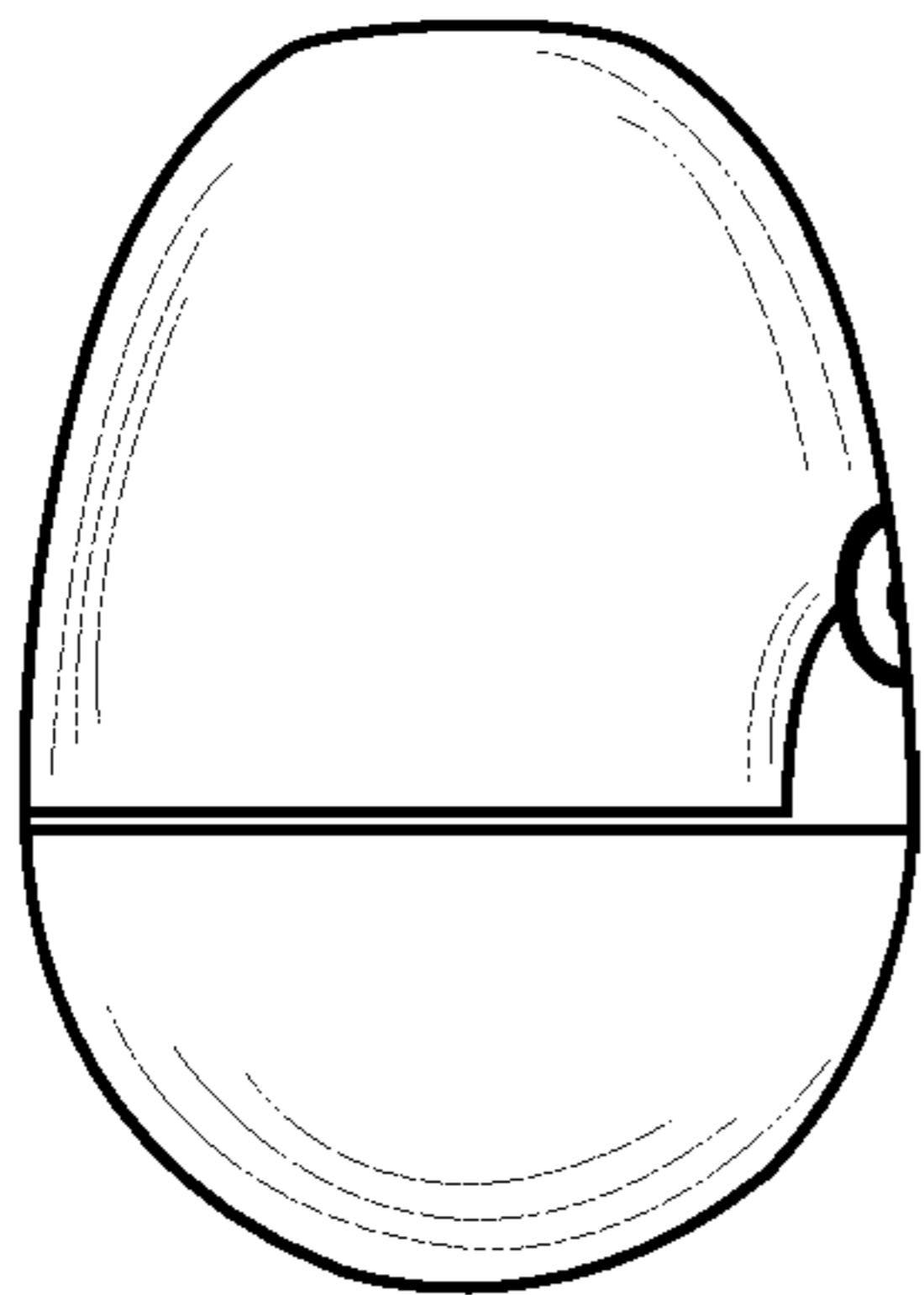

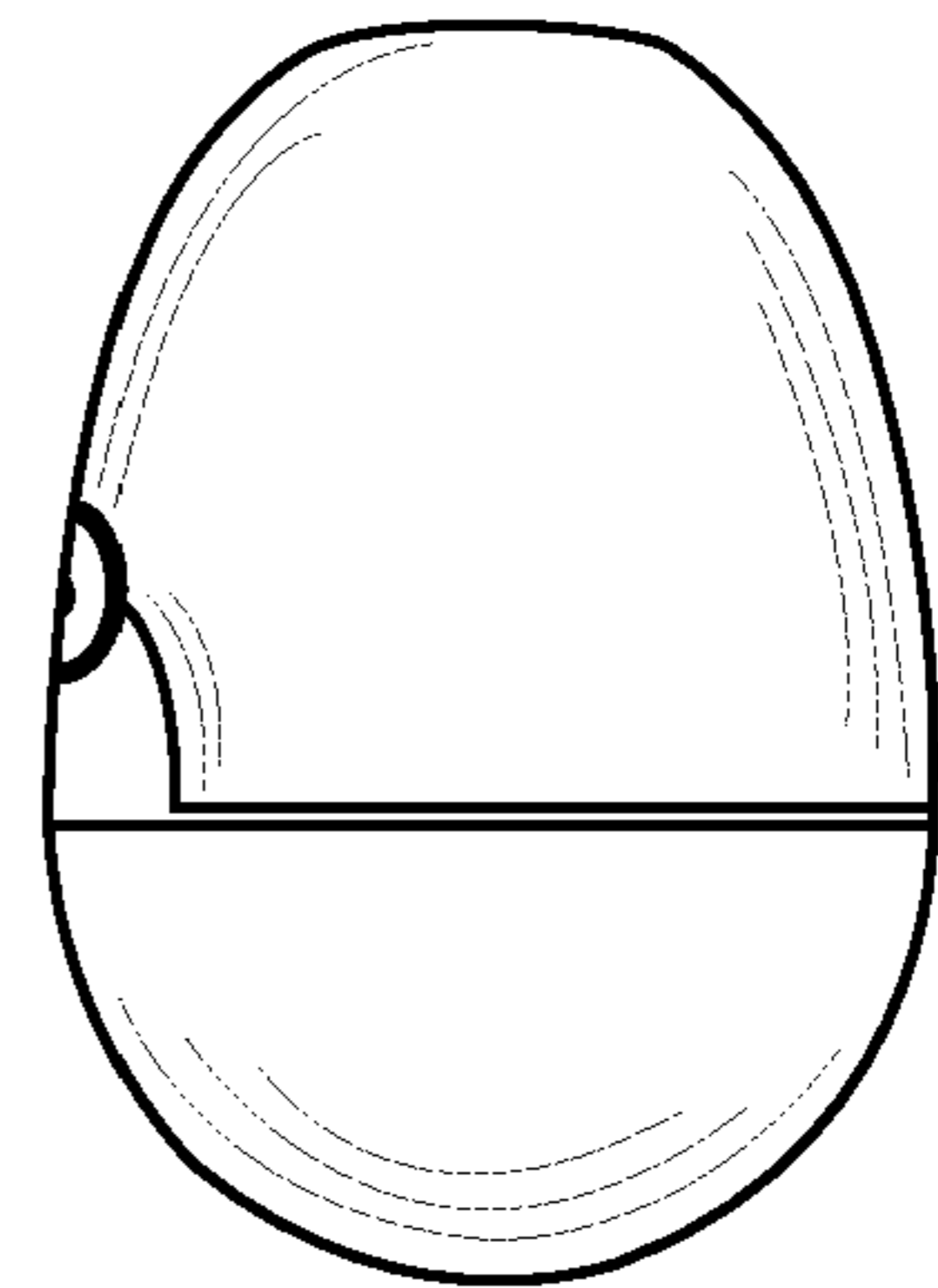

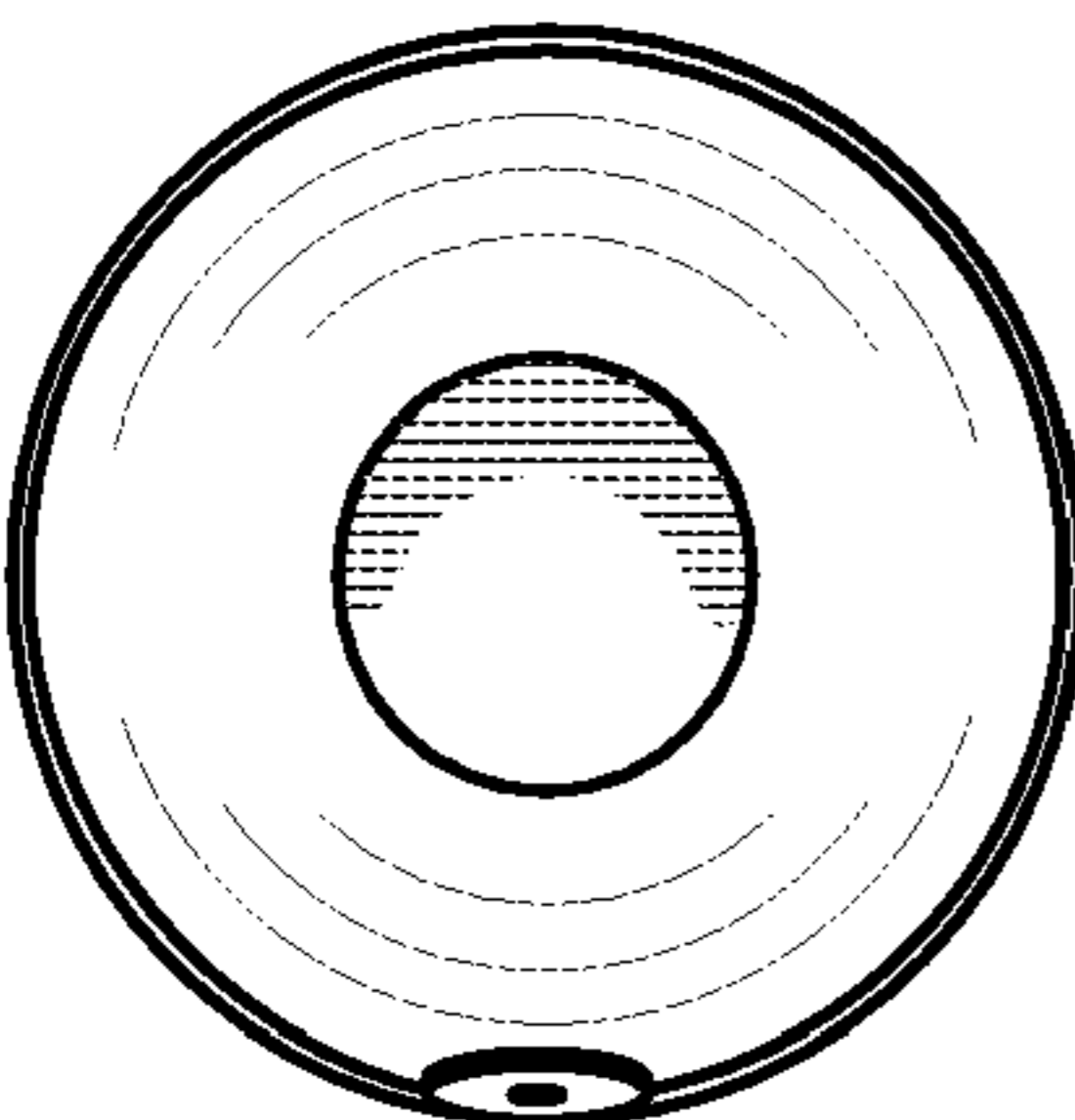

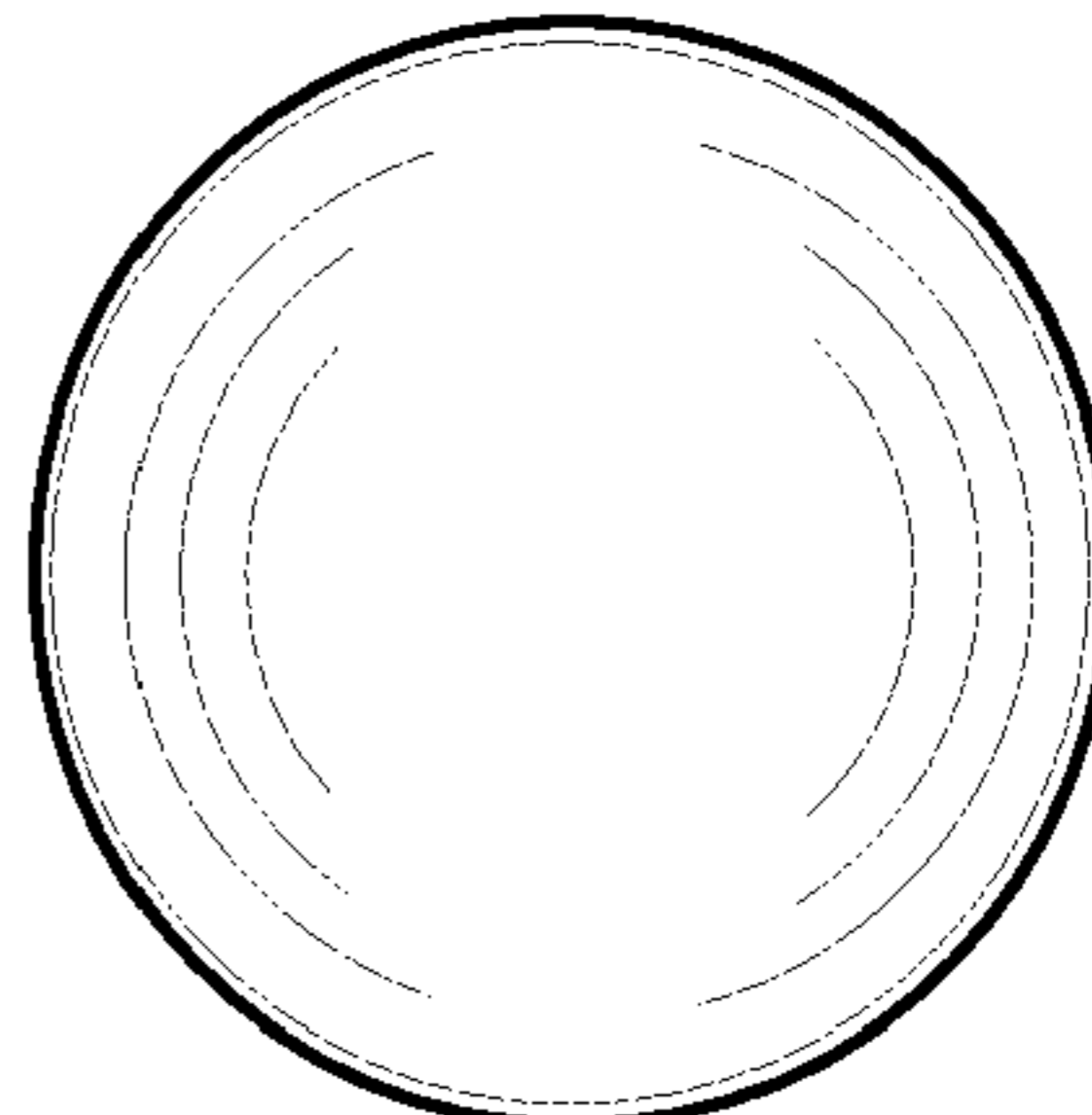
