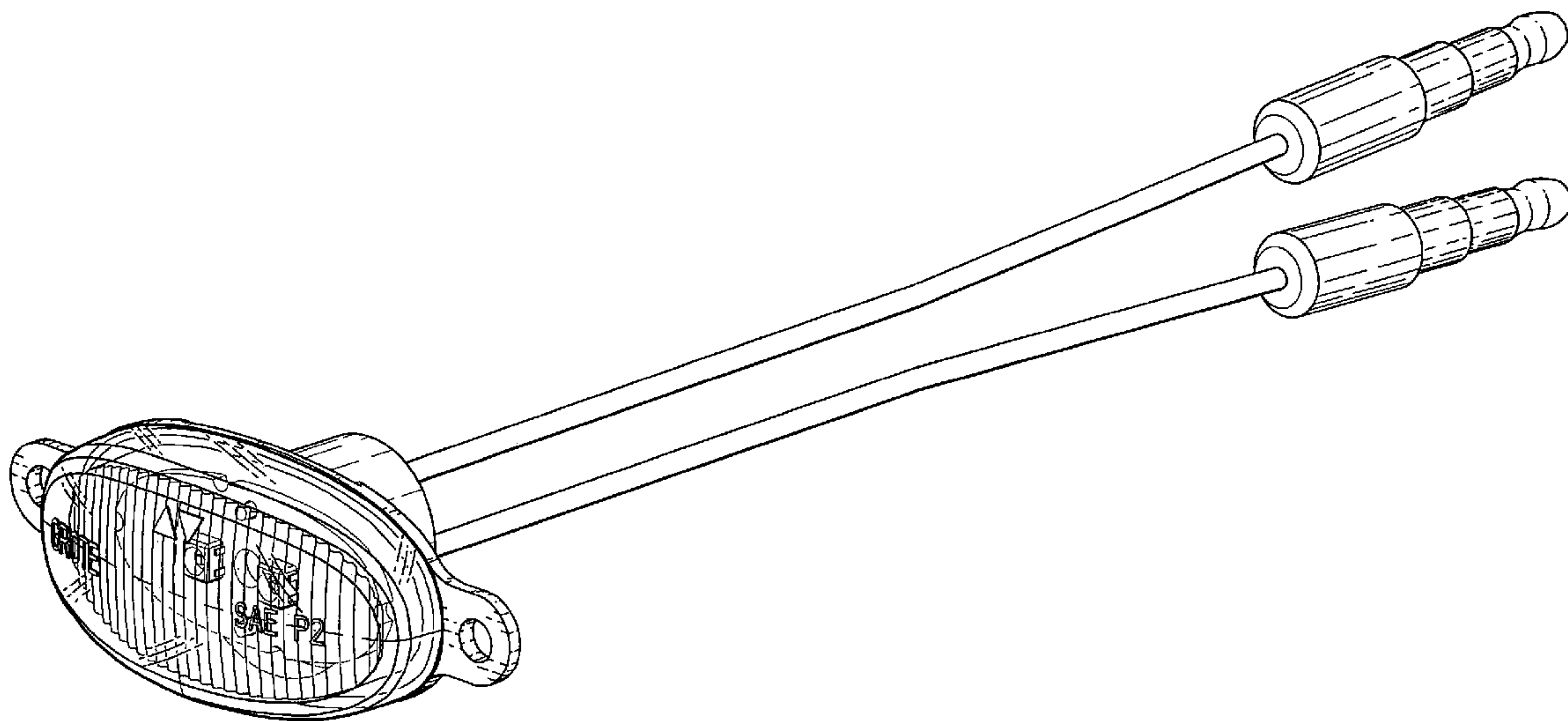
FIG. 5 is a bottom plan view of a first embodiment of our new oval sidemarker lamp design.

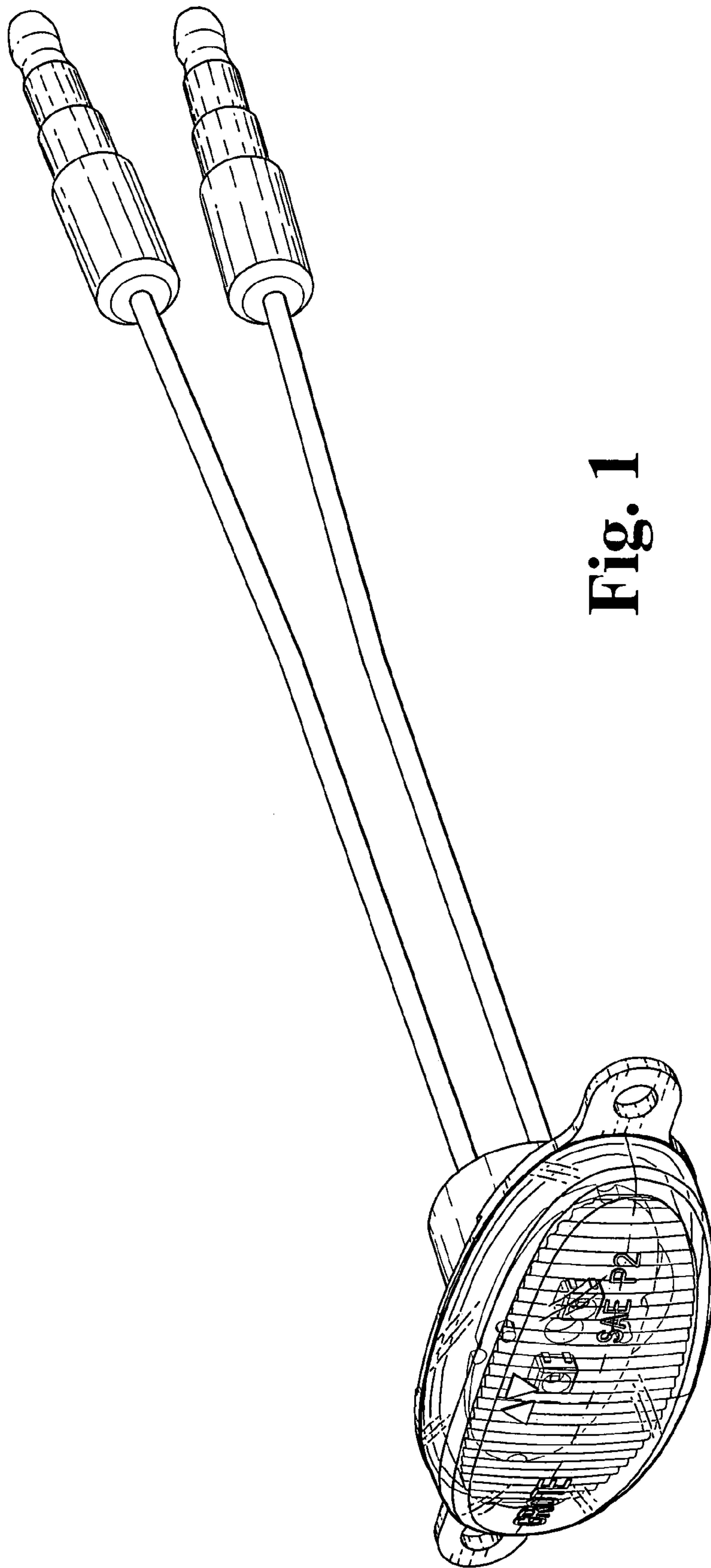

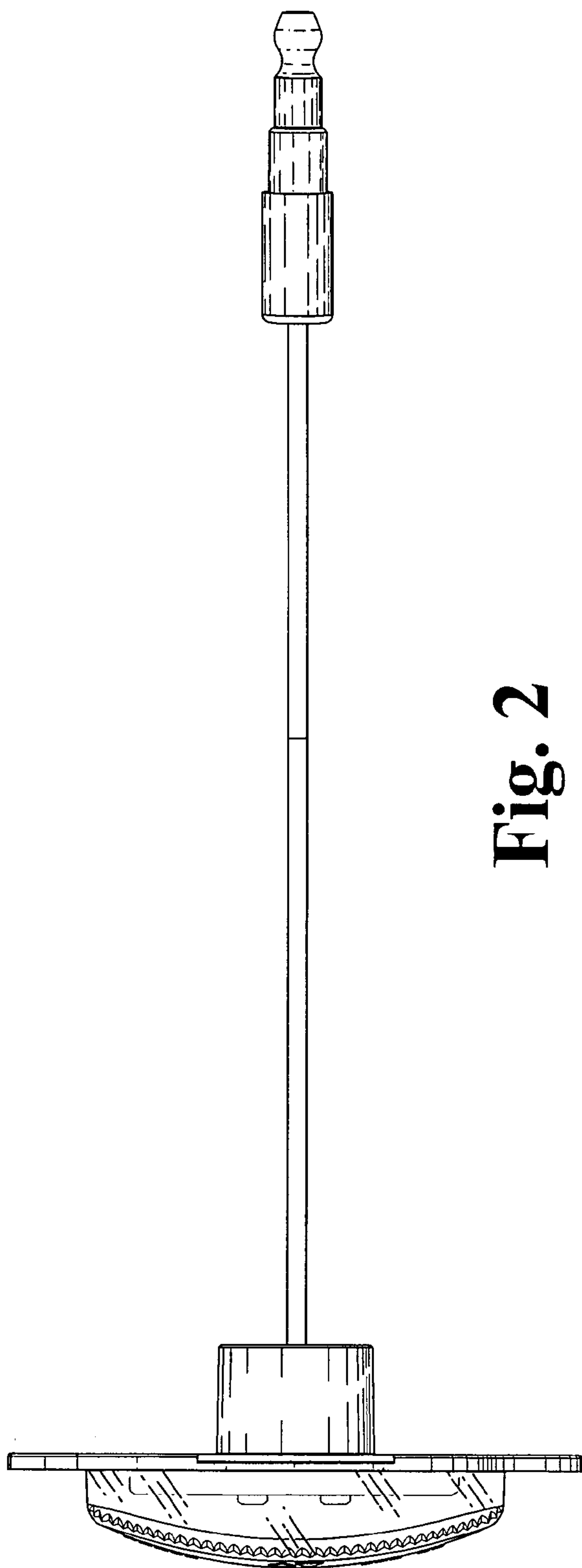

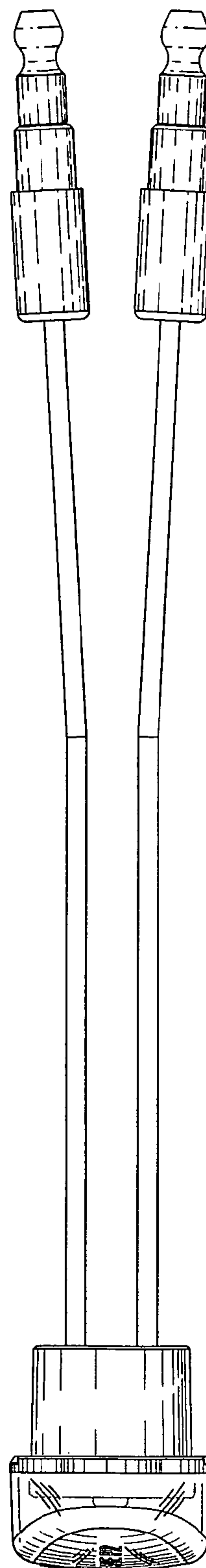
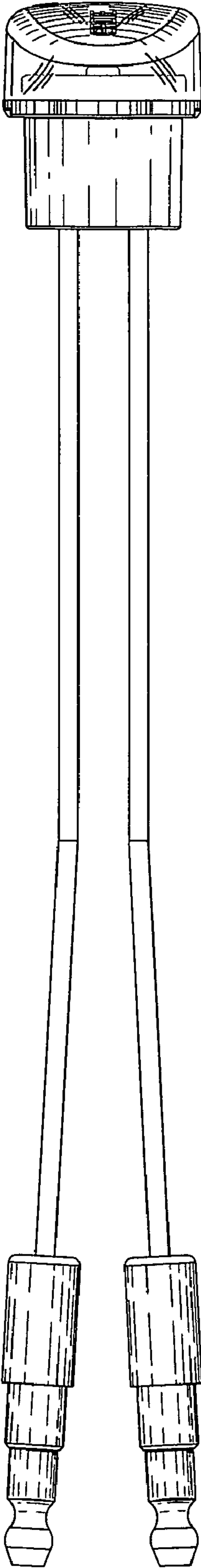
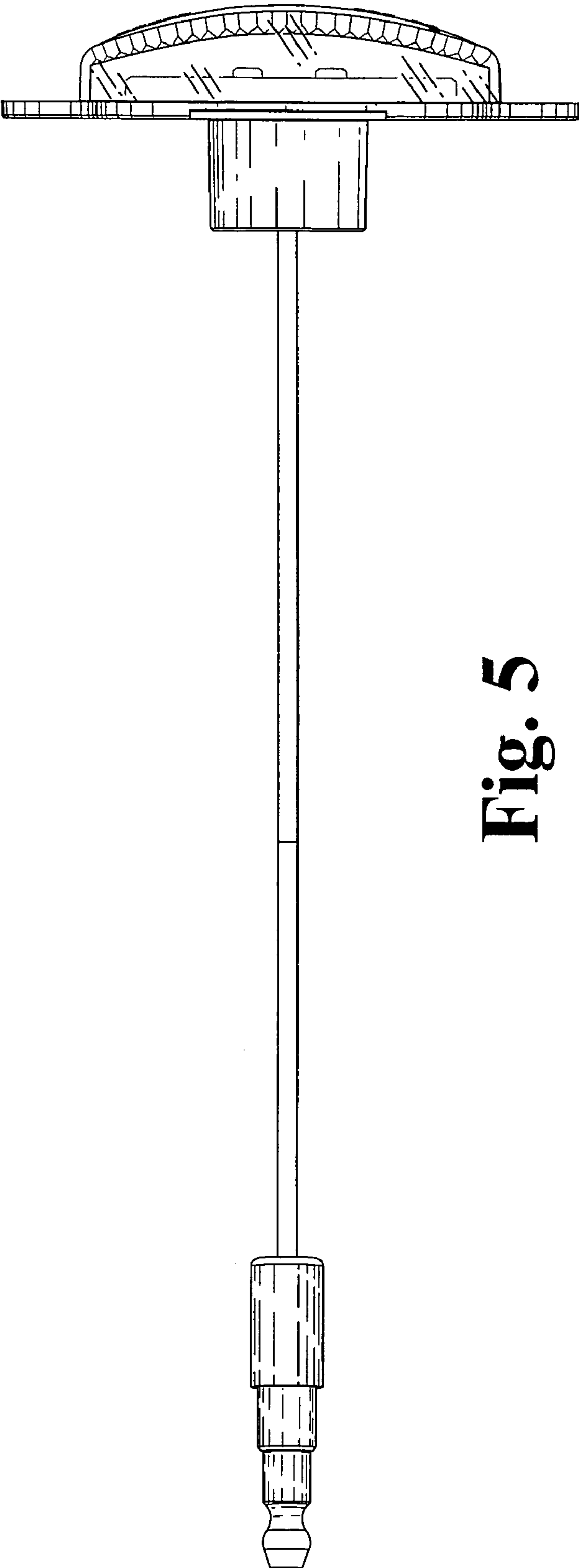


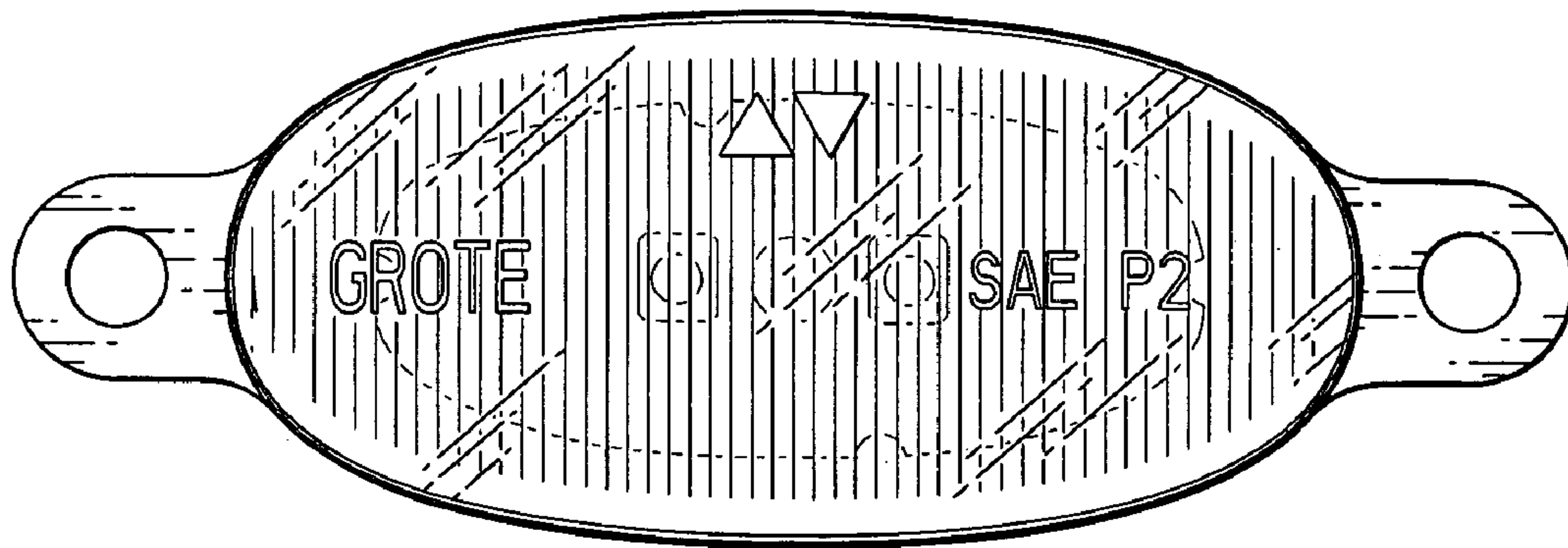

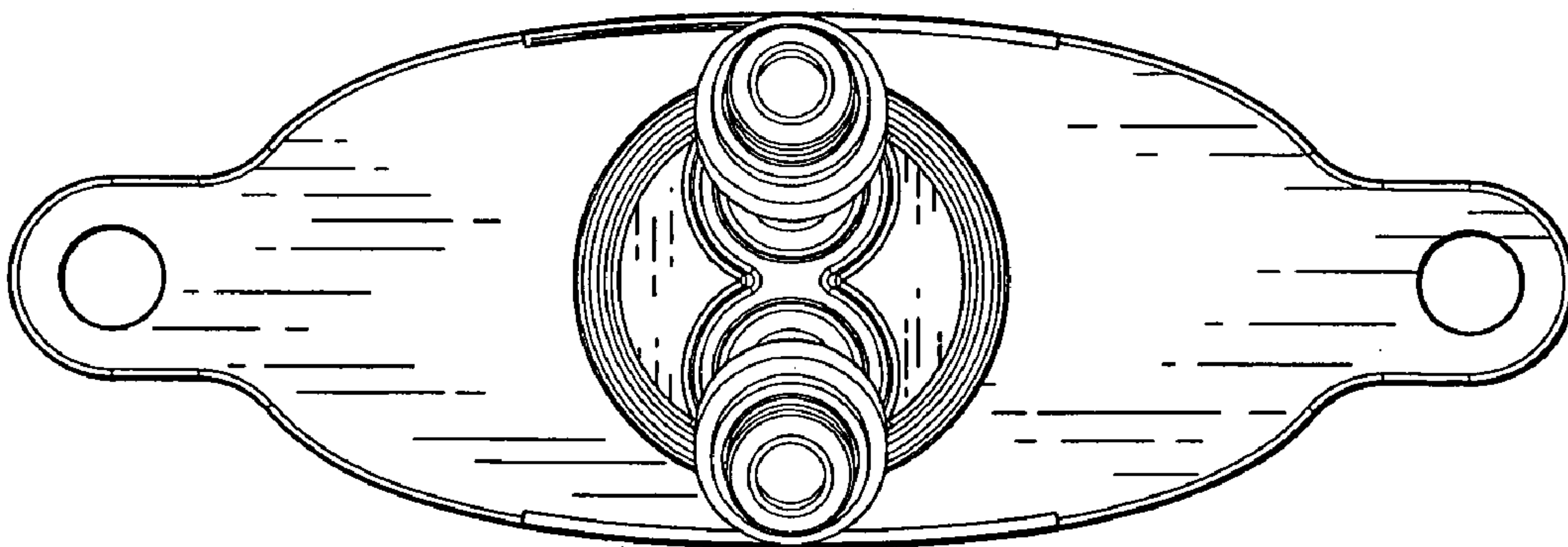
