**DESCRIPTION**

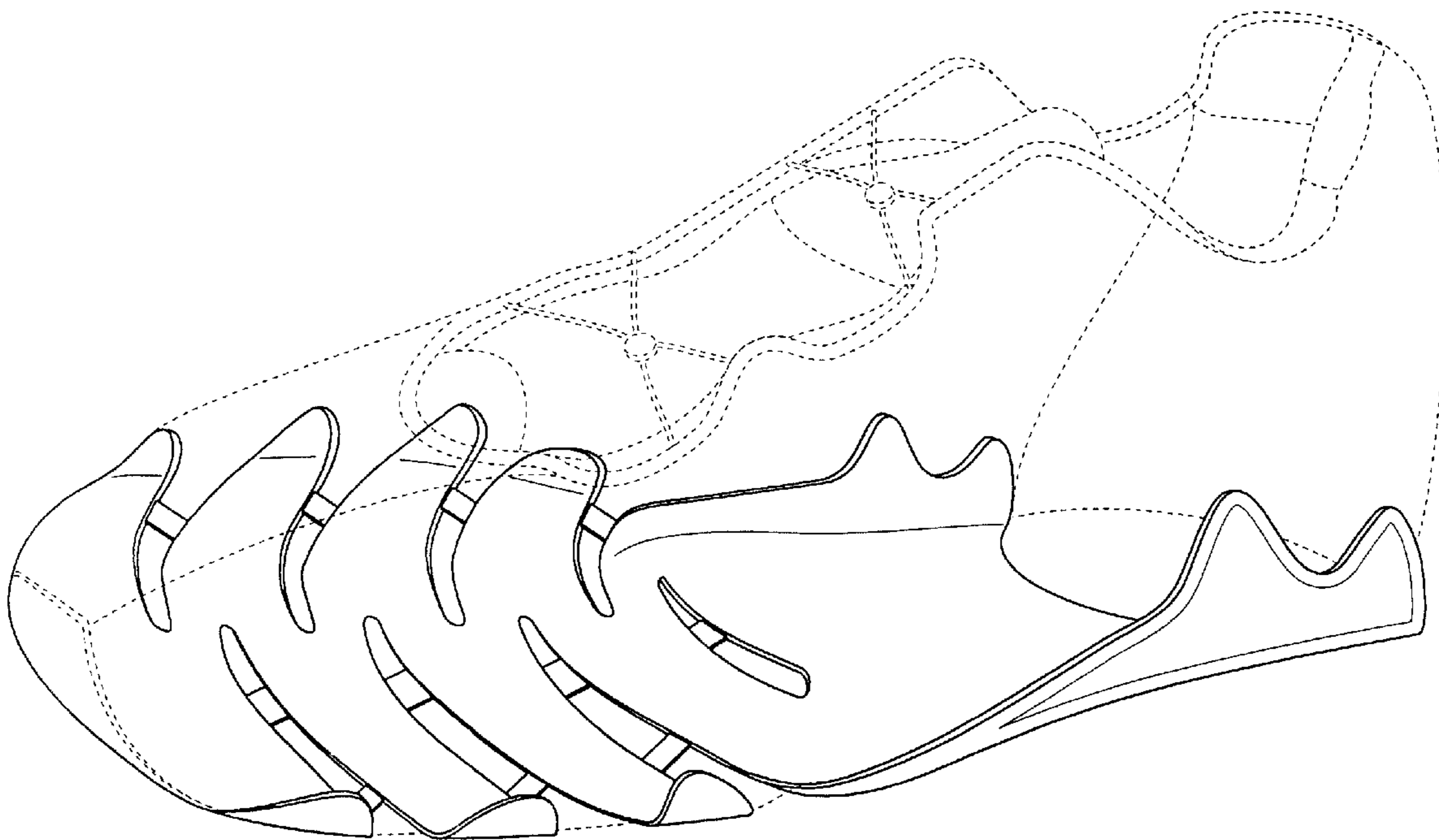

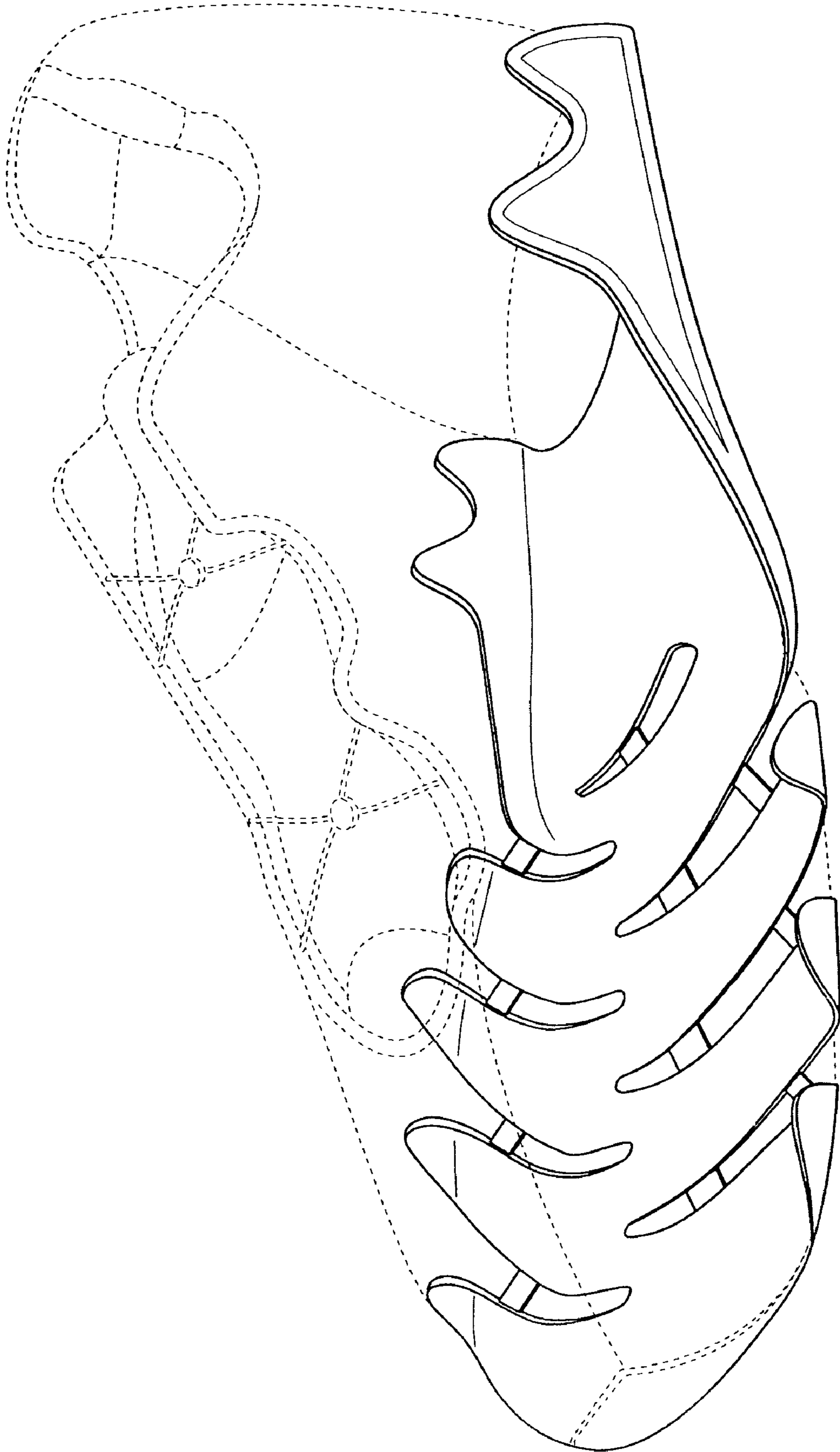

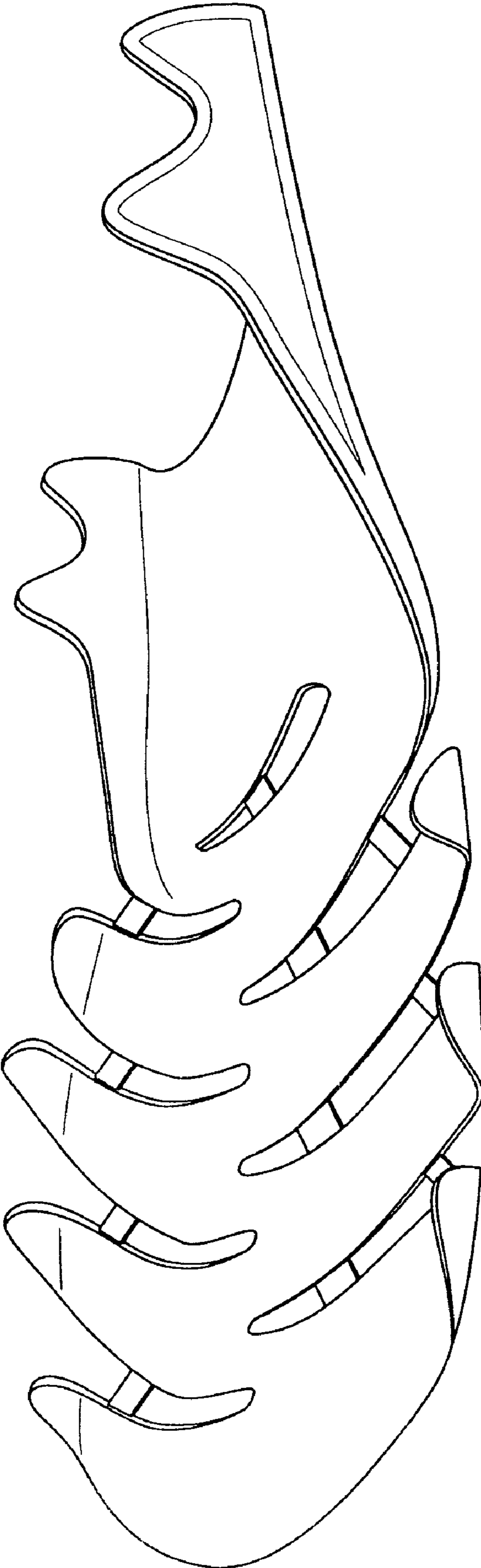

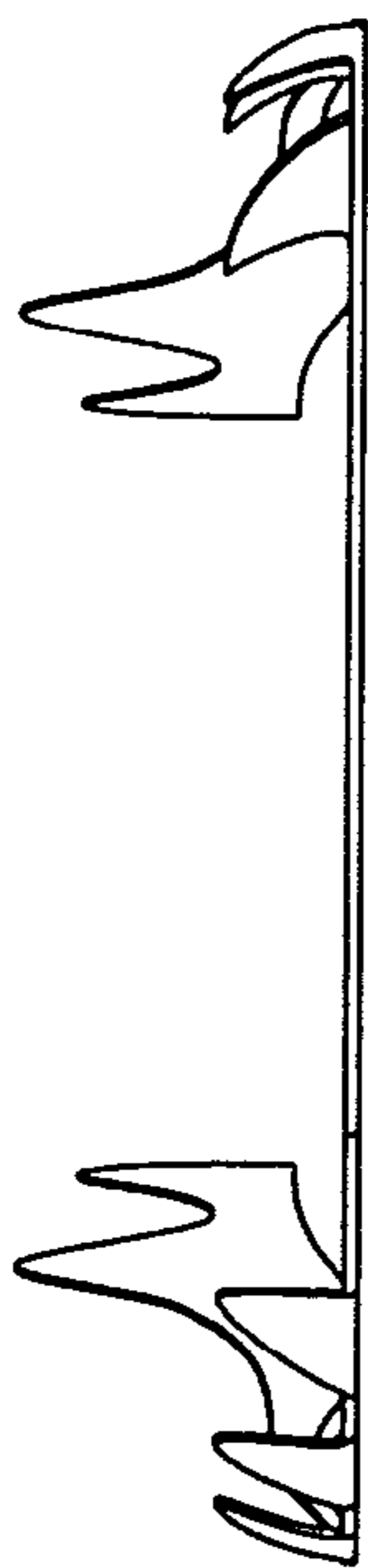

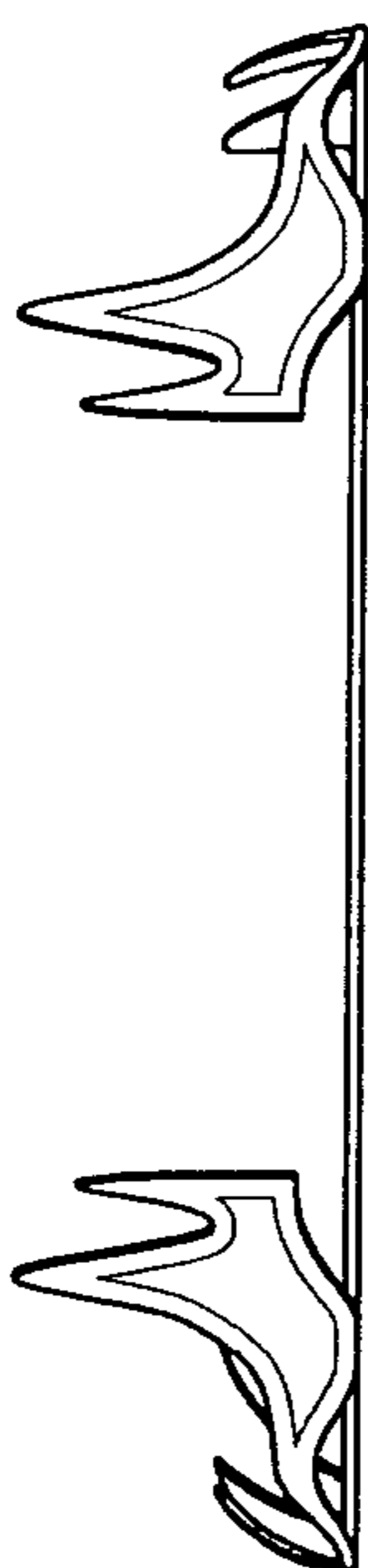

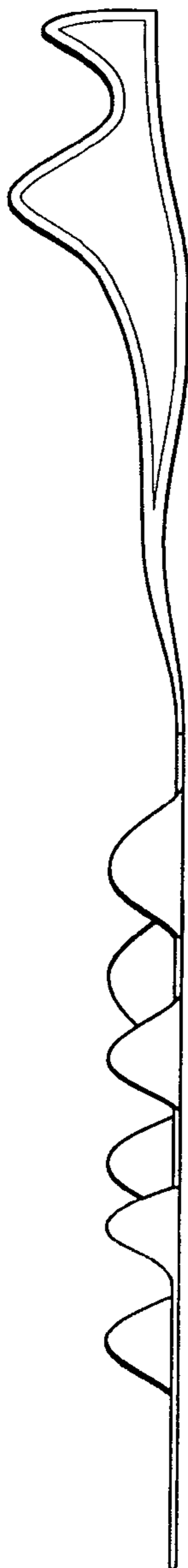

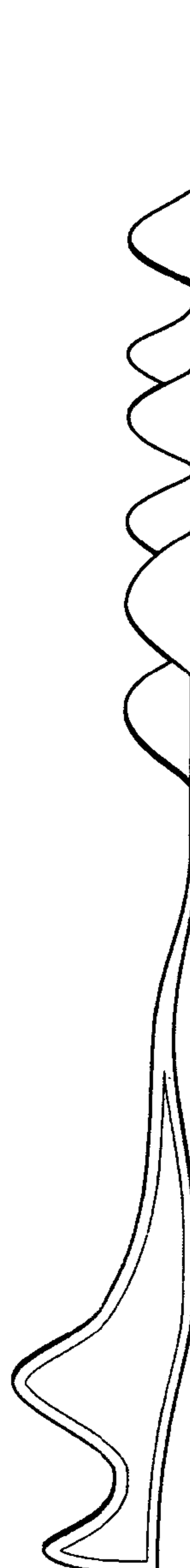

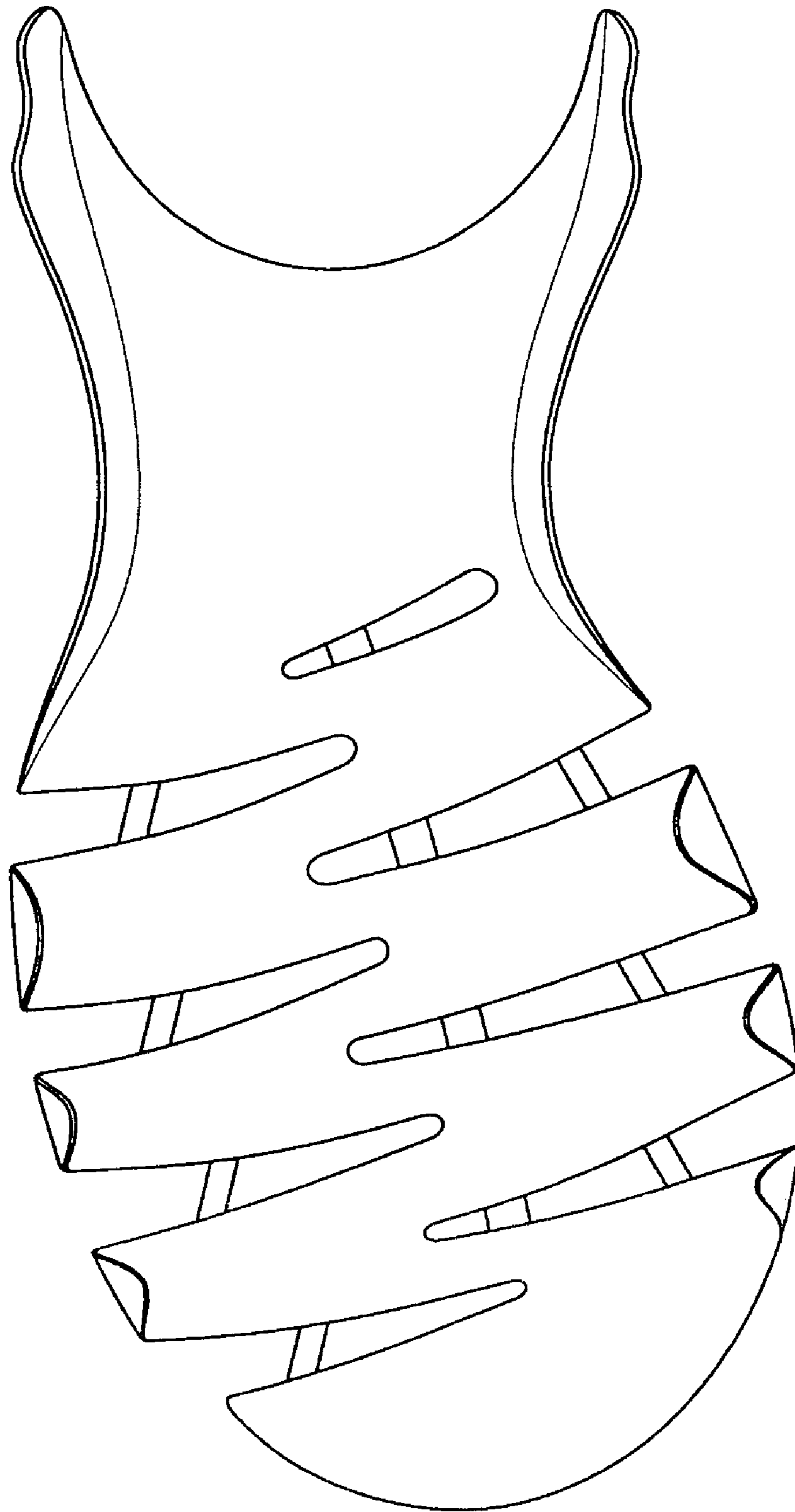

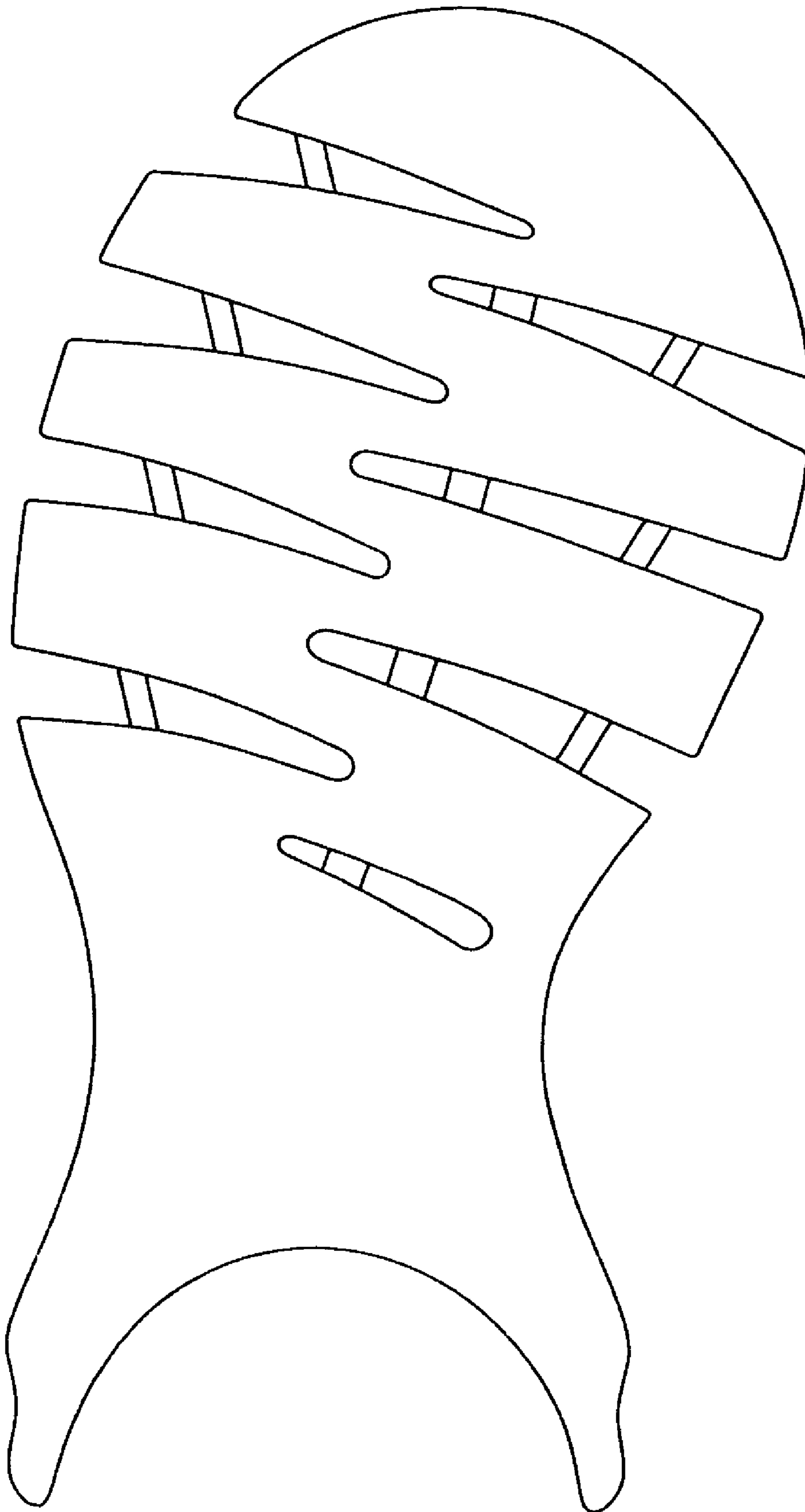
