(57) **CLAIM**

We claim the ornamental design for a water filtration system without a handle, as shown.

DESCRIPTION

FIG. 1 is a left side front perspective view of a water filtration system;

FIG. 2 is a left side rear perspective view thereof;

FIG. 3 is a left side view thereof;

FIG. 4 is a rear elevational view thereof;

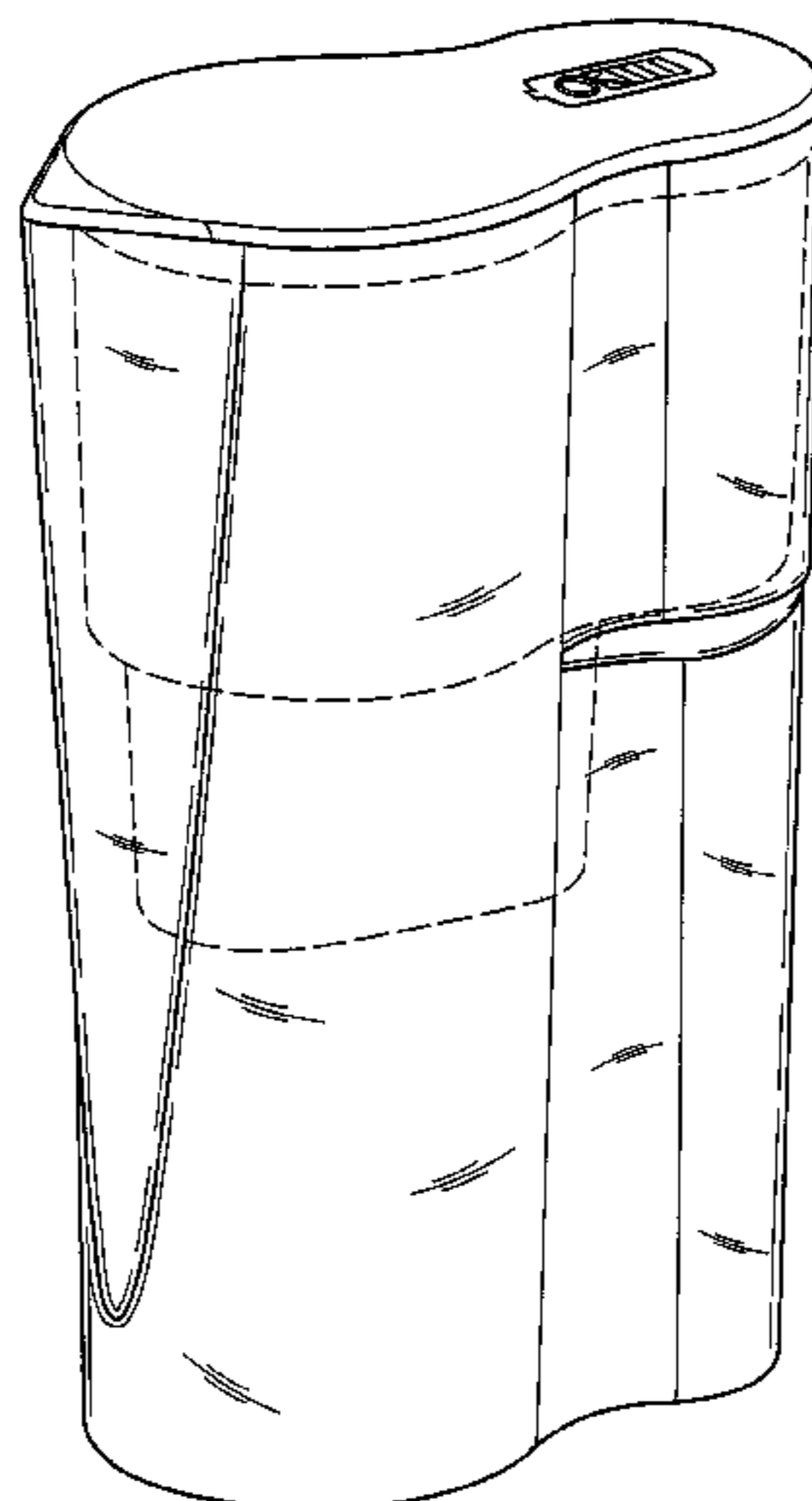
FIG. 5 is a front elevational view thereof;

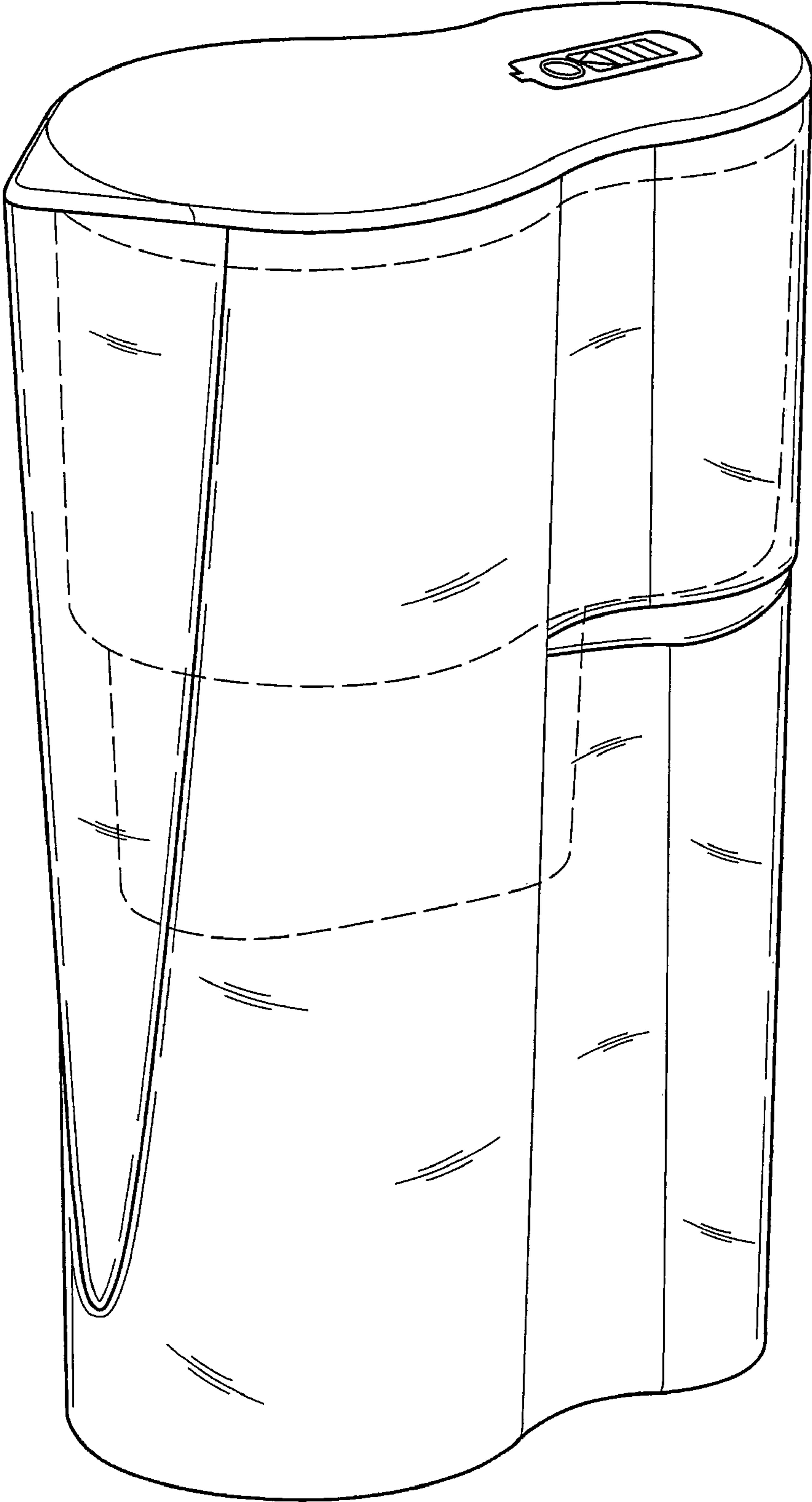

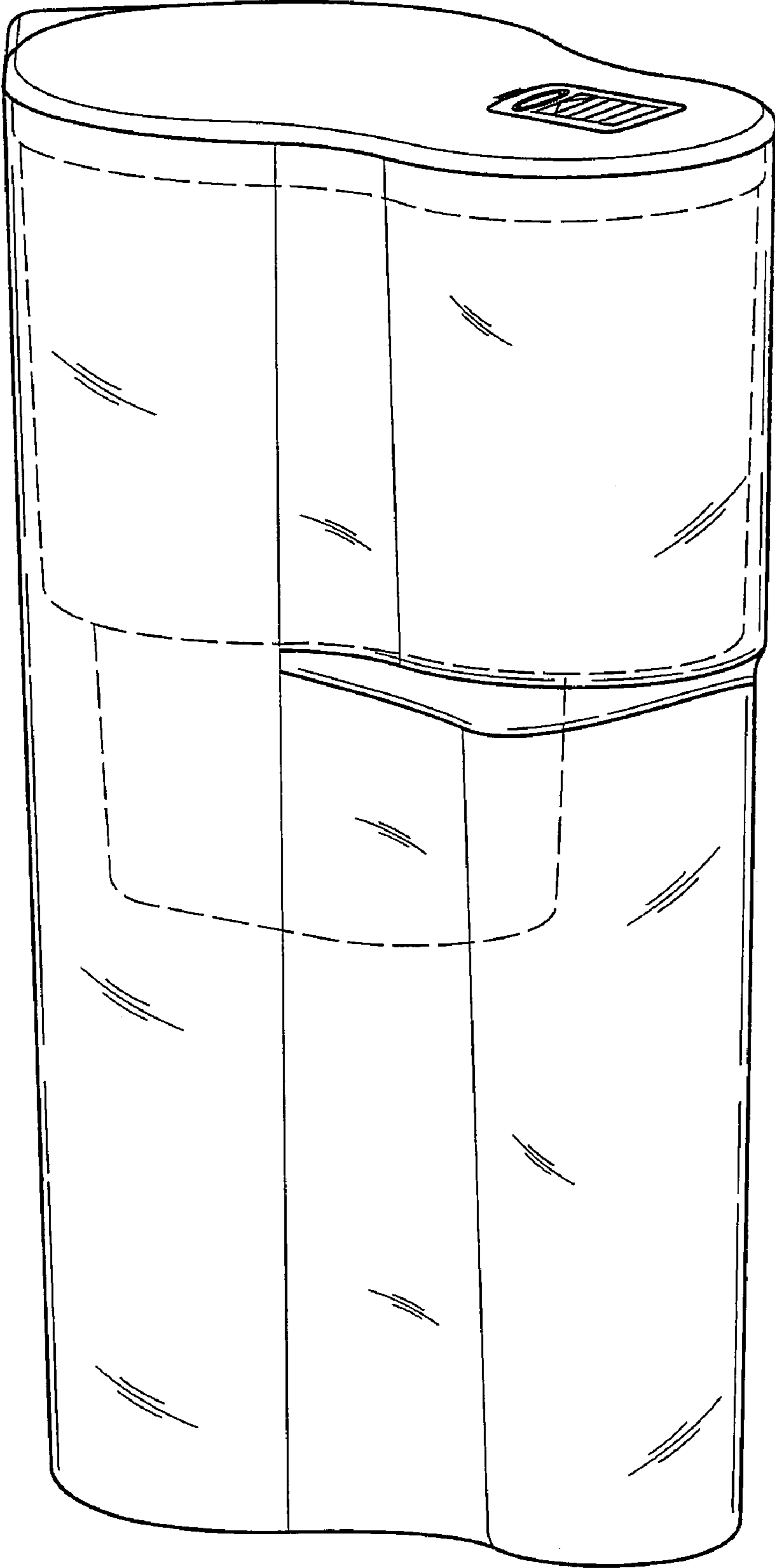

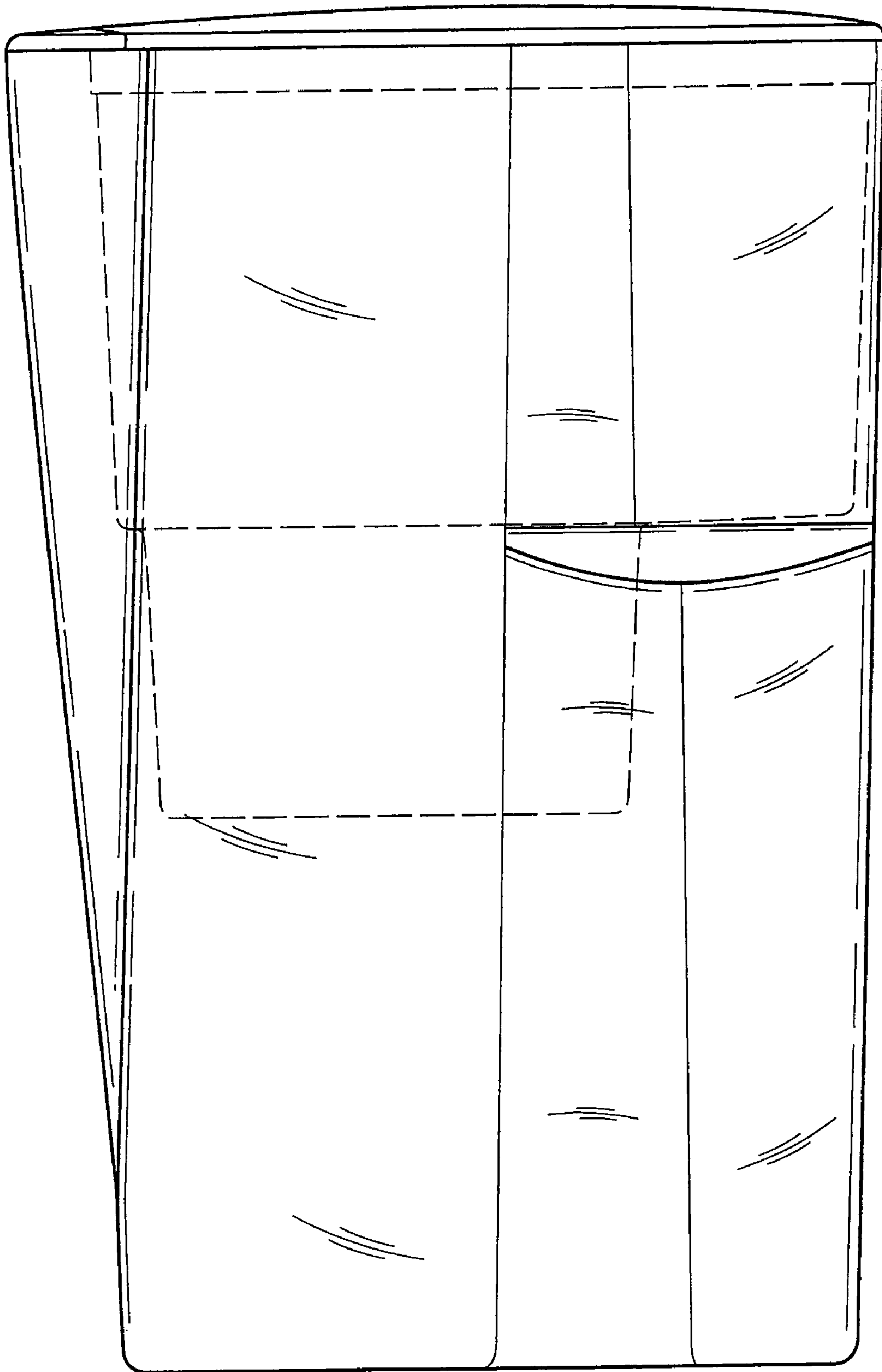

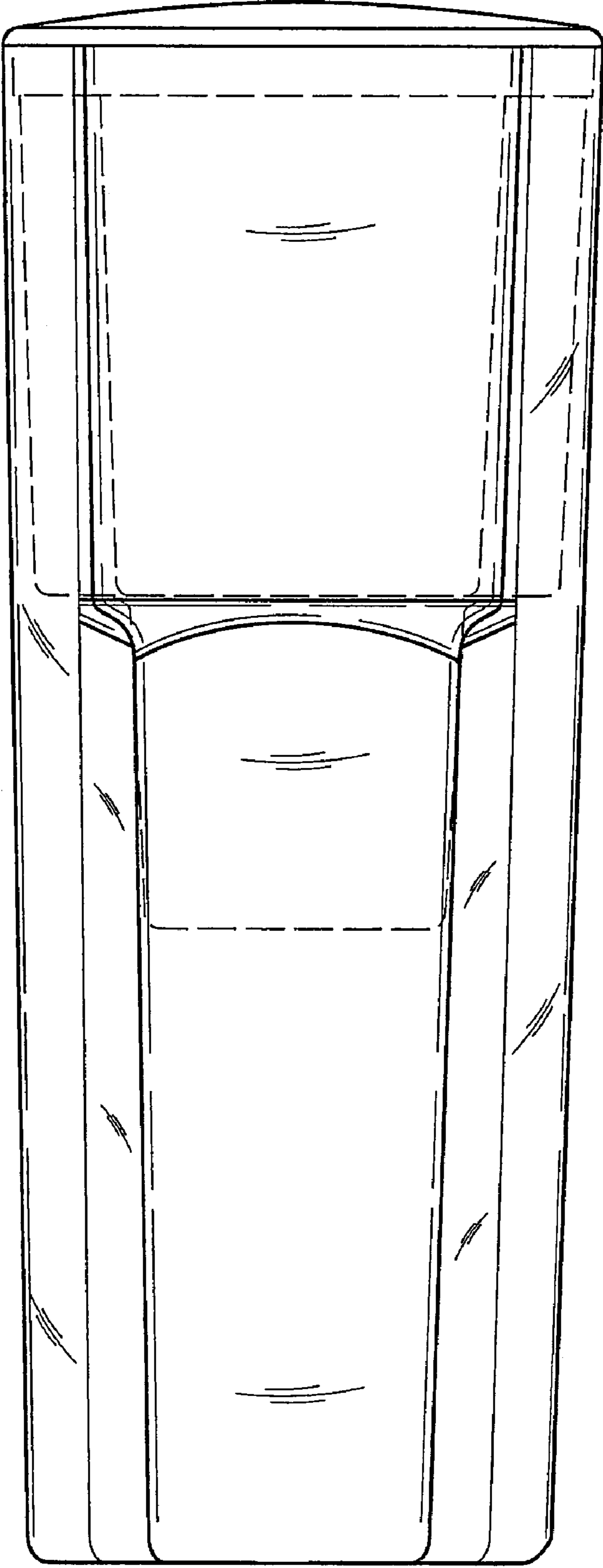

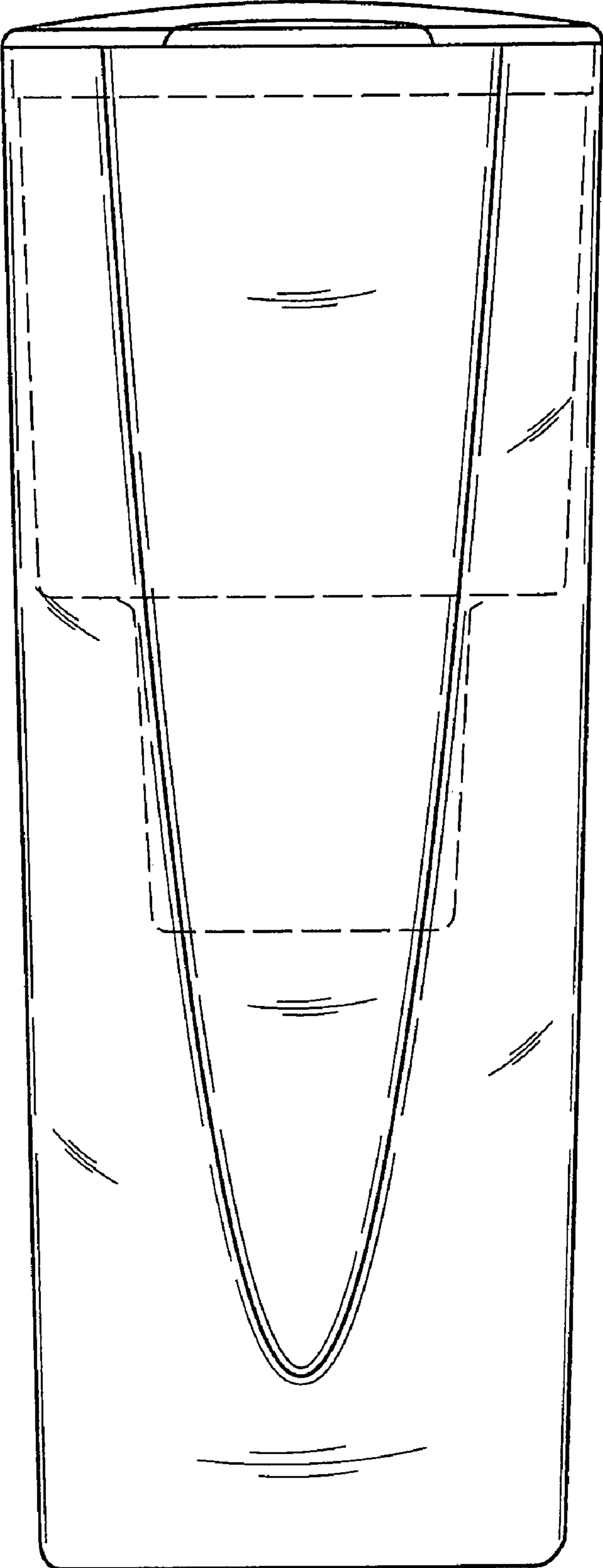

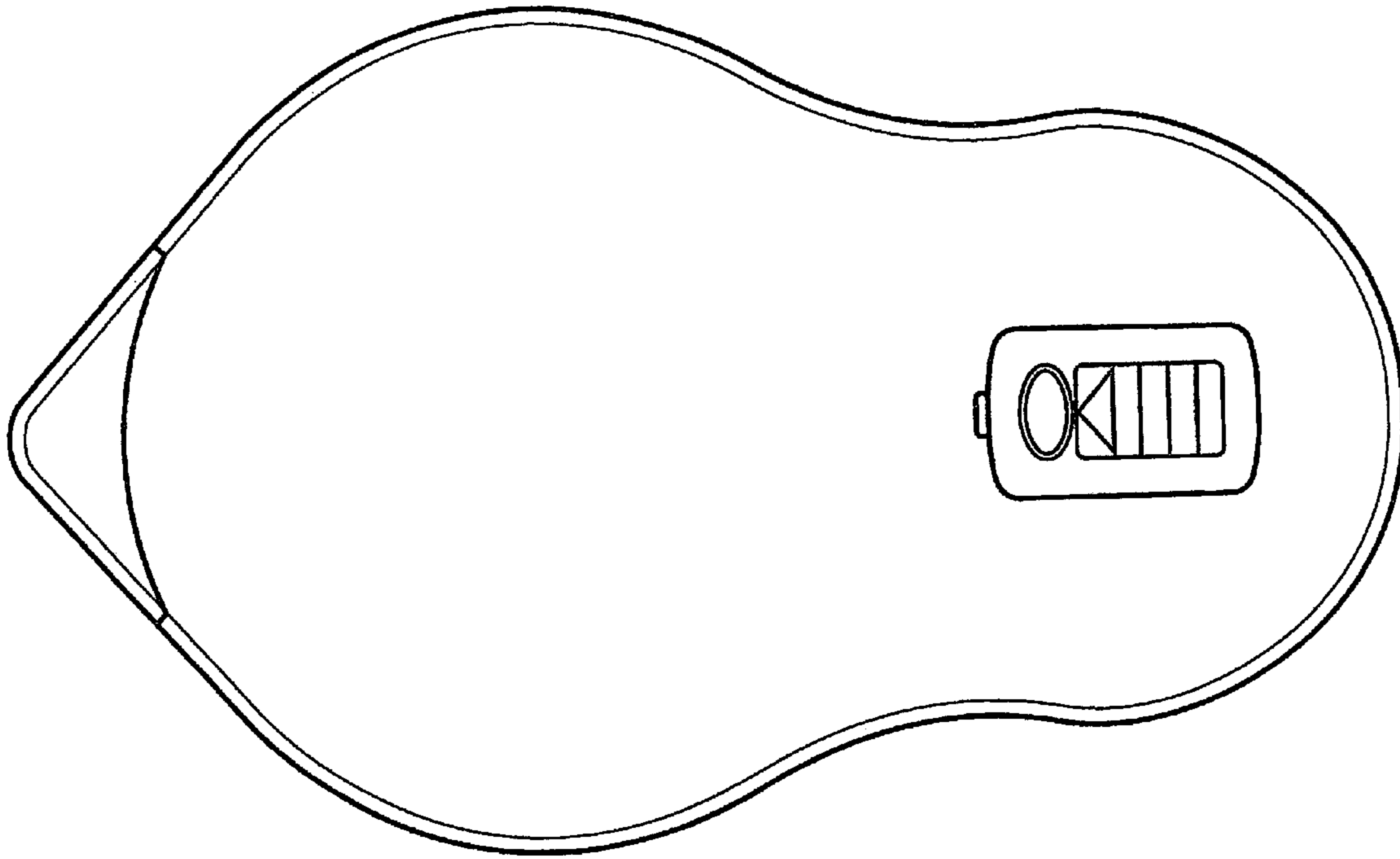

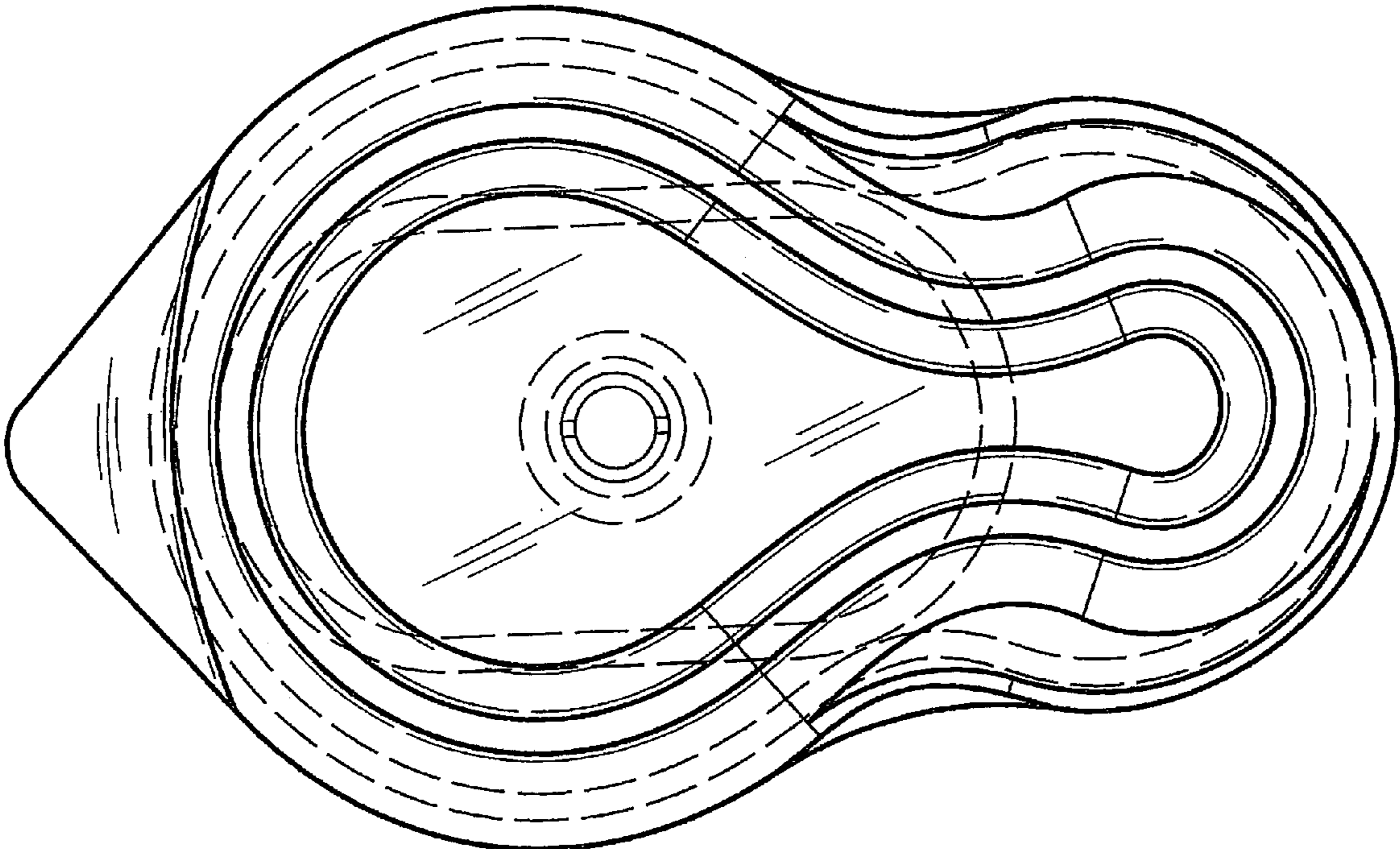
