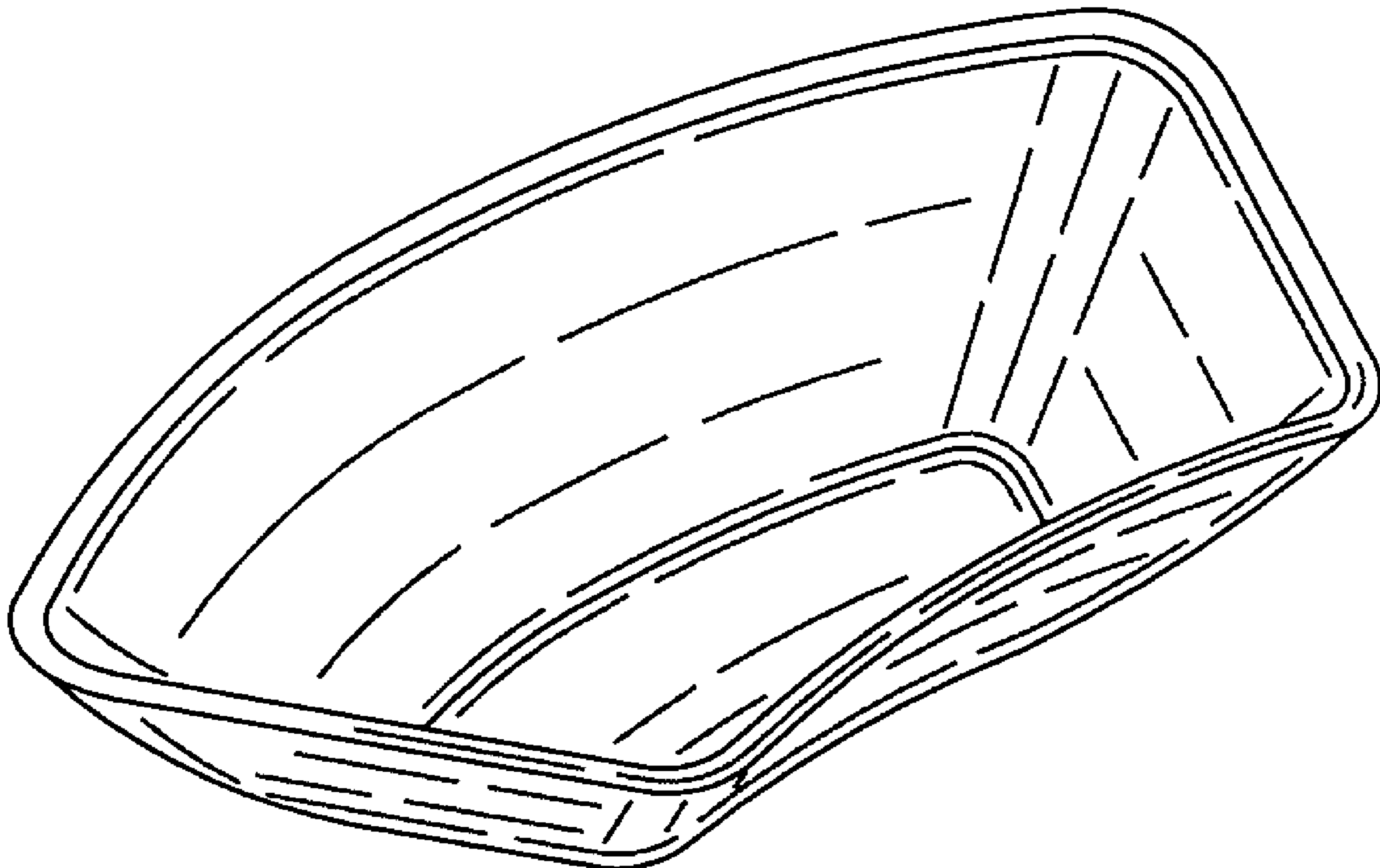
(57) **CLAIM**

The ornamental design for a serving dish, as shown and described.

DESCRIPTION

- FIG. 1 is a top, right side and front perspective view of the serving dish showing the new design;
- FIG. 2 is a front elevation view thereof, the rear elevation being a mirror image thereof;
- FIG. 3 right side elevation view thereof;

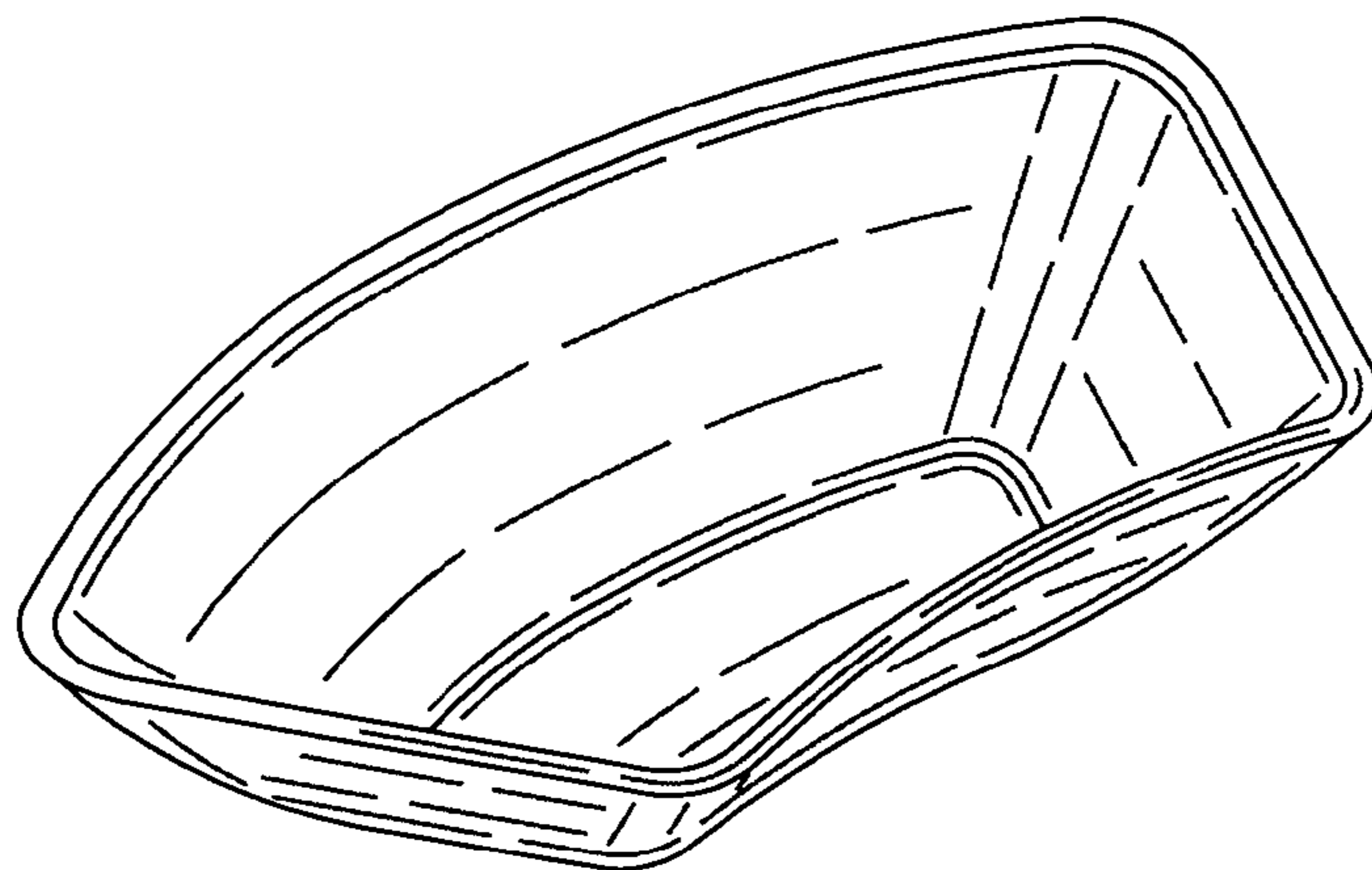

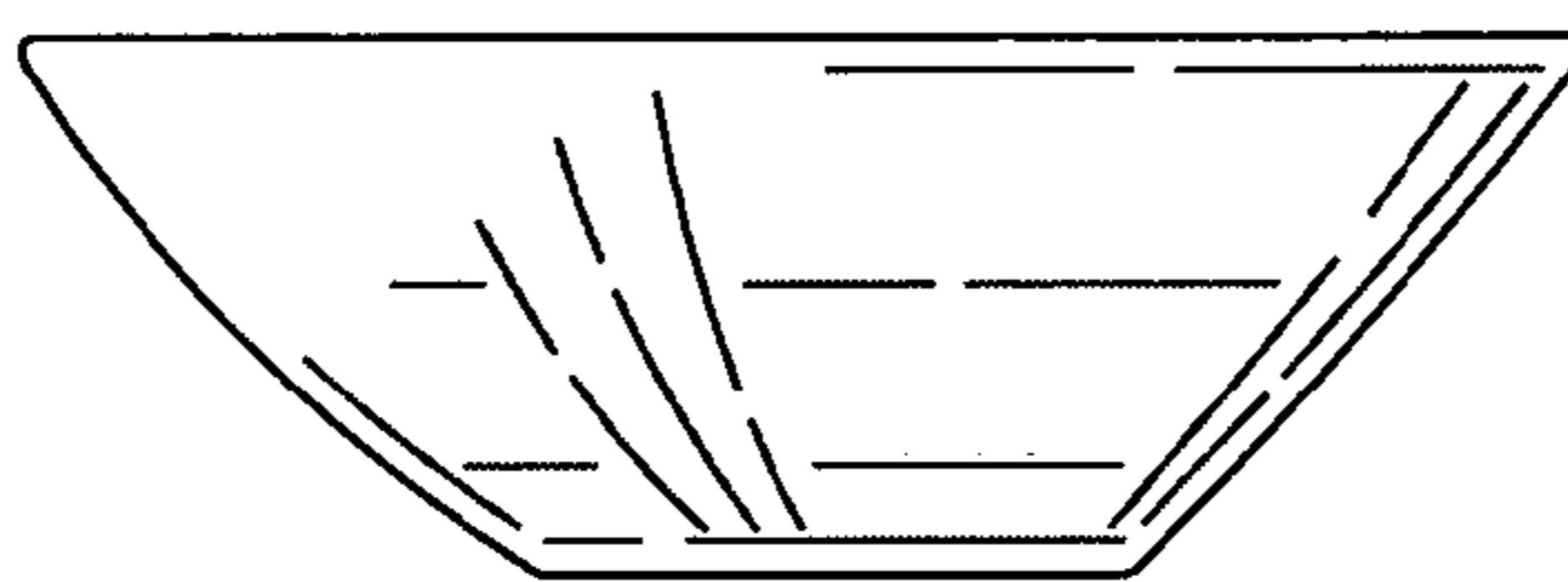

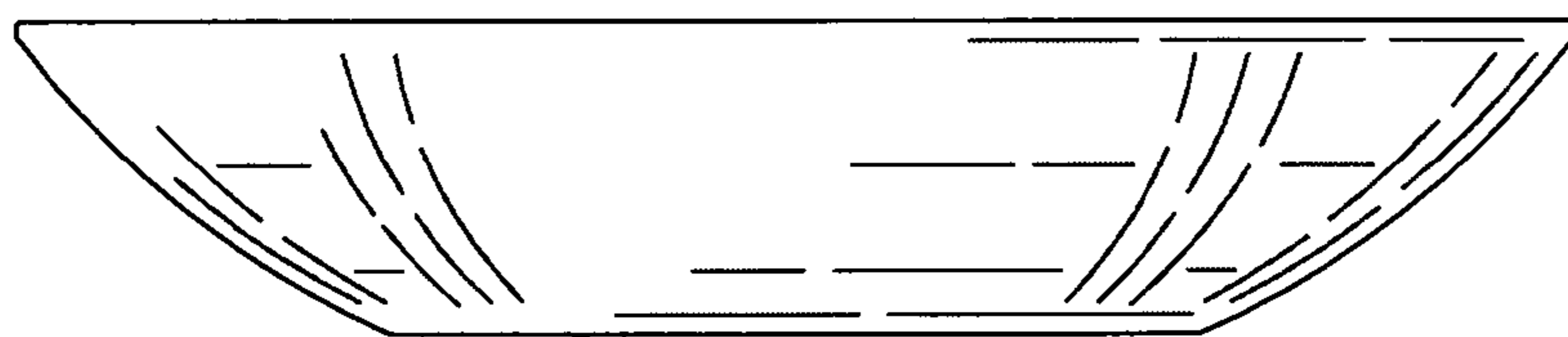

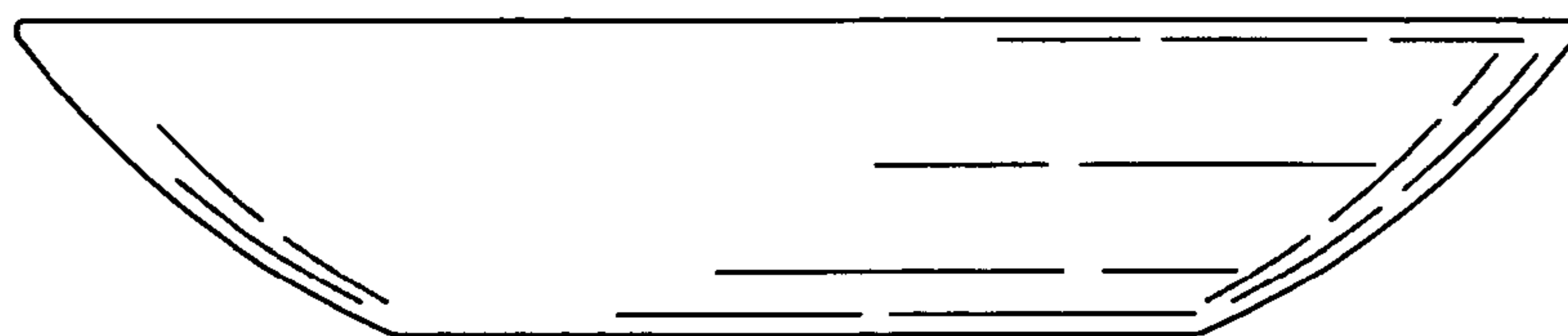

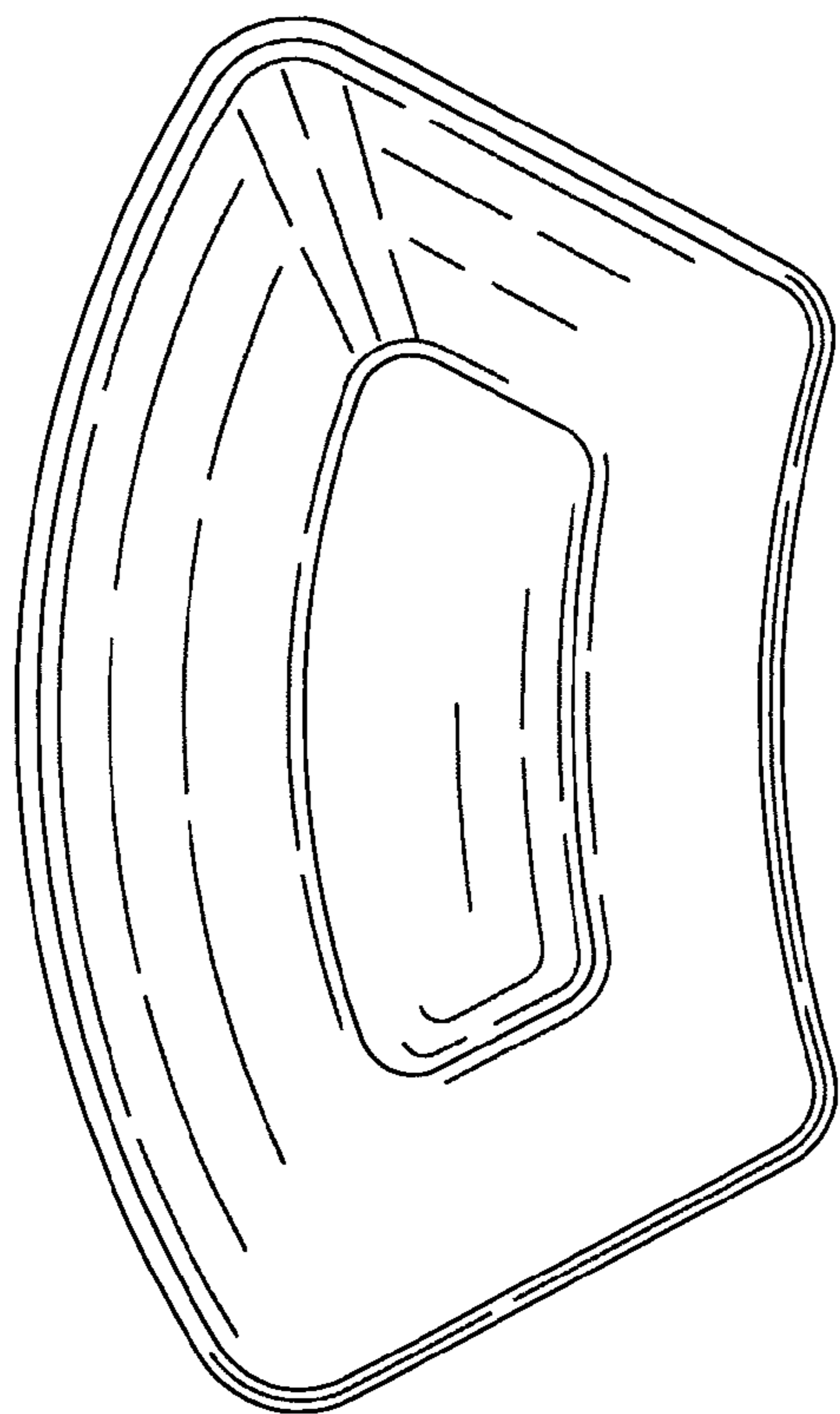

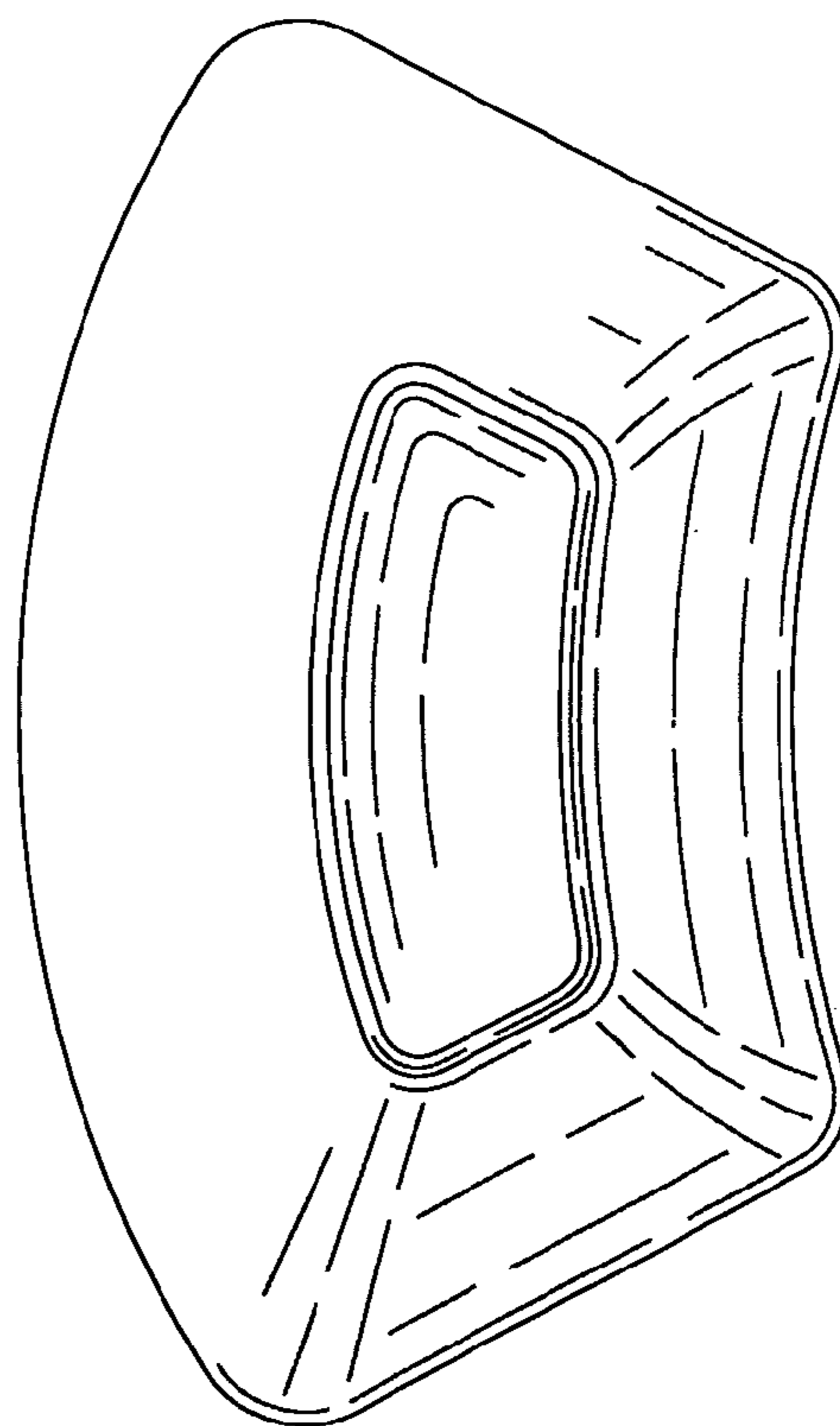
