(57) **CLAIM**

The ornamental design for an elevated utensil support, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the elevated utensil support; FIG. 2 is a left side elevational view of the elevated utensil support of FIG. 1;

FIG. 3 is a right side elevational view of the elevated utensil support of FIG. 1;

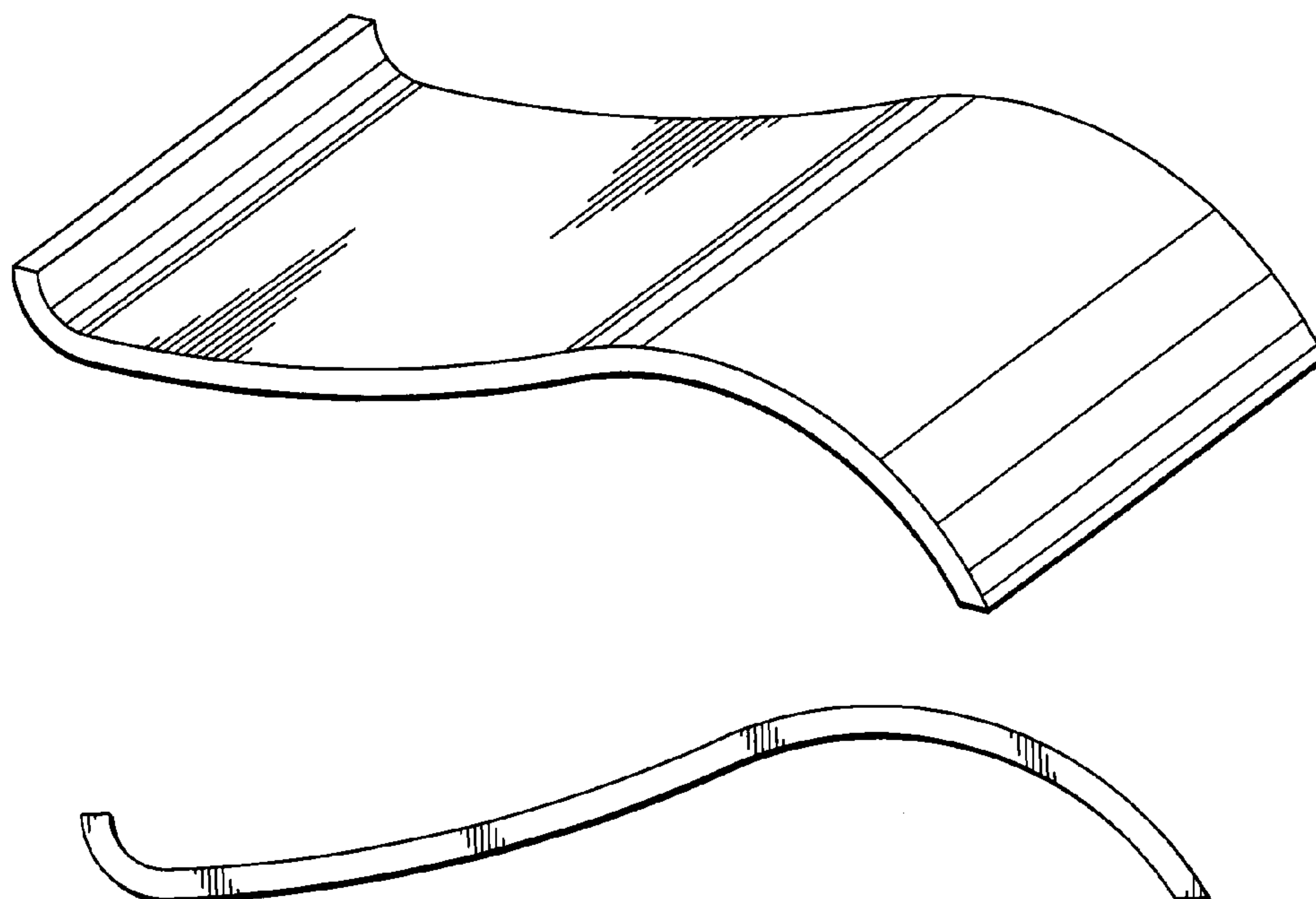
FIG. 4 is a front view of the elevated edge of the elevated utensil support of FIG. 2;

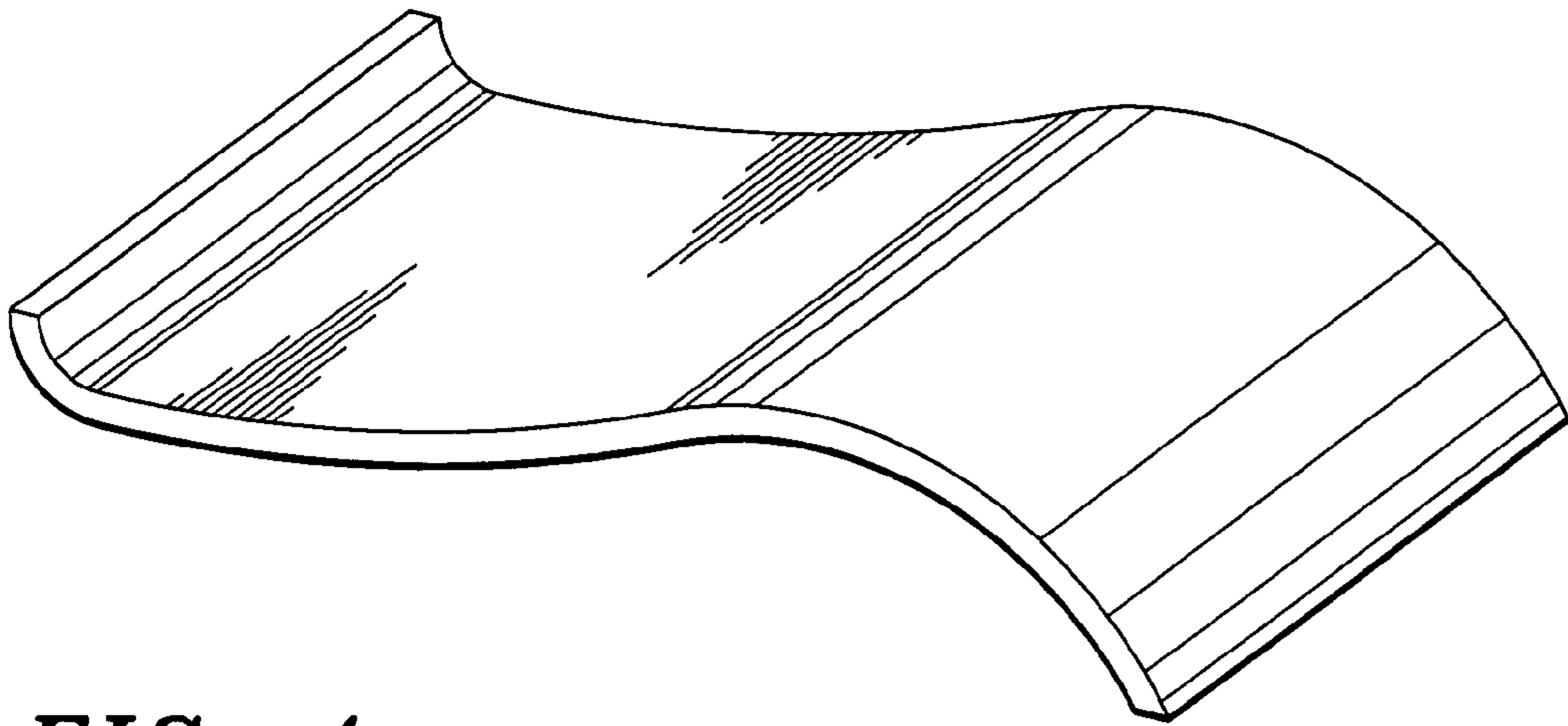

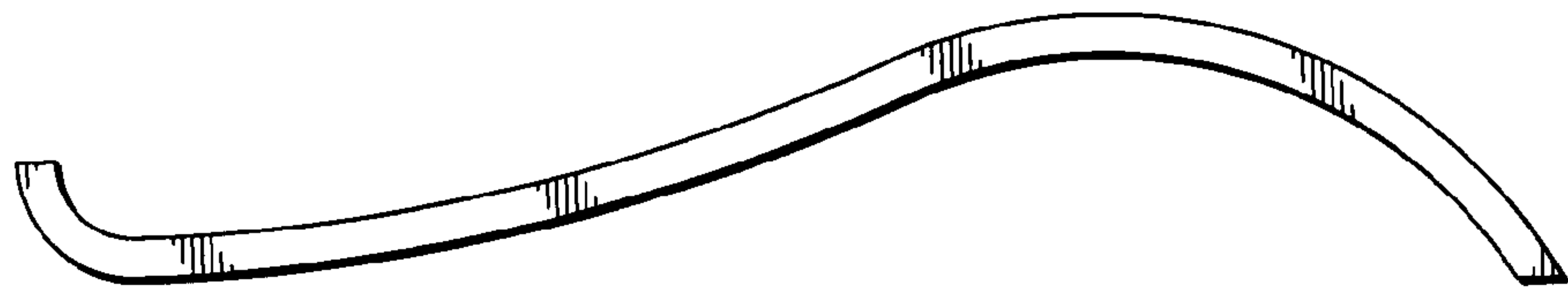

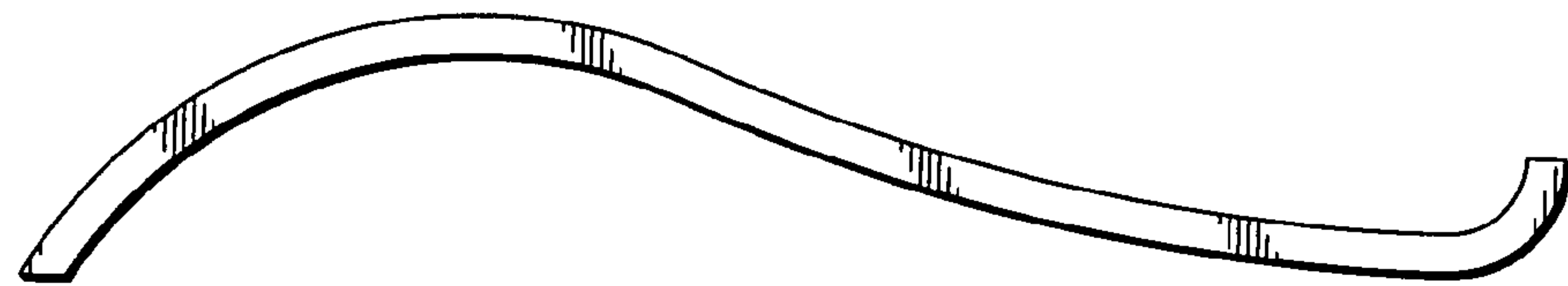

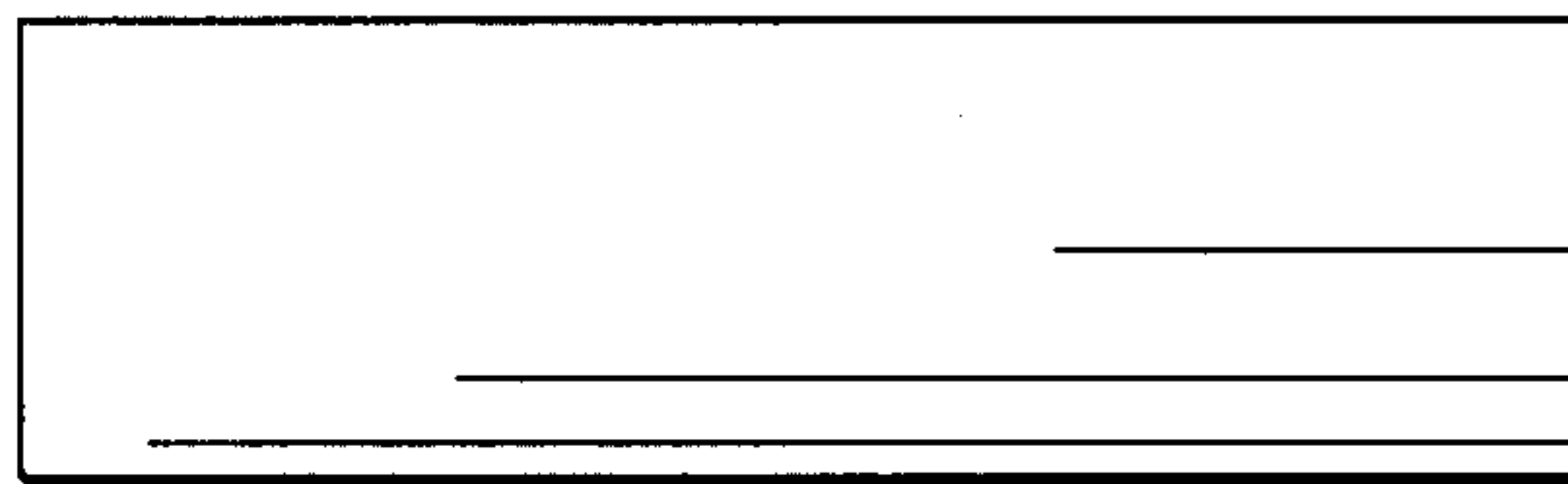
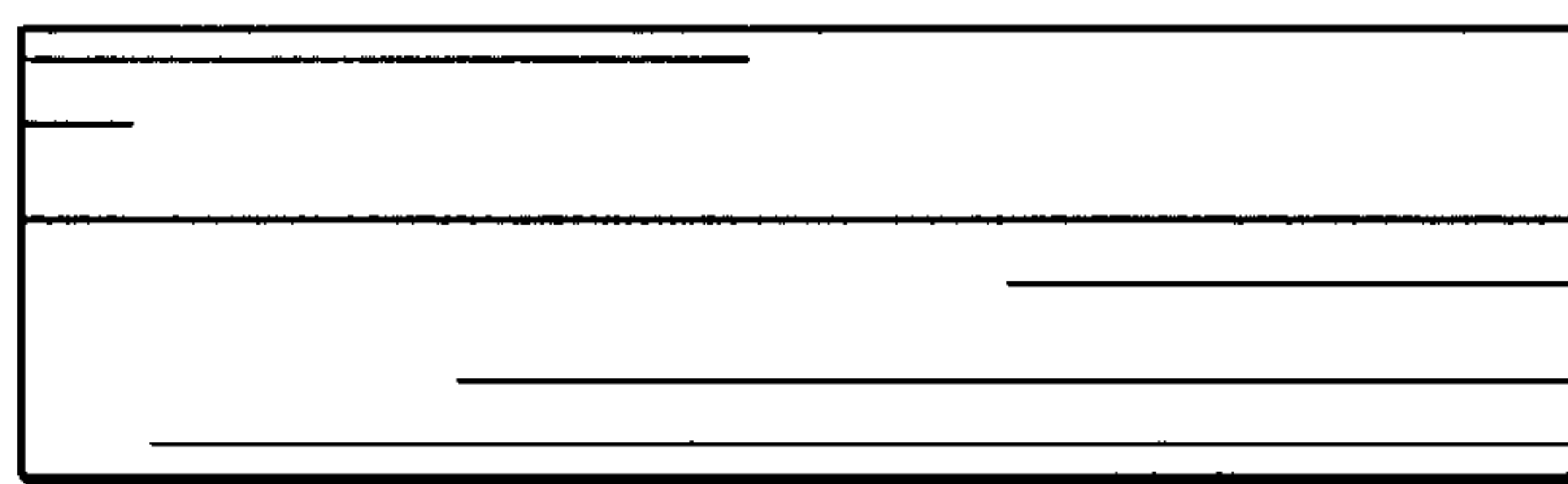

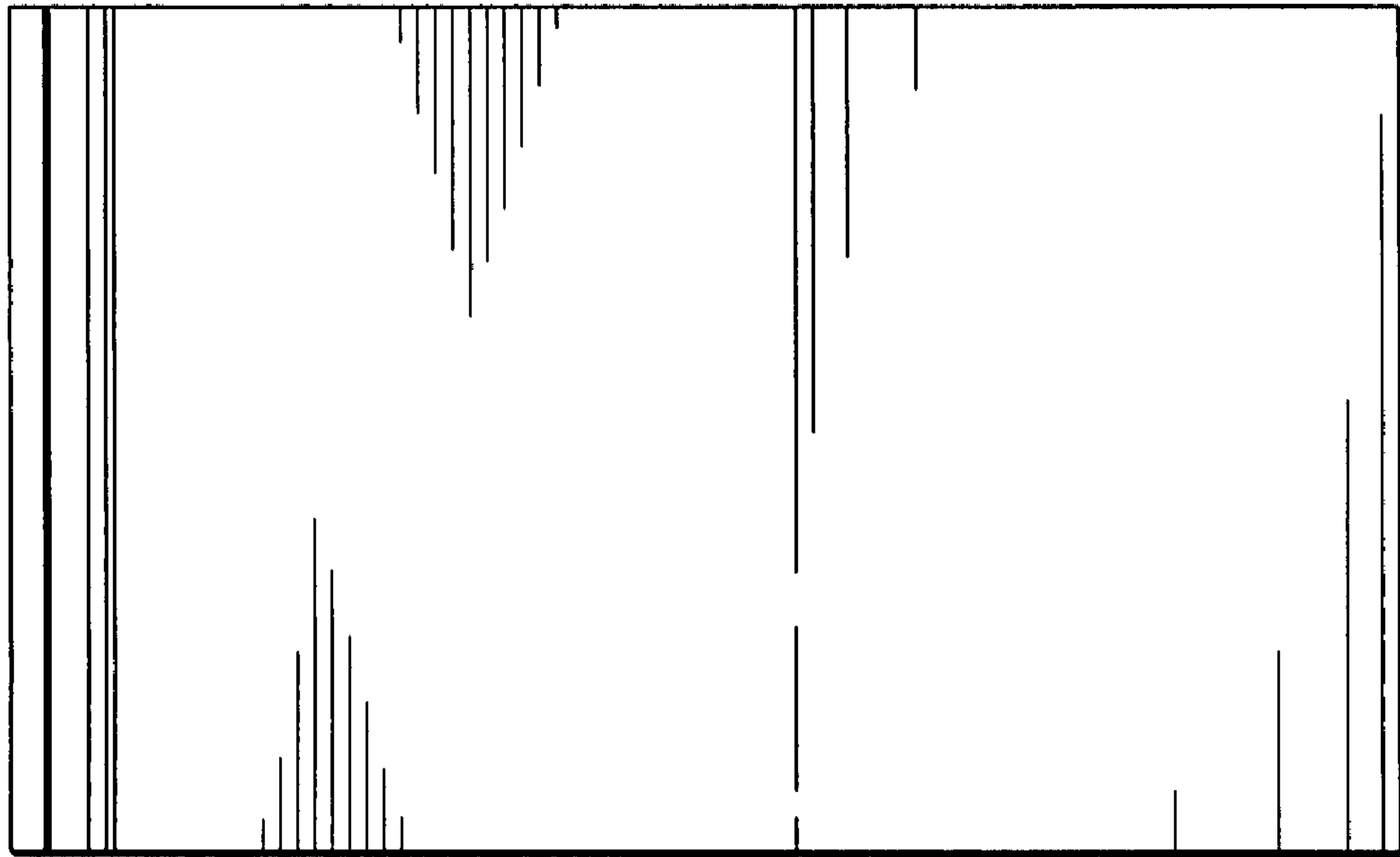

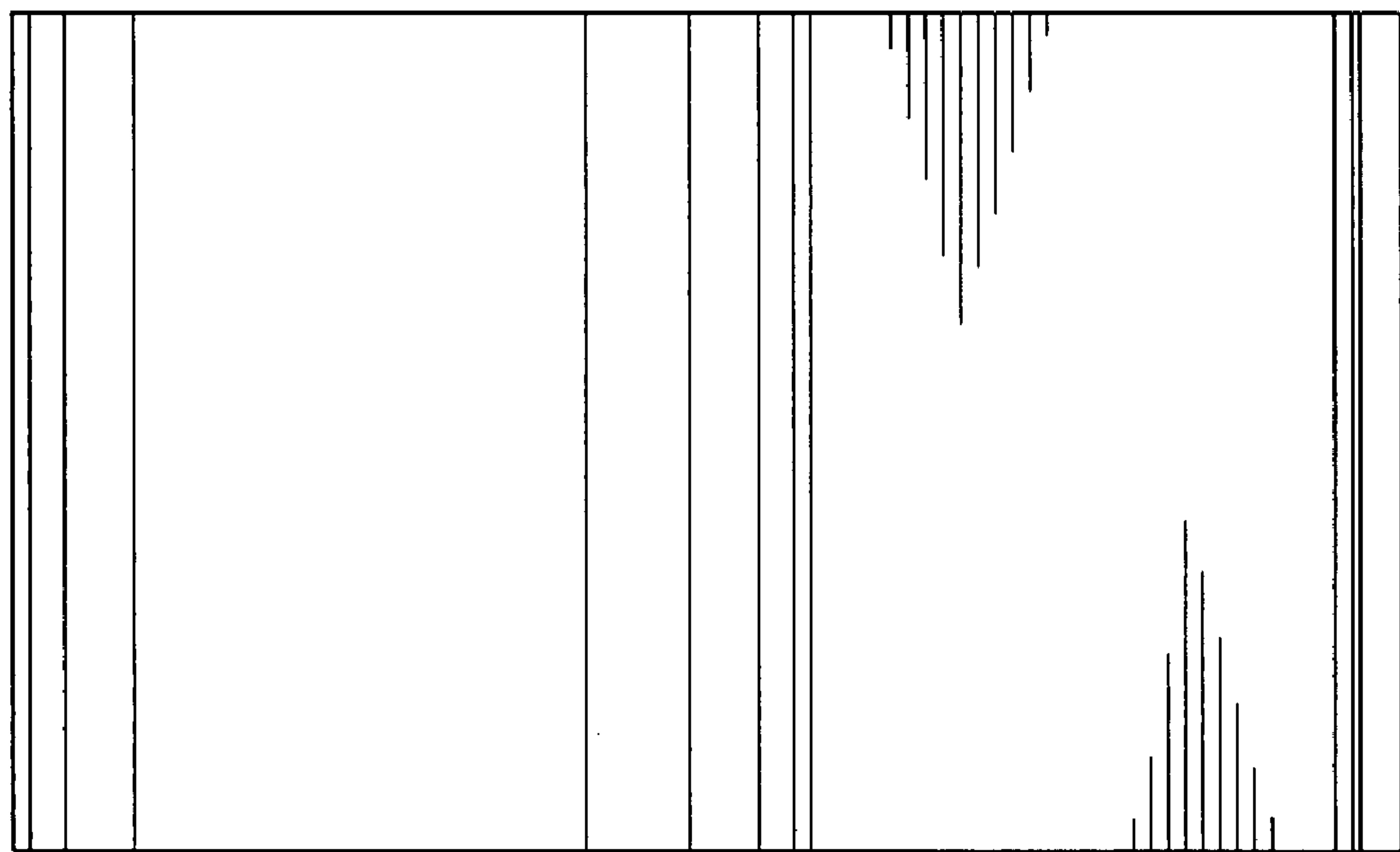
