**DESCRIPTION**

FIG. 1 is a perspective view of a picnic tote showing our new design;

FIG. 2 is a front elevational view of the embodiment of the present invention shown in FIG. 1;

FIG. 3 is a right side elevational view of the embodiment of the present invention shown in FIG. 1;

FIG. 4 is a rear elevational view of the embodiment of the present invention shown in FIG. 1;

FIG. 5 is a left side elevational view of the embodiment of the present invention shown in FIG. 1;

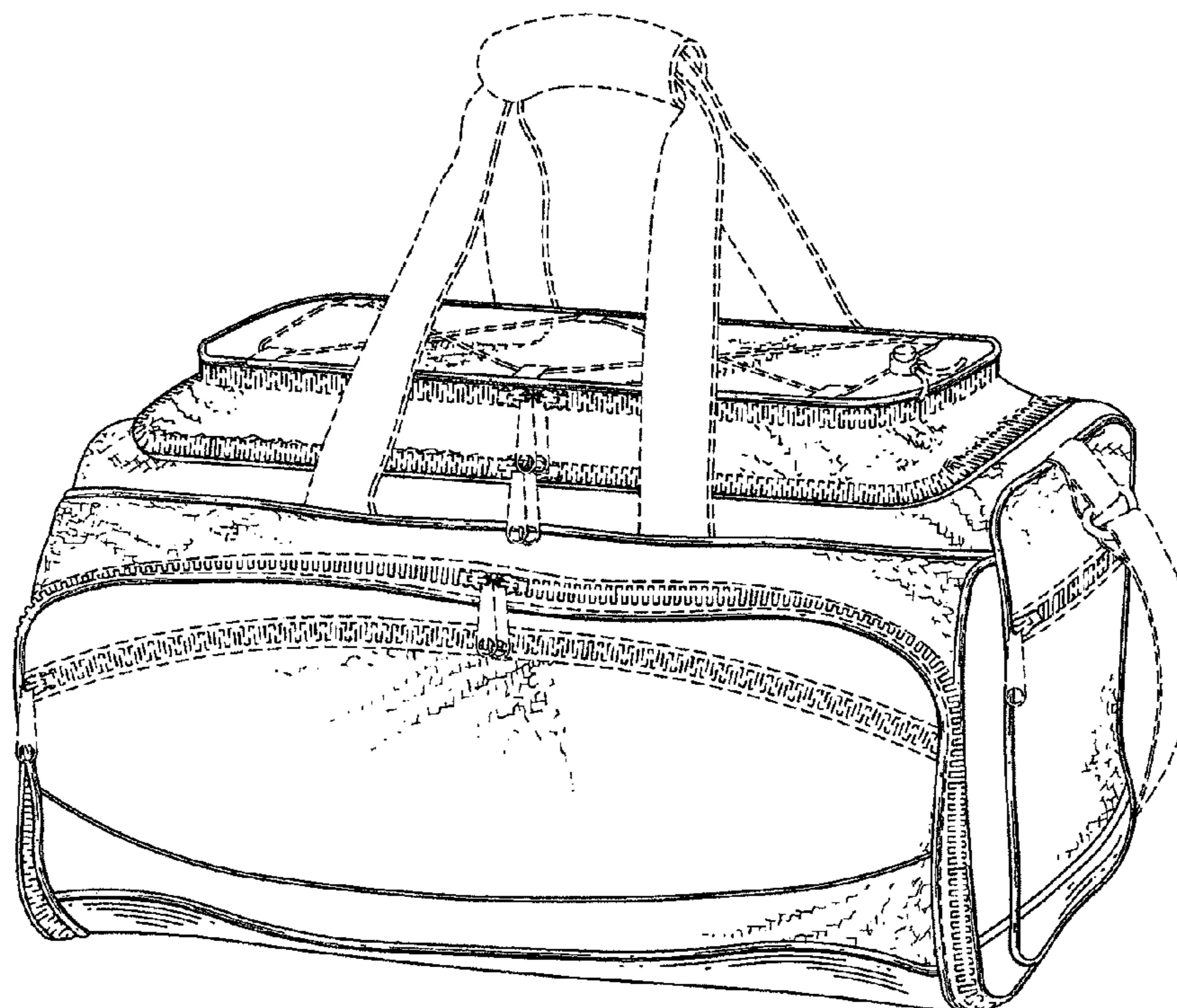
FIG. 6 is a top plan view of the embodiment of the present invention shown in FIG. 1;

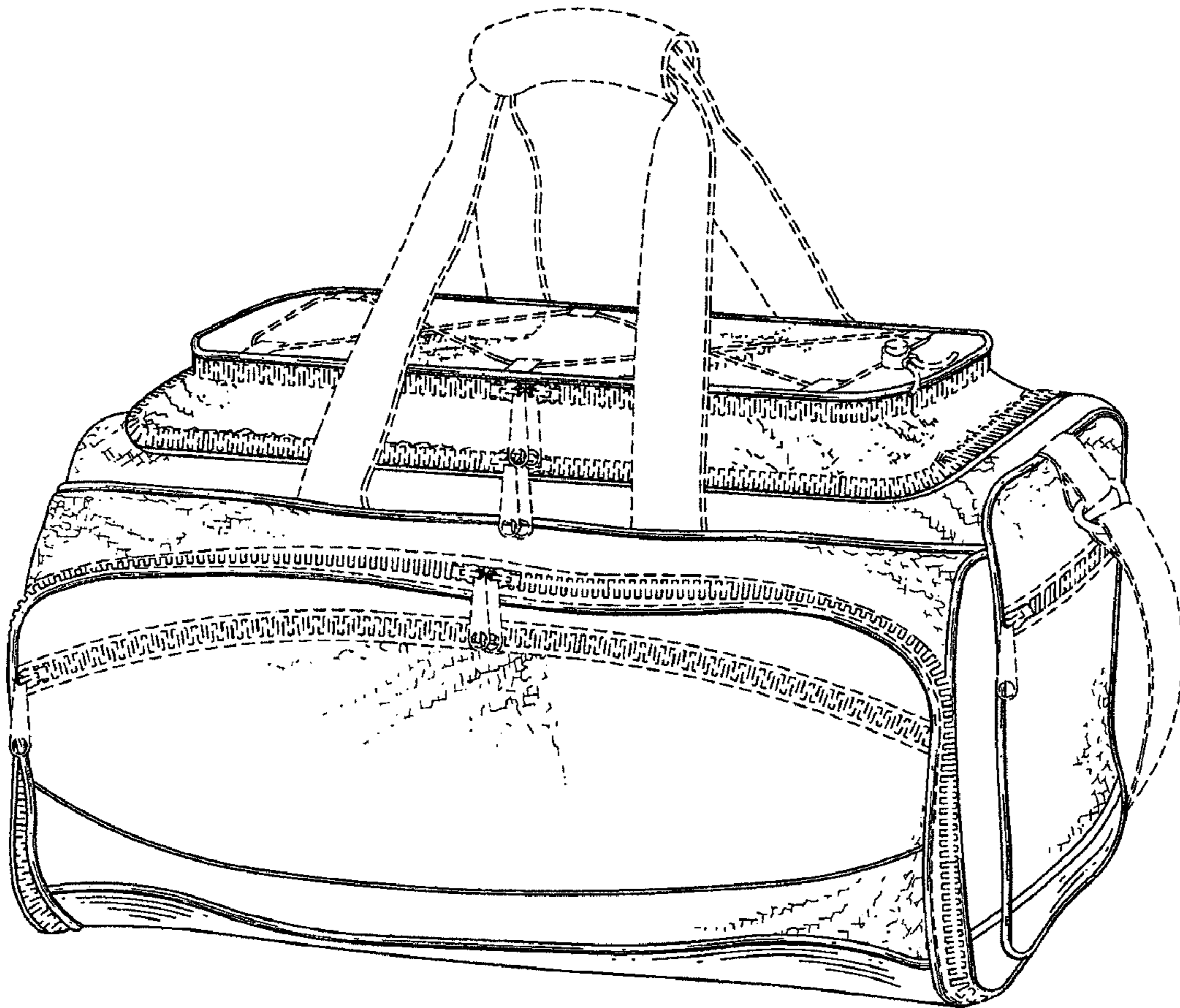

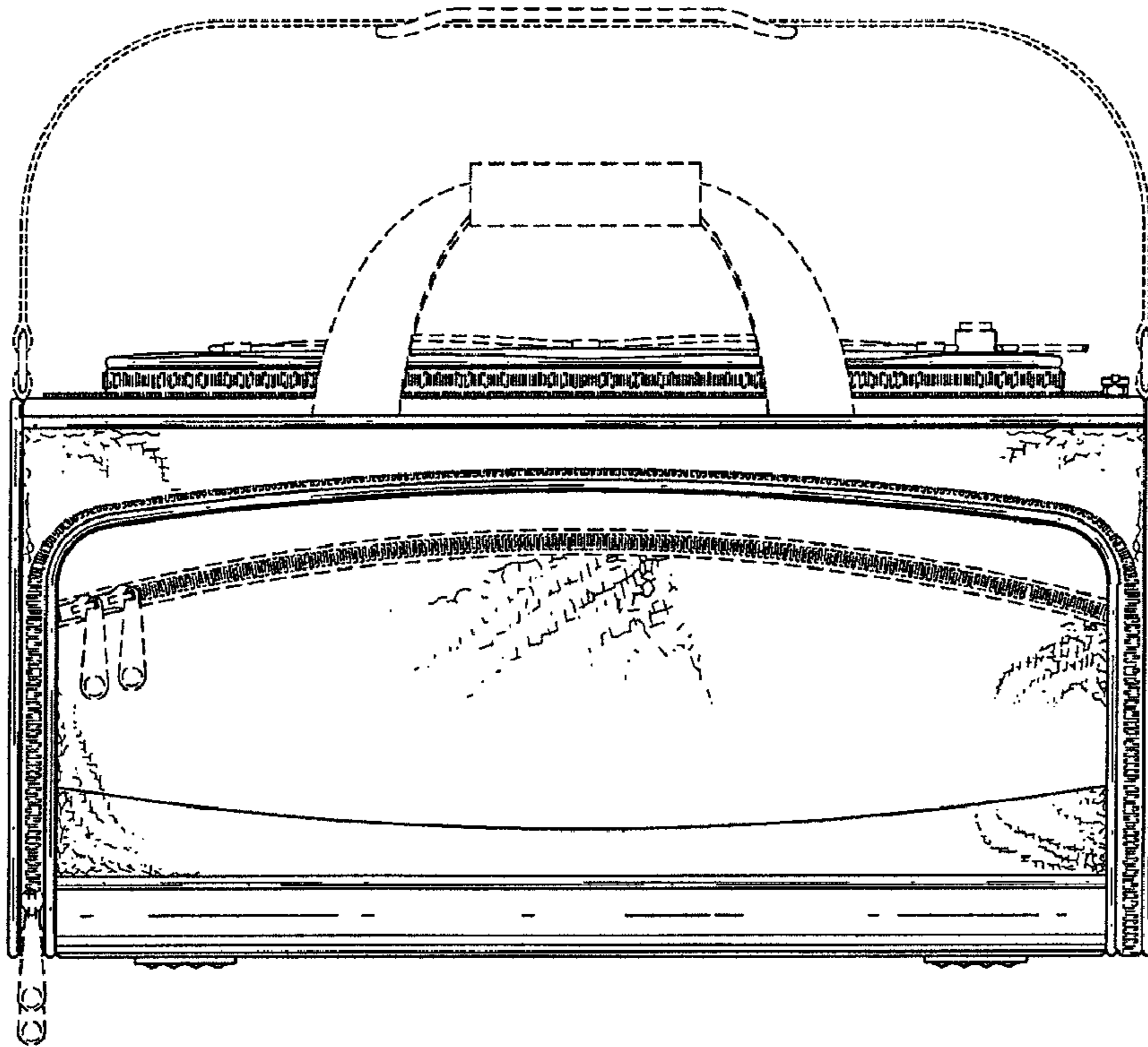

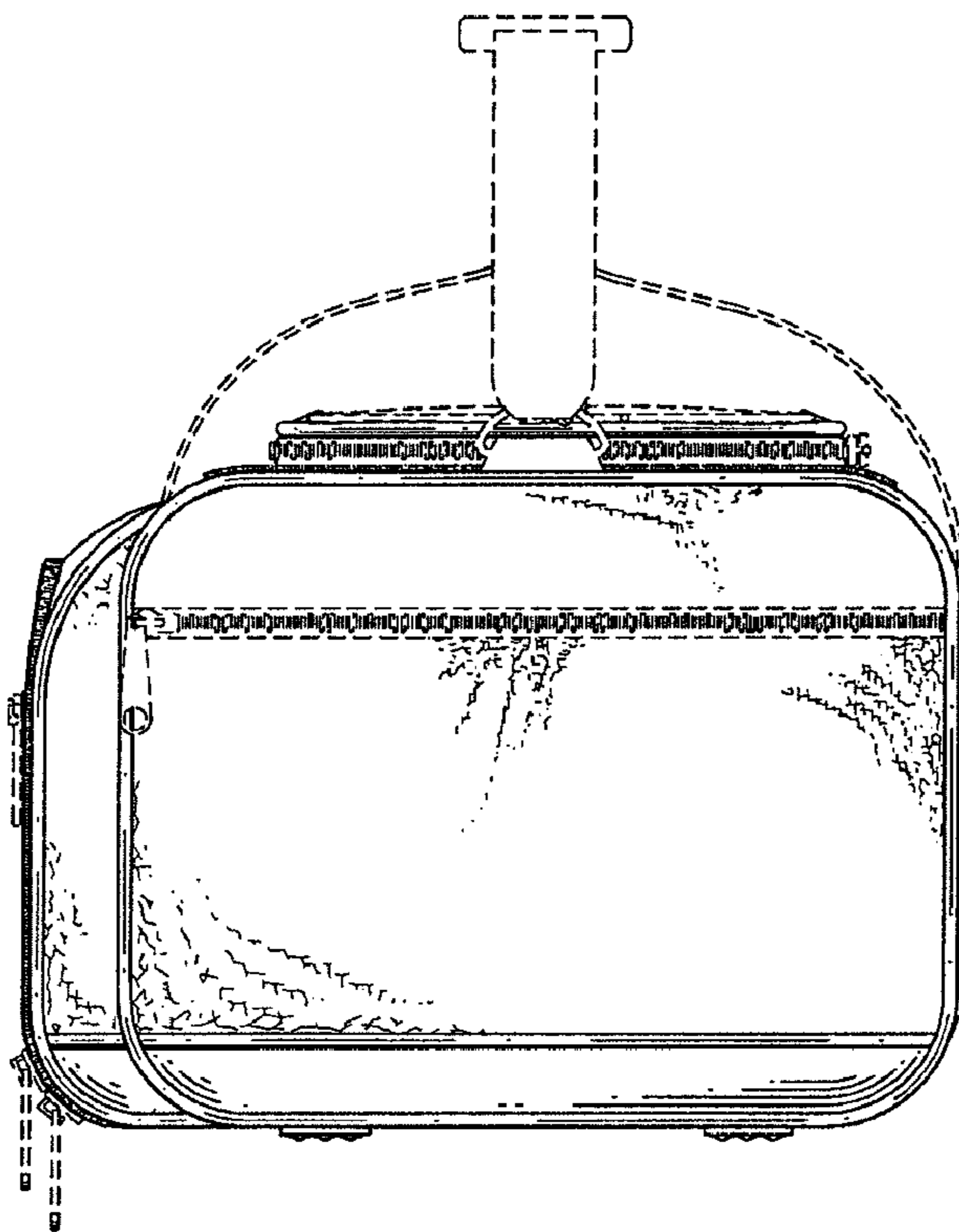

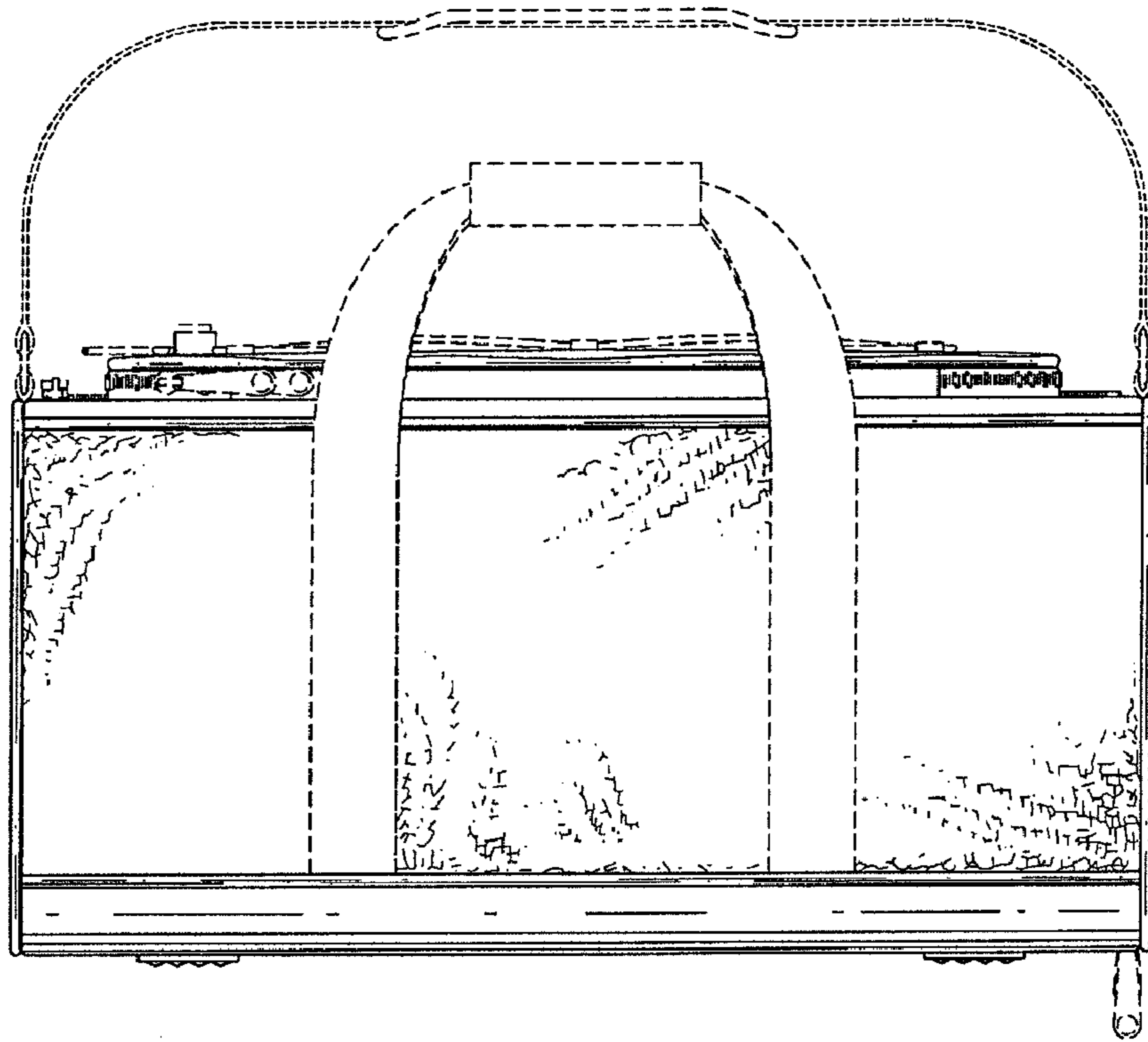

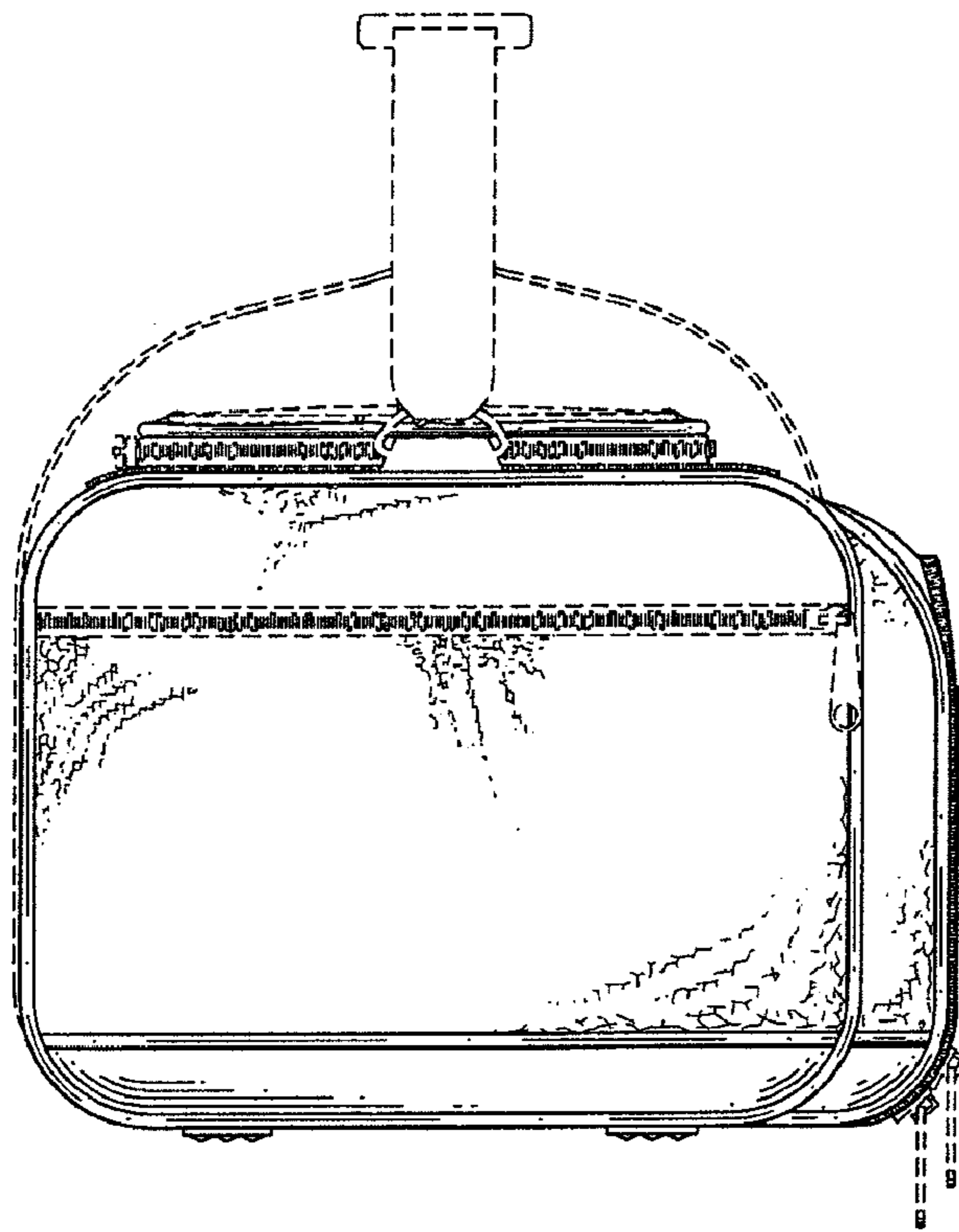

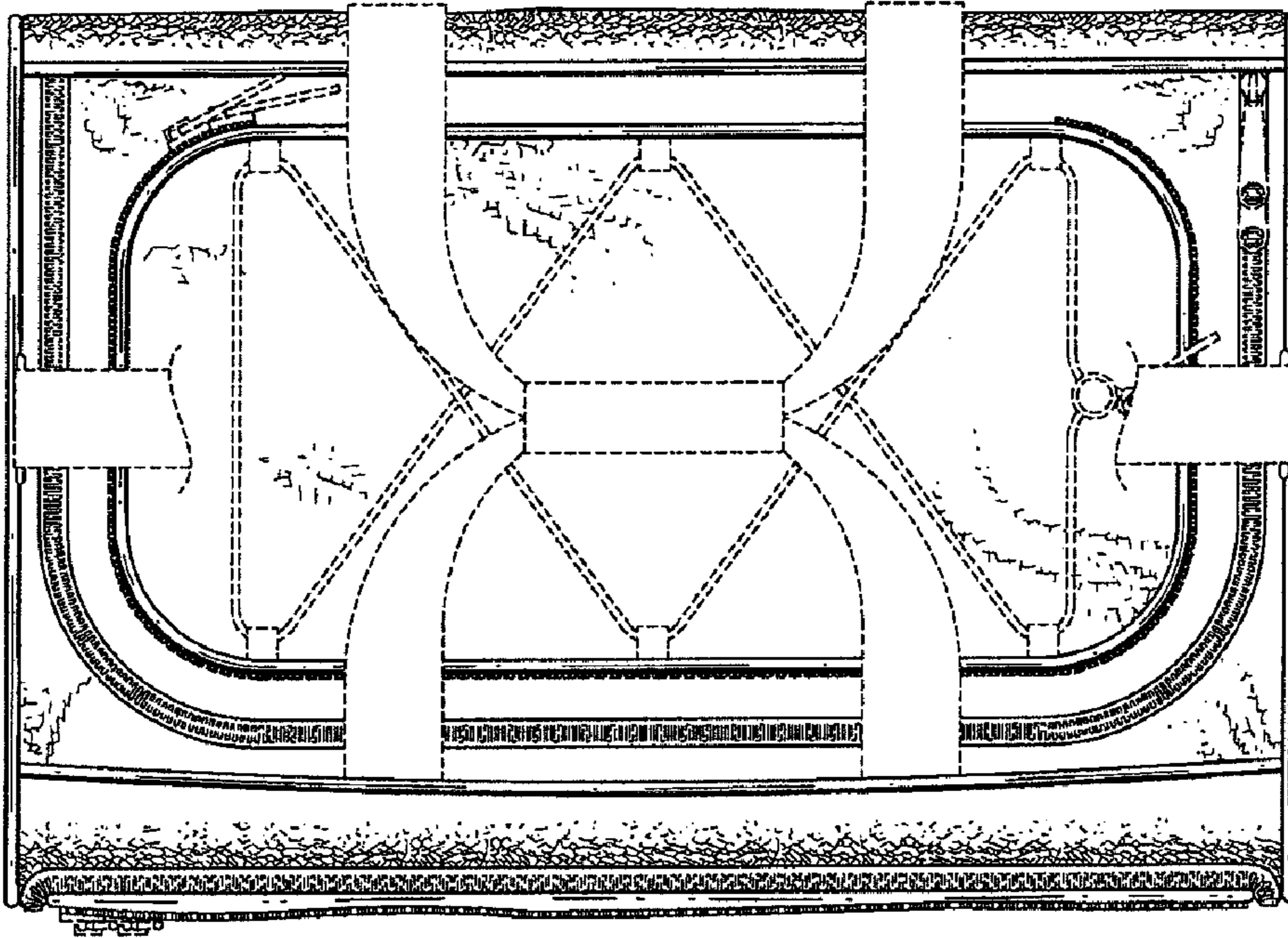

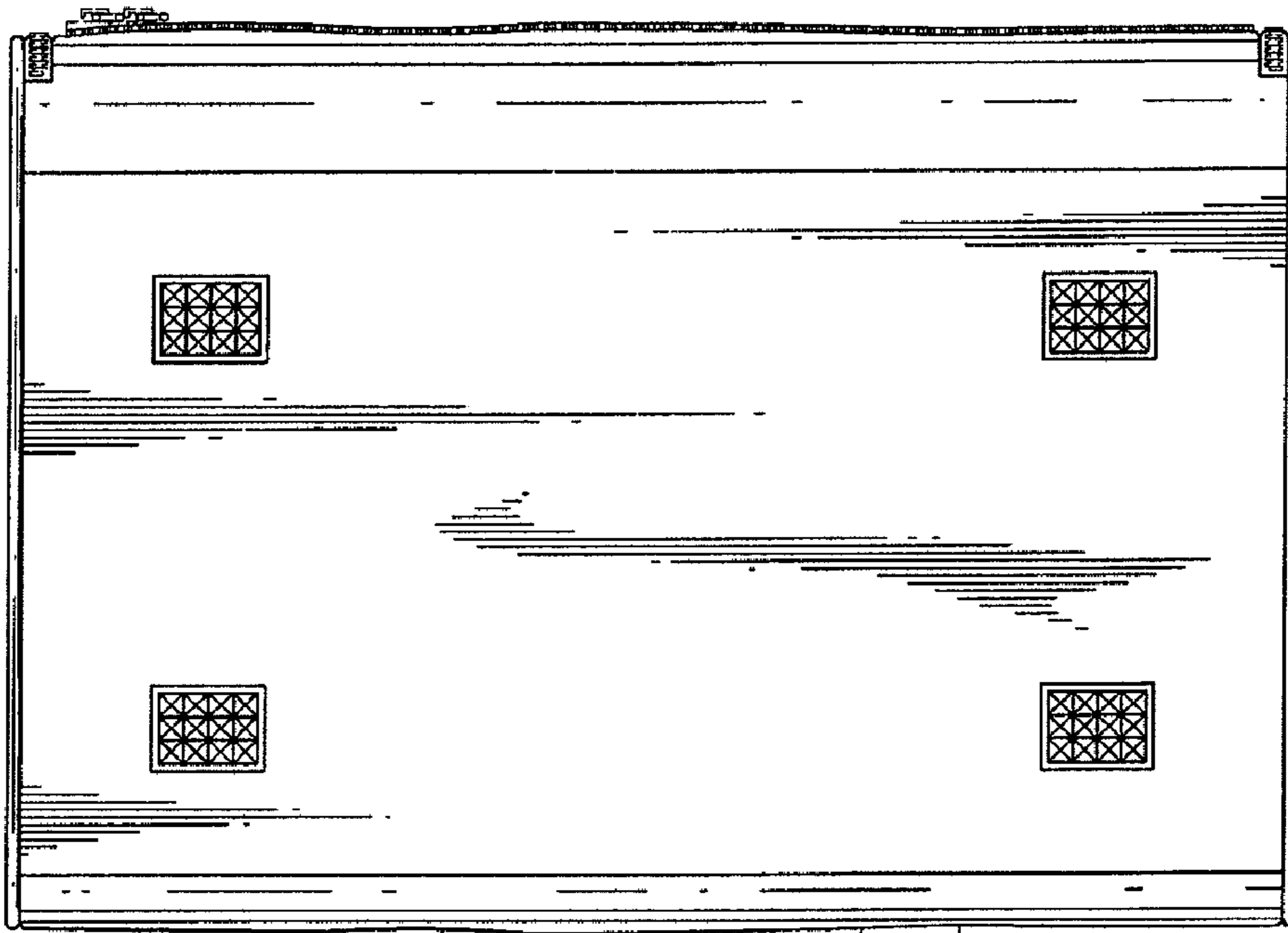

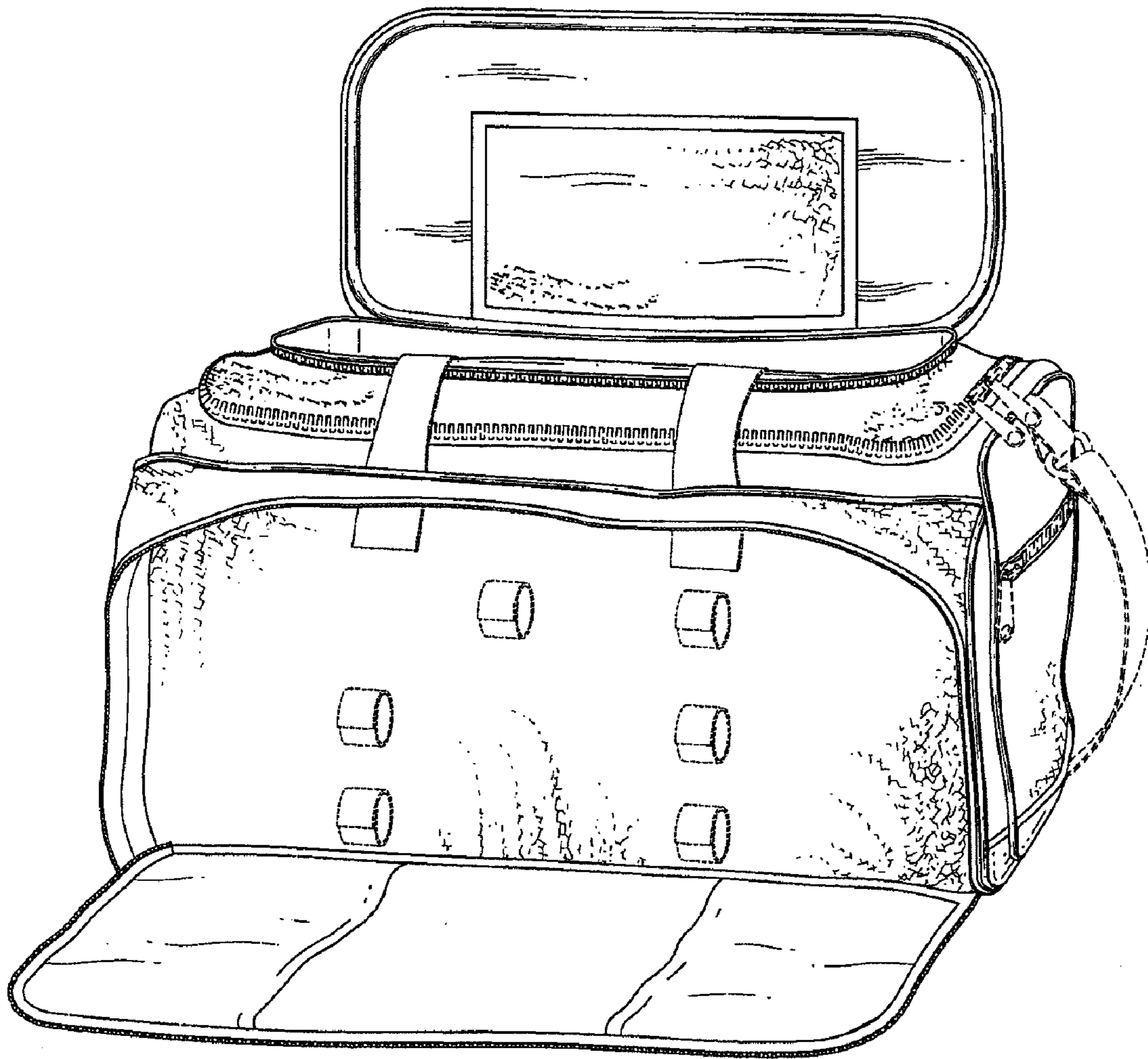
