(57) **CLAIM**

I claim the ornamental design for a spout, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a spout according to the invention;

FIG. 2 is a front view of the spout of FIG. 1;

FIG. 3 is a plan view of the spout of FIG. 1;

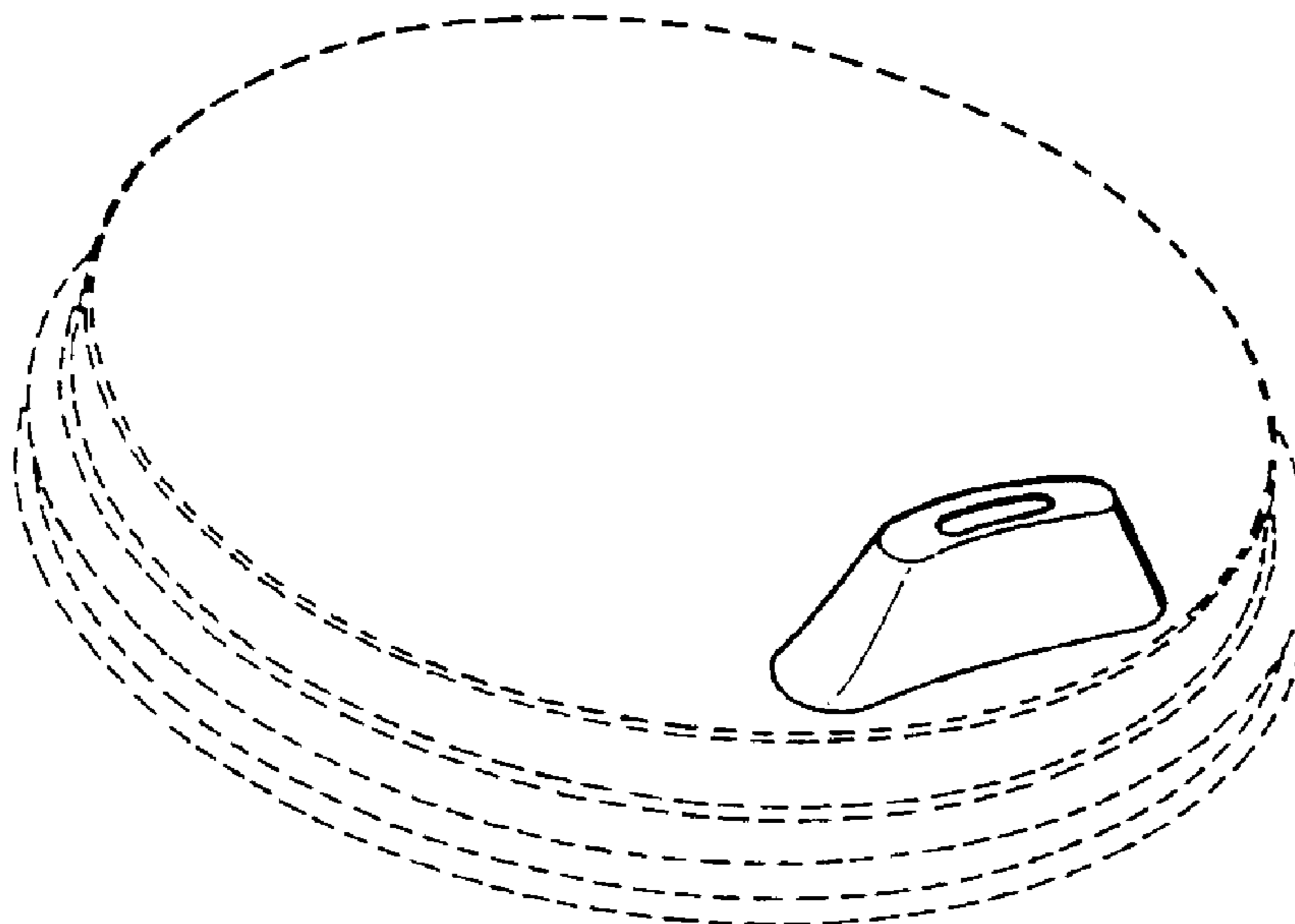
FIG. 4 is a right-hand side view of the spout of FIG. 1, wherein a left-hand side view (not shown) is a mirror image of the right-hand side view;

FIG. 5 is a rear view of the spout of FIG. 1; and,

FIG. 6 is an inverted plan view of the spout of FIG. 1.

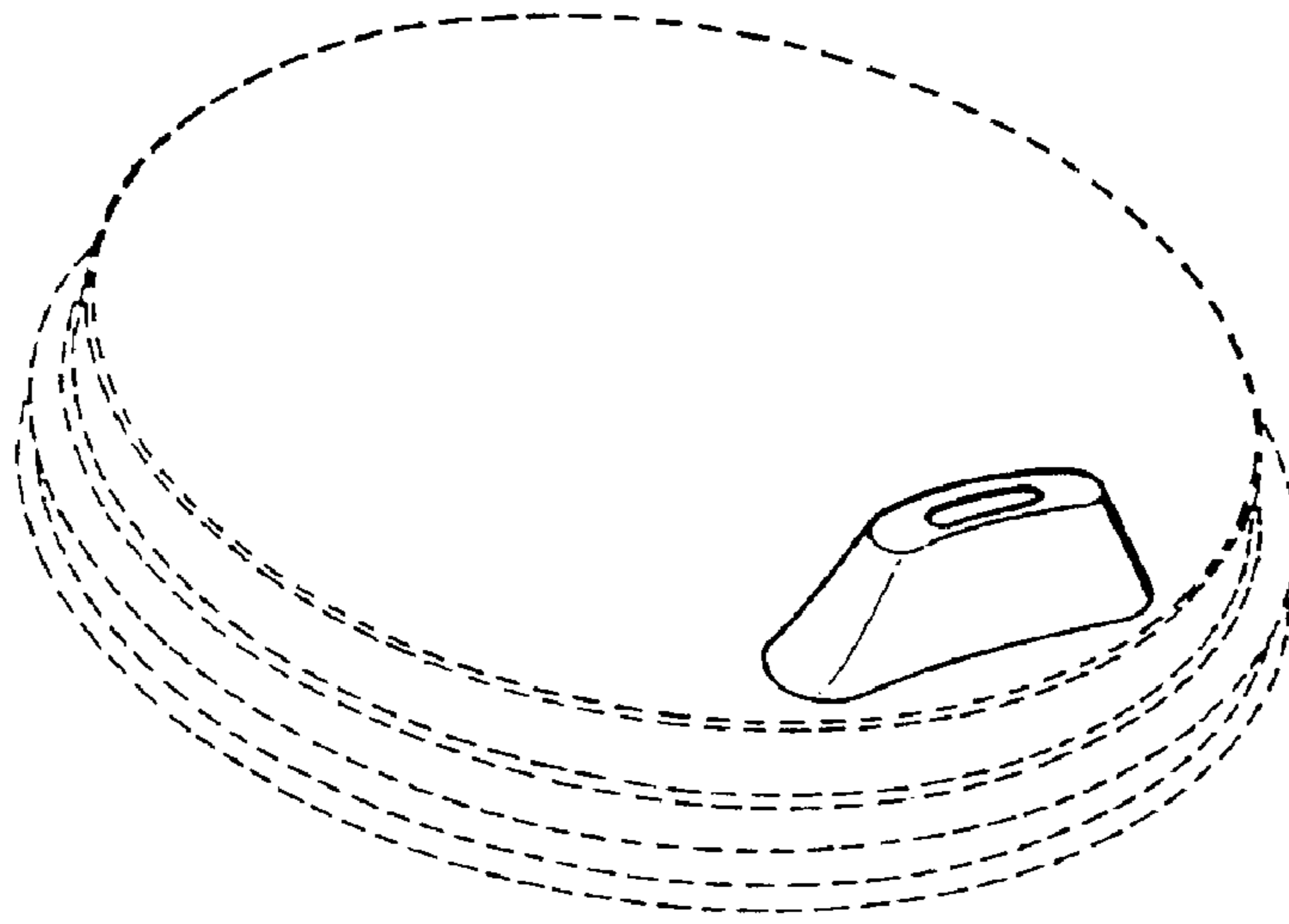

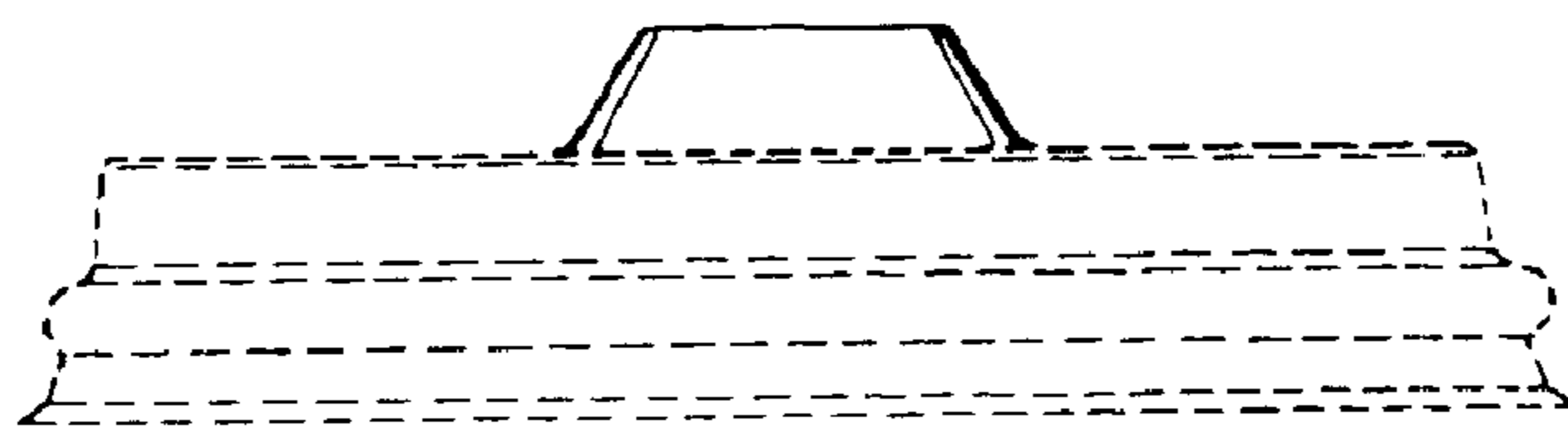

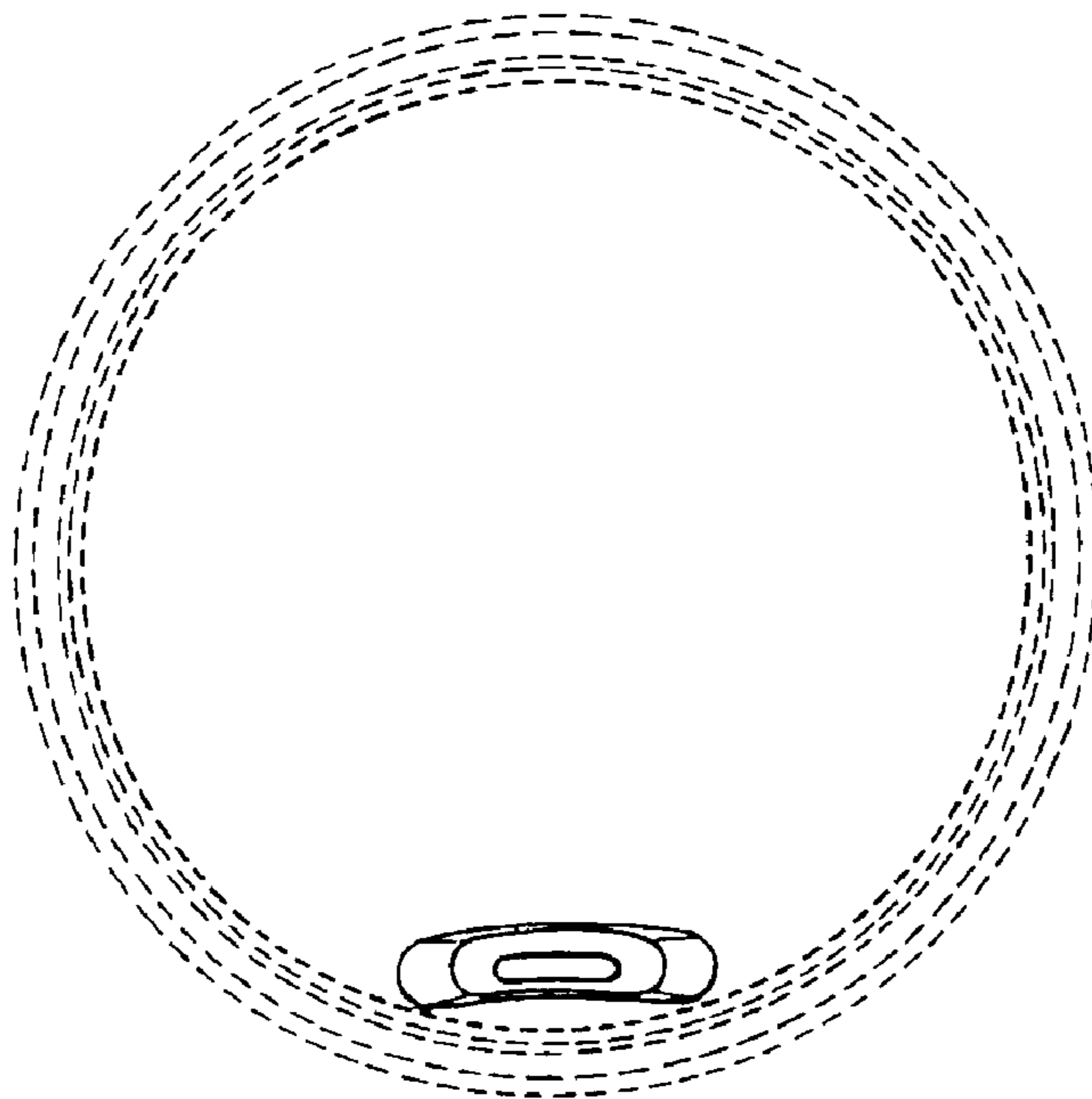

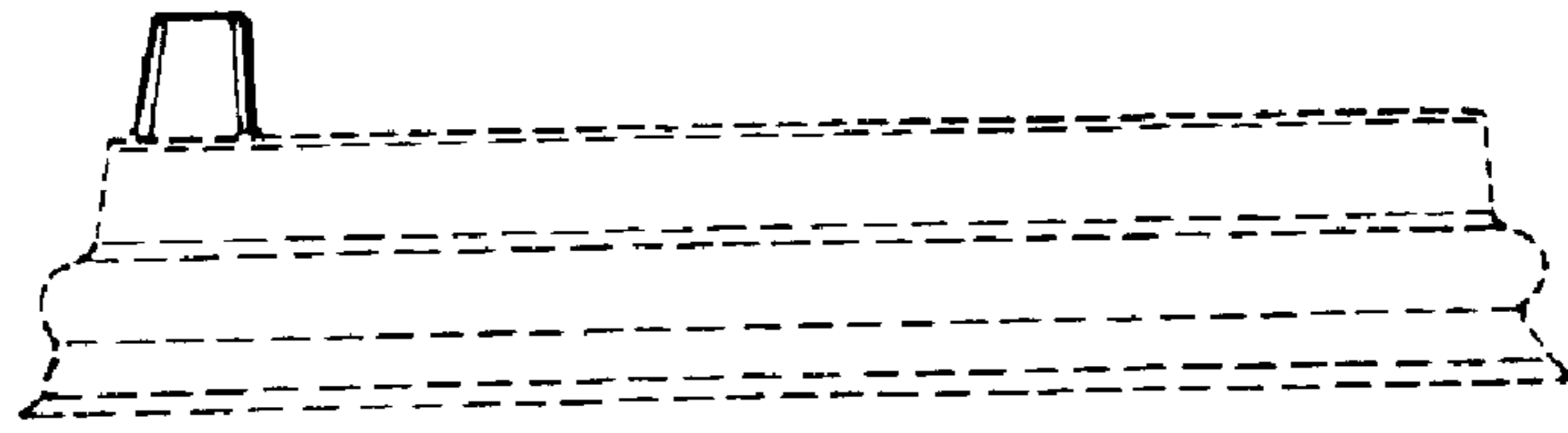

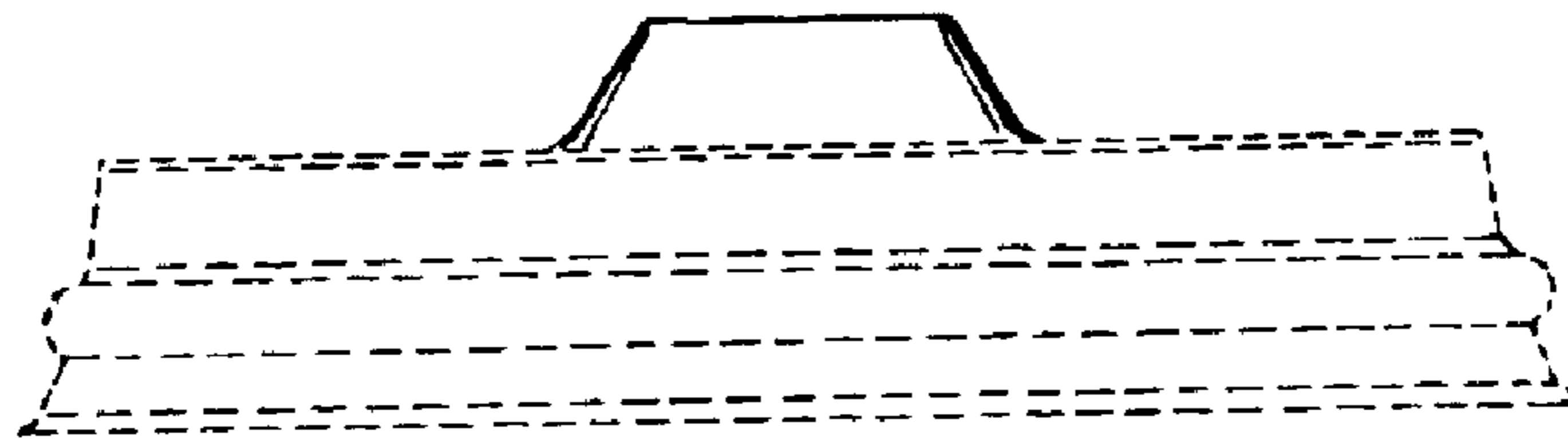

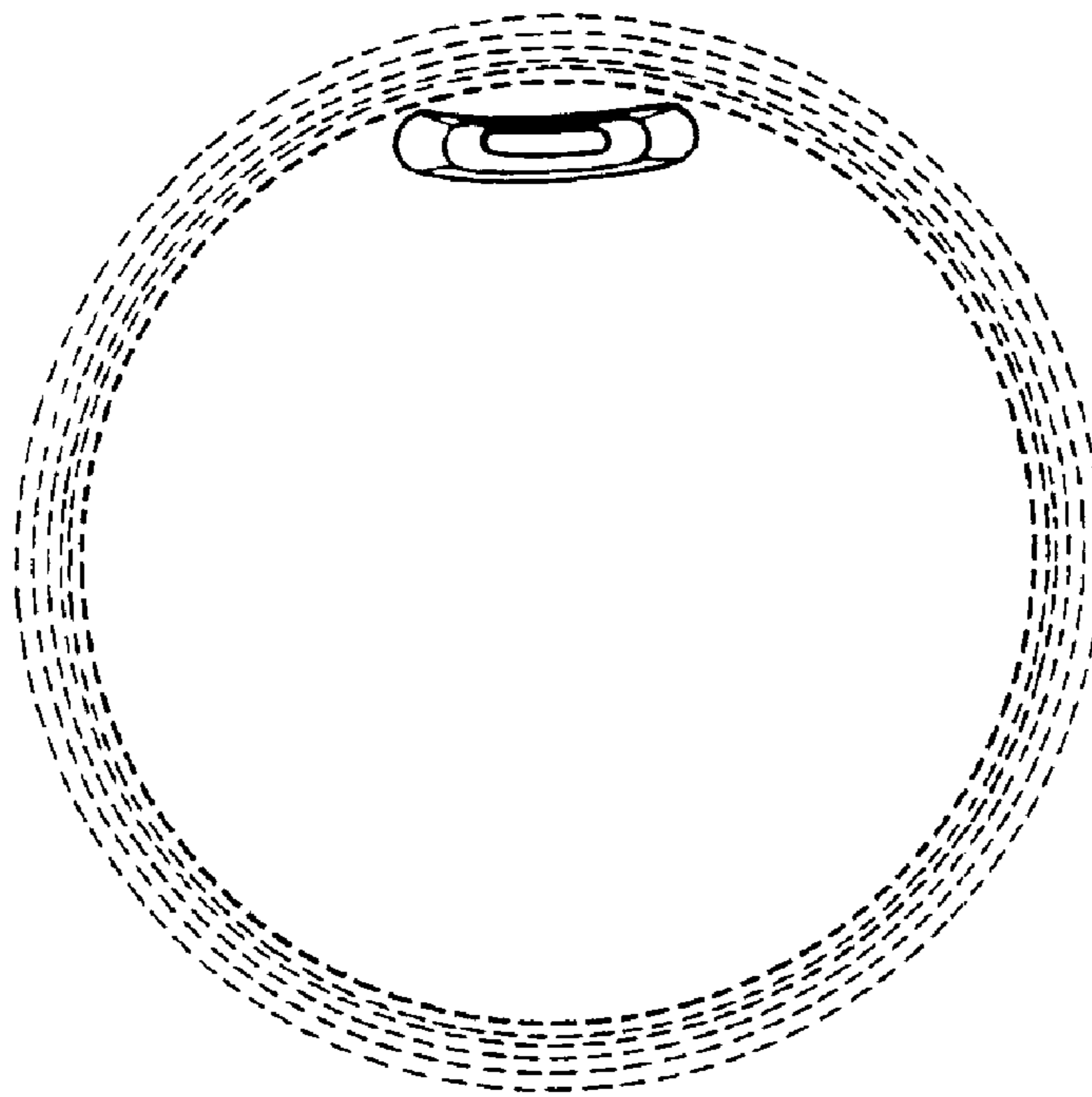
