(57) **CLAIM**

I claim the ornamental design for a lighting article, as shown and described.

DESCRIPTION

FIG. 1 is a side elevation view of a lighting article showing my new design; and,

FIG. 2 is a cross sectional view taken along I—I of FIG. 1.

The lighting article is characterized by an elongated body presenting one or more flower-like lighting elements.

All surfaces not shown form no part of the claimed design.

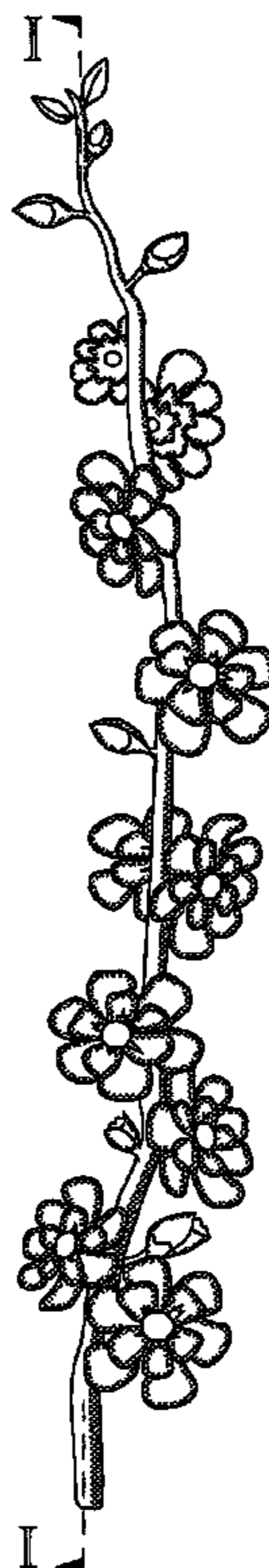

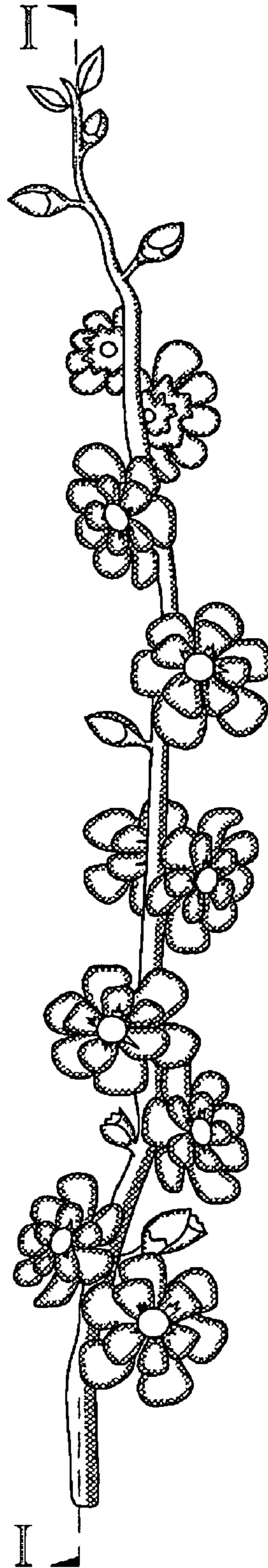
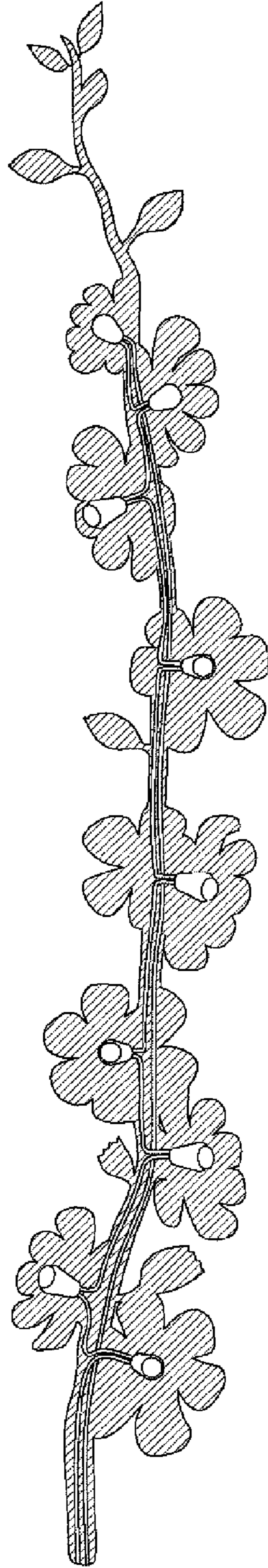
