**DESCRIPTION**

FIG. 1 is a perspective view of an elongated implement retaining apparatus showing my new design;

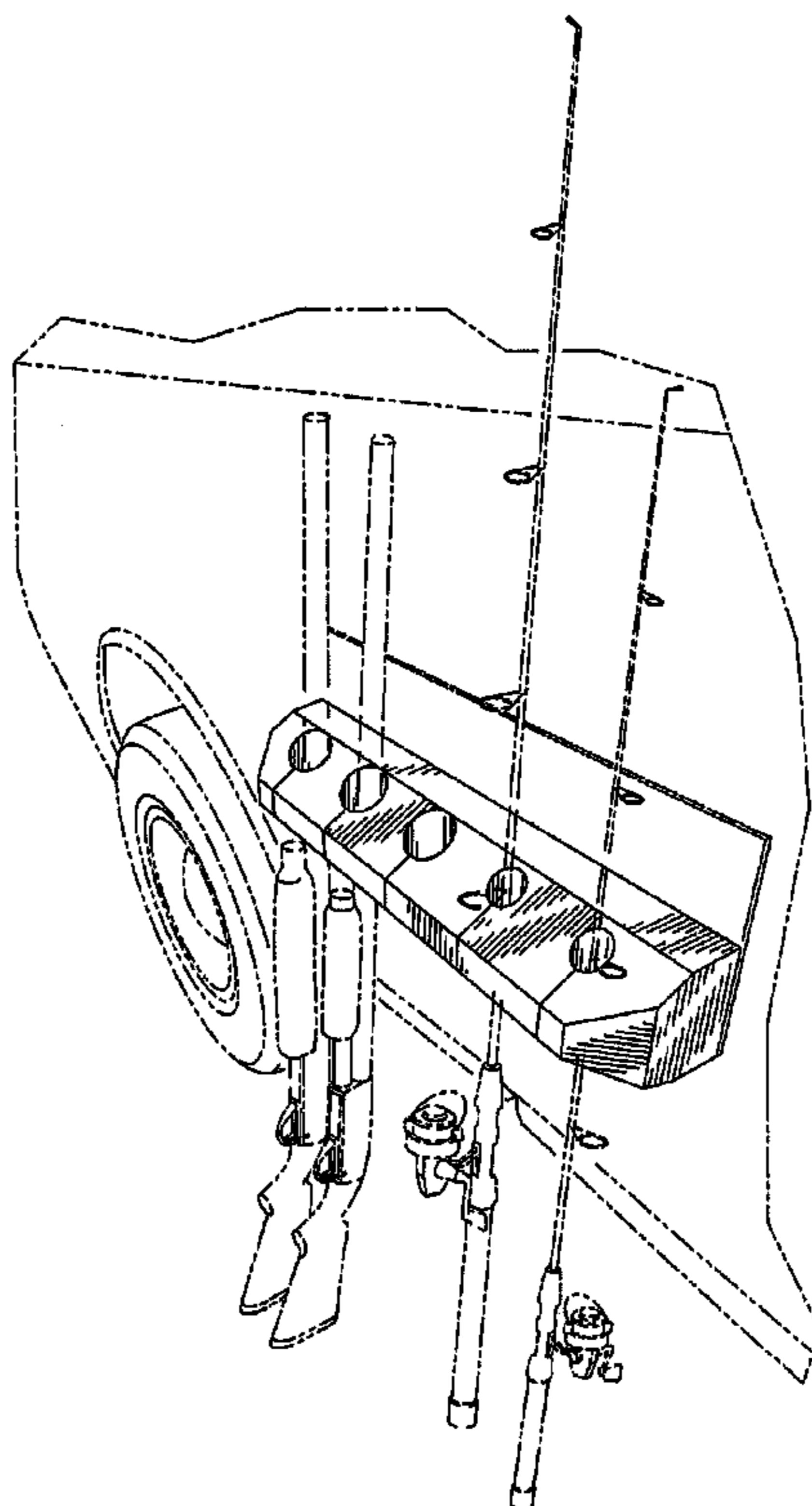

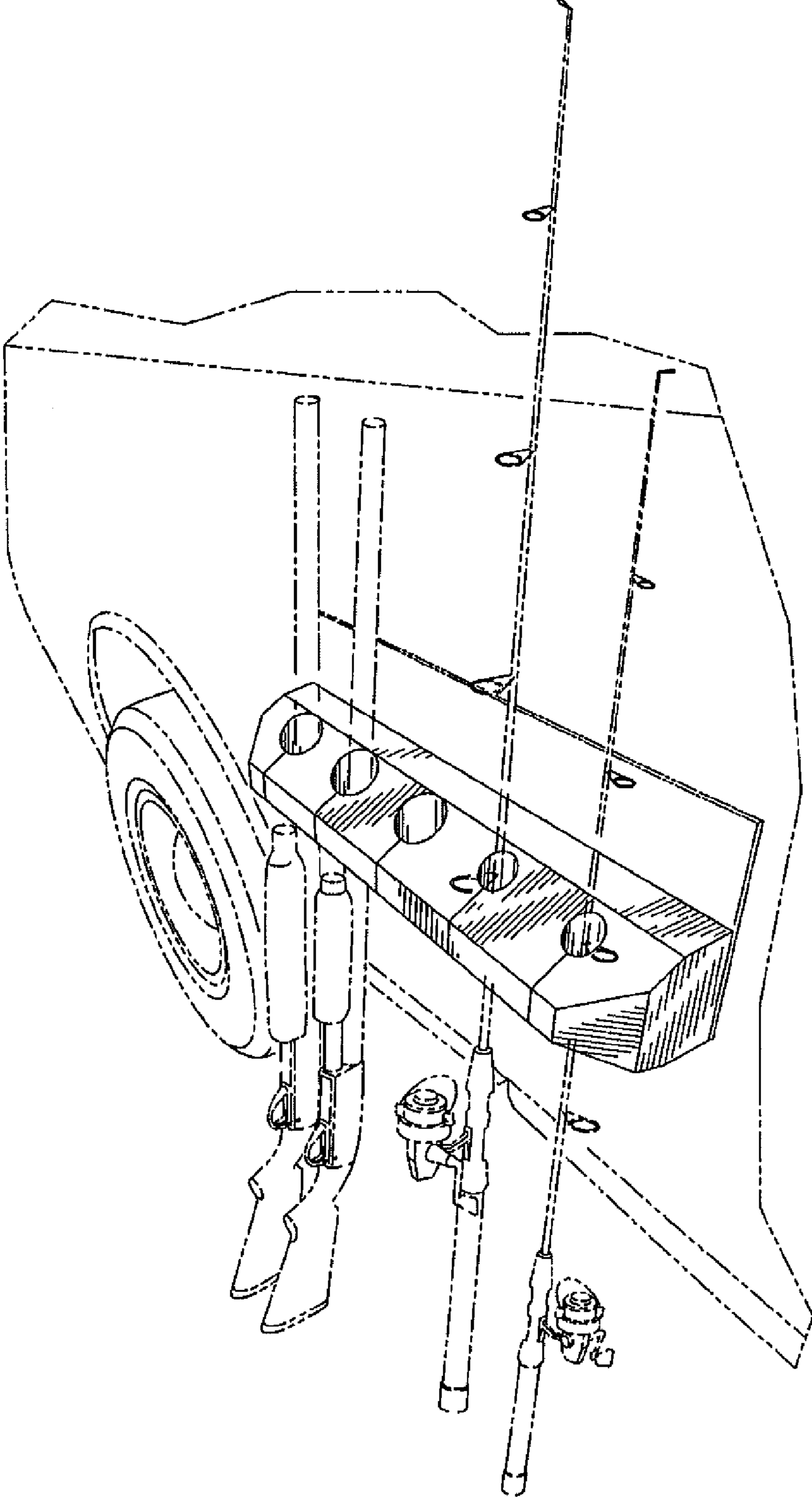

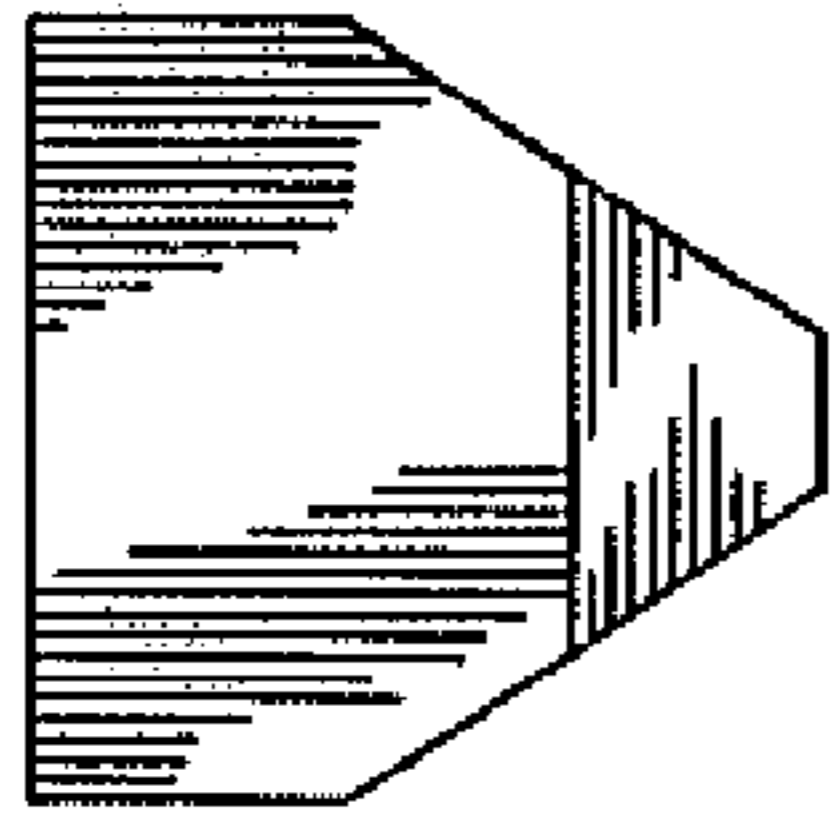

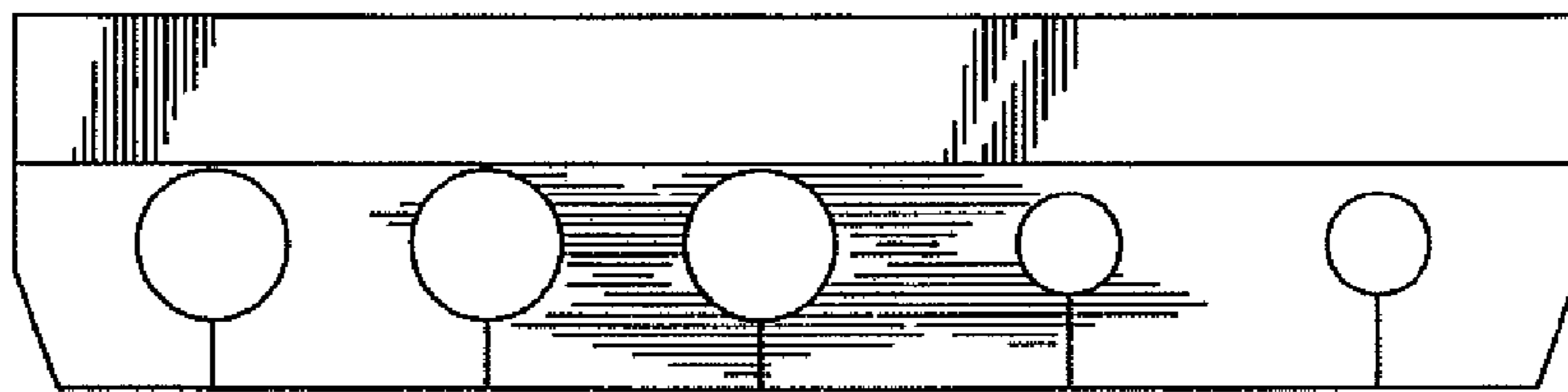

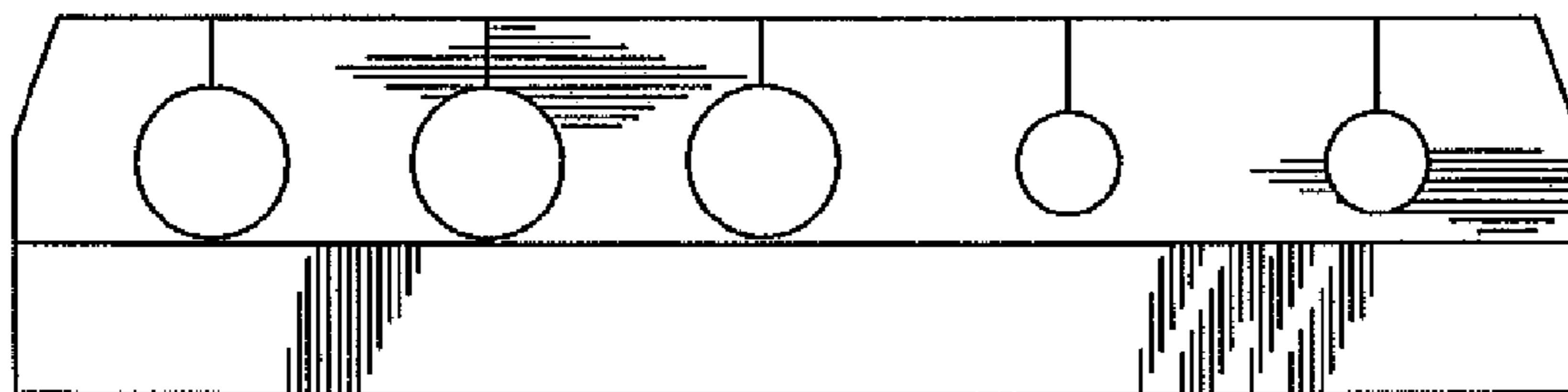

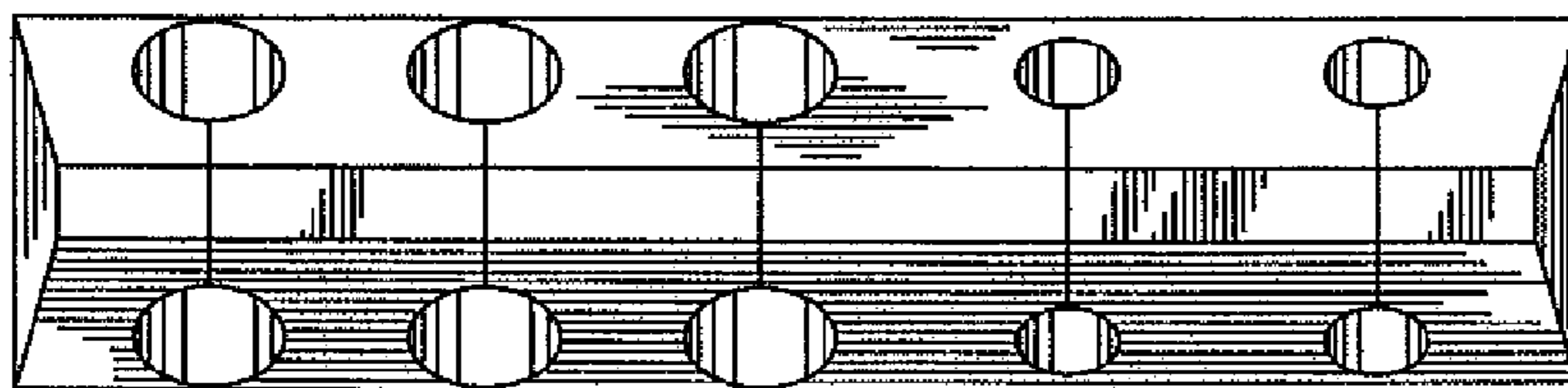
